FIG. 1 is a left perspective view of a radiator grill for a vehicle according to our design, the right perspective view being mirror symmetrical;

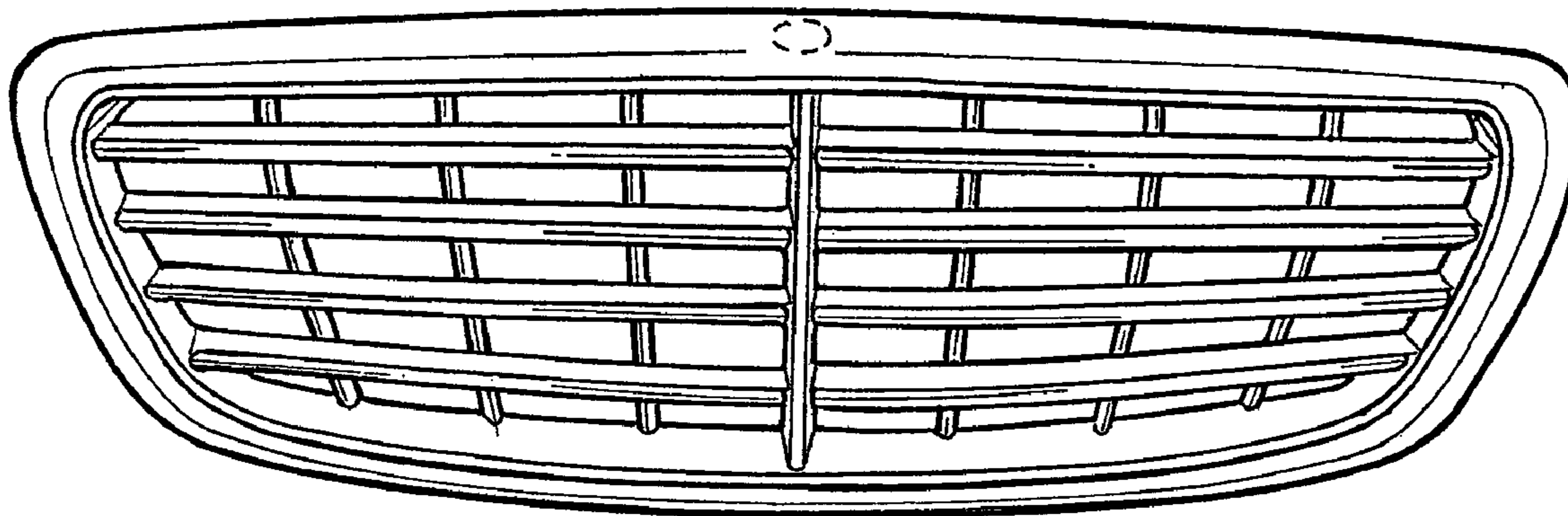
FIG. 2 is a front view thereof;

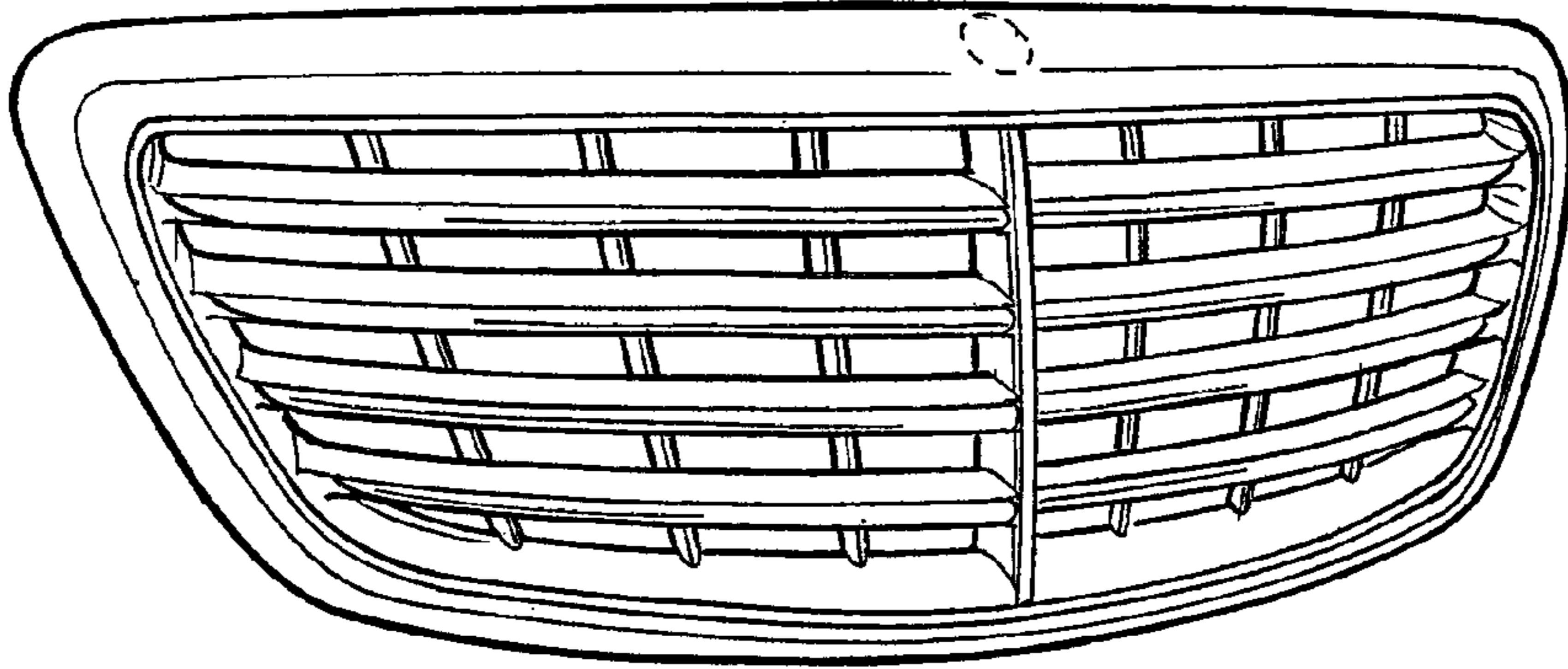

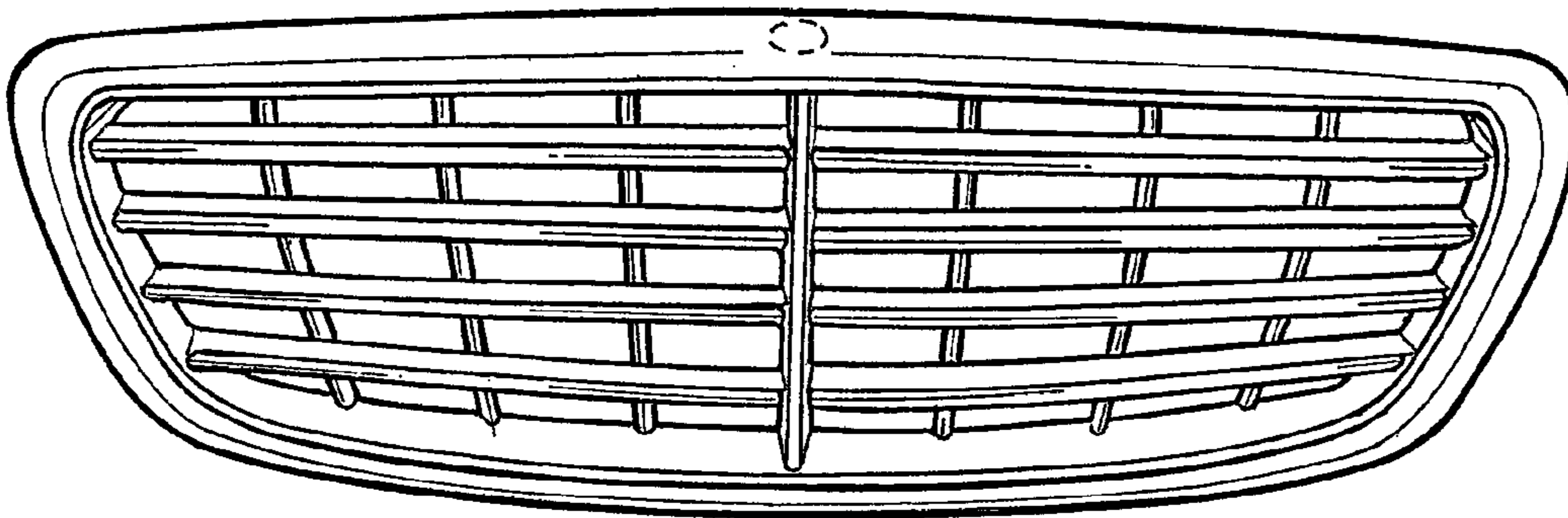

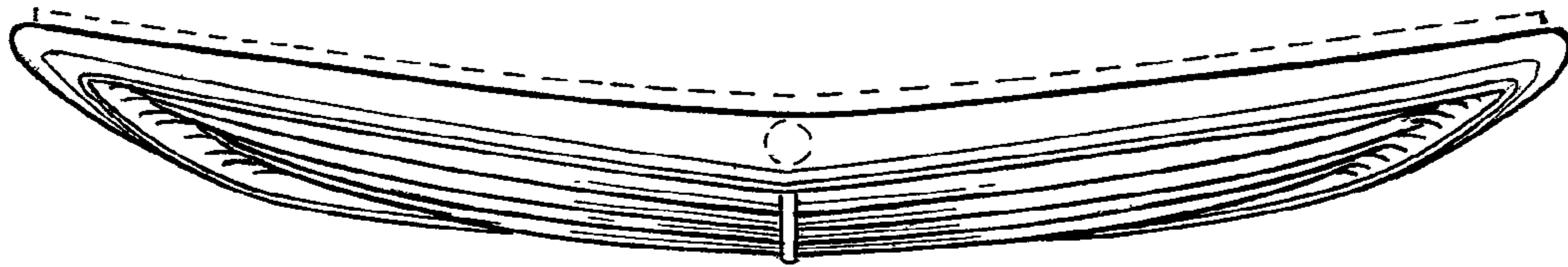

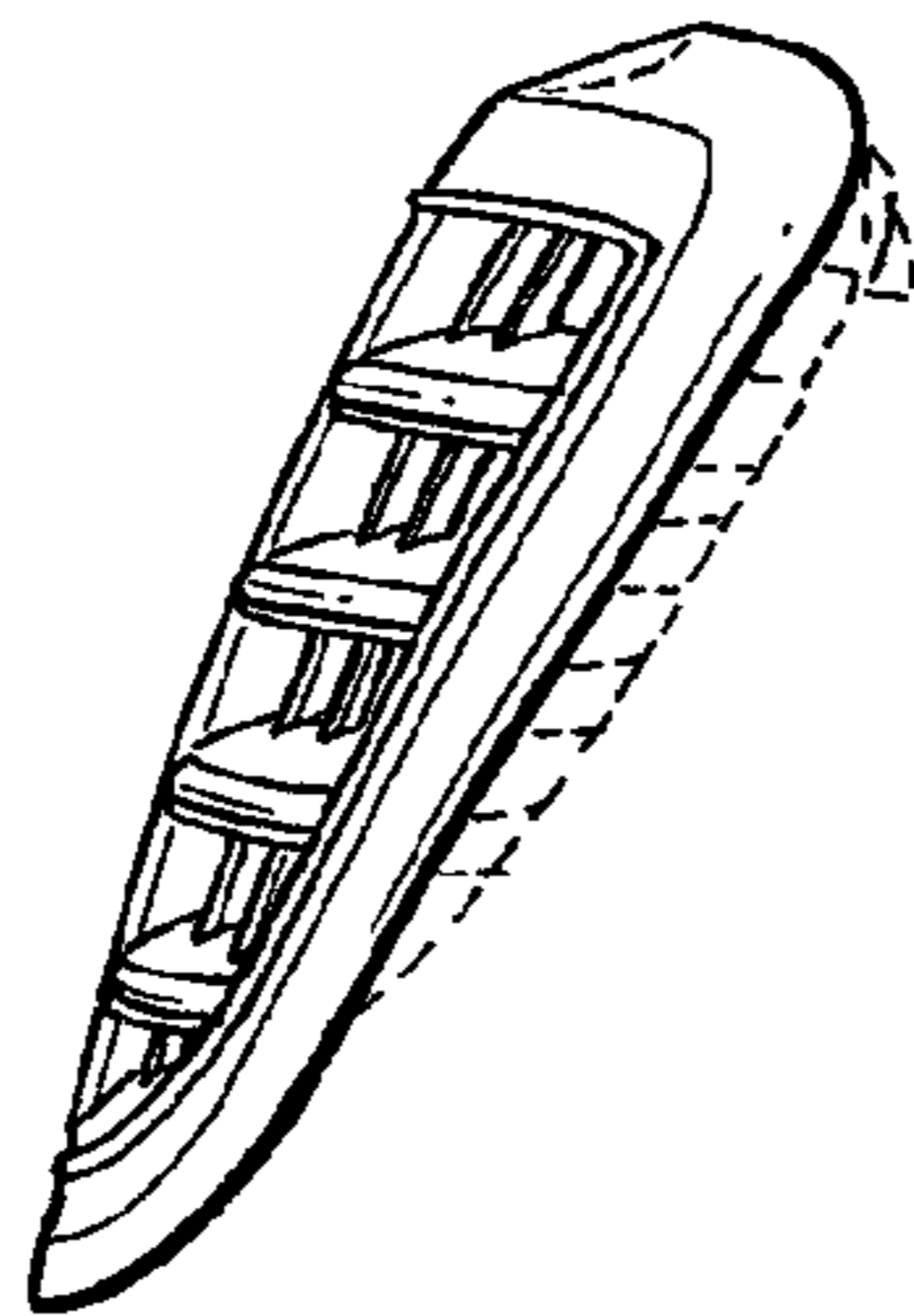
