(57) **CLAIM**

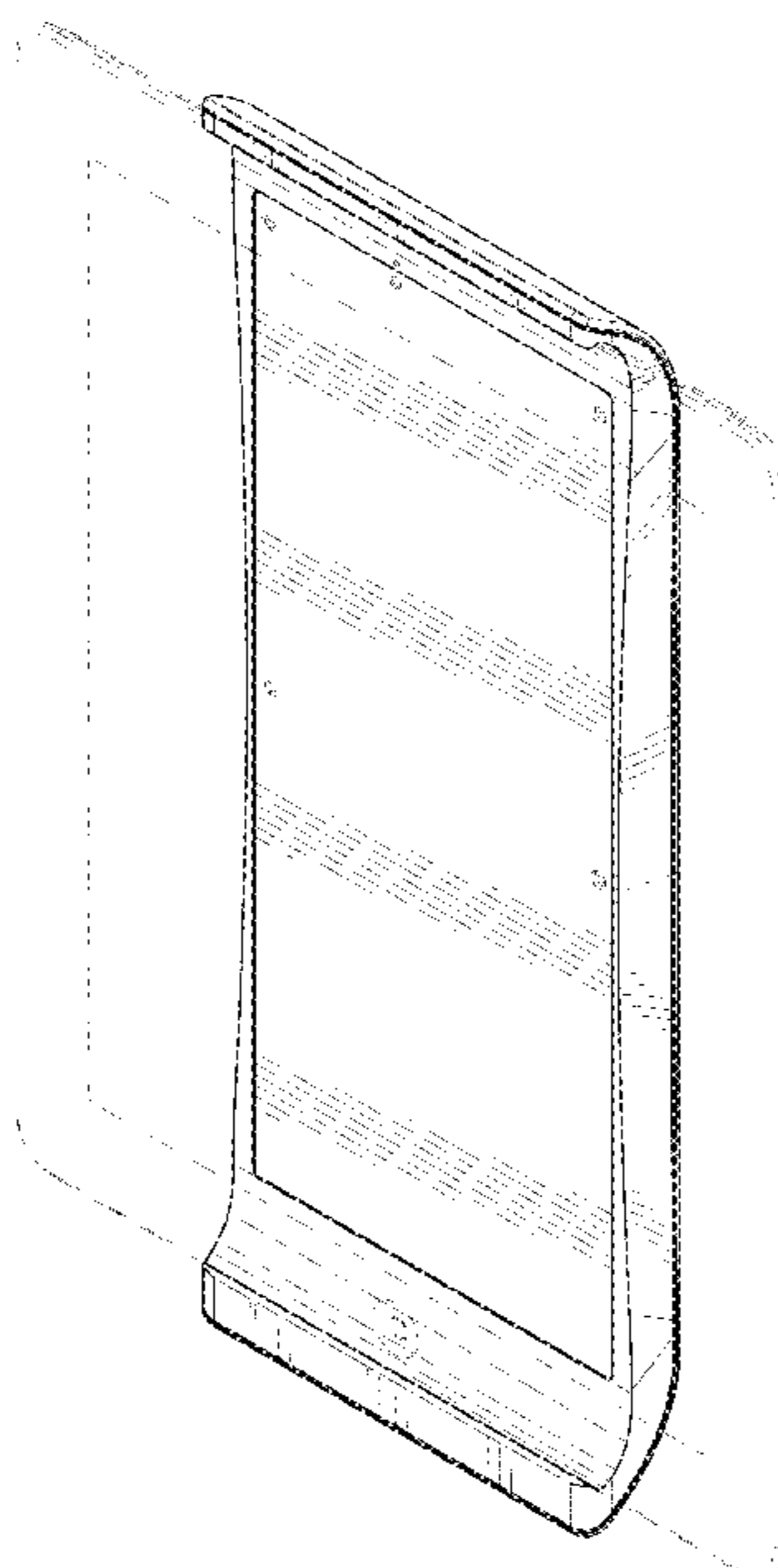
The ornamental design for a storage device for a mobile device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a storage device for a mobile device;
FIG. 2 is a first side view of the storage device for a mobile device shown in FIG. 1;

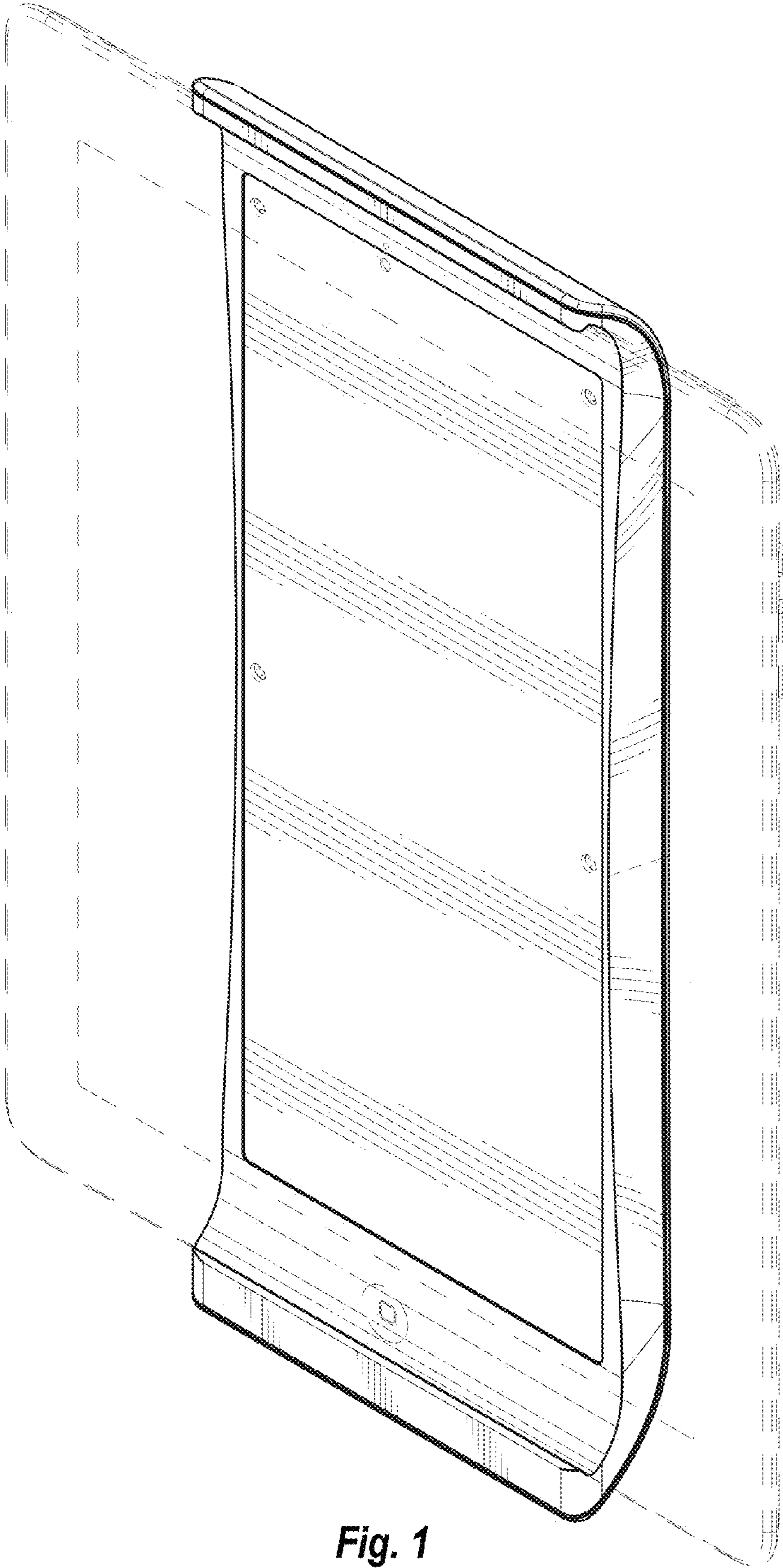

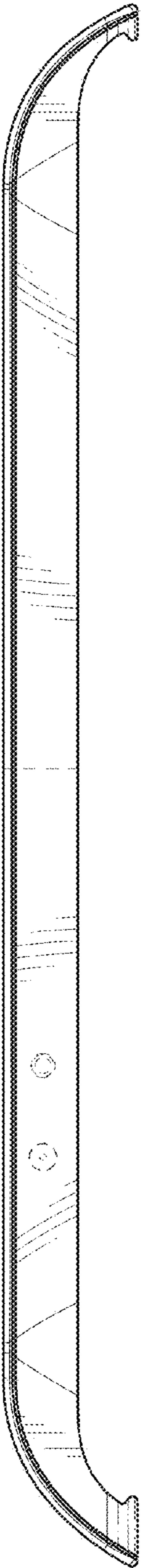

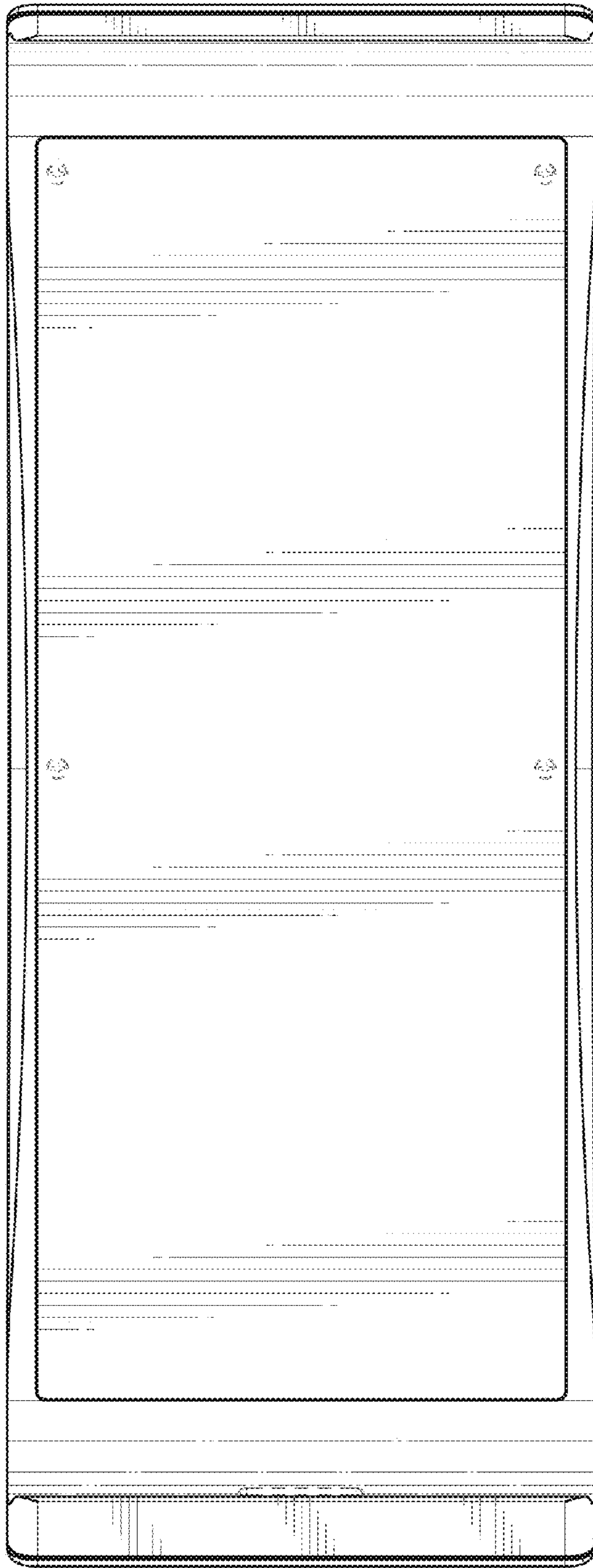

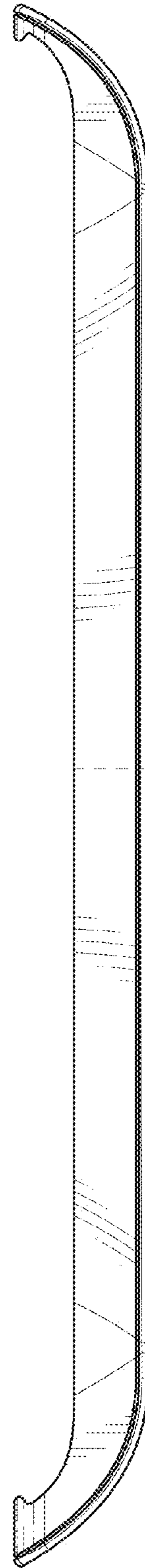

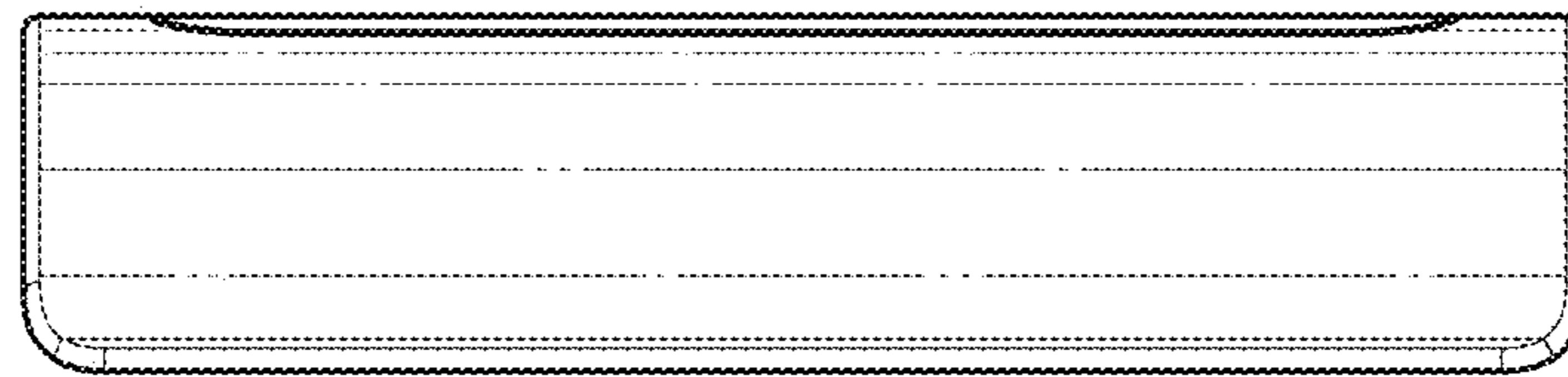

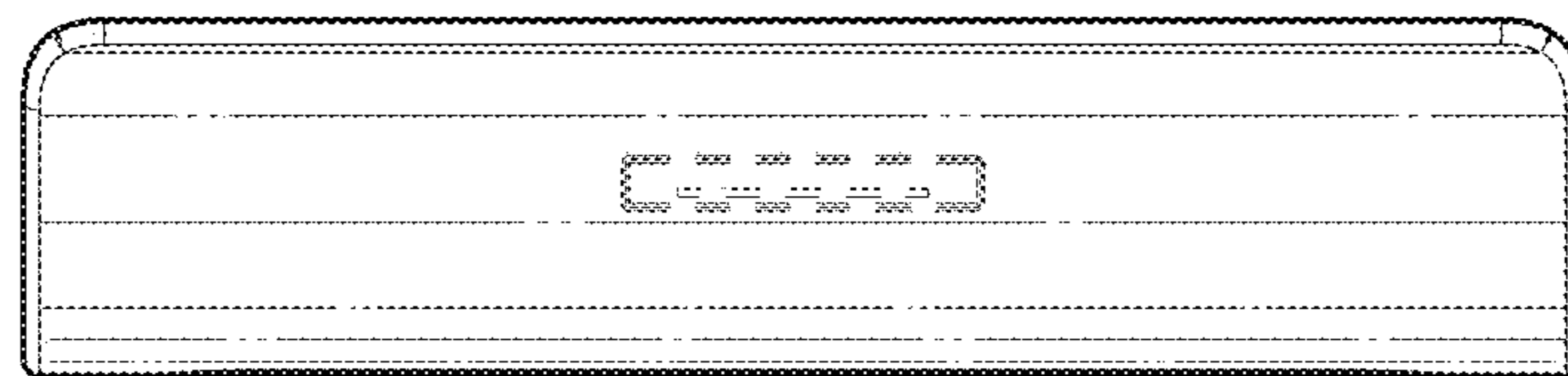

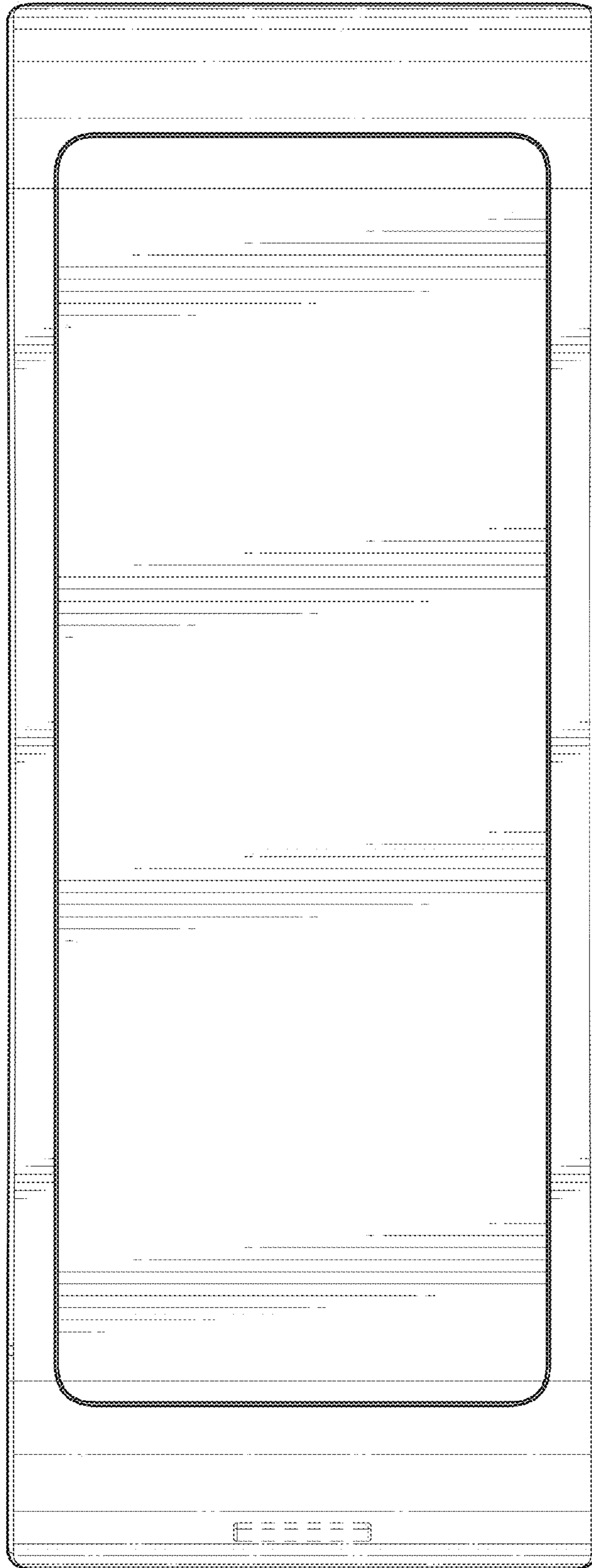
