(57) **CLAIM**

The ornamental design for a display screen or portion thereof with a graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 a front view of a display screen or portion thereof with a graphical user interface showing my new design; and, FIG. 2 is another front view of the display screen or portion thereof with a graphical user interface of FIG. 1 as applied to a mobile terminal.

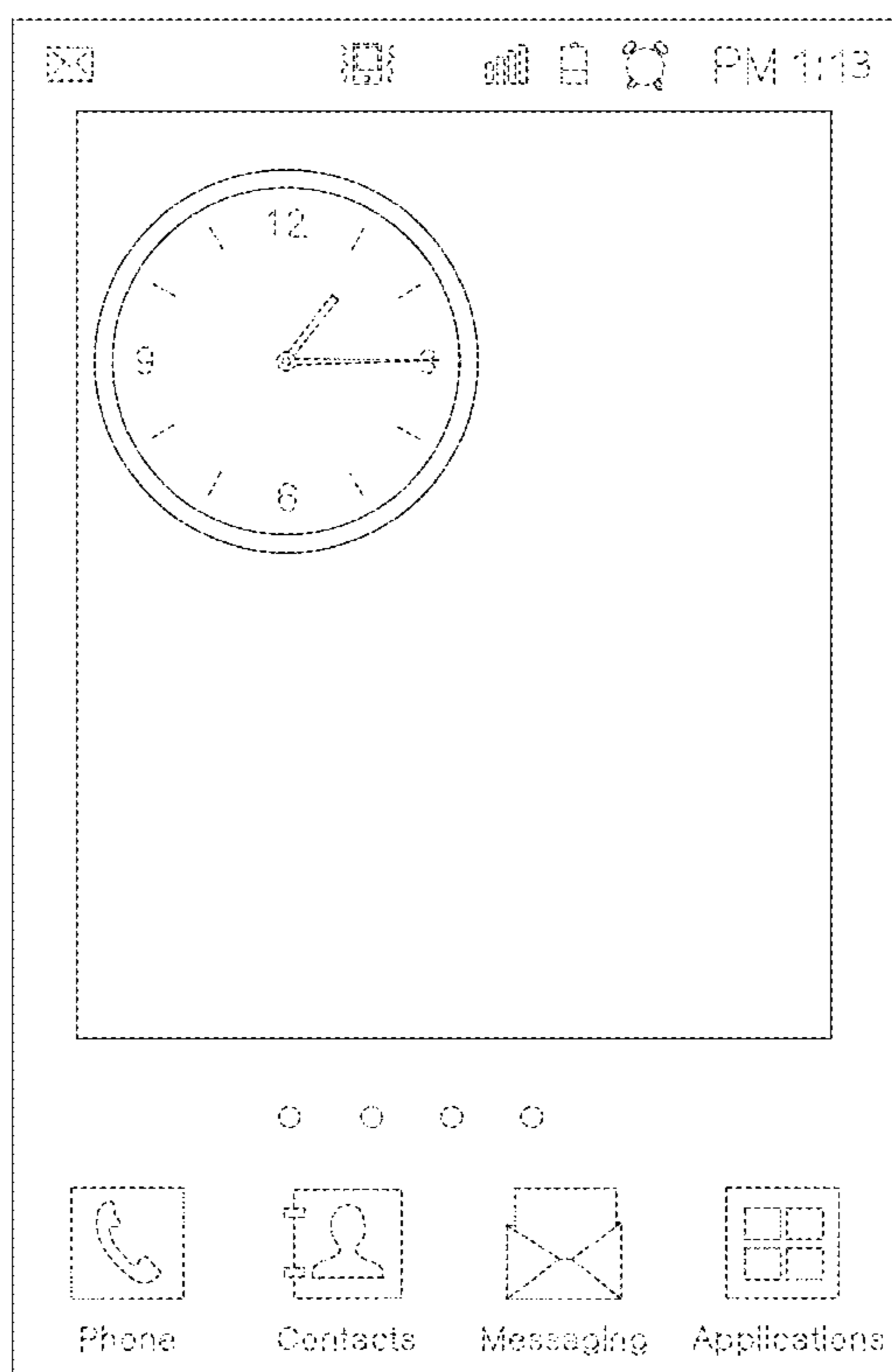

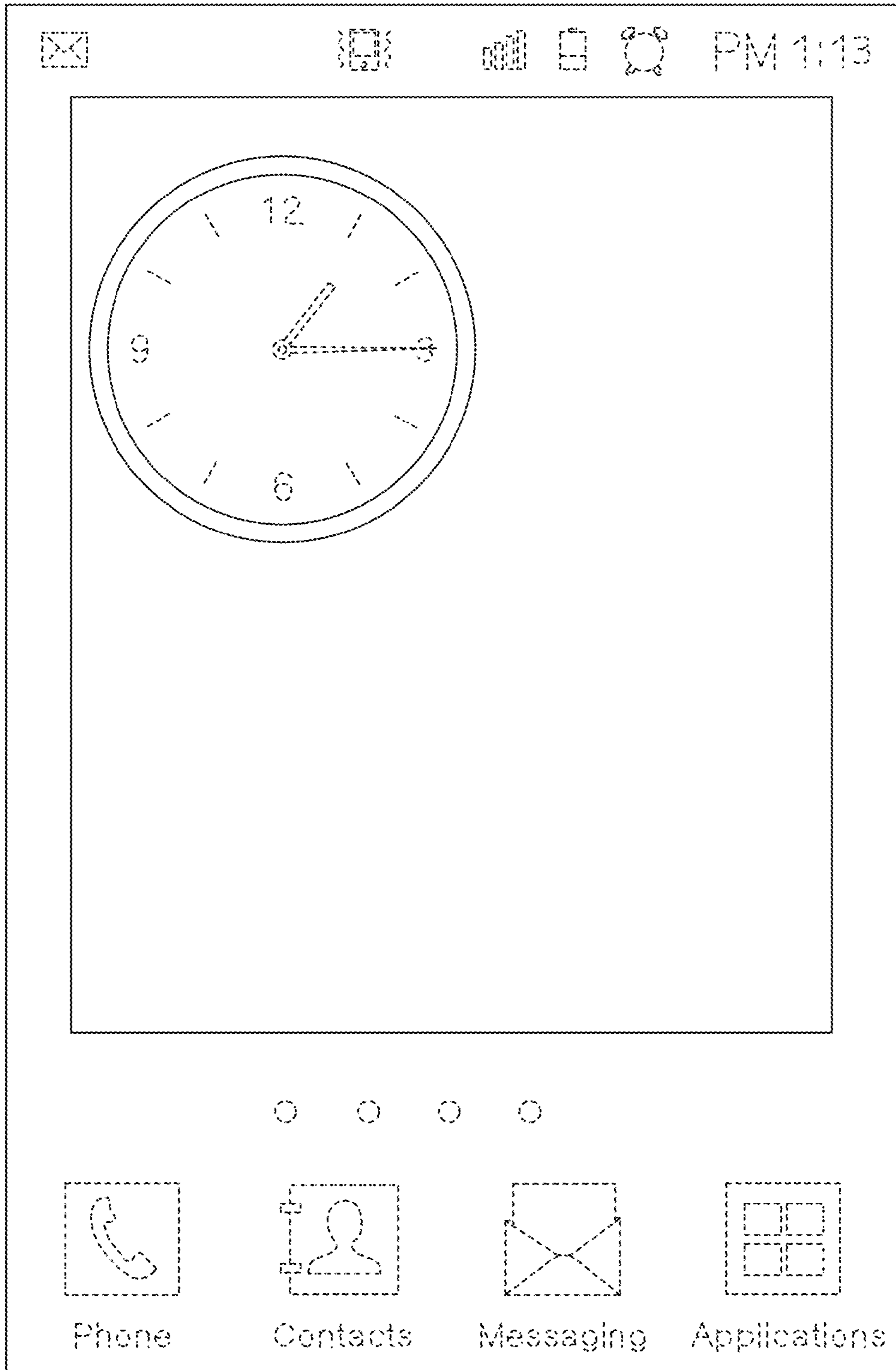
