The ornamental design for a display screen or portion thereof with icon, as shown and described.

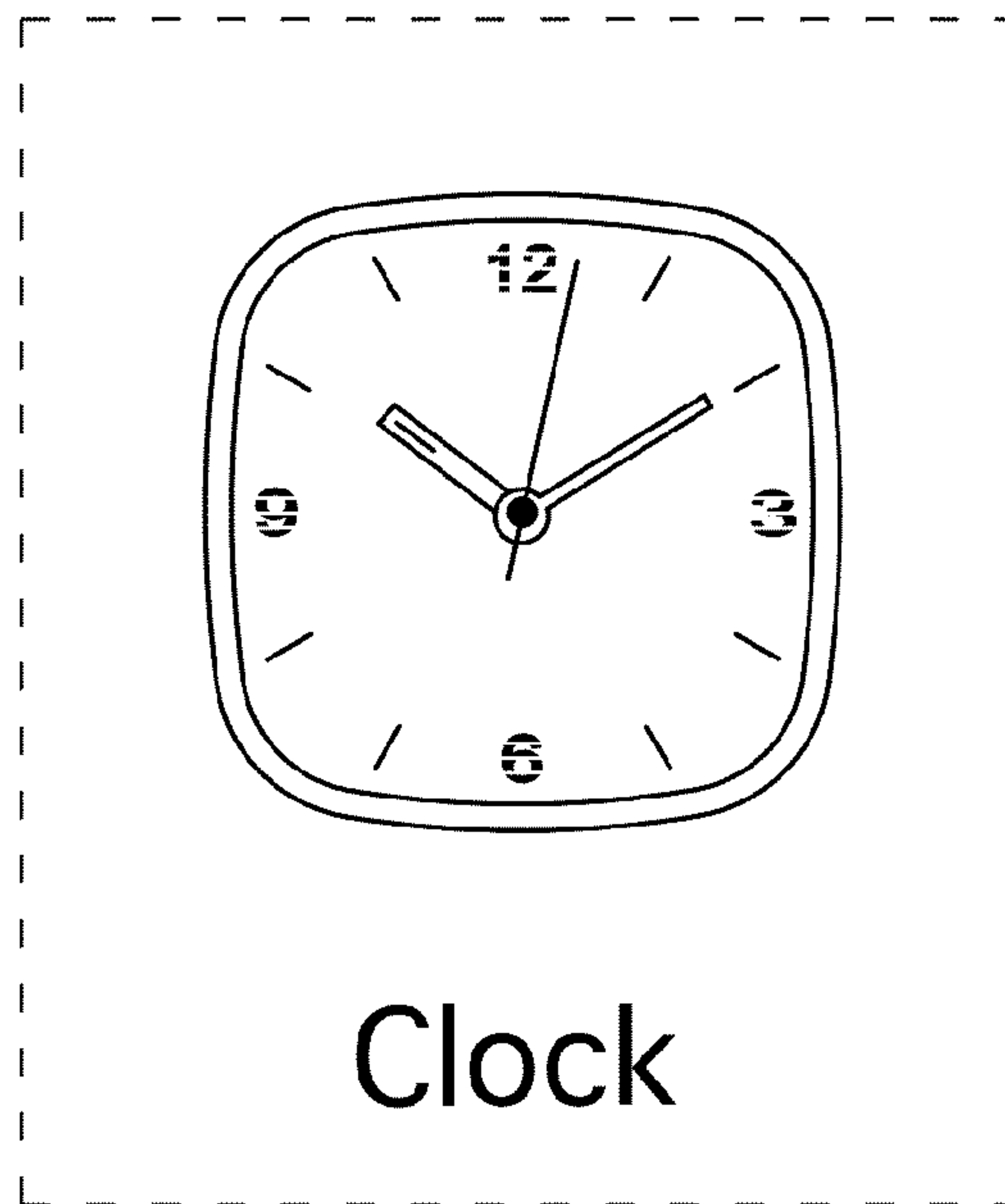
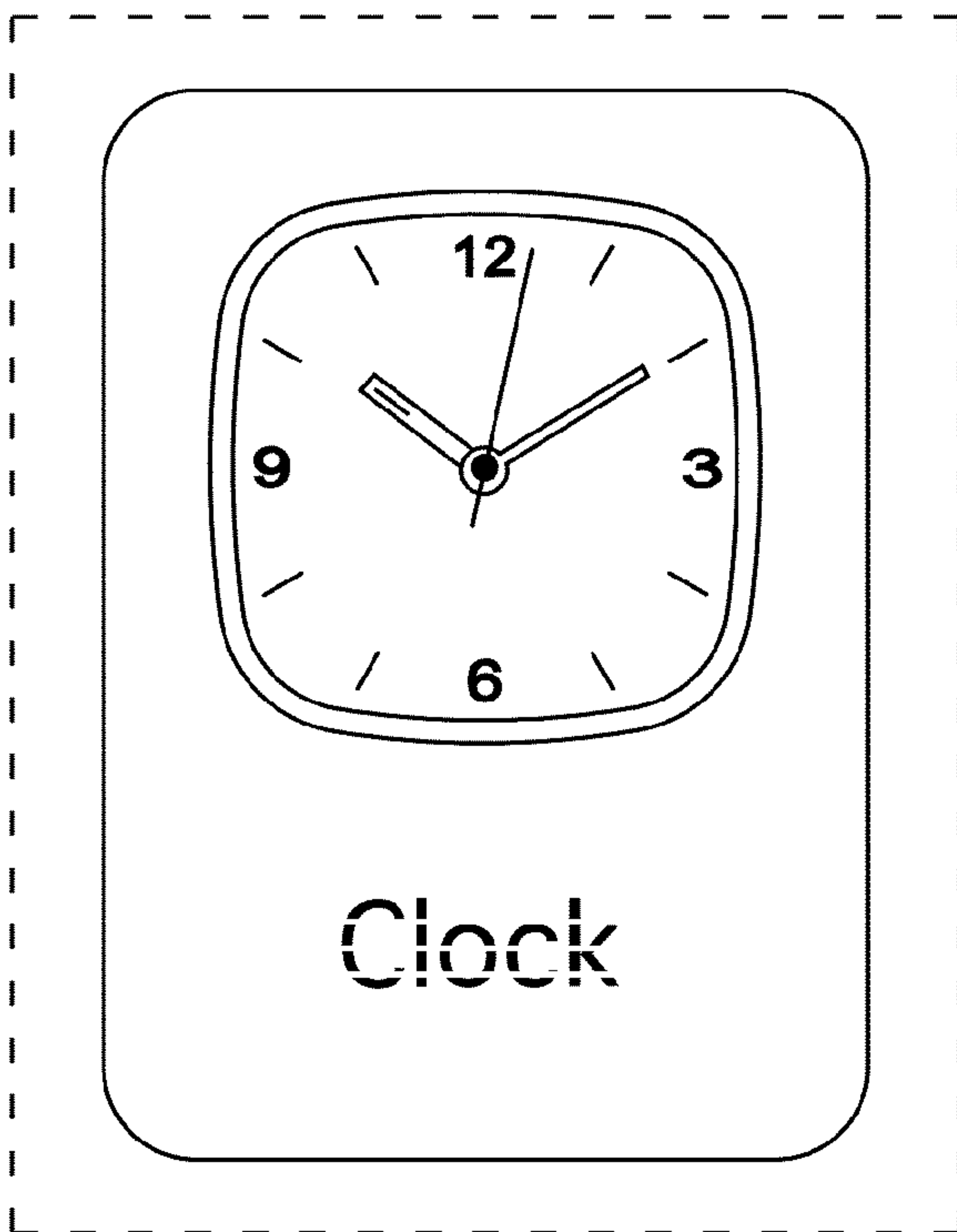
**DESCRIPTION**

FIG. 1 is a view of the display screen or portion thereof with icon; and,

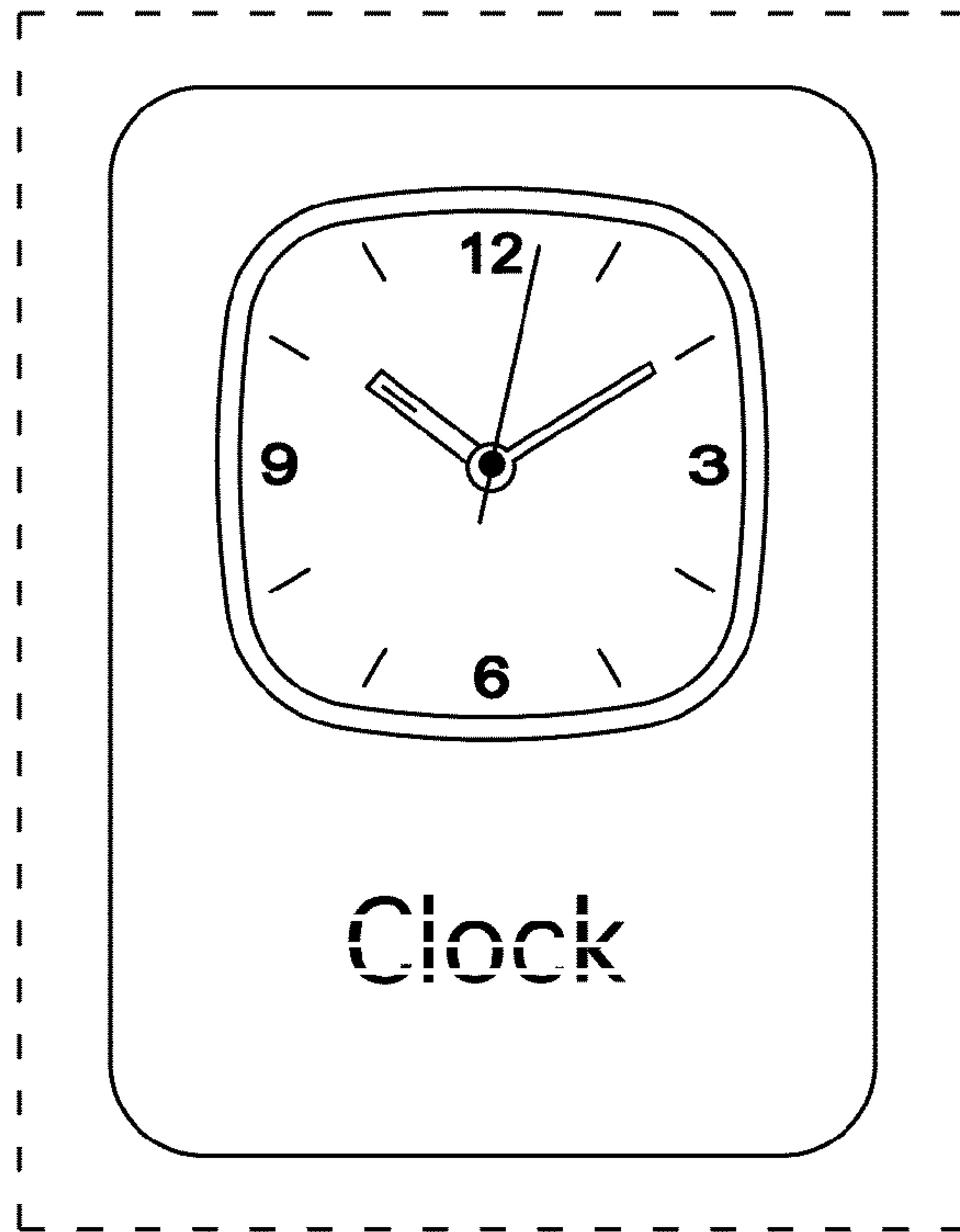

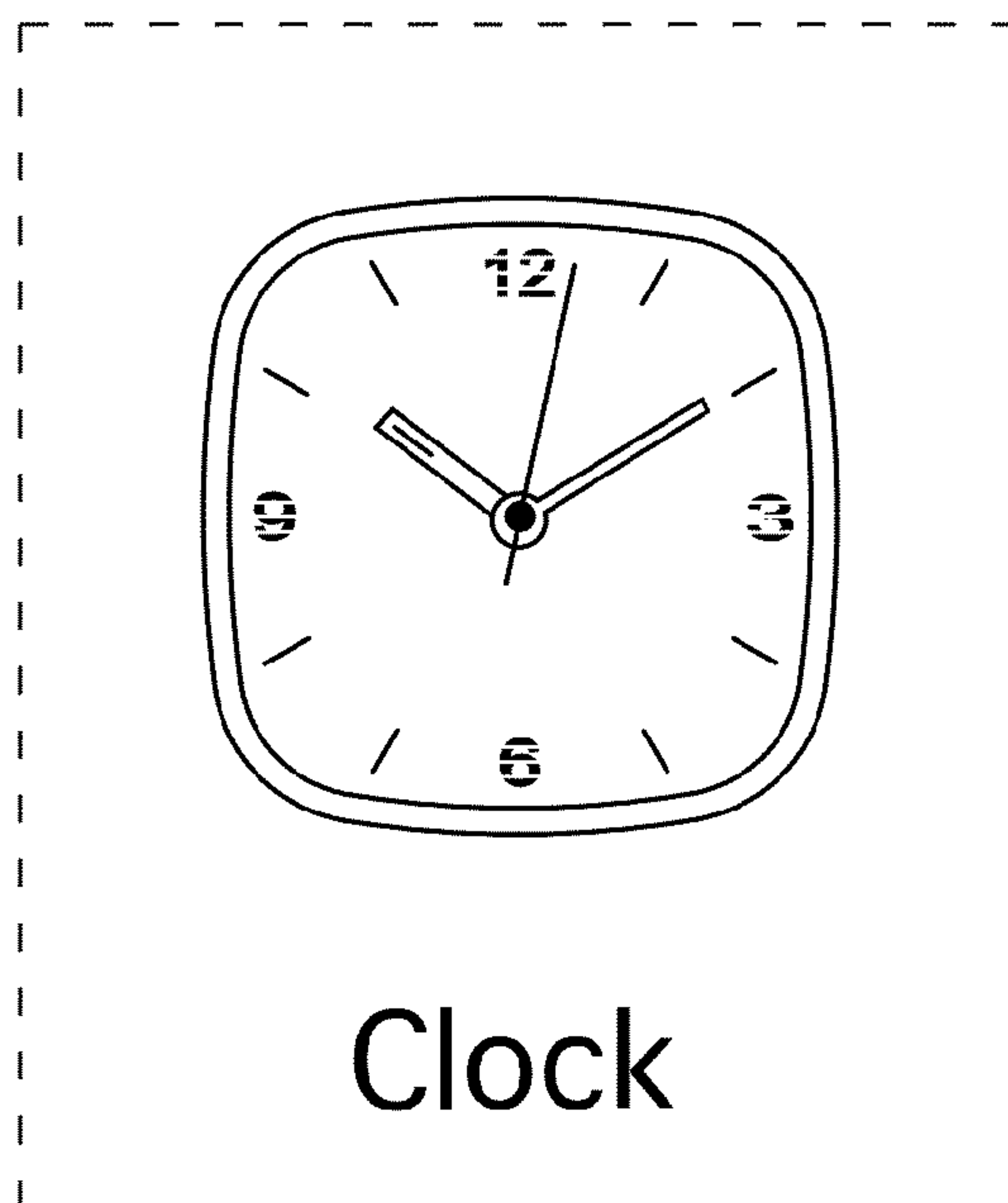
