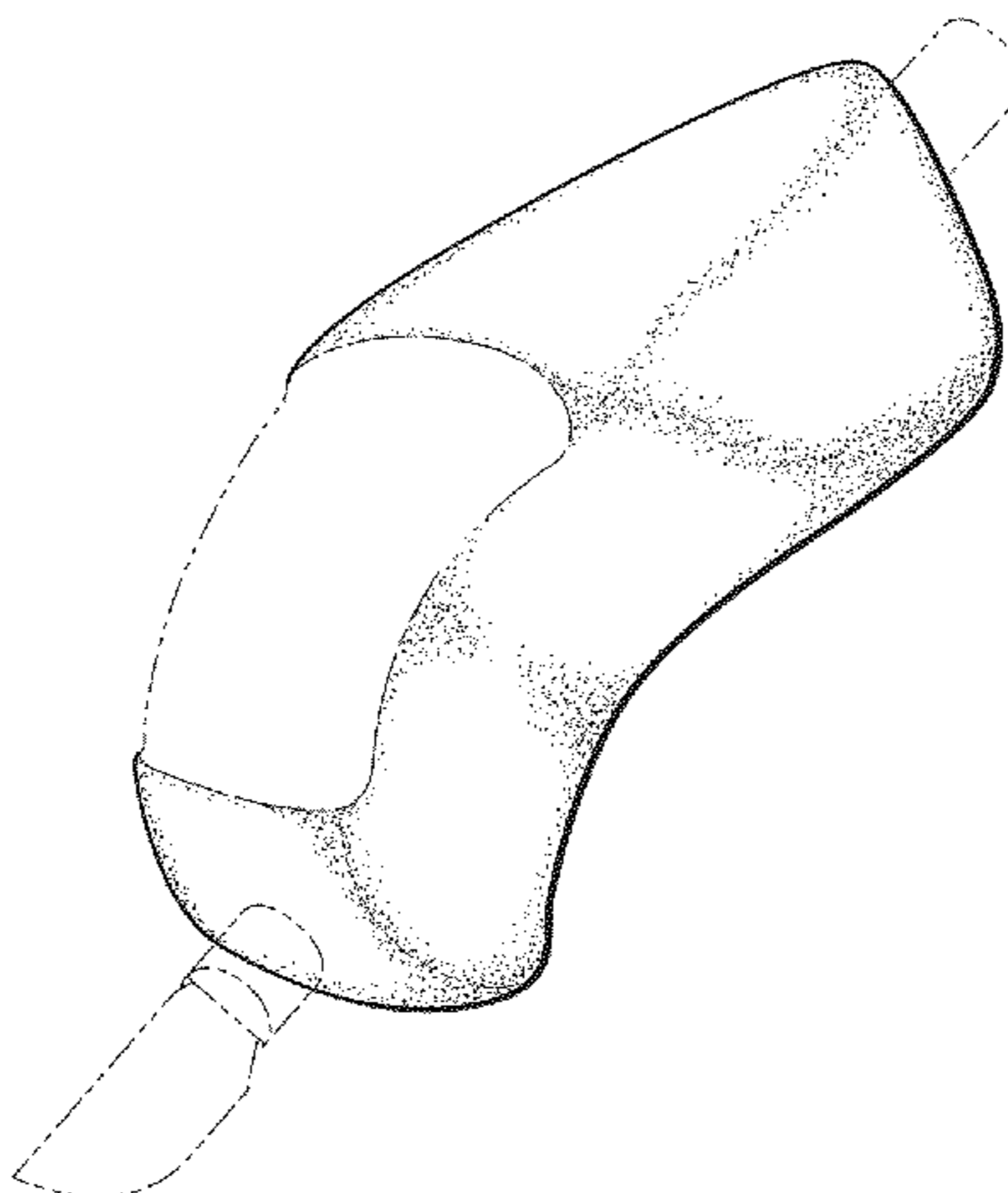
(57) **CLAIM**

The ornamental design for an ergonomic handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of my invention;

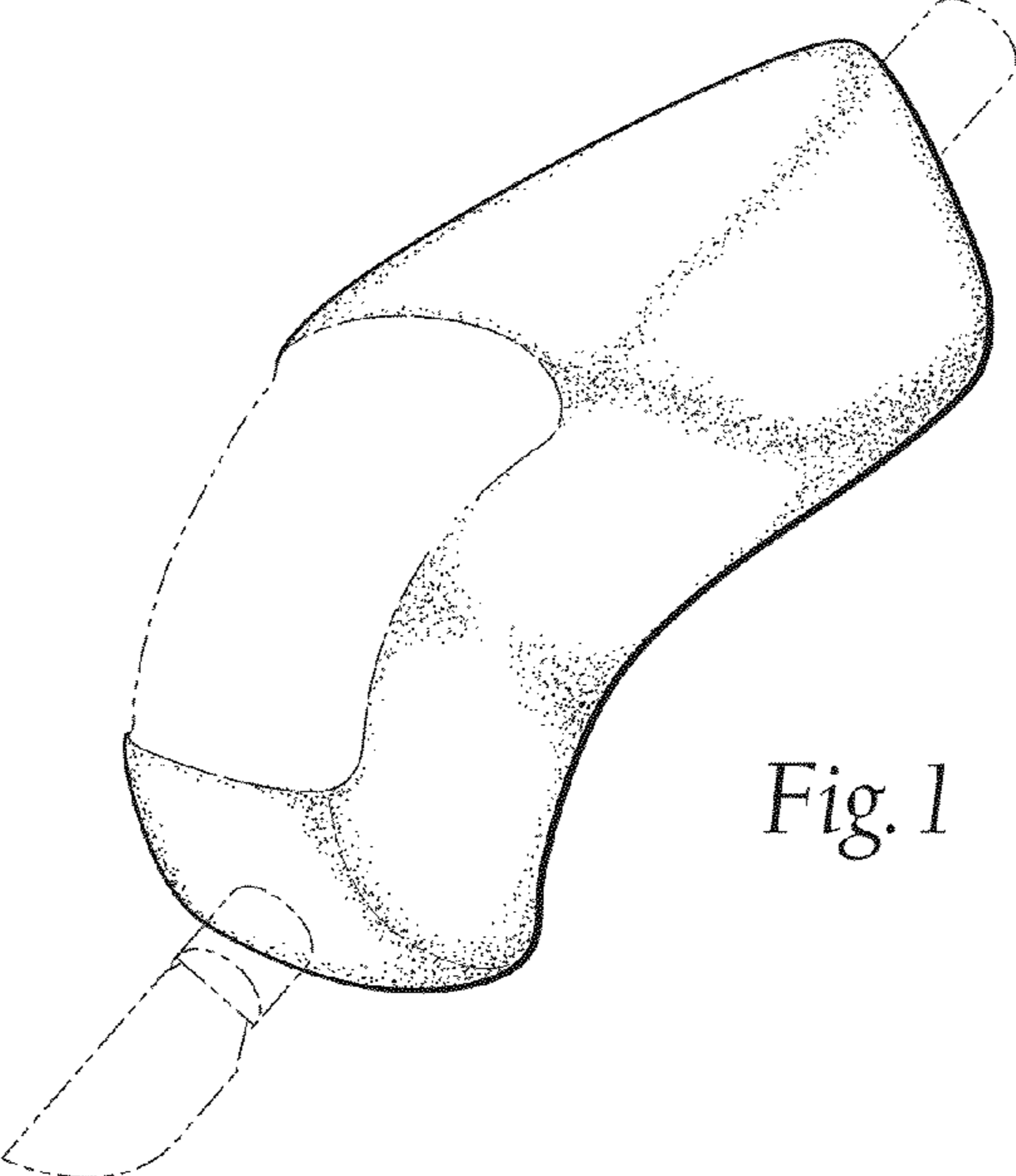

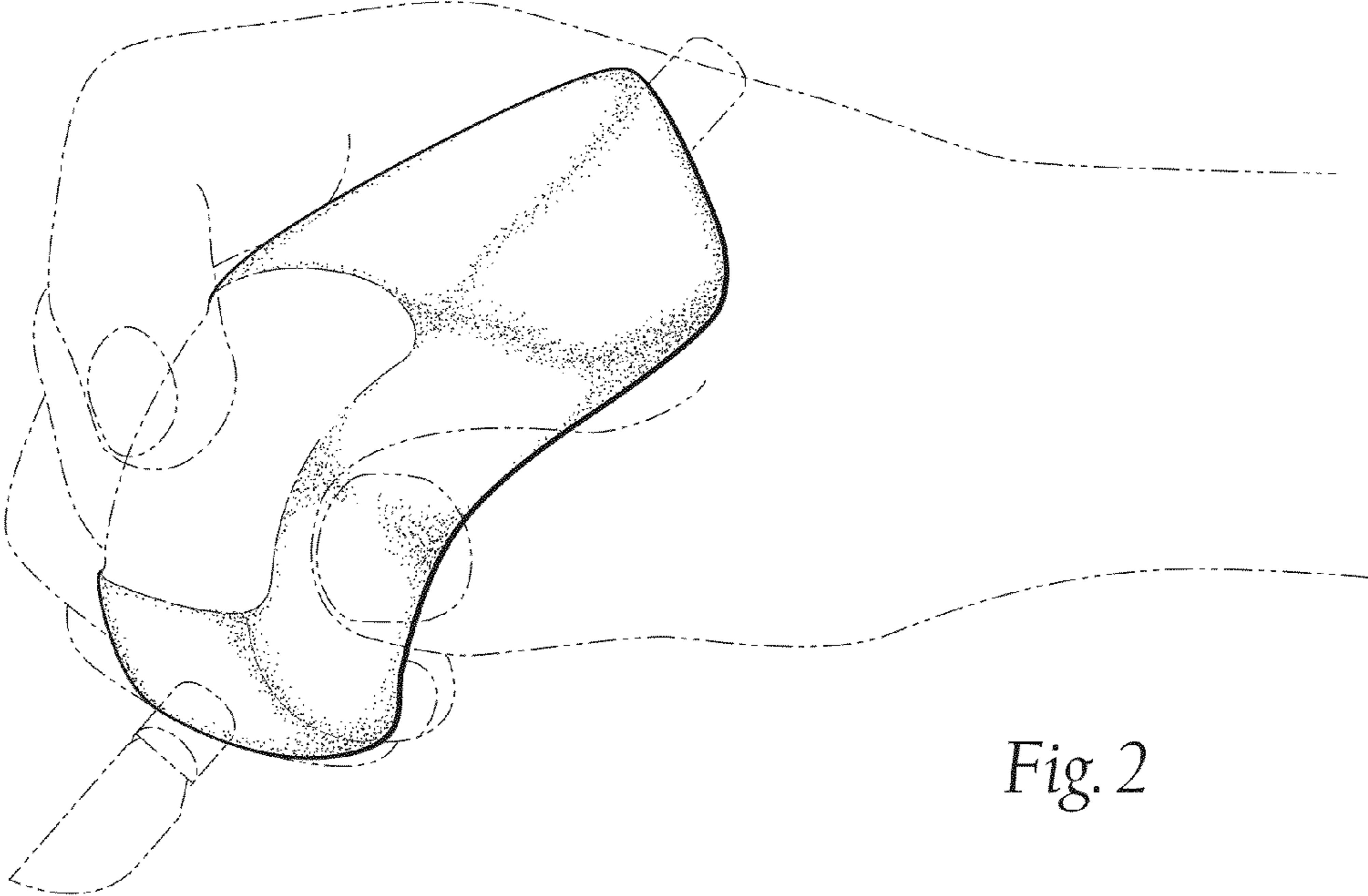

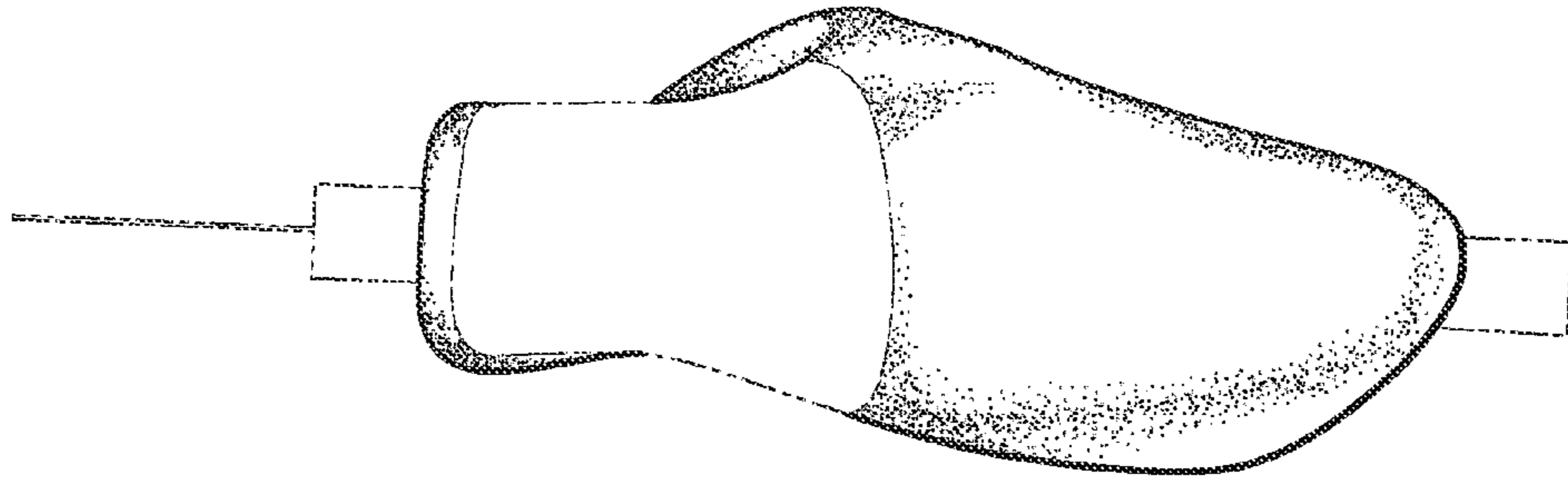

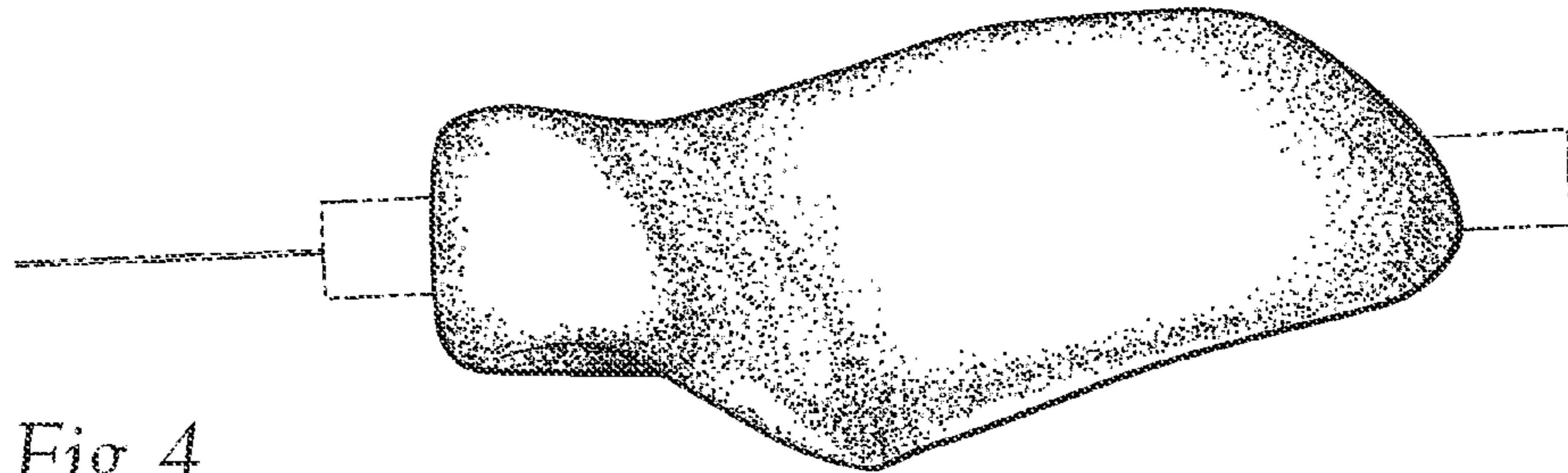

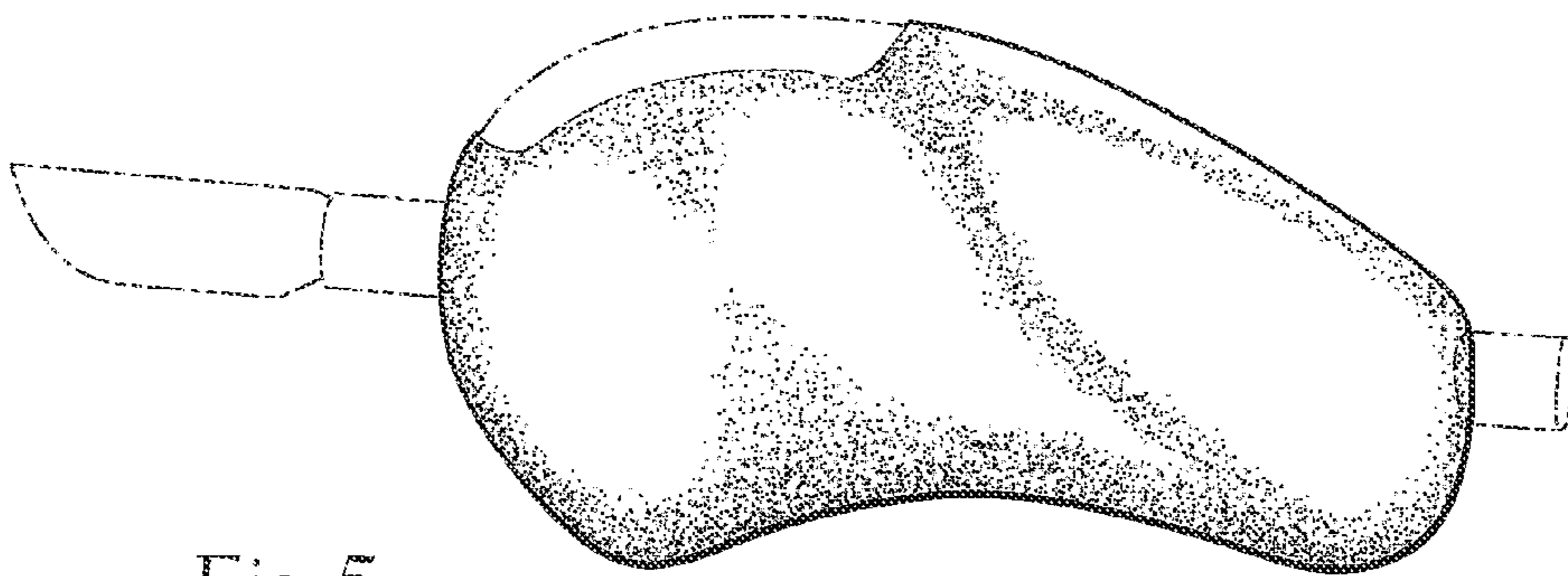

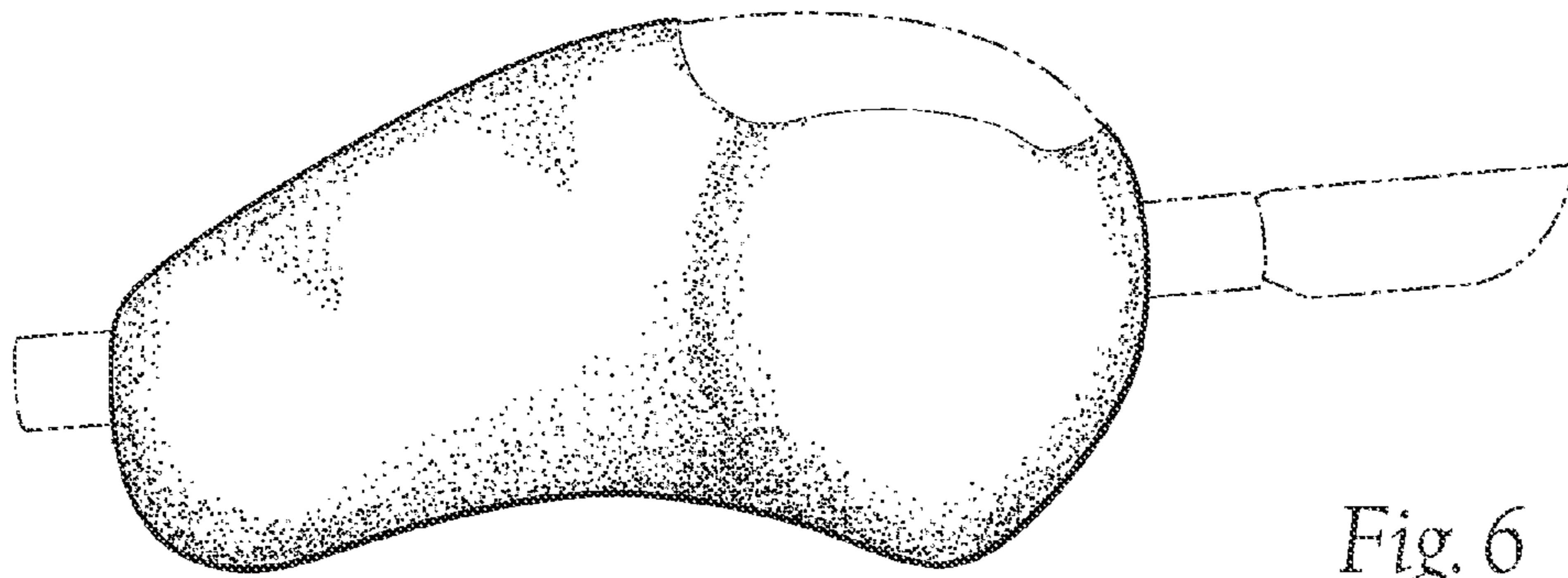

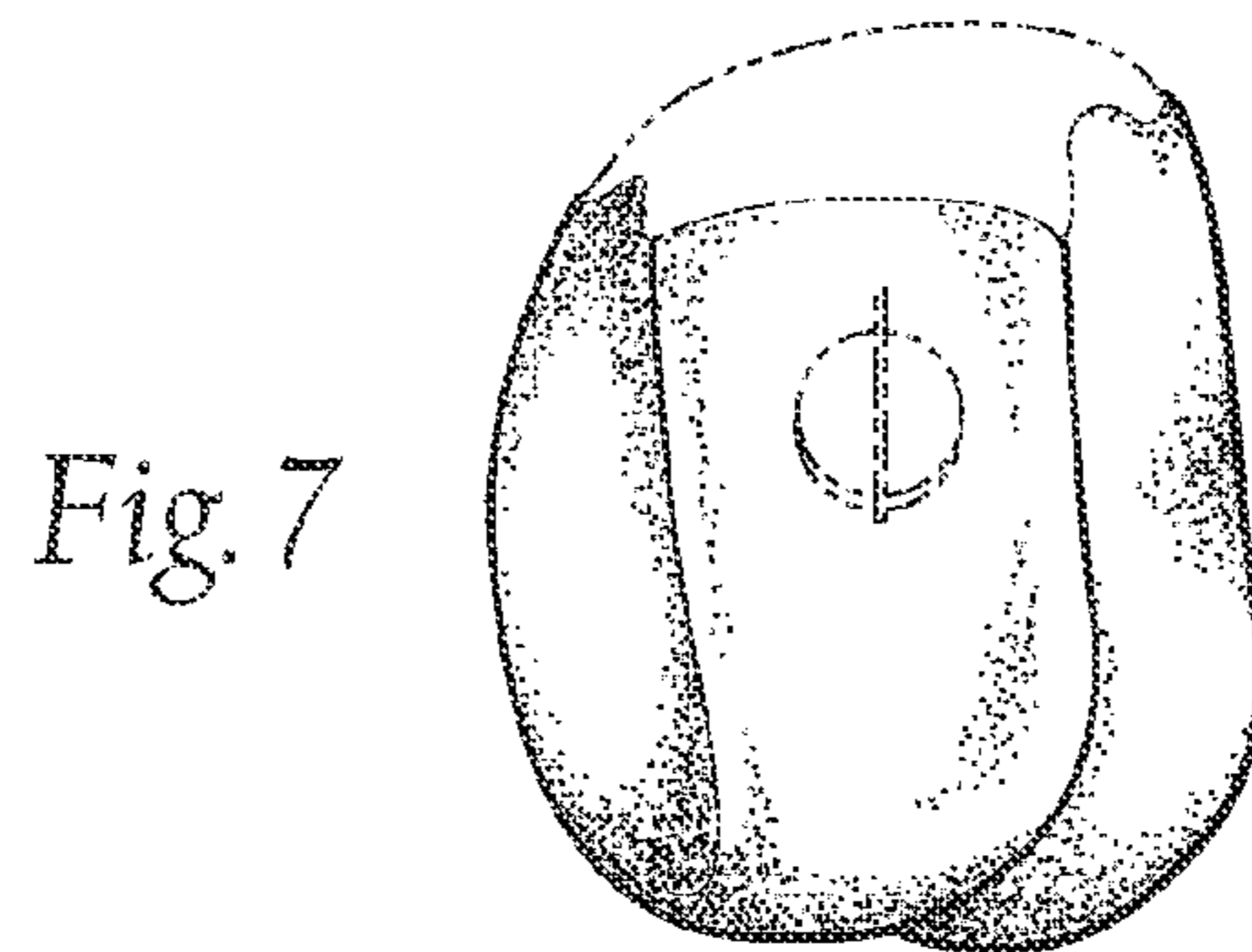

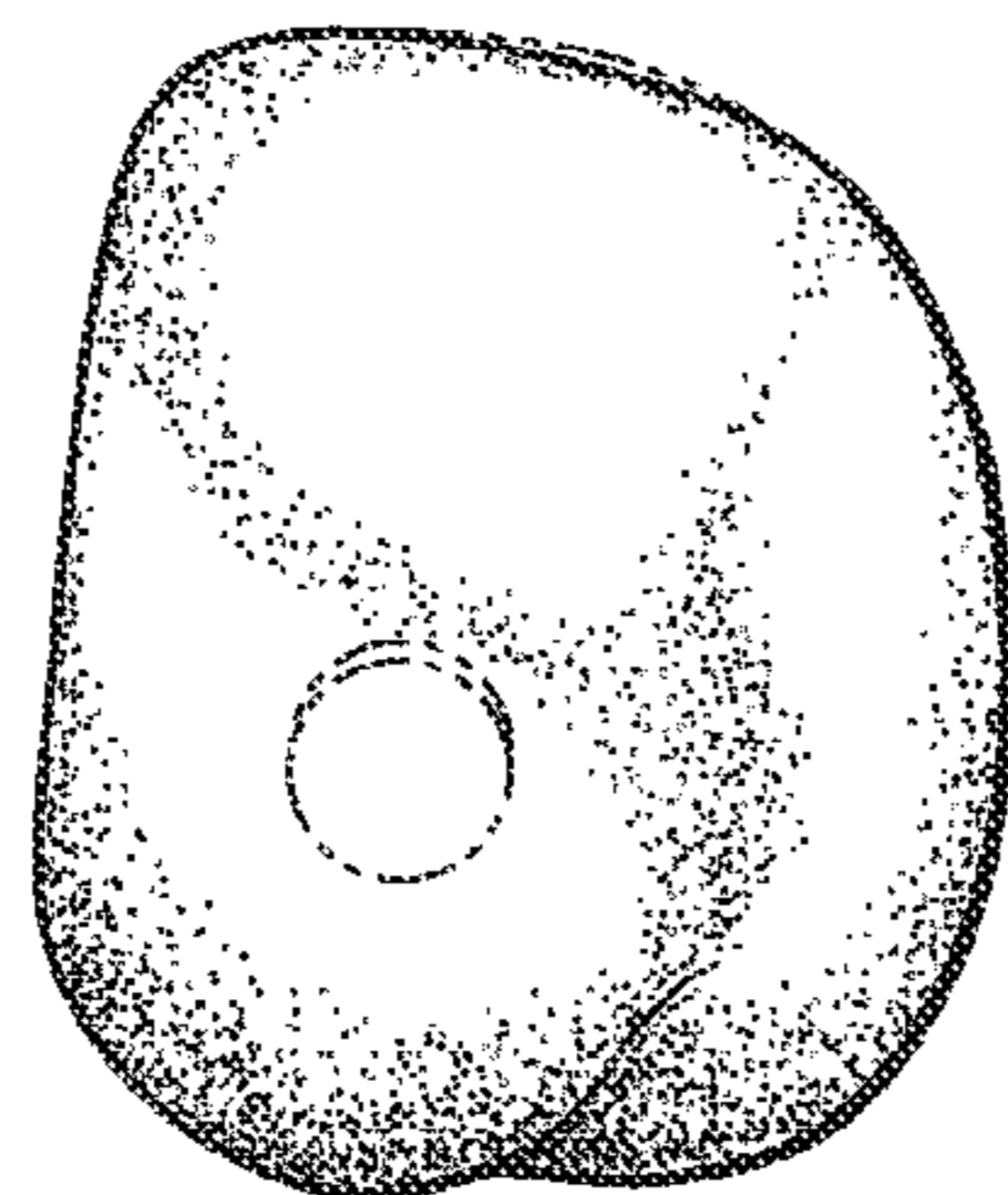

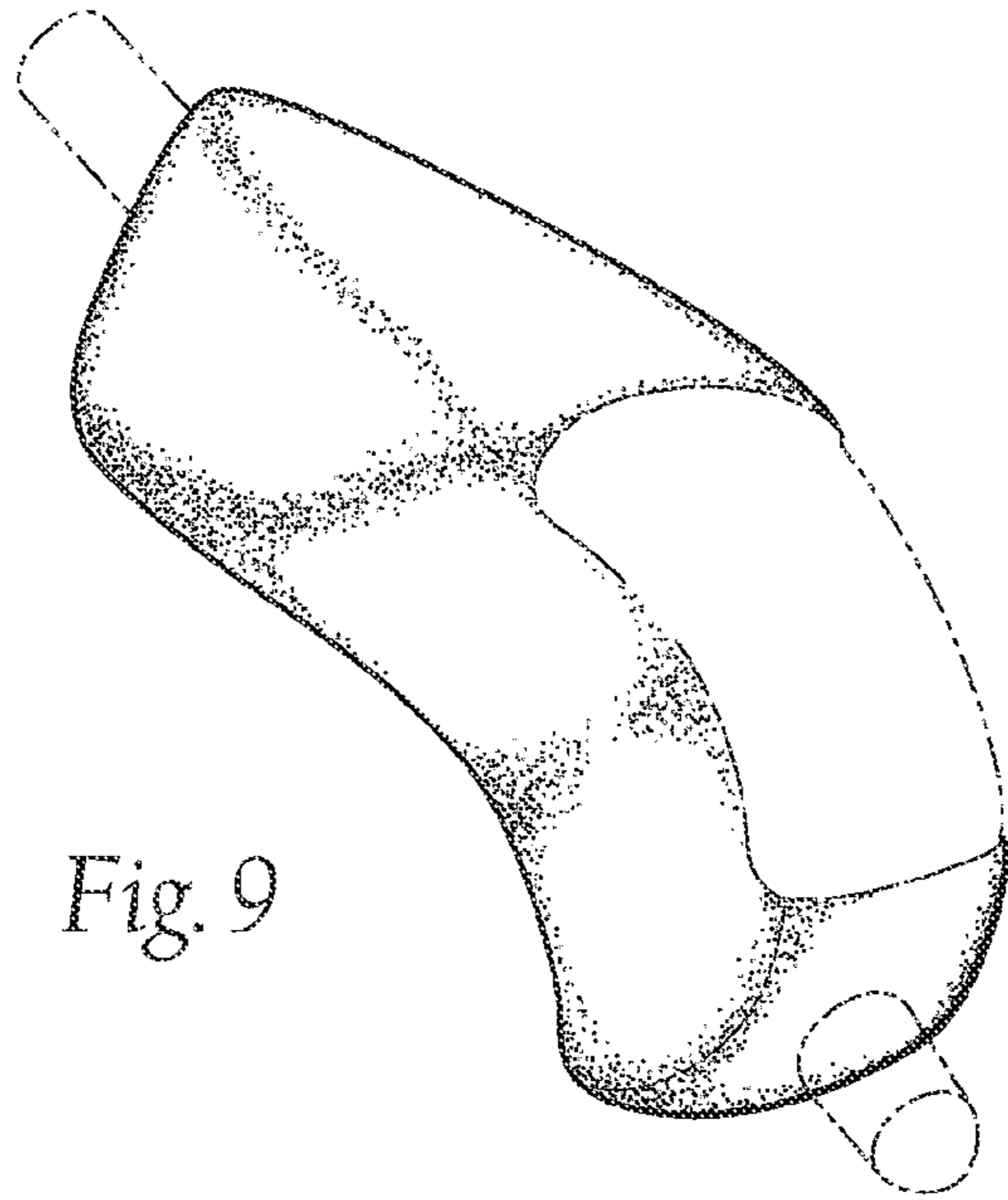

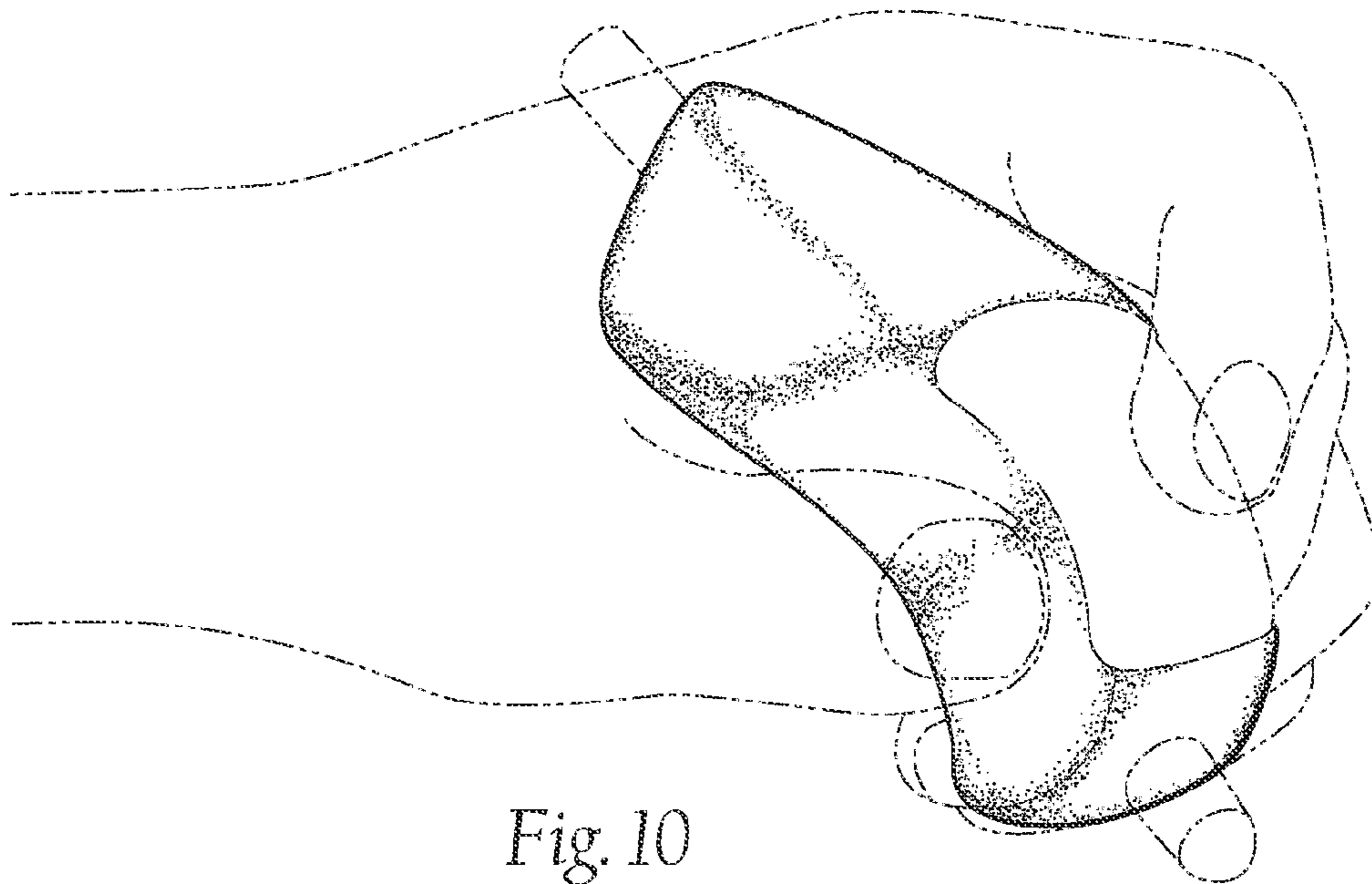

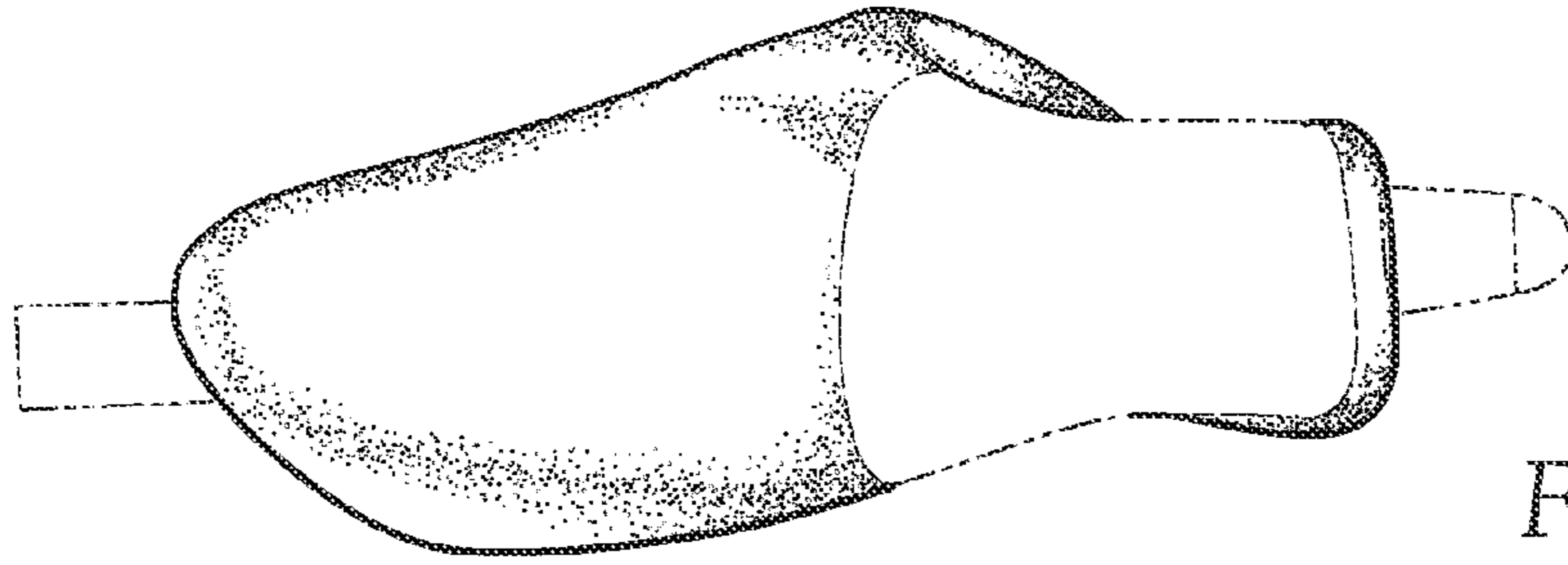

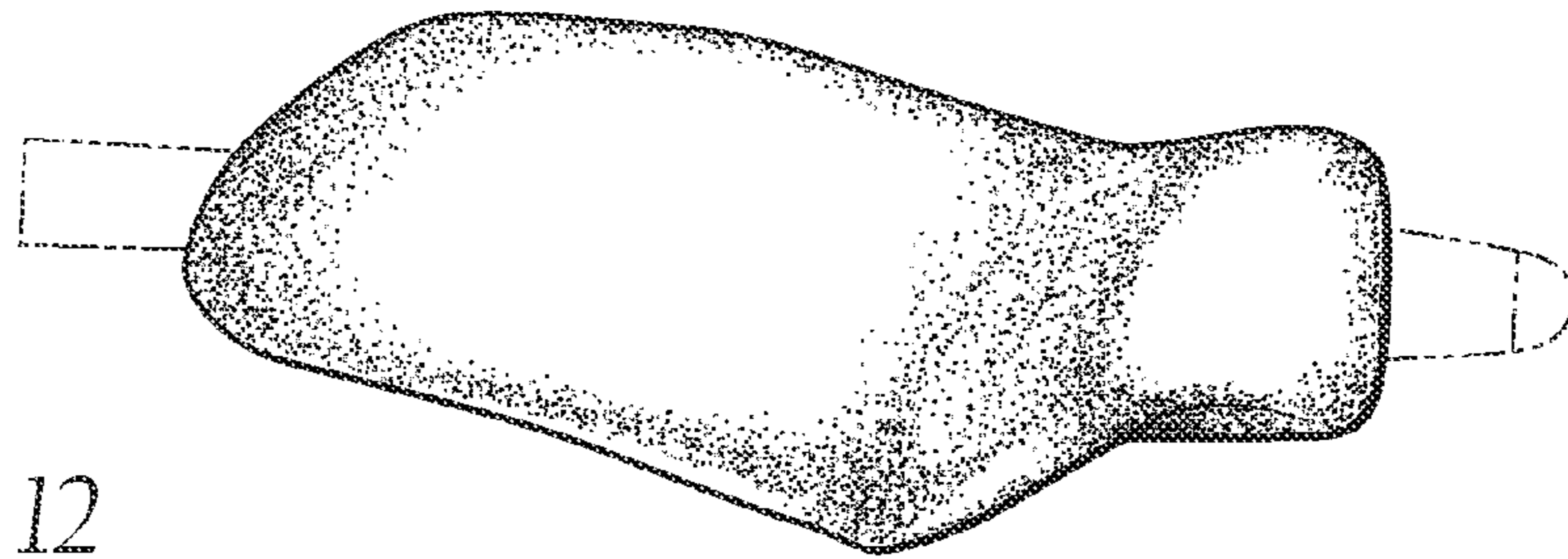

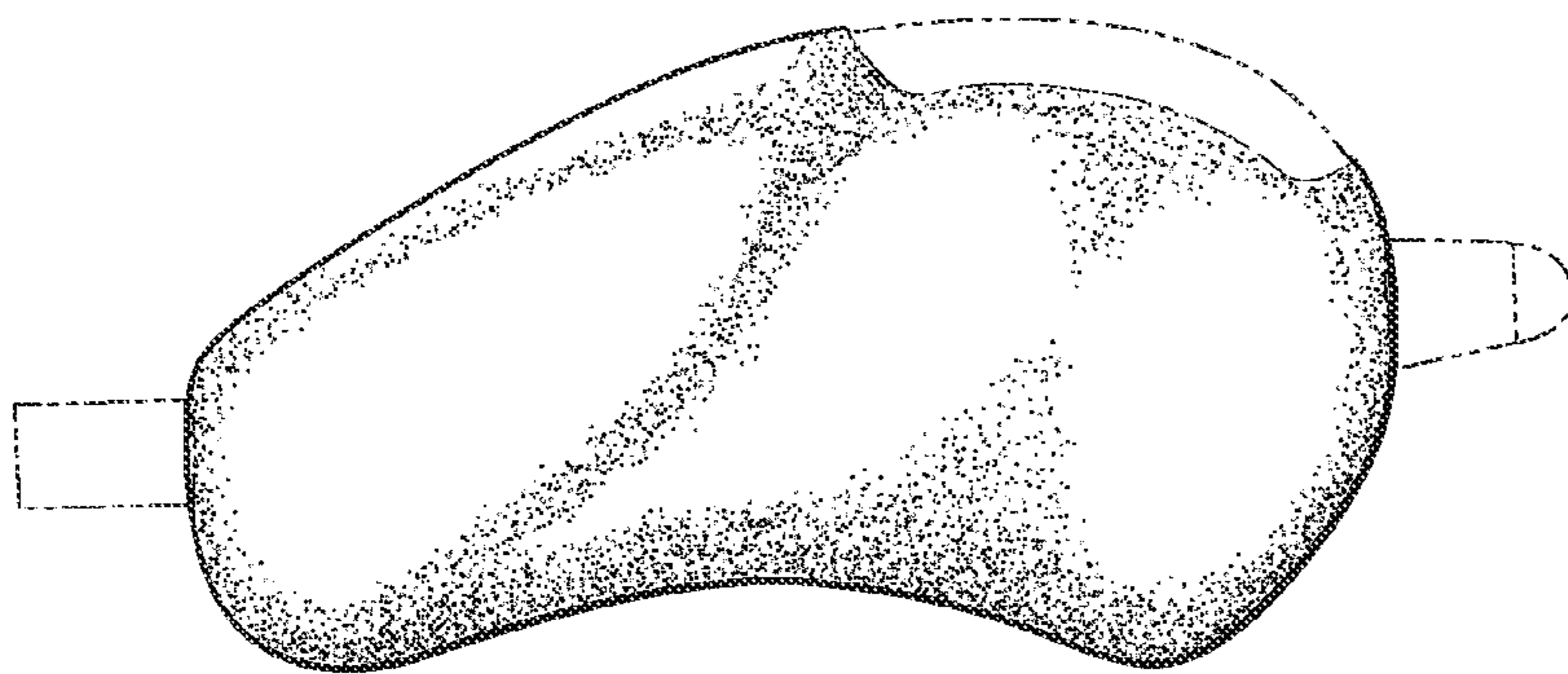

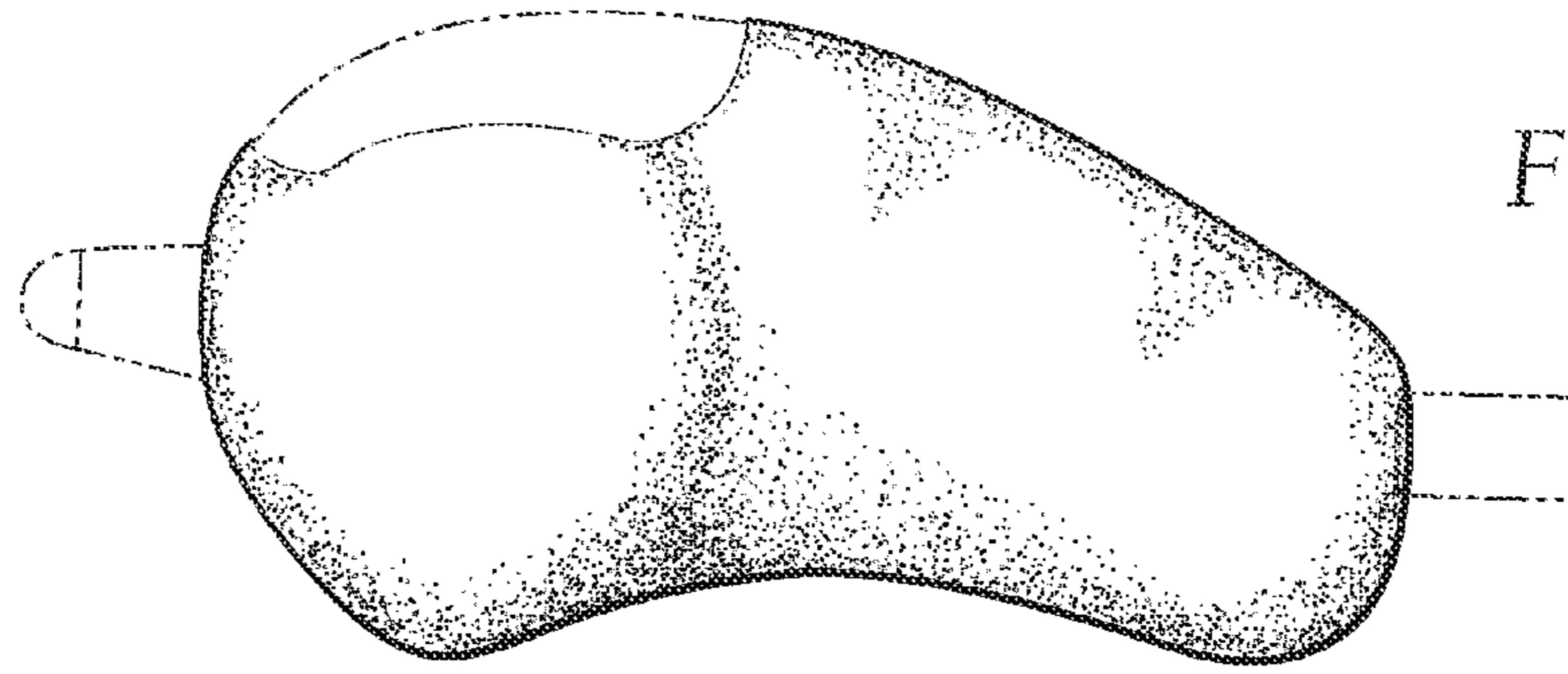

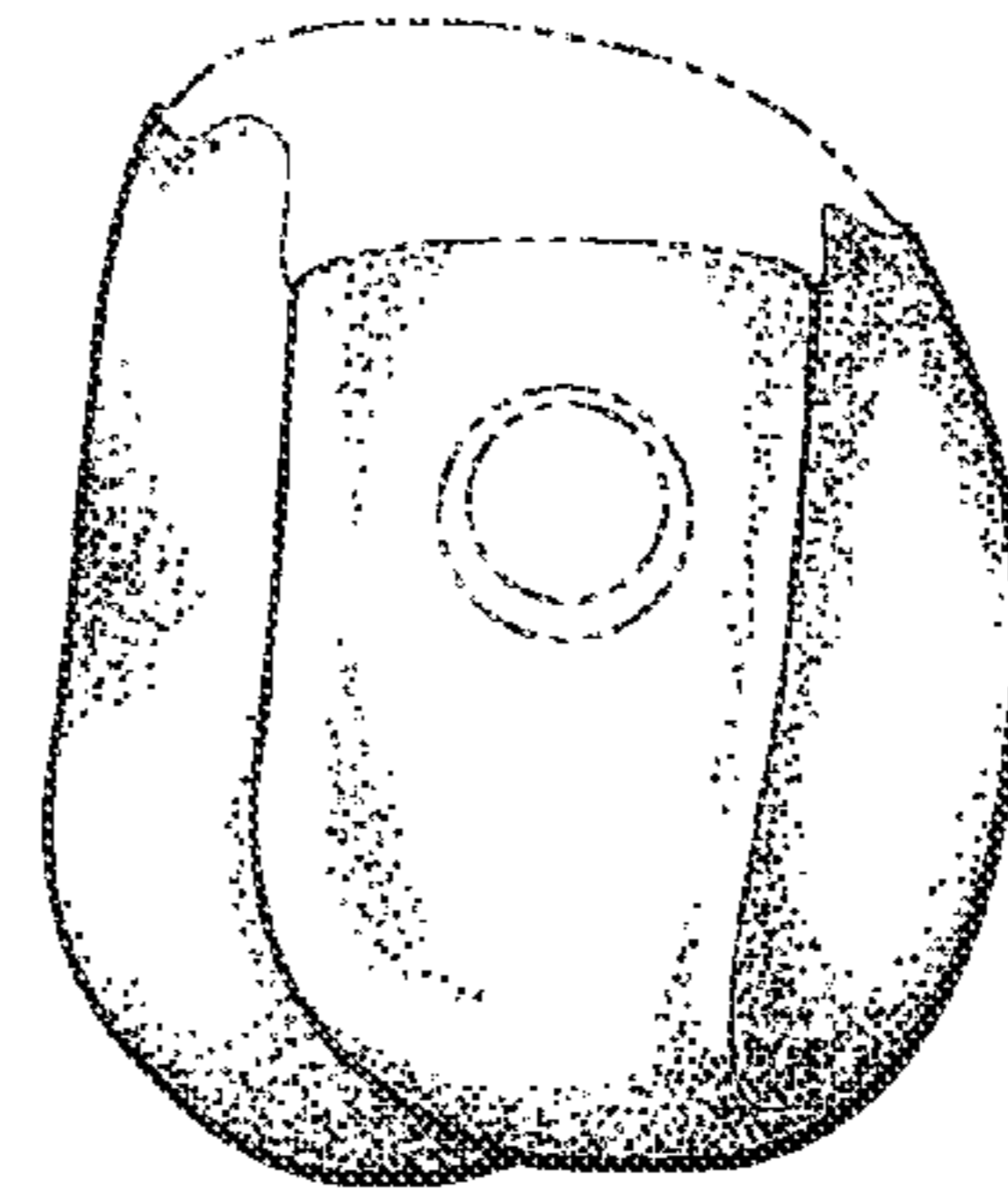

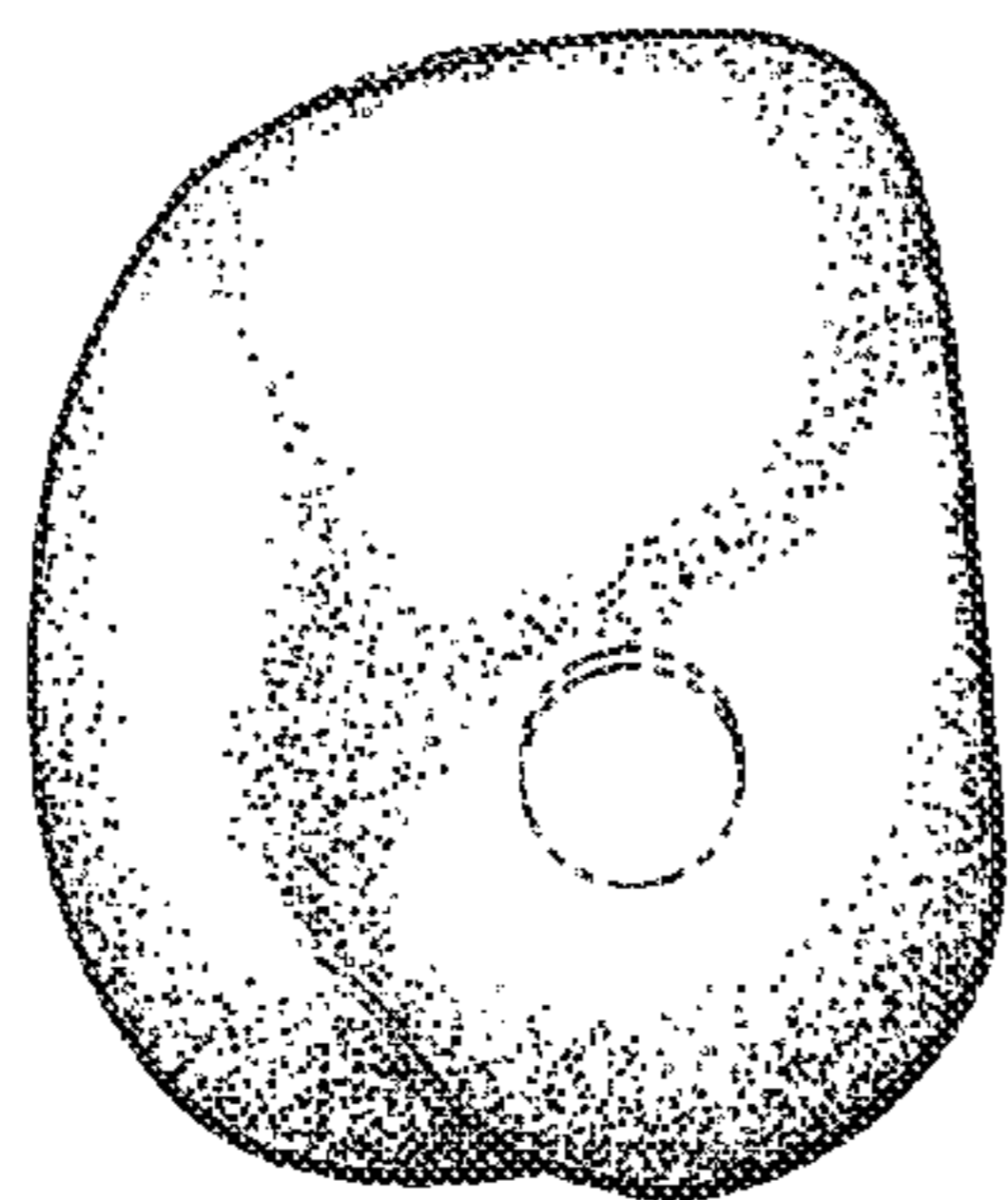
