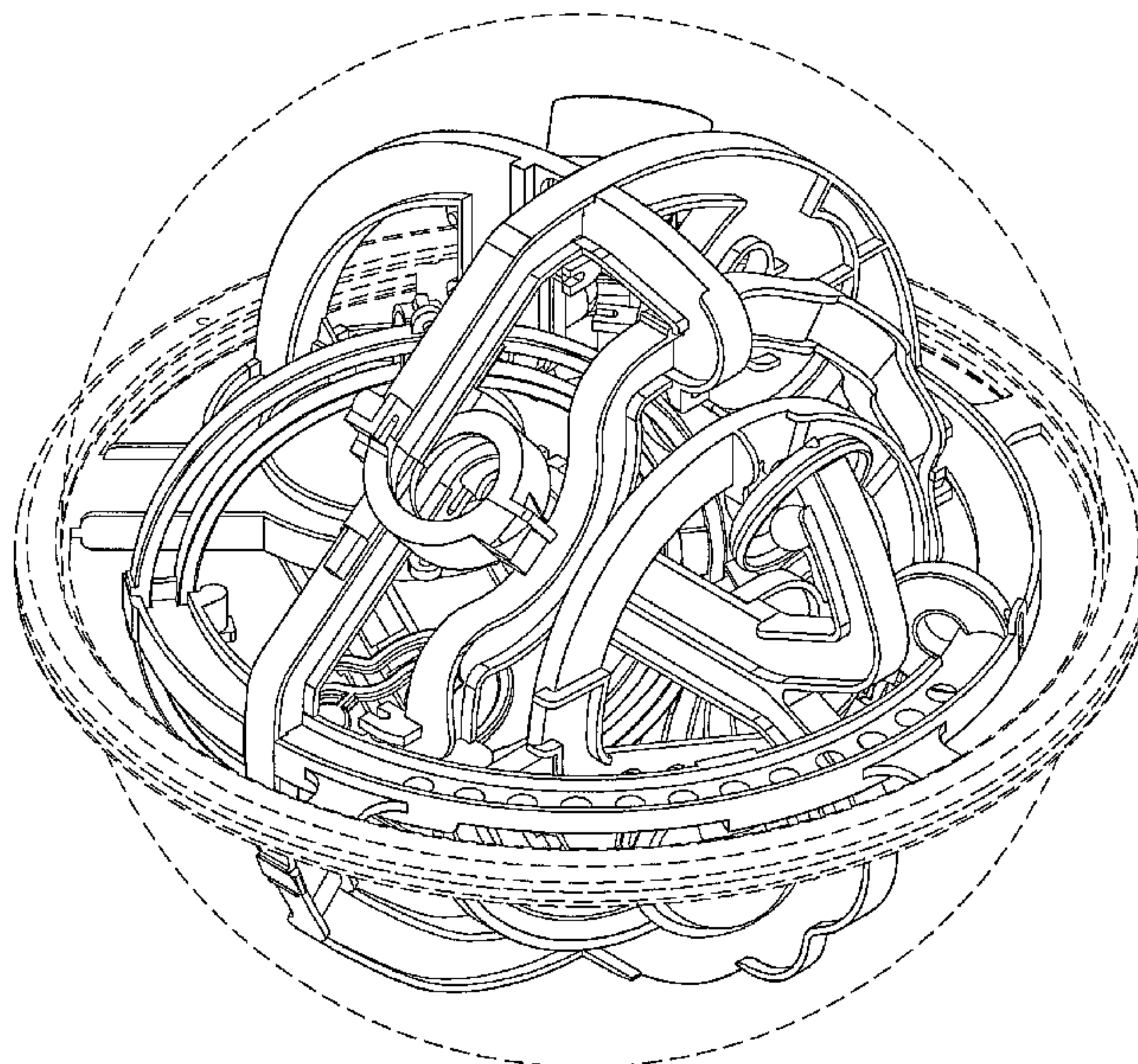
(57) **CLAIM**

I claim the ornamental design for a maze game, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, left perspective view of a maze game.
FIG. 2 is a bottom, left, front perspective view of the maze game.
FIG. 3 is a front elevation view of the maze game.
FIG. 4 is a right side view of the maze game.
FIG. 5 is a left side view of the maze game.
FIG. 6 is a rear view of the maze game.

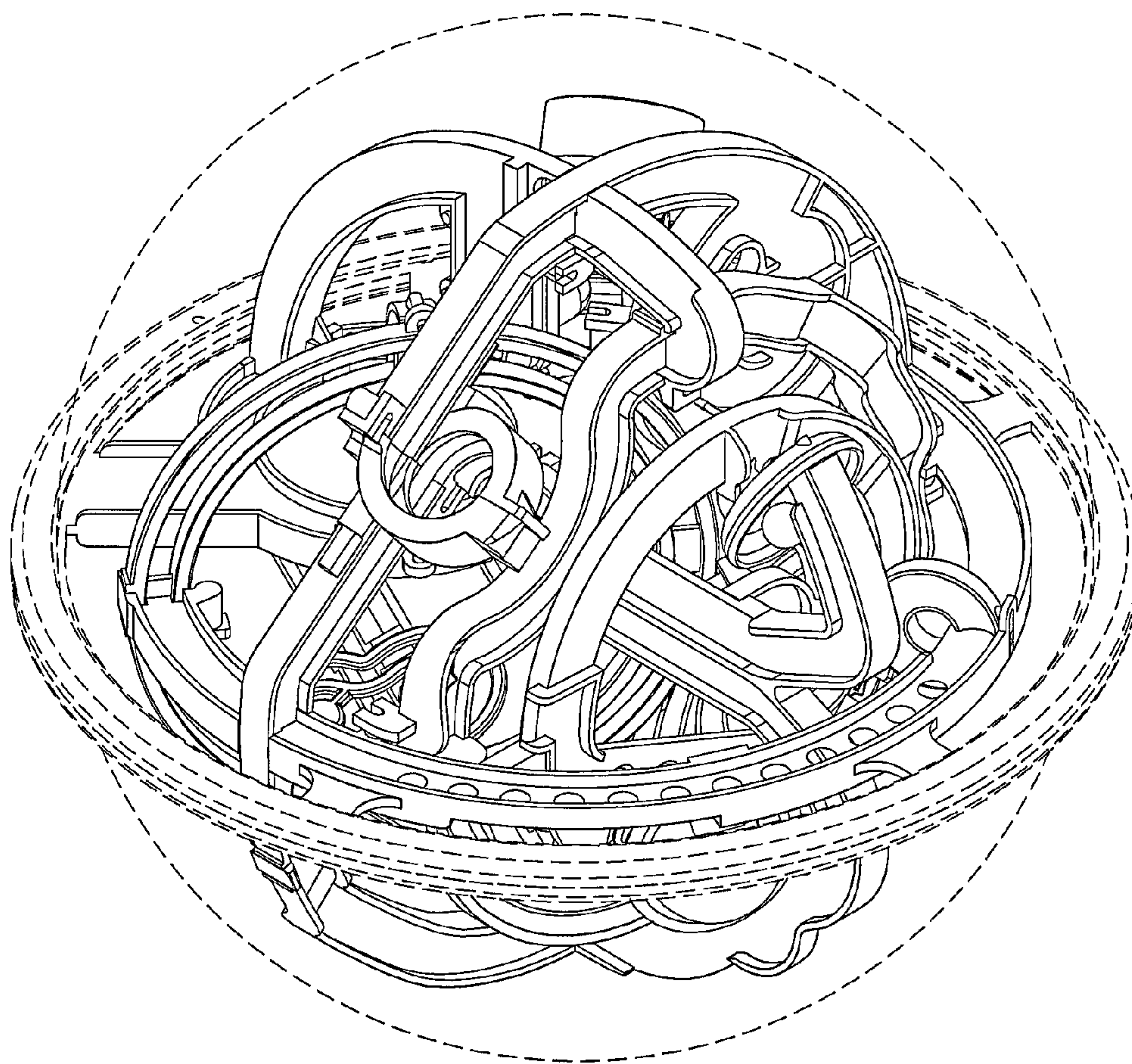

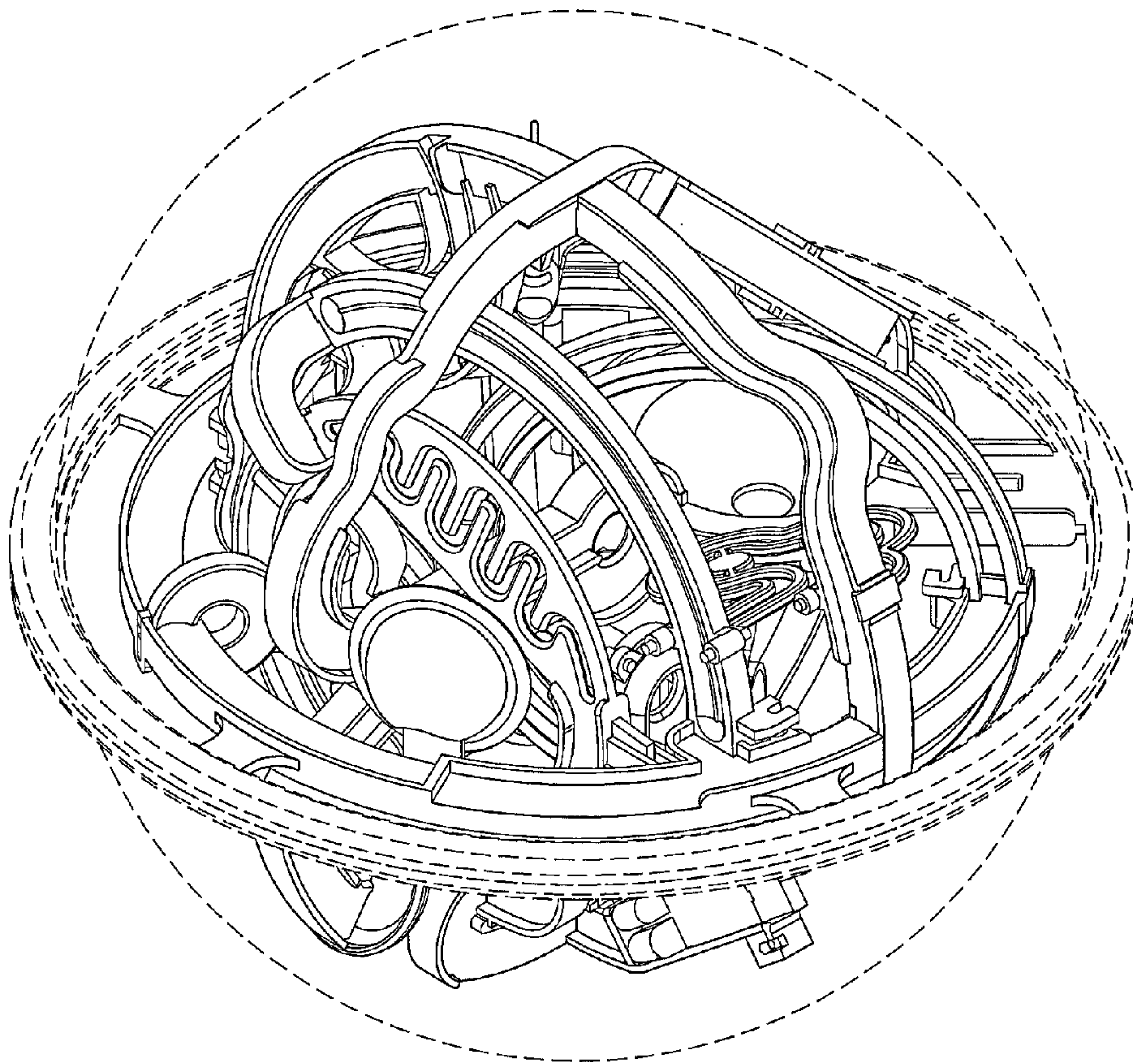

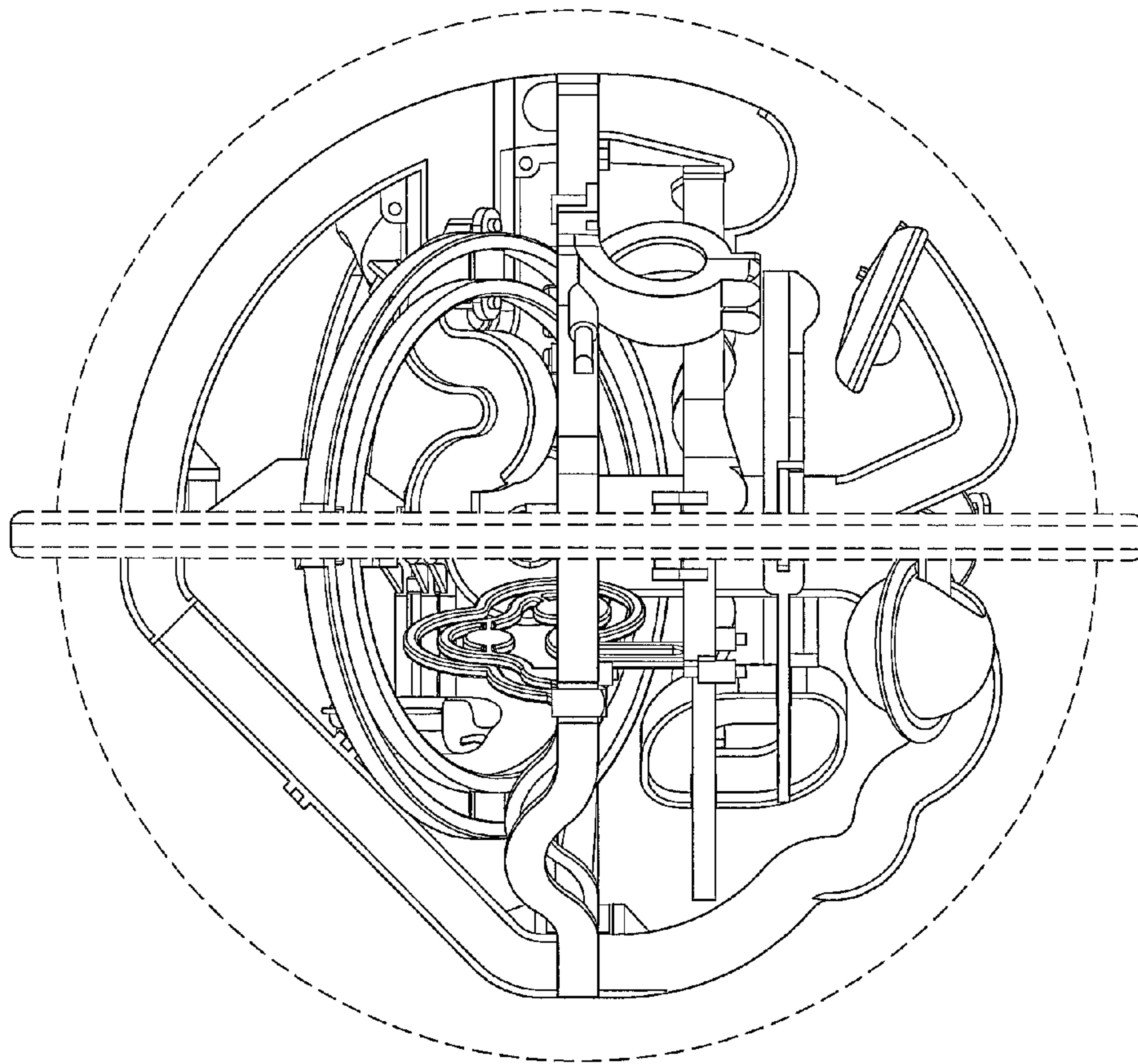

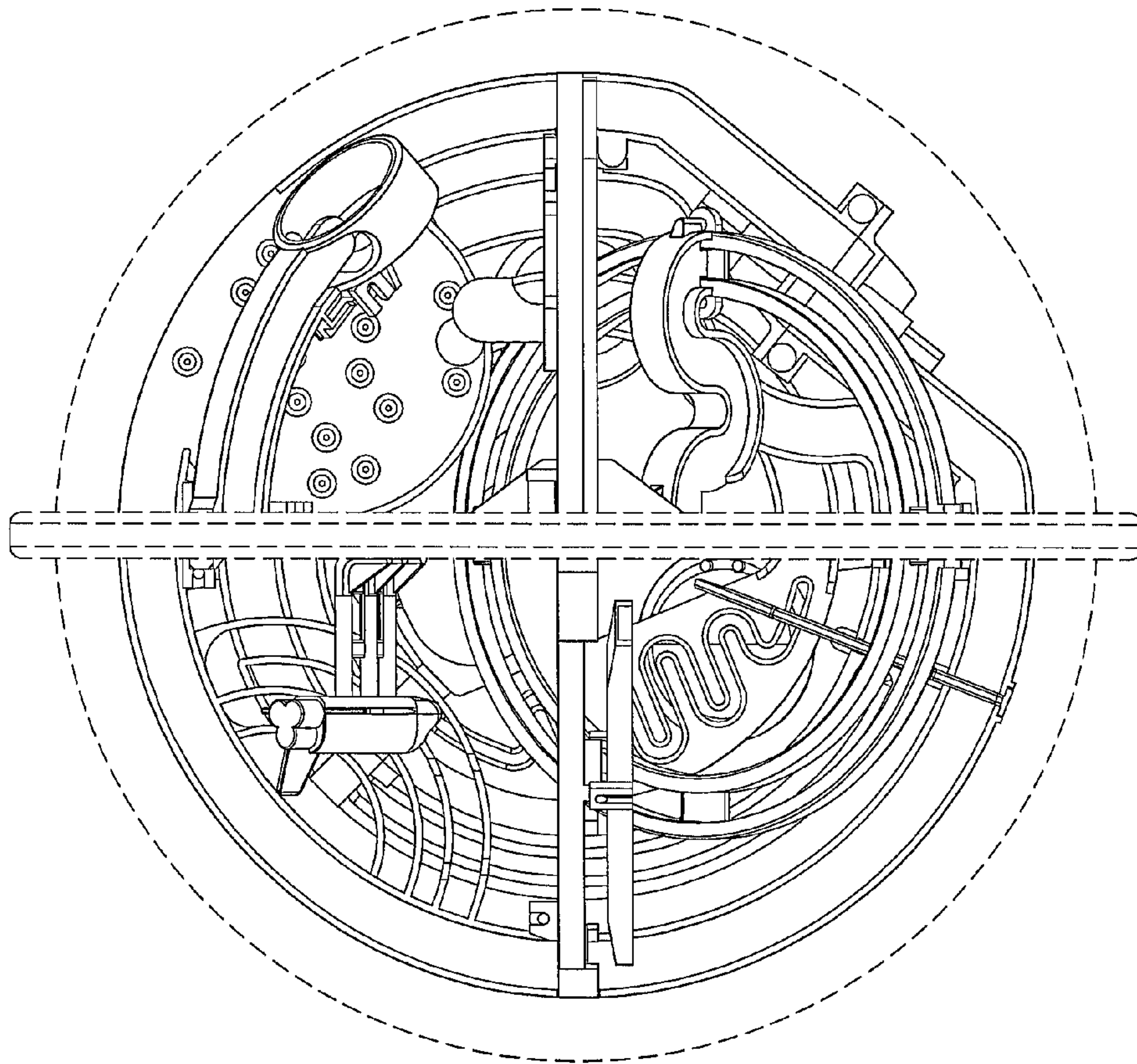

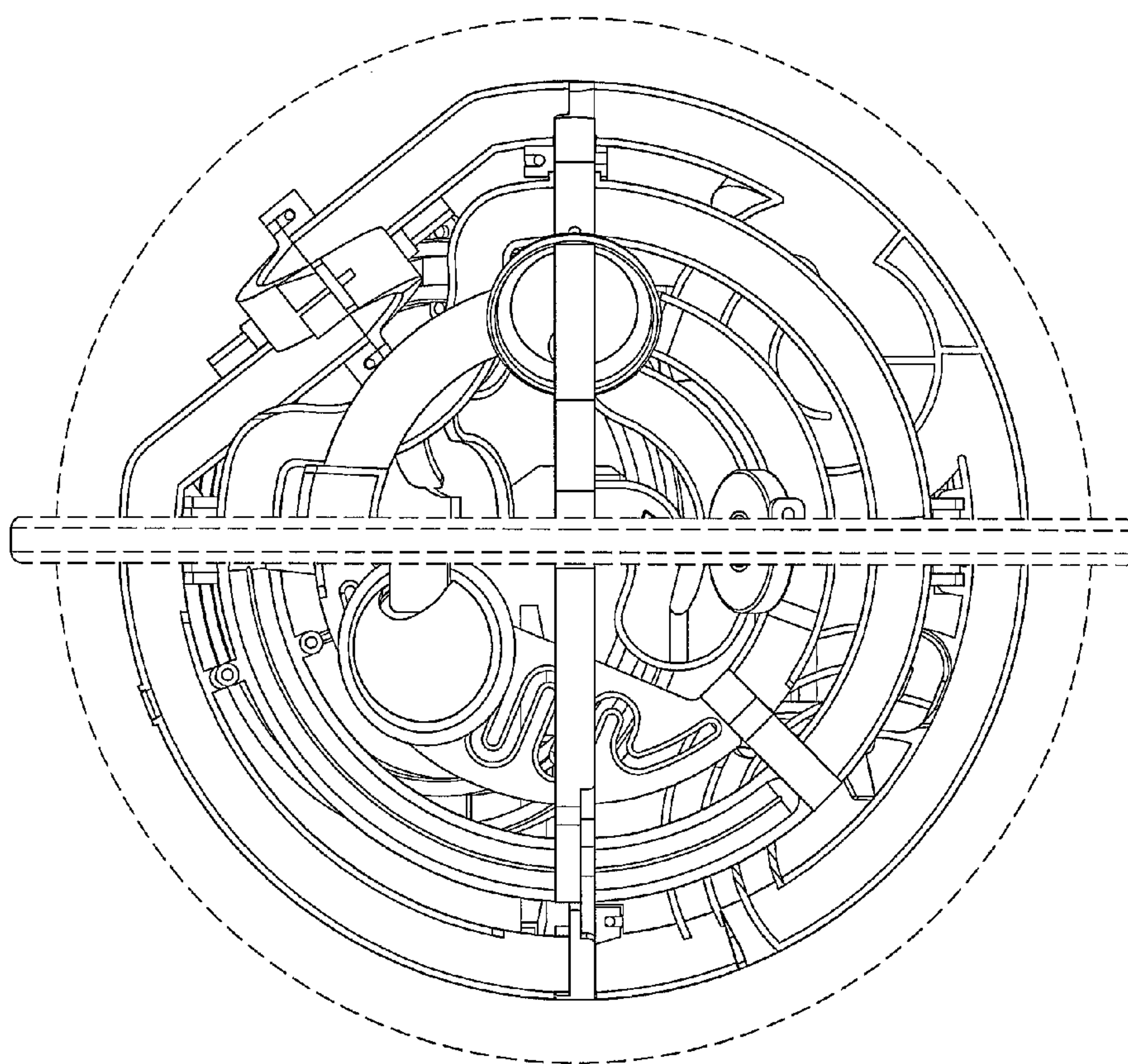

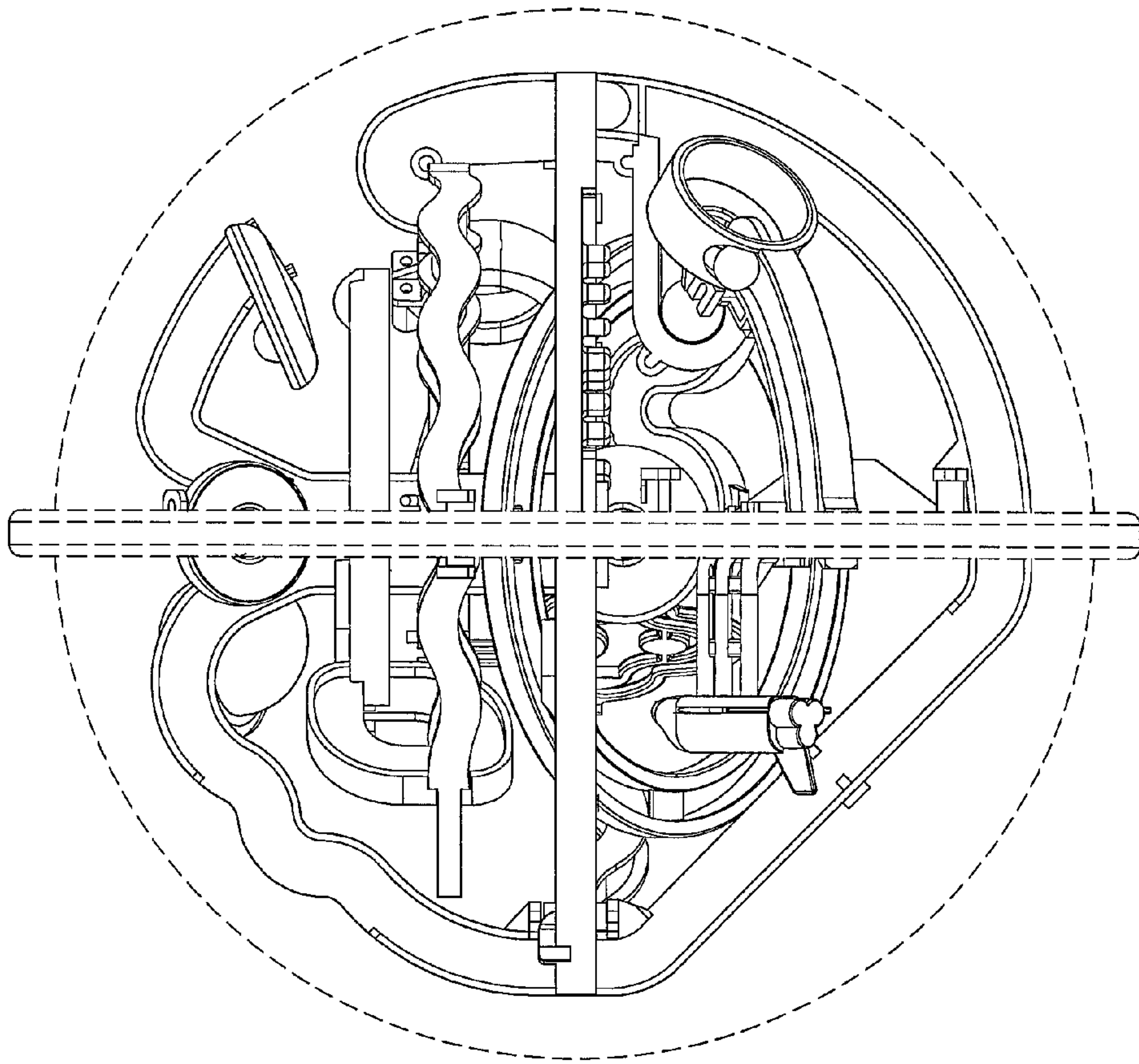

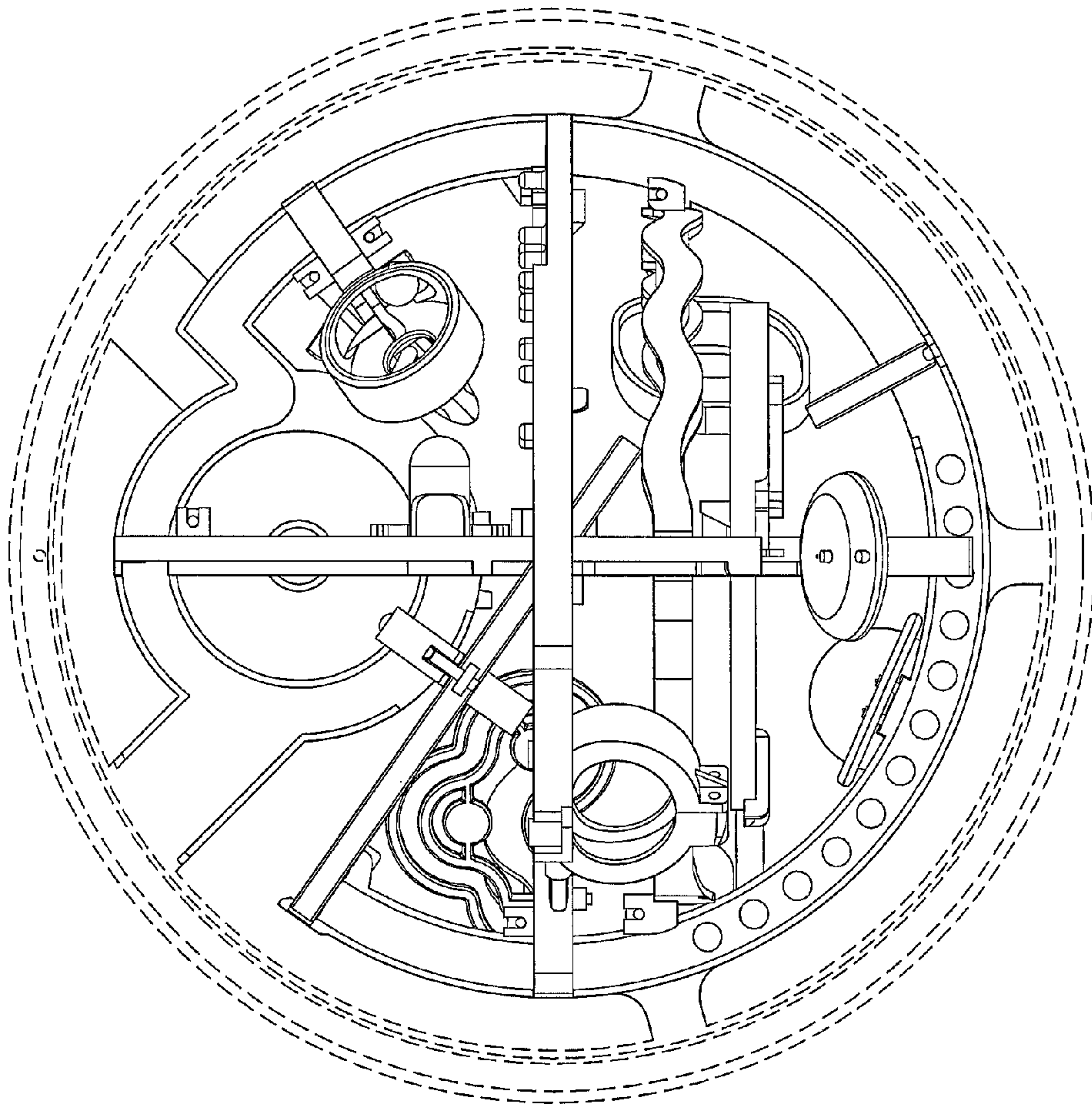

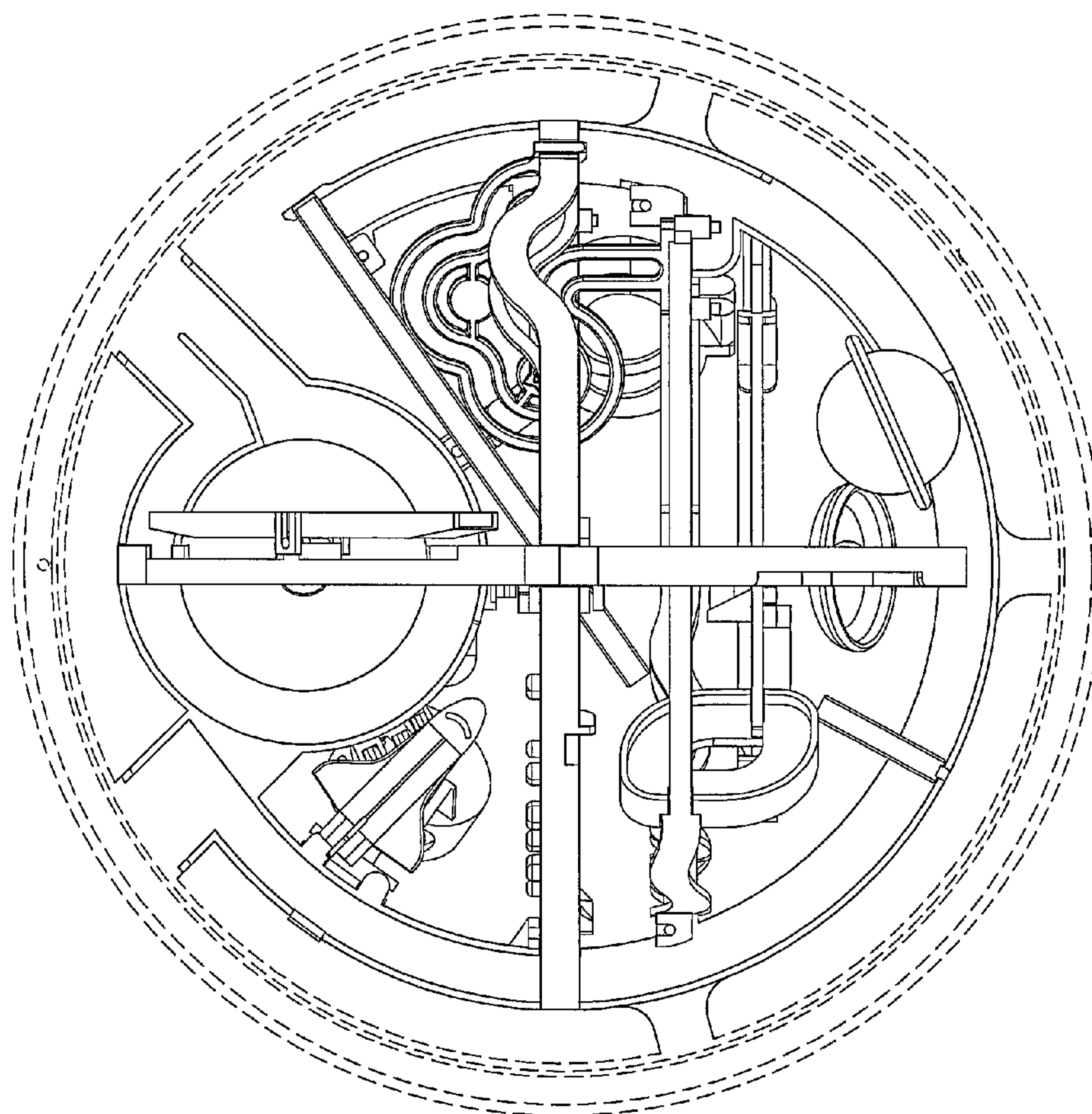
