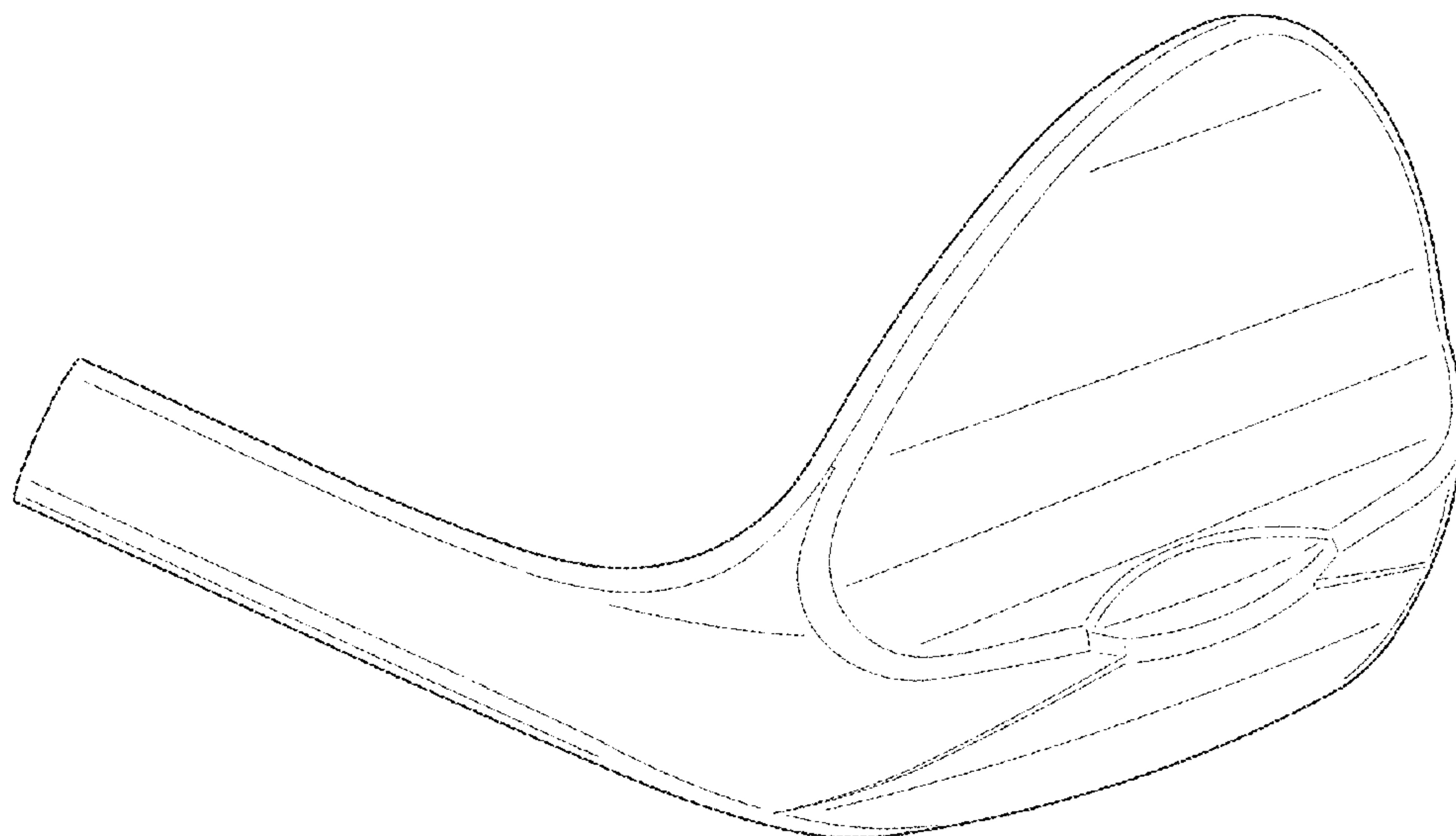
(57) **CLAIM**
The ornamental design for an iron golf club head, as shown
and described.

DESCRIPTION

FIG. 1 illustrates a front side perspective view of an iron golf club head employing an ornamental design in accordance with the present invention;
FIG. 2 illustrates a back side perspective view of the iron golf club head of FIG. 1;
FIG. 3 illustrates a top side view of the iron golf club head of FIG. 1;
FIG. 4 illustrates a bottom side view of the iron golf club head of FIG. 1;
FIG. 5 illustrates a front side view of the iron golf club head of FIG. 1;

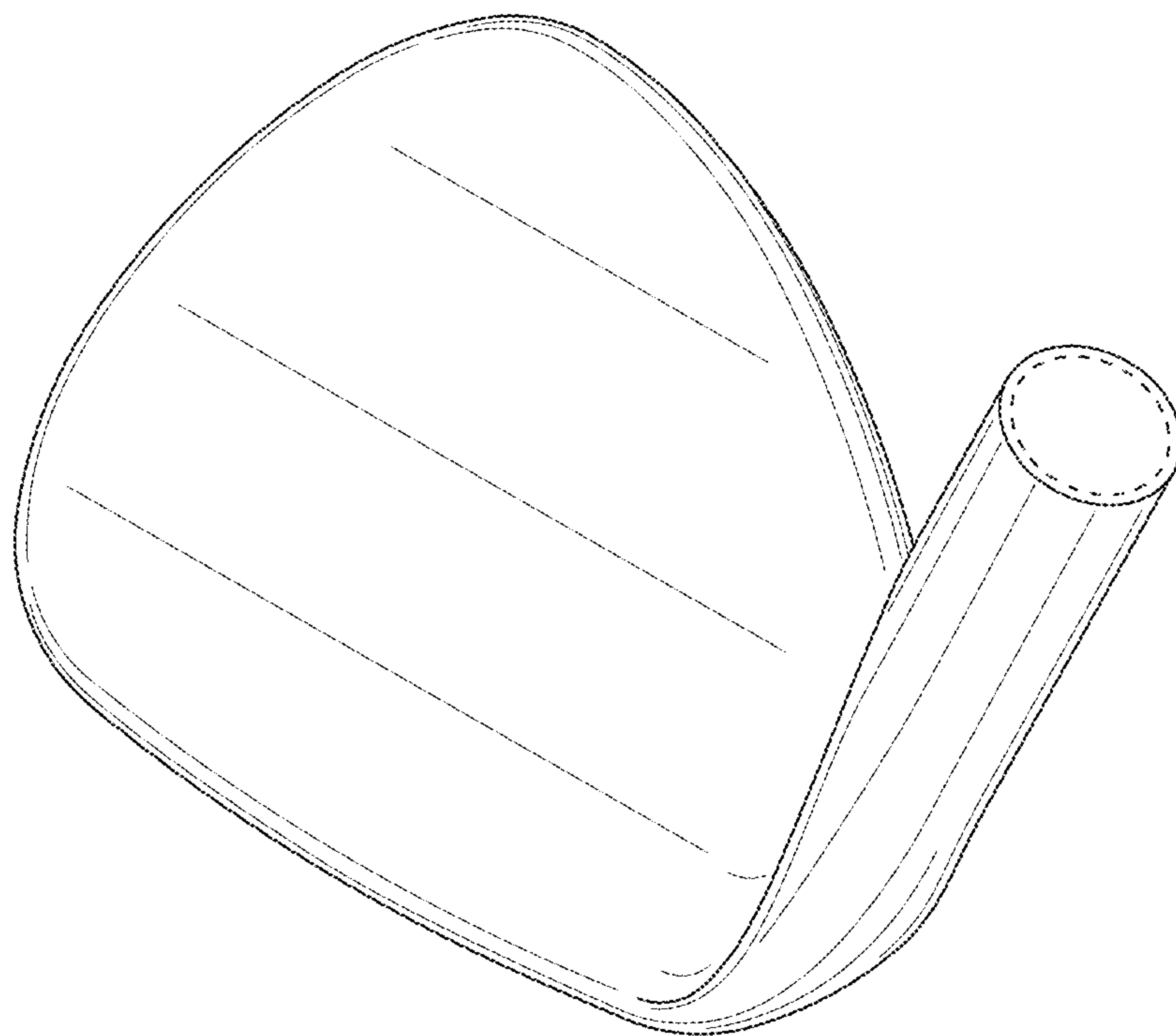

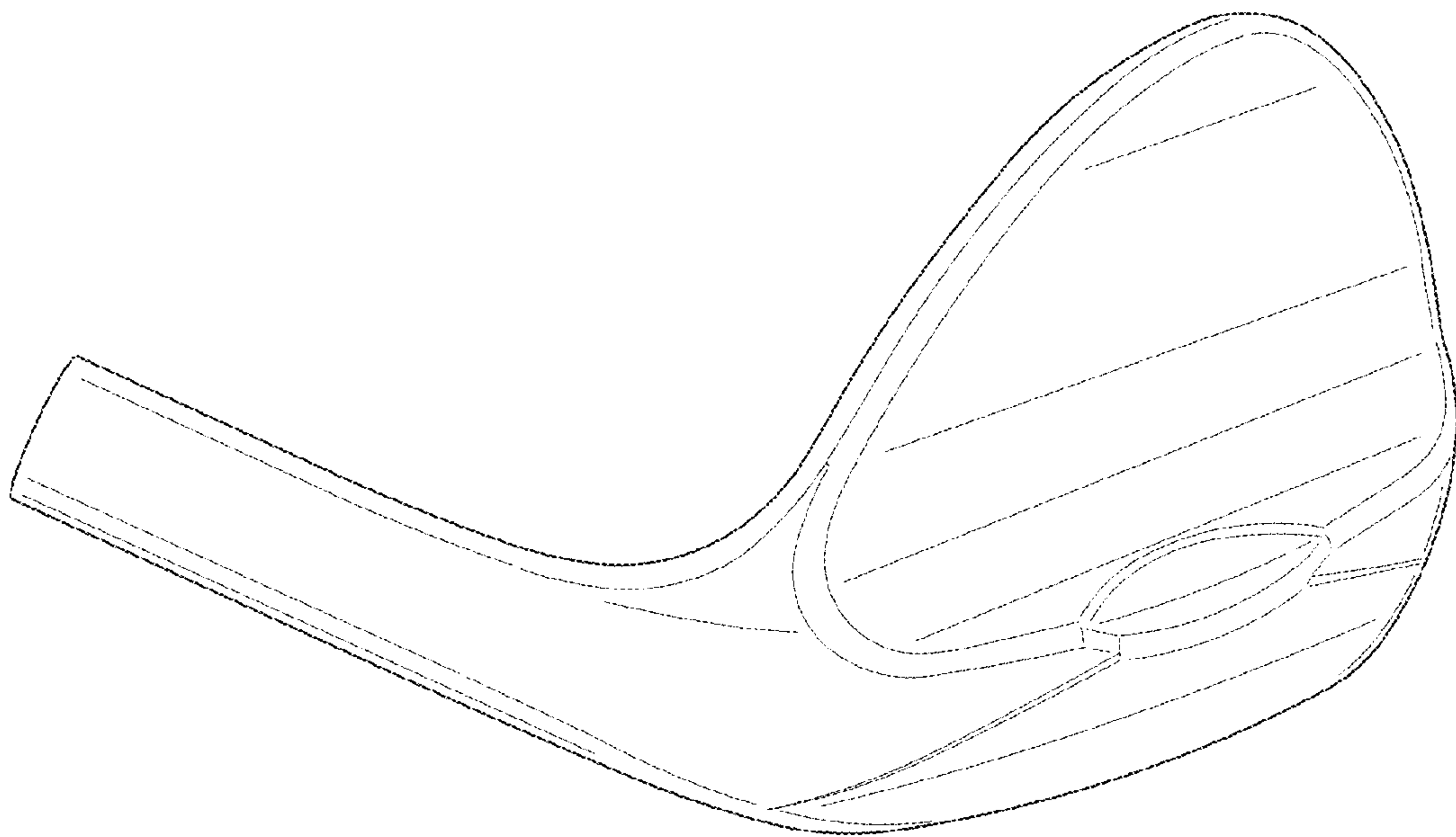

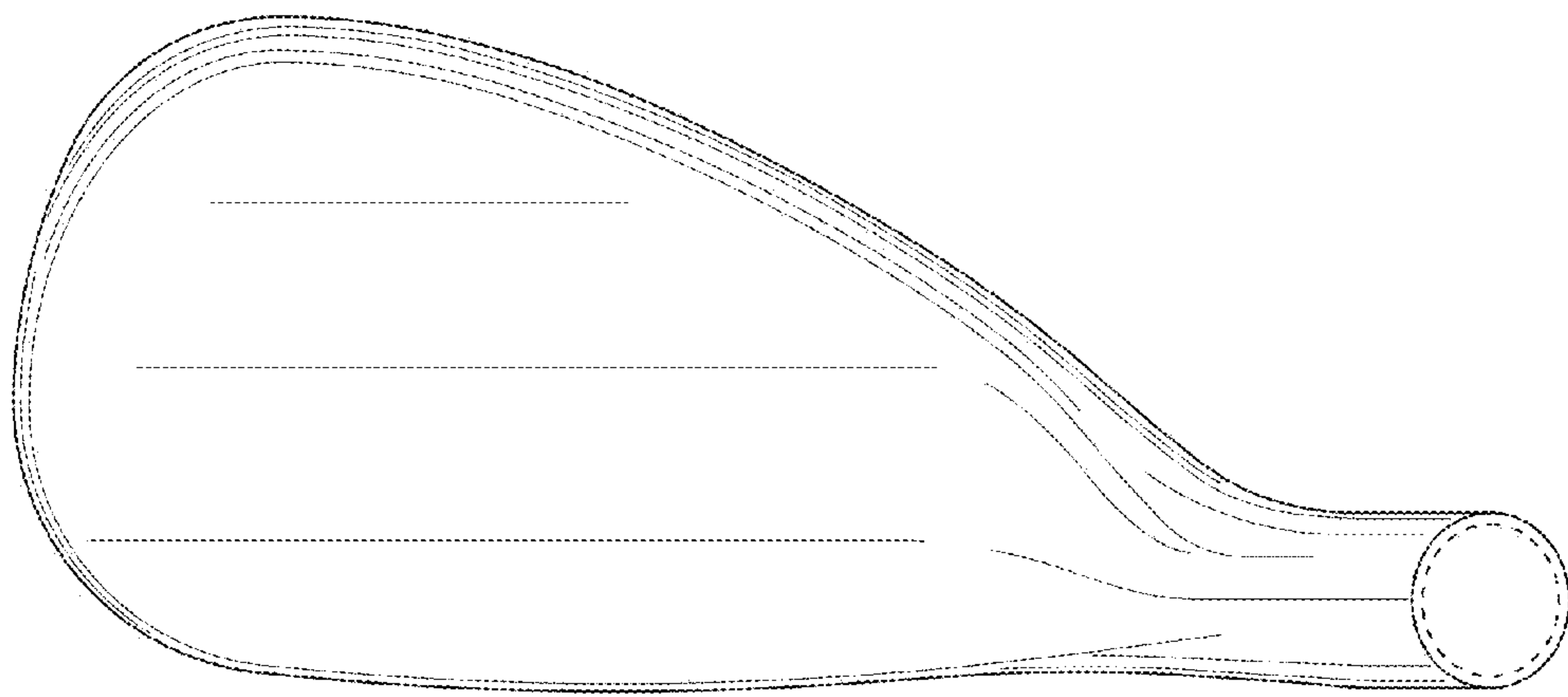

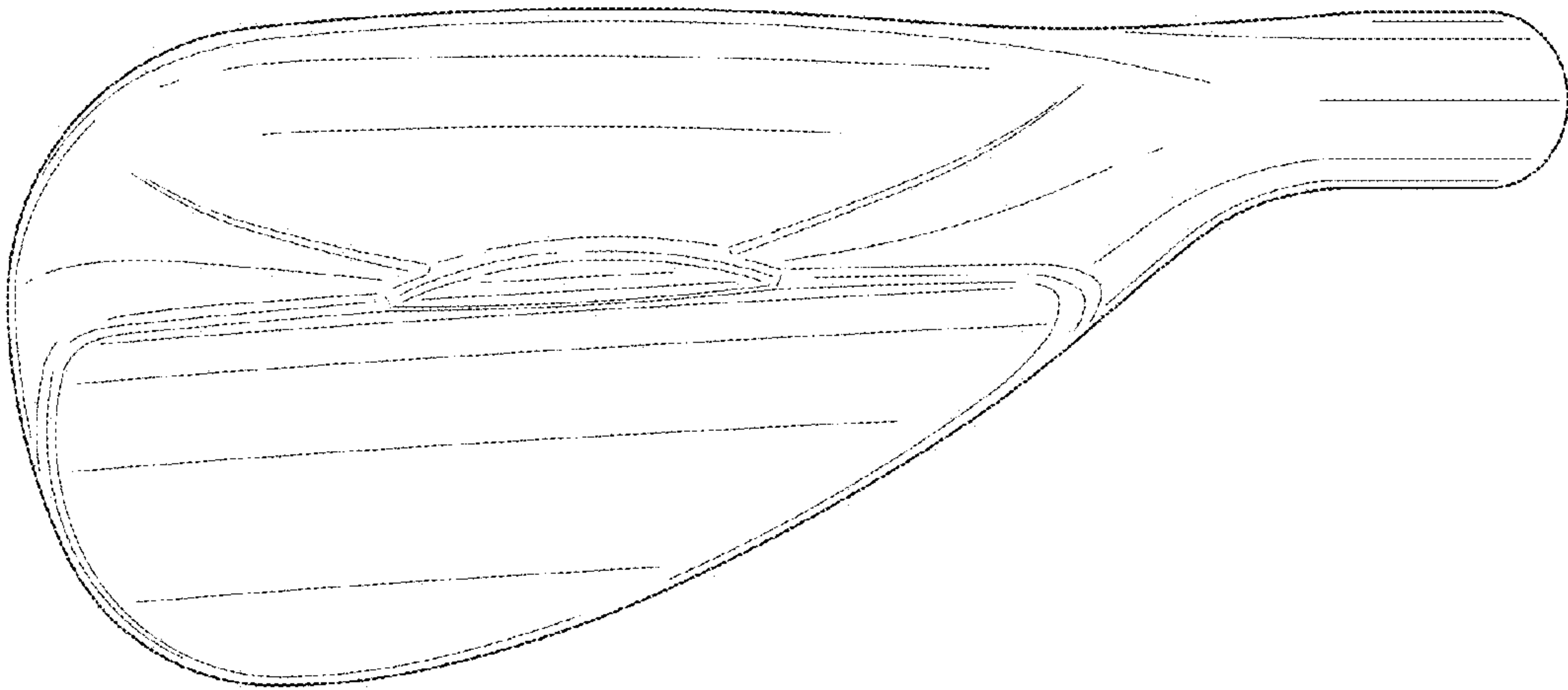

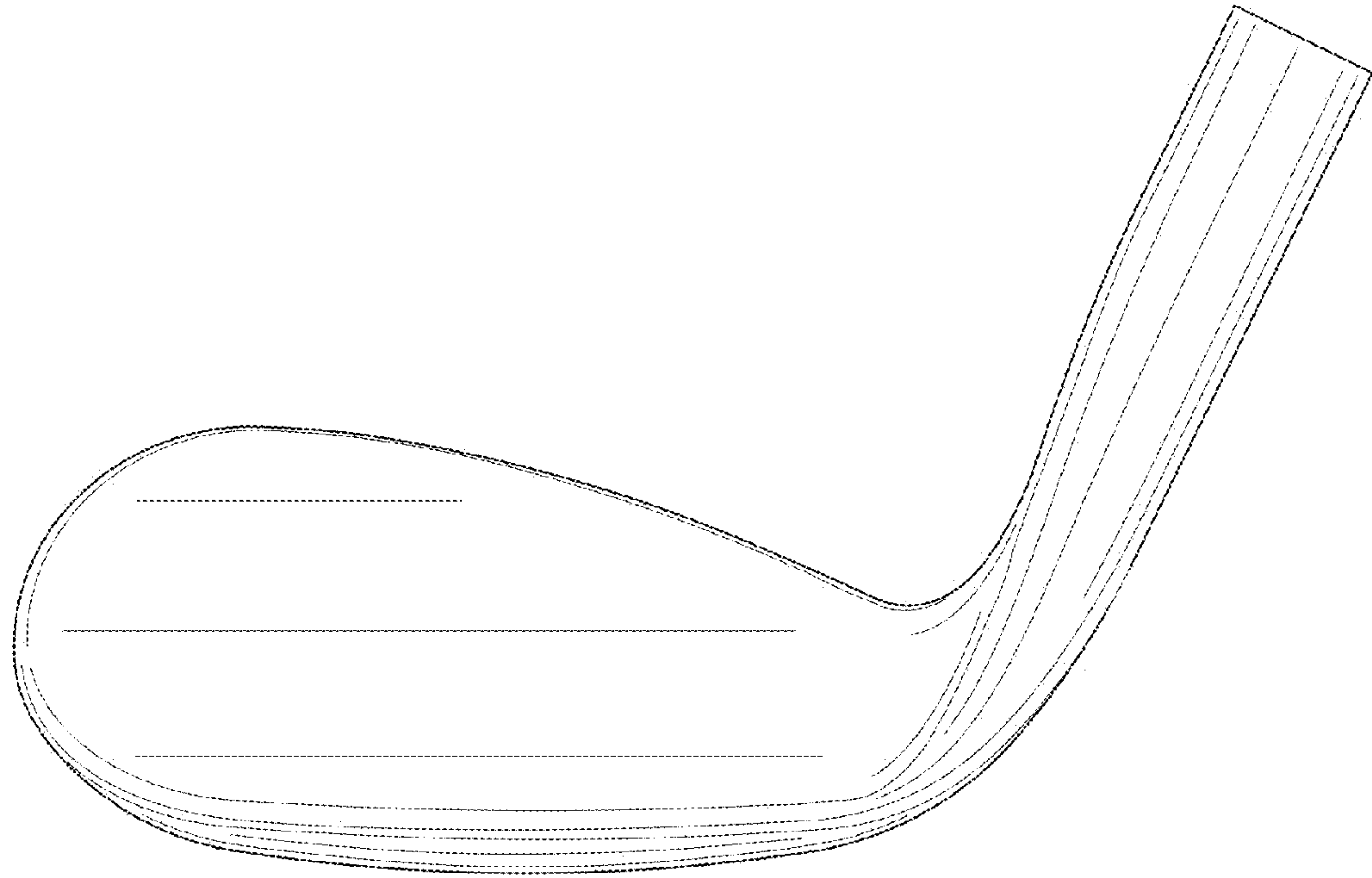

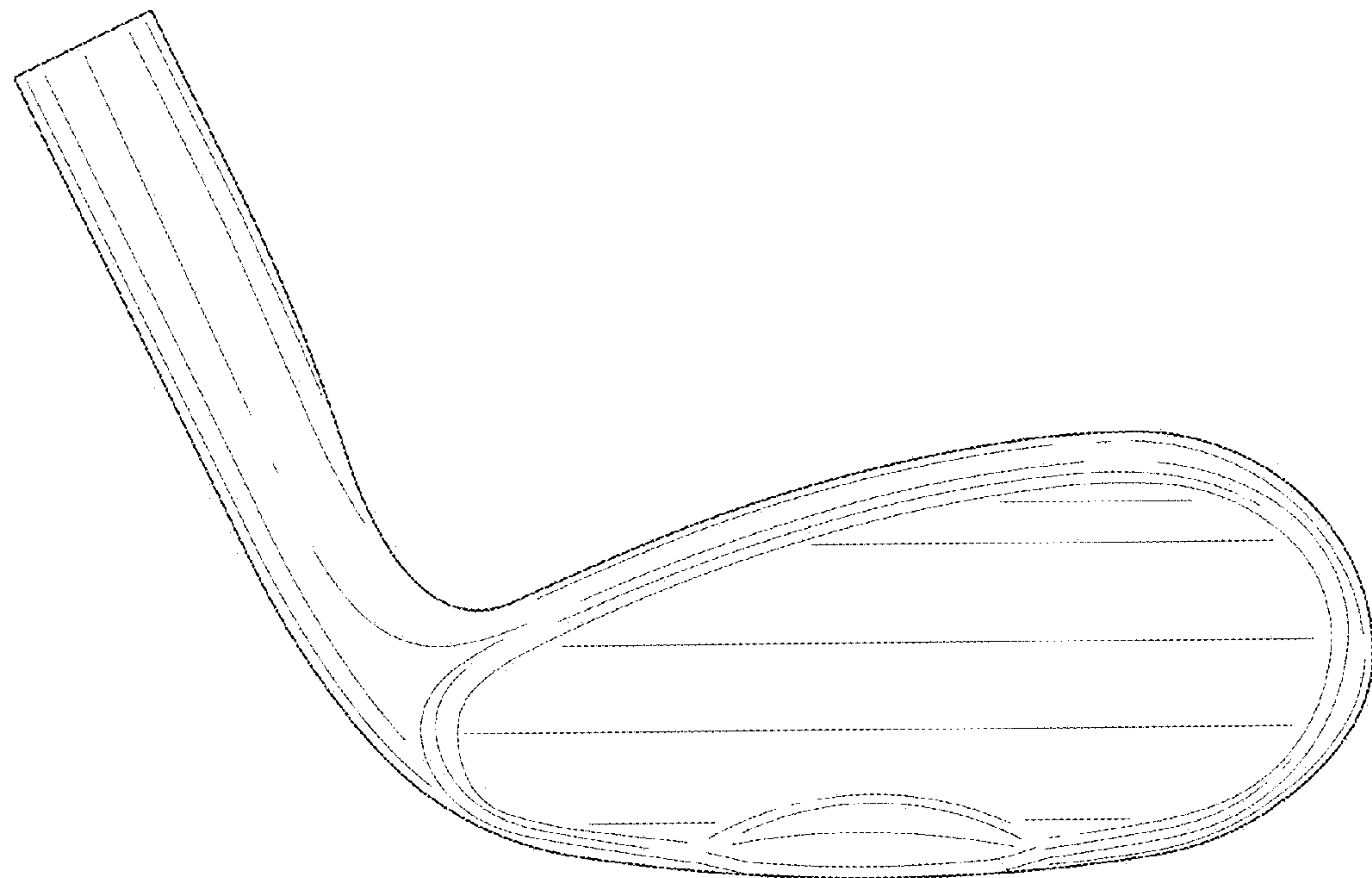

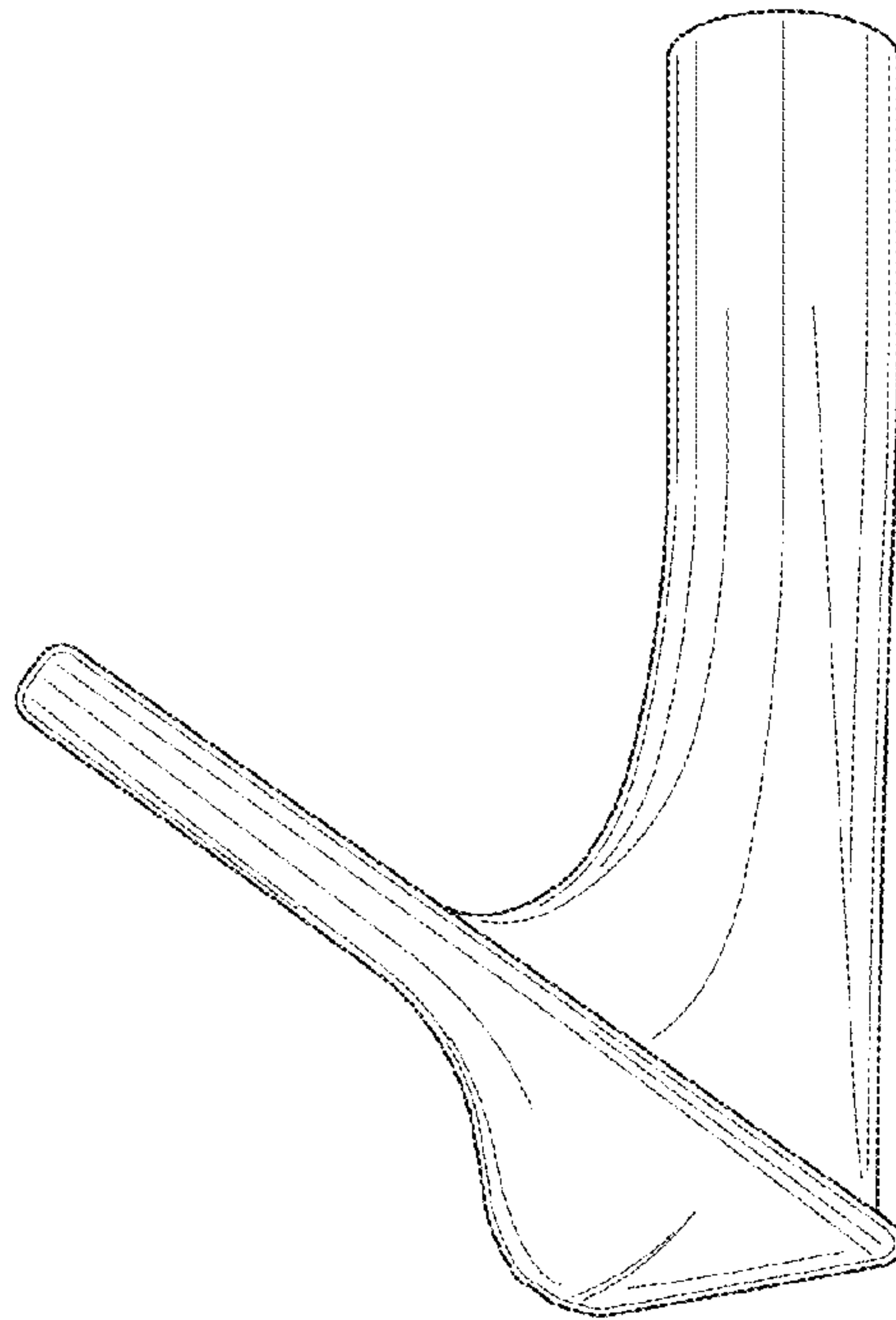

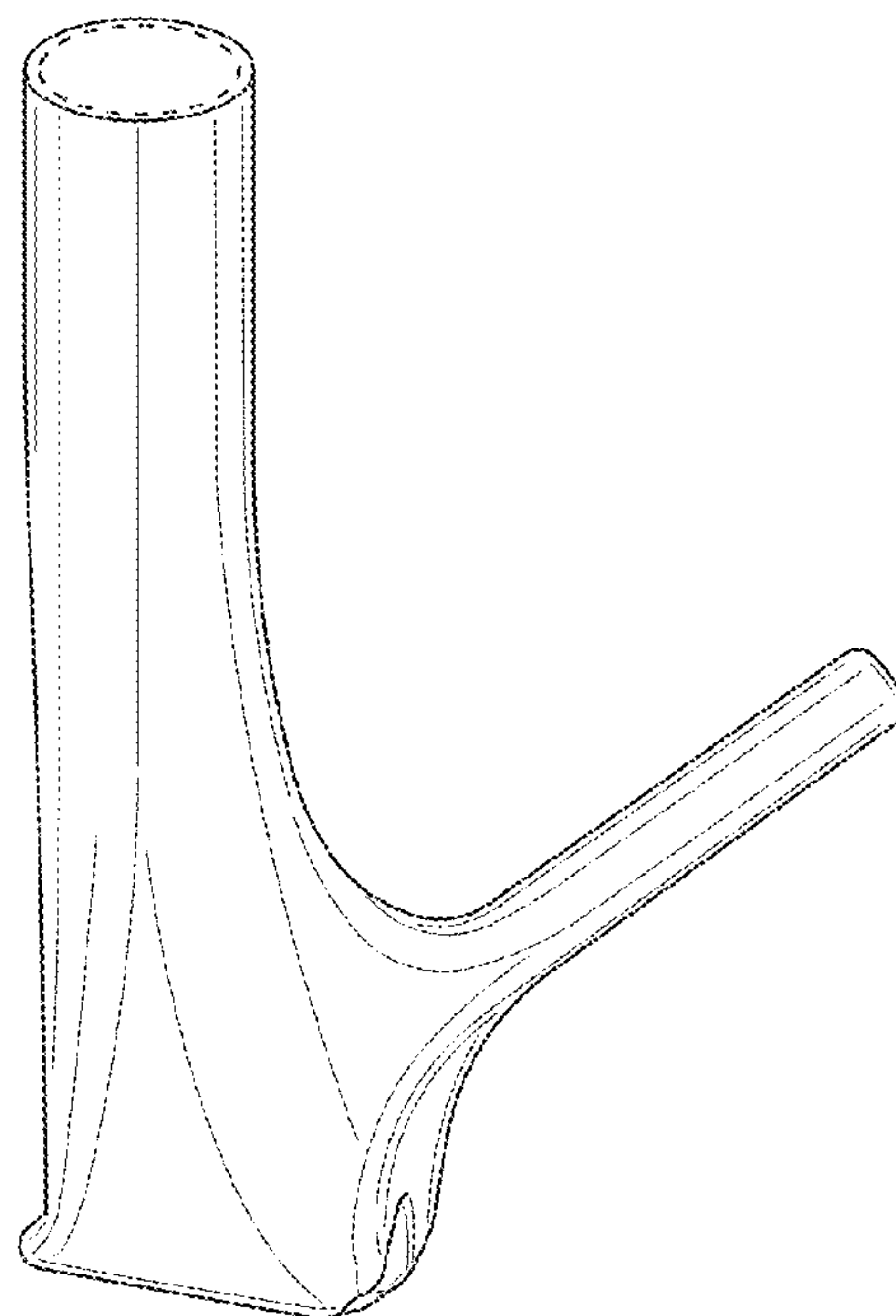
