(57) **CLAIM**

The ornamental design for a fan guide, as shown and described.

DESCRIPTION

FIG. 1 is a front top perspective view of the fan guide according to the present invention;

FIG. 2 is a top plan view of the fan guide illustrated in FIG. 1; FIG. 3 is a bottom plan view of the fan guide illustrated in FIG. 1;

FIG. 4 is a side plan view of the fan guide illustrated in FIG. 1;

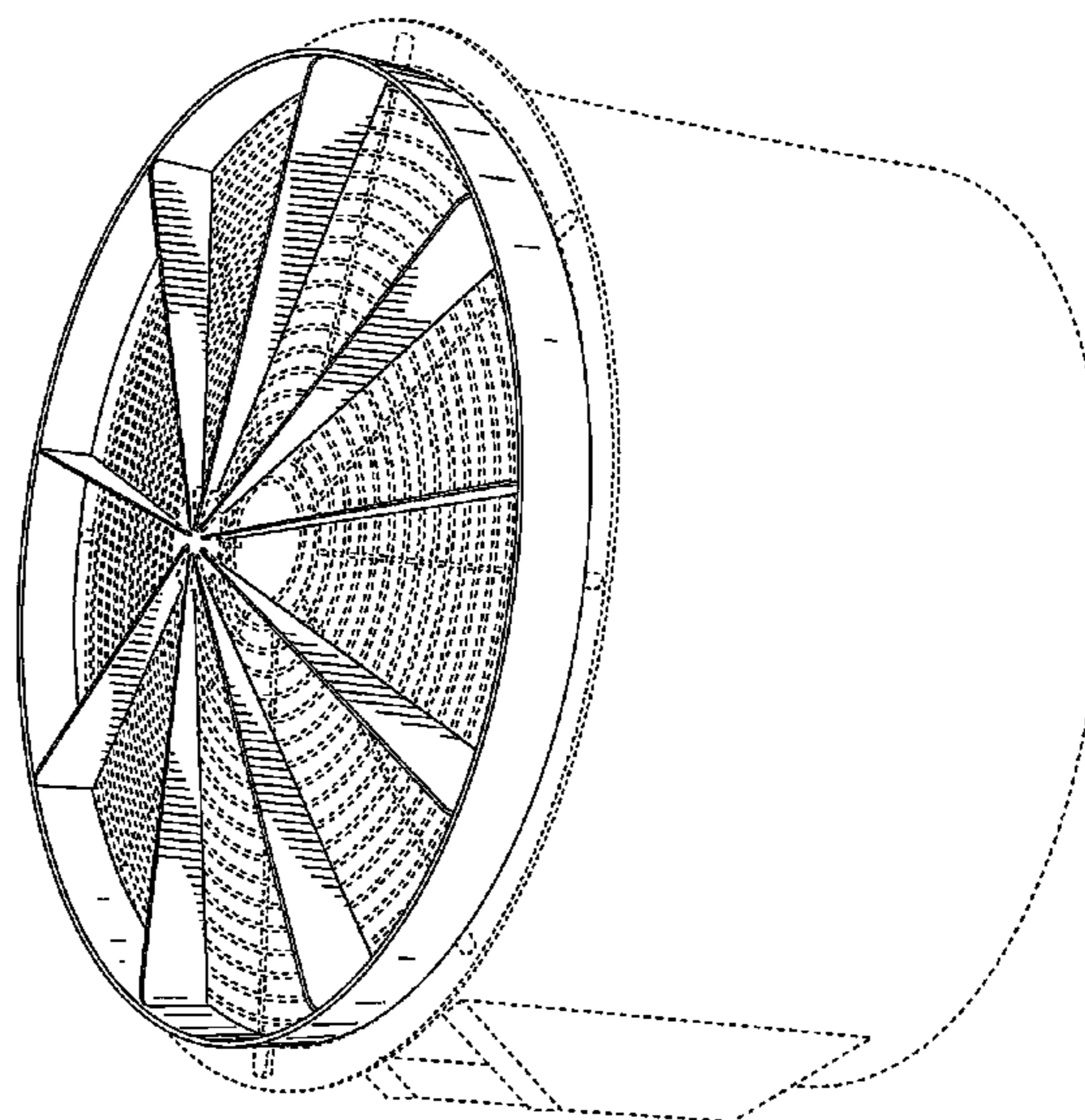
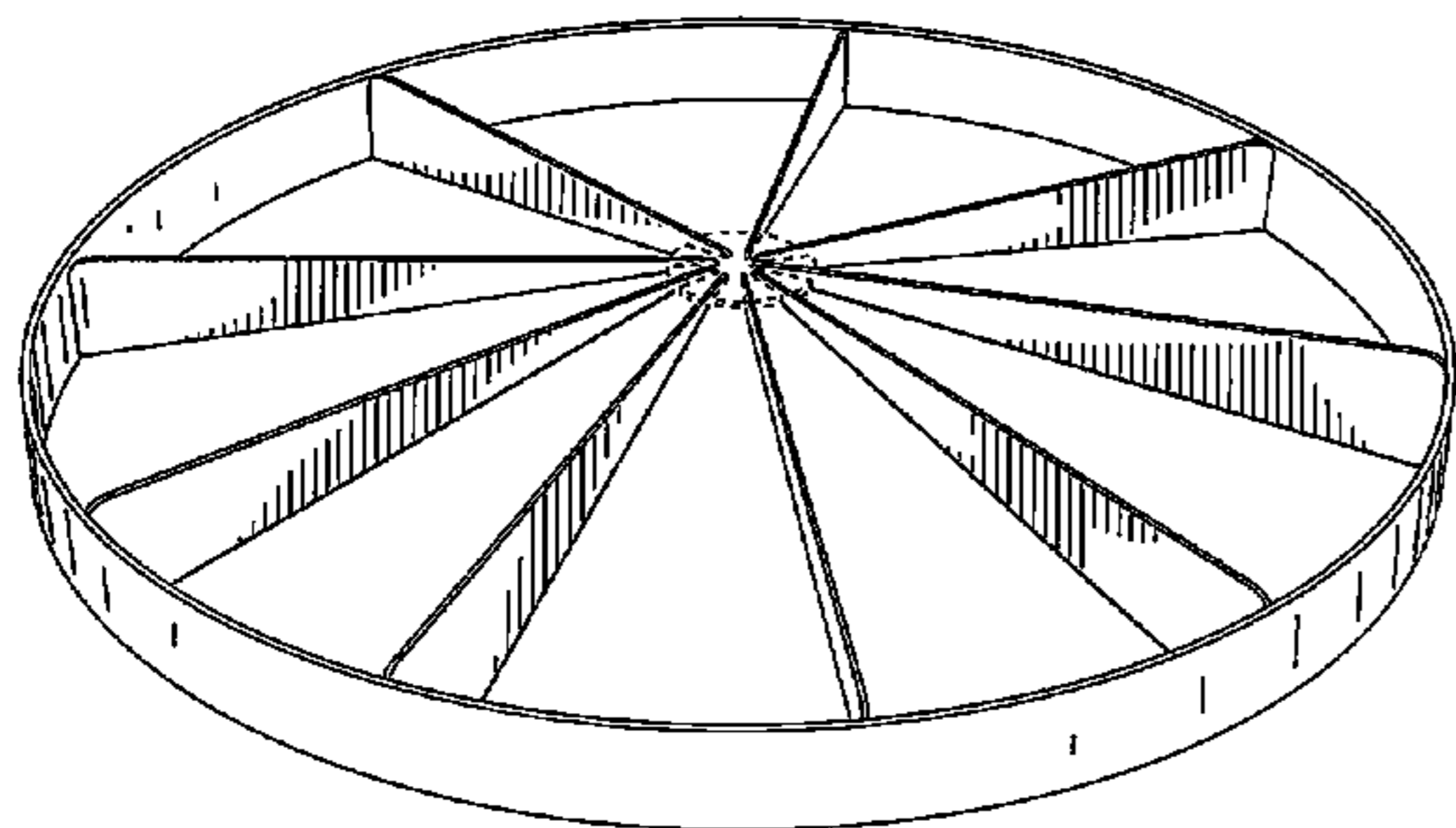
FIG. 5 is a side cross-section view of the fan guide illustrated in FIG. 1 taken along line 5-5;

FIG. 6 is a perspective view of the fan guide illustrated in FIG. 1 installed inside a fan guard; and,

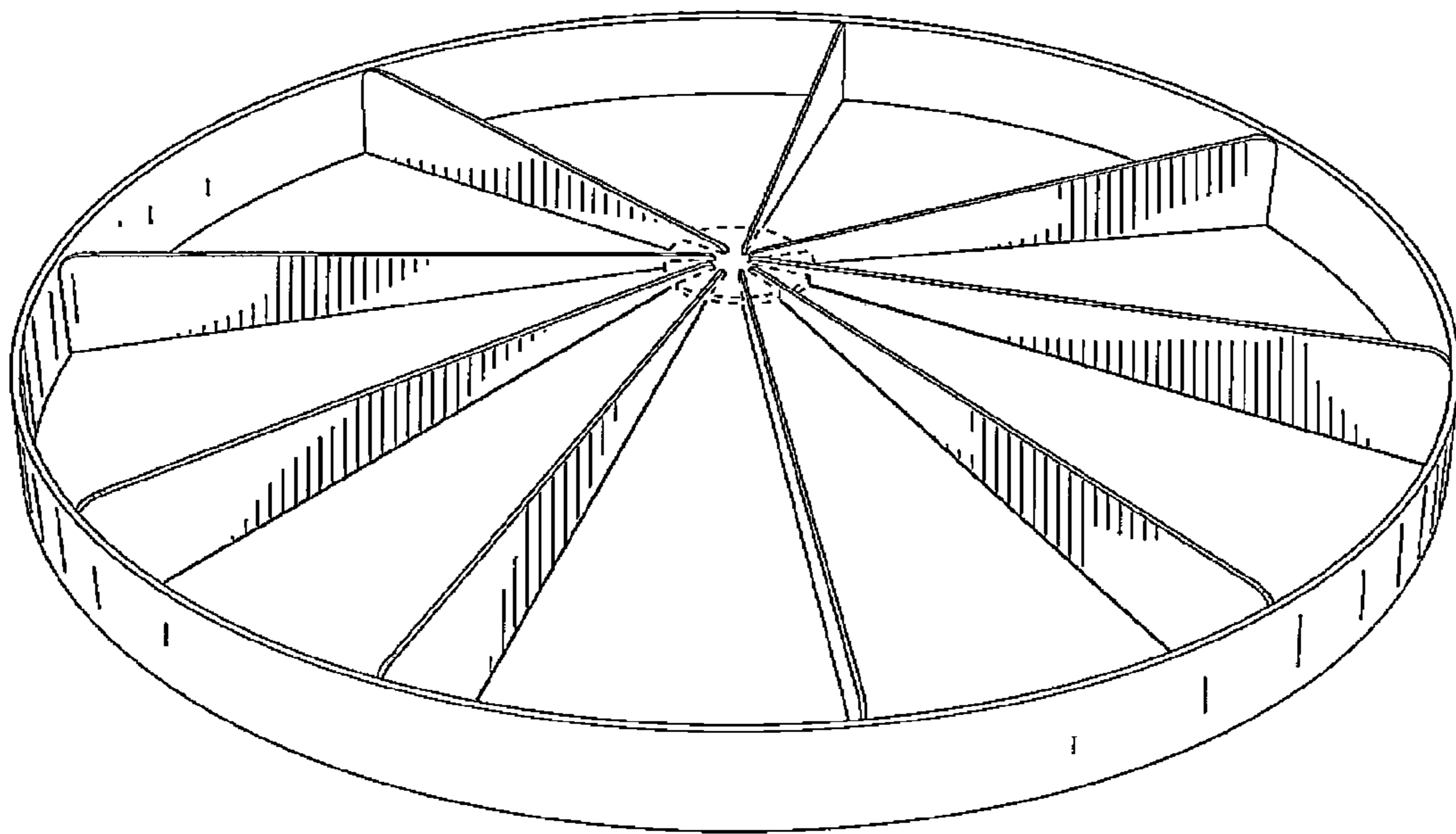

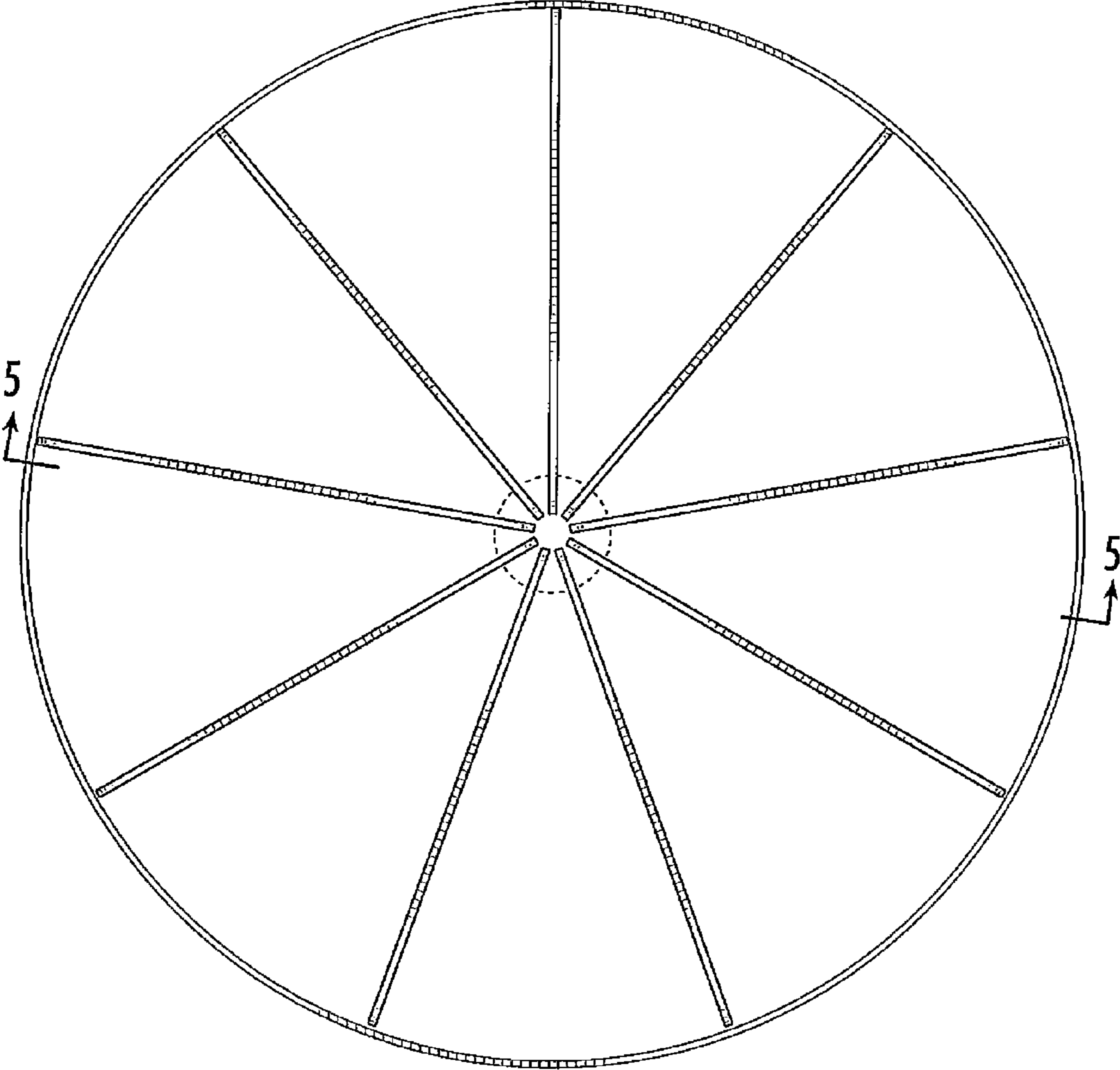

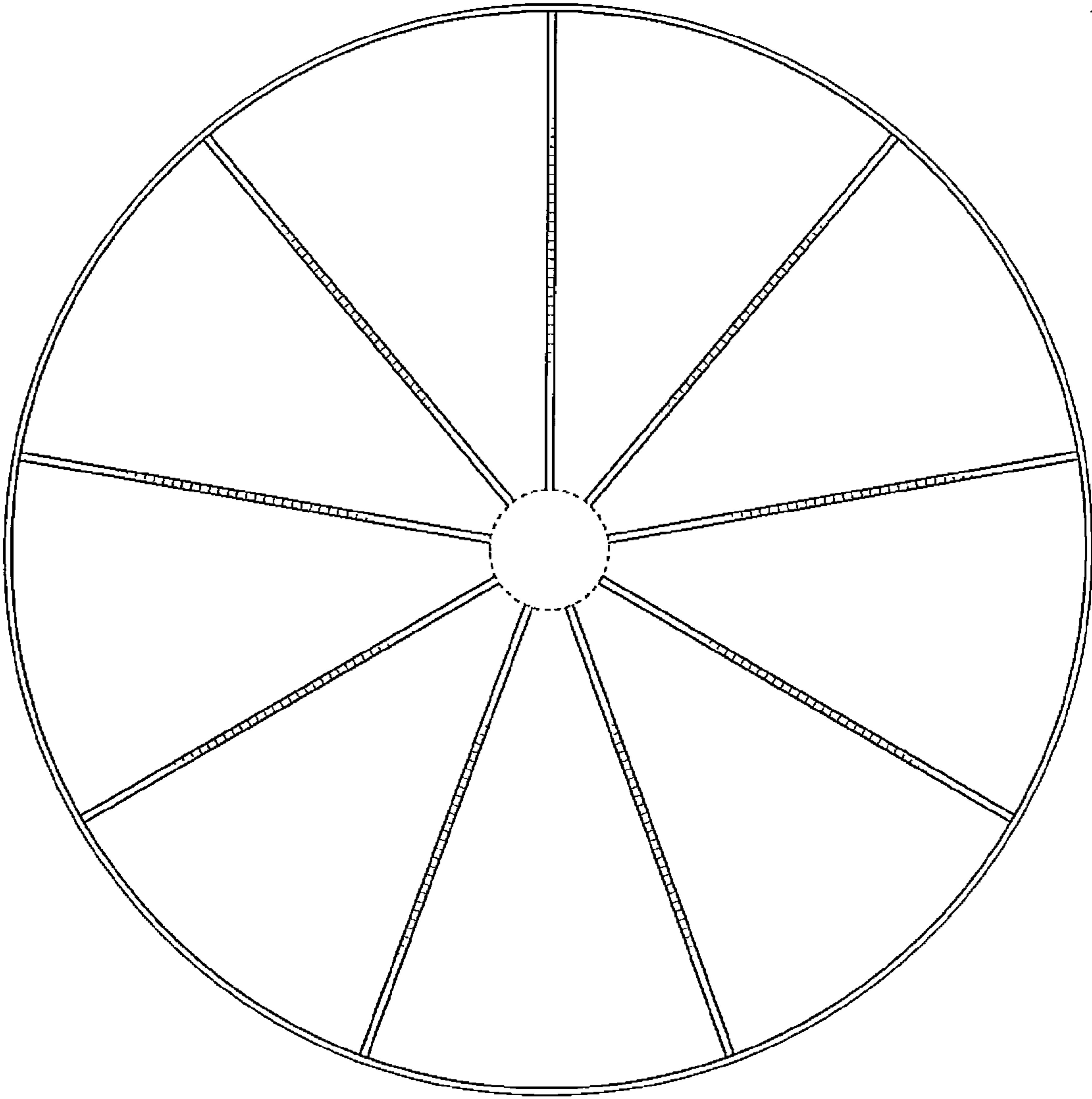

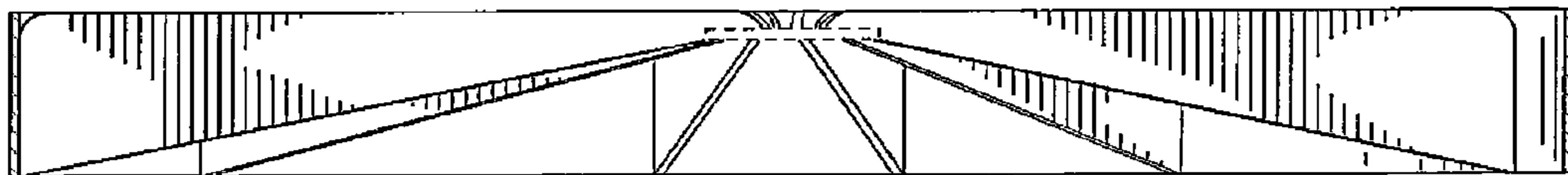

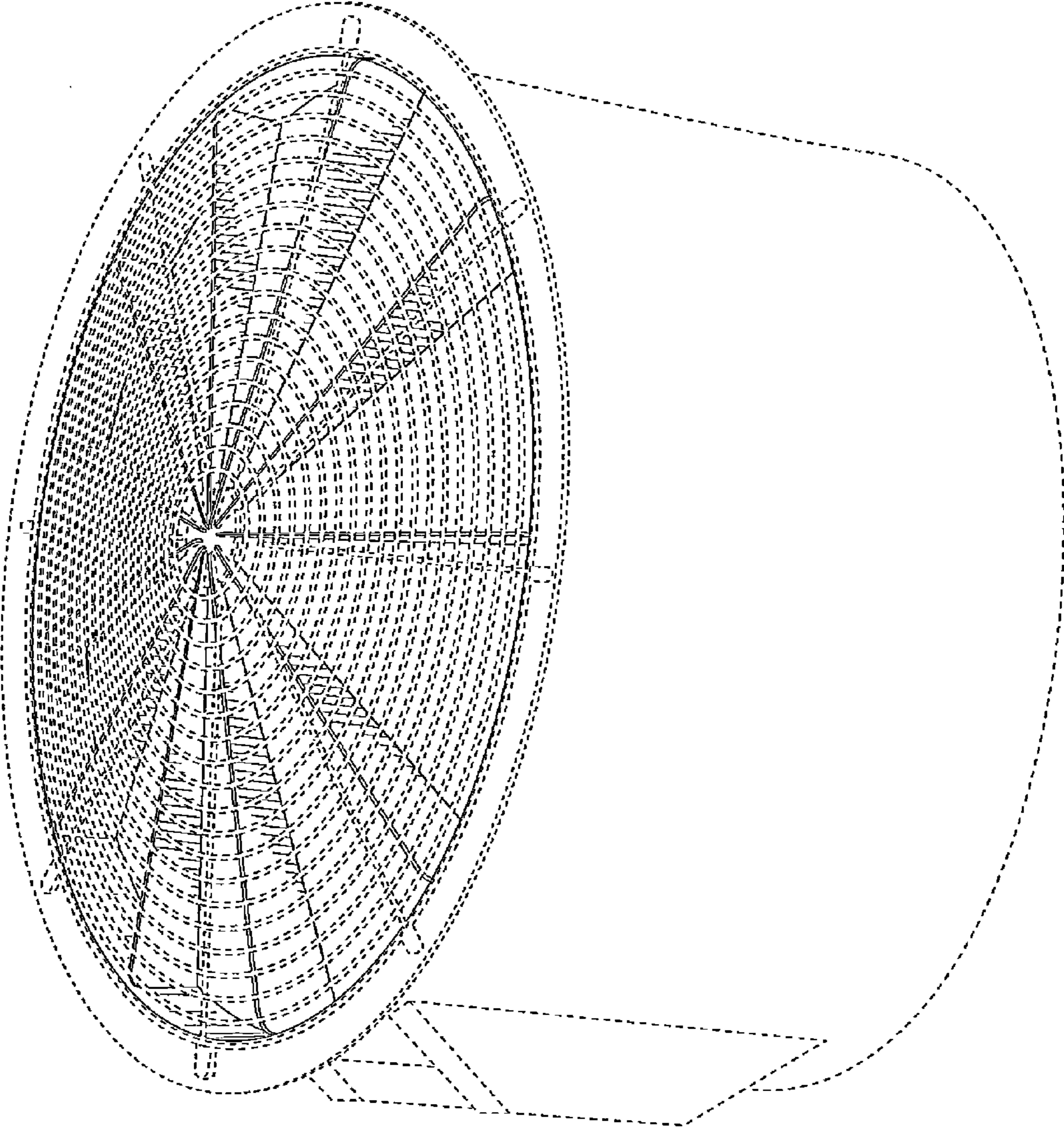

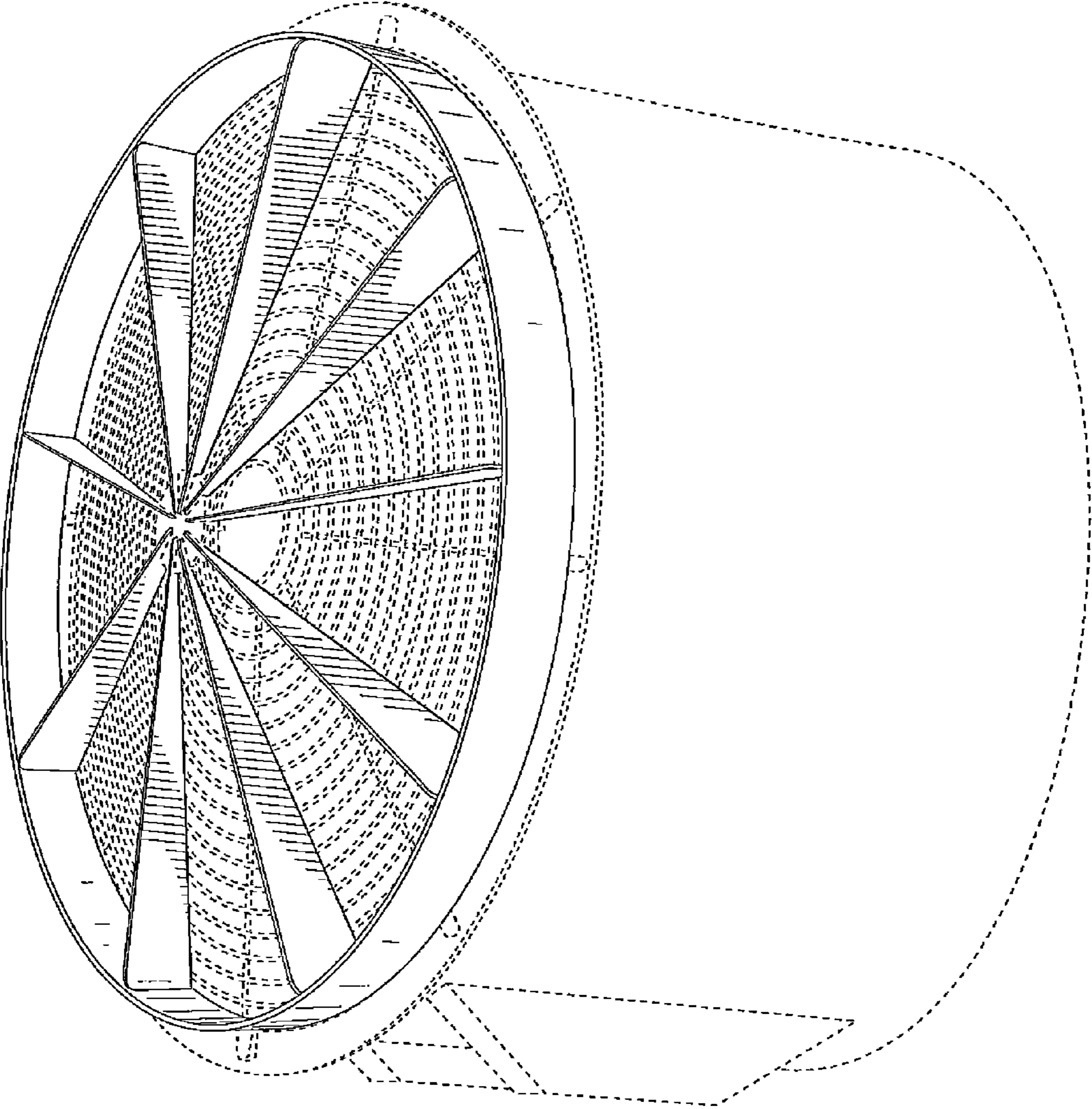
