FIG. 3 is a side element view of the ultrasonic probe;

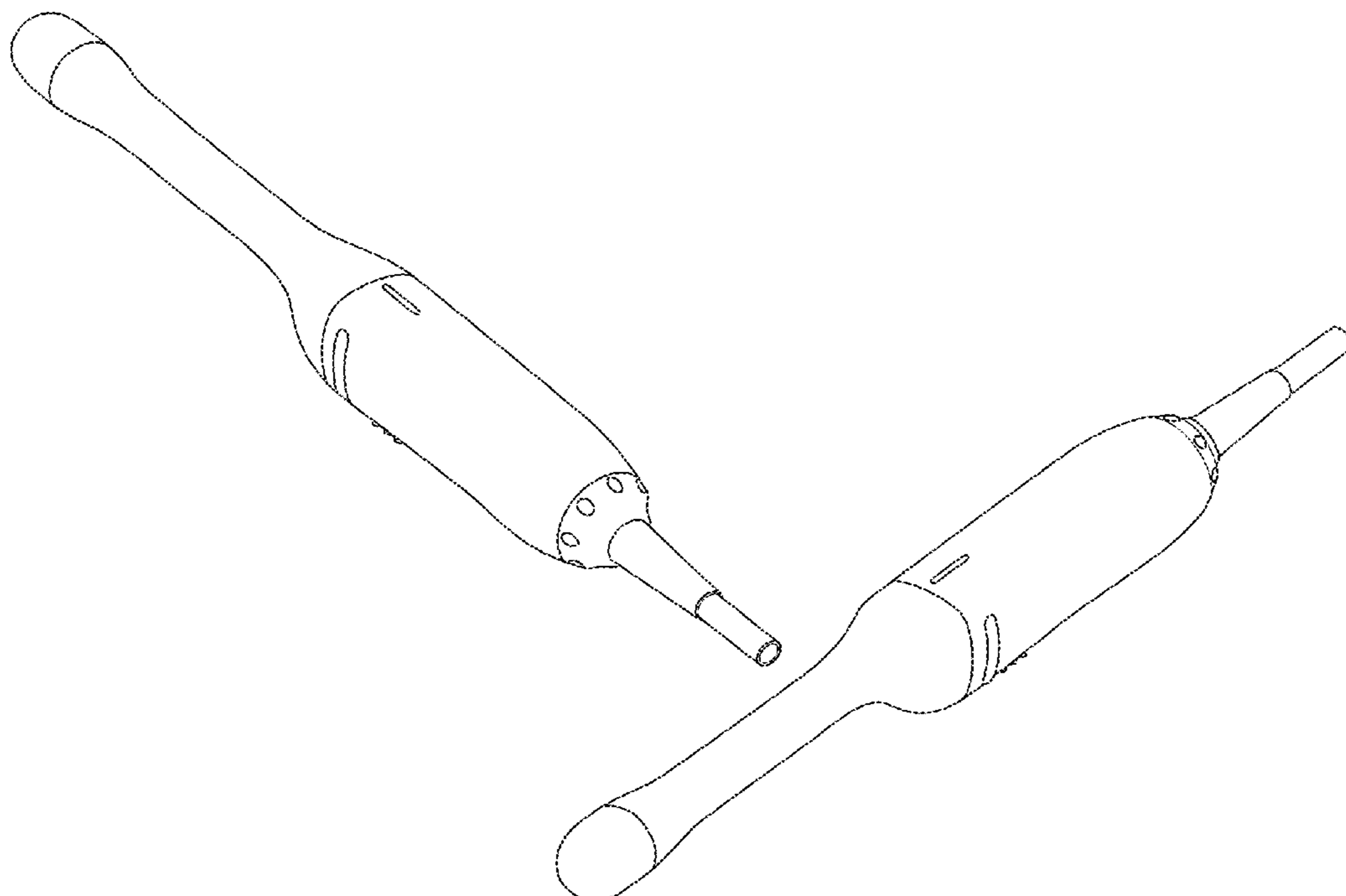
FIG. 4 is a rear end view of the ultrasonic probe;

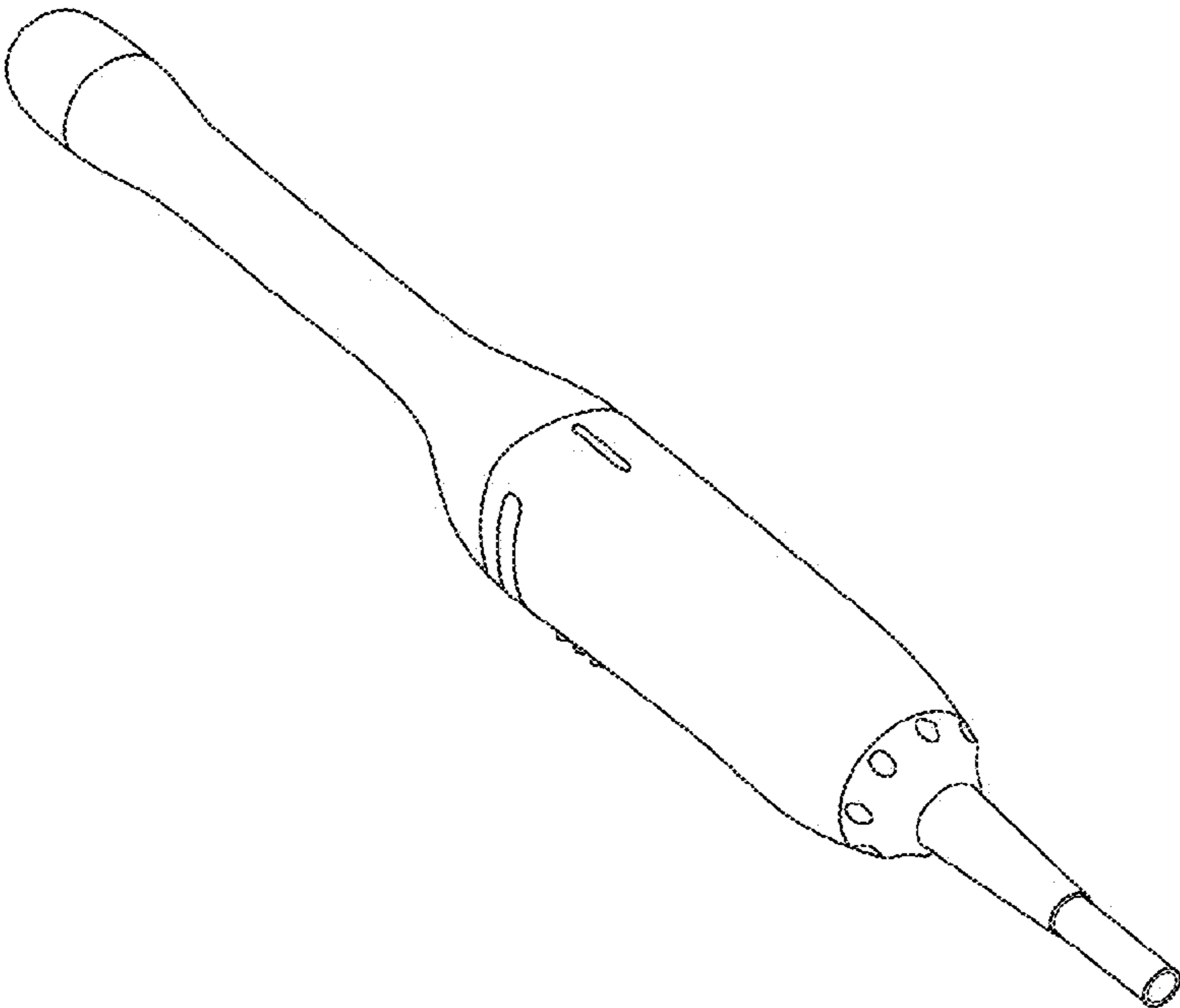

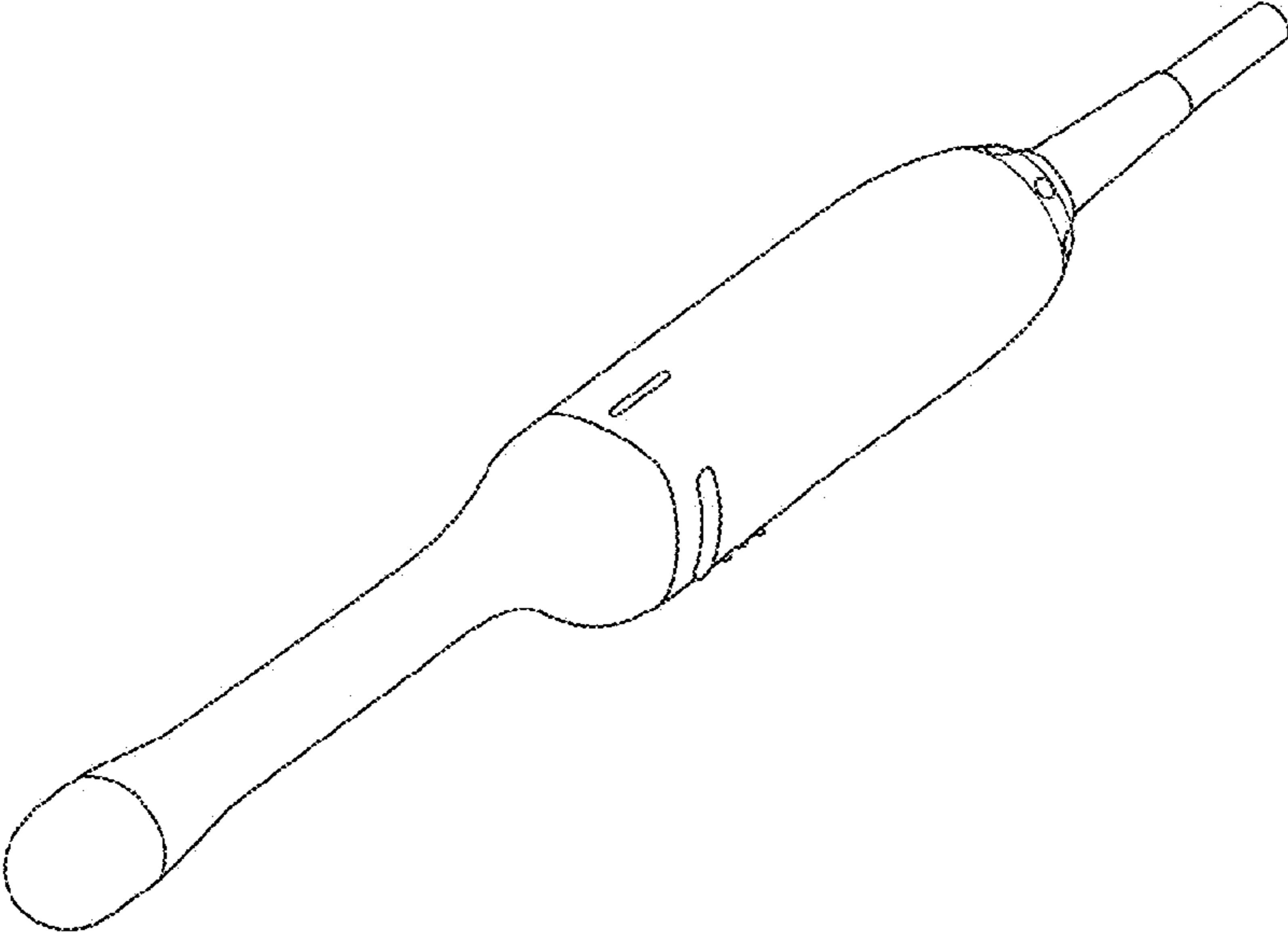

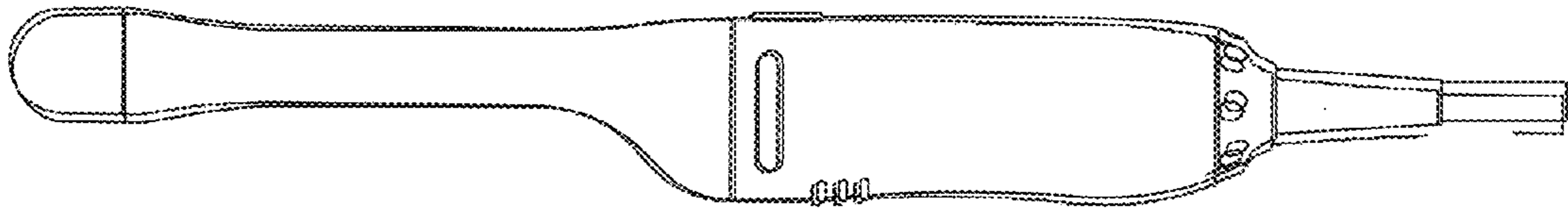

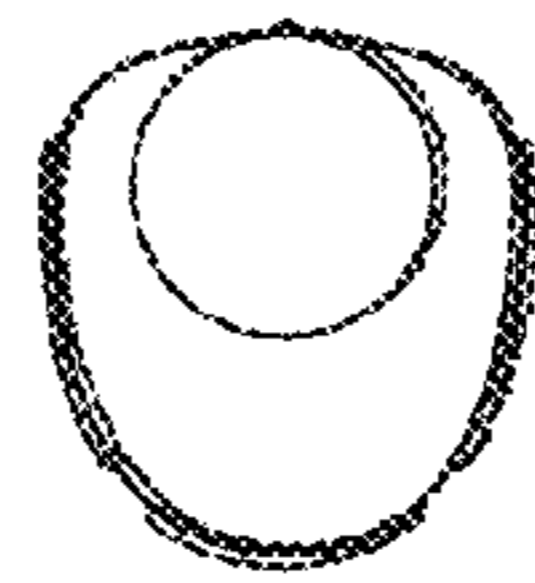

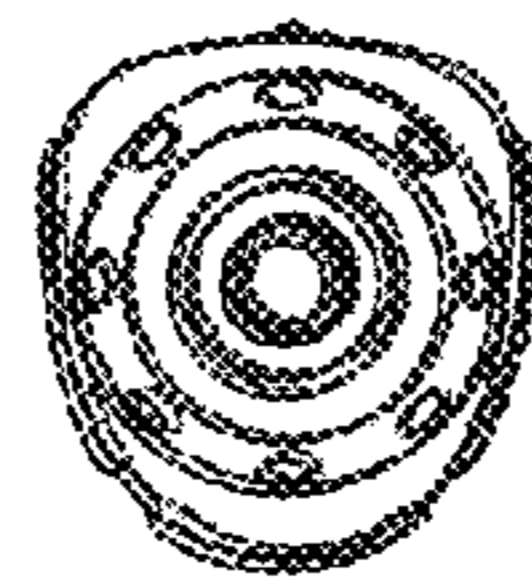

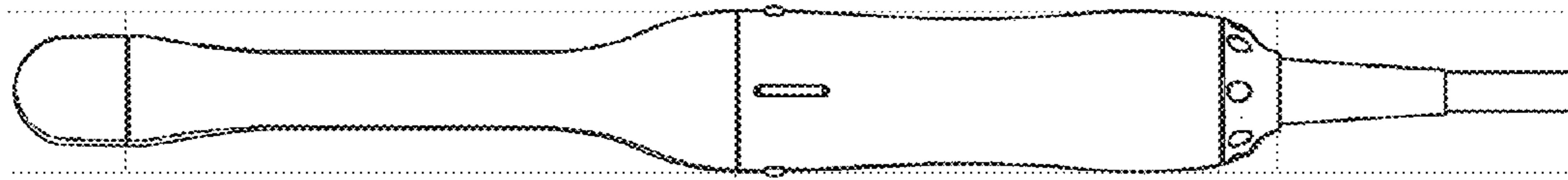

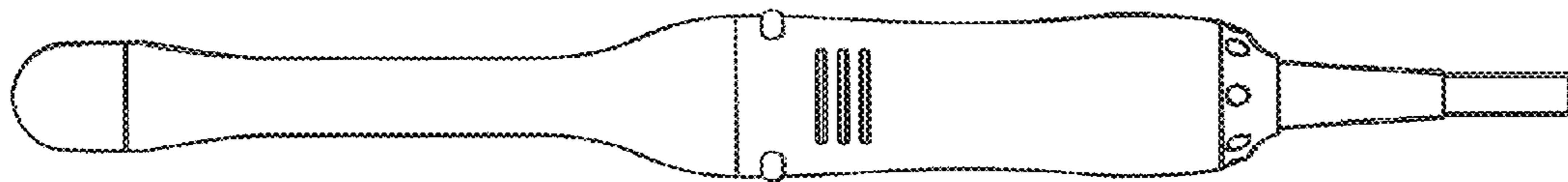

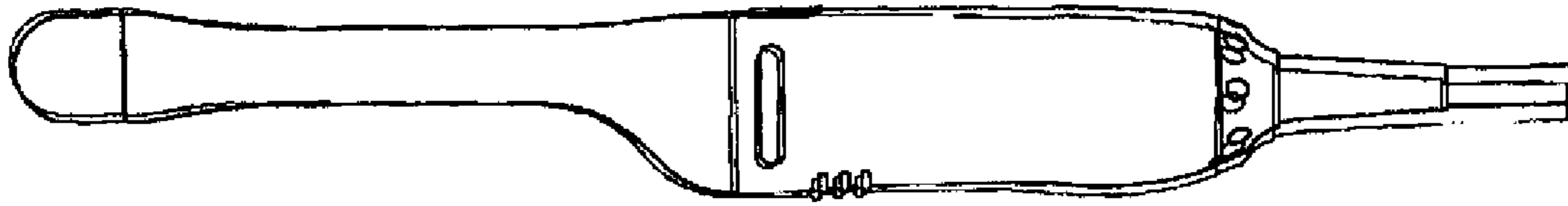

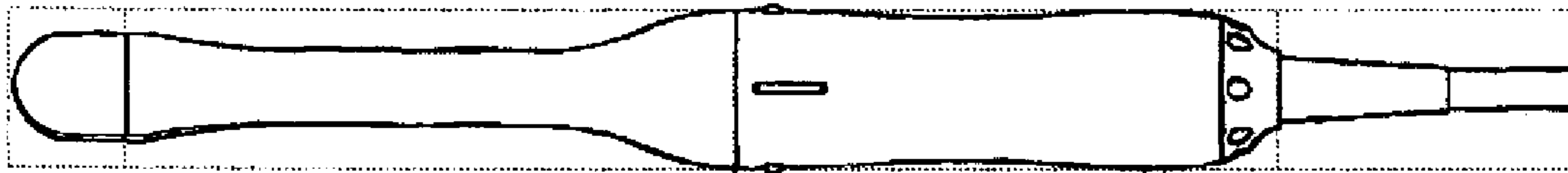

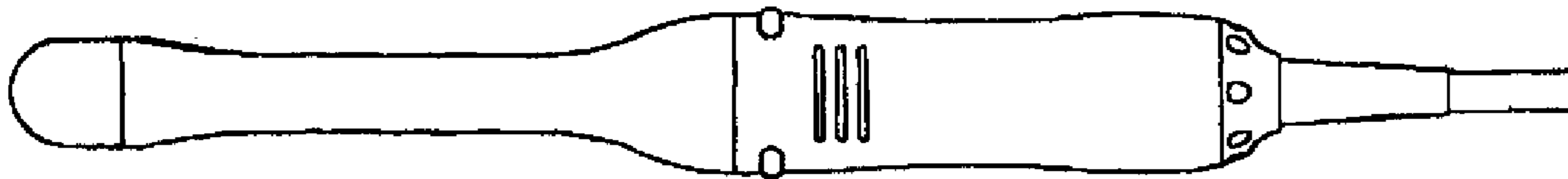
