(57) **CLAIM**

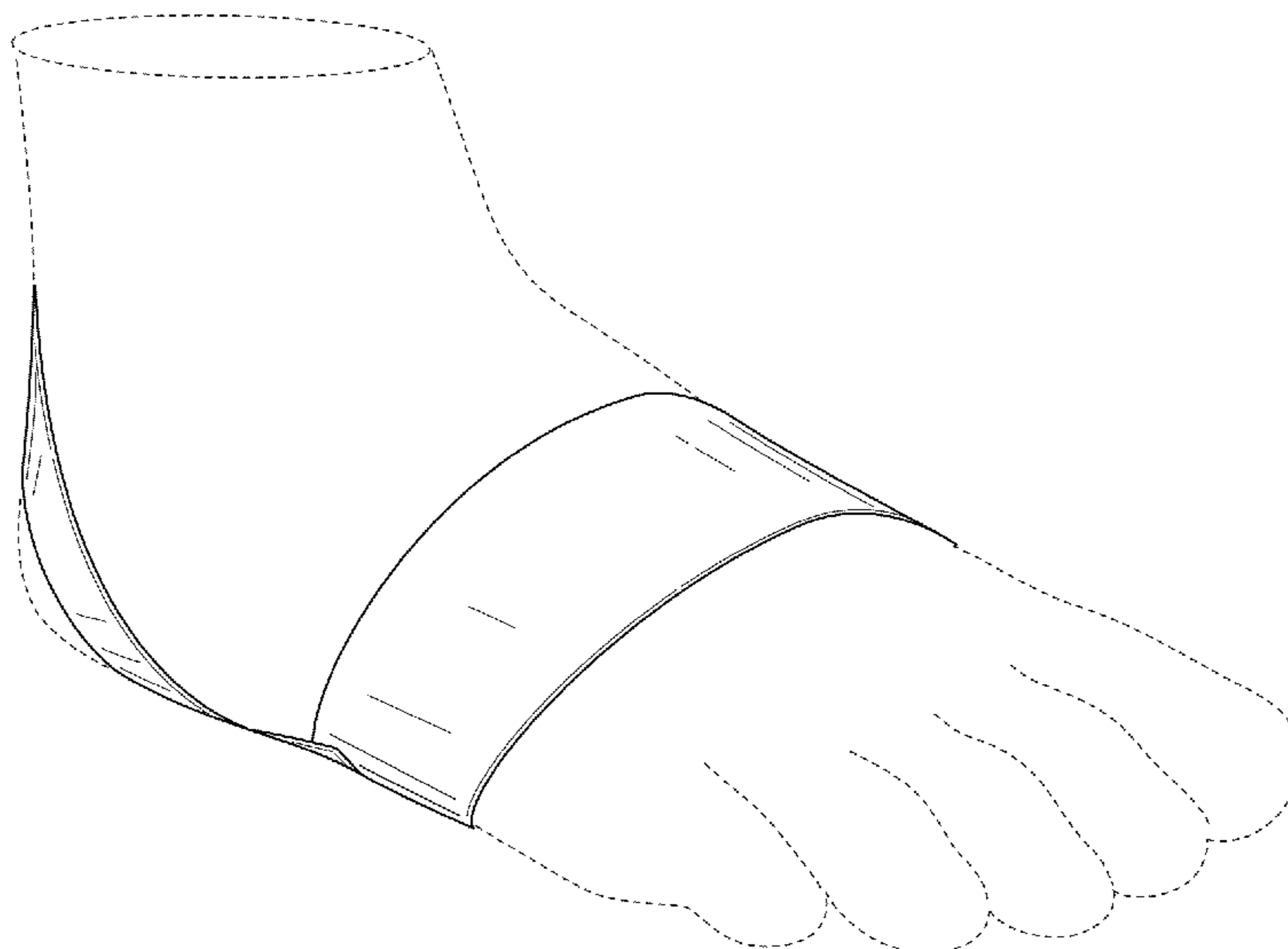
The ornamental design for a foot arch support, as shown and described.

DESCRIPTION

FIG. 1 is a right side perspective view of the foot arch support according to the present design;

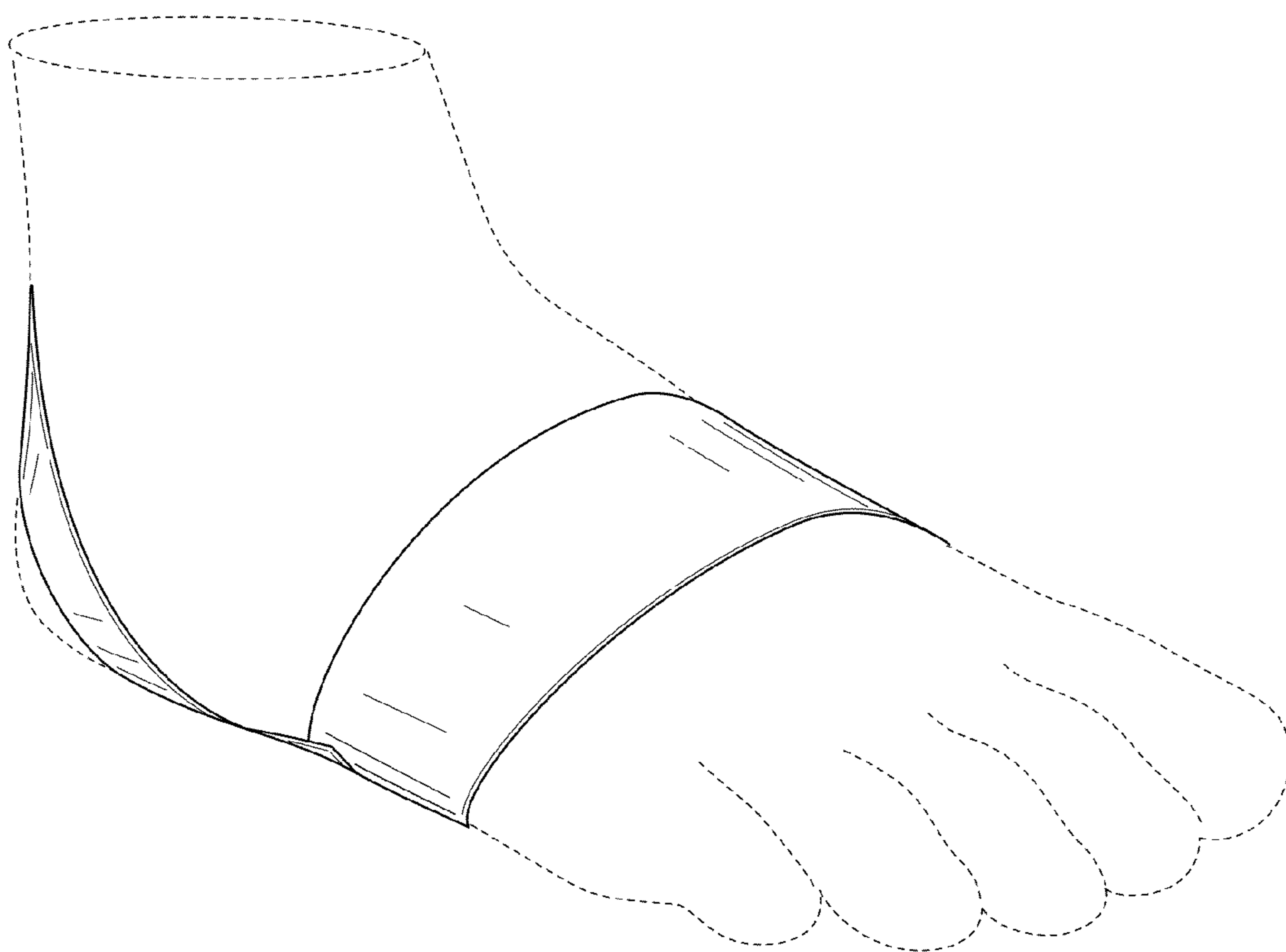

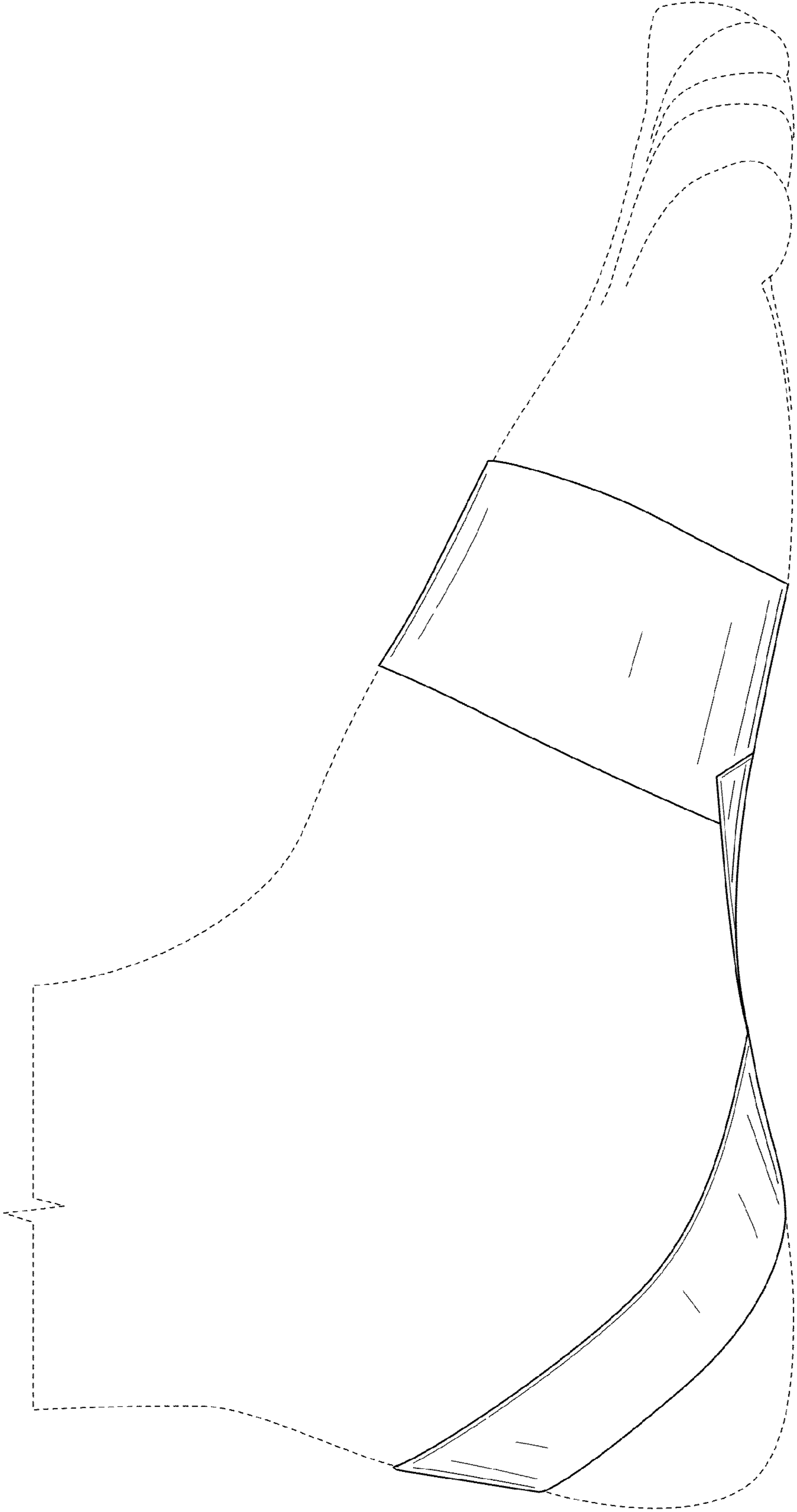

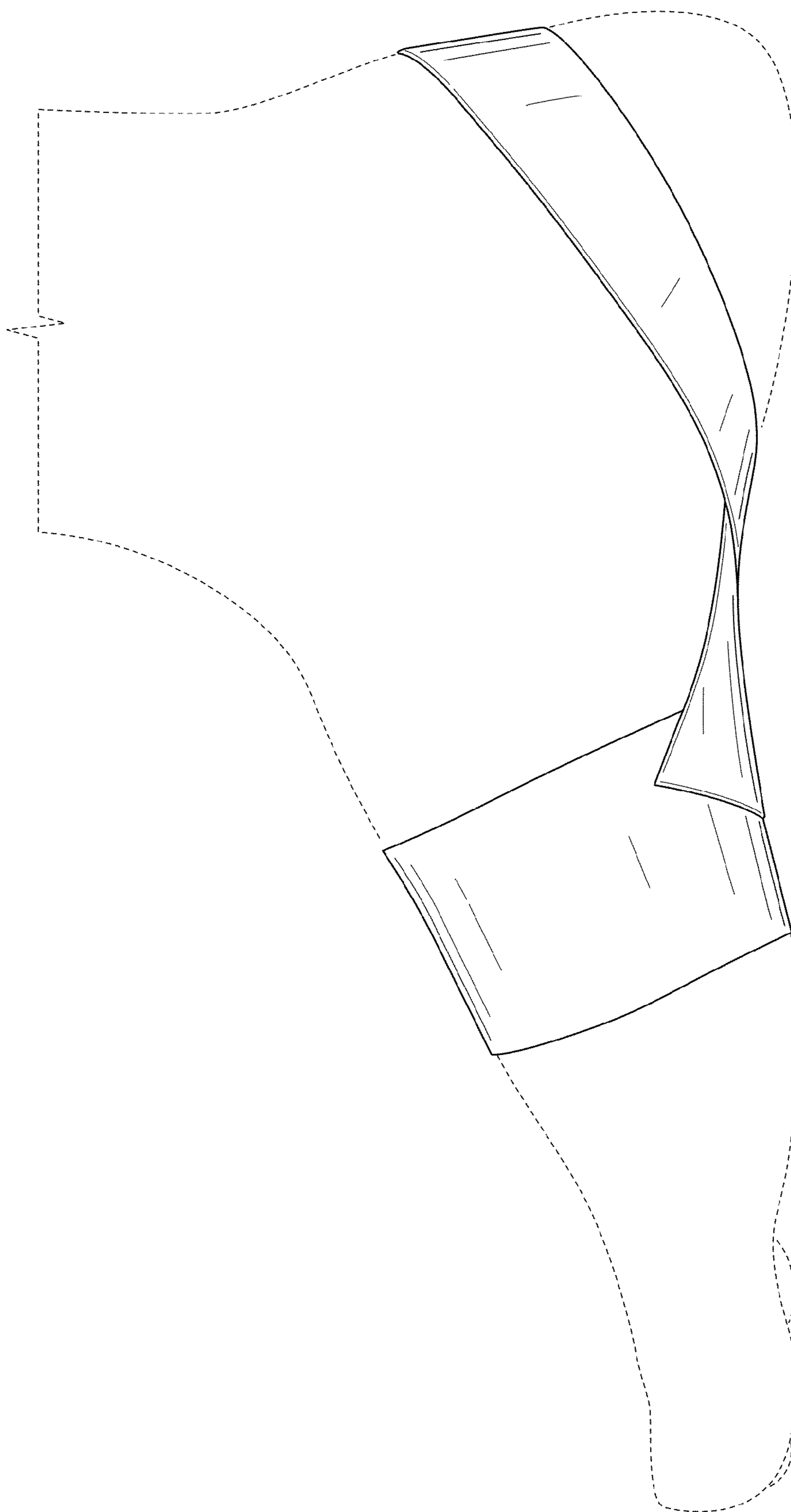

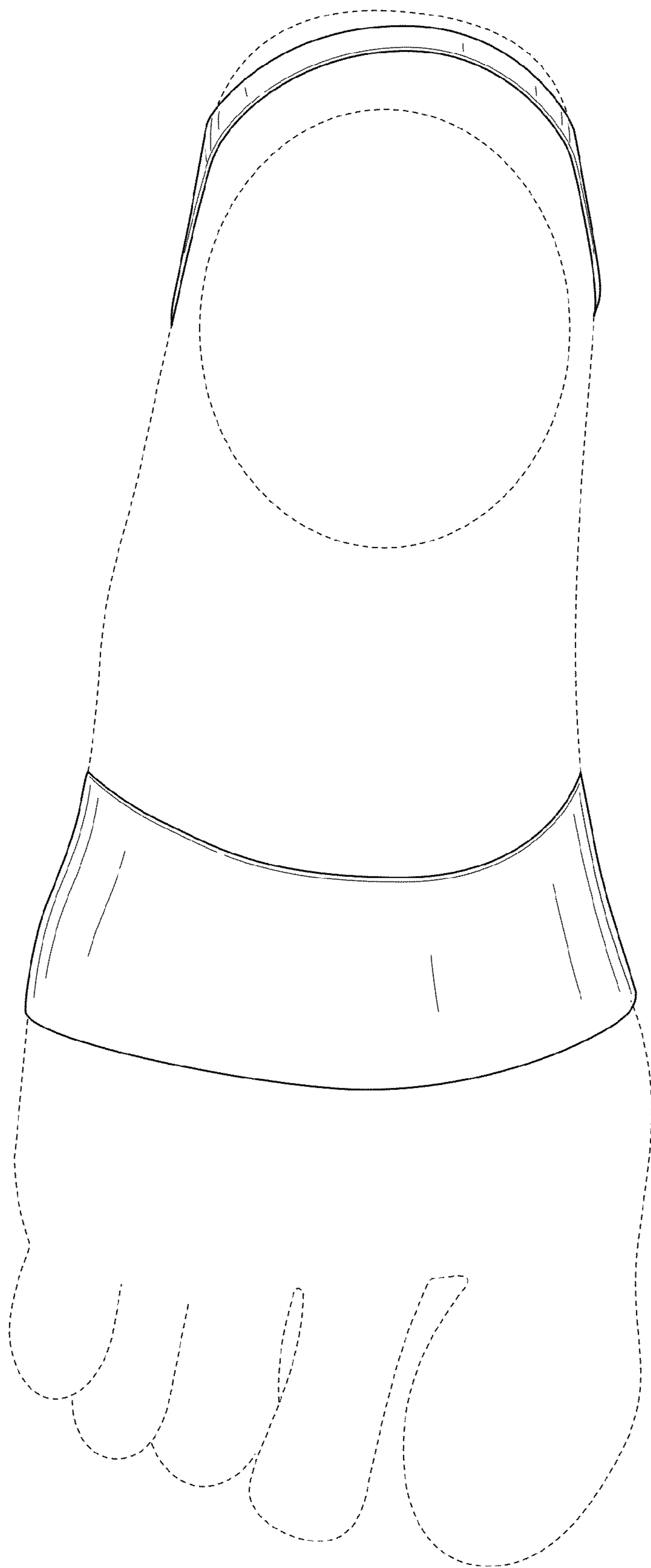

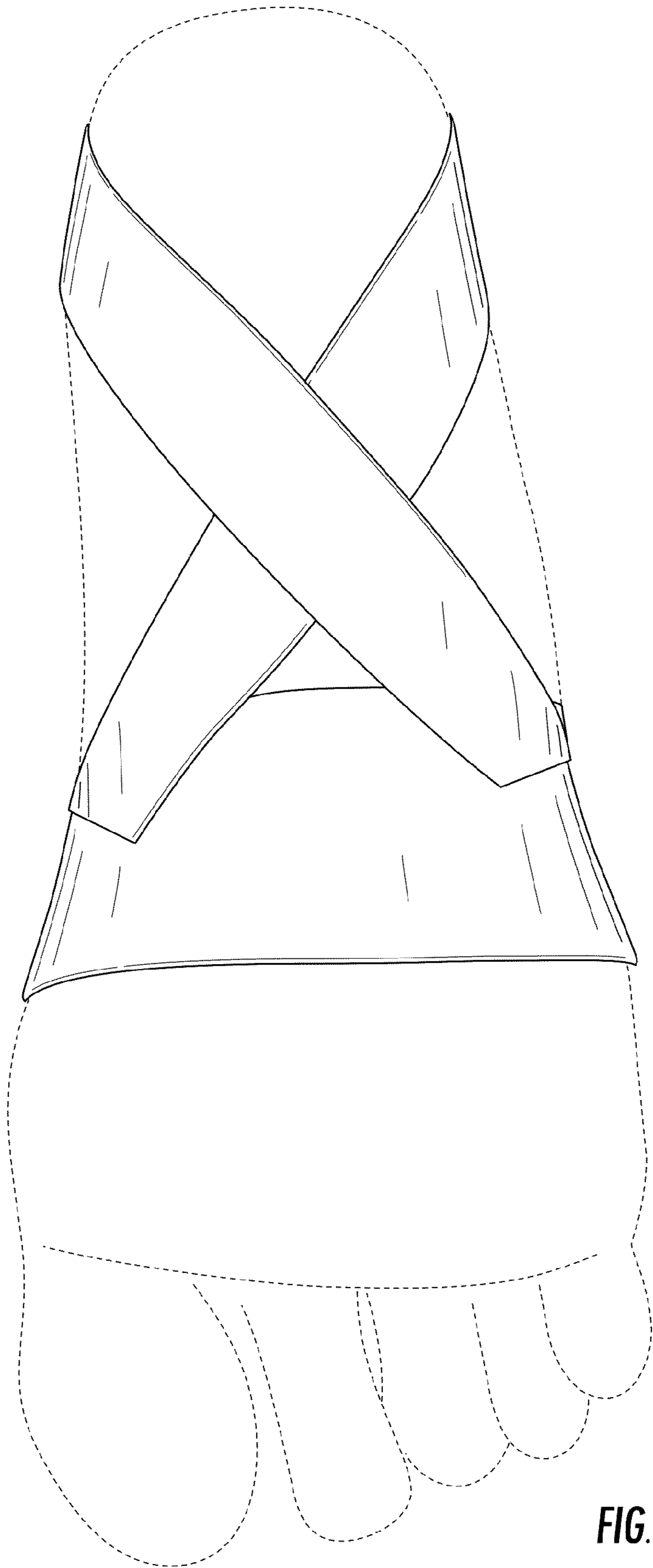

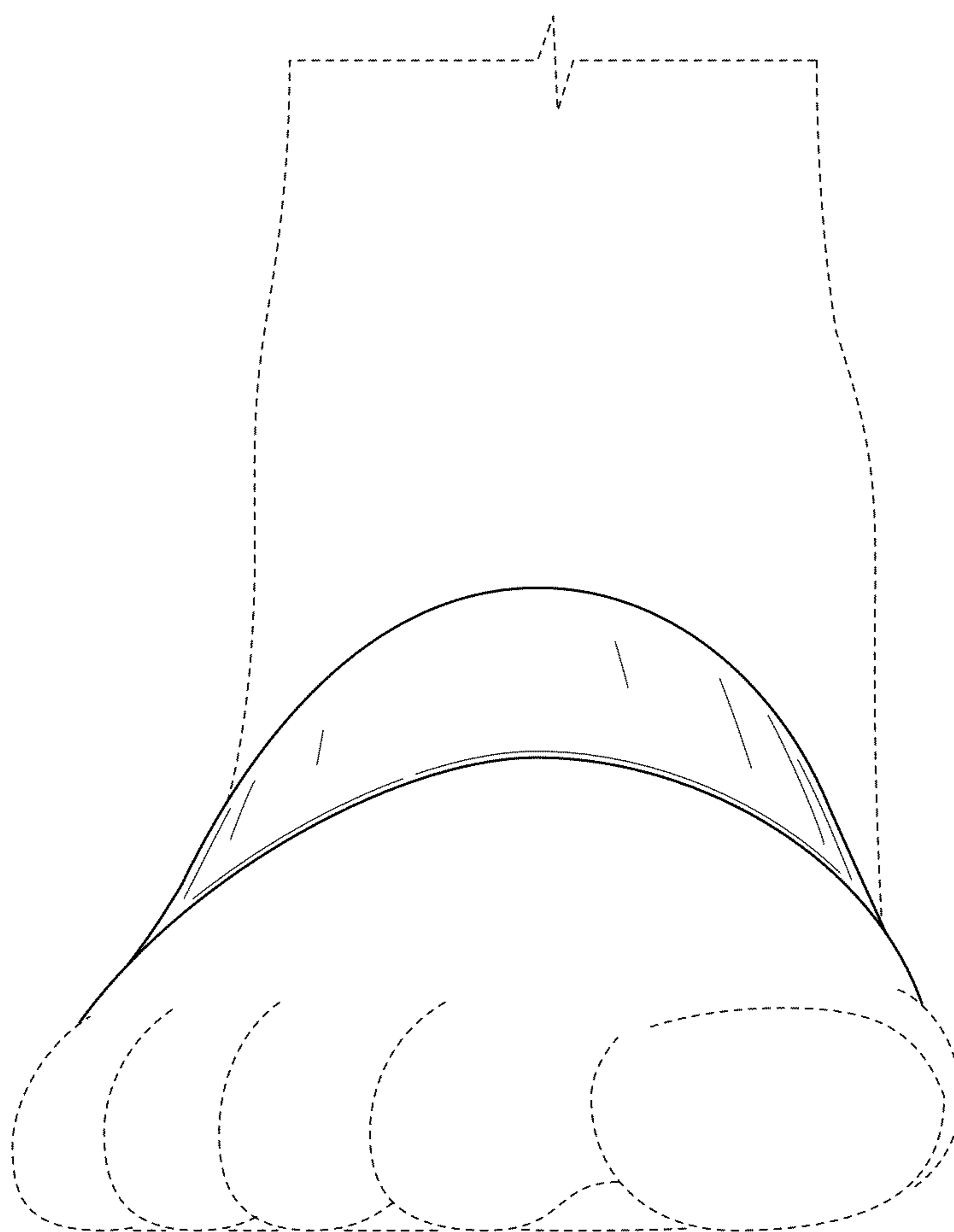

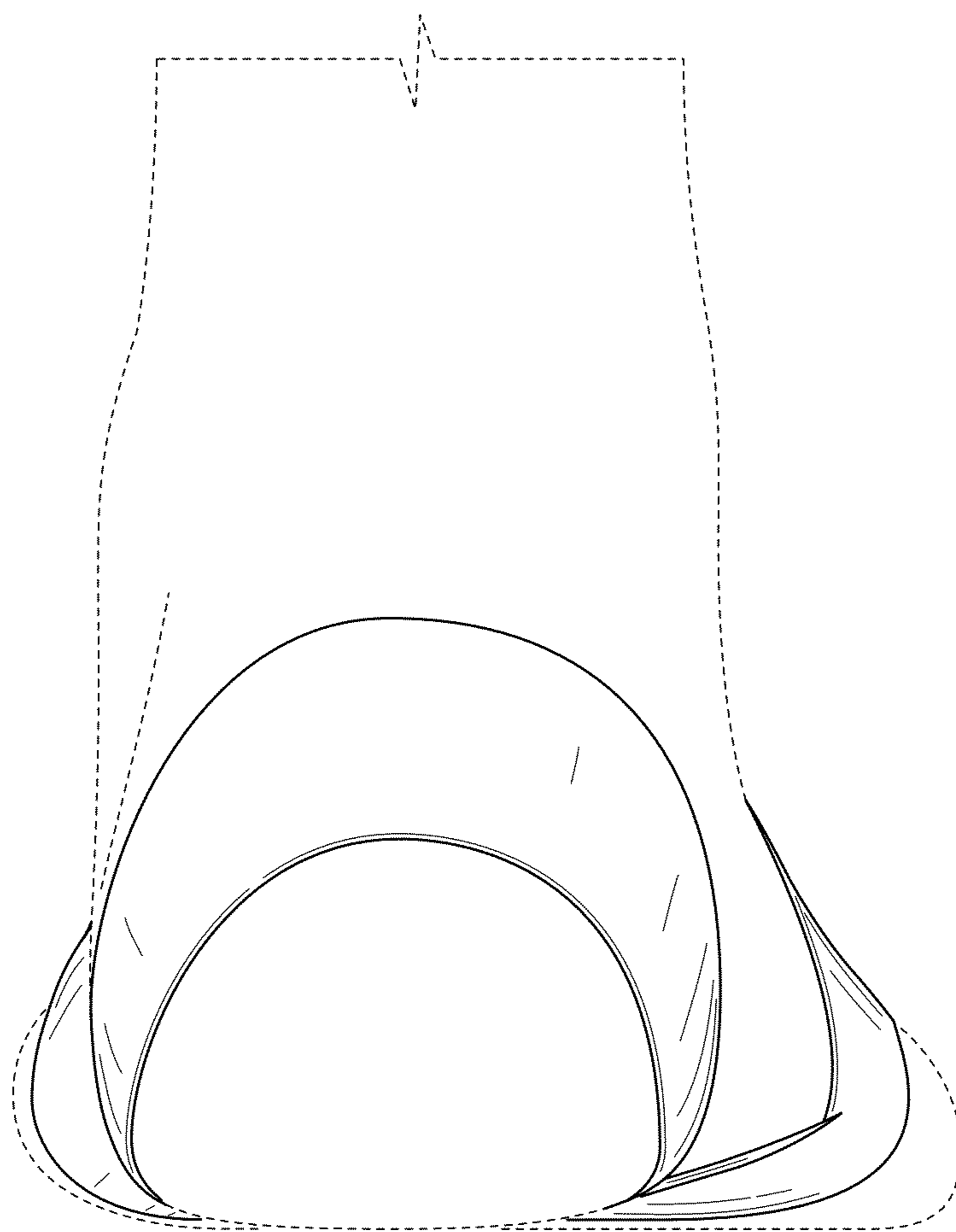
