FIG. 4 is a rear view of the design.

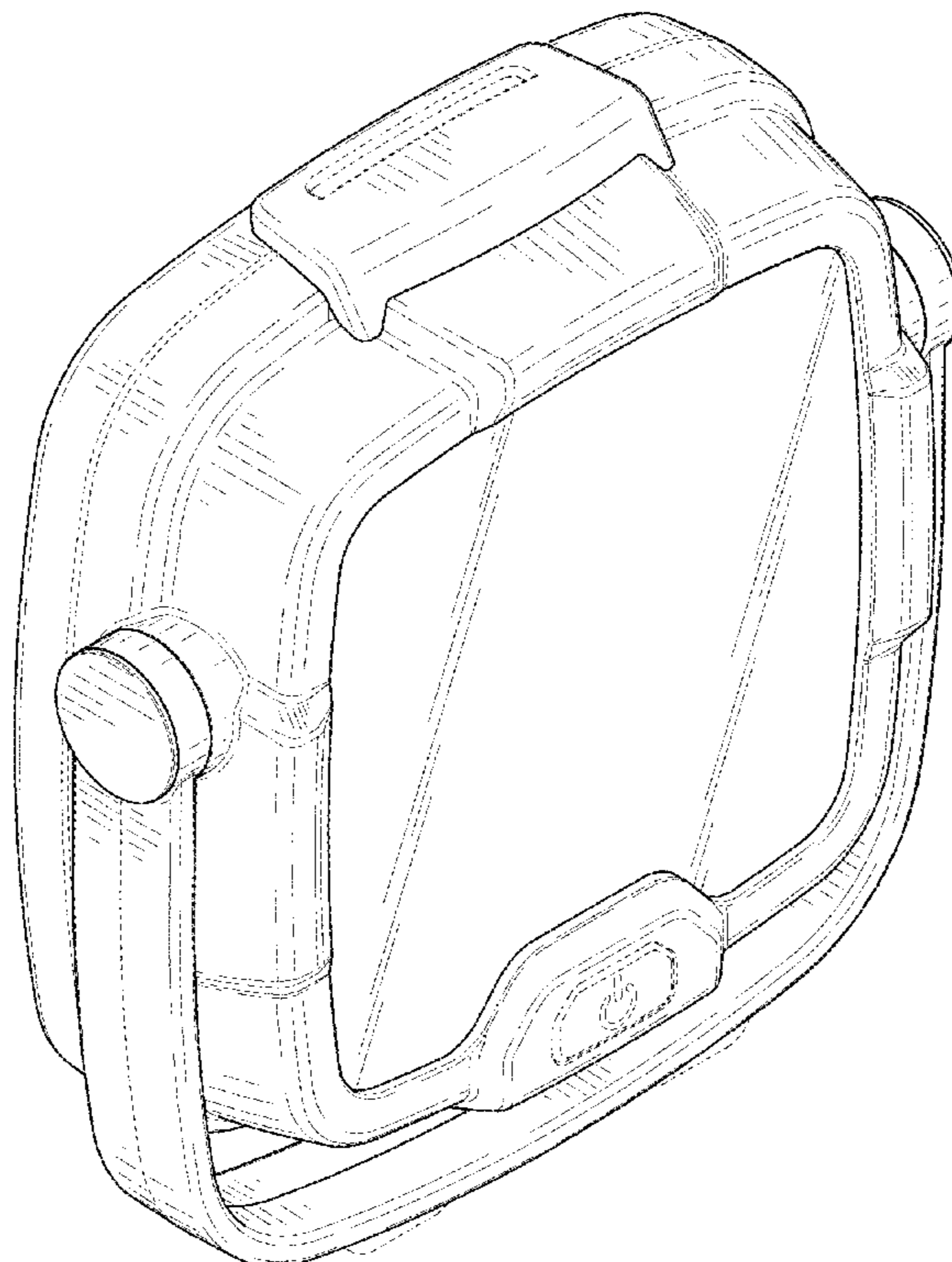
FIG. 5 is a left side view of the design.

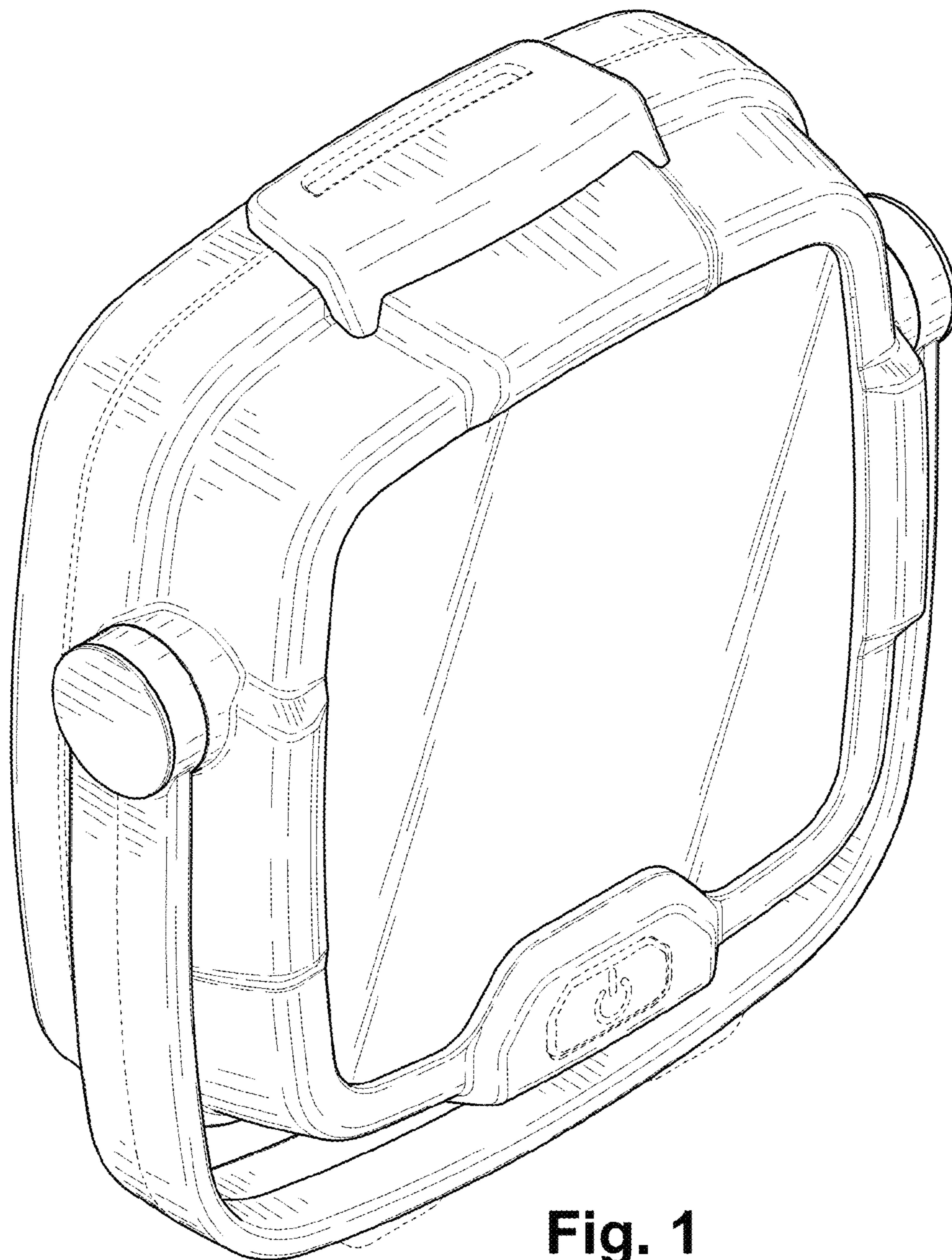
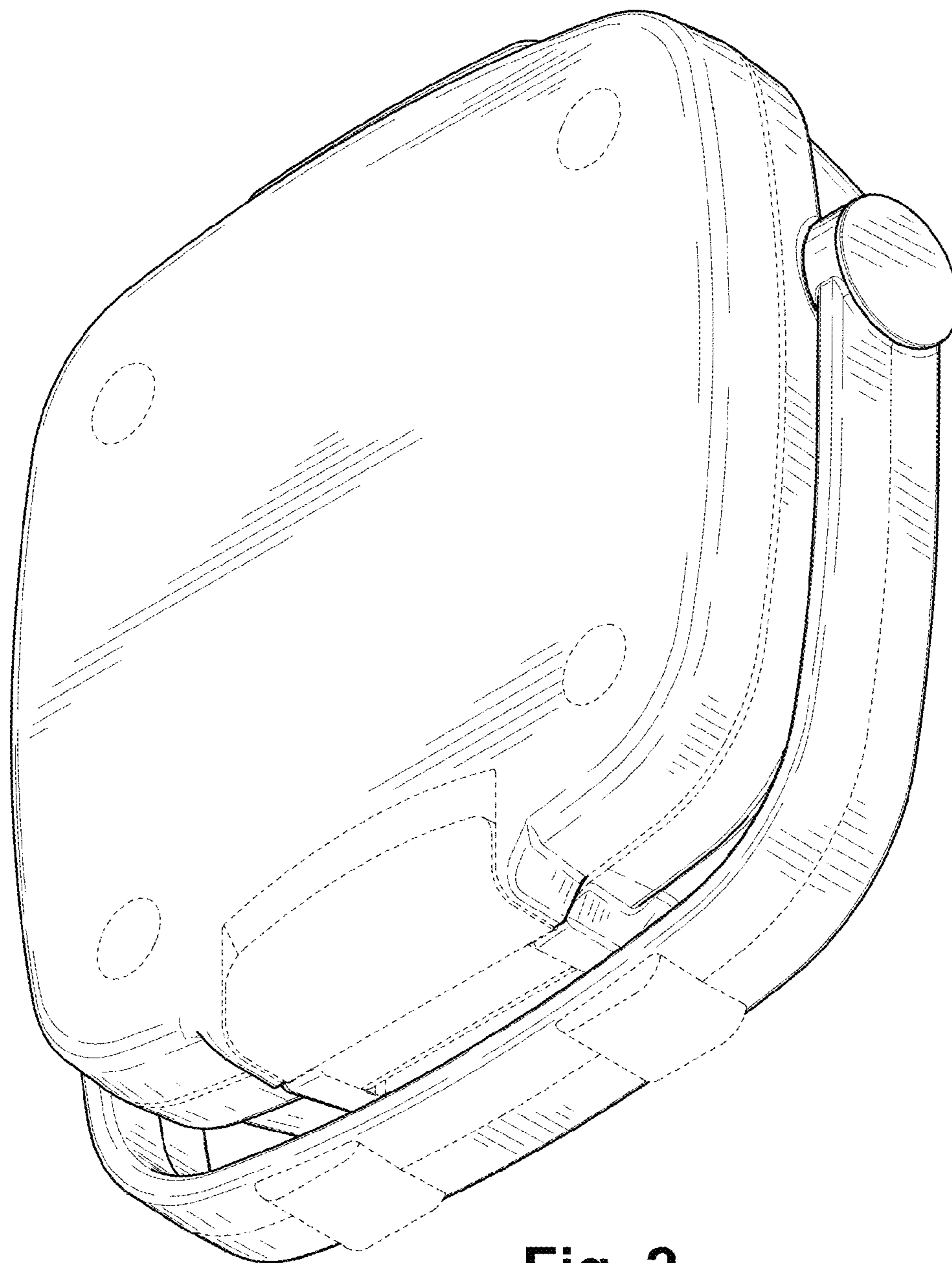

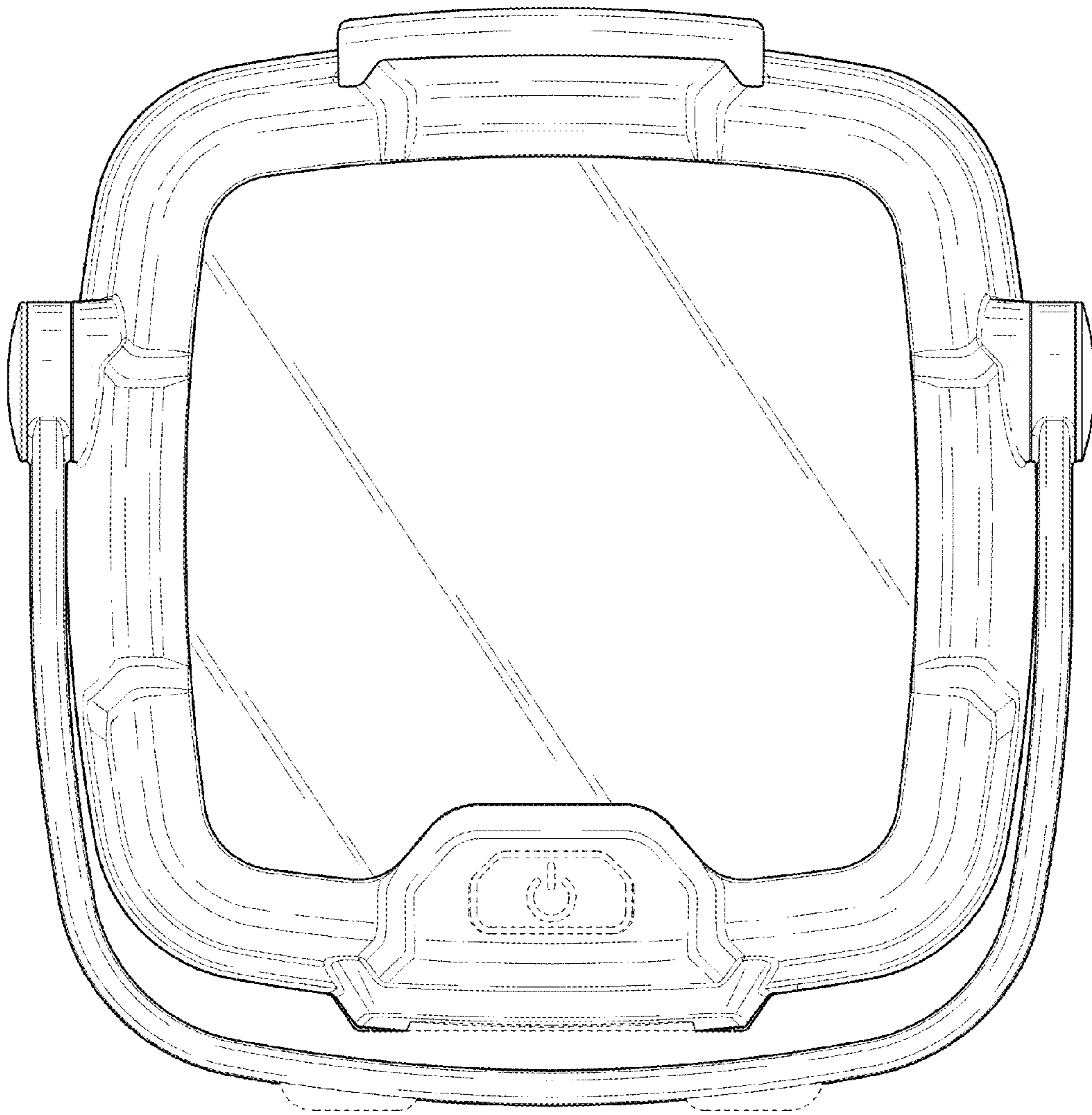

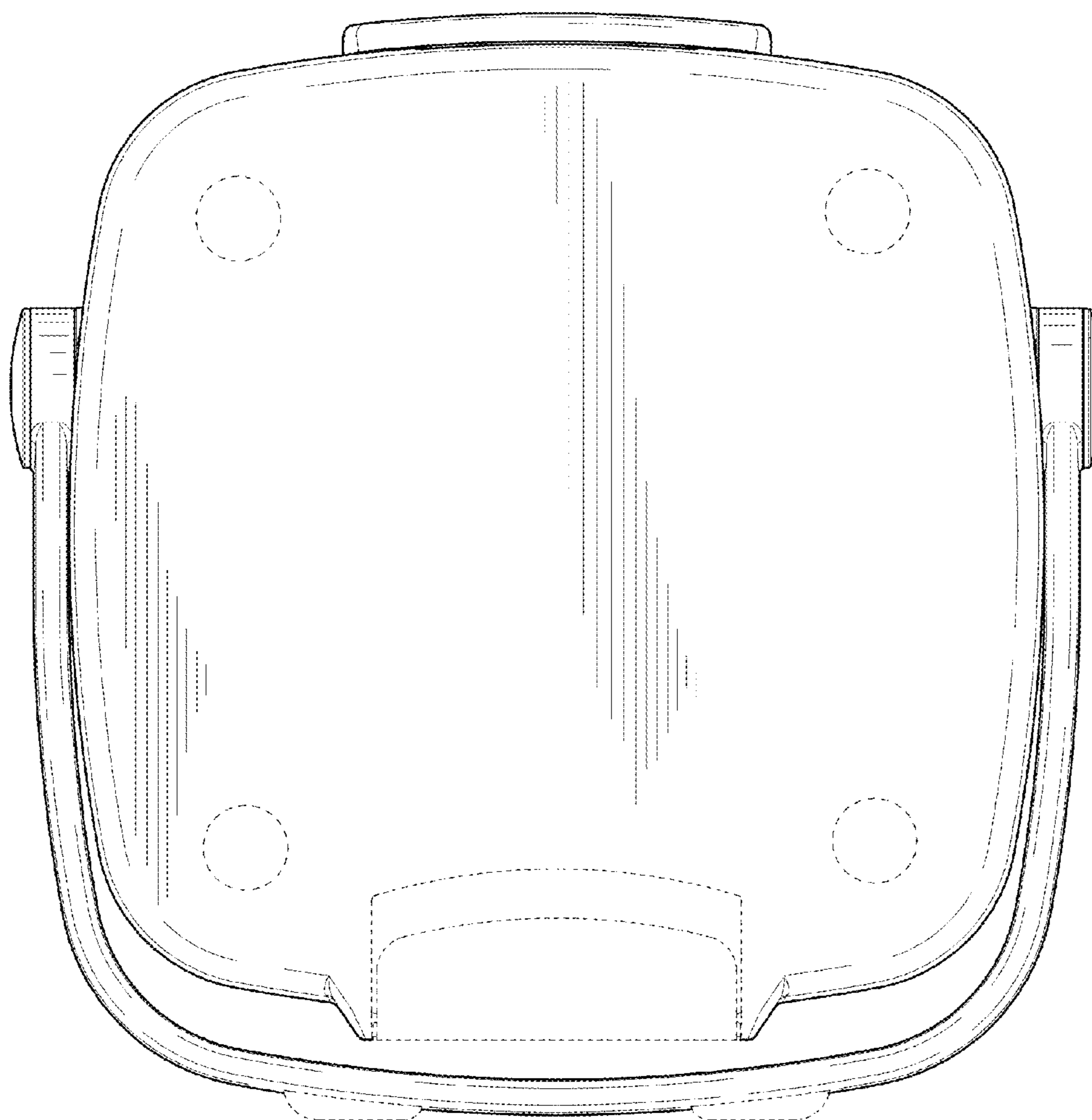
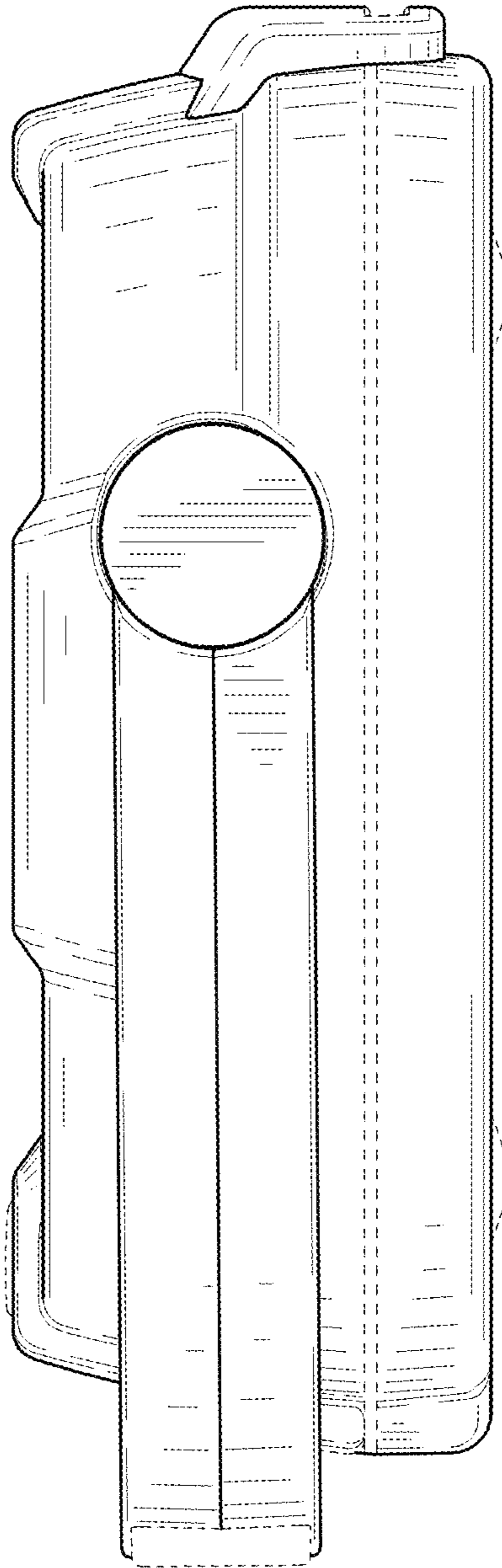
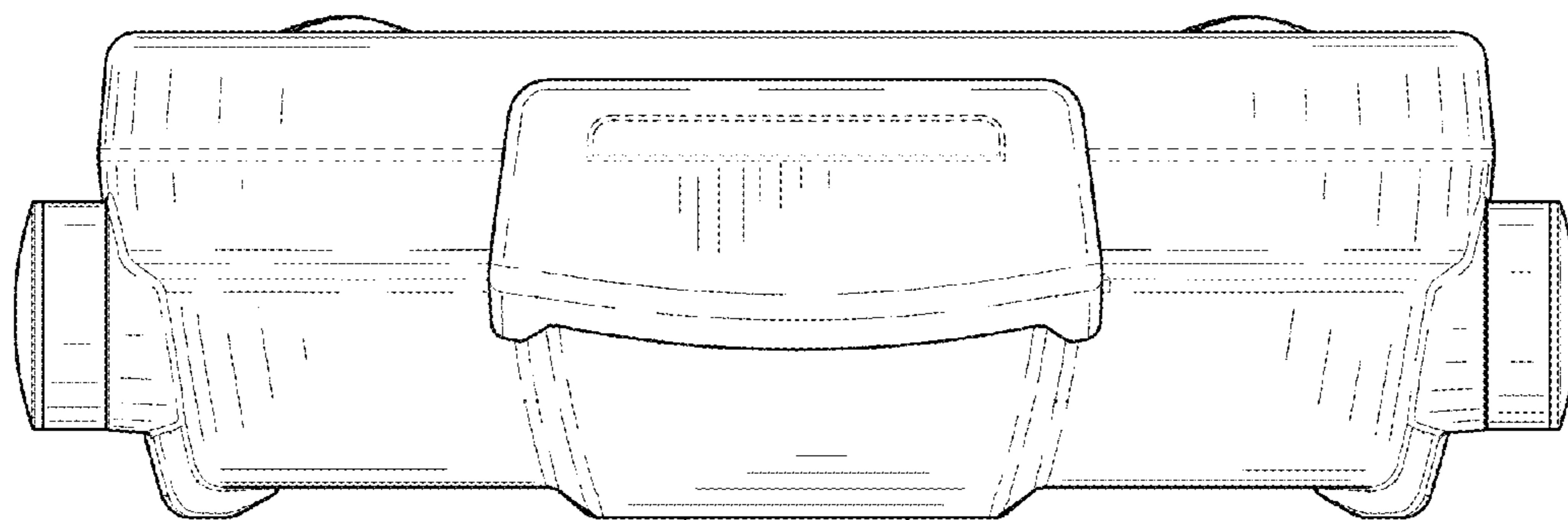


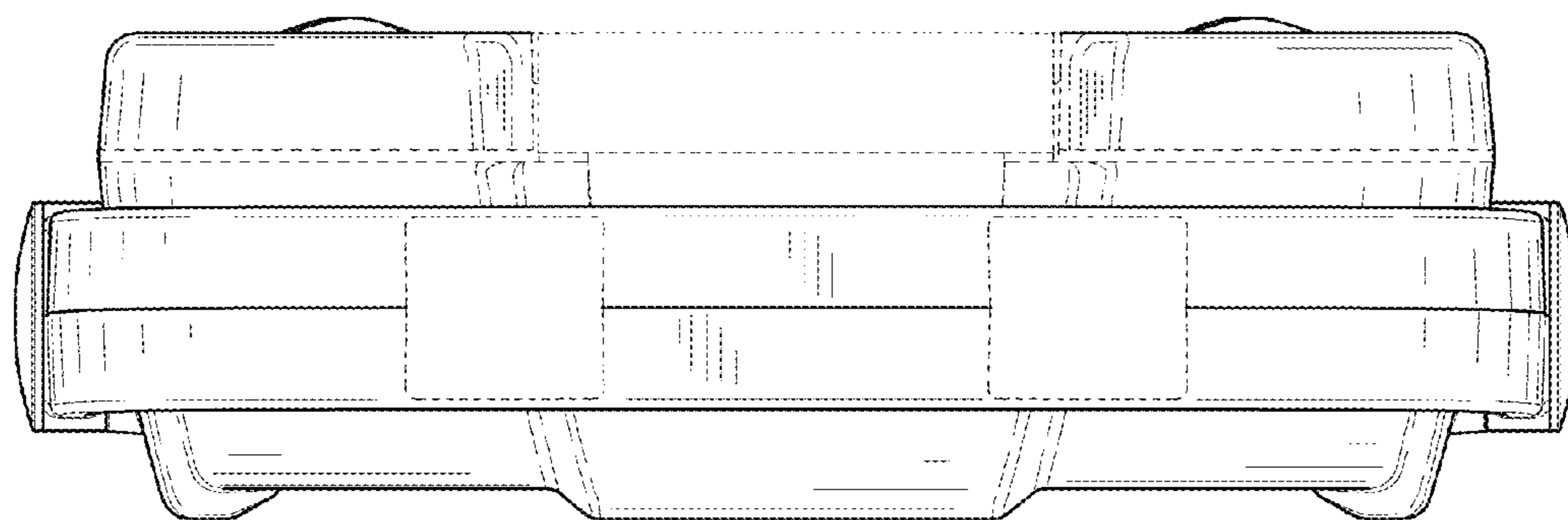
