FIG. 4 is a right view of the lamp shown in FIG. 1;

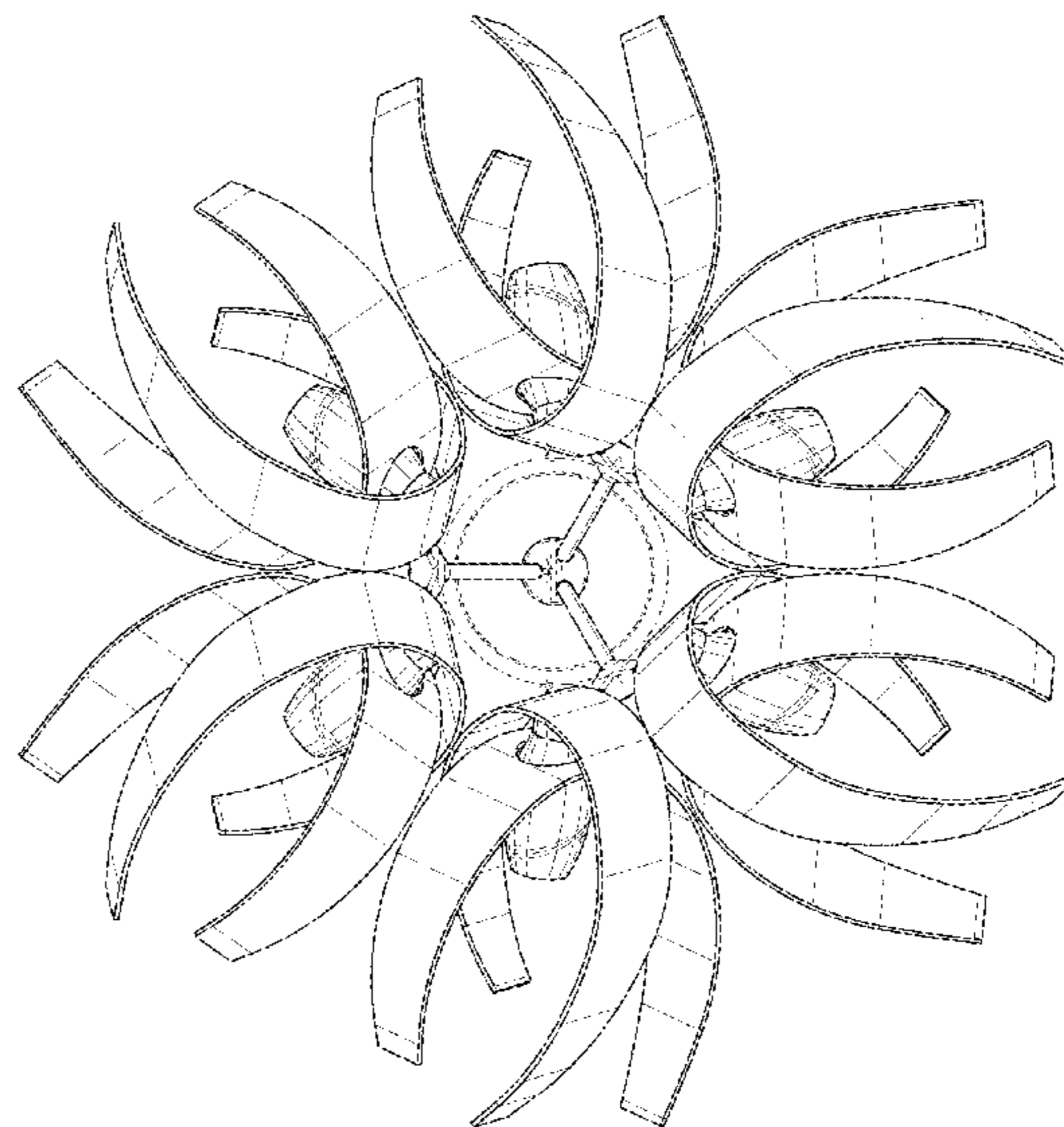
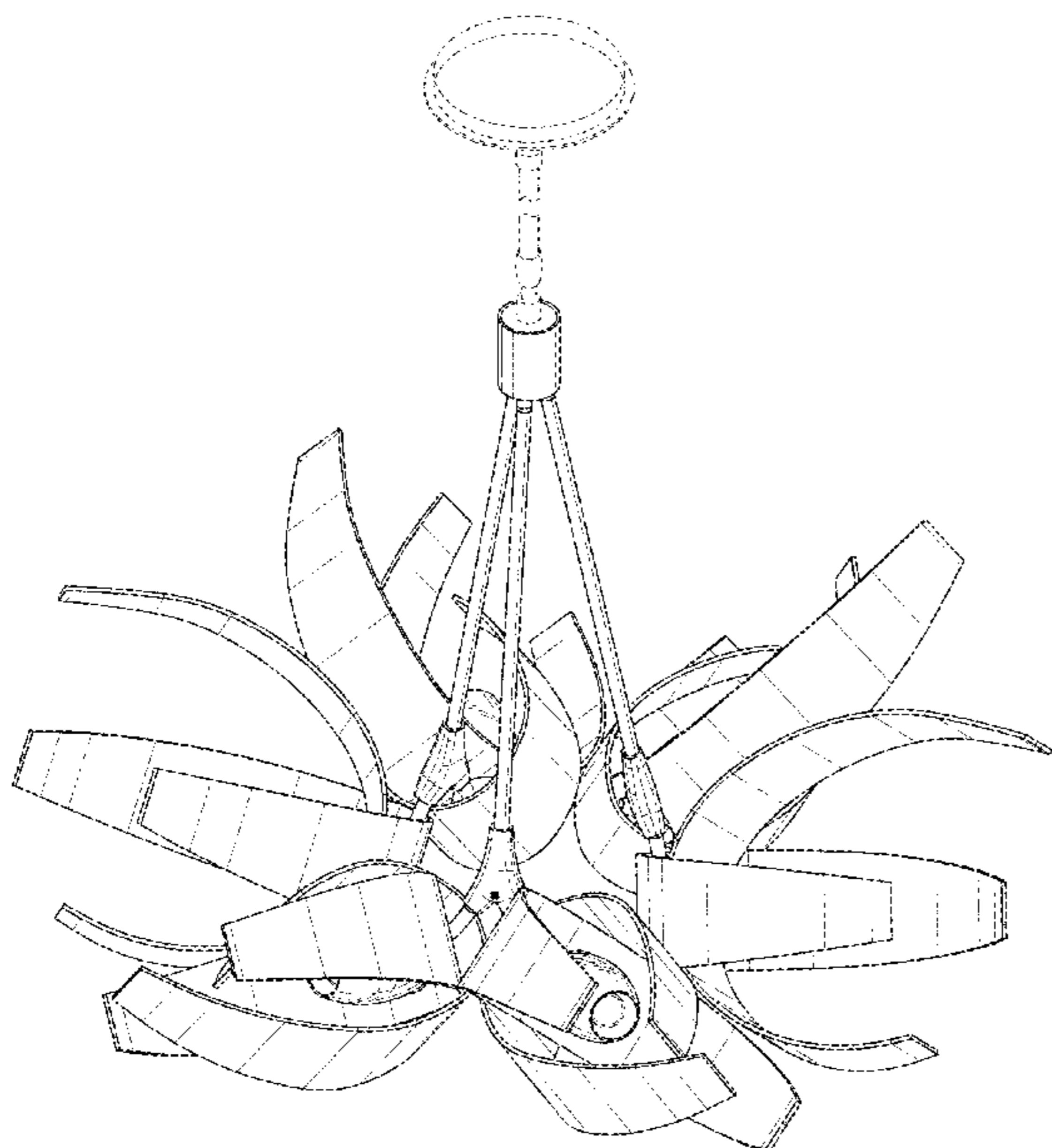
FIG. 5 is a left view of the lamp shown in FIG. 1;

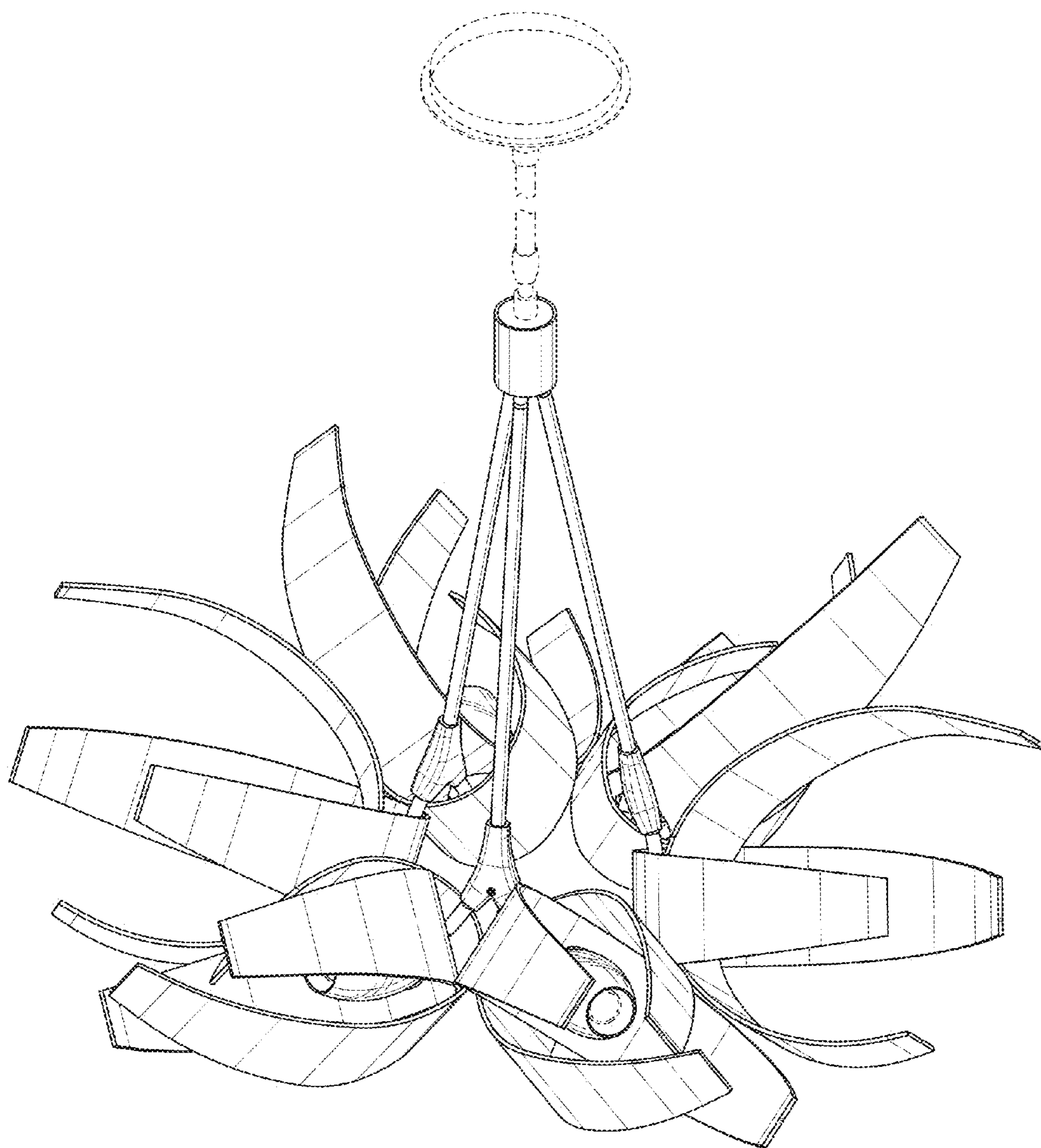

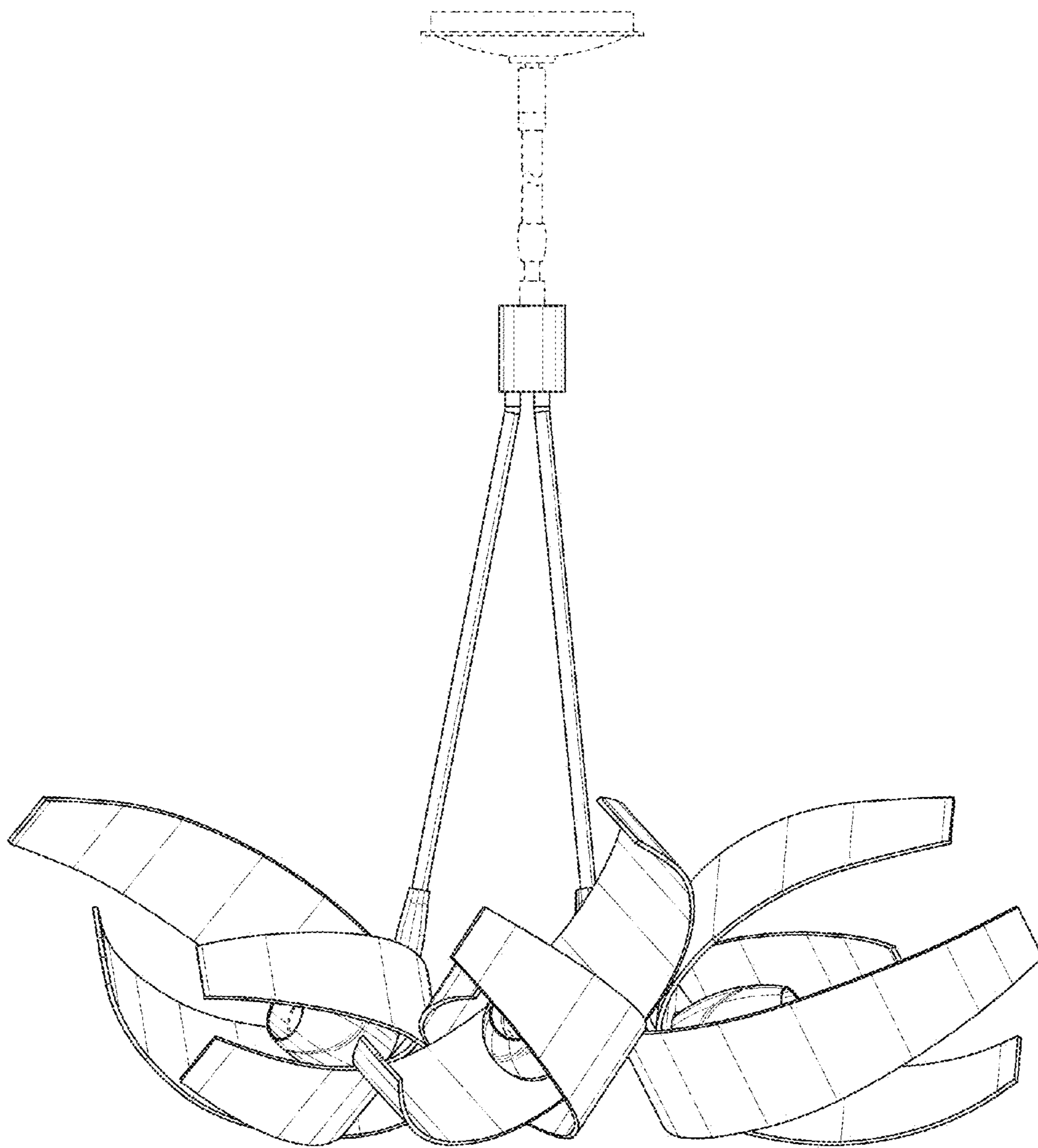

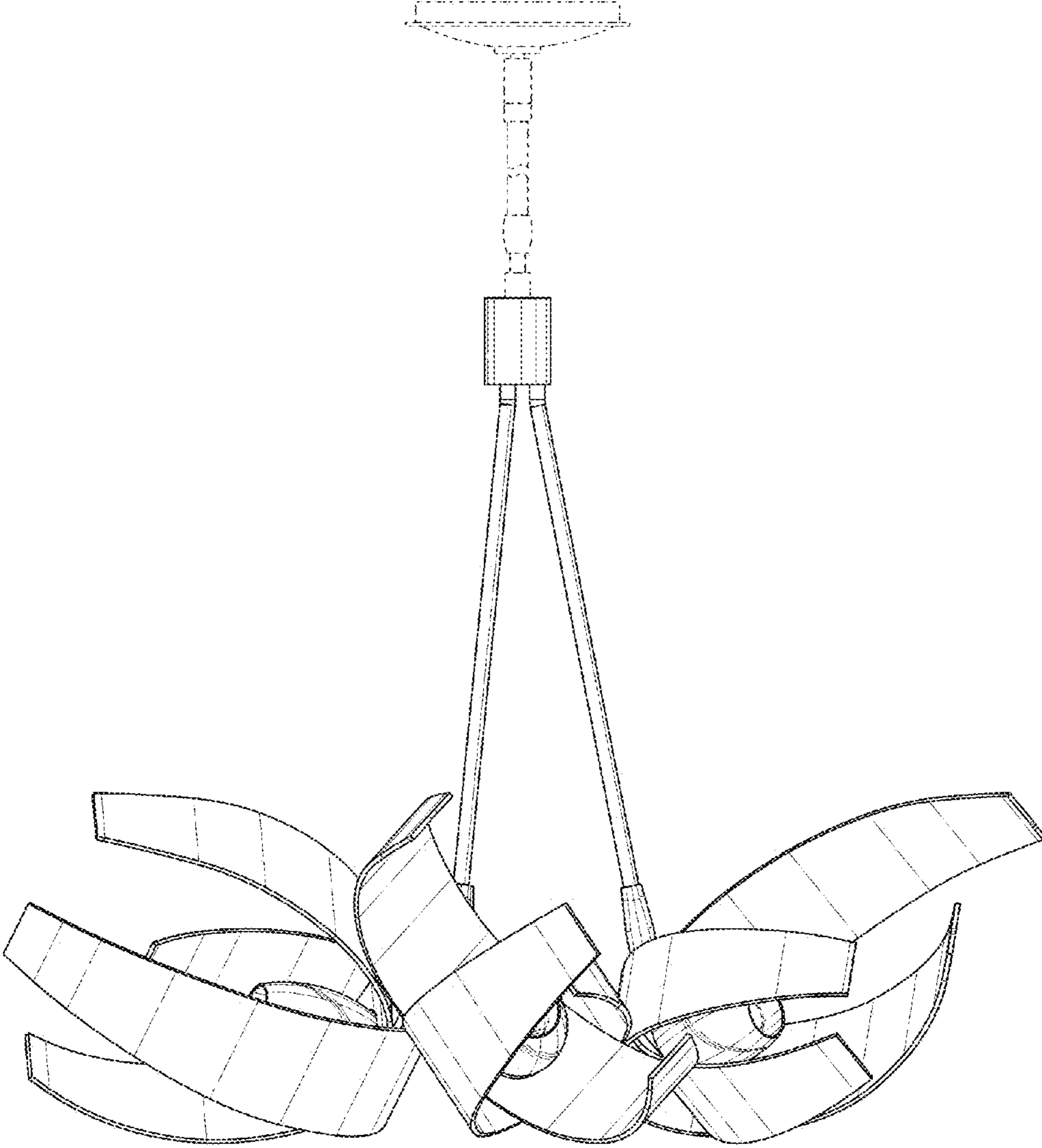

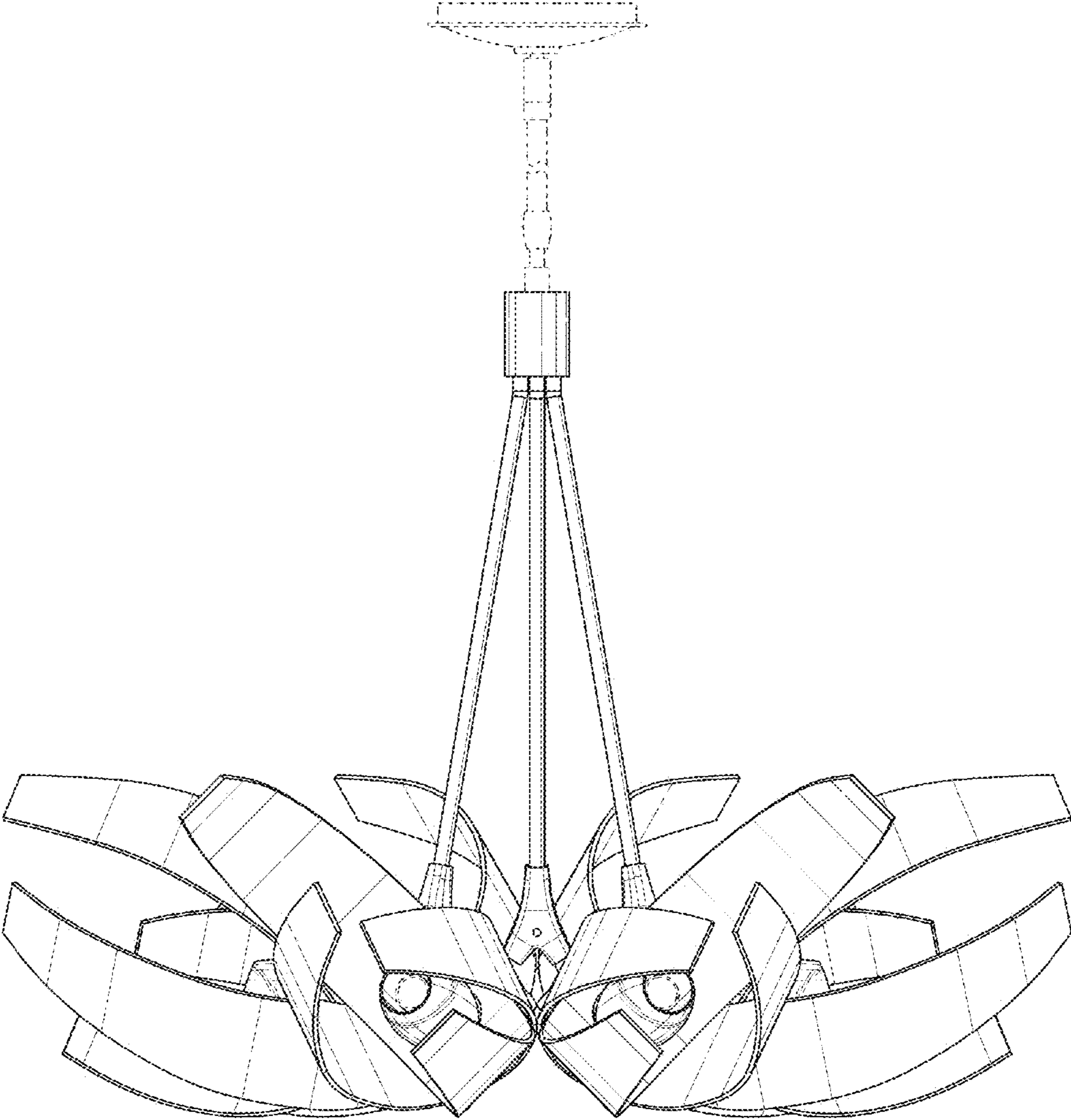

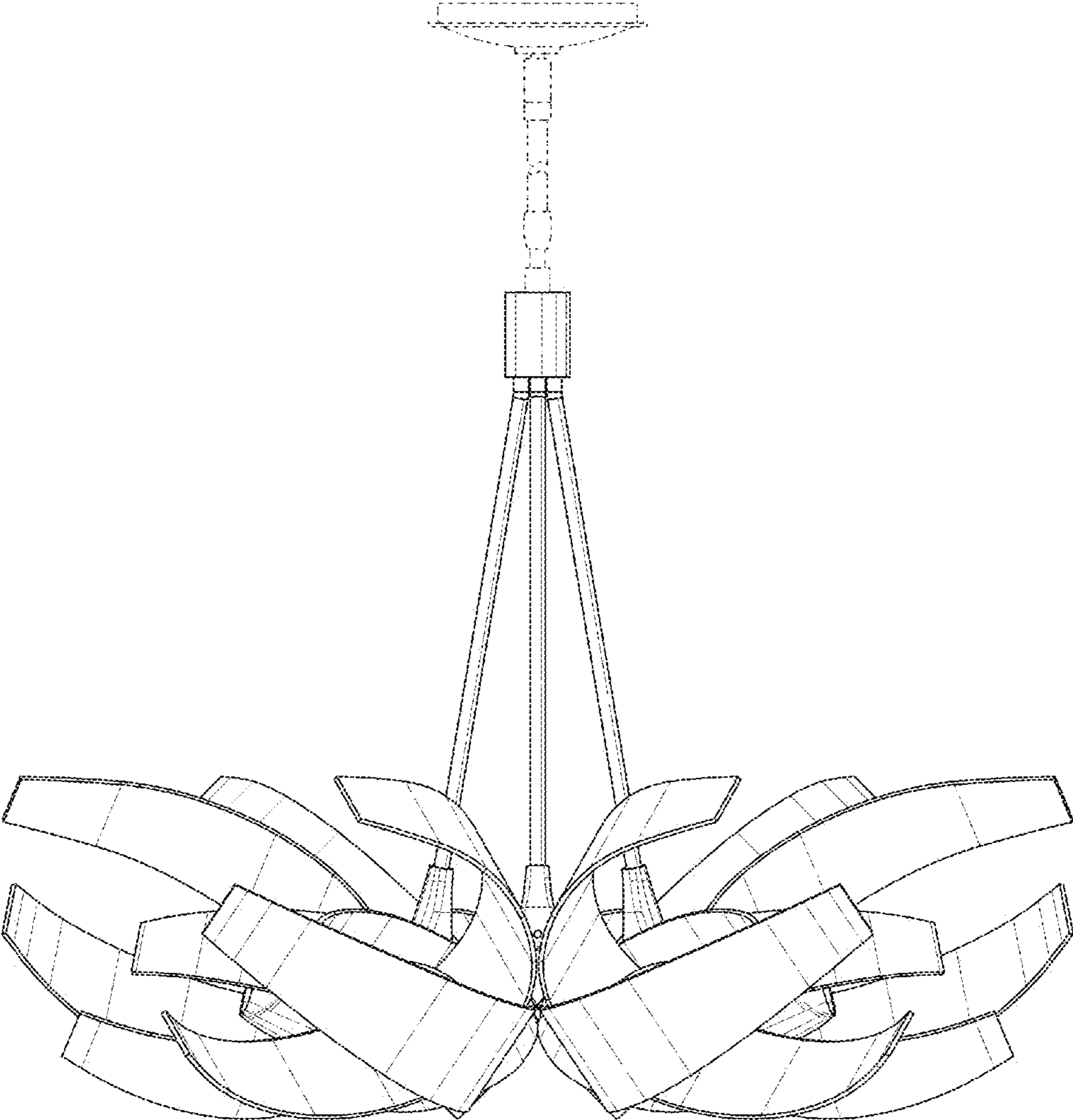

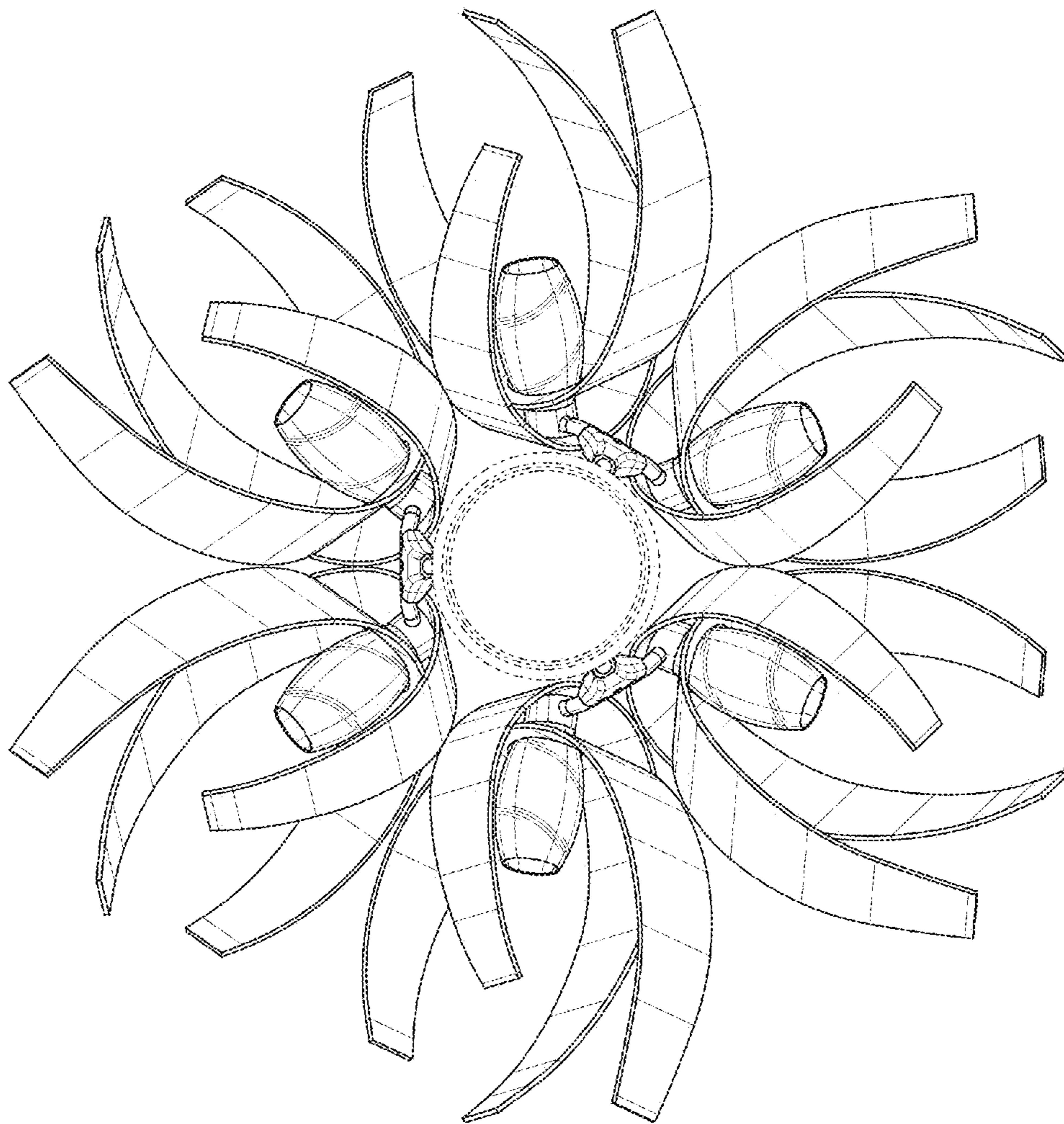

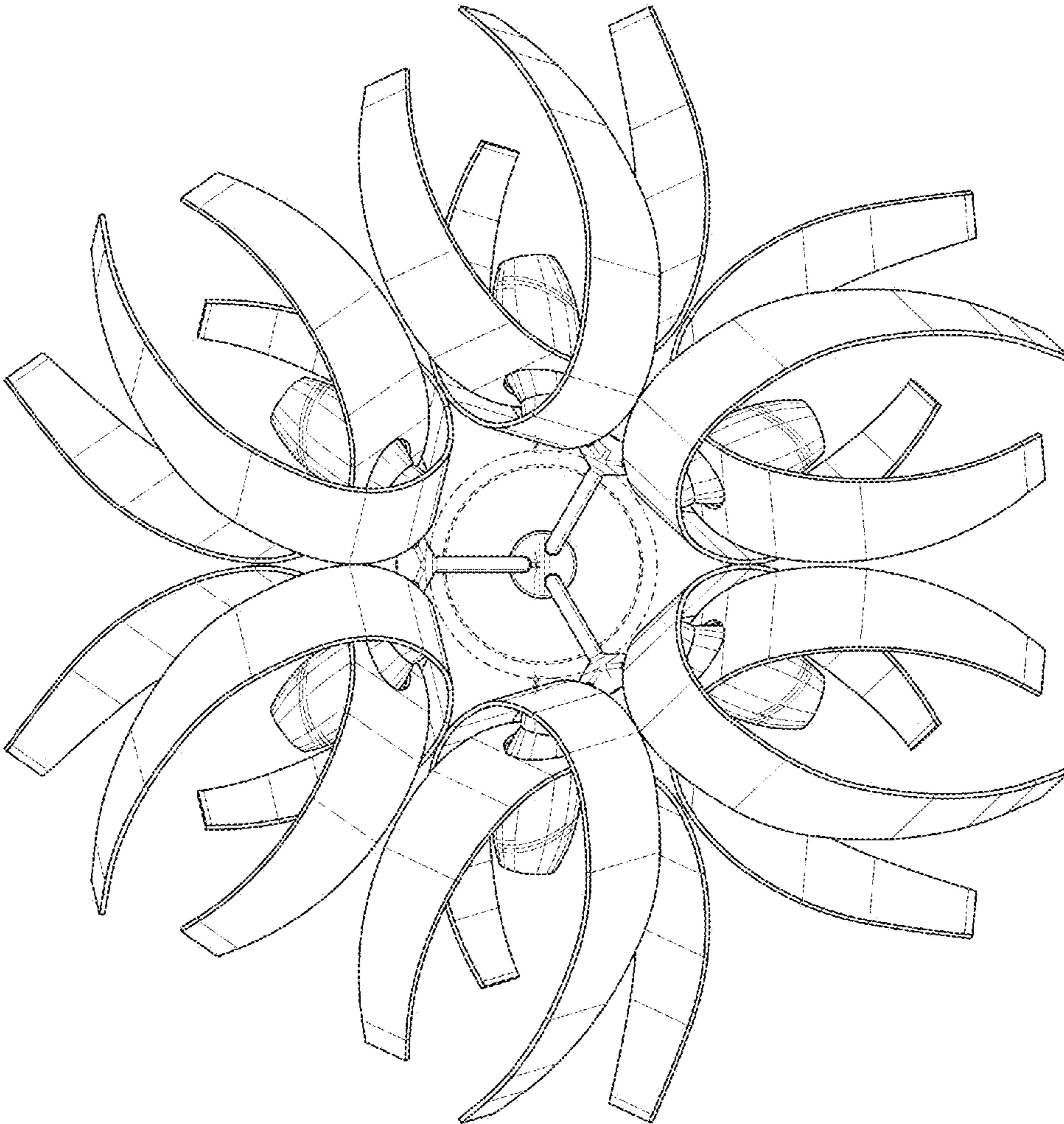
