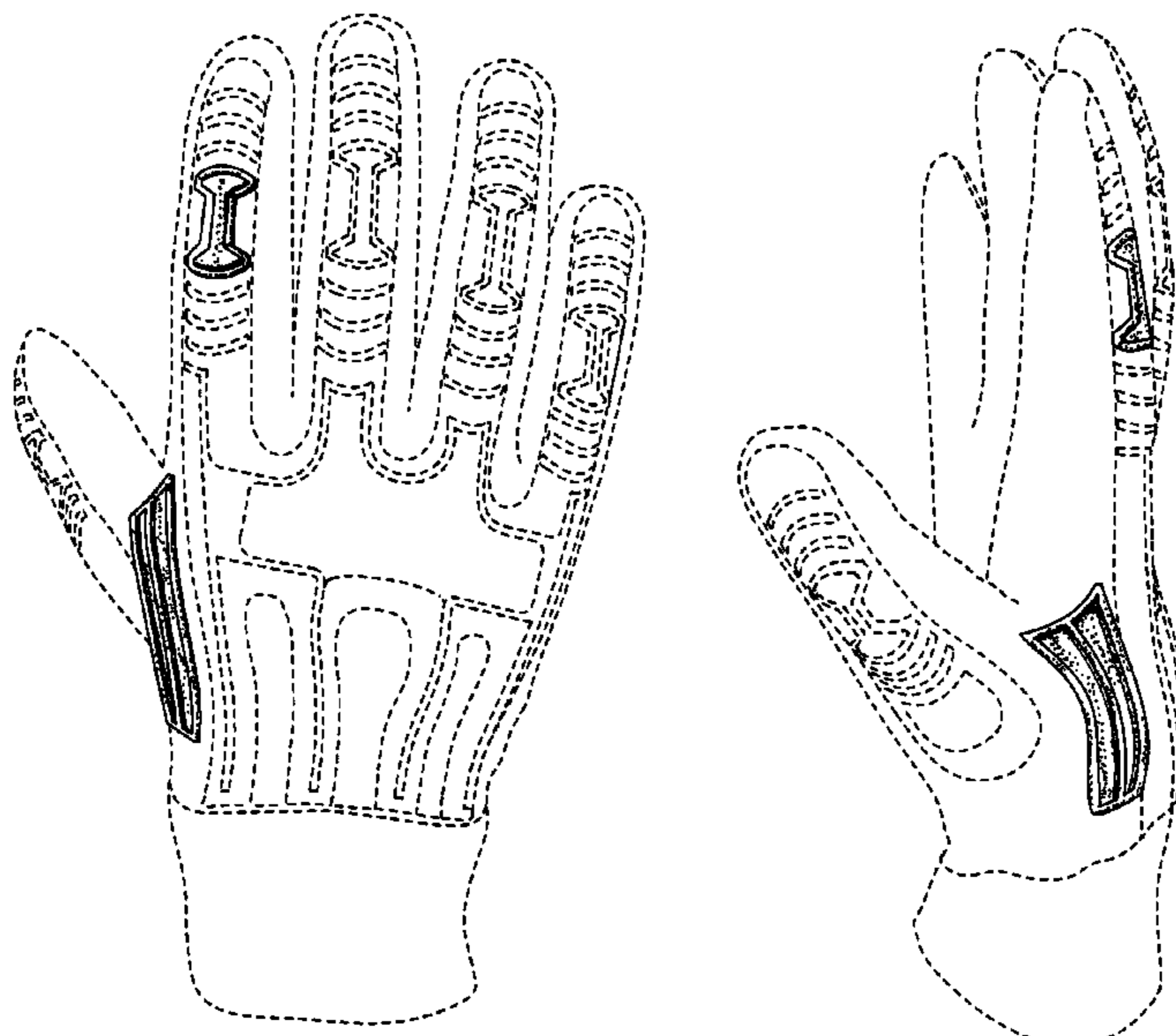
(57) **CLAIM**

I claim the ornamental design for a glove, as shown and described.

DESCRIPTION

FIG. 1 is a back elevational view of one embodiment of a glove of the present invention;
FIG. 2 is a front elevational view of the glove of FIG. 1;
FIG. 3 is a first side elevational view of the glove of FIG. 1;
FIG. 4 is a second side elevational view of the glove of FIG. 1; and,
FIG. 5 is a top plan view of the glove of FIG. 1.

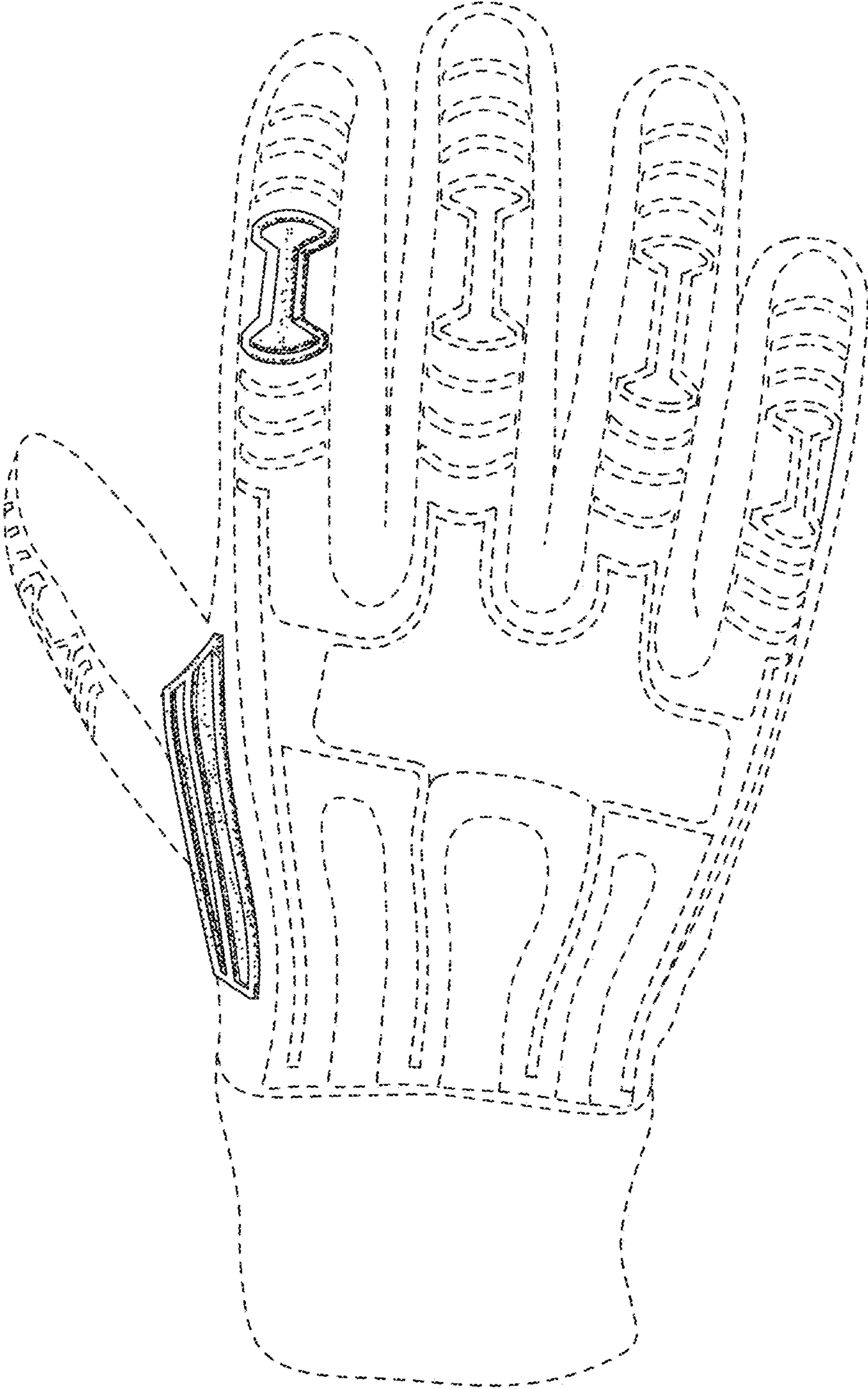

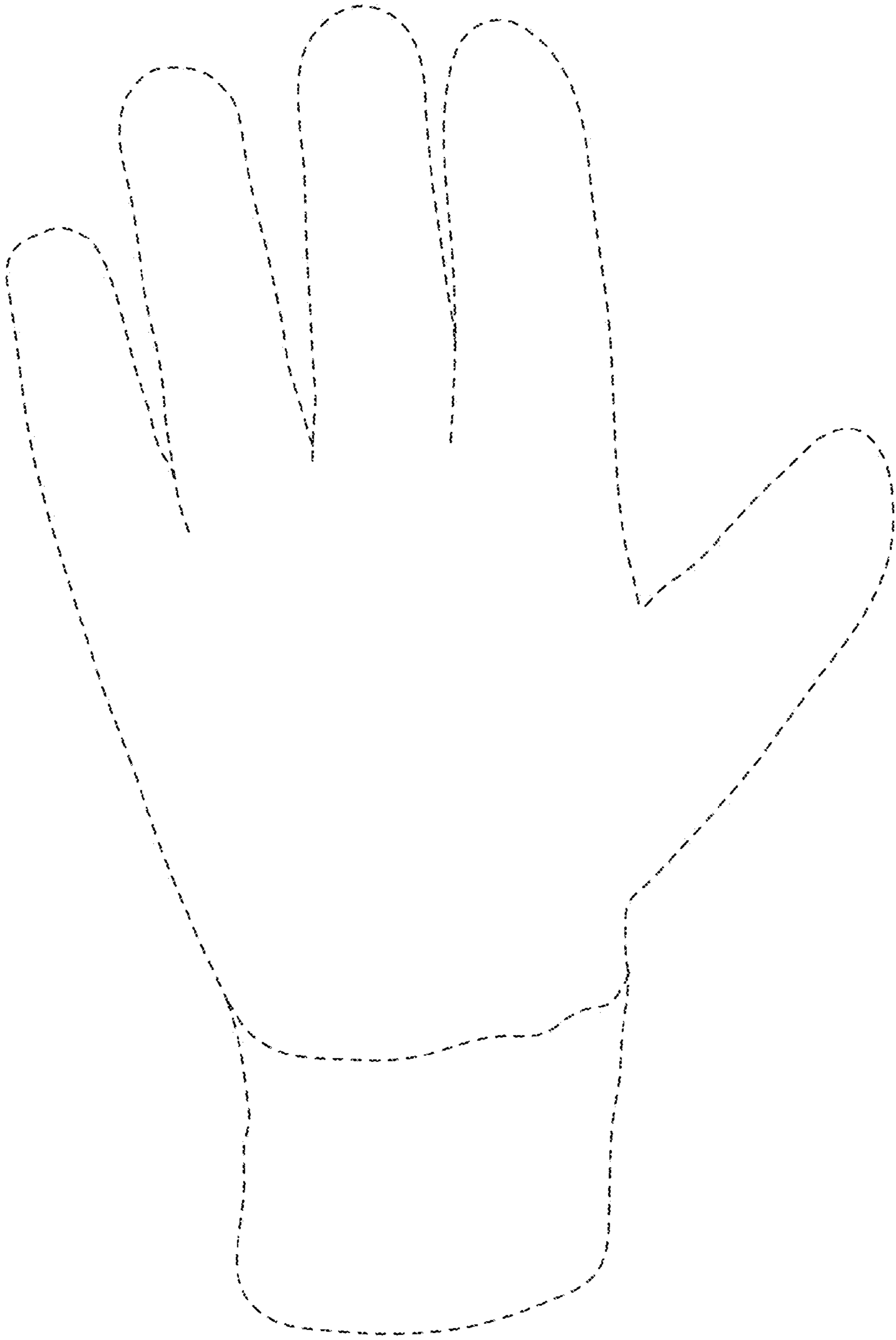

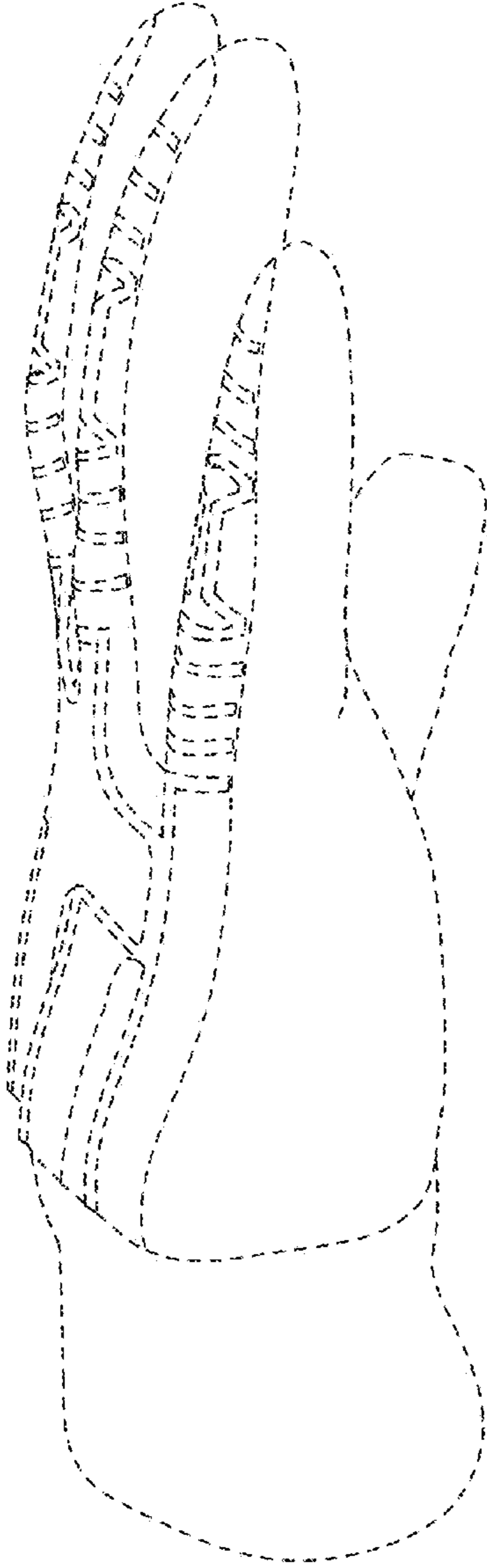

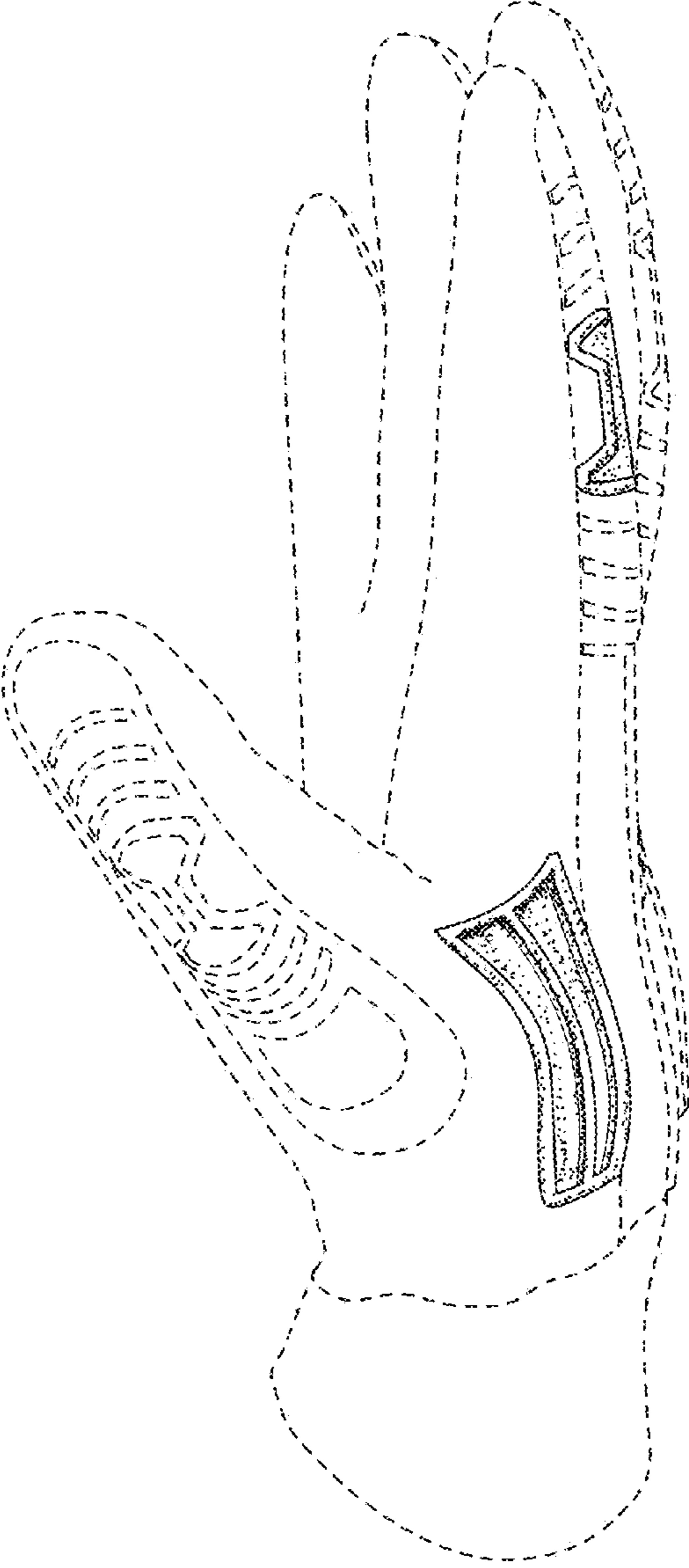

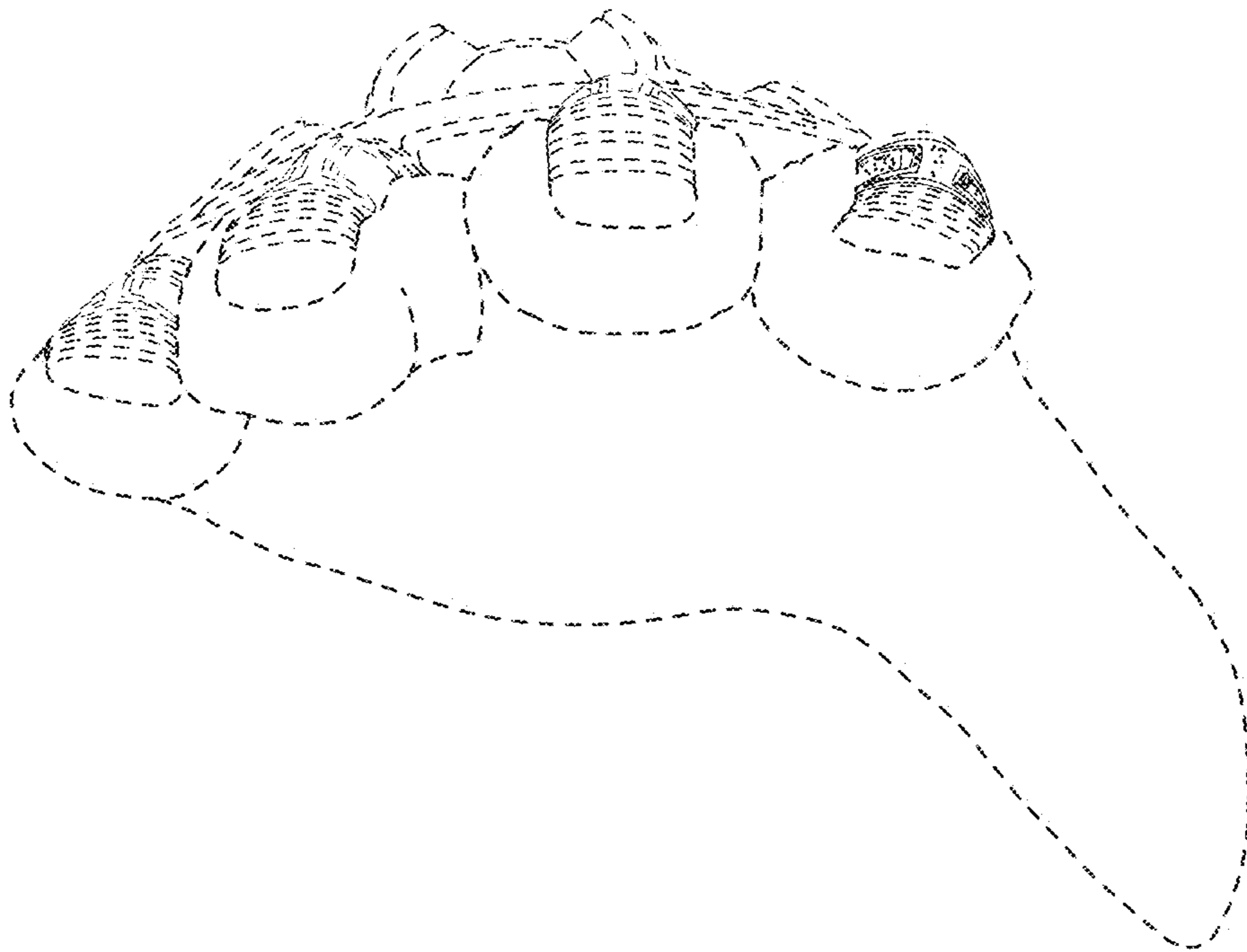
