(57) **CLAIM**

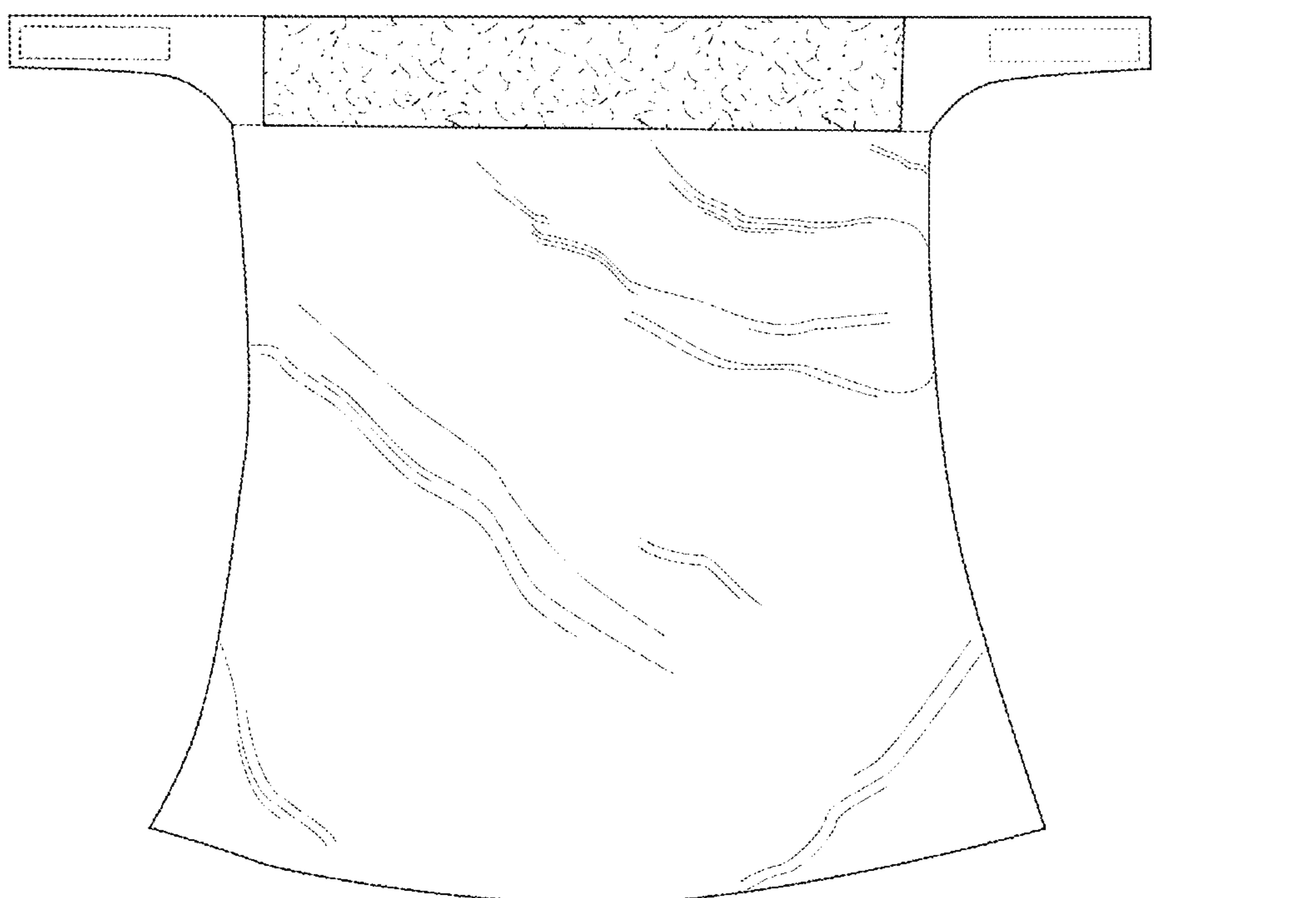
The ornamental design for a bandana, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a bandana.
FIG. 2 is a back elevation view of a bandana.
FIG. 3 is a right side elevation view of a bandana.
FIG. 4 is a left side elevation view of a bandana.
FIG. 5 is a top plan view of a bandana.
FIG. 6 is a bottom plan view of a bandana; and,
FIG. 7 is a perspective view of the bandana shown in FIGS. 1-6, except in a configuration wherein the front arms of the bandana are overlapping.

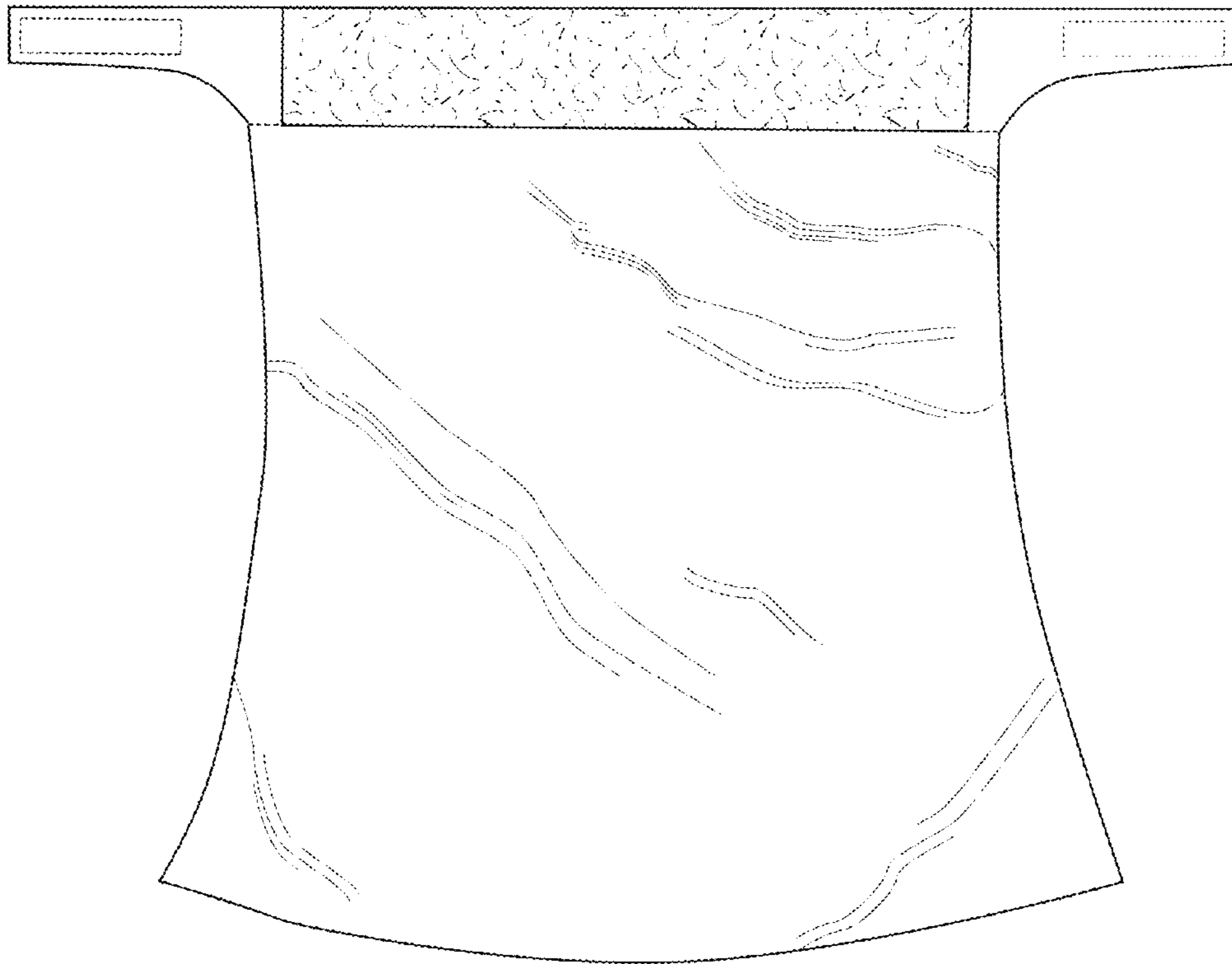

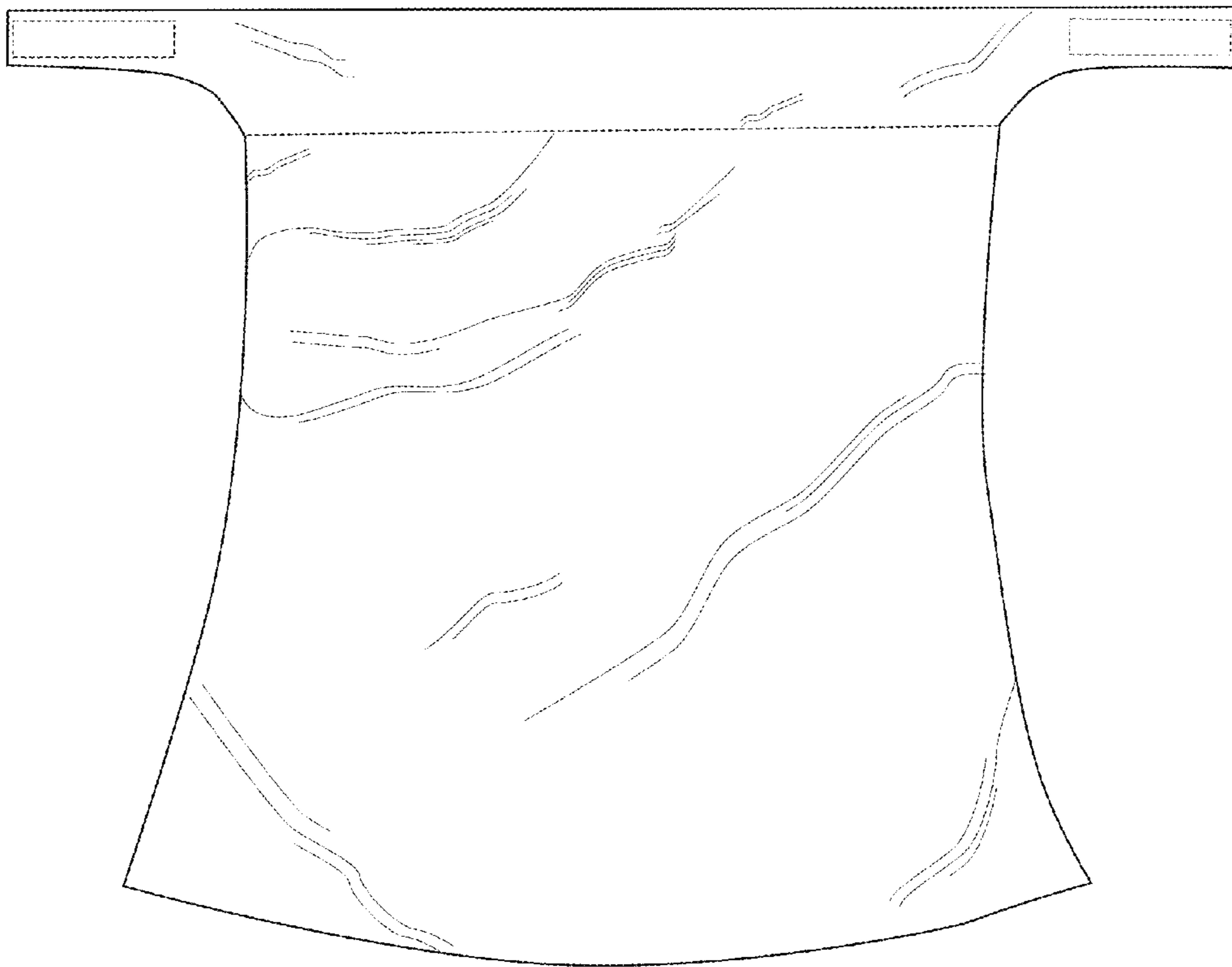

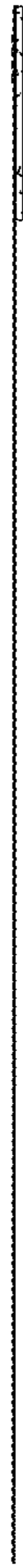

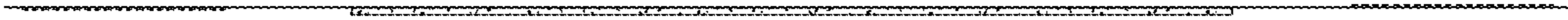

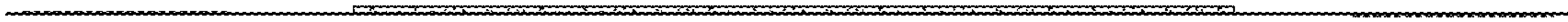

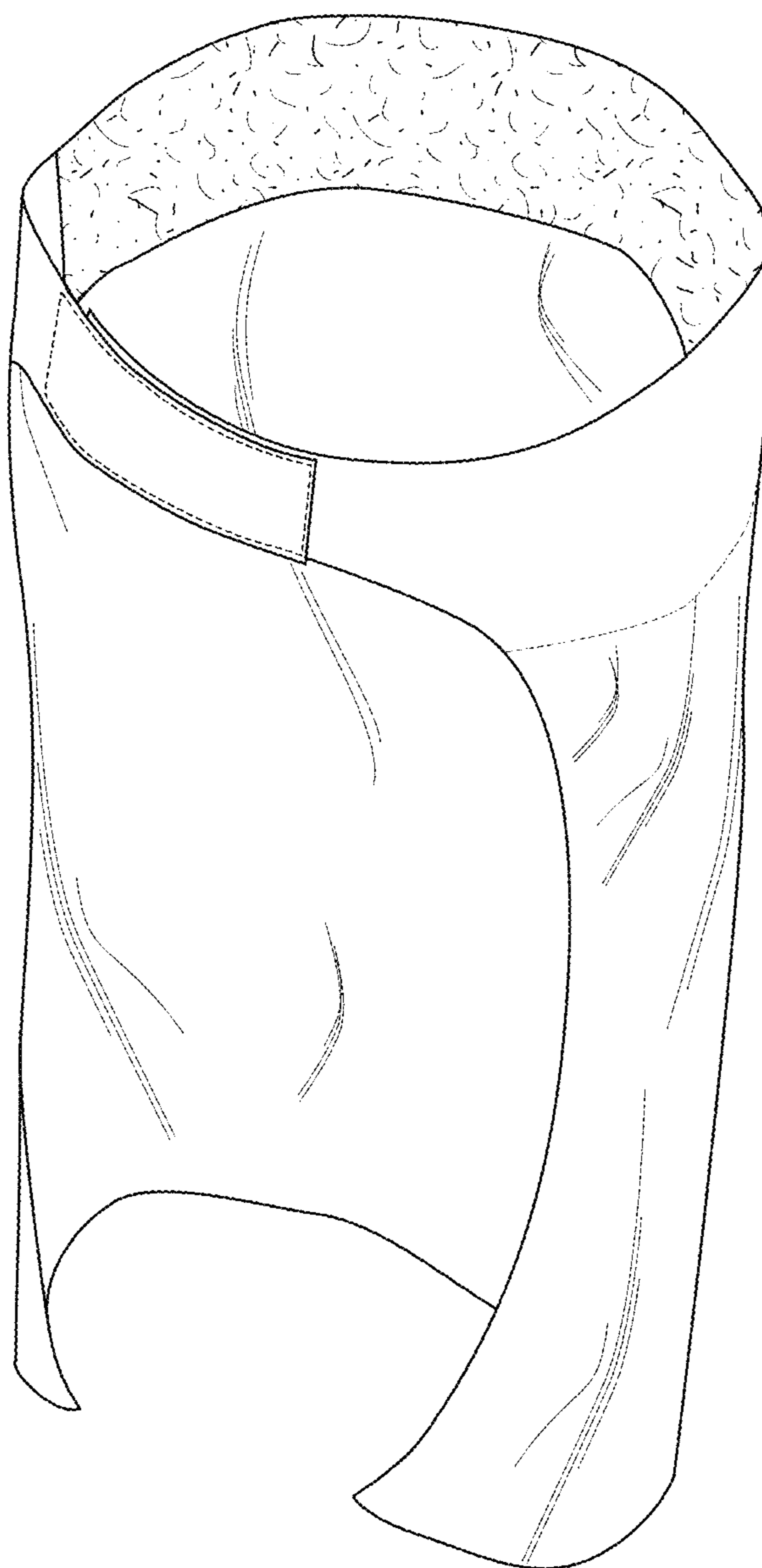
