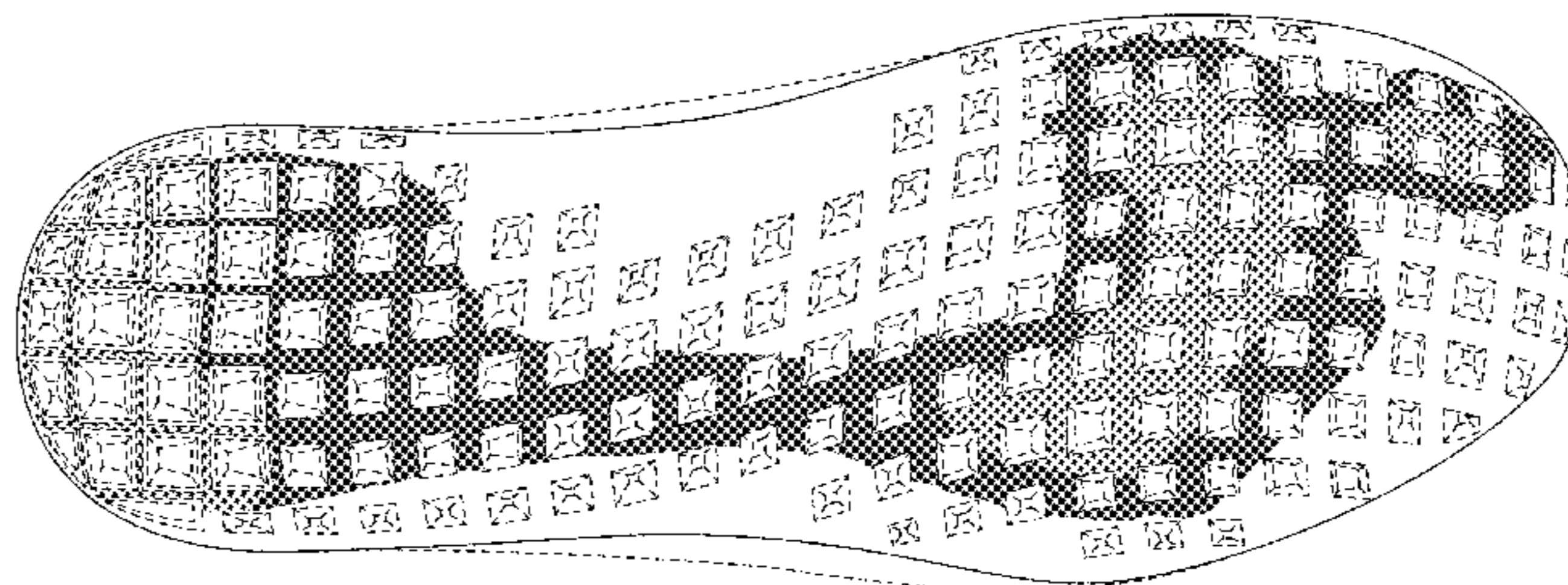
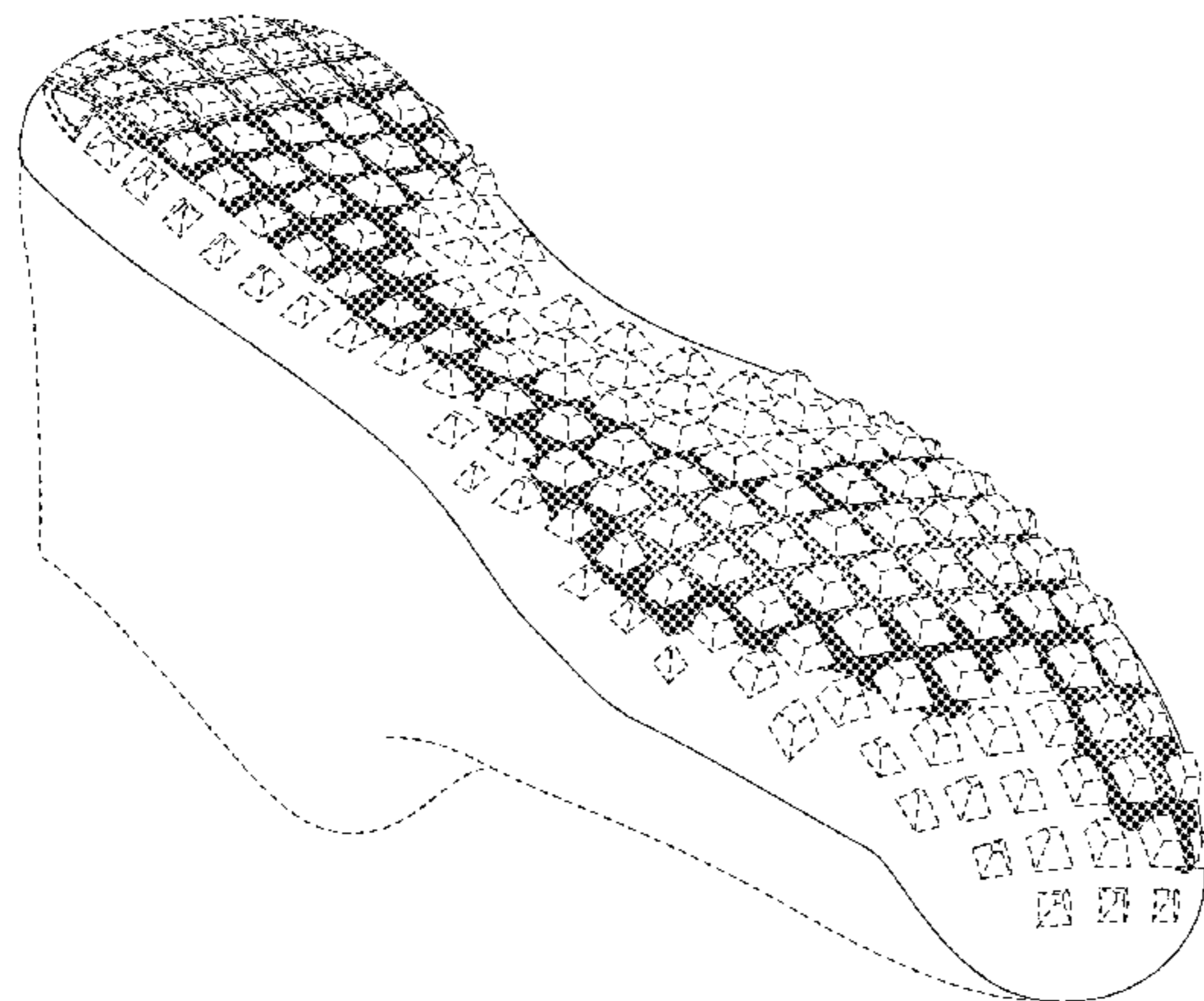
The ornamental design for a shoe outsole with a surface ornamentation contrast, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe outsole with a surface ornamentation contrast showing my new design; FIG. 2 is a plan view thereof; and, FIG. 3 is a rear perspective view thereof.

The broken line showing of the unshaded elements within the claimed area are for environmental purposes only. The contrast in grayscale shading between the different regions in the figures represents a contrast of appearance. The broken line showing of the remainder of the shoe is for environmental purposes only and forms no part of the claimed design.

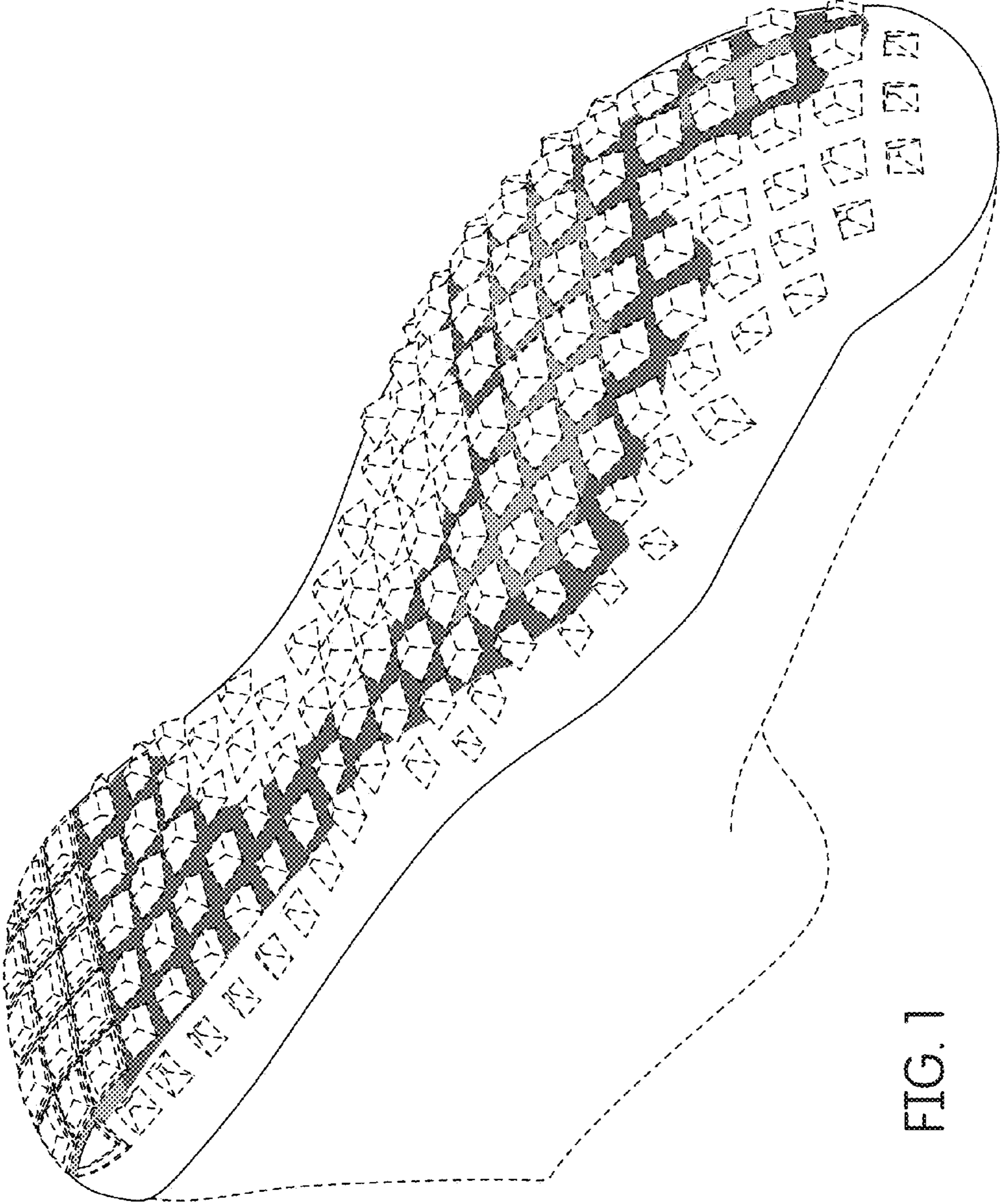

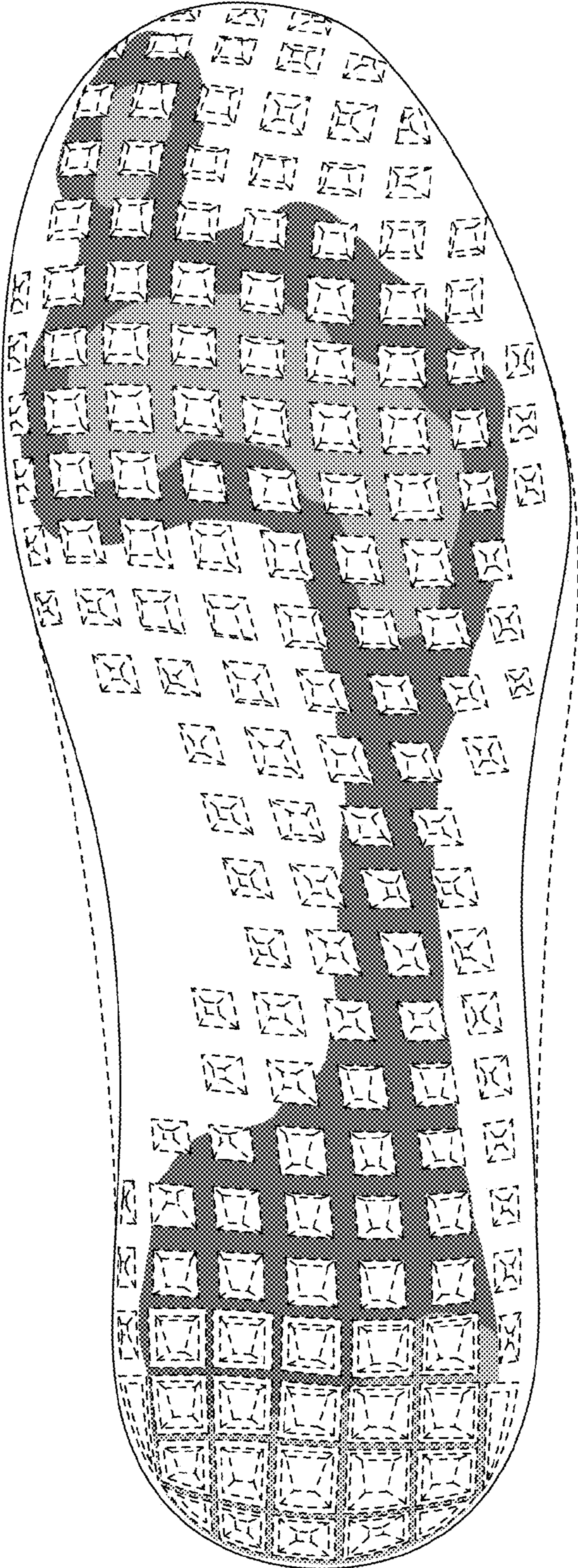

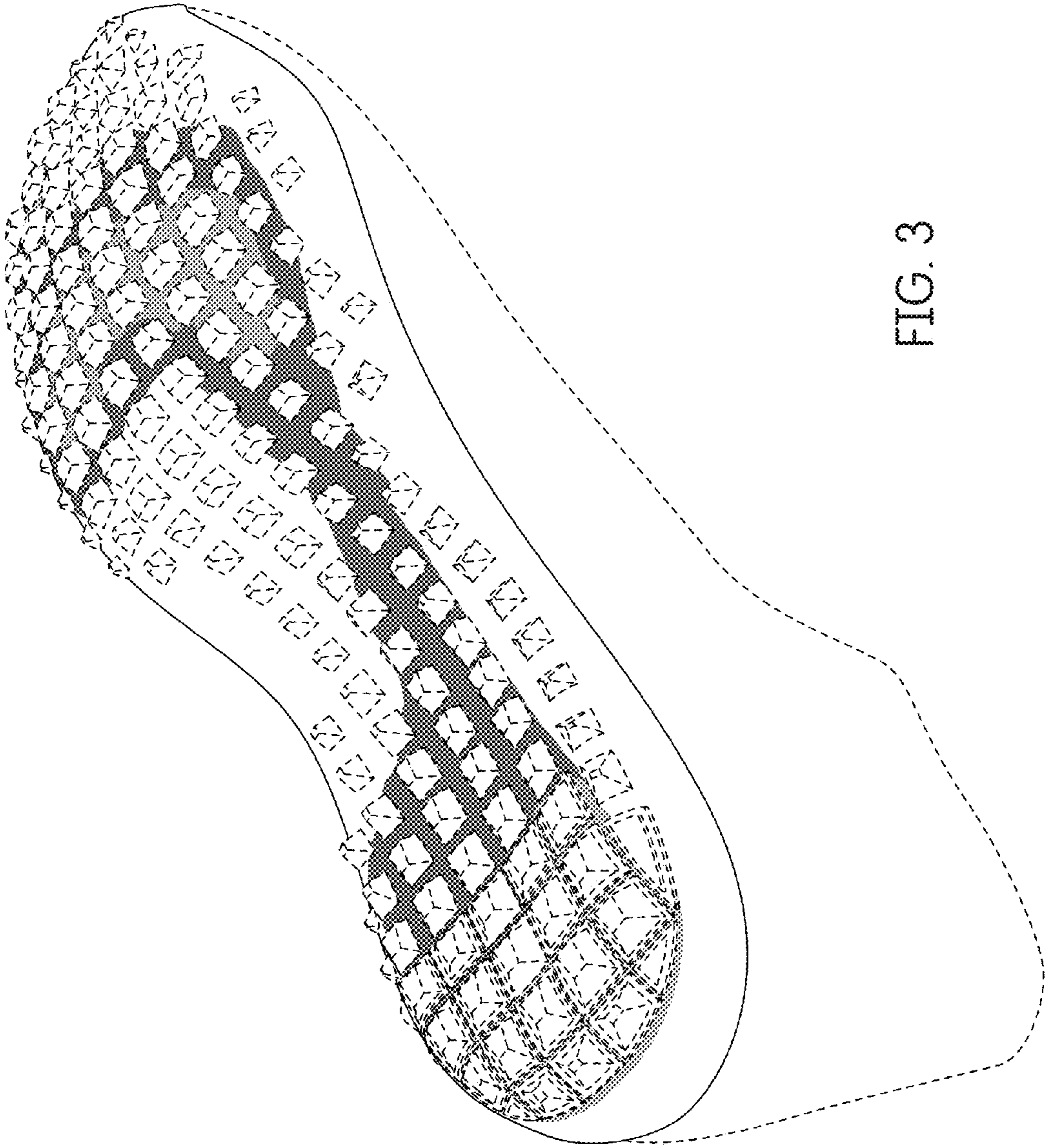
