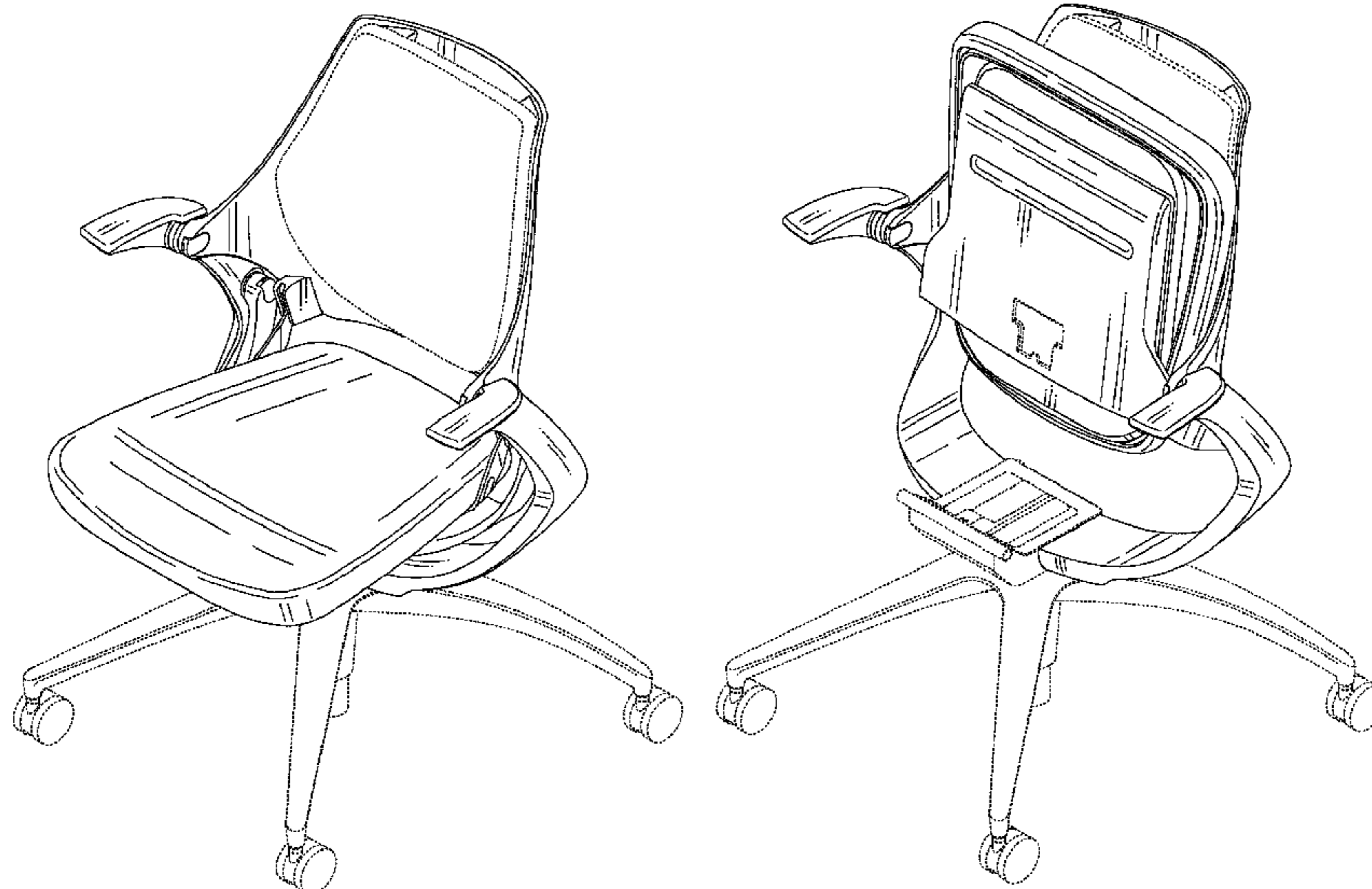
(57) **CLAIM**

The ornamental design for the chair, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the front, top and right side of the chair;
FIG. 2 is a perspective view of the rear, top and left side thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a right side view thereof, a left side view being a mirror image of the right side view;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom view thereof; and,
FIG. 8 is a perspective view of the front, top and right side of the chair in a case that a seat is folded up.
The portions of the article in broken lines are shown for illustrative purposes only and form no part of the claimed design.

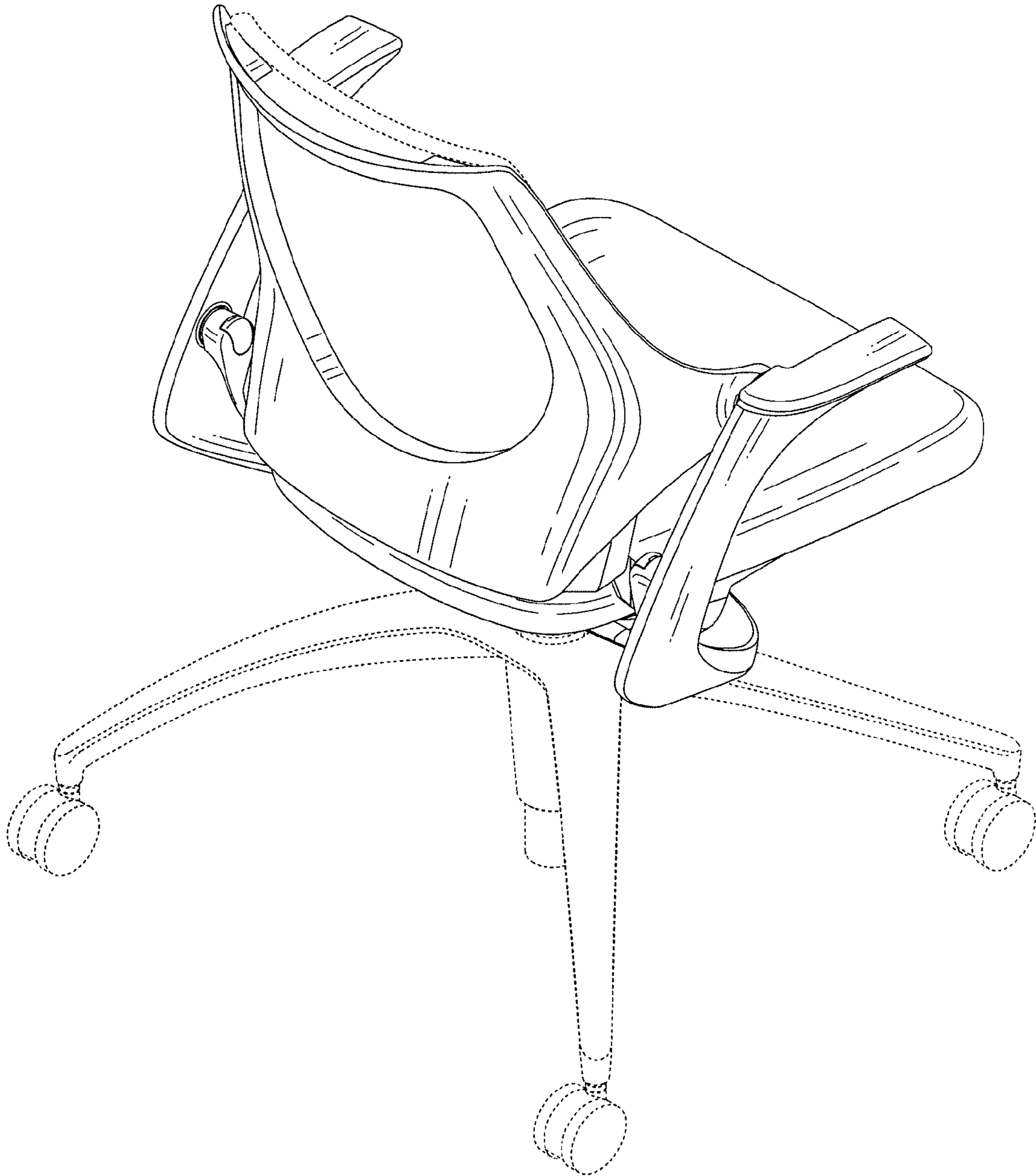

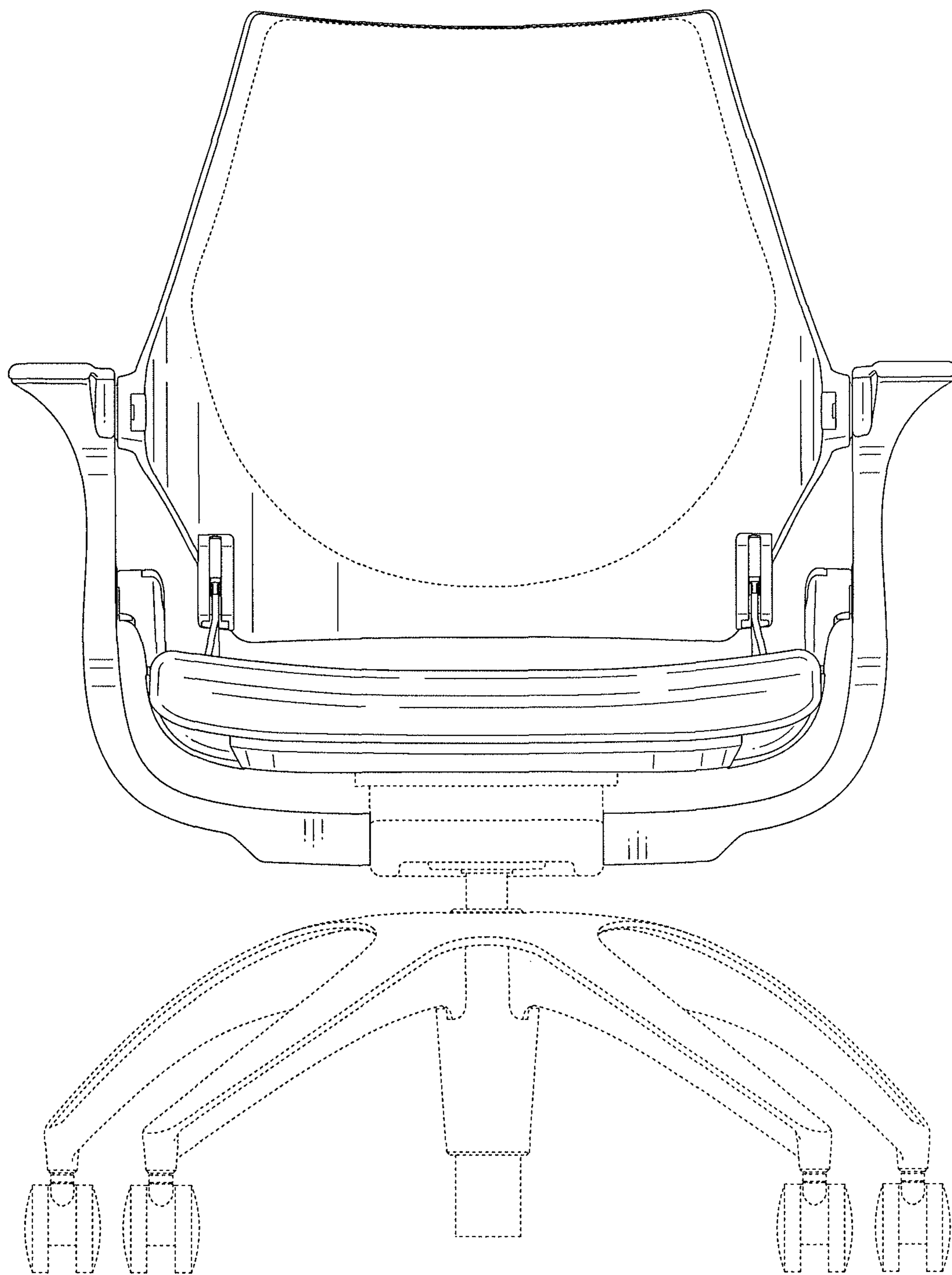

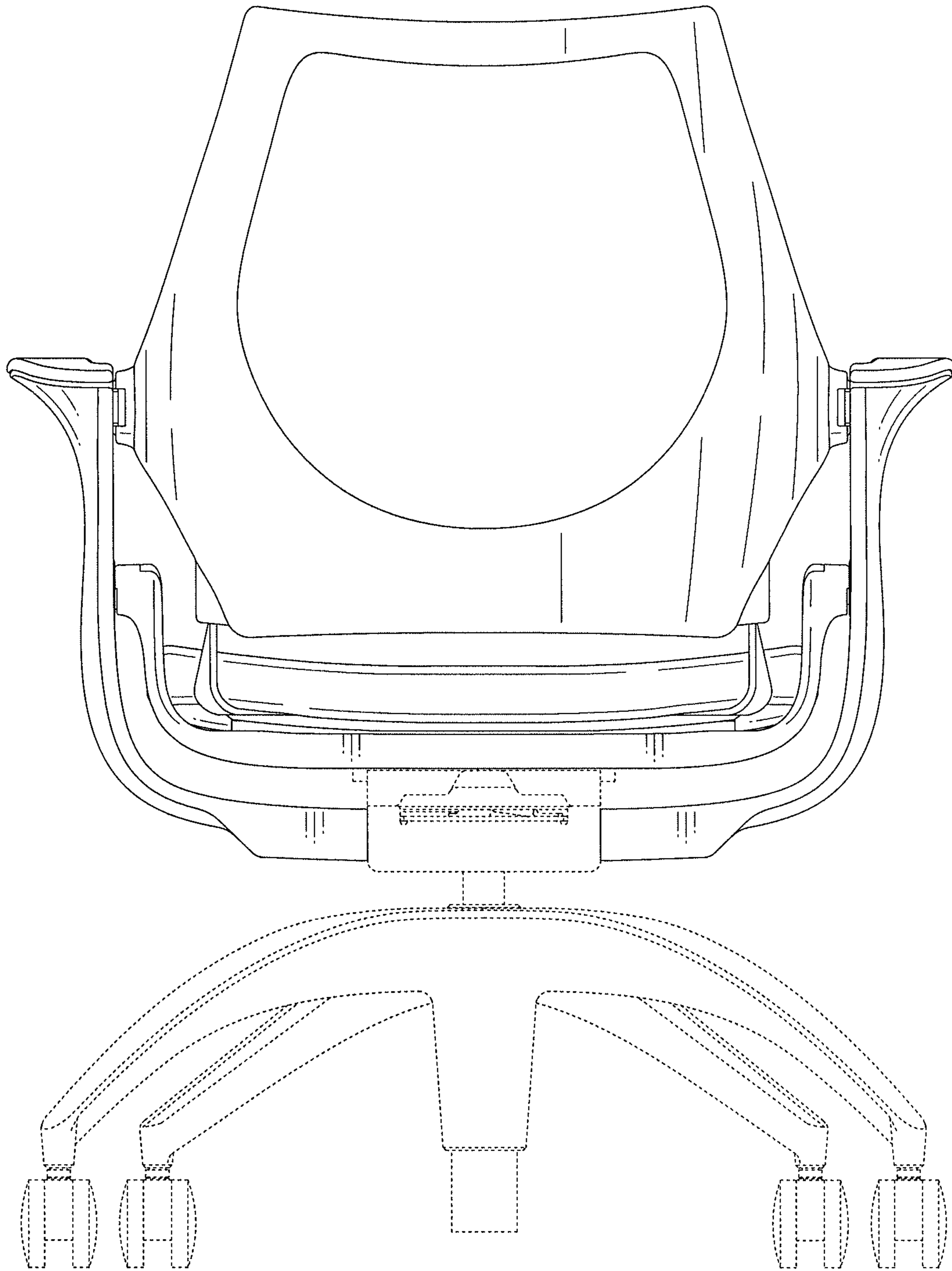

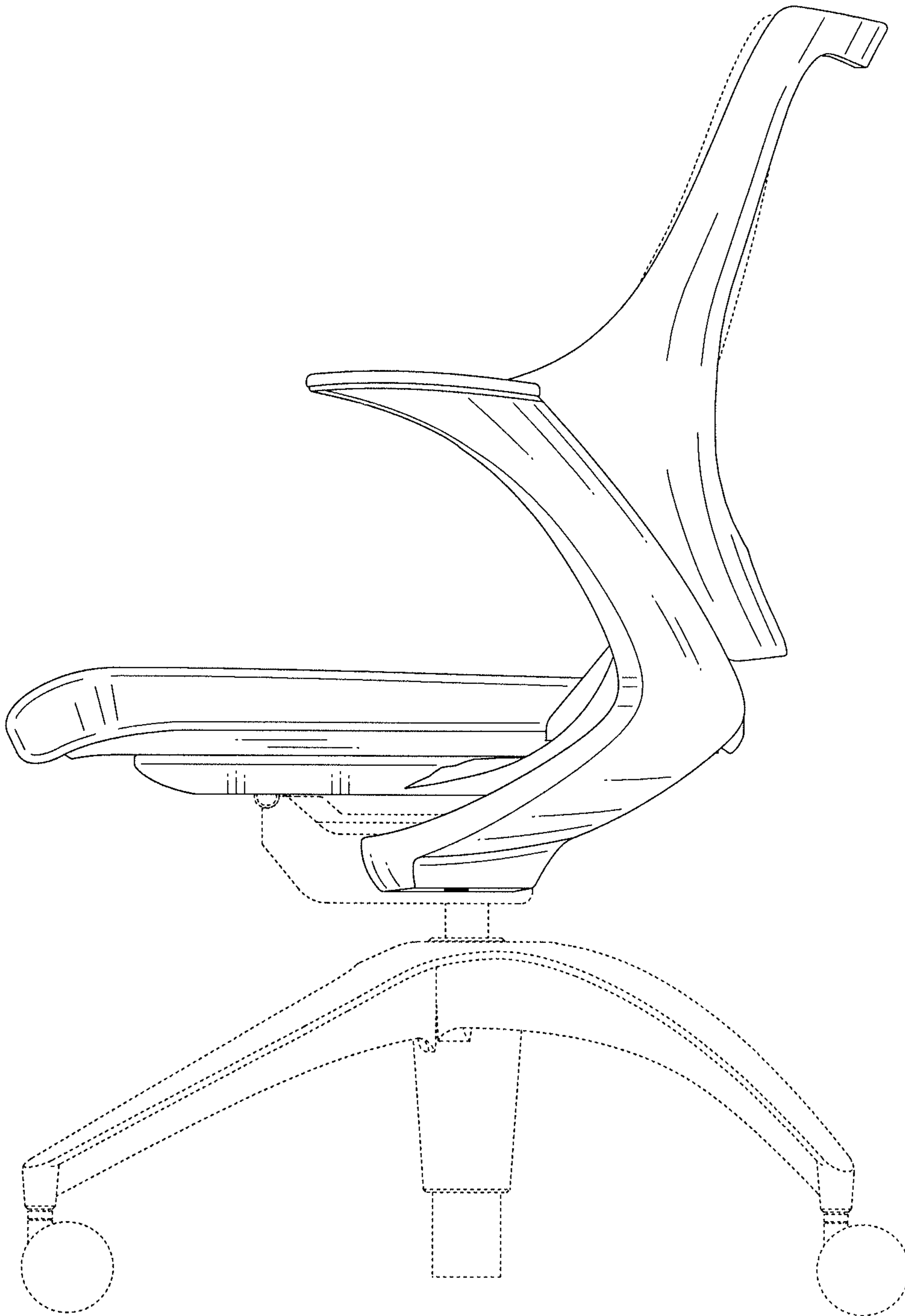

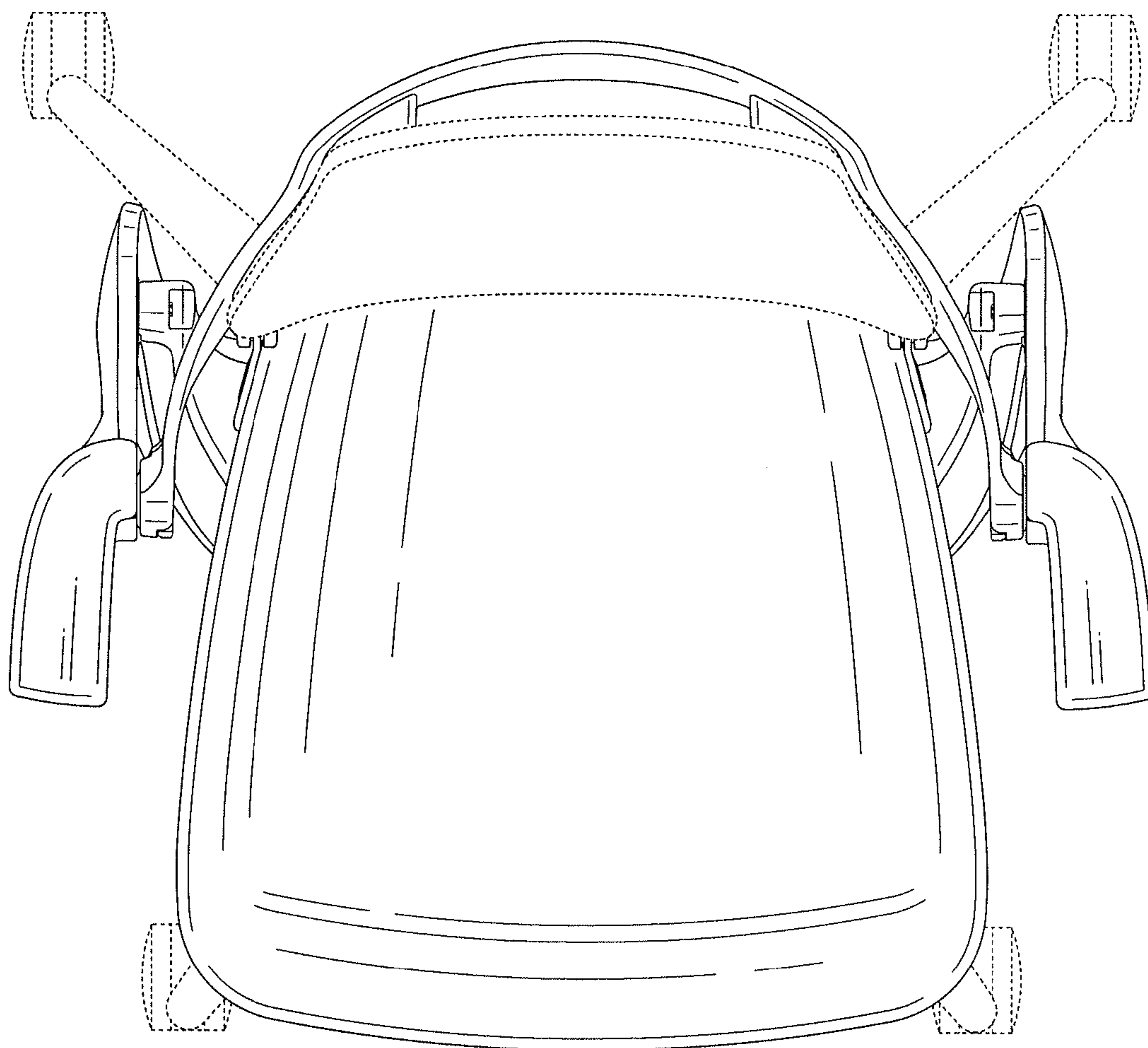

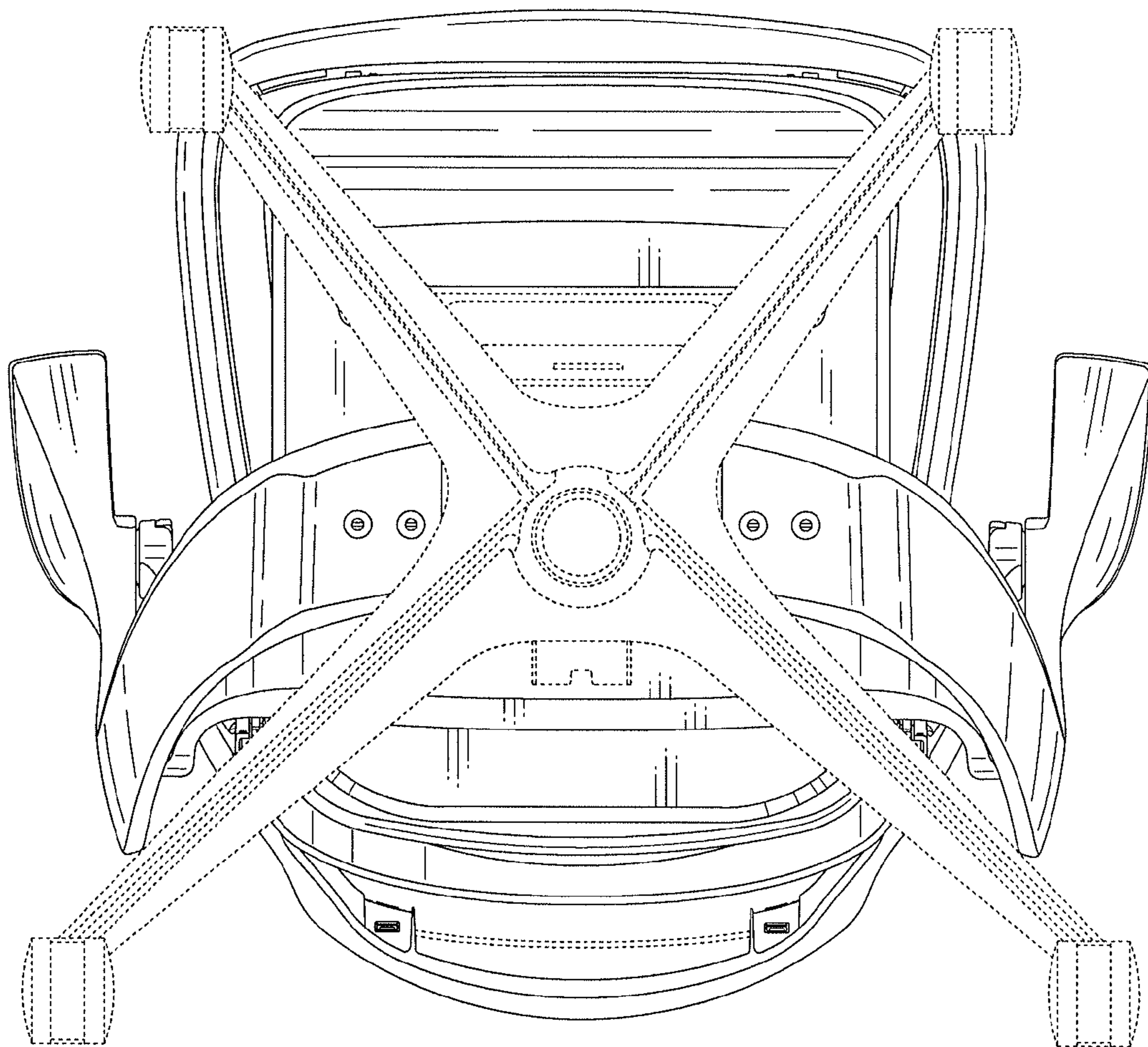
