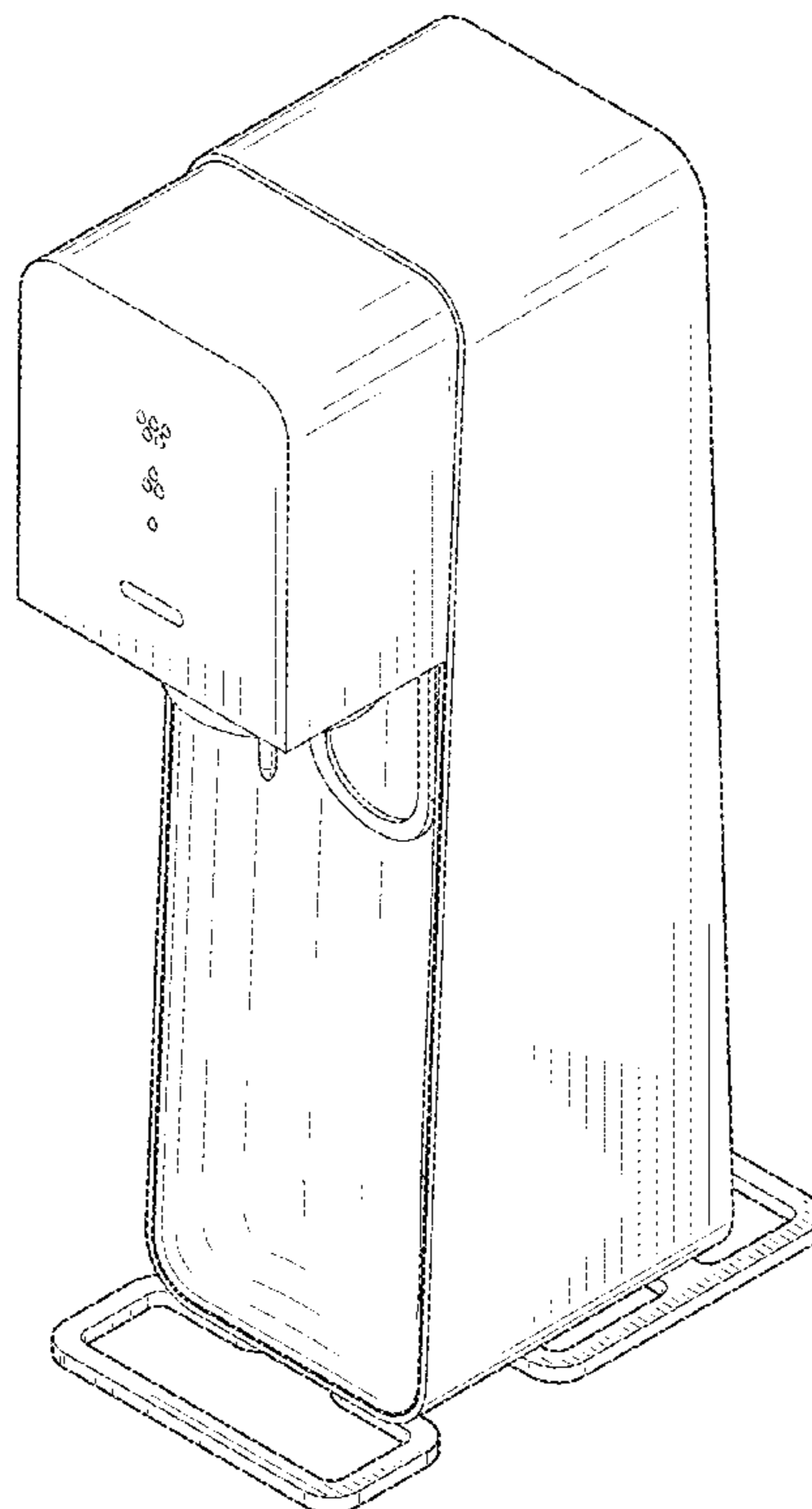
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of the domestic soda-water preparing device;

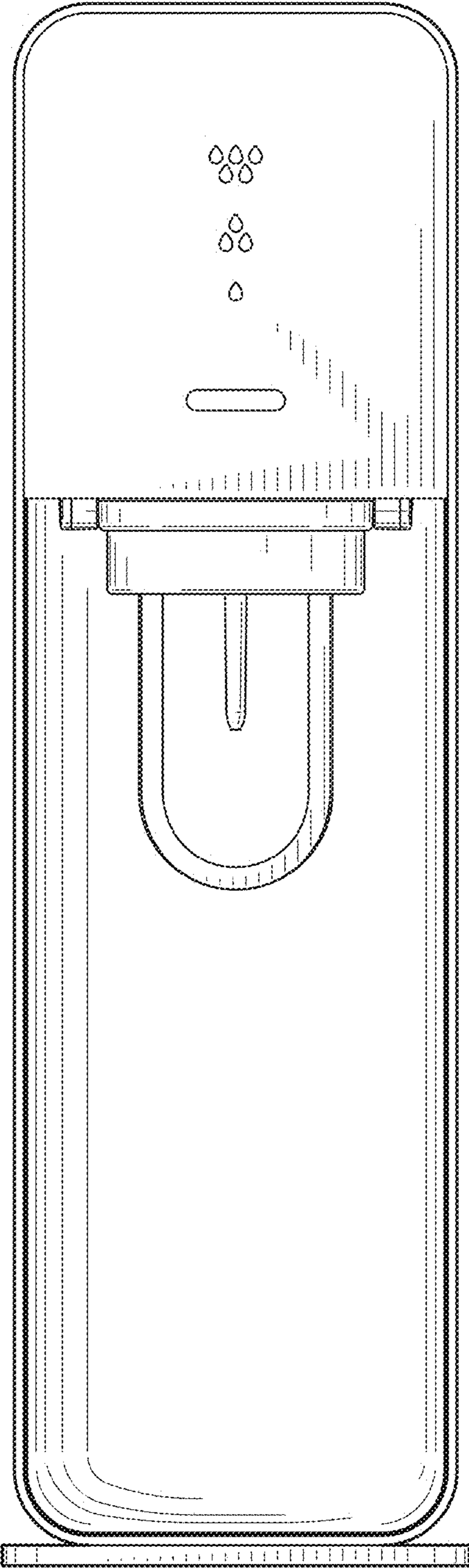

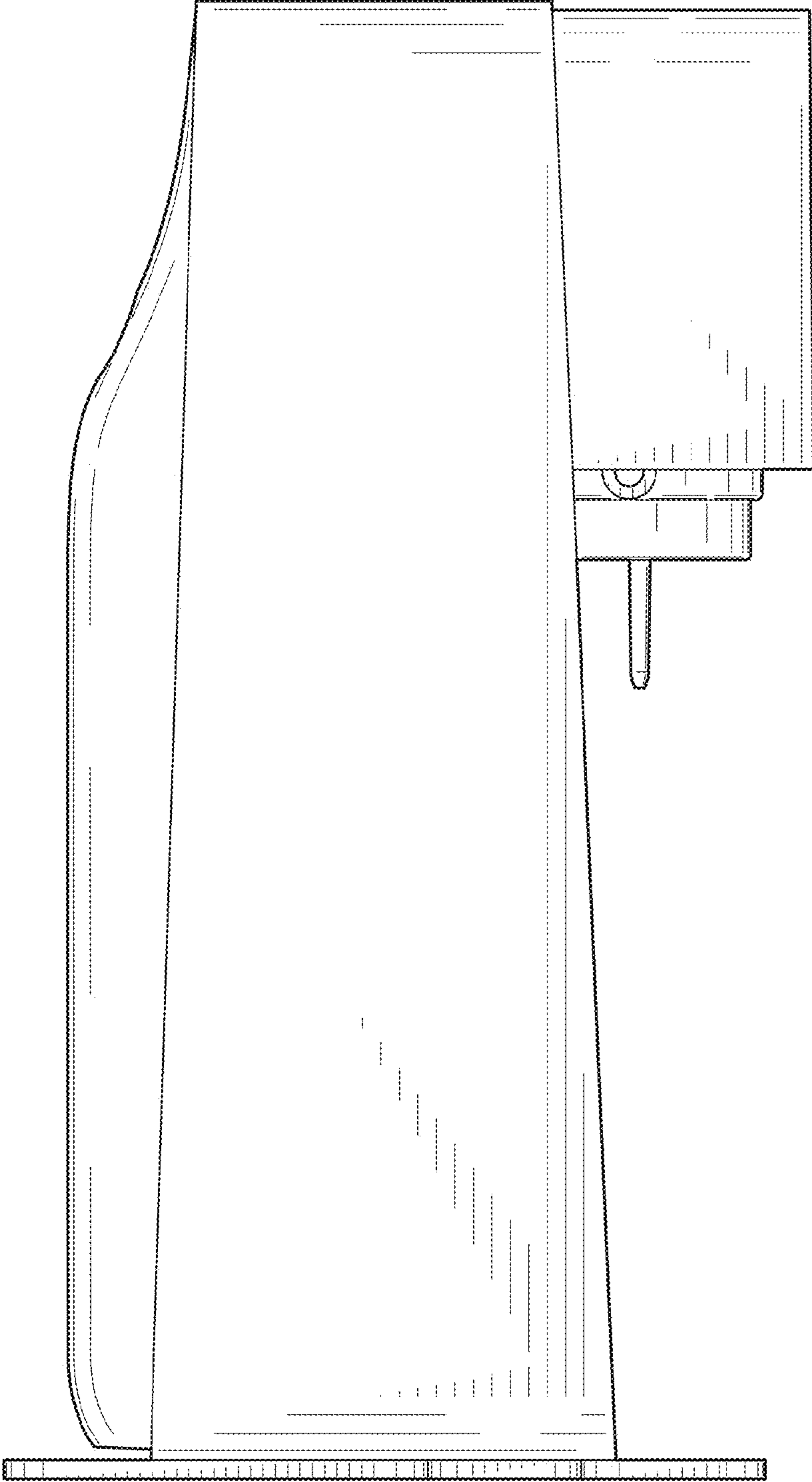

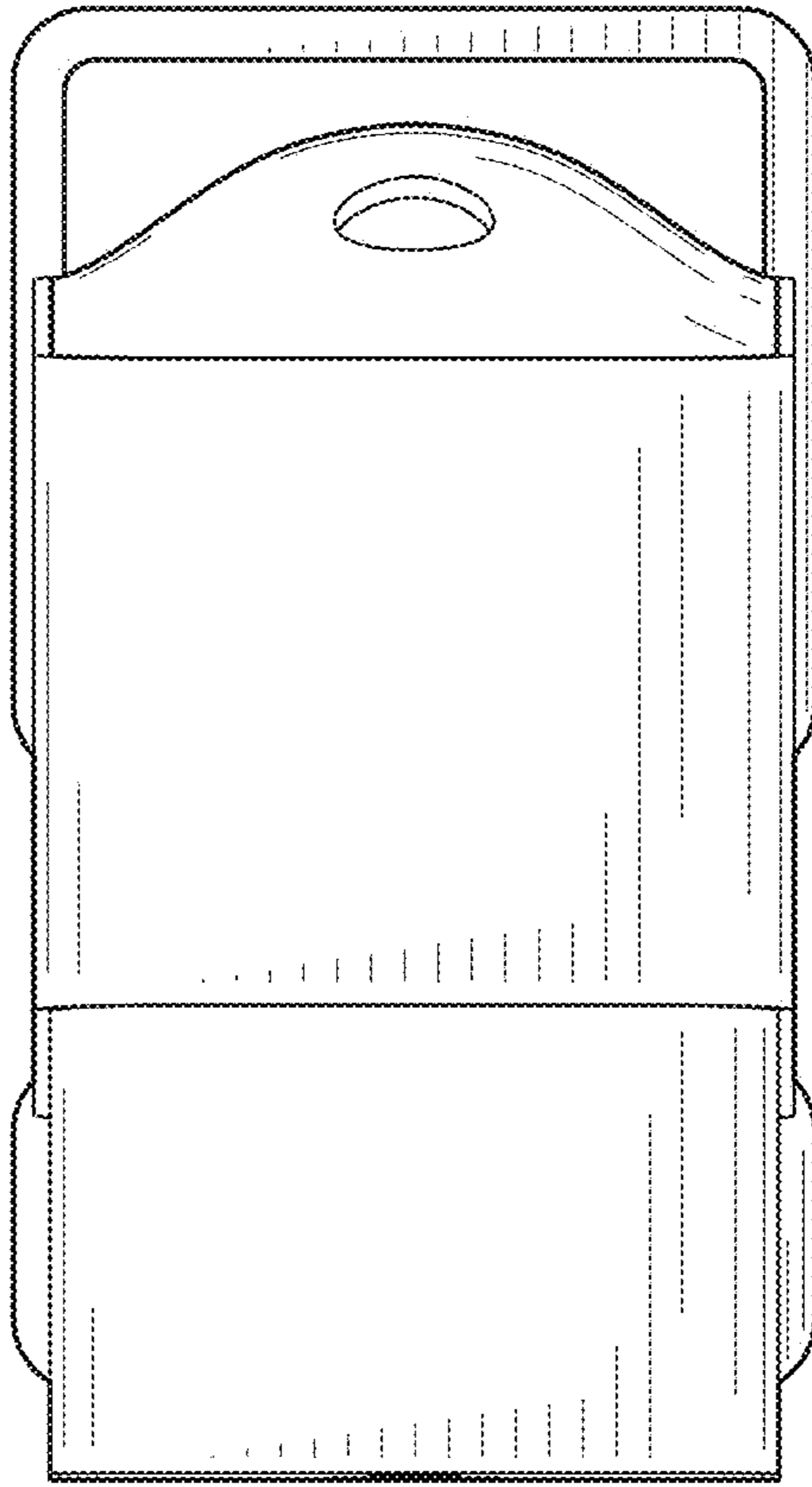

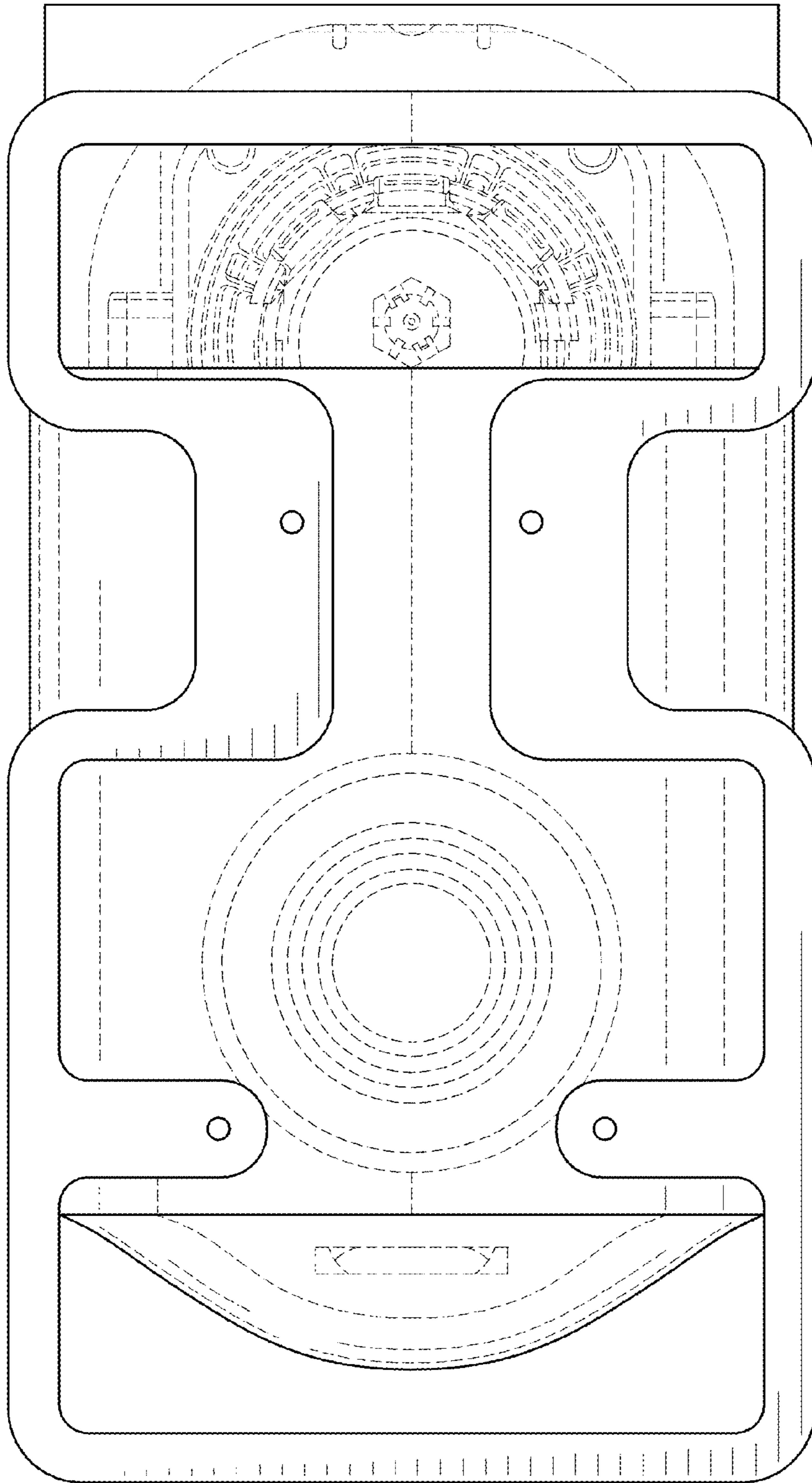

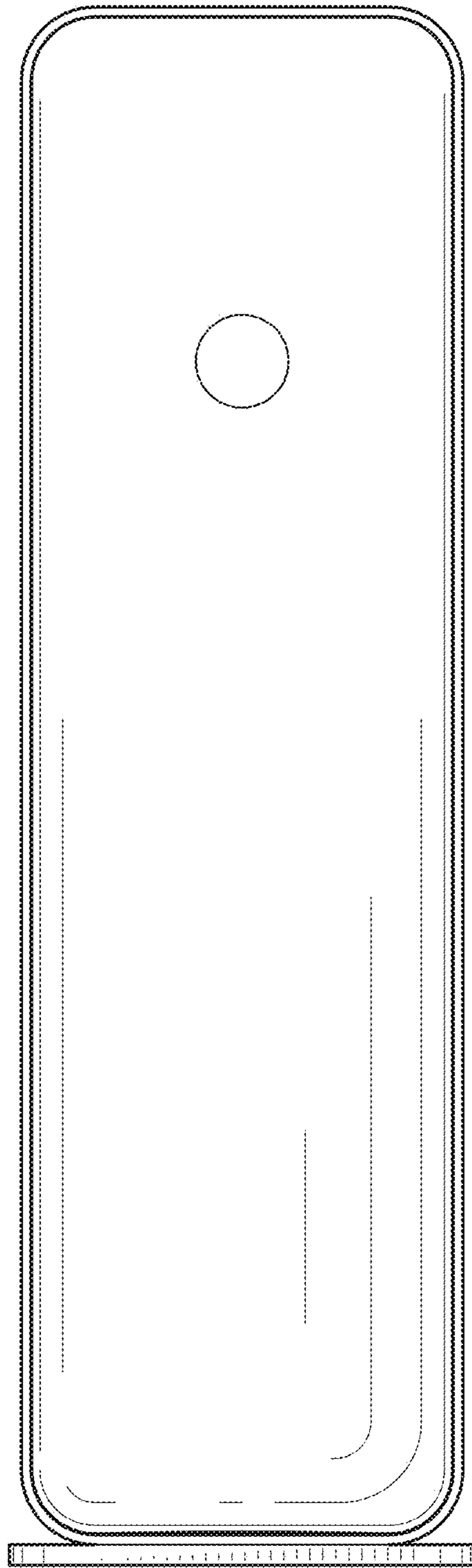

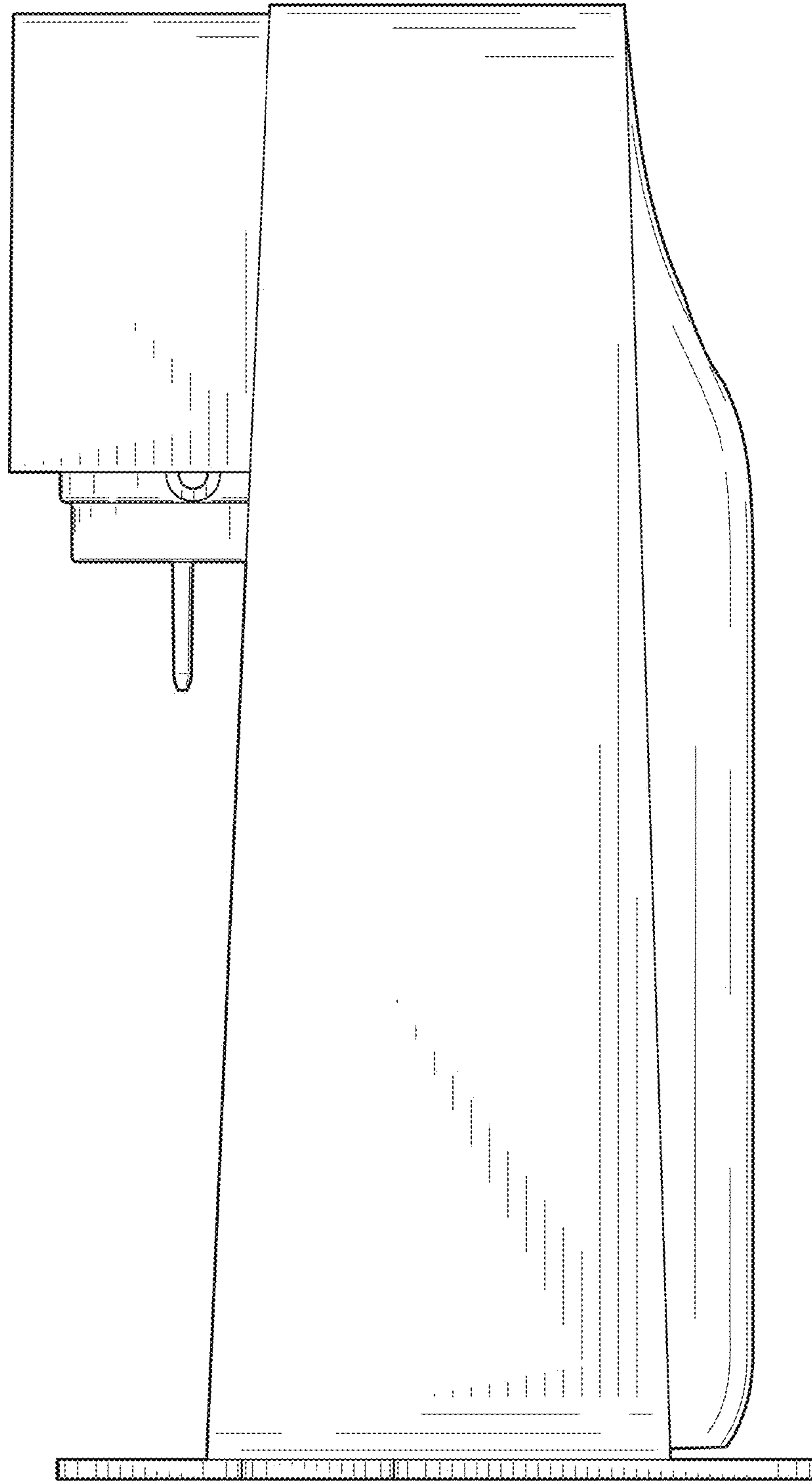

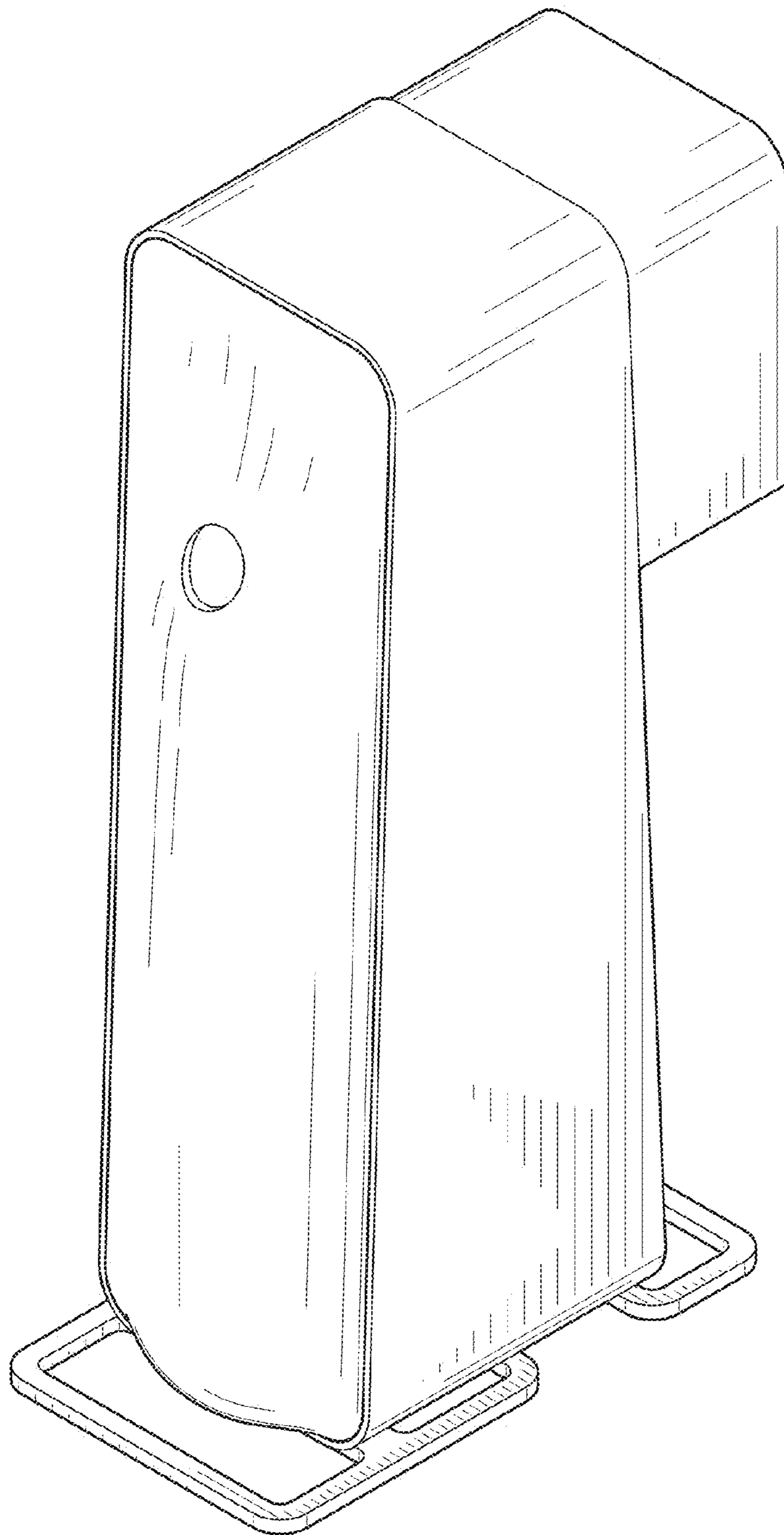

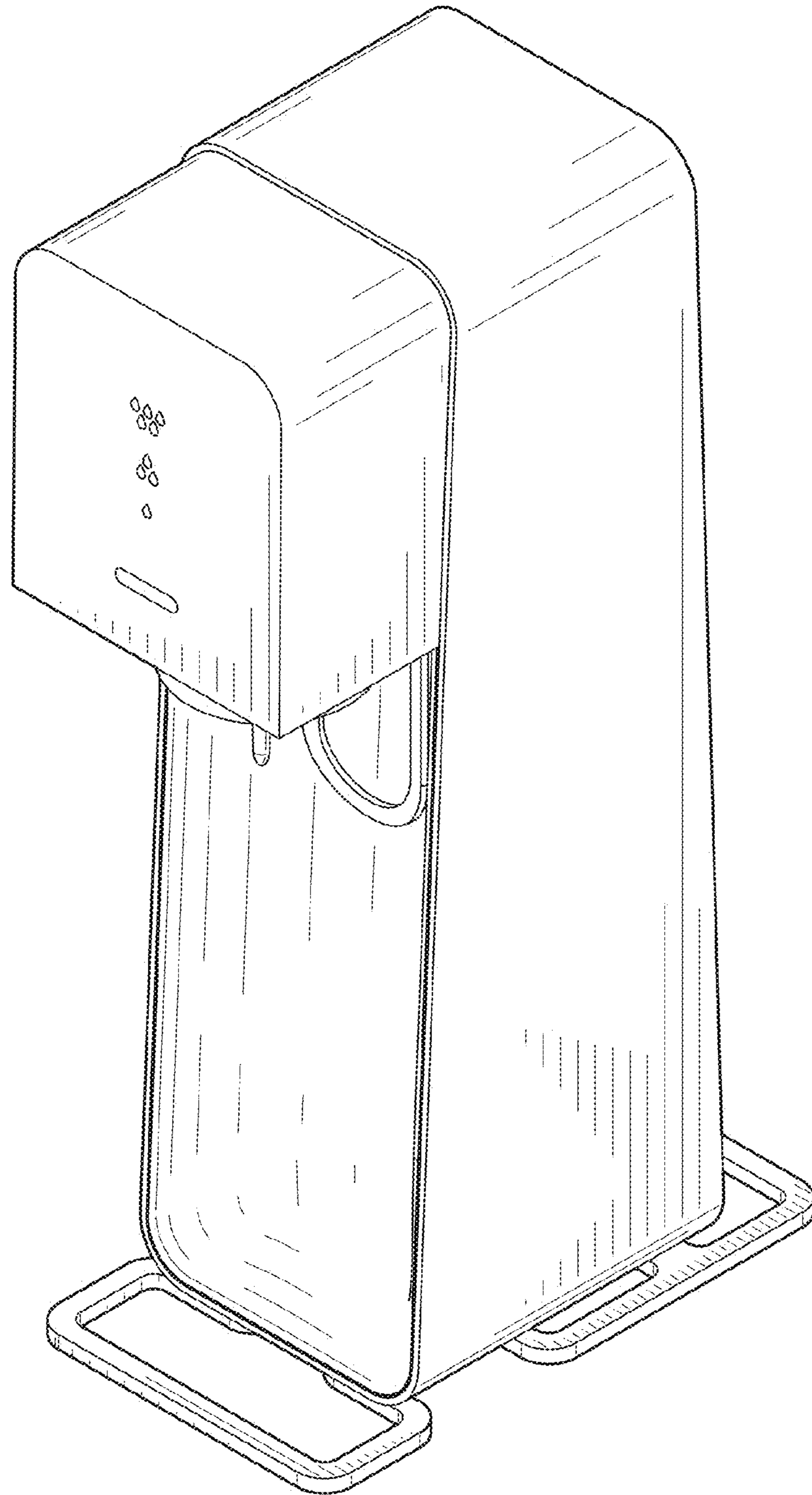
