(57) **CLAIM**

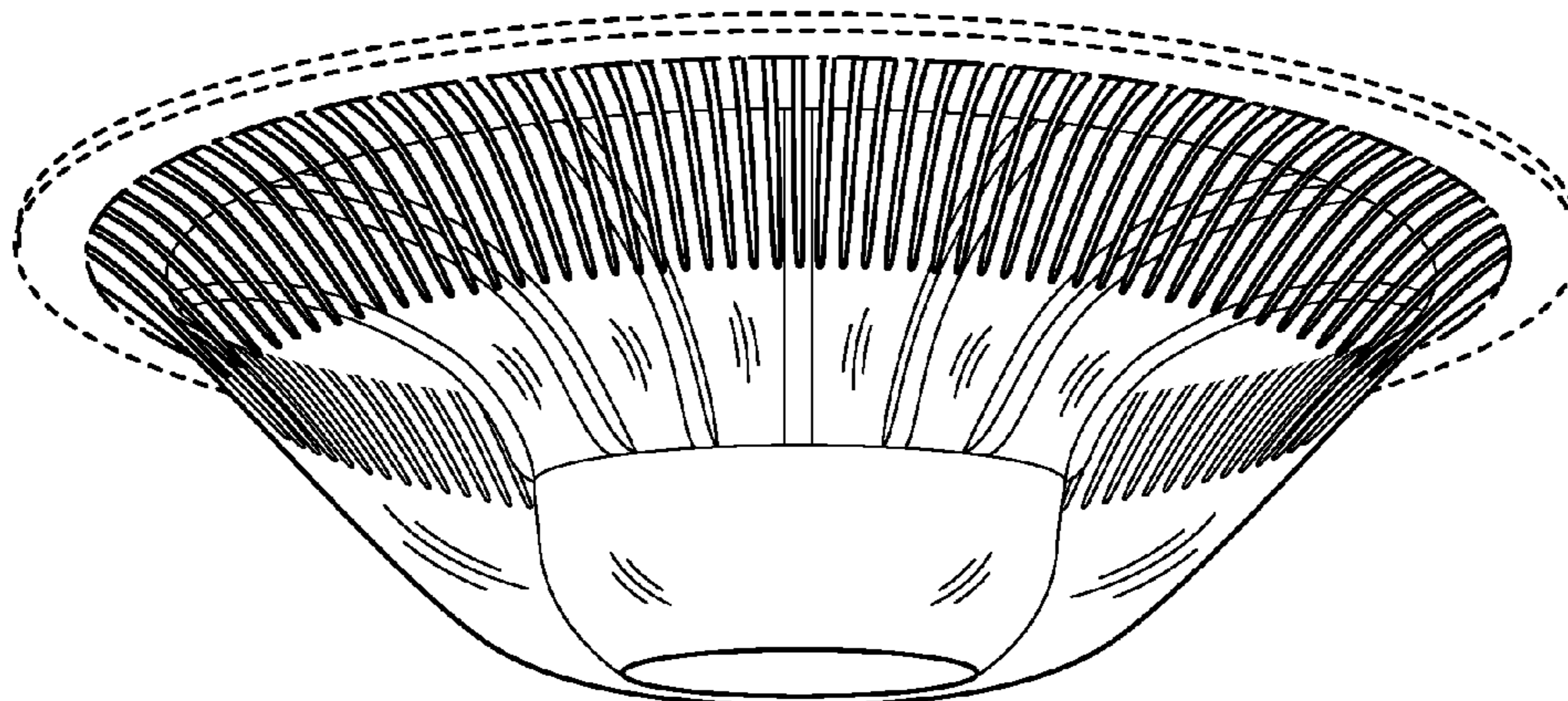
The ornamental design for a nozzle, as shown and described.

DESCRIPTION

FIG. 1 is a bottom, front perspective view of a nozzle showing our new design; and, FIG. 2 is a front view thereof, the right, left and rear views being identical thereto.

The uneven-length broken lines represent unclaimed boundaries of the claimed design. The even-length broken lines showing the remainder of the nozzle are for environmental purposes only and form no part of the claimed design.

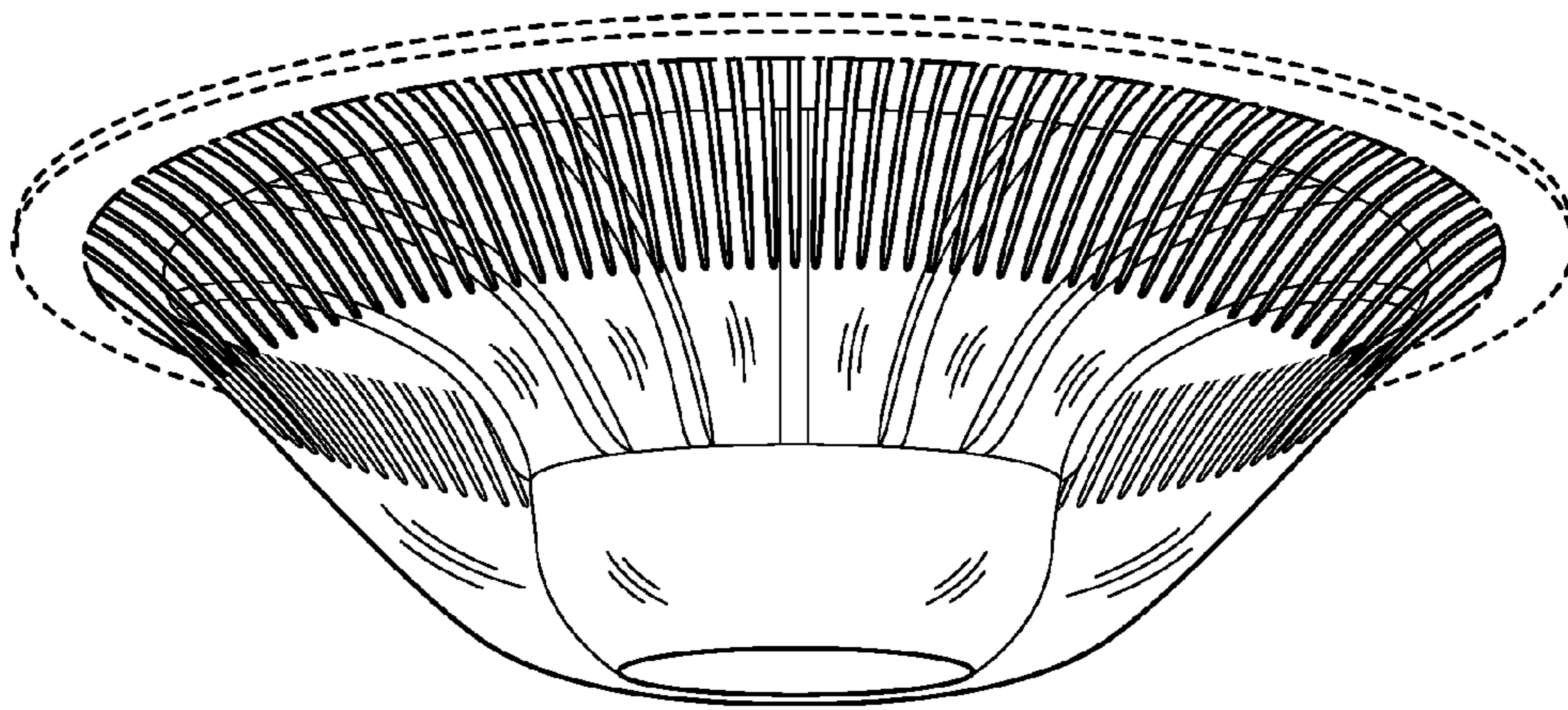

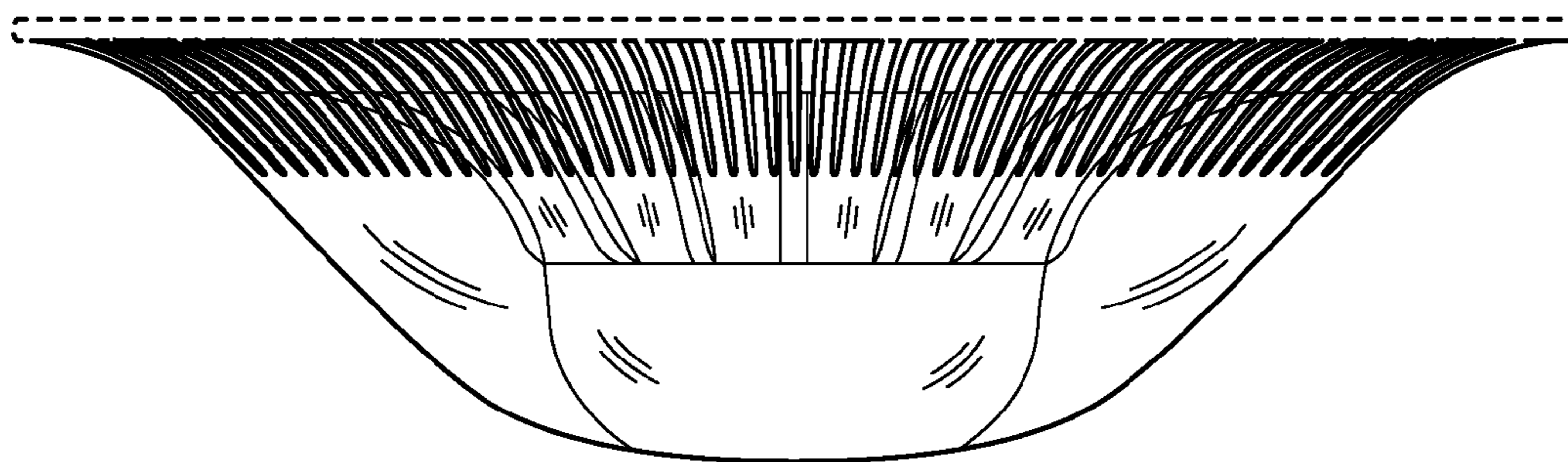
