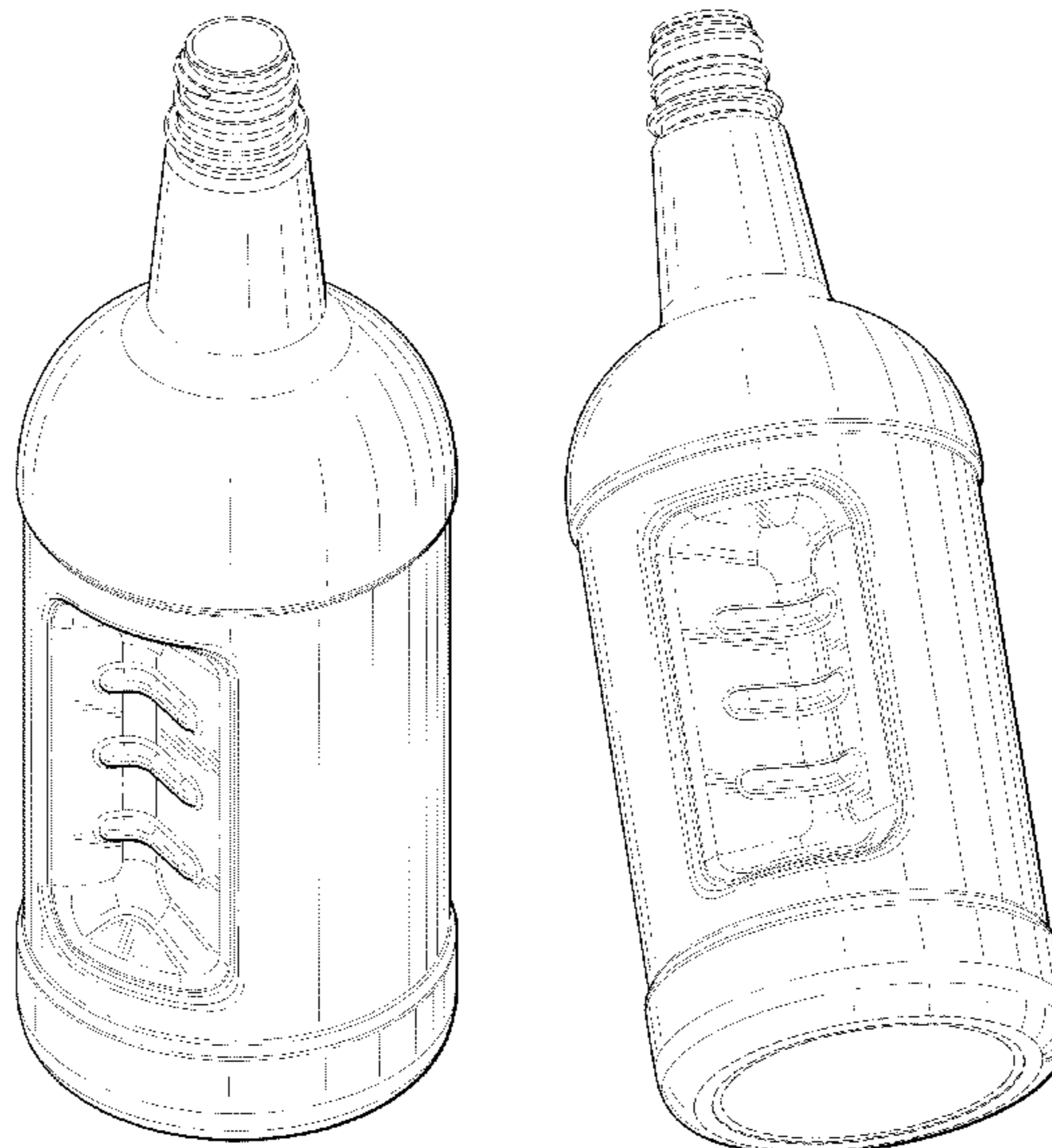
(57) **CLAIM**

The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a top, rear, left side perspective view of a container showing our new design;
FIG. 2 is a top, front perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.
The broken lines shown in the drawings of the pour spout portion and central bottom surface portion are included for the purpose of illustrating environmental structure and form no part of the claimed design.

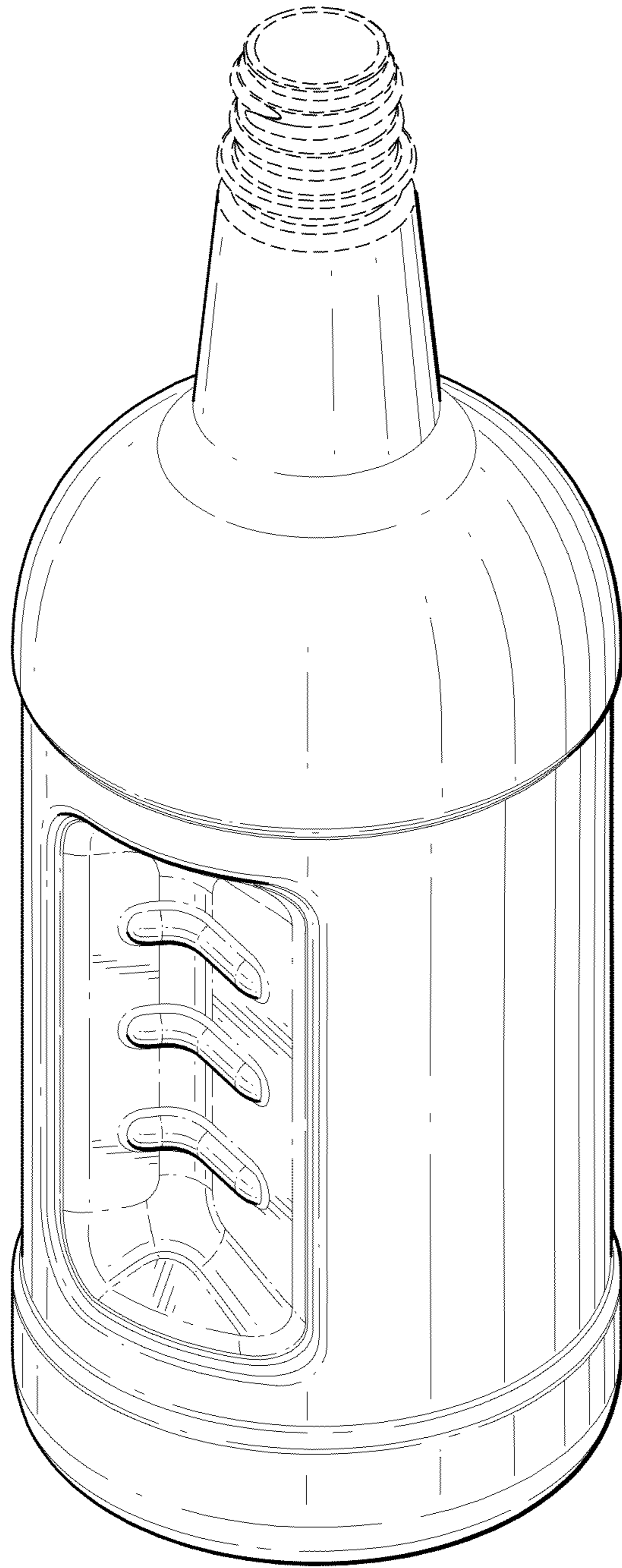

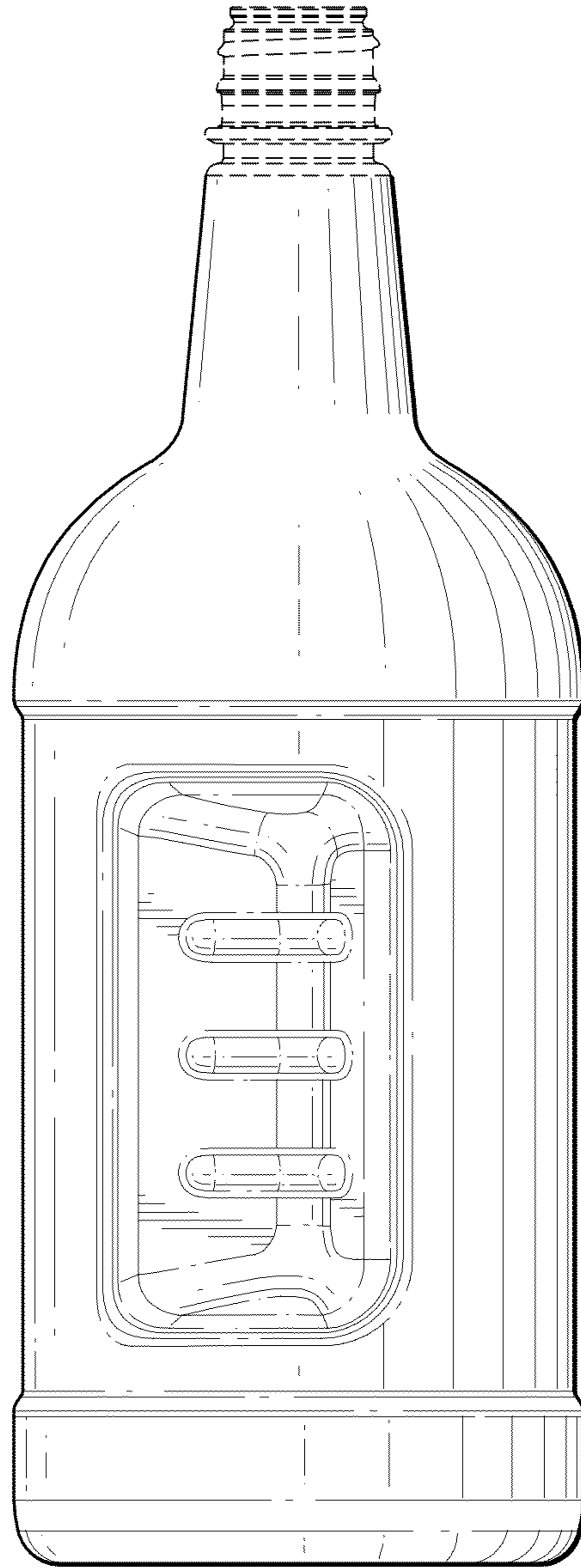

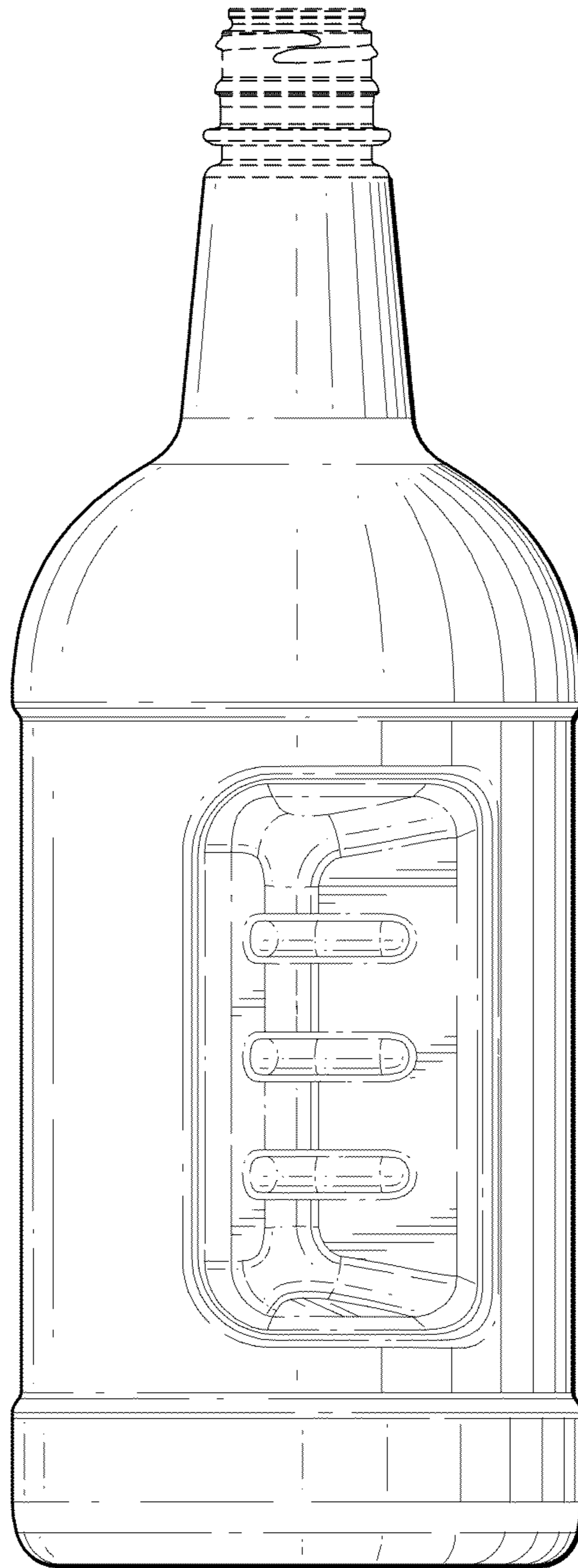

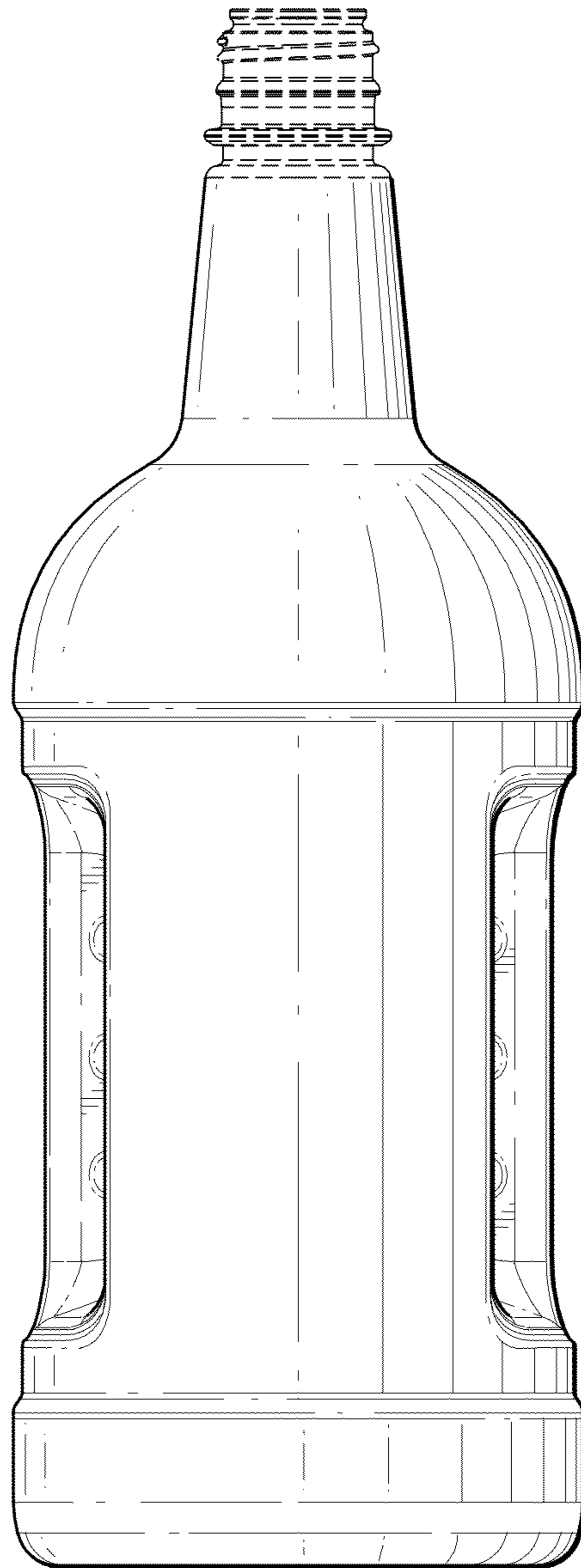

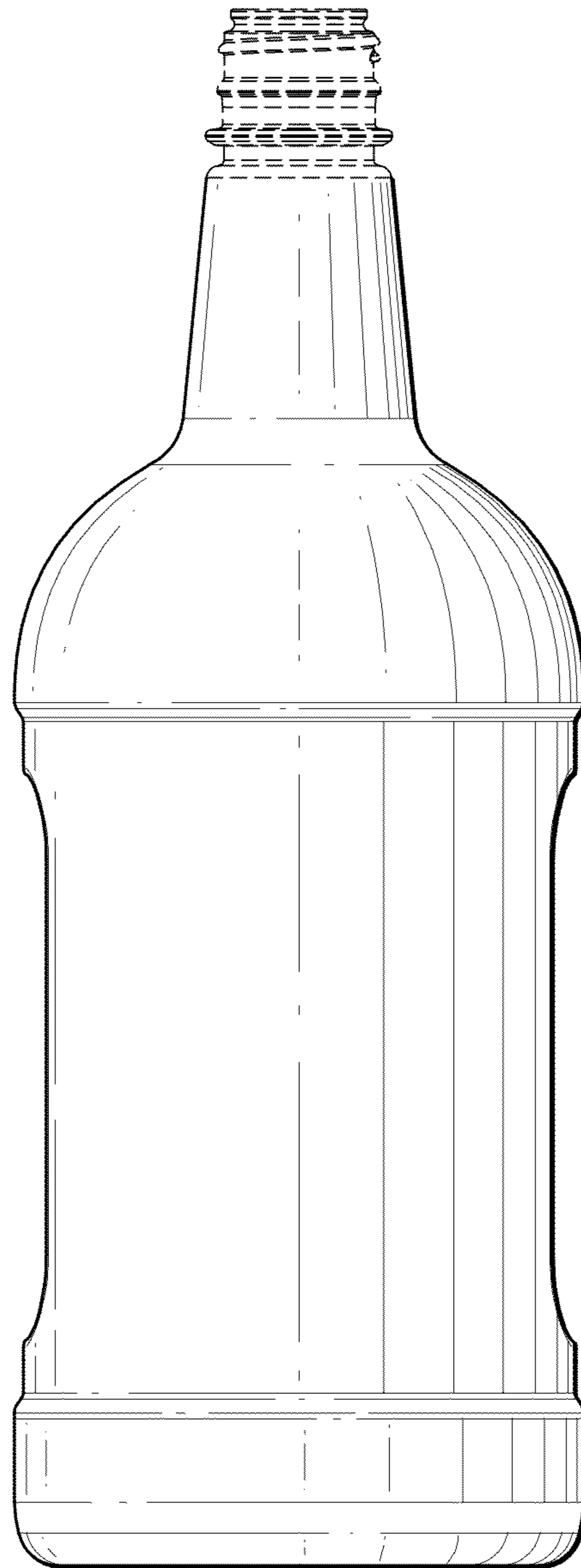

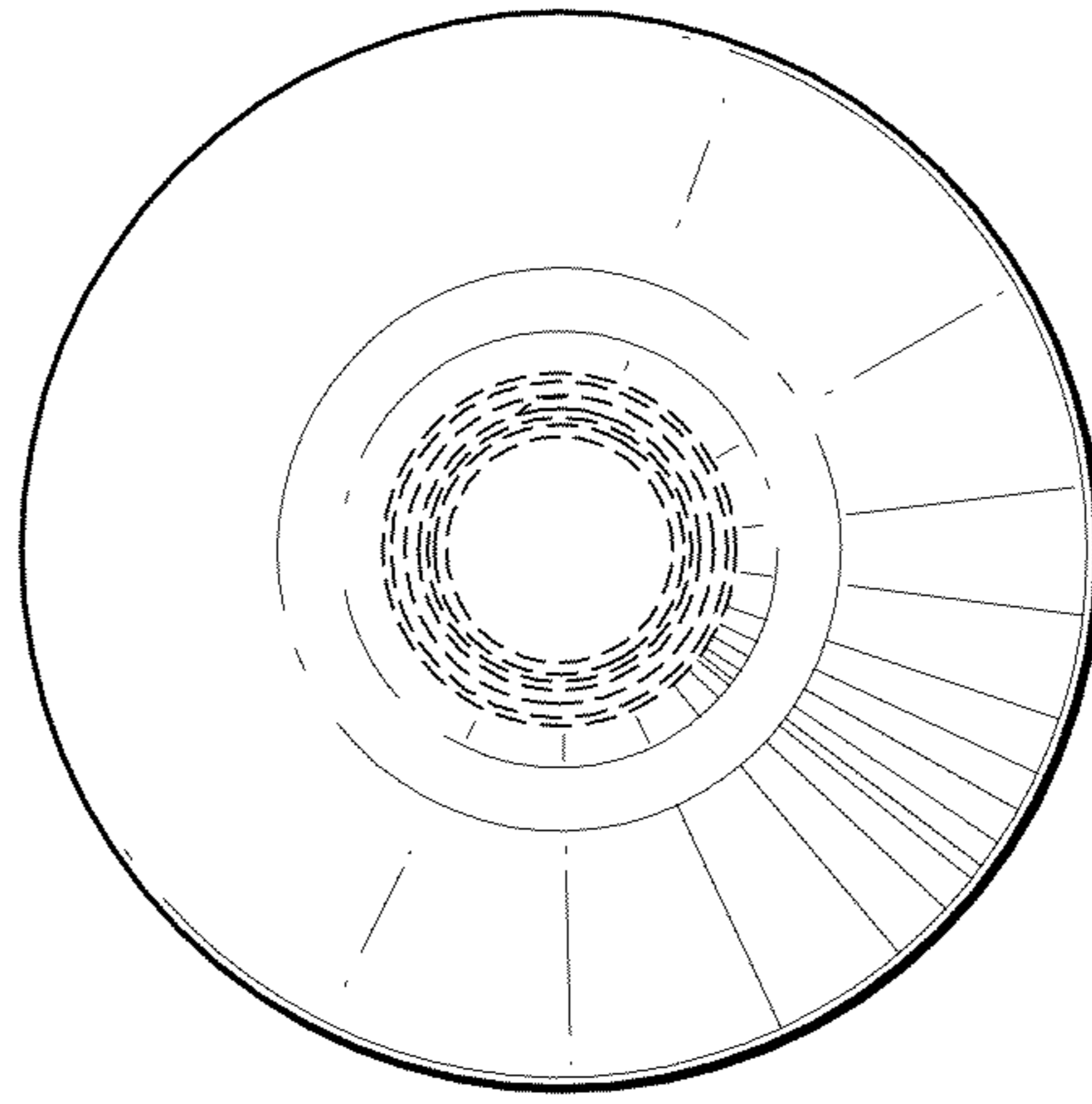

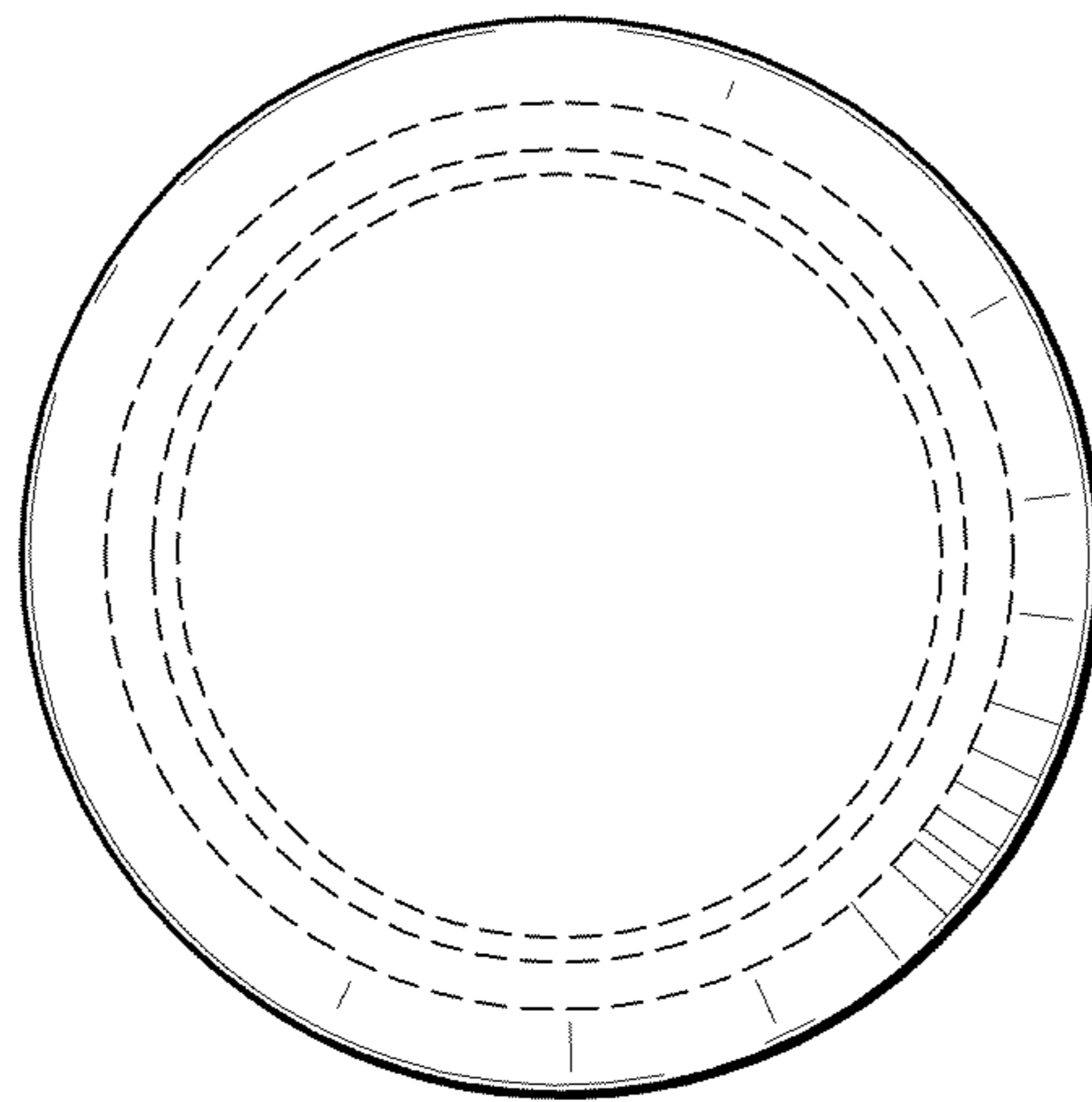
