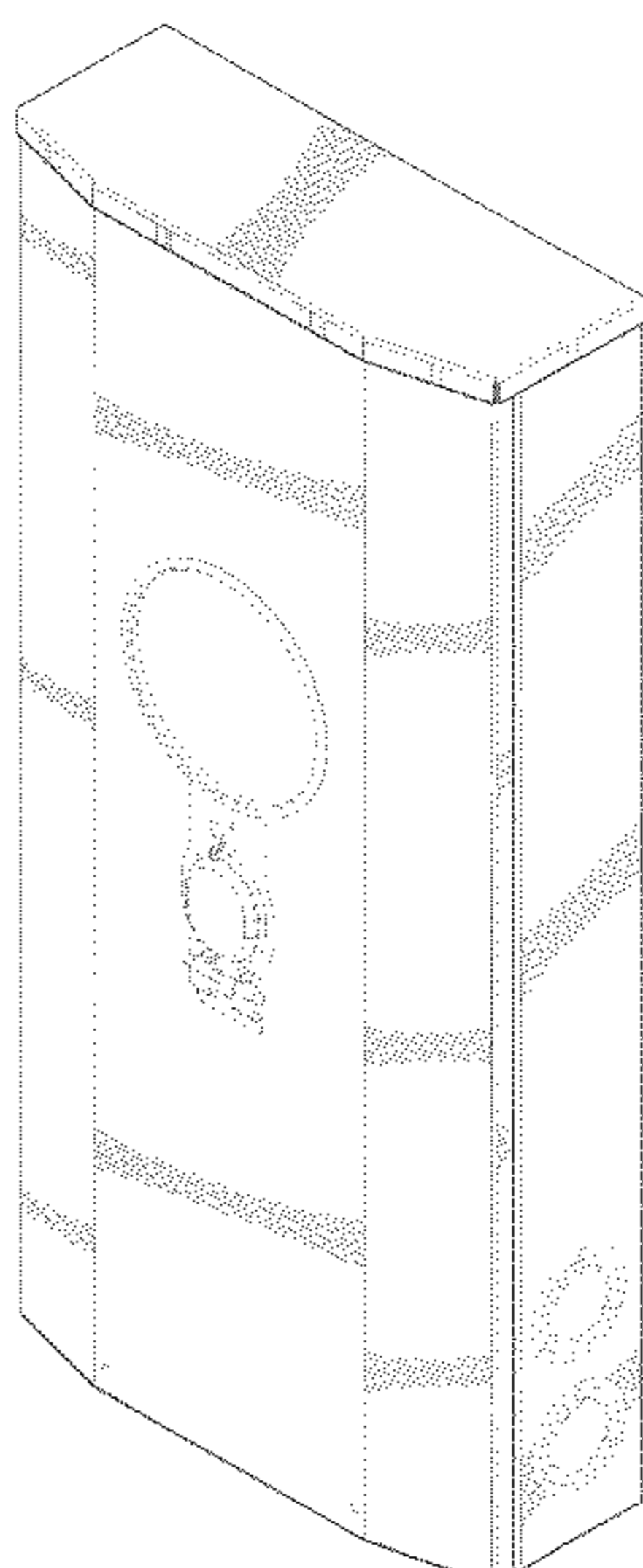
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of the meter socket cabinet of the present invention;
 FIG. 2 is a front elevation view thereof;
 FIG. 3 is a side elevation view thereof;
 FIG. 4 is a top plan view thereof; and,
 FIG. 5 is a bottom plan view thereof.

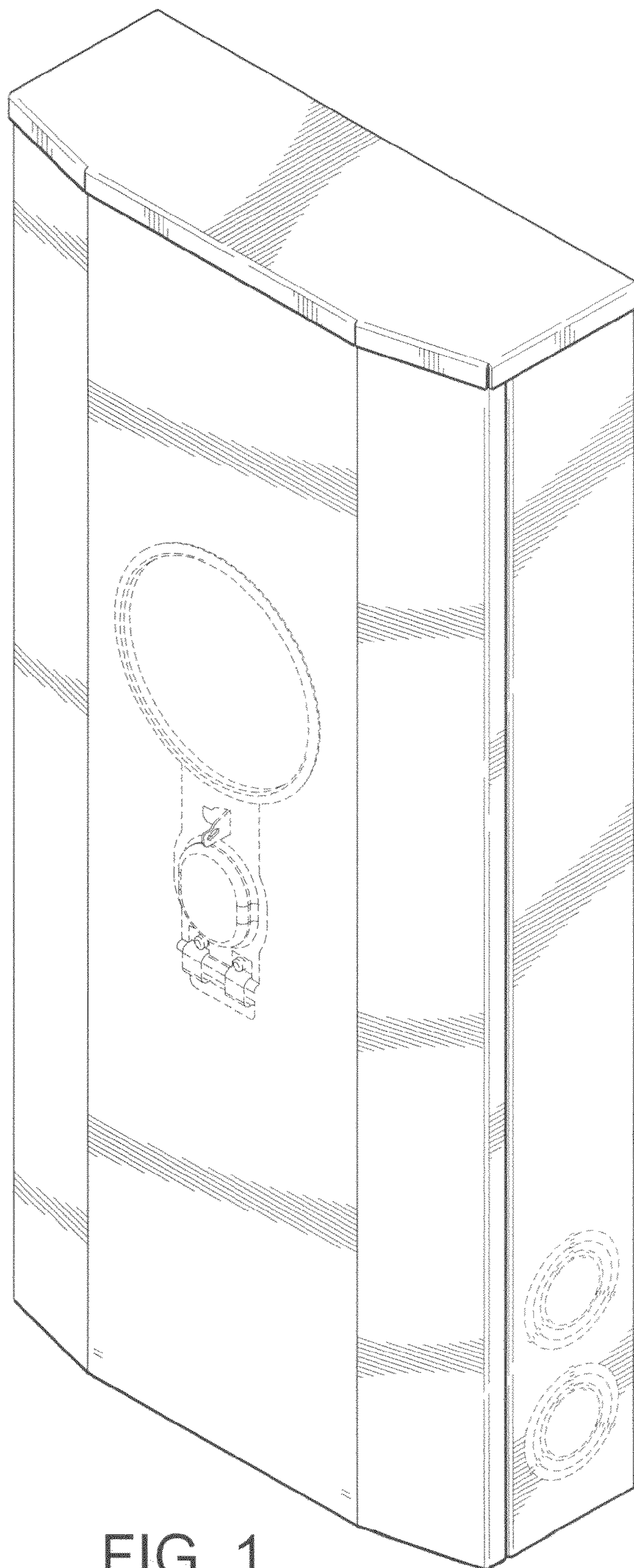

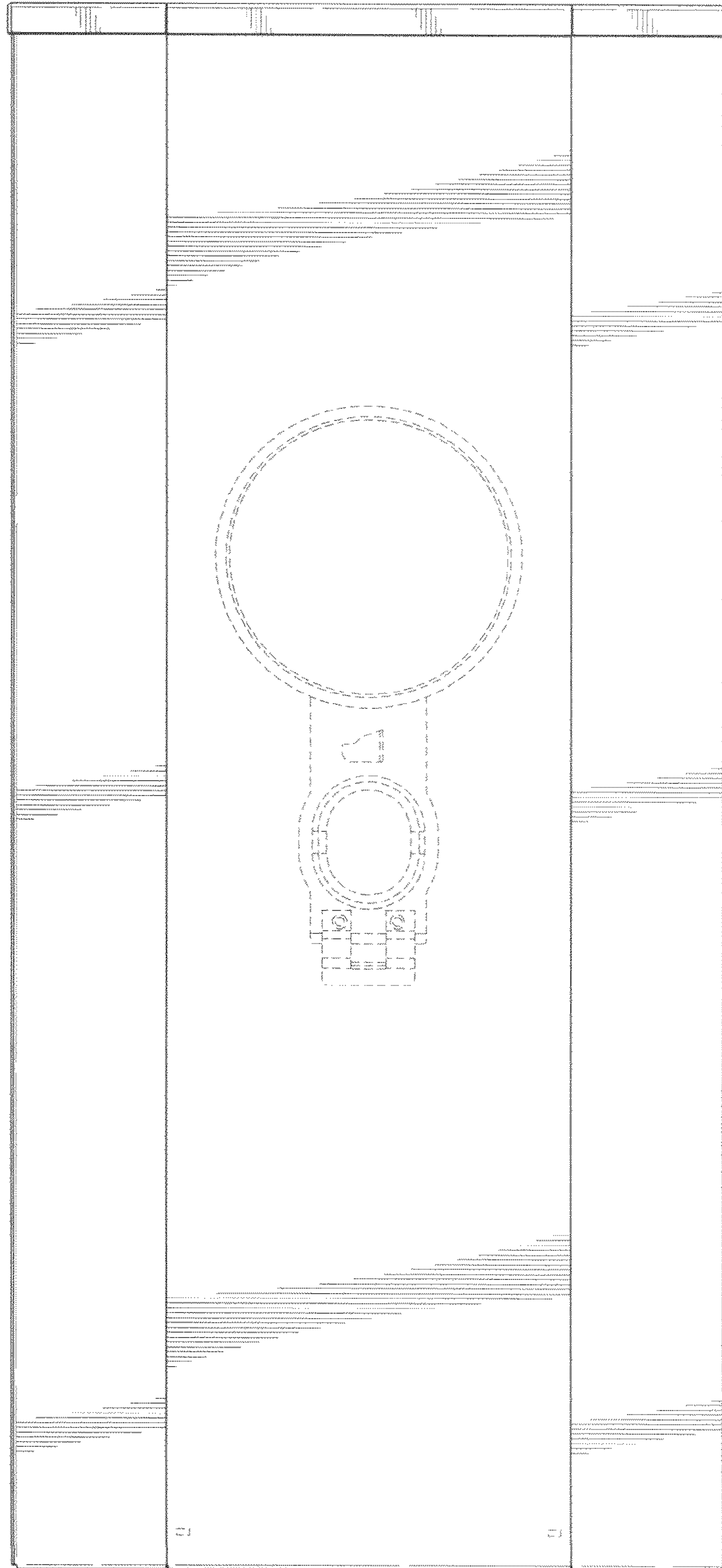

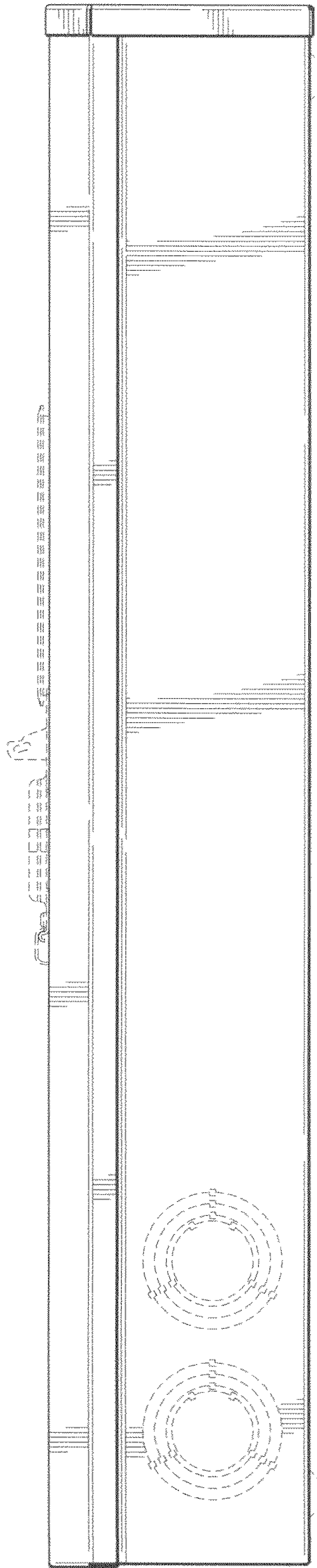

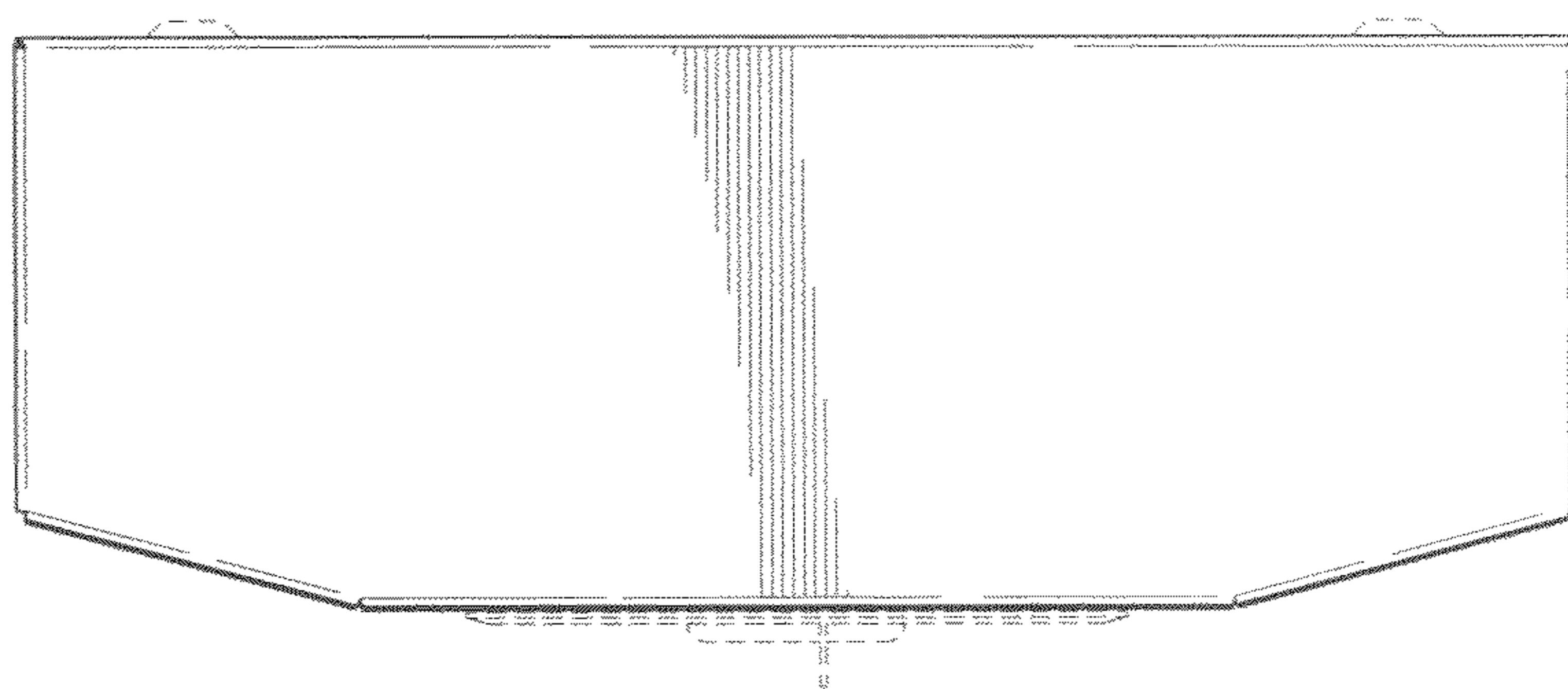

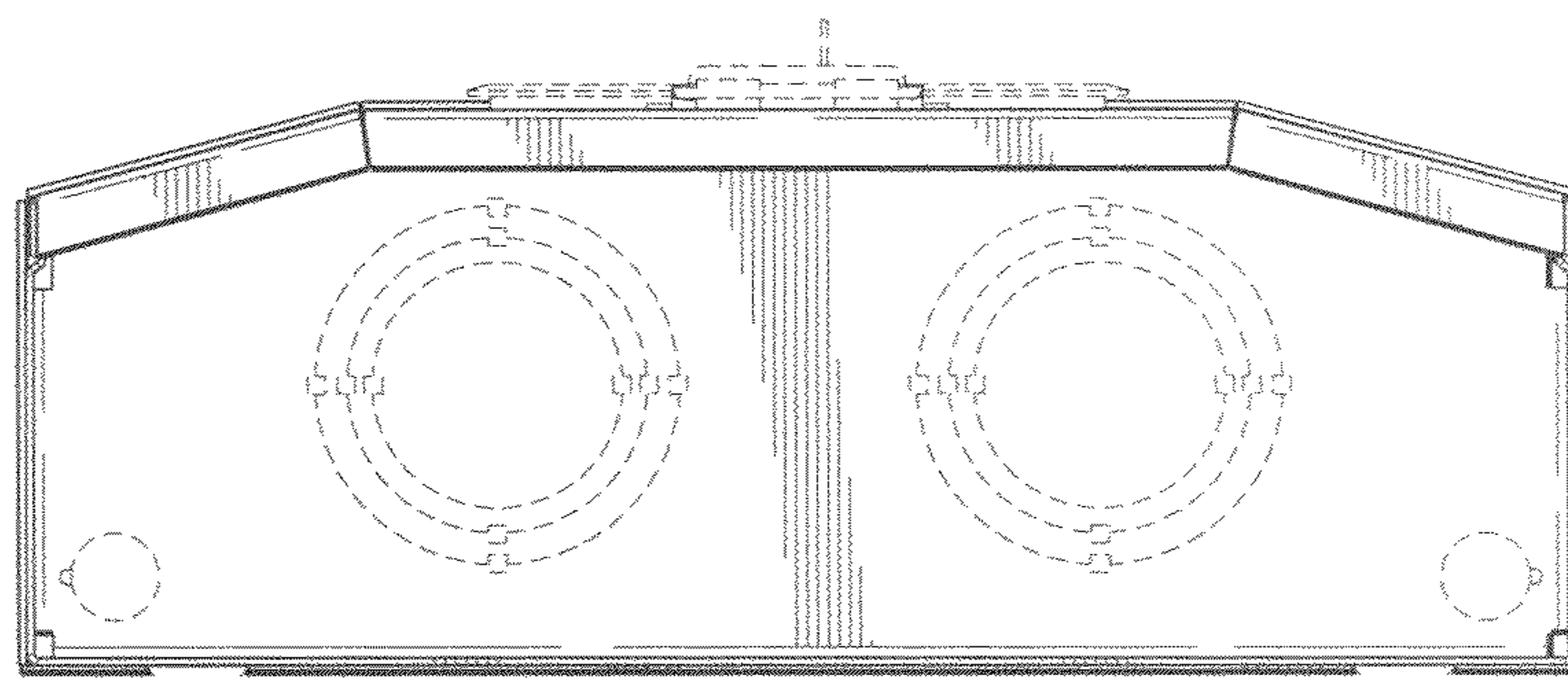
