FIG. 3 is a front elevation view

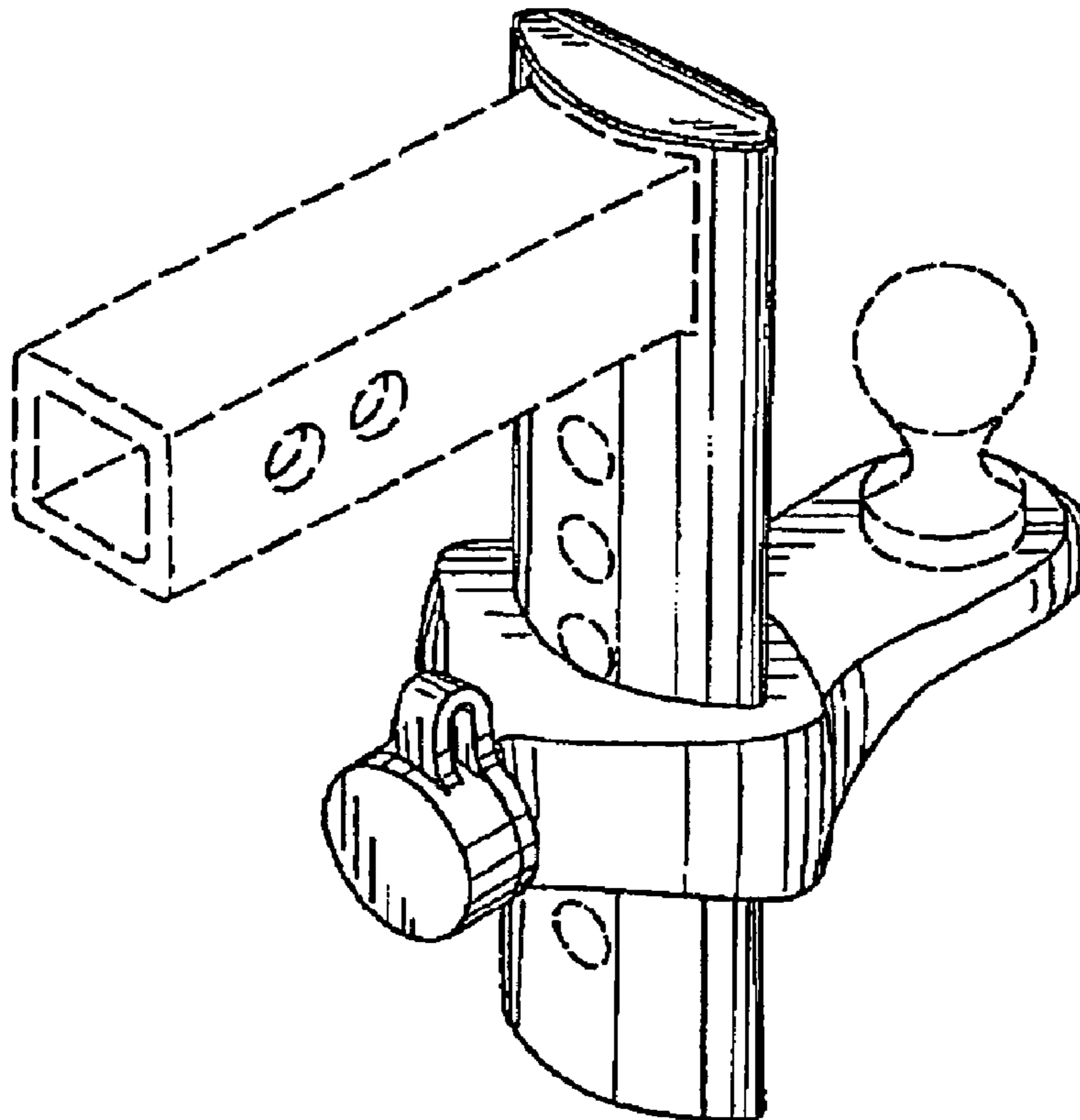
FIG. 4 is a top plan view

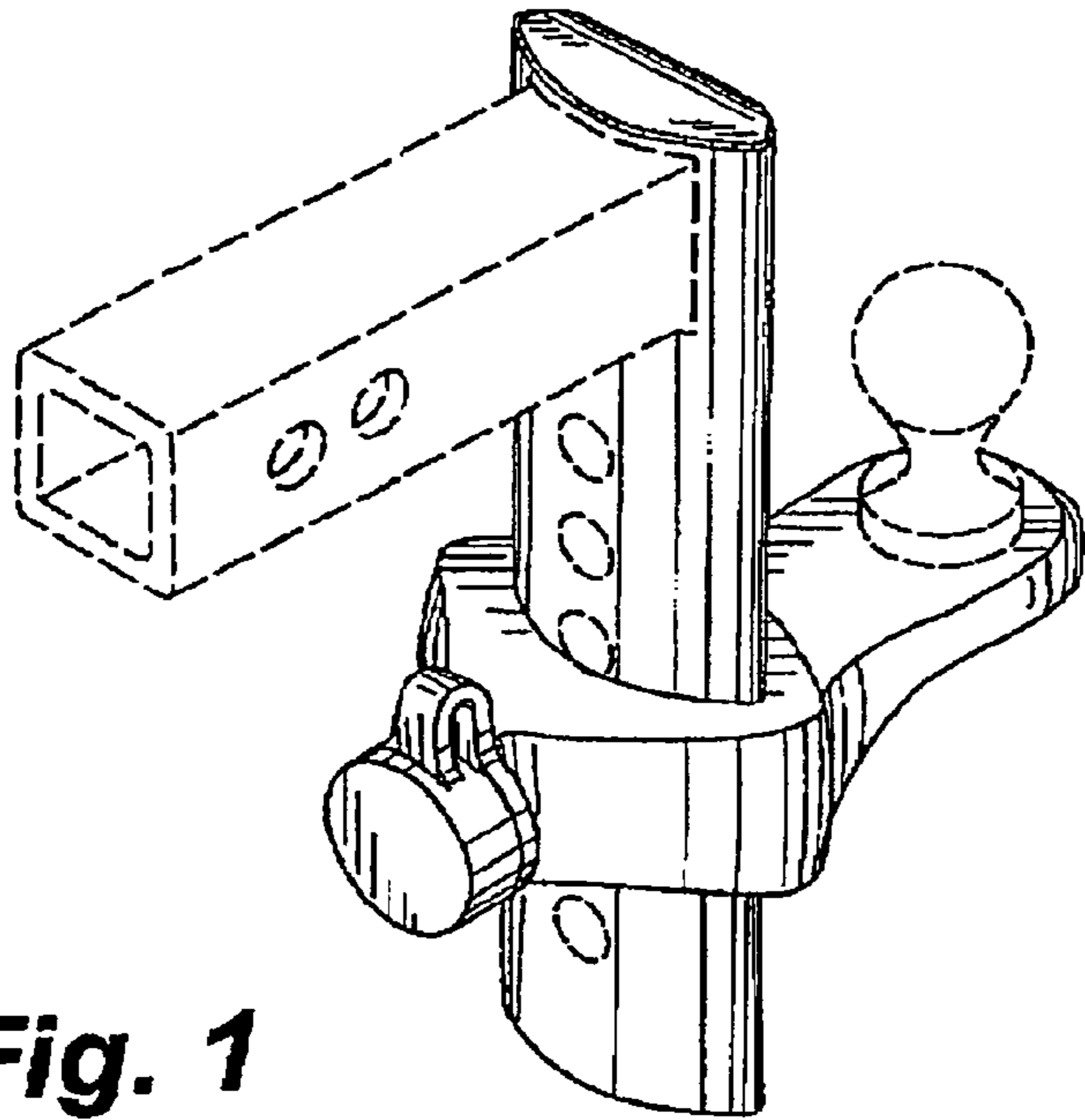
FIG. 5 is a right elevation view; and,

FIG. 6 is a bottom plan view.

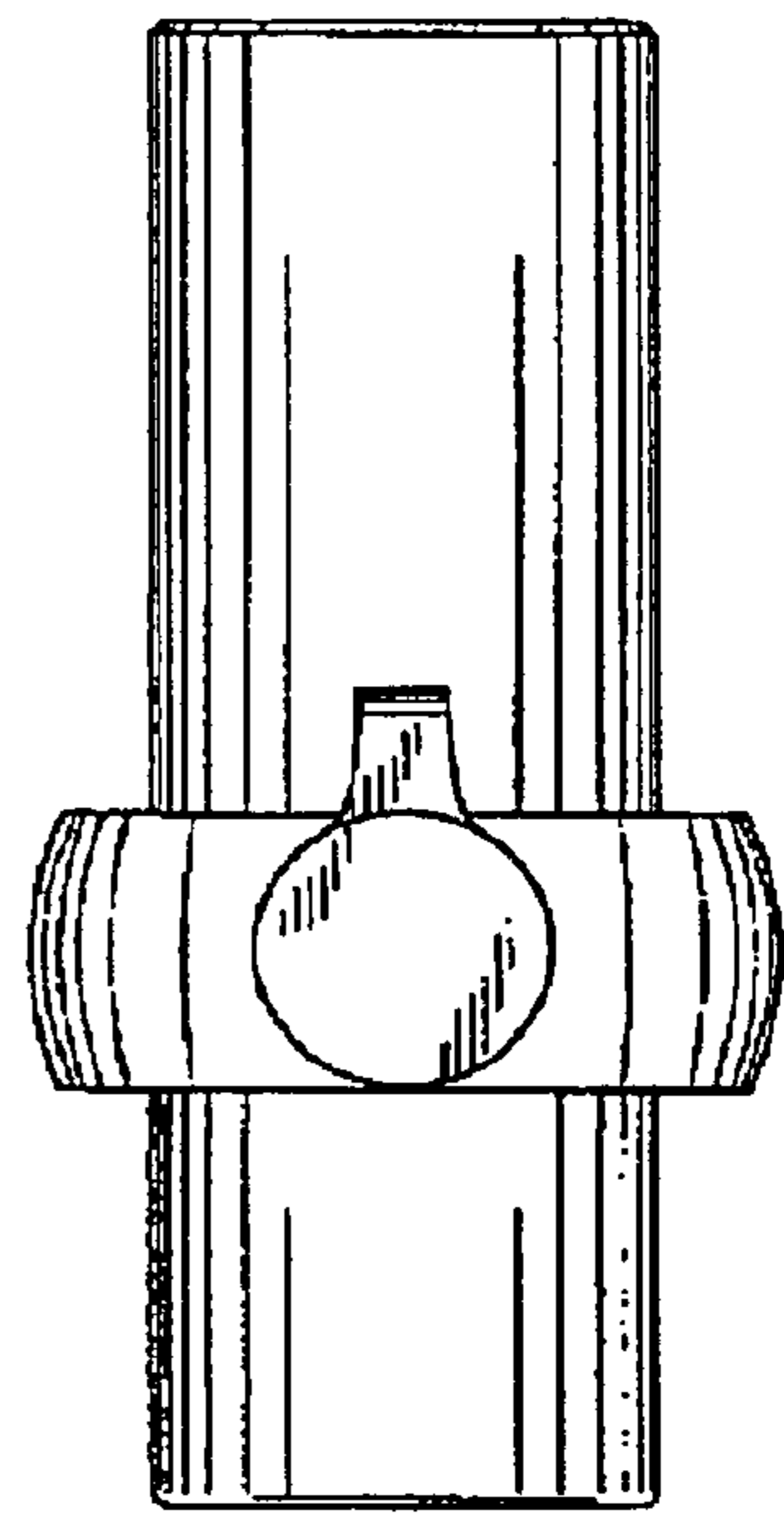
The broken lines in FIG. 1 depict environmental structure associated with the design in a condition of use. The broken lines and structures they depict form no part of the claimed design.

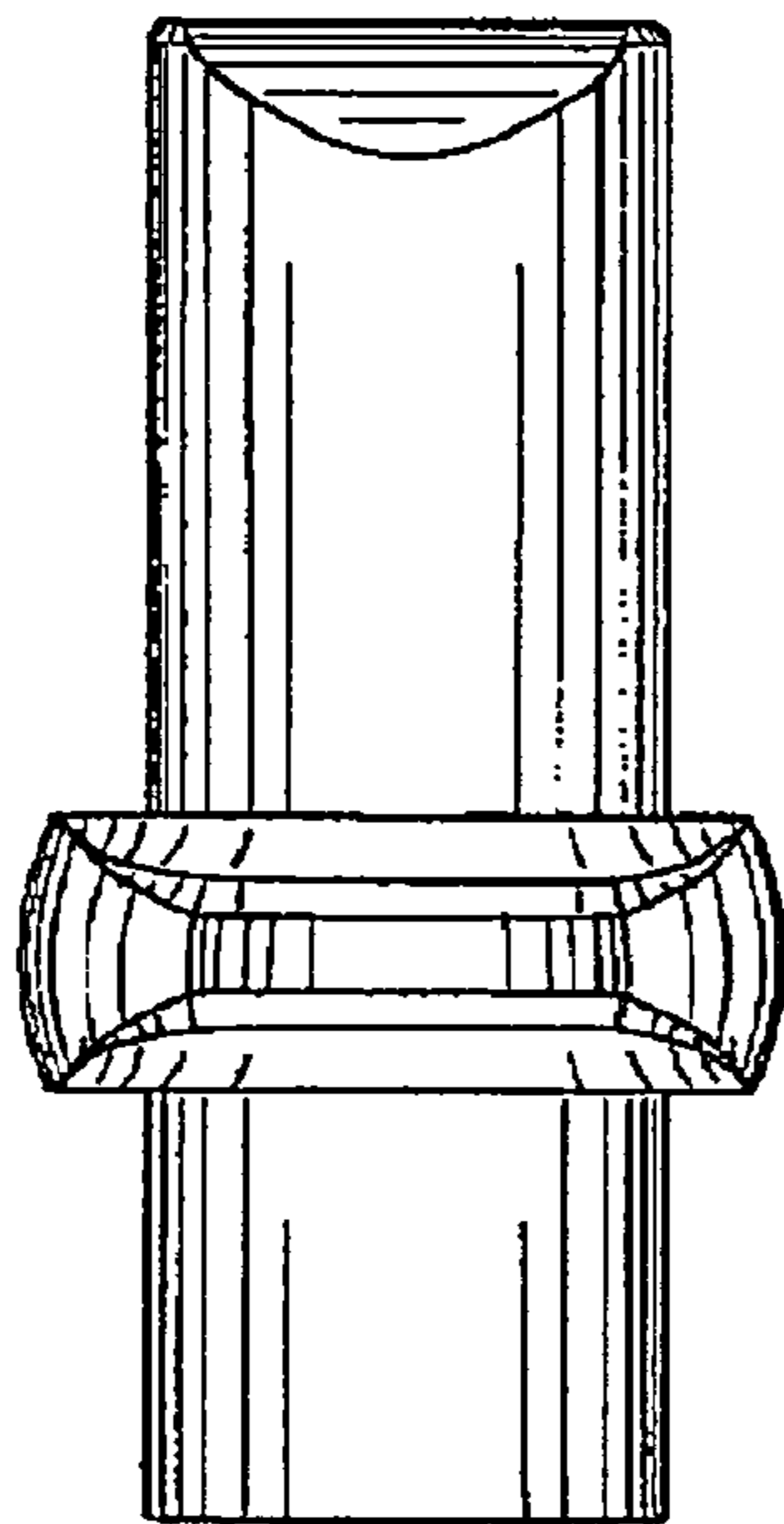

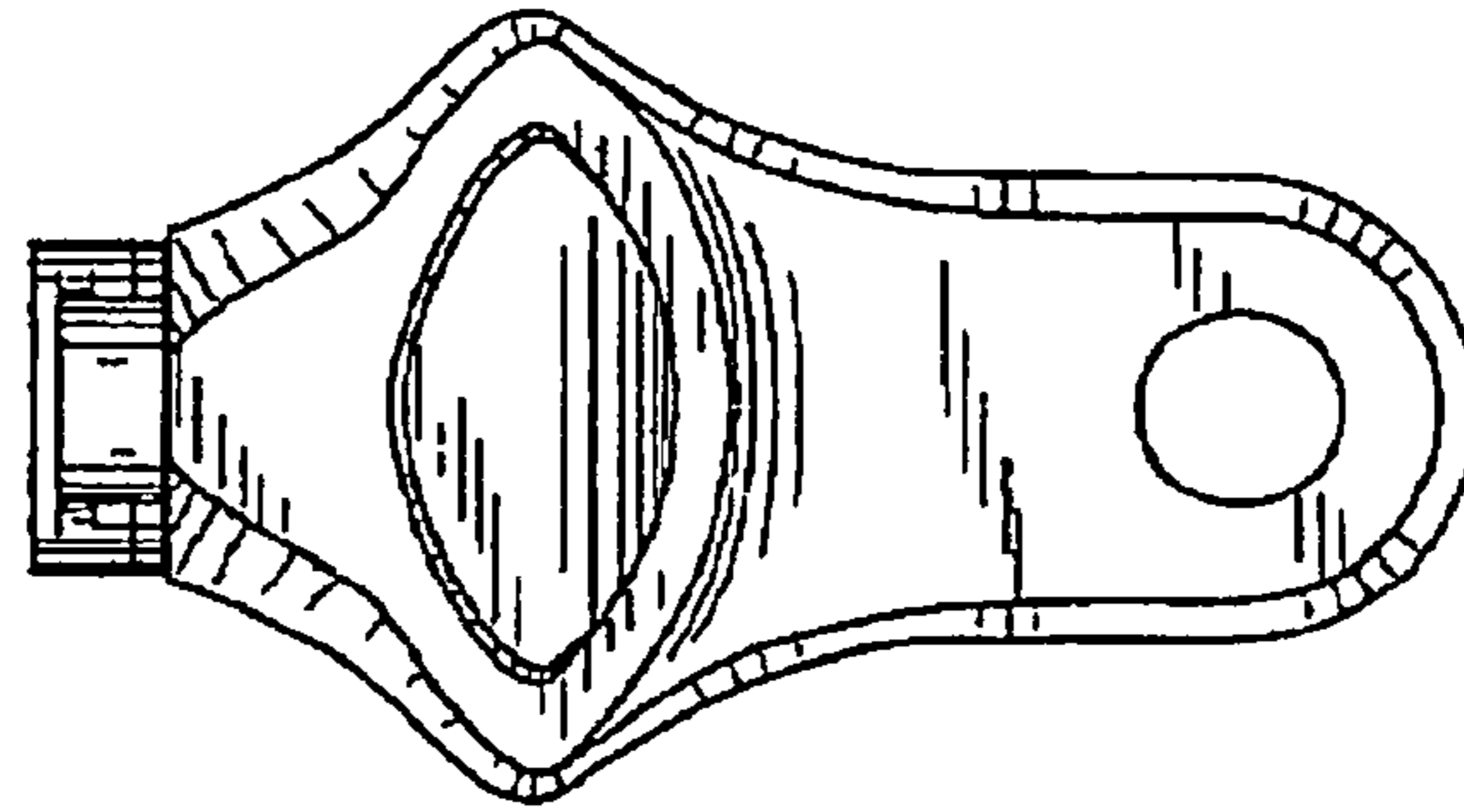

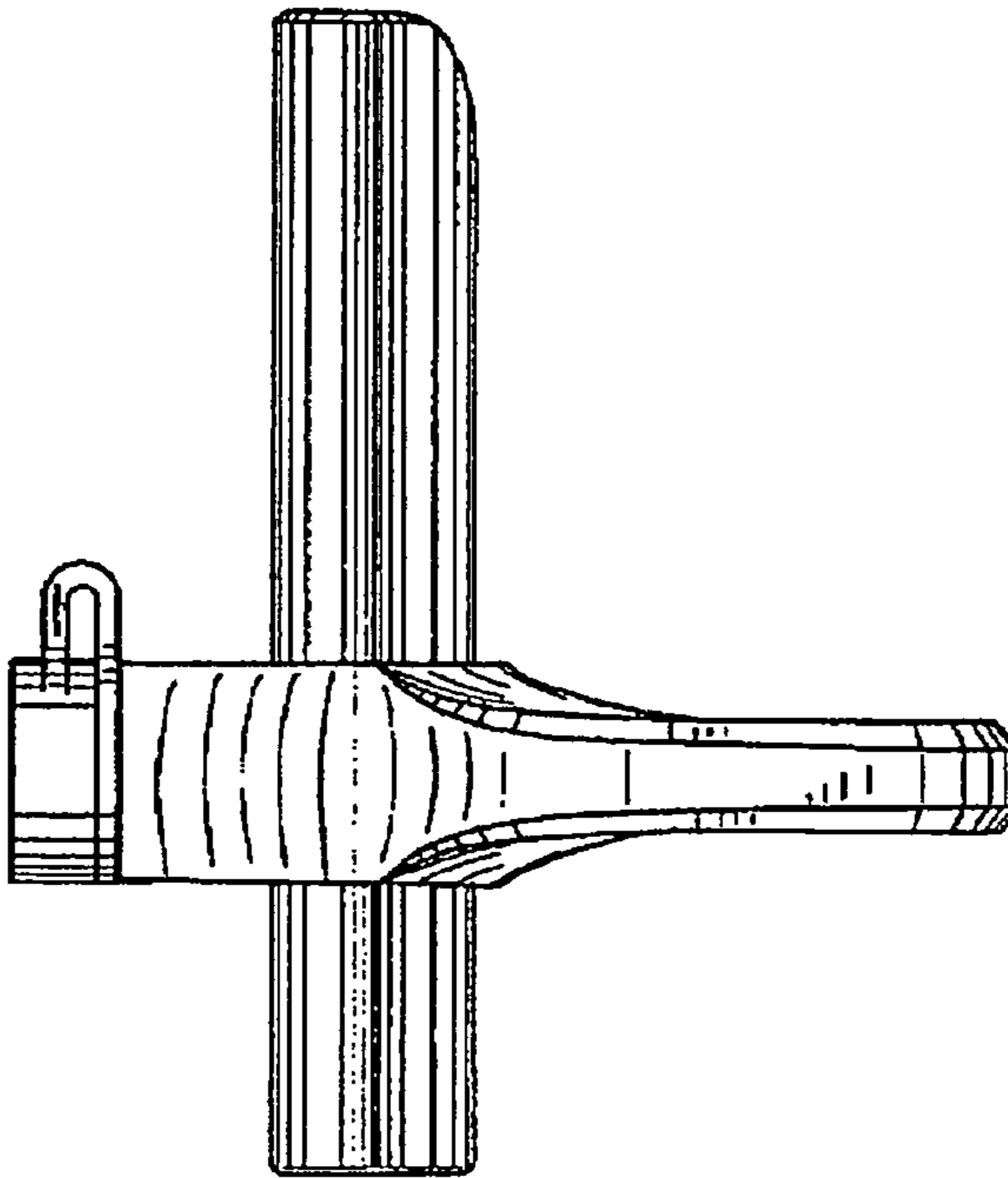
