(57) **CLAIM**

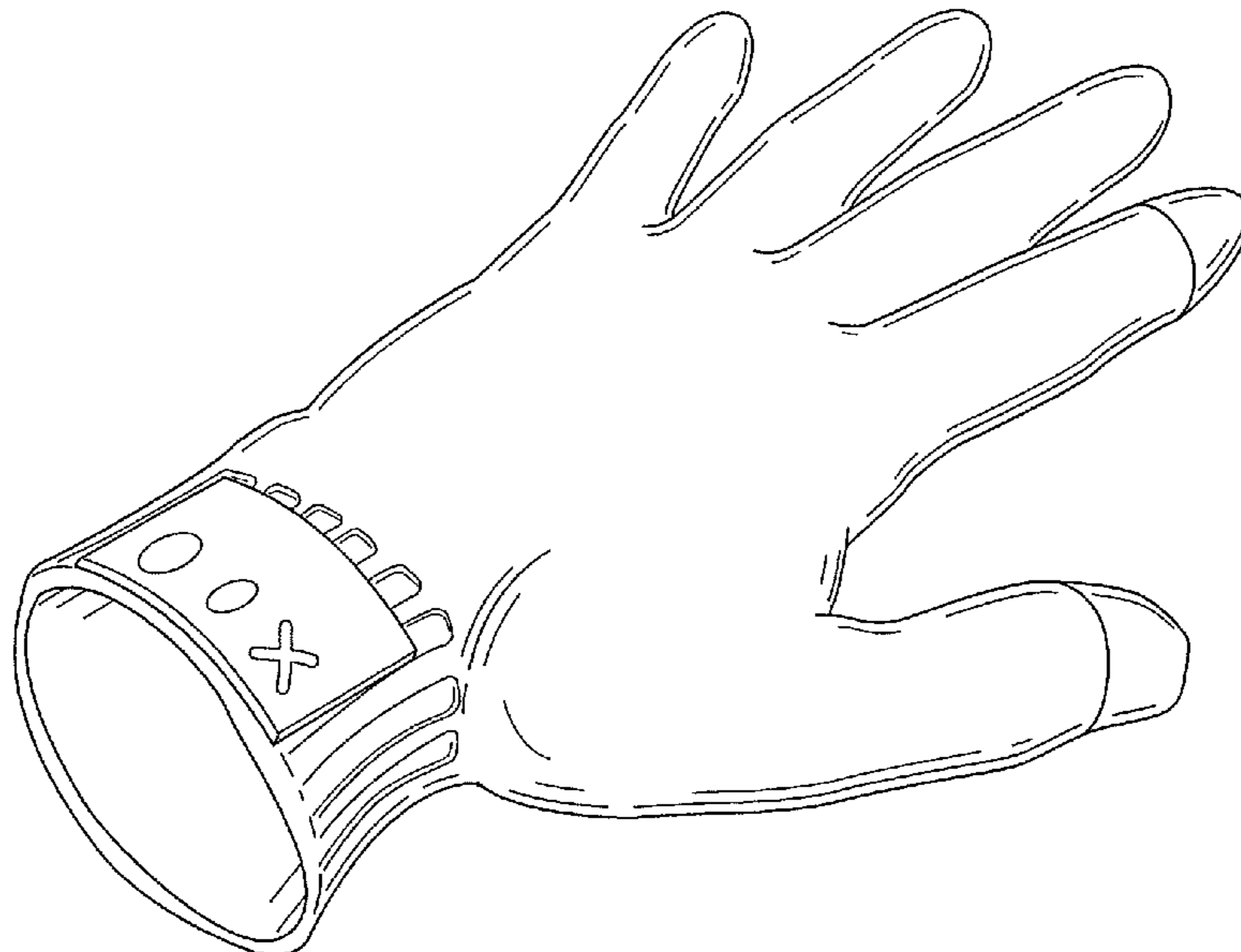
I claim the ornamental design for a glove, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the glove, showing my new, original and ornamental design;
FIG. 2 is a top view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a right view thereof;
FIG. 5 is a left view thereof;
FIG. 6 is a front view thereof; and,
FIG. 7 is a rear view thereof.

The drawings show a left-handed glove. A right-handed glove is also claimed and would be a mirror image of the left-handed glove shown.

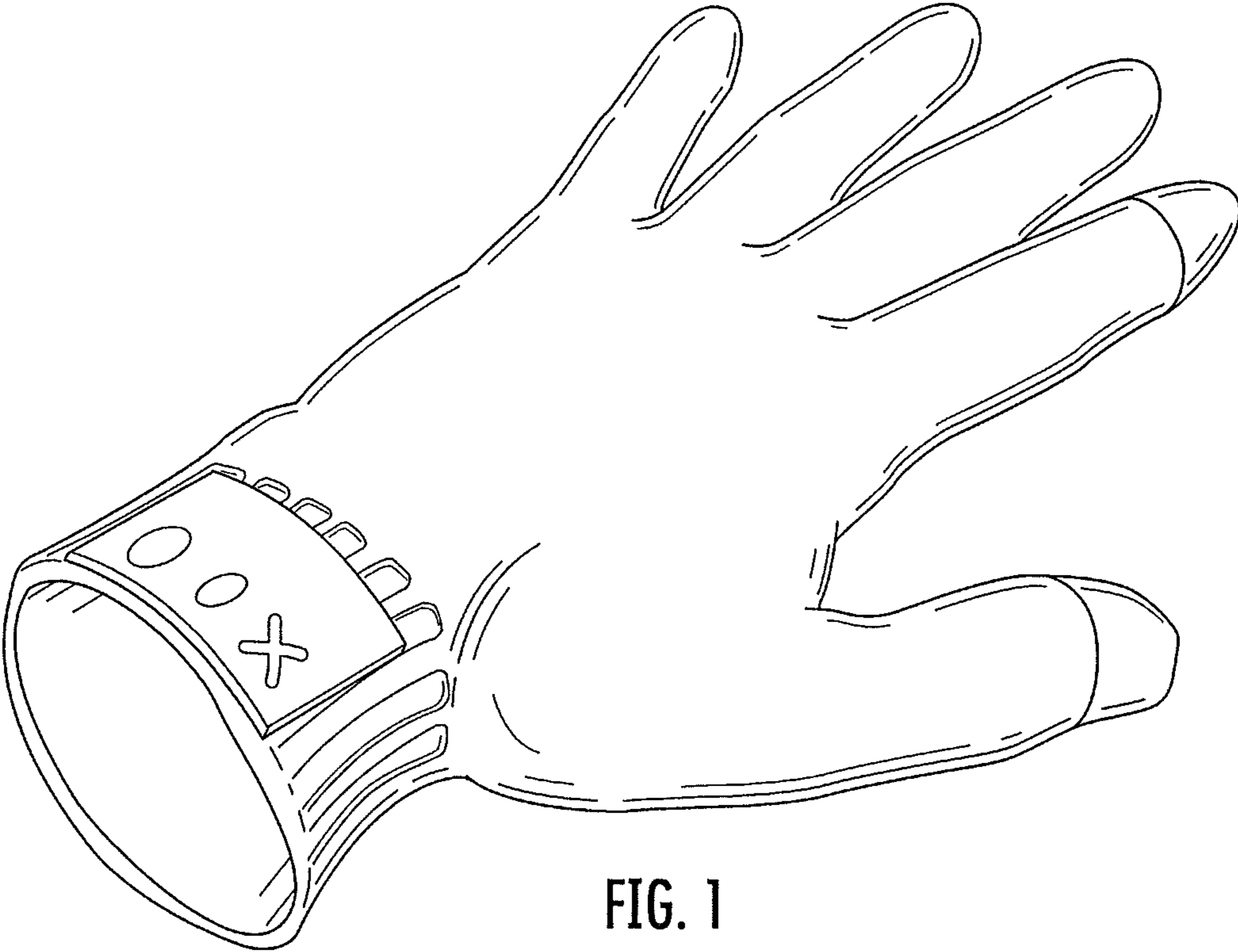

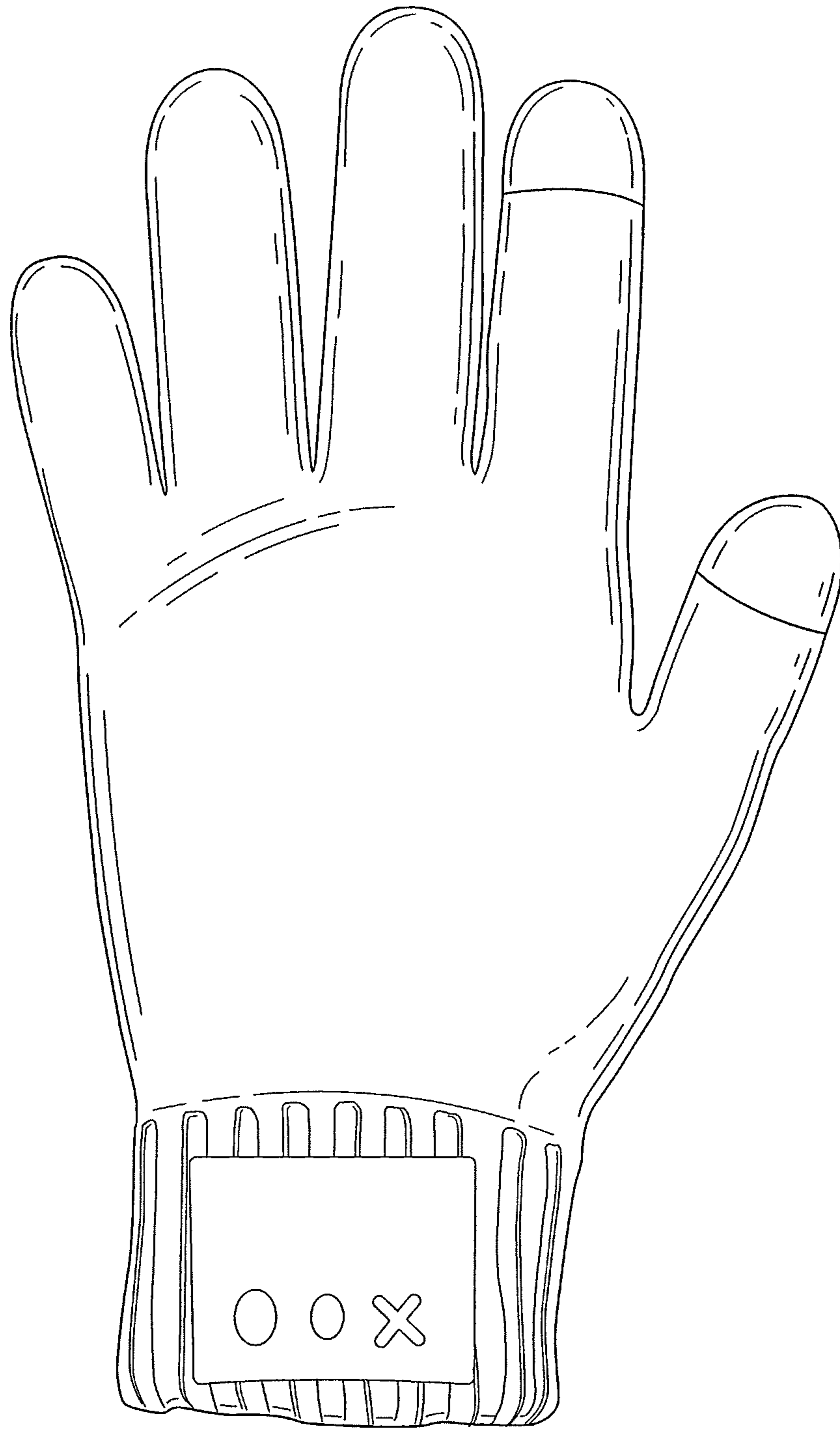

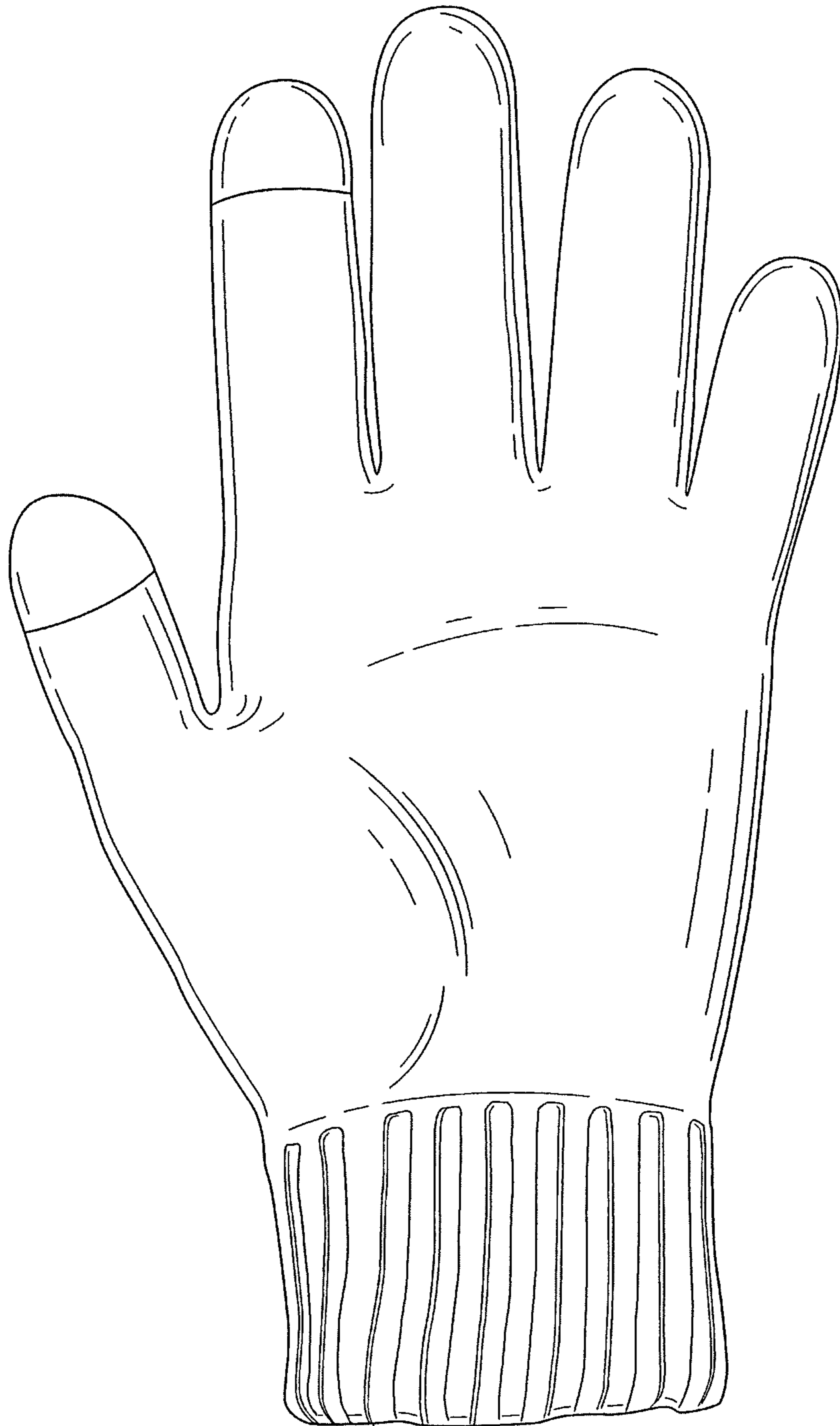

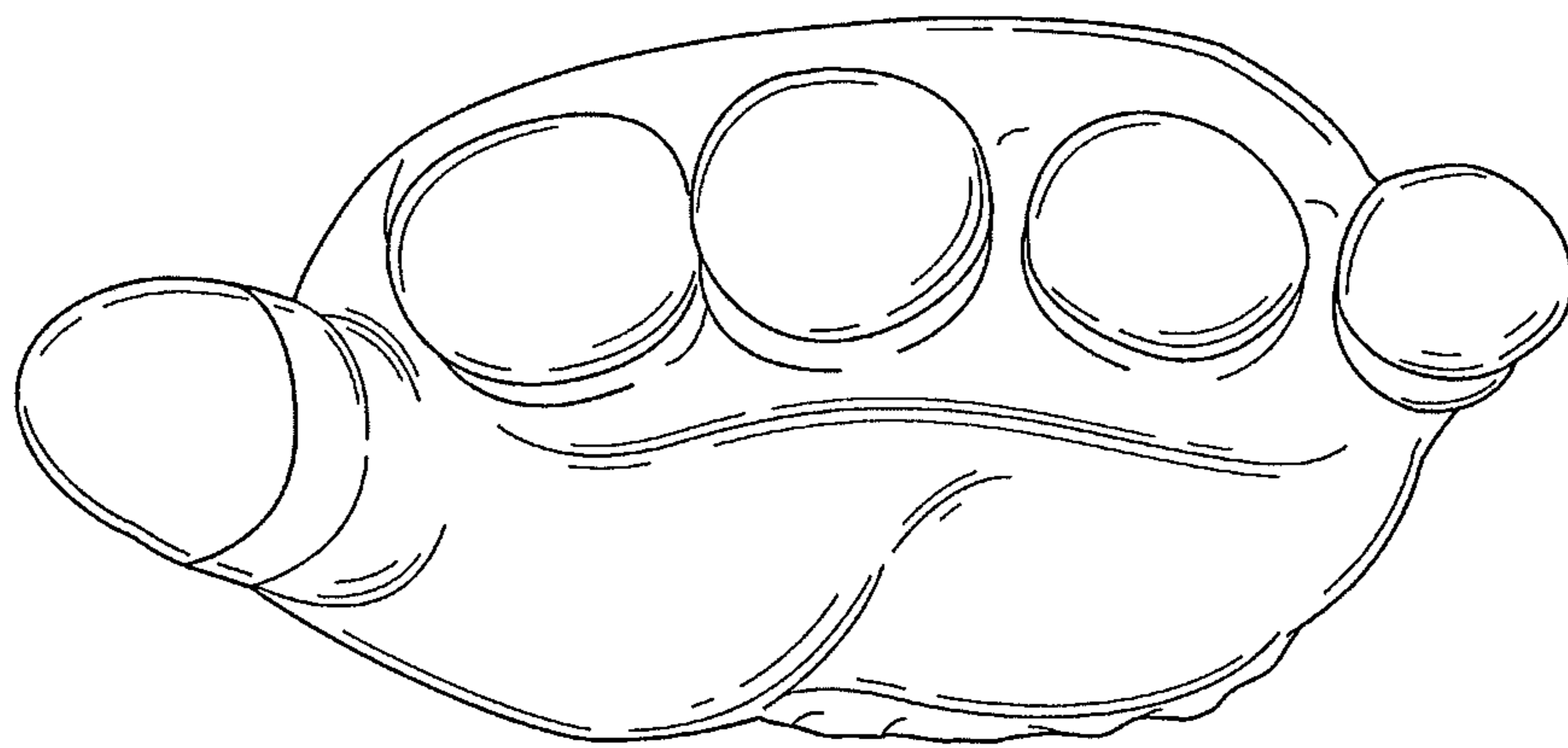

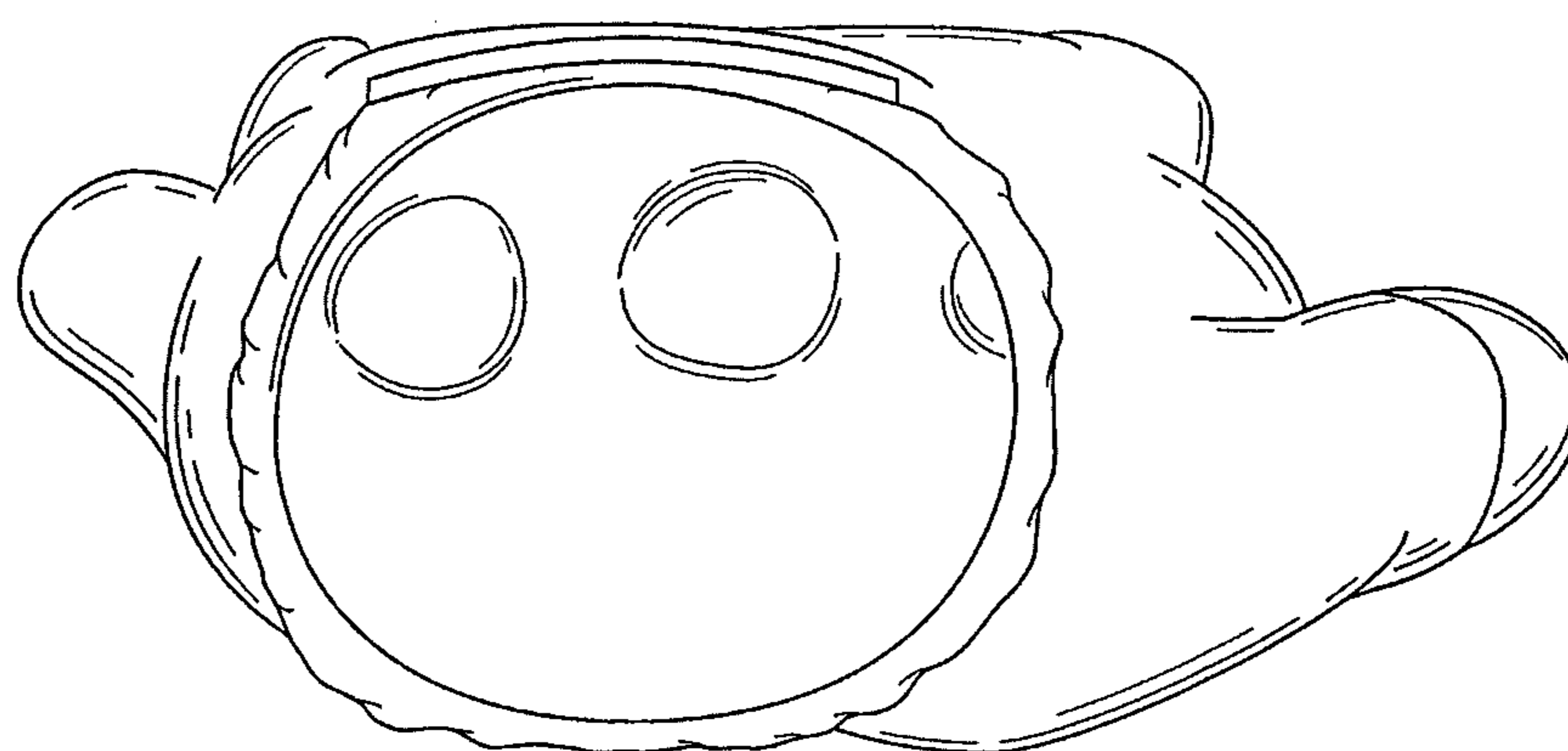
