(57) **CLAIM**

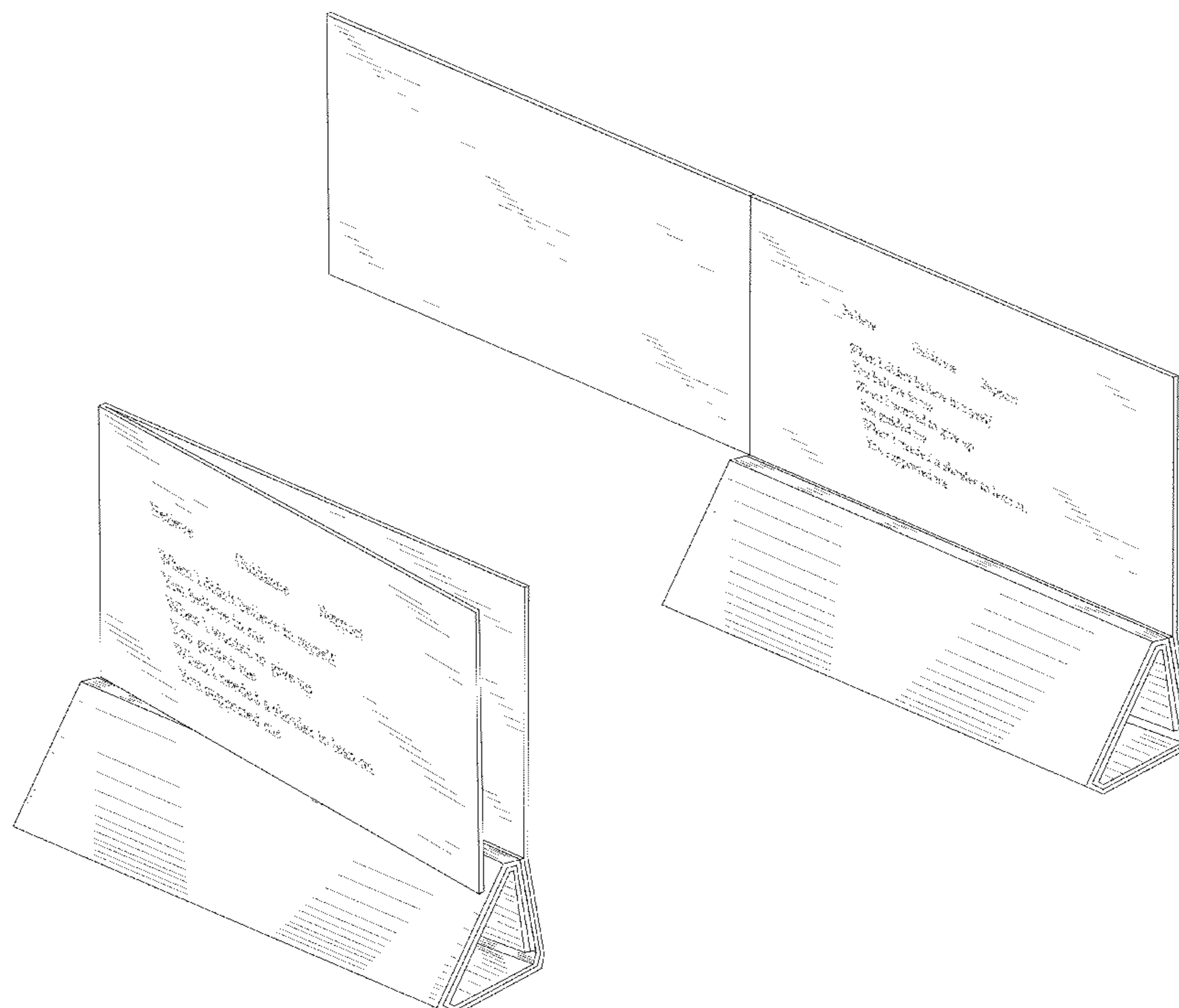
The ornamental design for a group greeting card, as shown and described.

**DESCRIPTION**

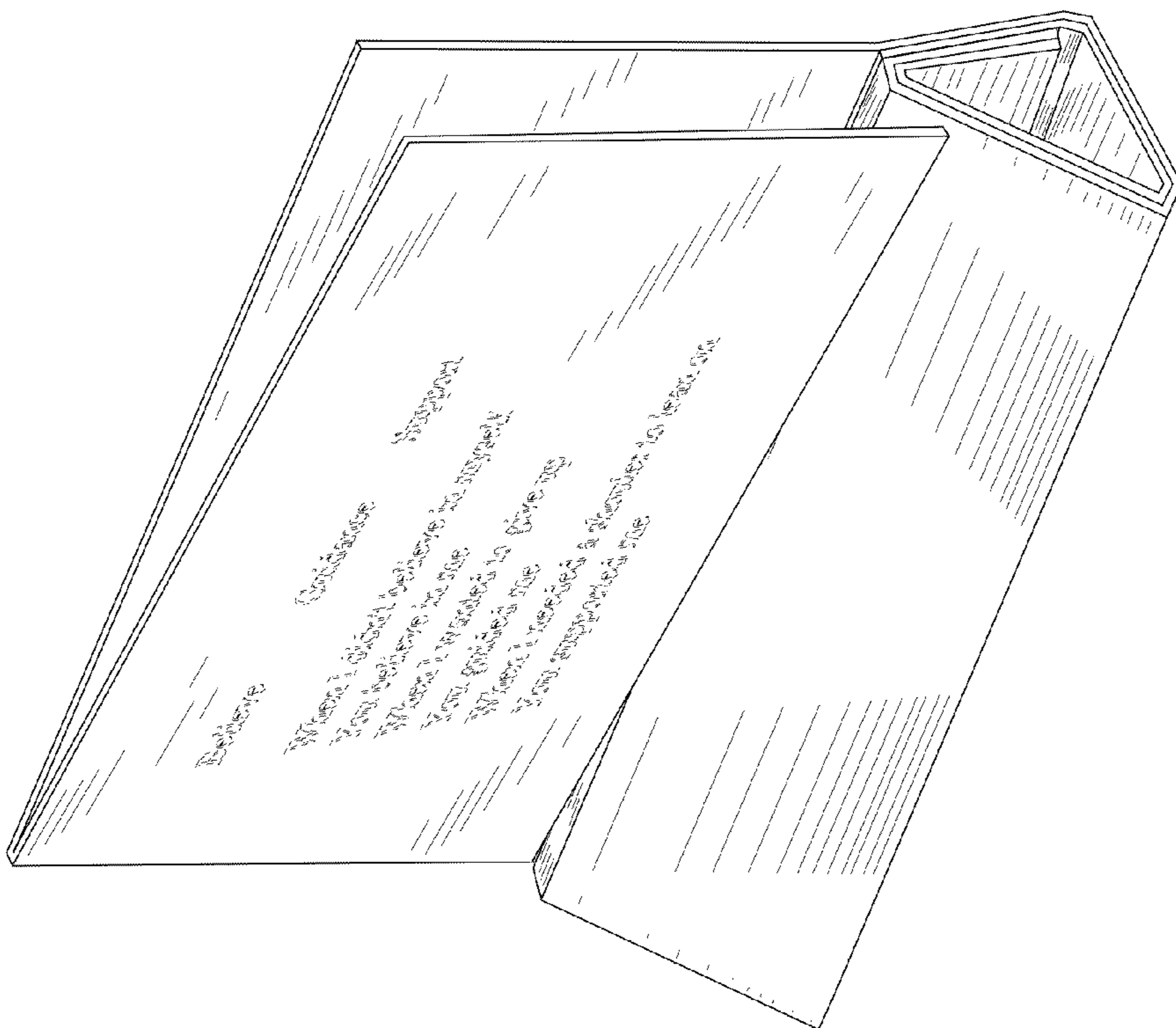

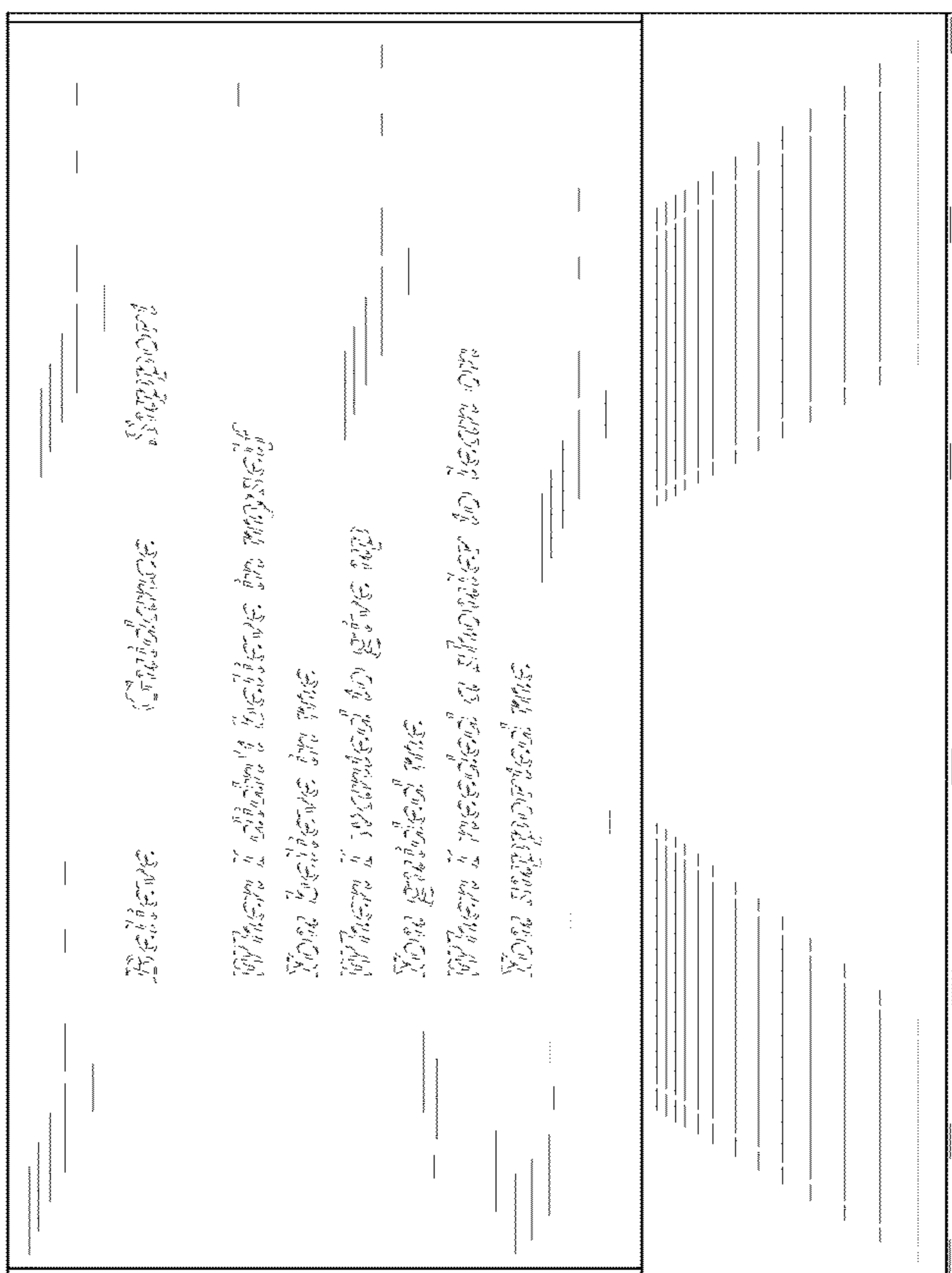

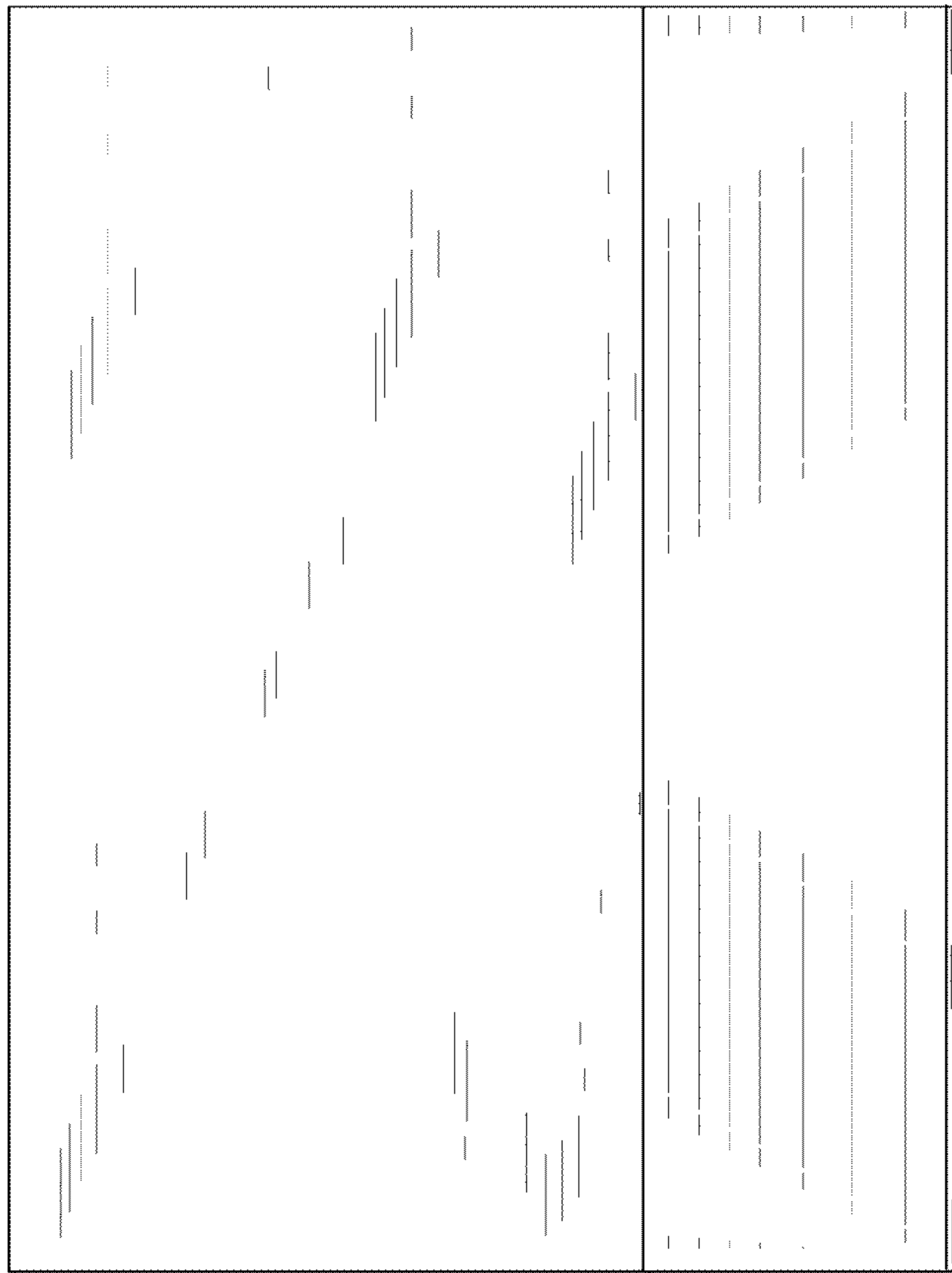

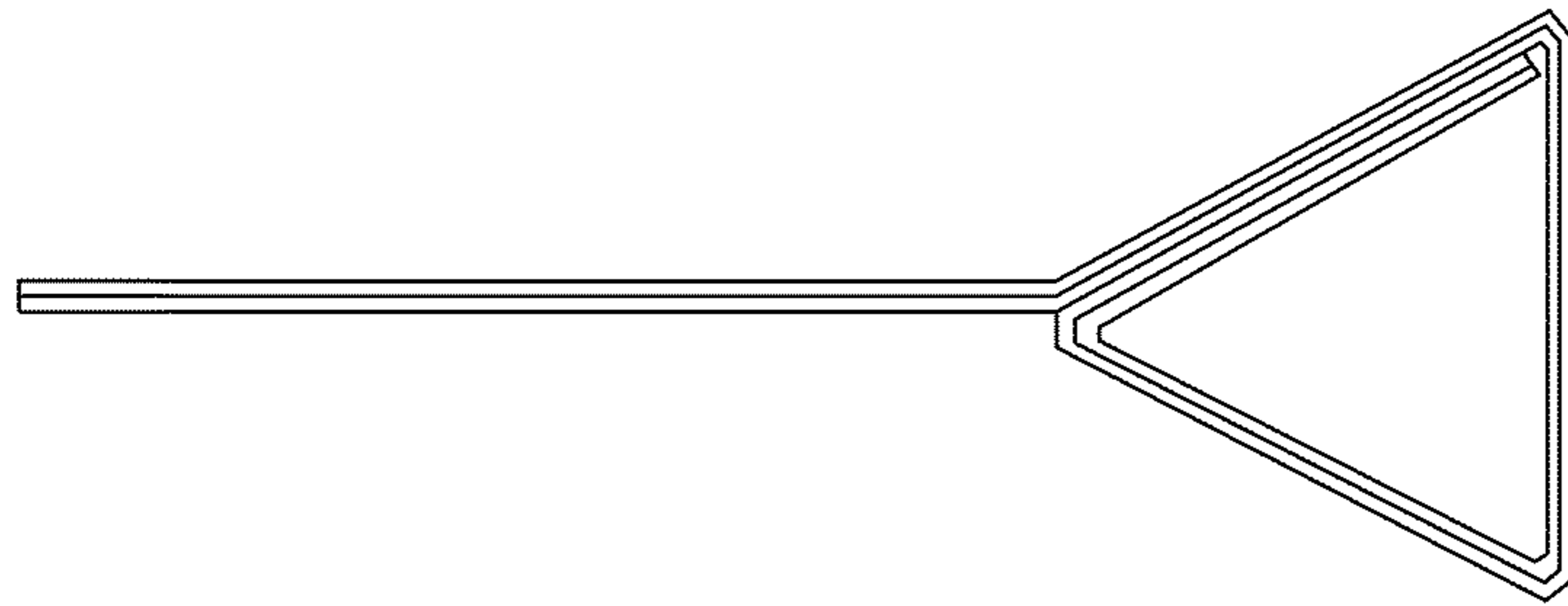

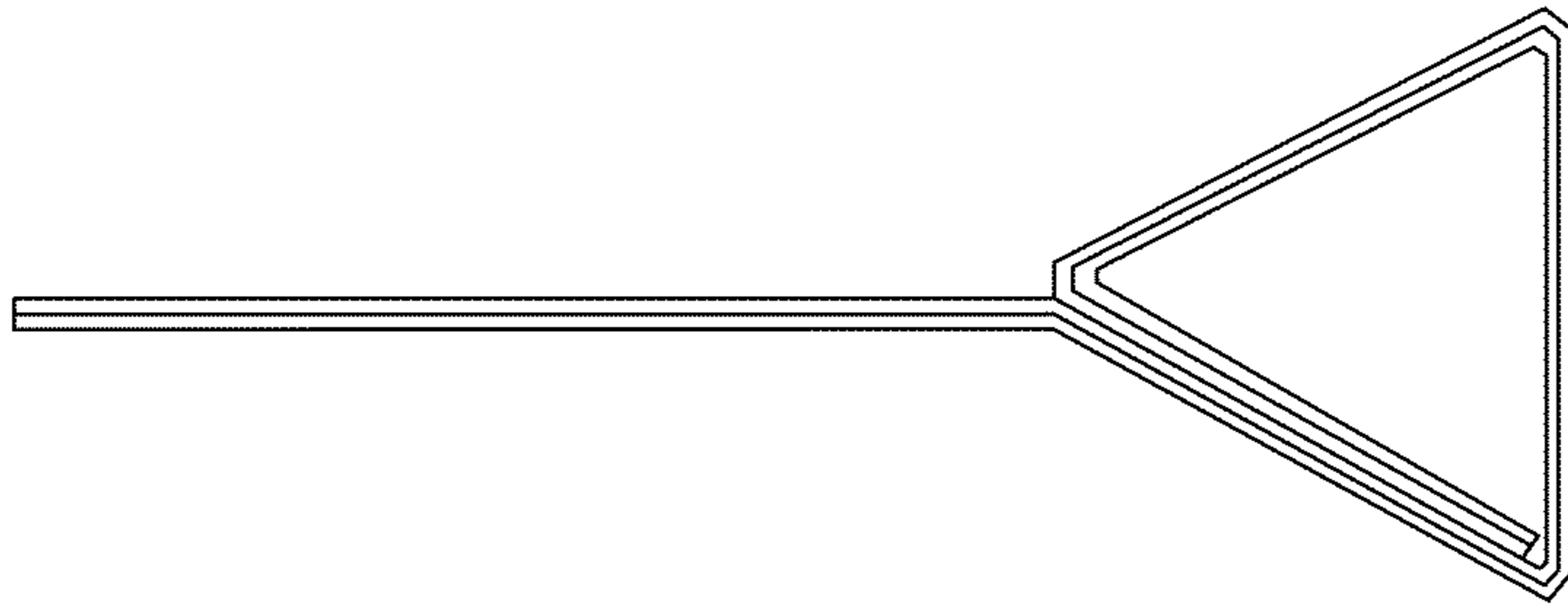

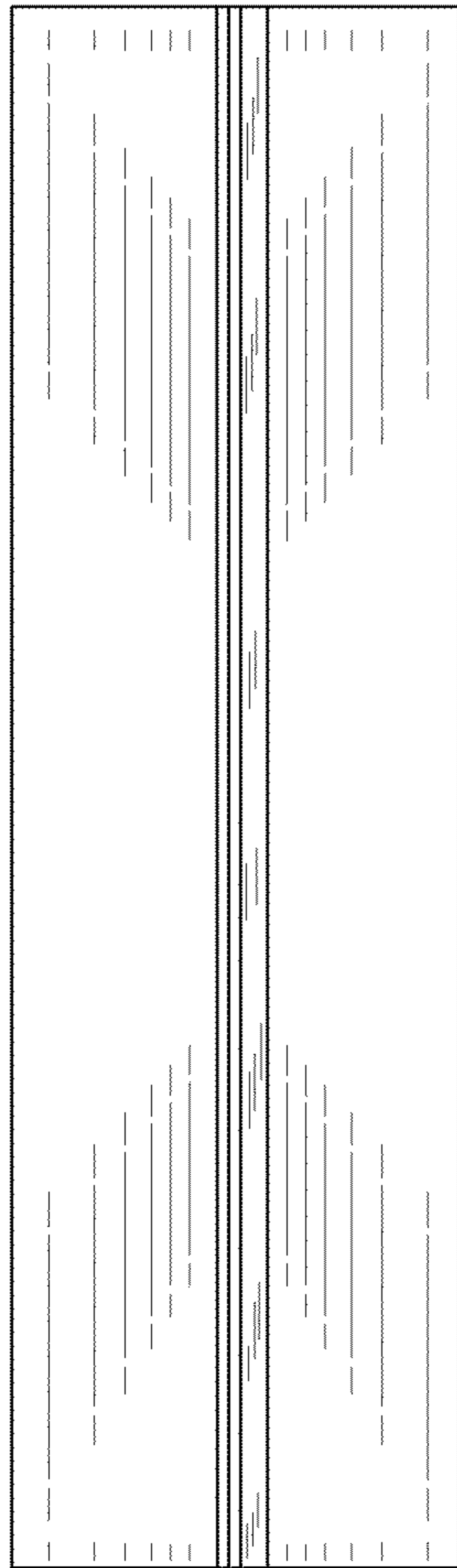

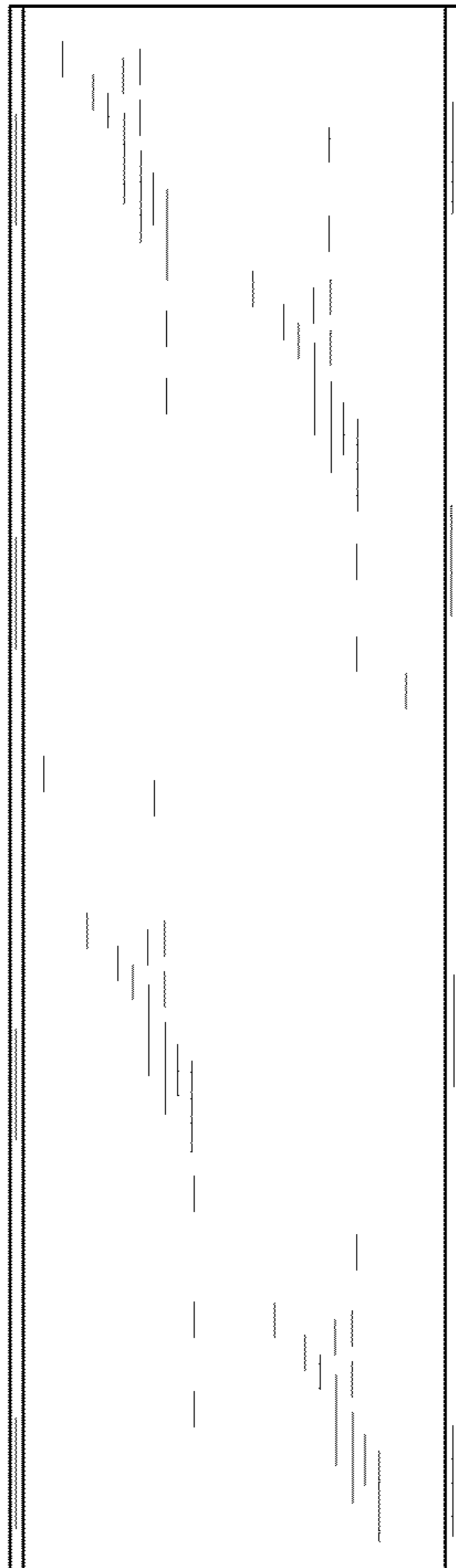

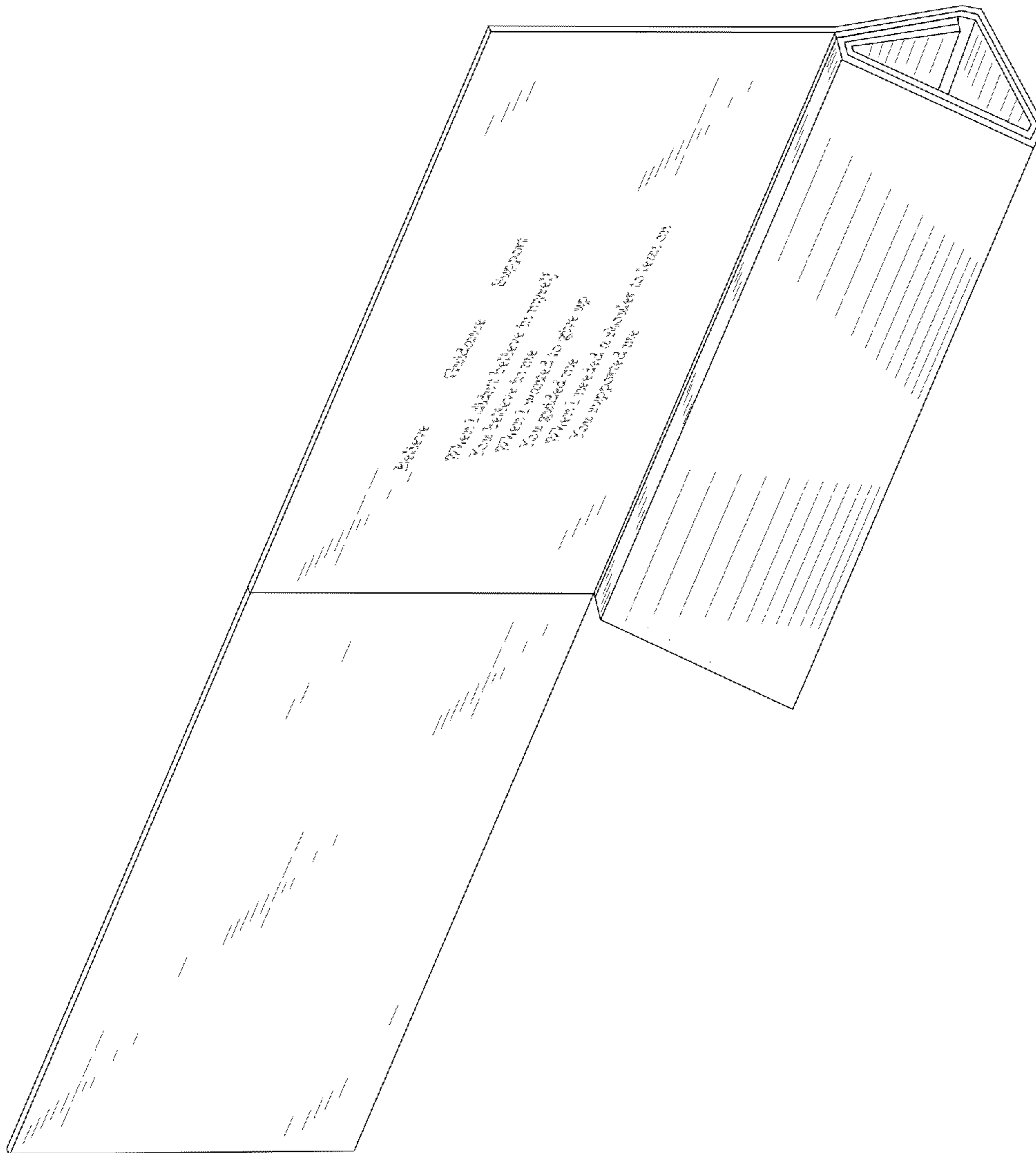

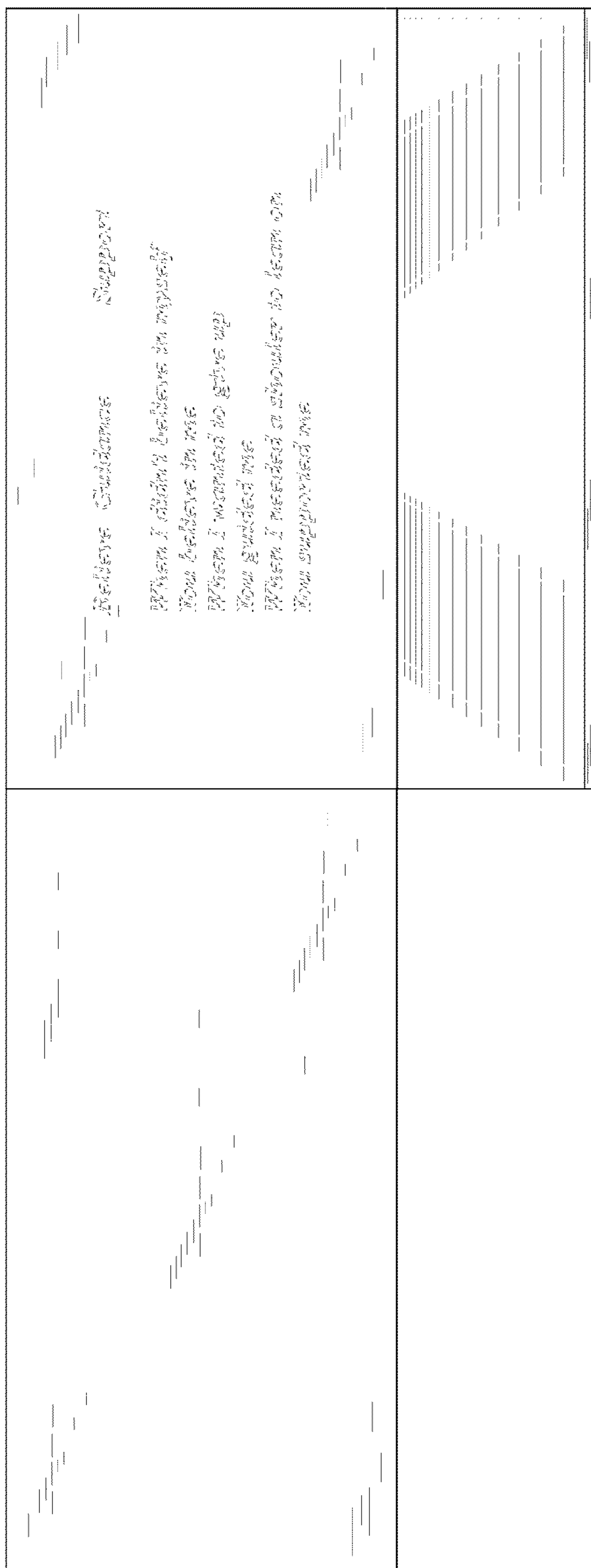

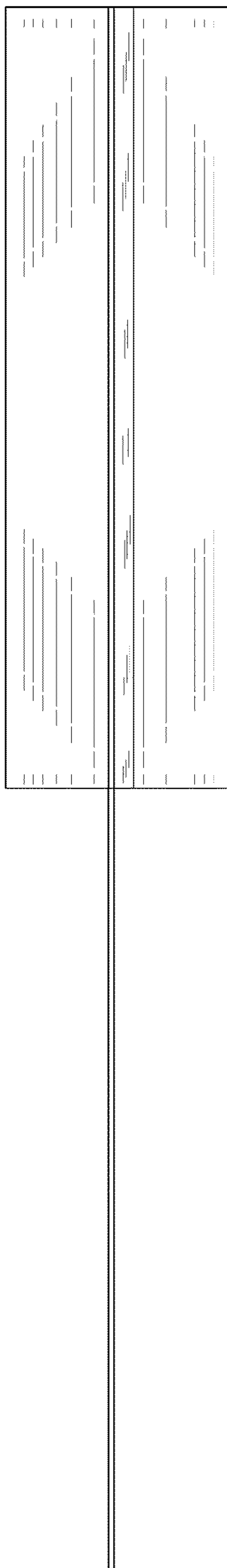

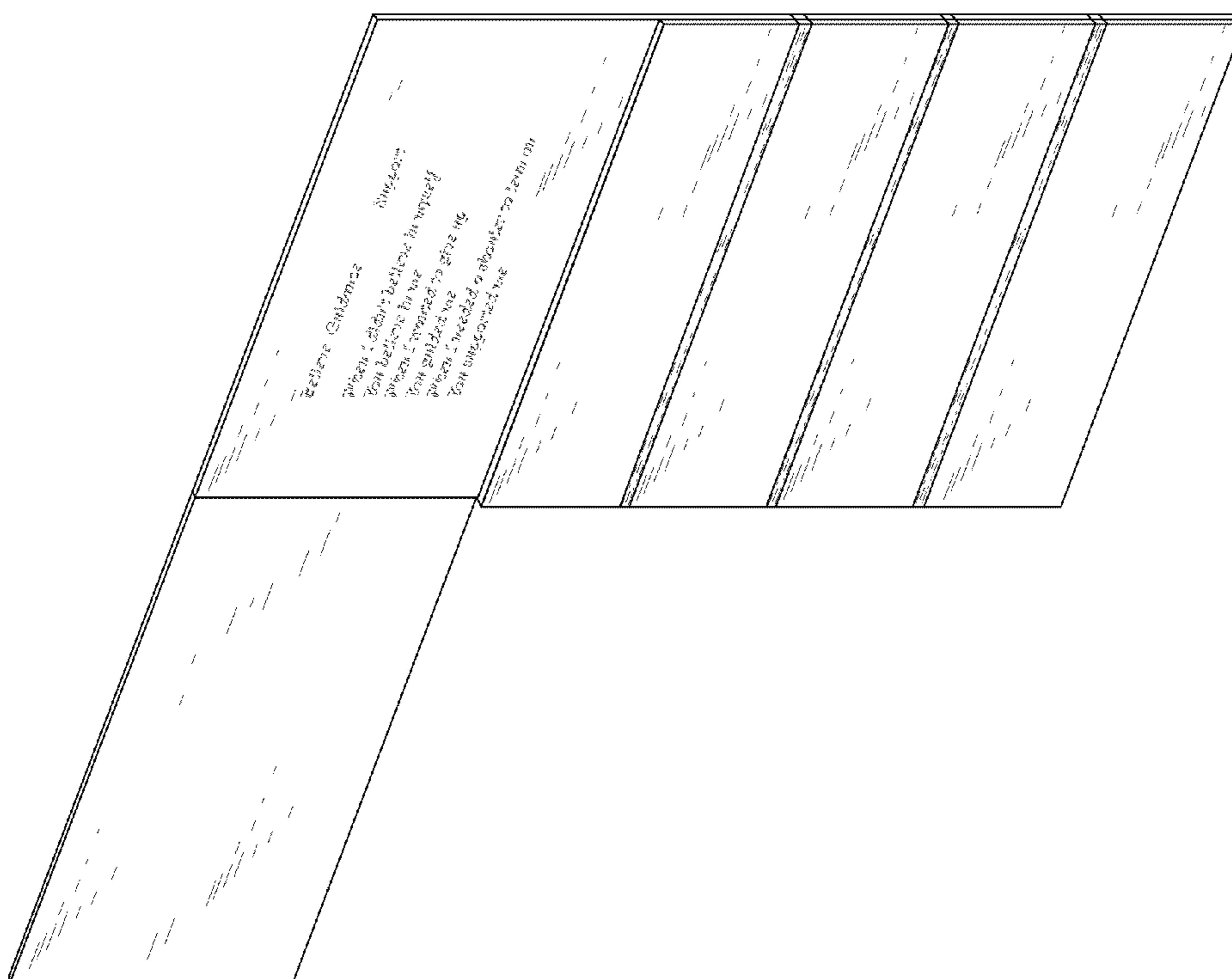

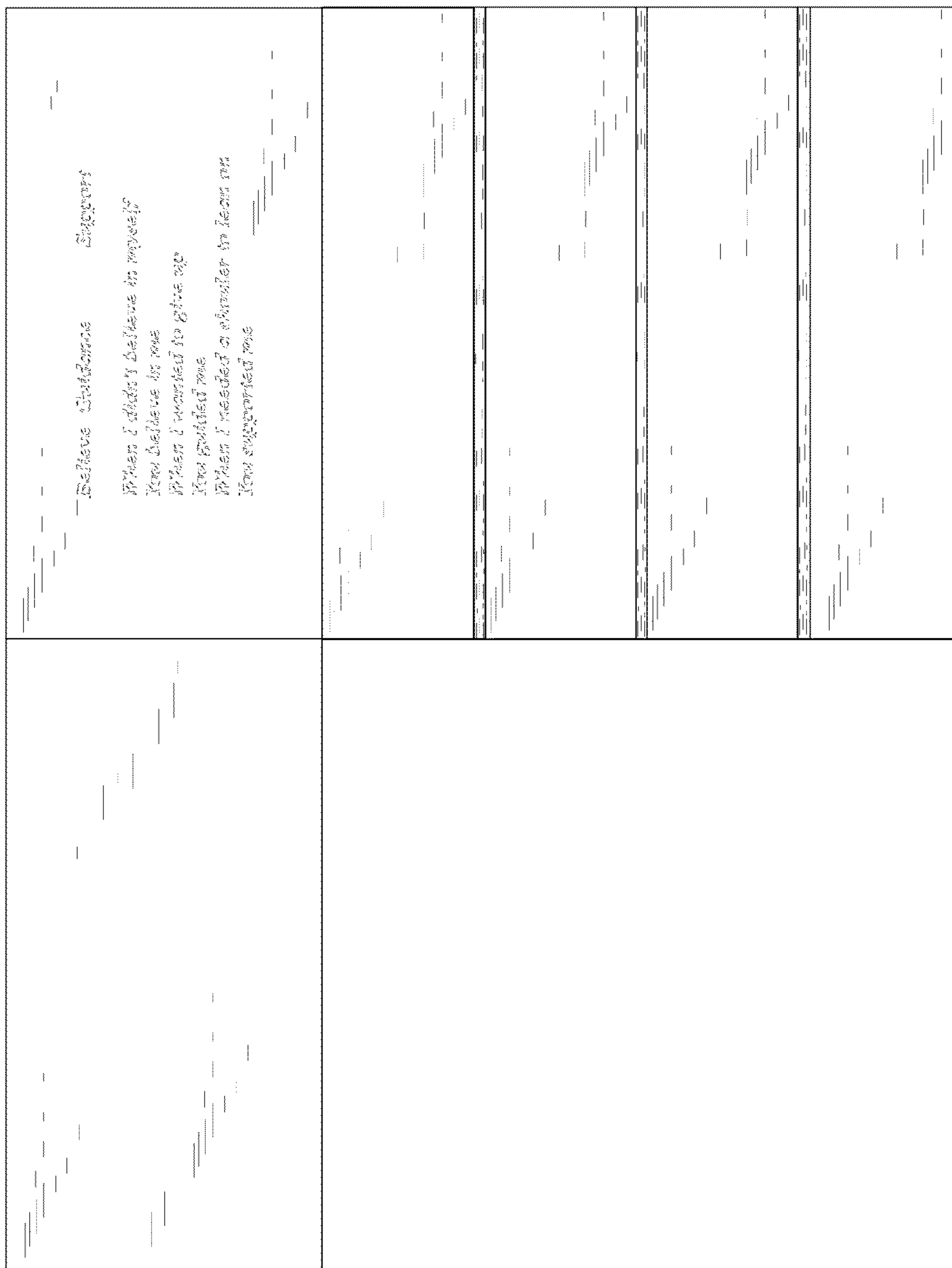

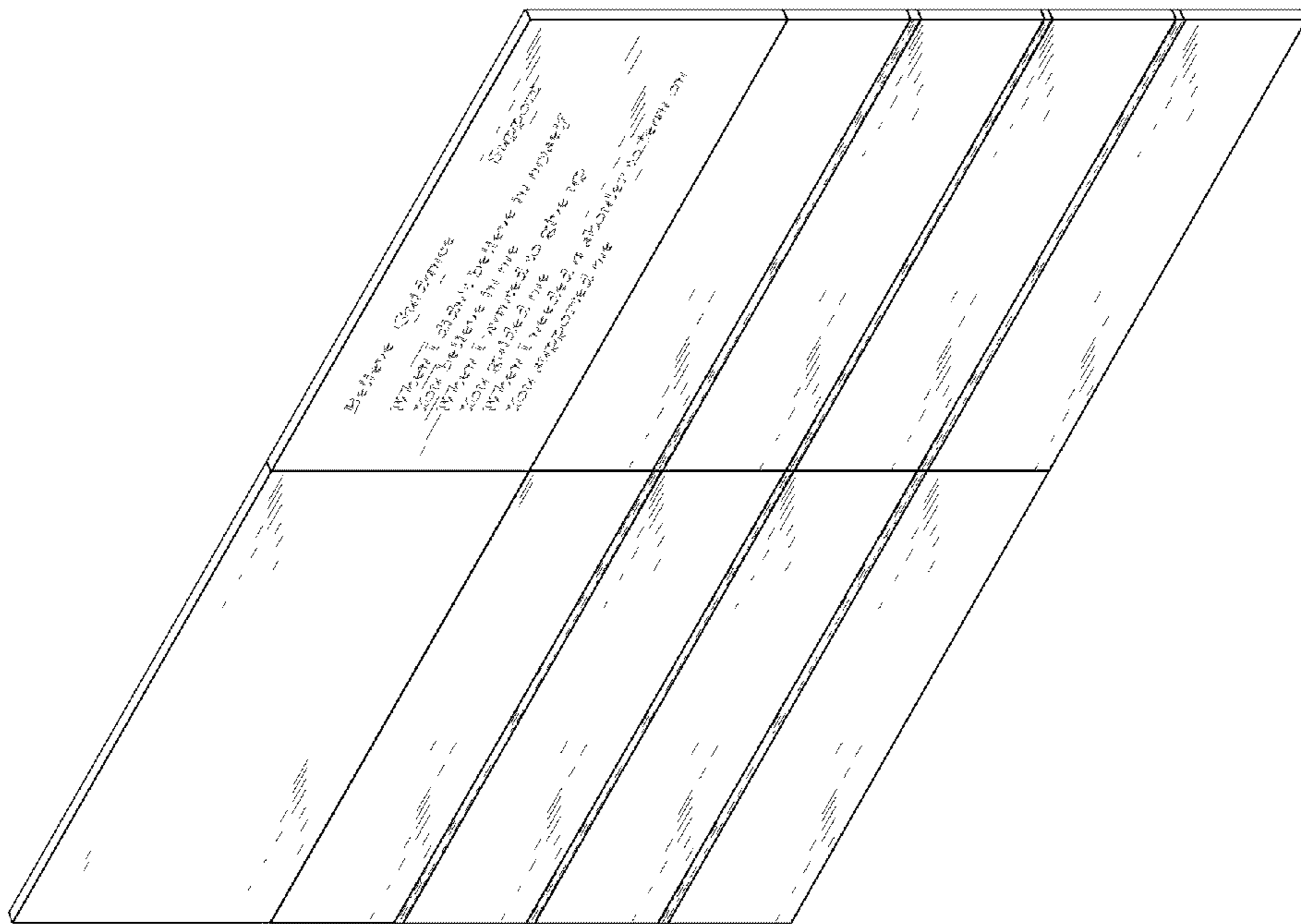

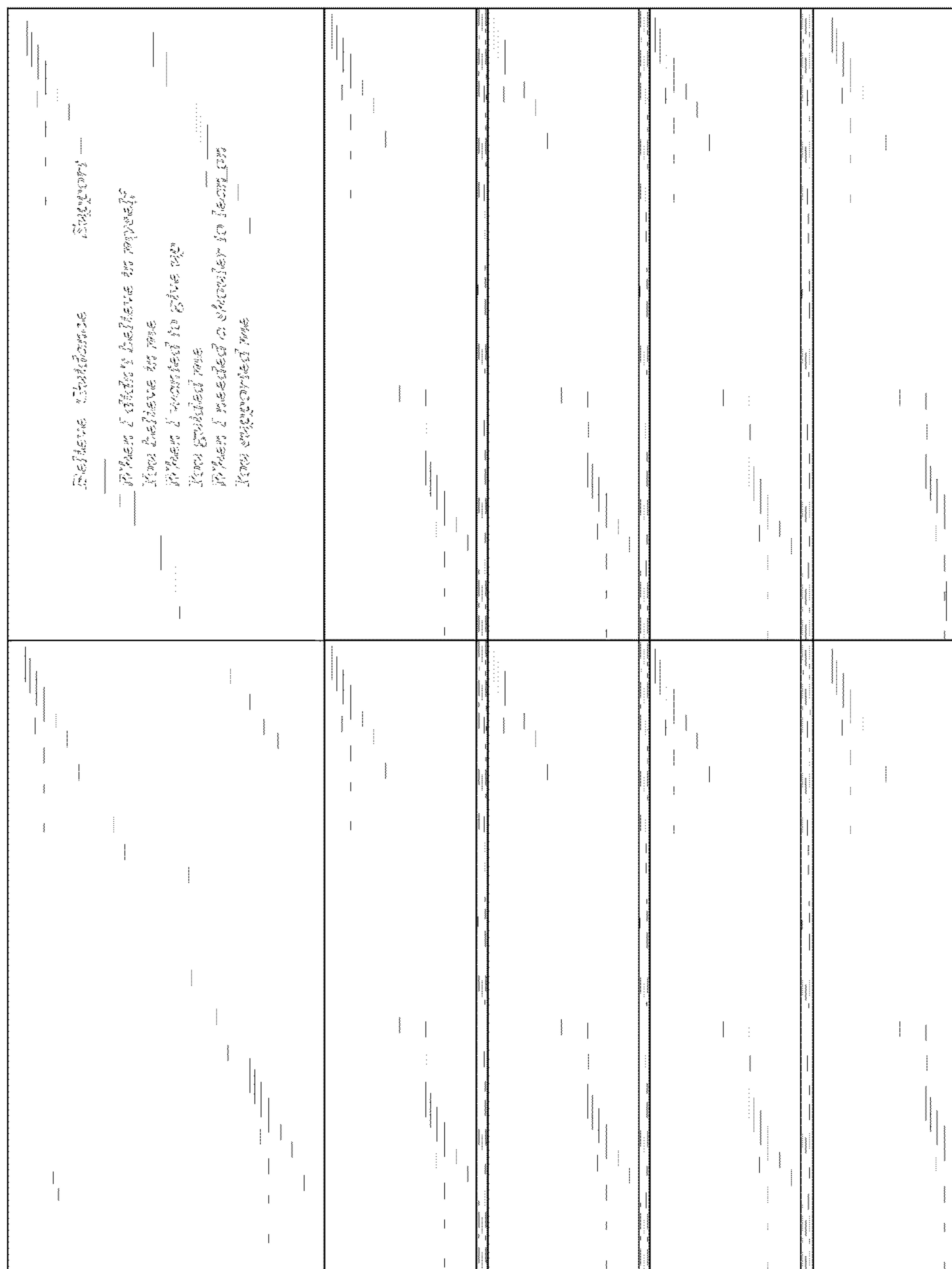
