The ornamental design for a wristband, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of a wristband showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a top plan view; the opposite side not shown is a substantial mirror image thereof;
FIG. 4 is a right side elevation view; the opposite side not shown is a substantial mirror image thereof; and,
FIG. 5 is a top, back perspective view thereof.
The broken line shown on the inner surface of the wristband in FIG. 5 represent holes and is included for the purpose of illustrating environmental structure and form no part of the claimed design.

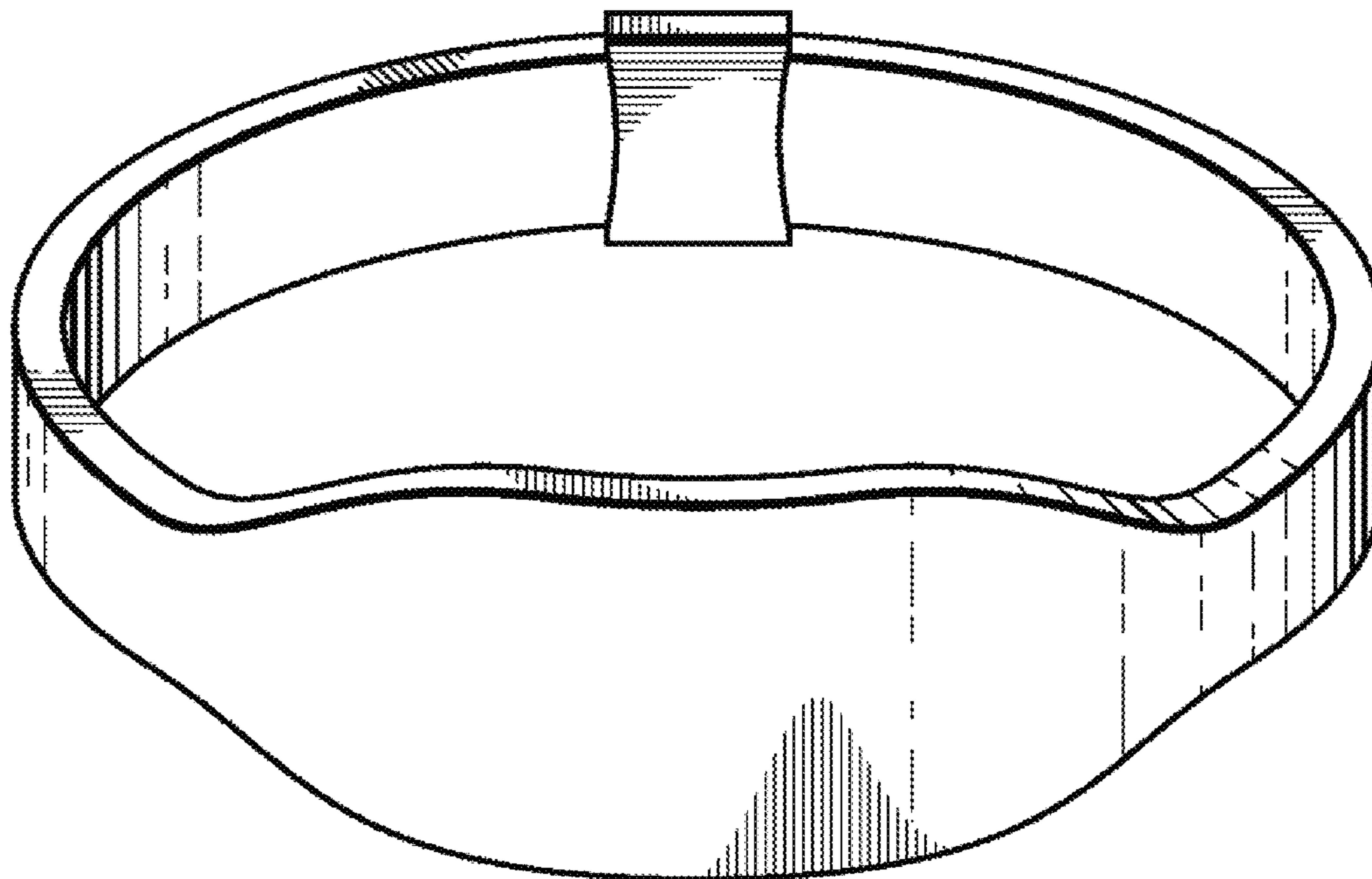

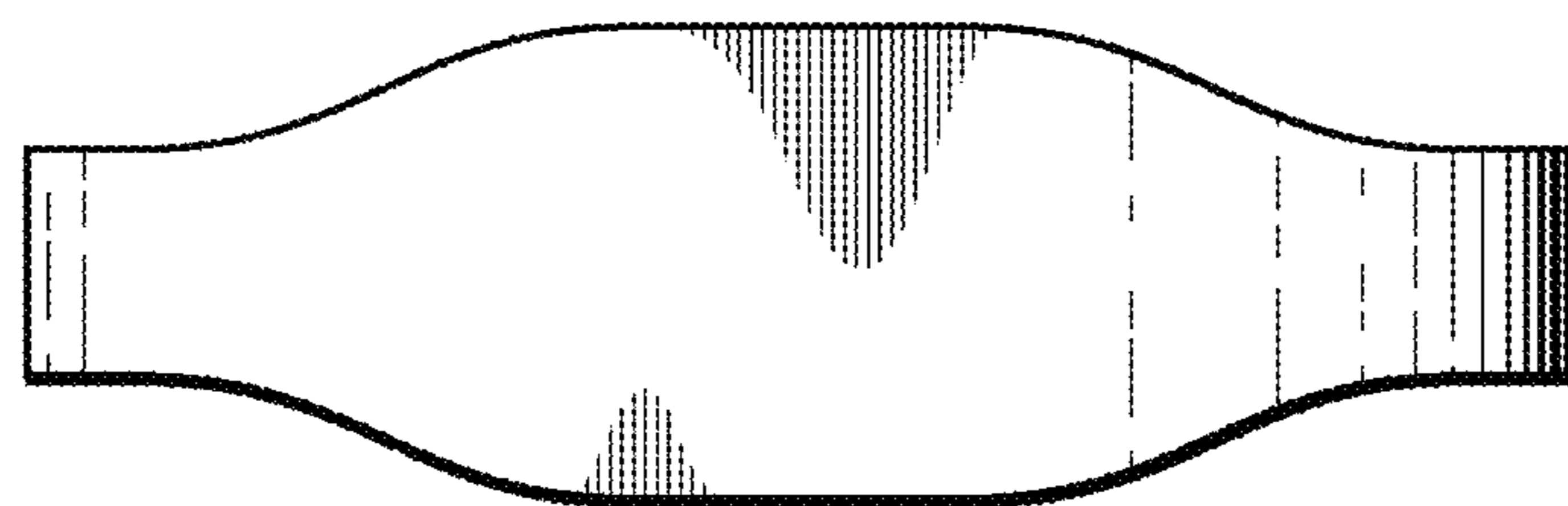
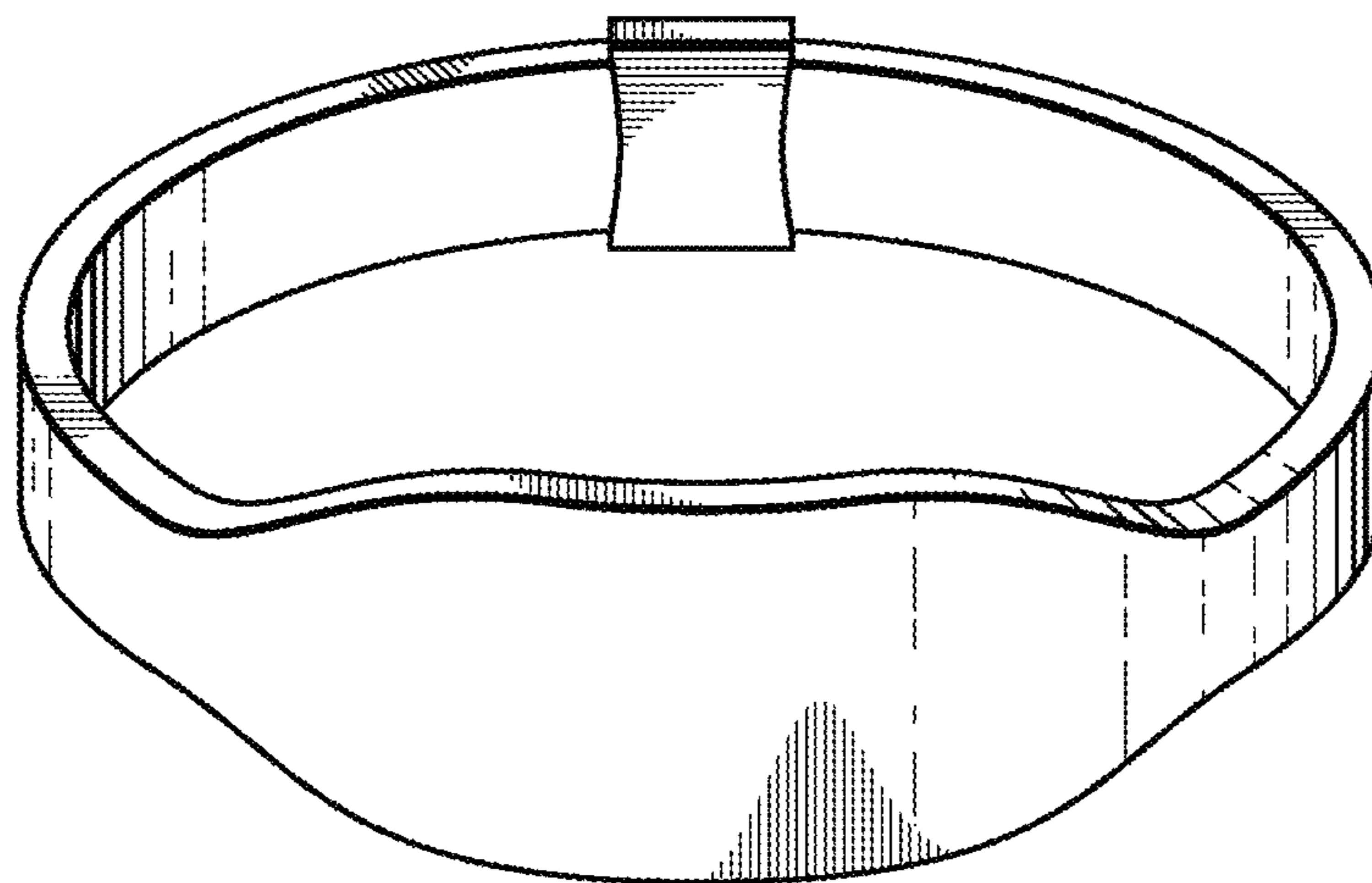

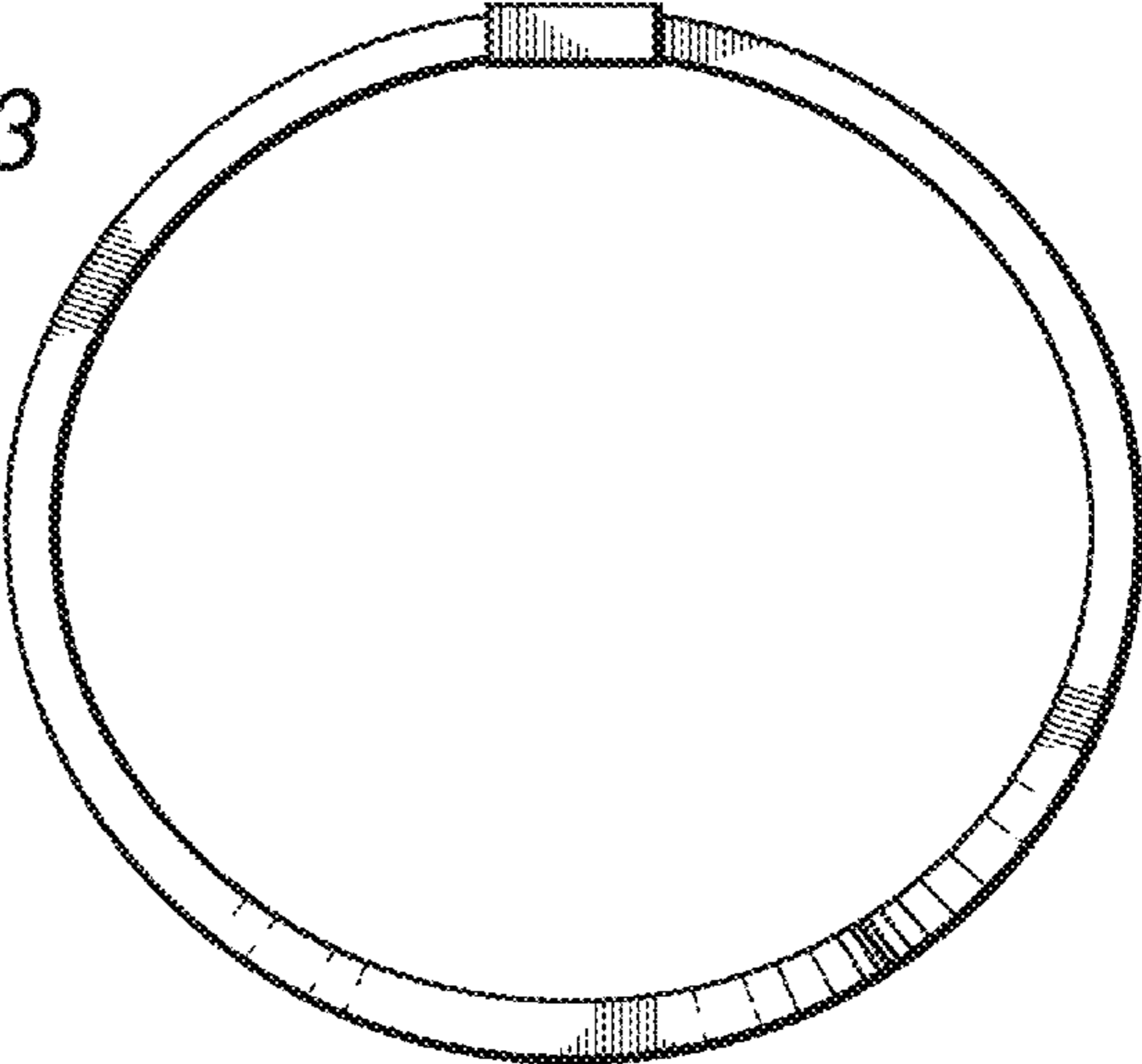
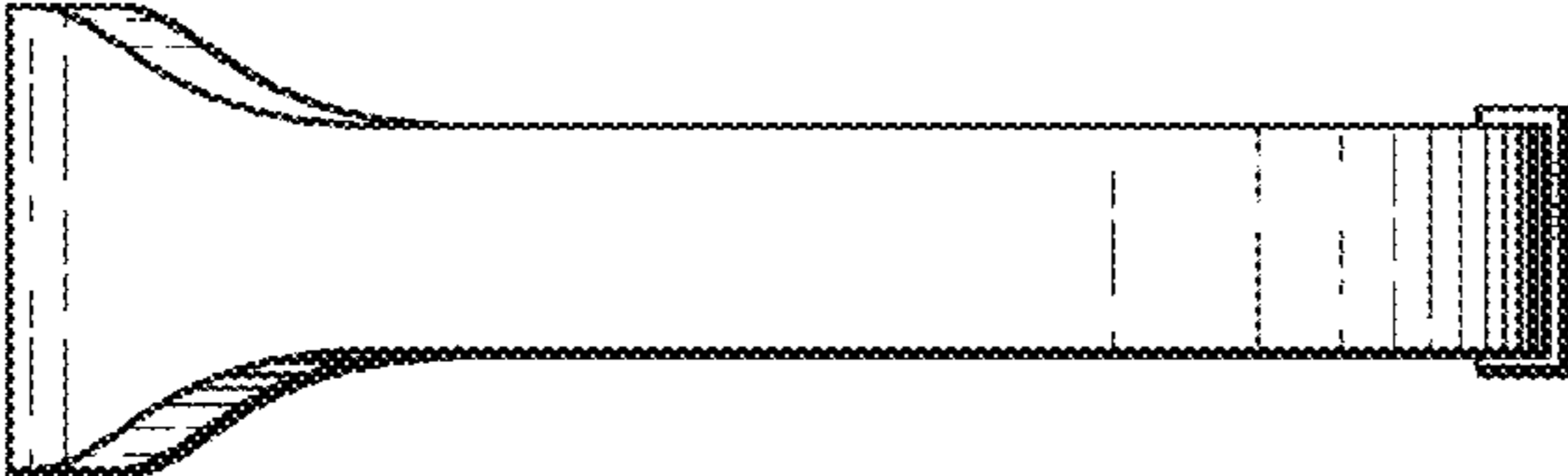

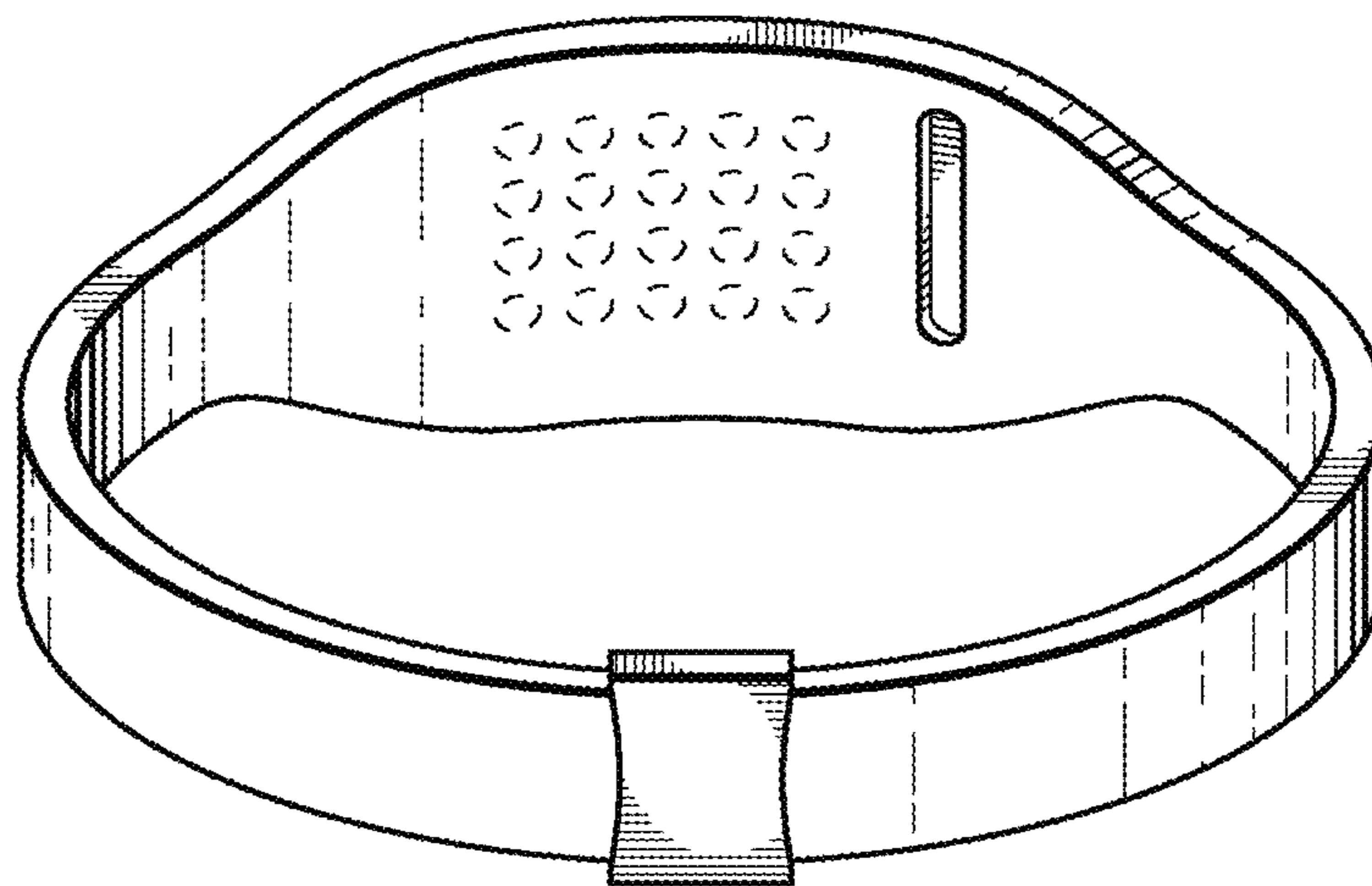
