FIG. 11 is right side view thereof;

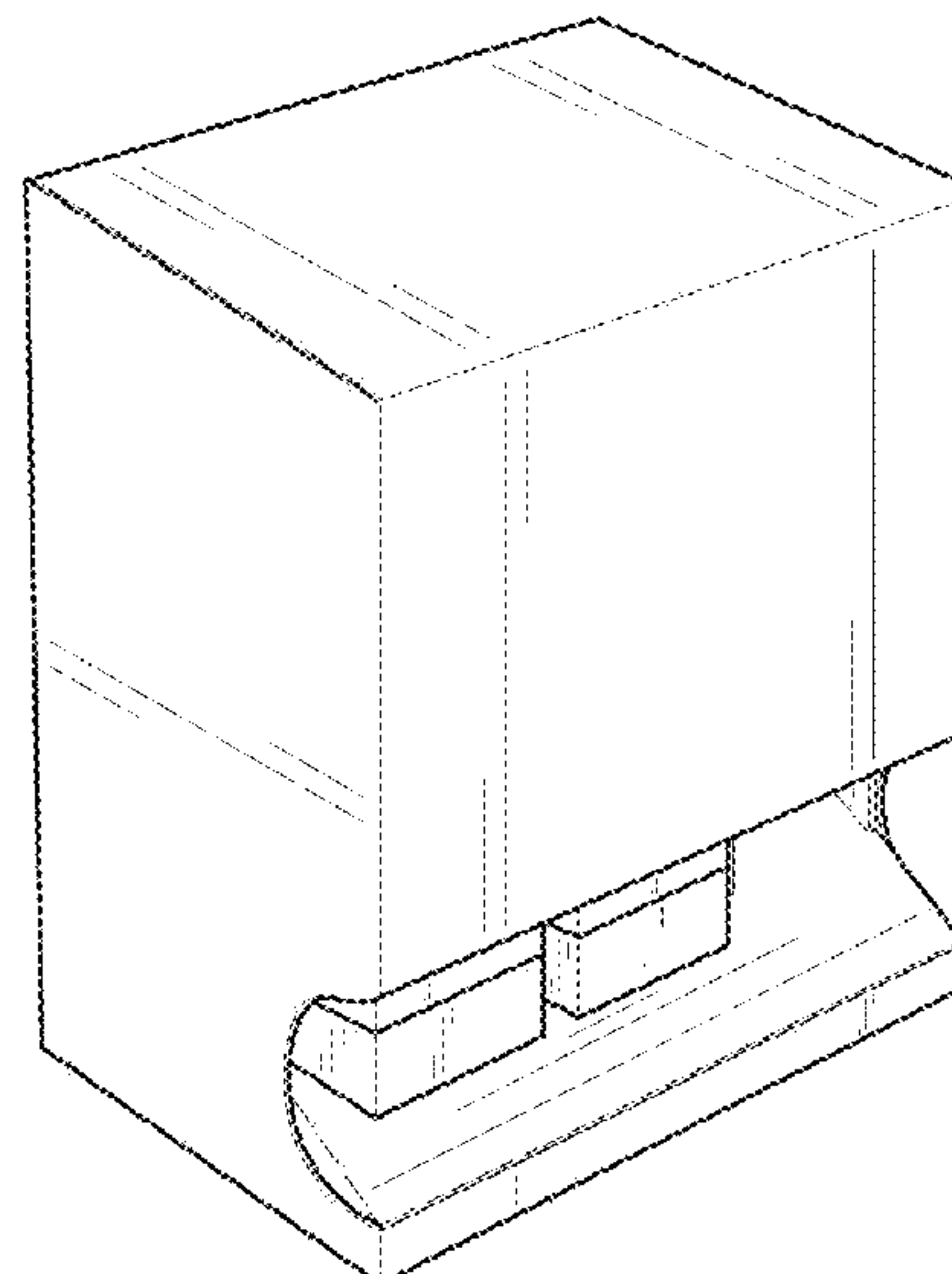
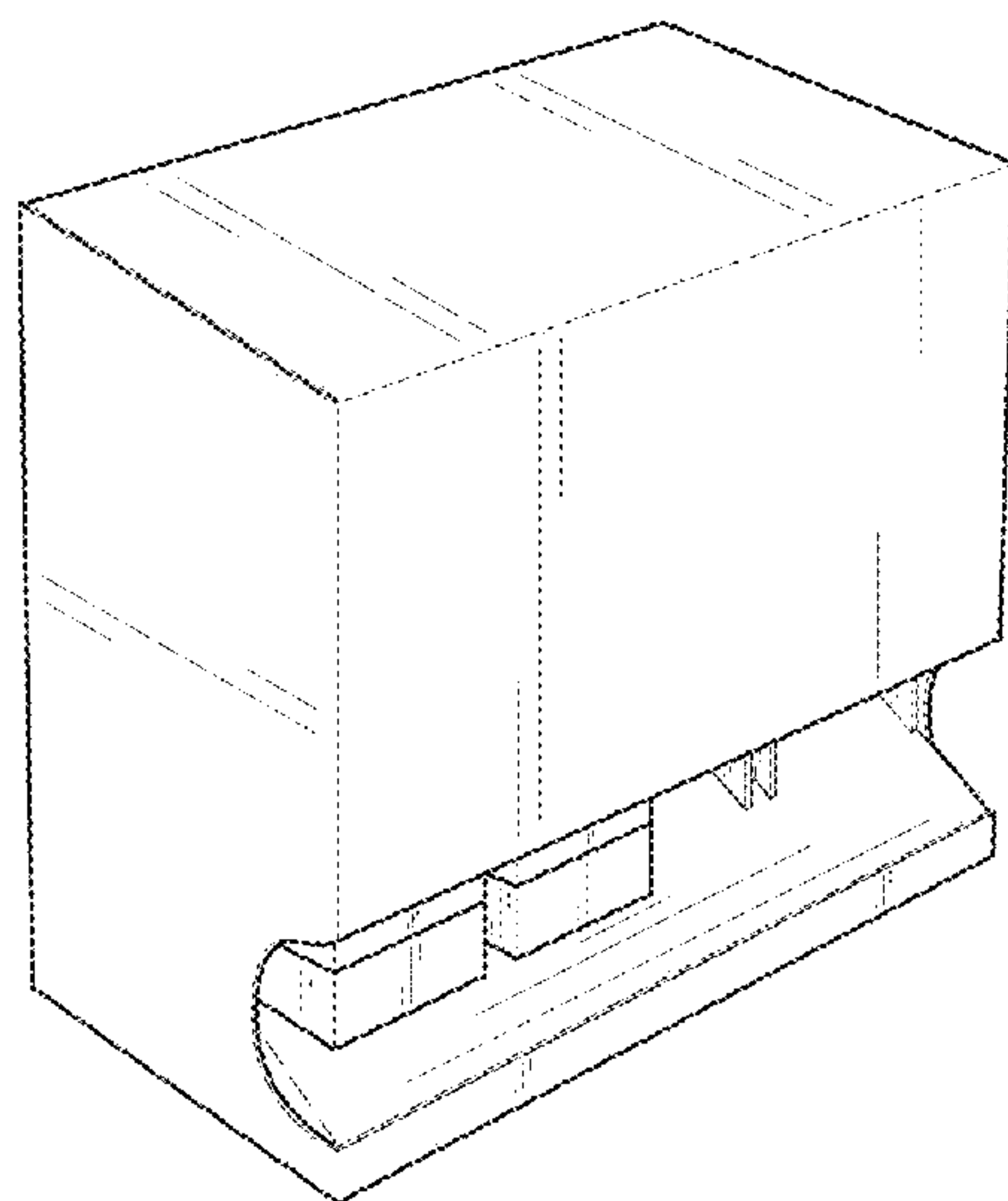
FIG. 12 is left side view thereof;

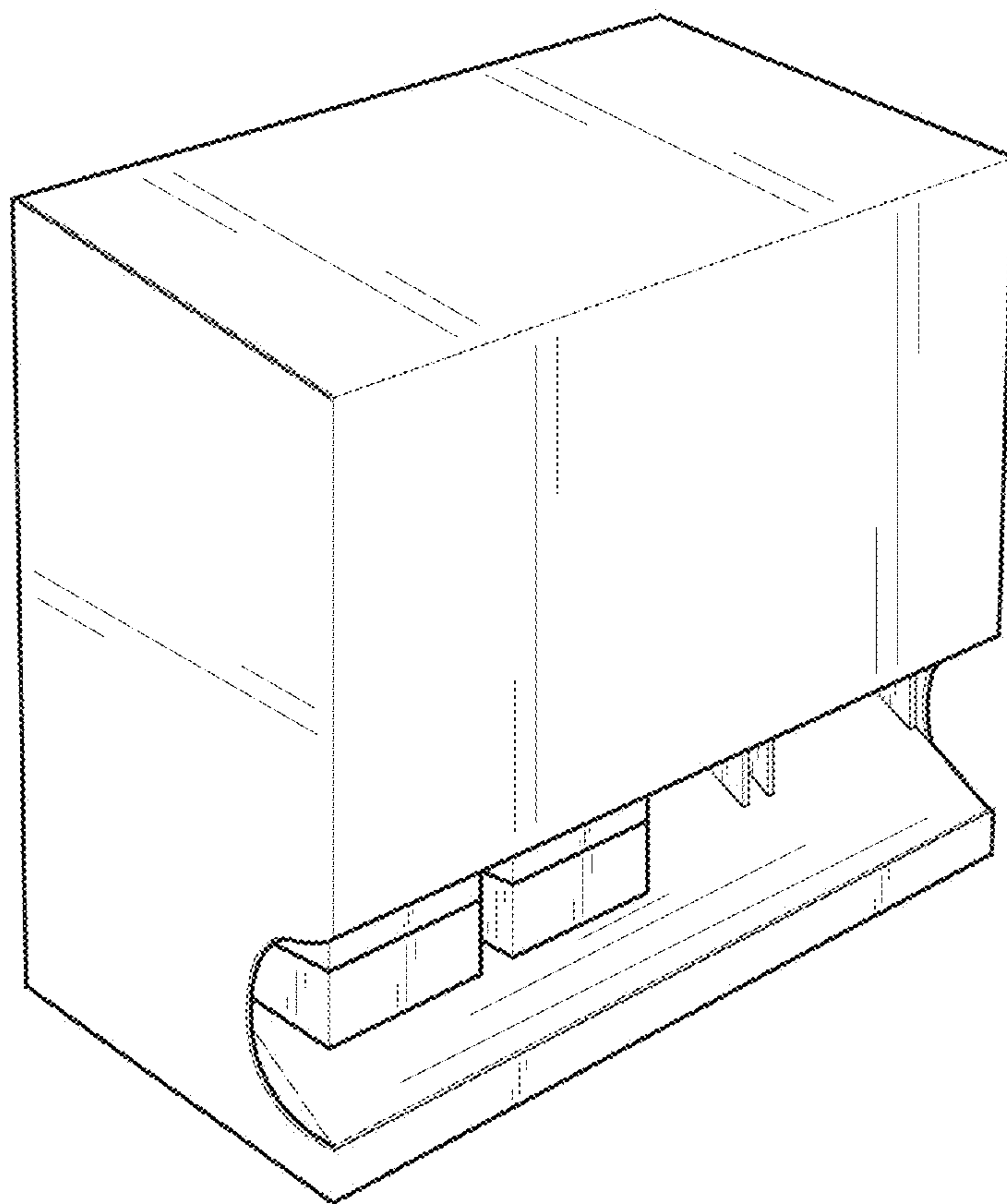

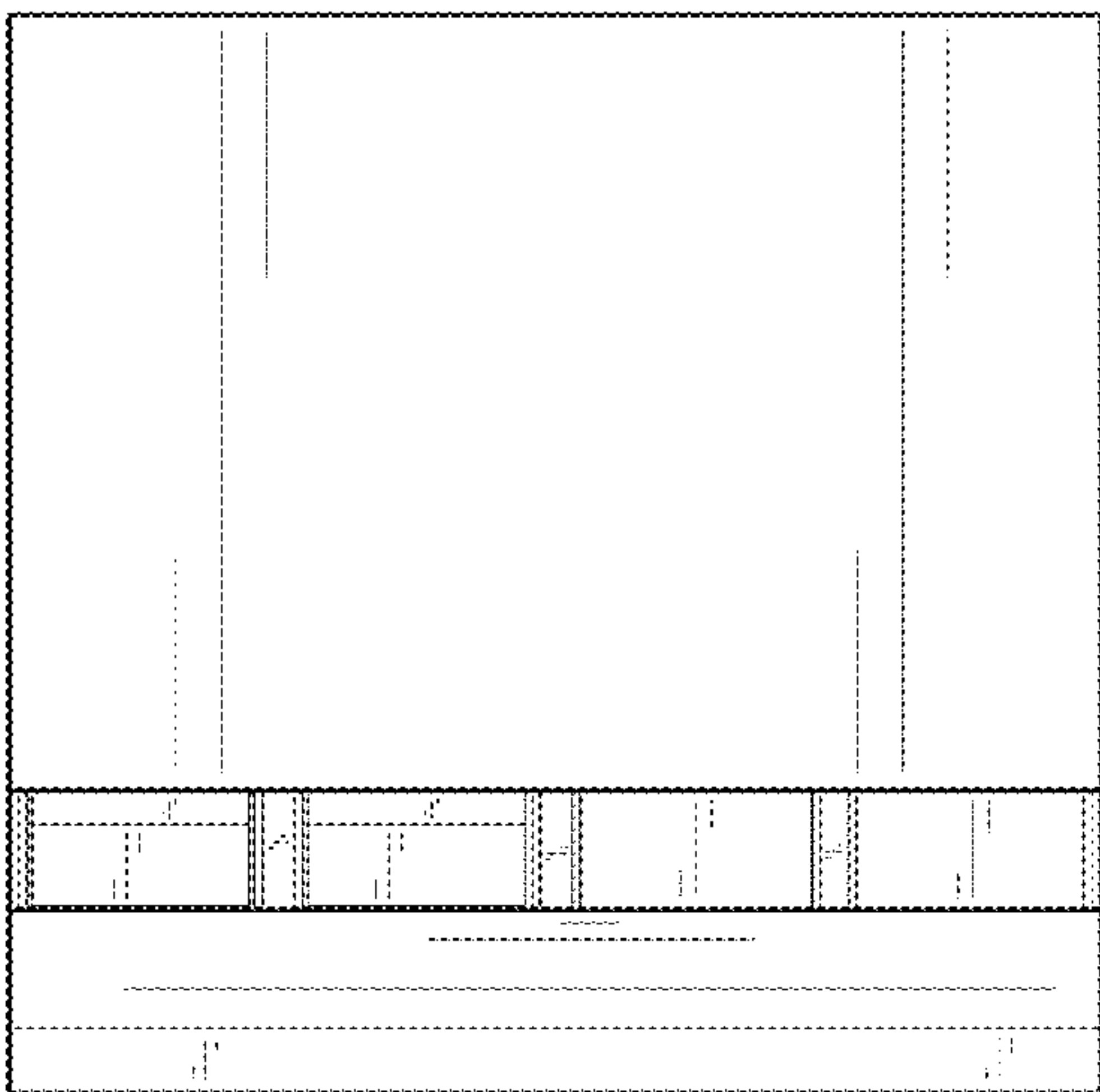

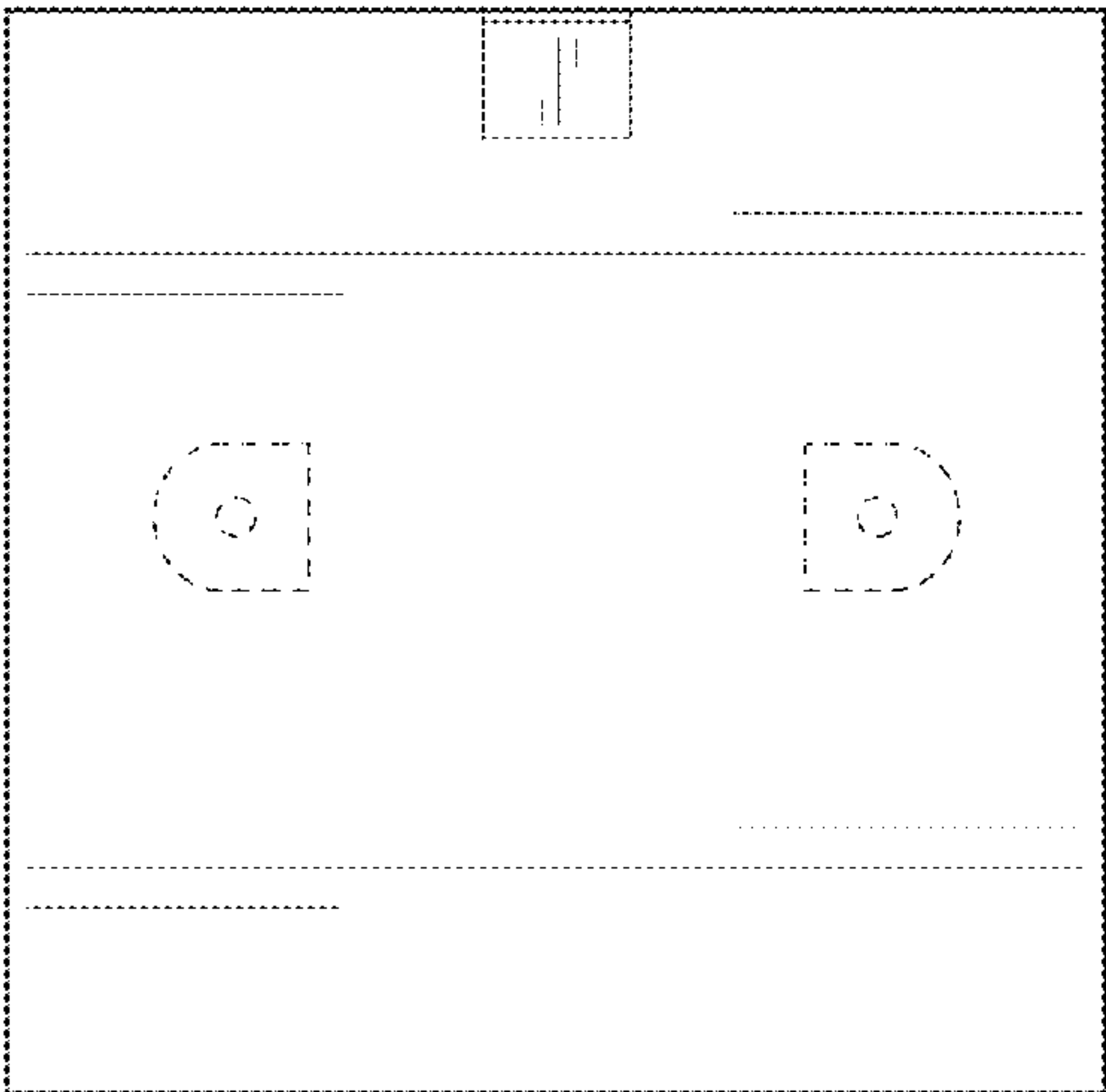

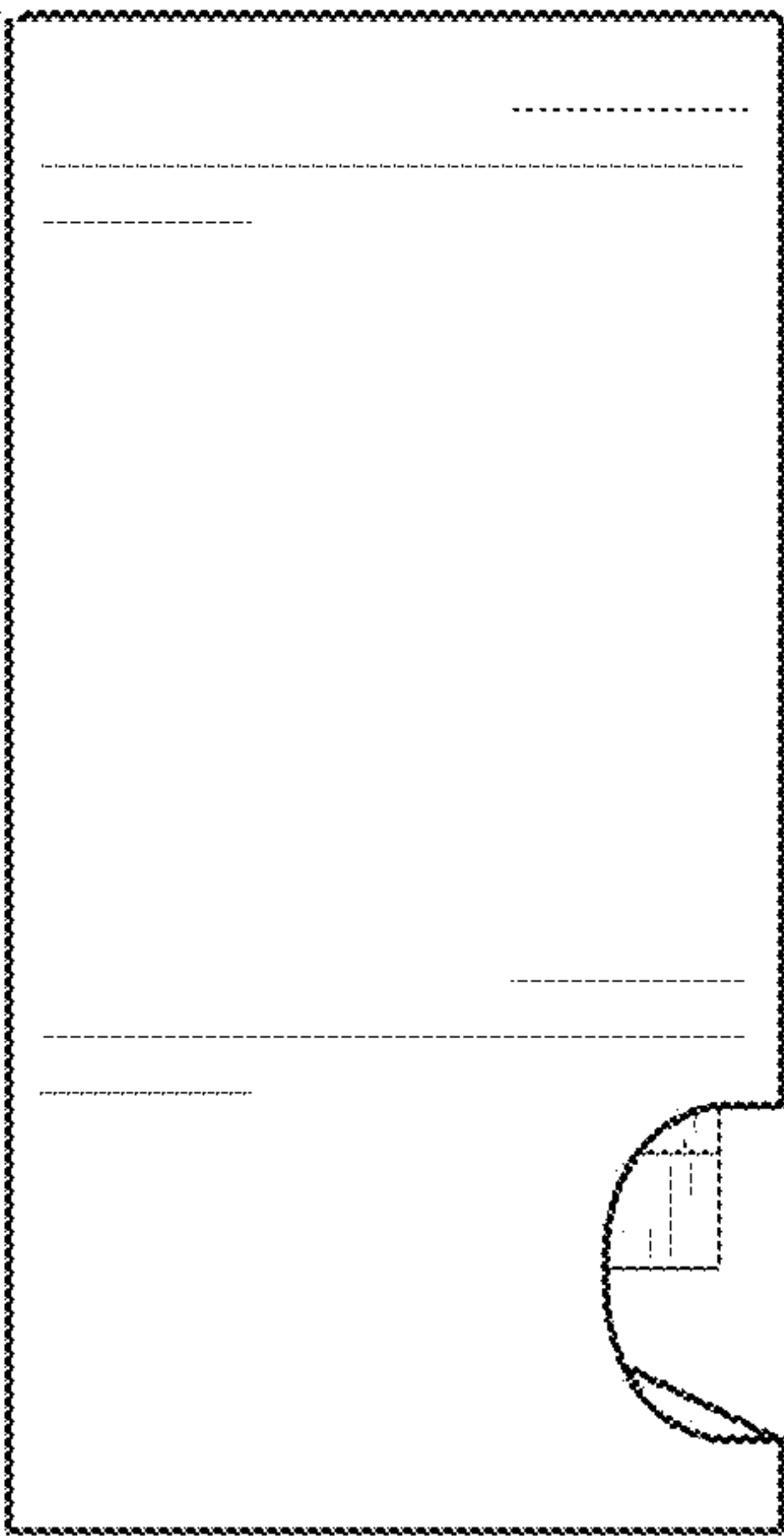

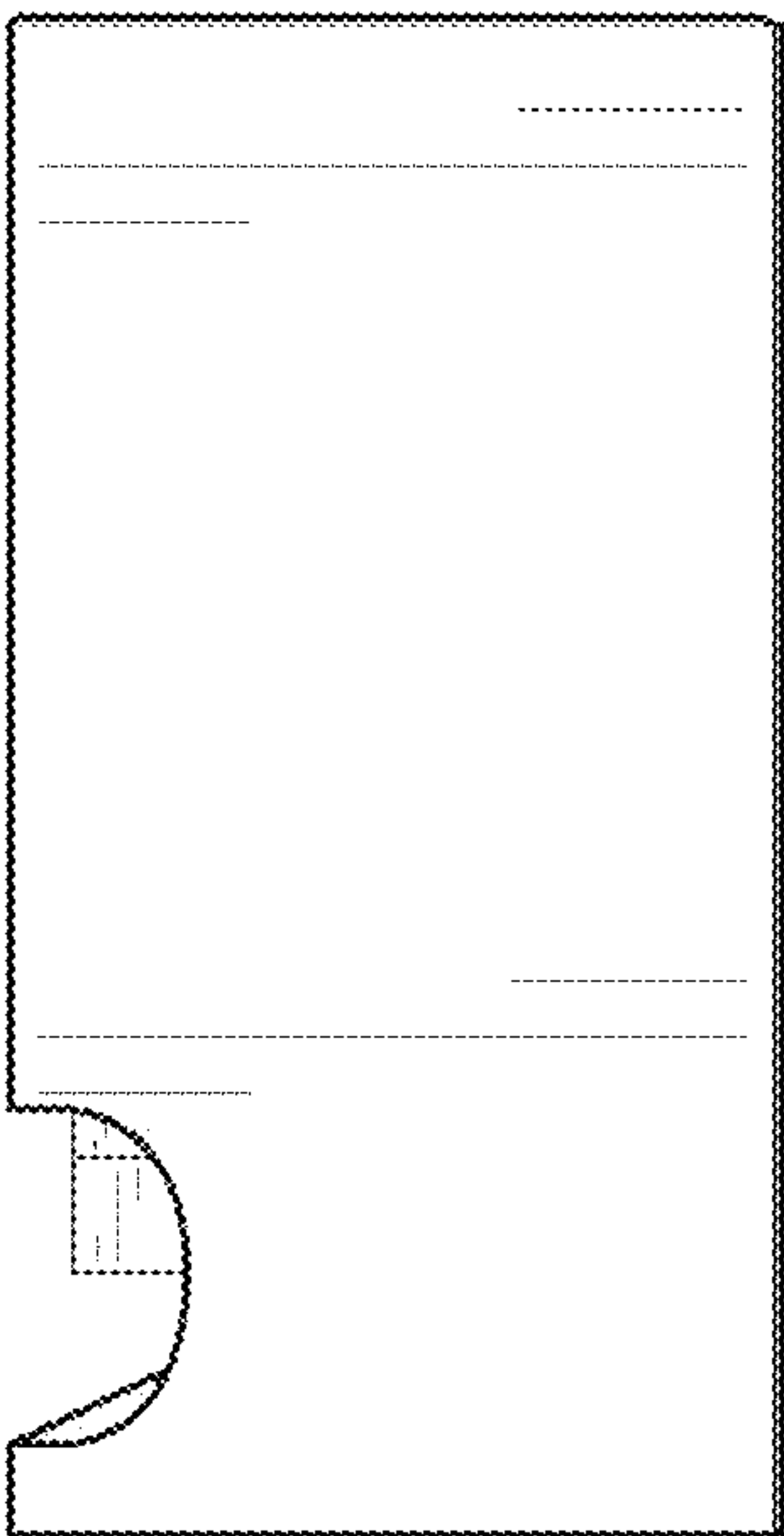

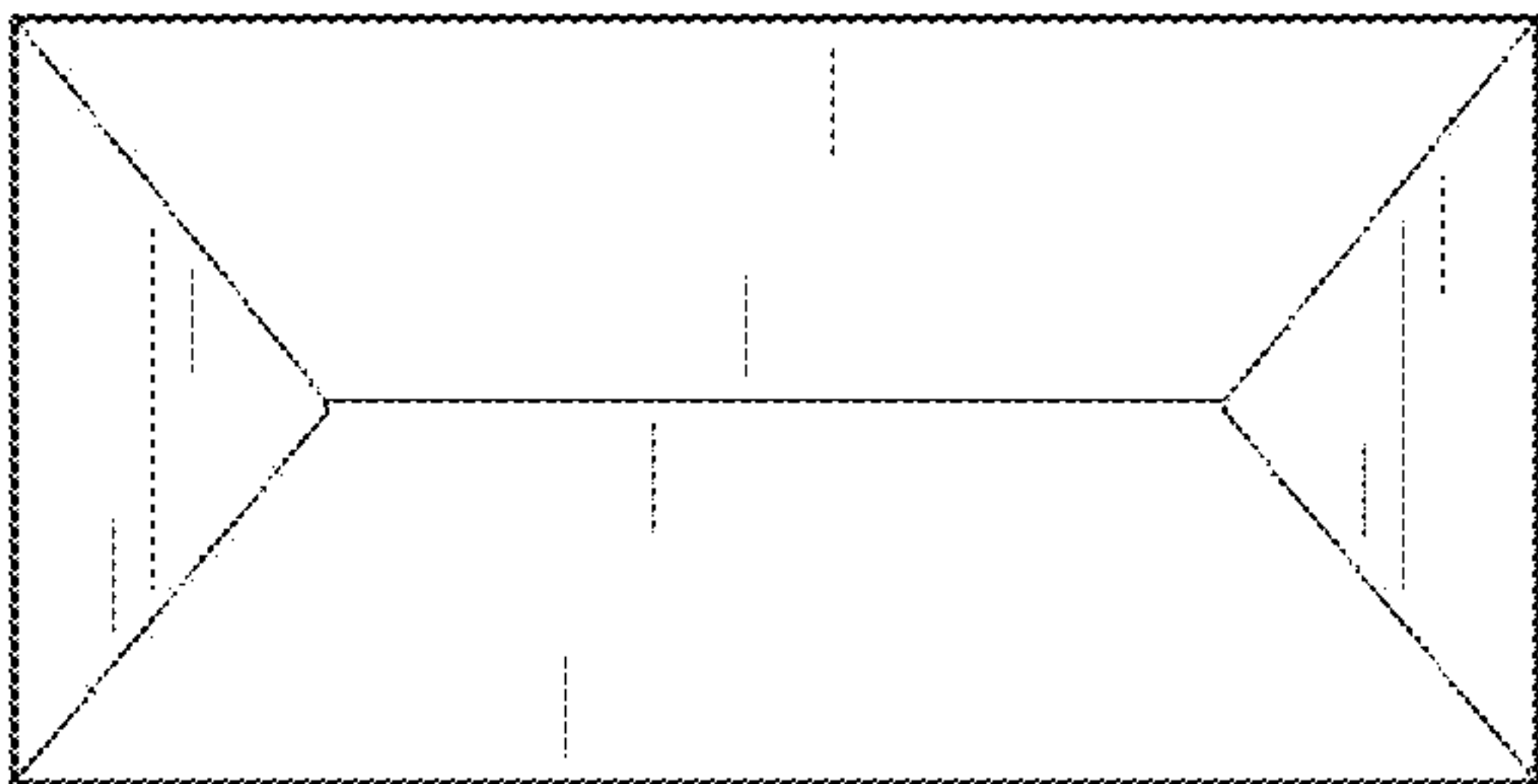

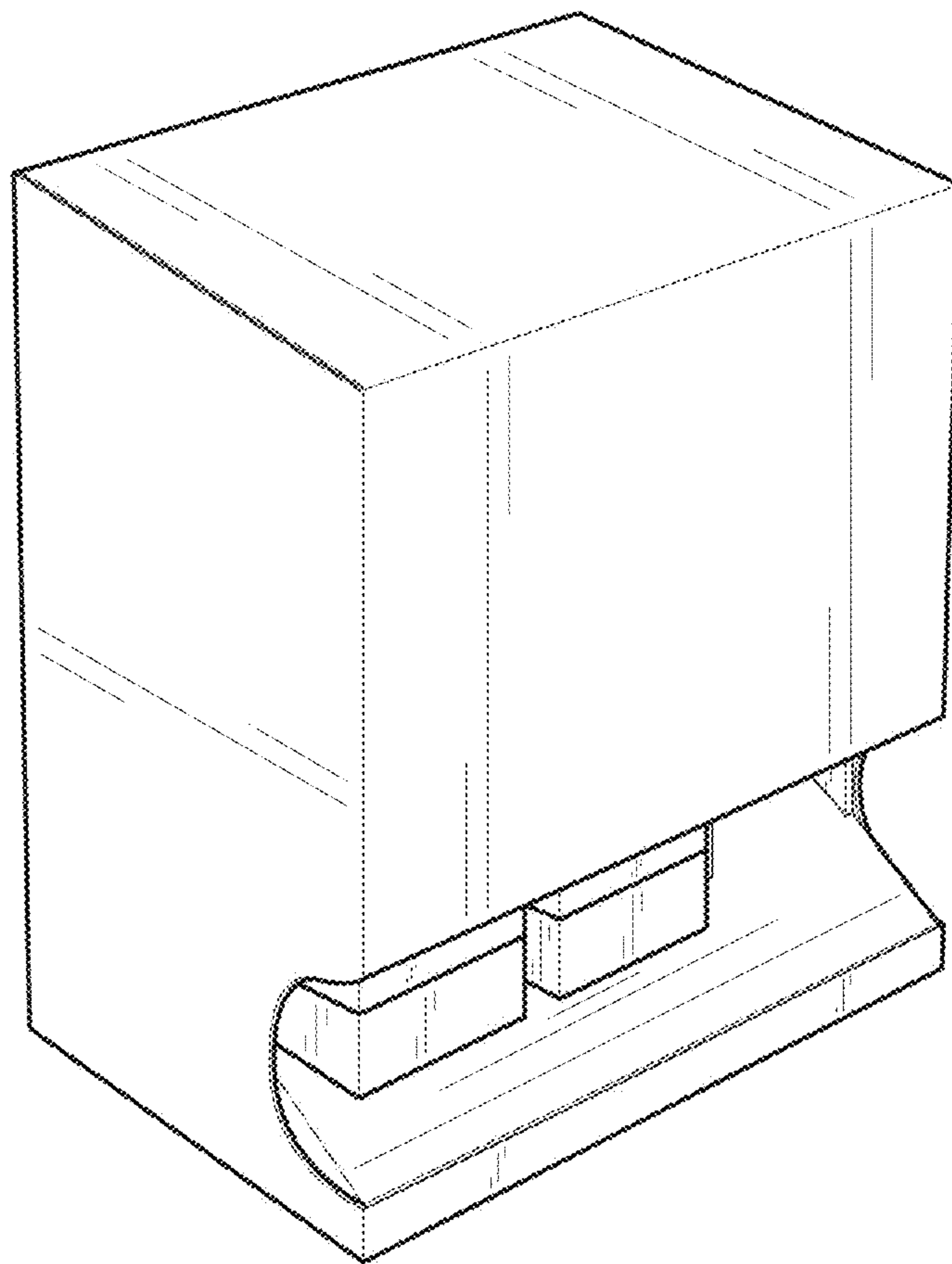

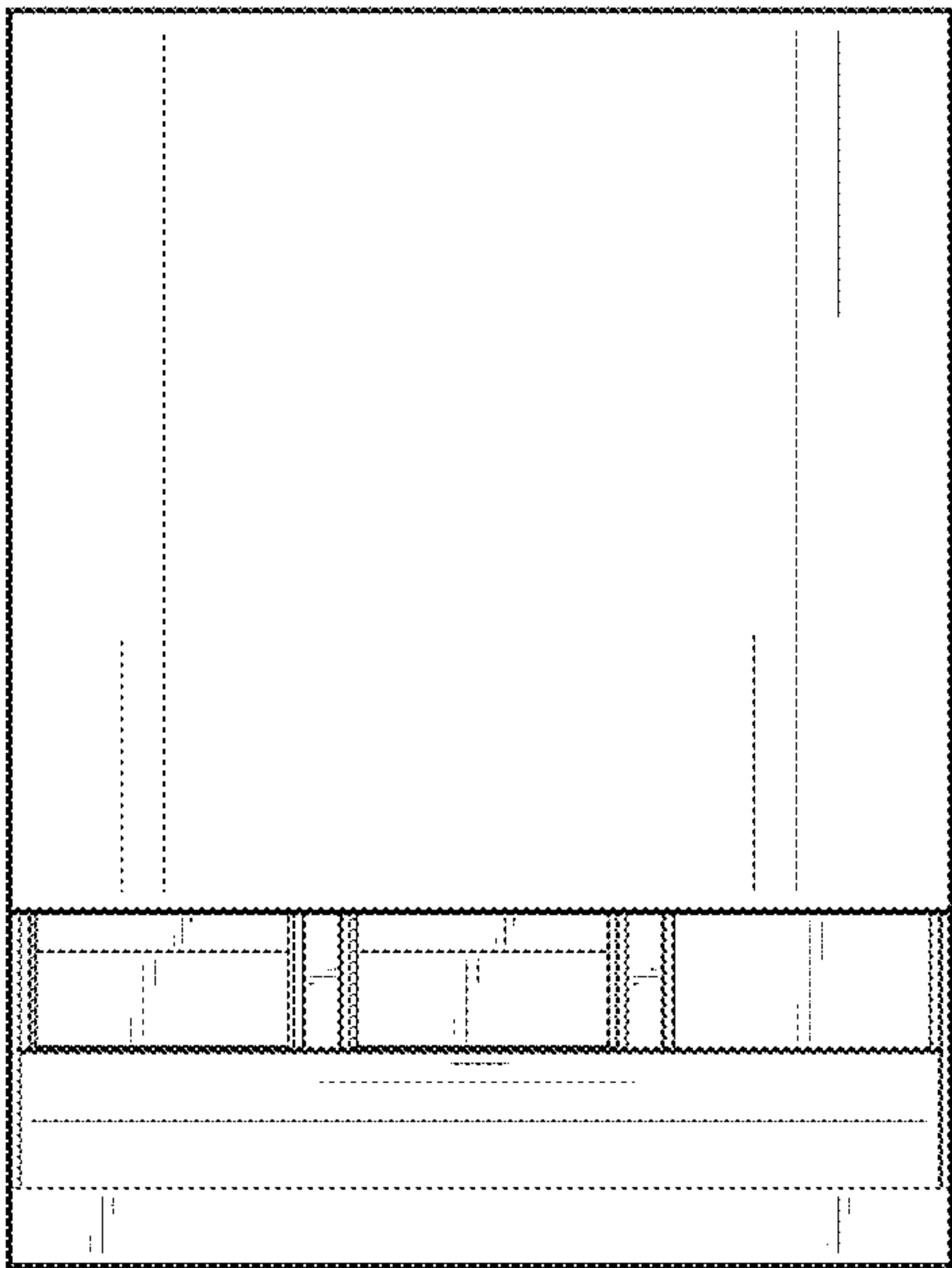

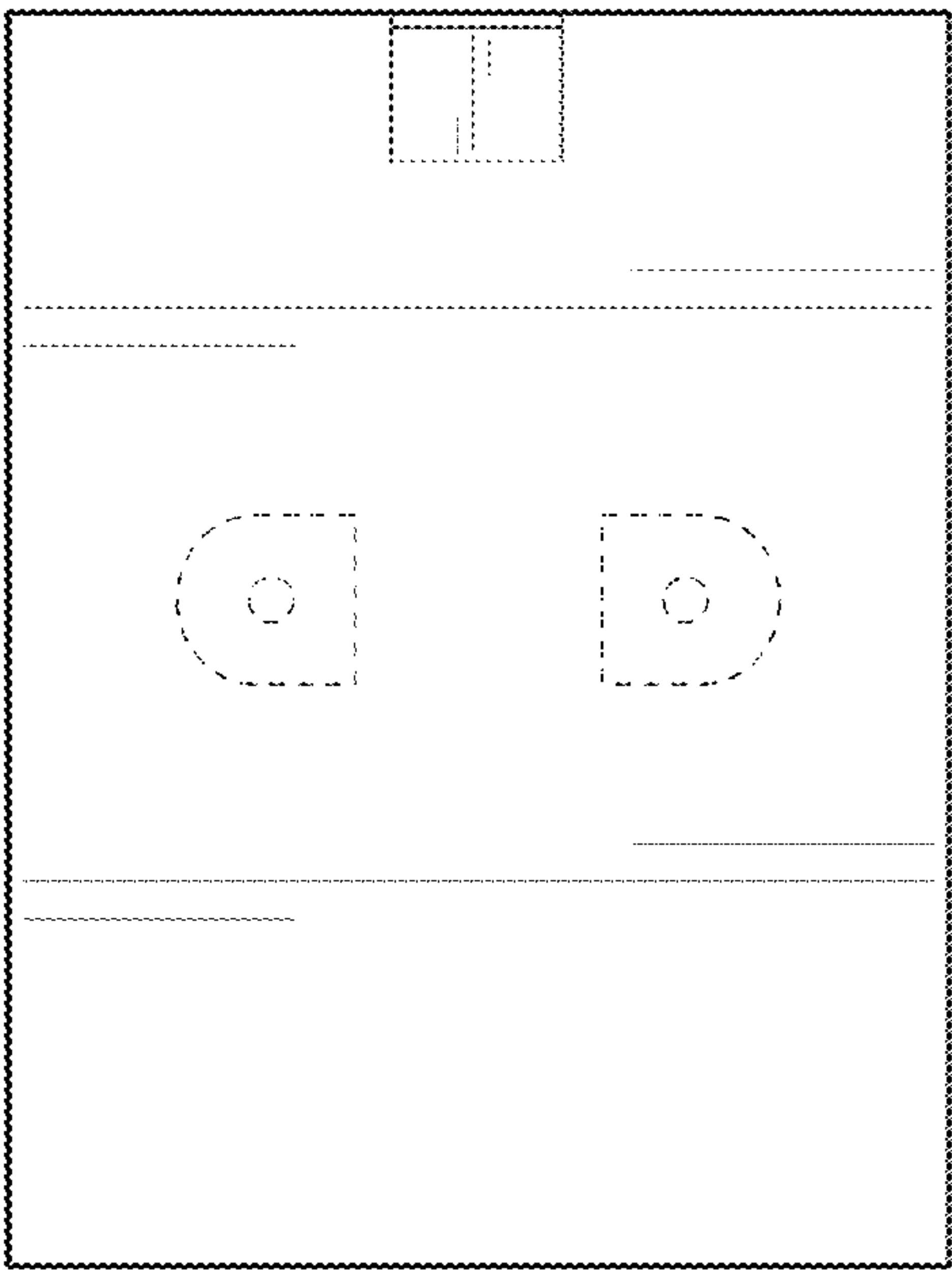

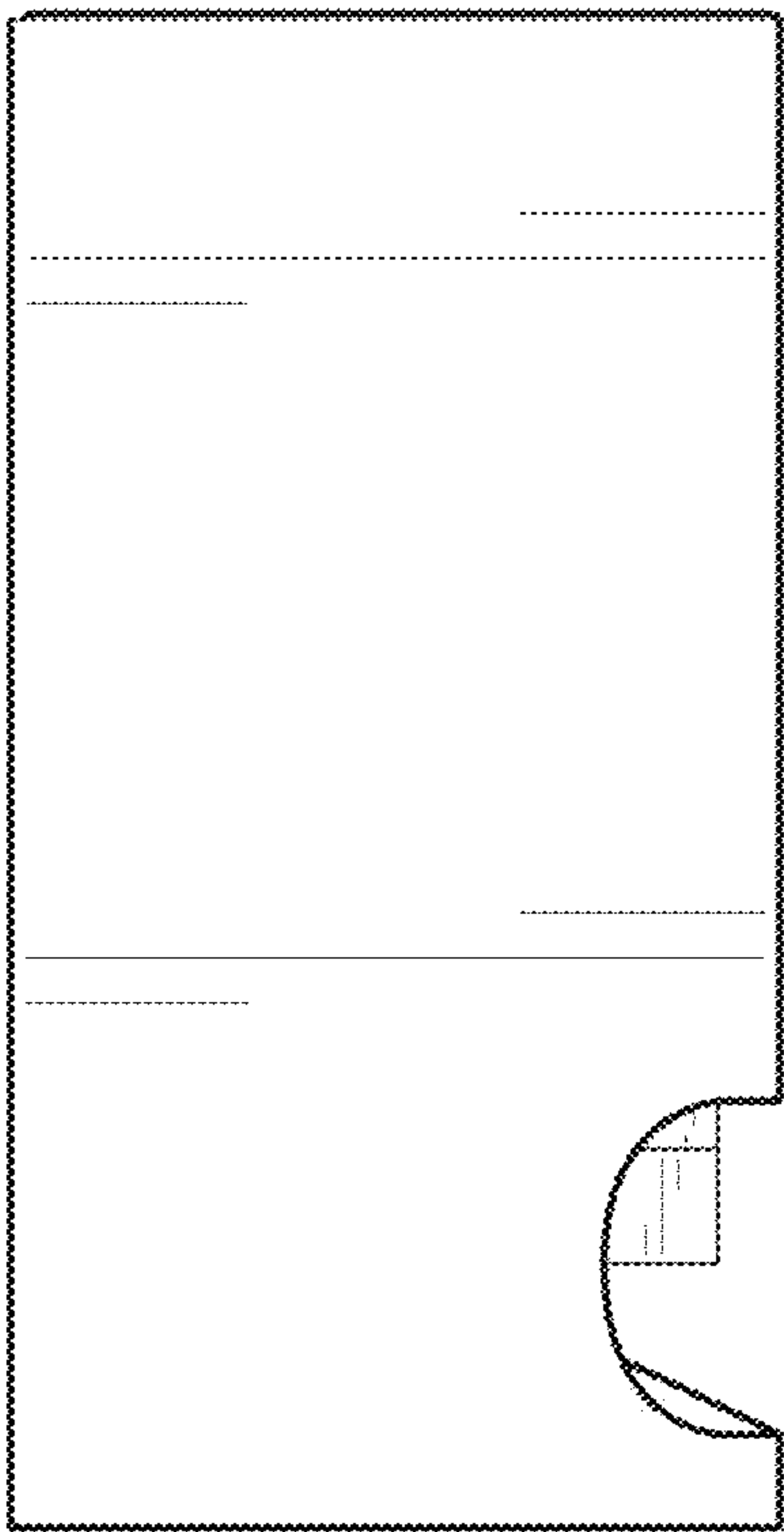

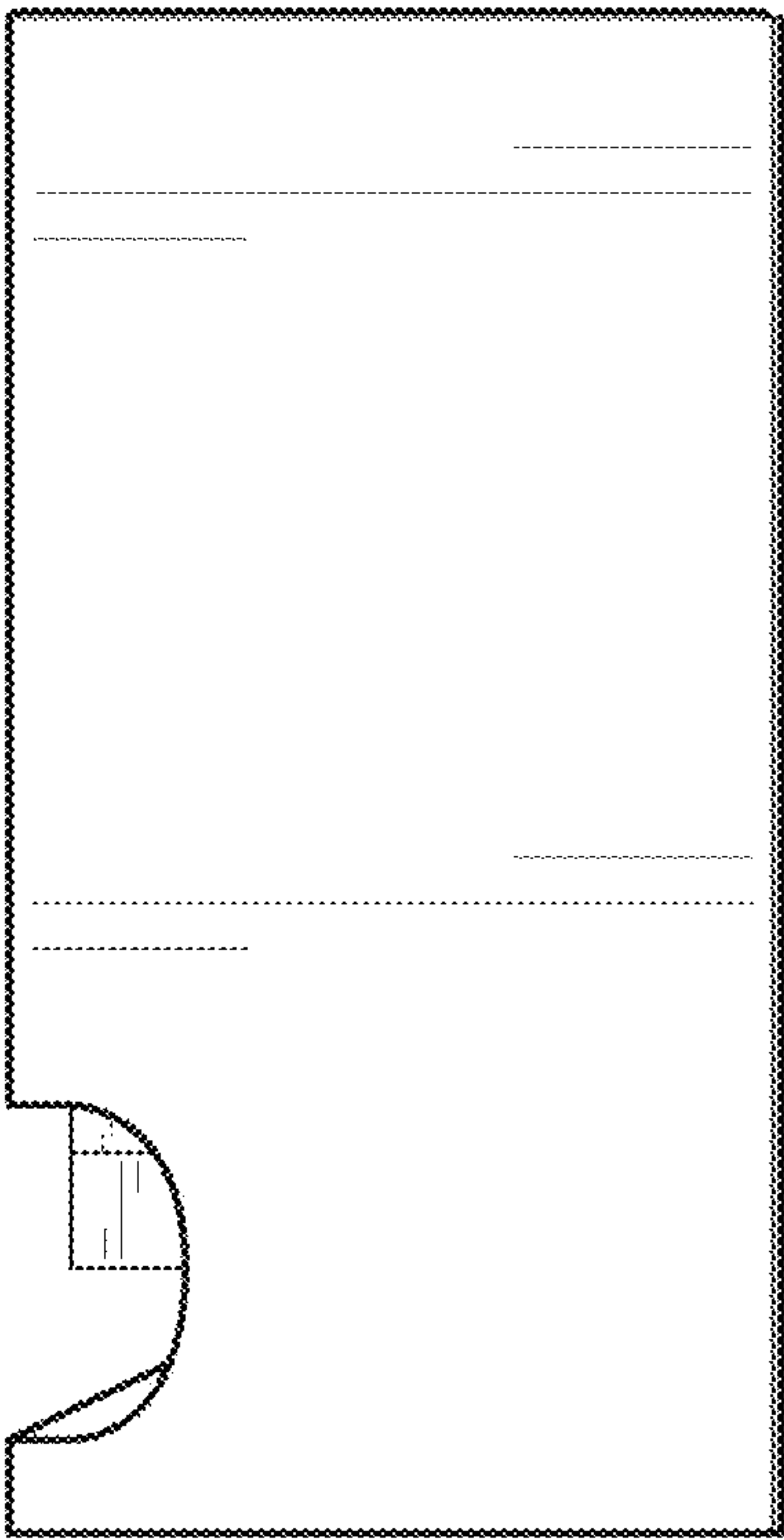

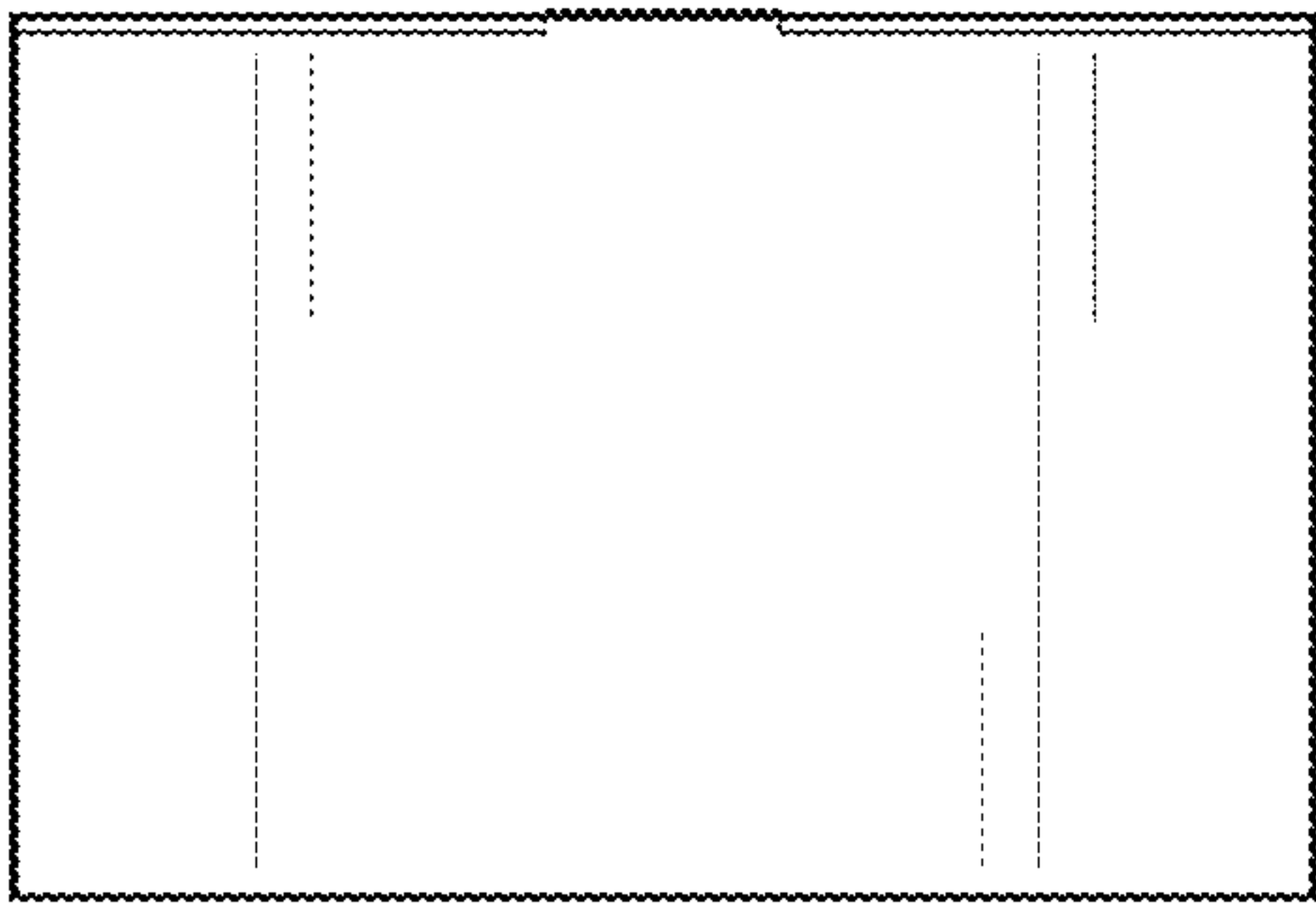

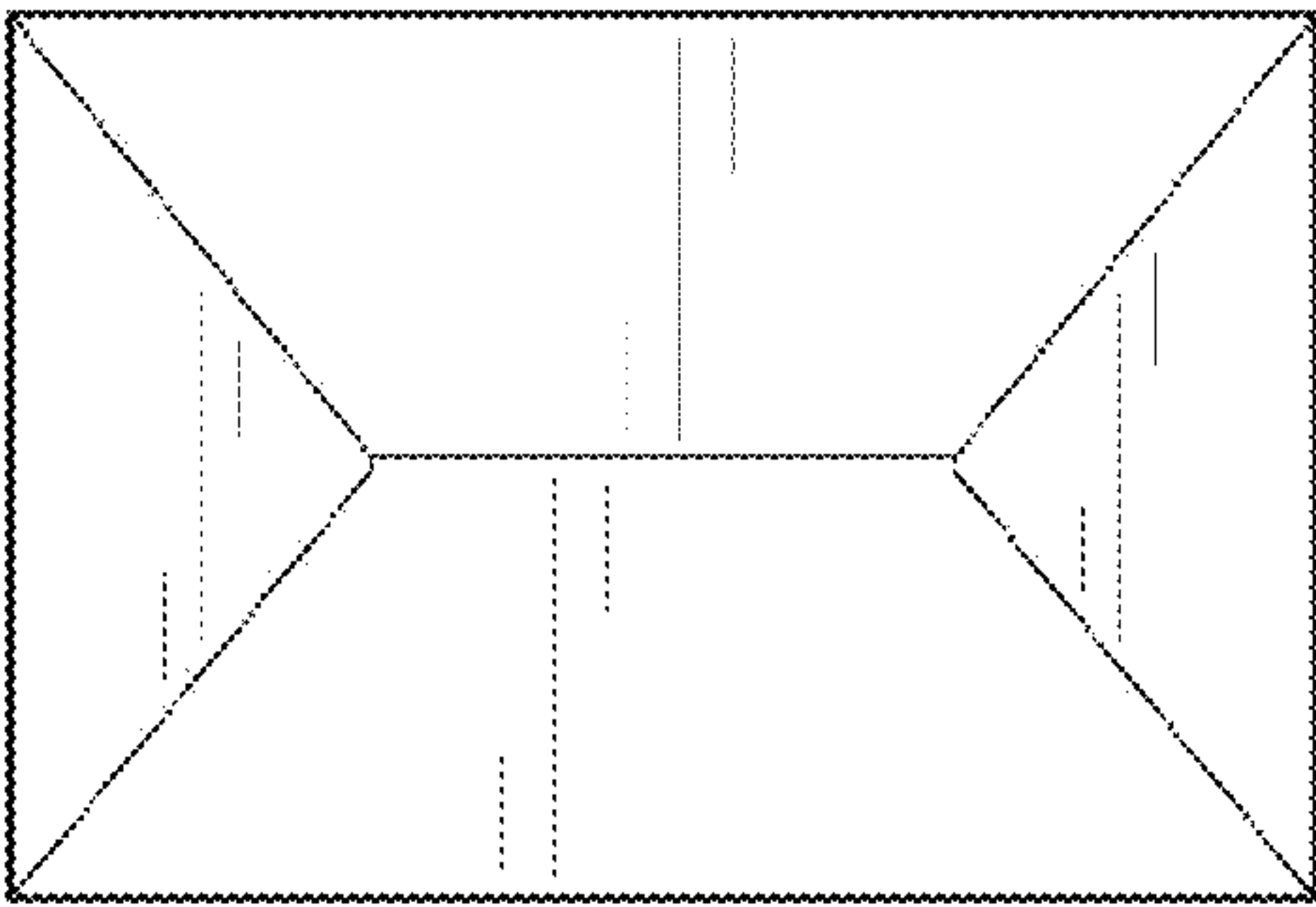
