(57) **CLAIM**

The ornamental design for an identification wristband, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an identification wristband embodying our new design, with an identification label partially removed;

FIG. 2 is a perspective view of the identification wristband of FIG. 1, illustrating the configuration of the identification wristband when worn about the wrist;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a rear elevational view thereof;

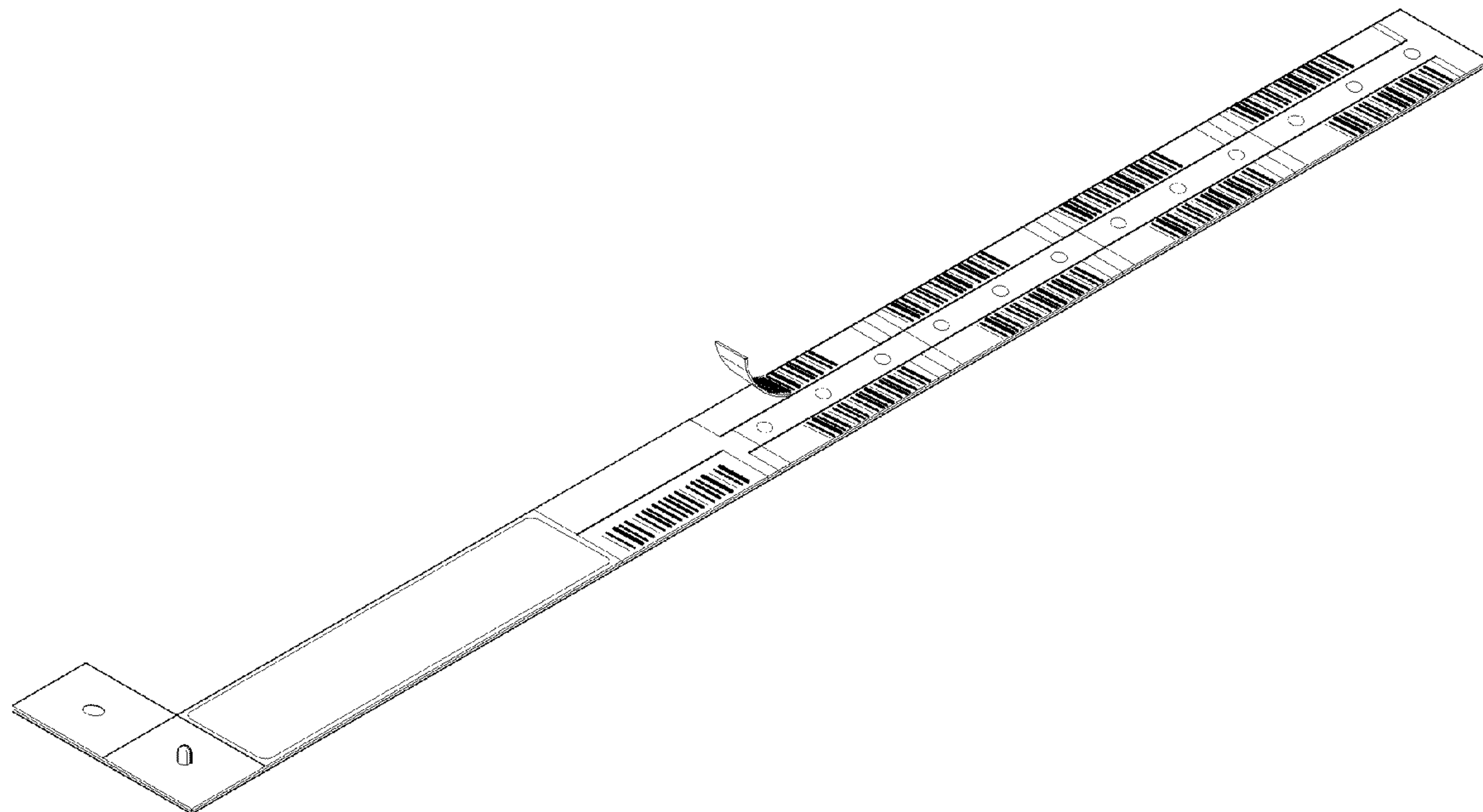
FIG. 6 is a front elevational view thereof;

FIG. 7 is a left side elevational view thereof; and,

FIG. 8 is a right side elevational view thereof.

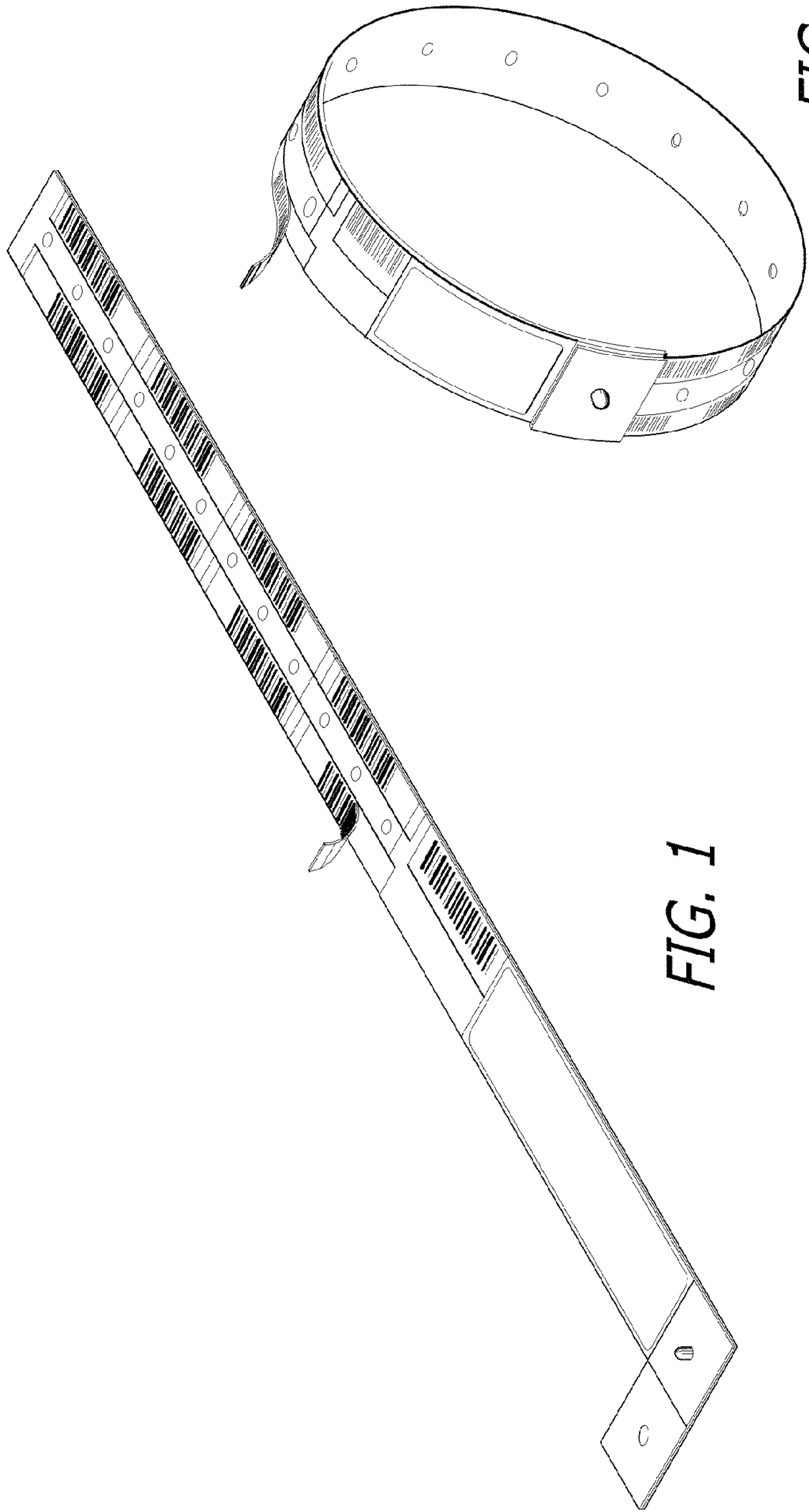

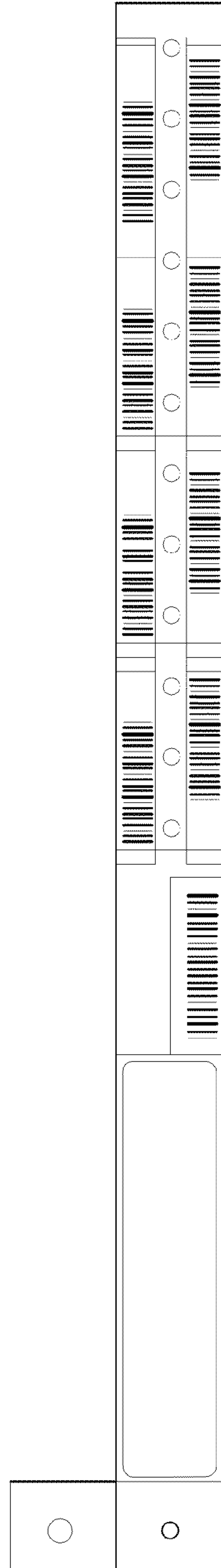

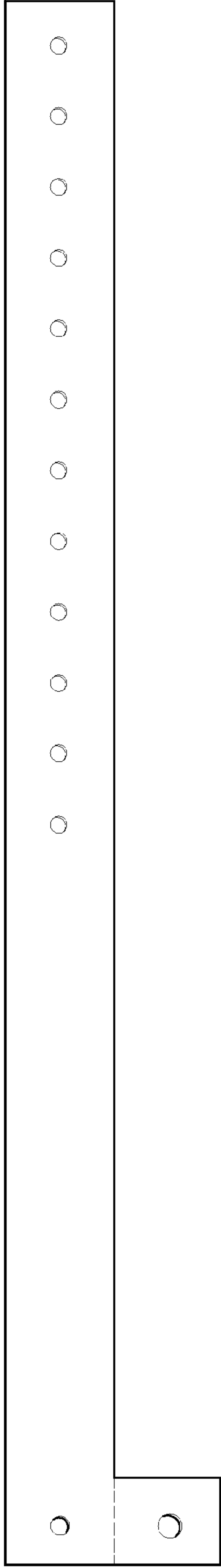

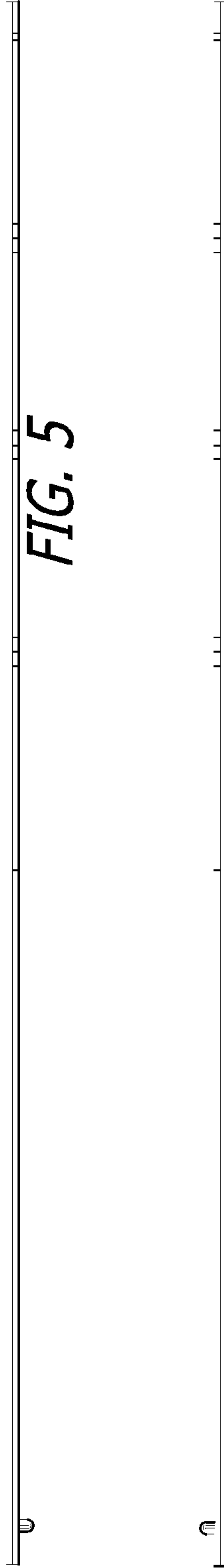

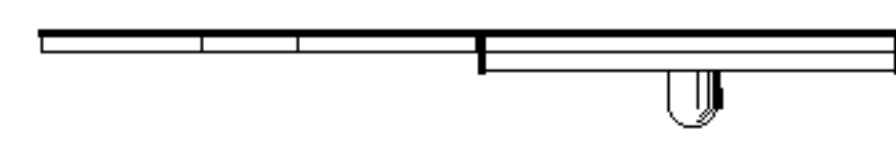
