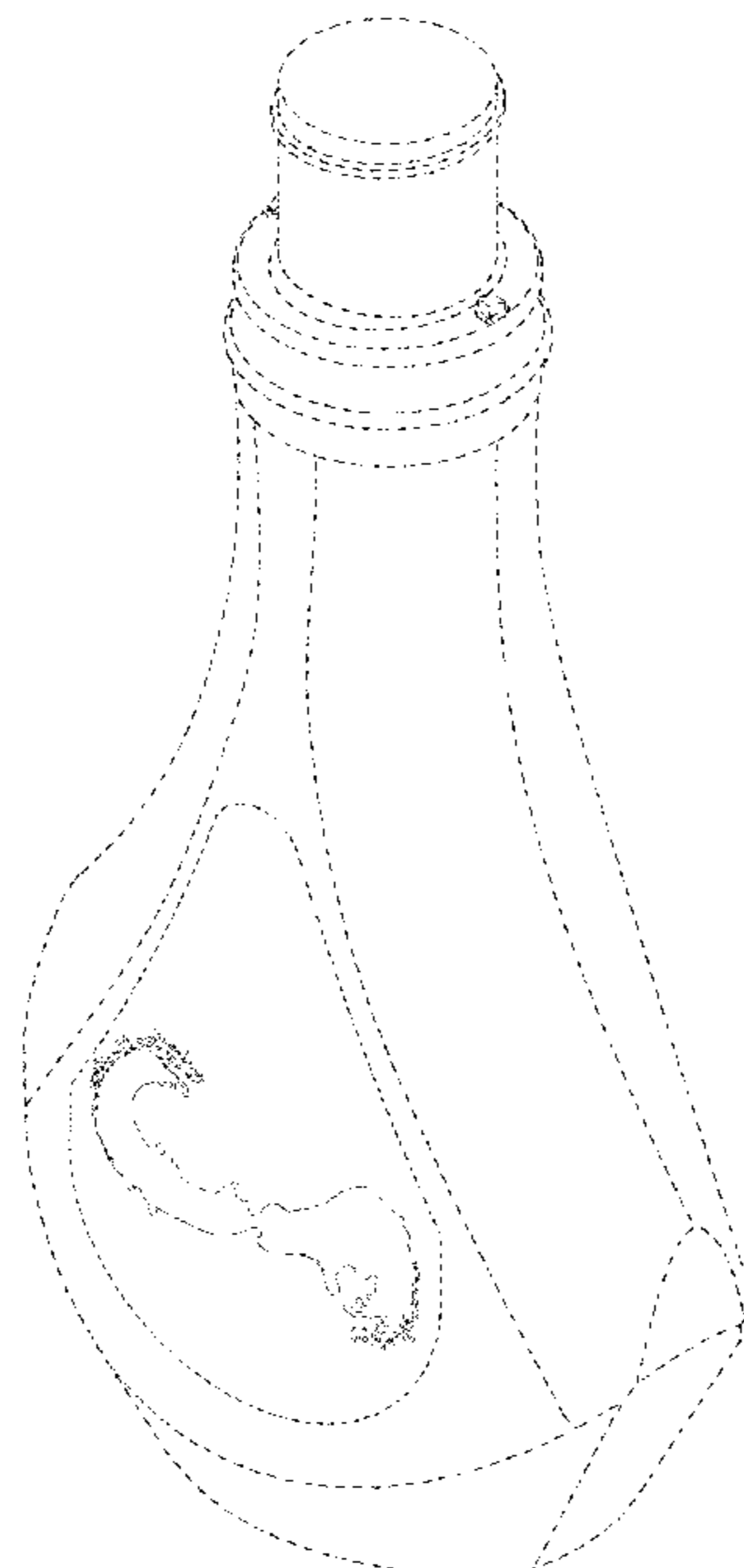
(57) **CLAIM**

The ornamental design for a label with surface ornamentation, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a label with surface ornamentation, showing our new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a back view thereof;  
FIGS. 4 and 5 are left and right side views thereof; and  
FIGS. 6 and 7 are top and bottom plan views thereof;  
FIG. 8 is a perspective view of a container ornamented with a label incorporating an alternate embodiment of the design;  
FIG. 9 is a front view thereof;  
FIG. 10 is a back view thereof;  
FIGS. 11 and 12 are left and right side views thereof; and,  
FIGS. 13 and 14 are top and bottom plan views thereof.  
The broken lines shown in the drawings depict environmental subject matter only and form no part of the claimed design.

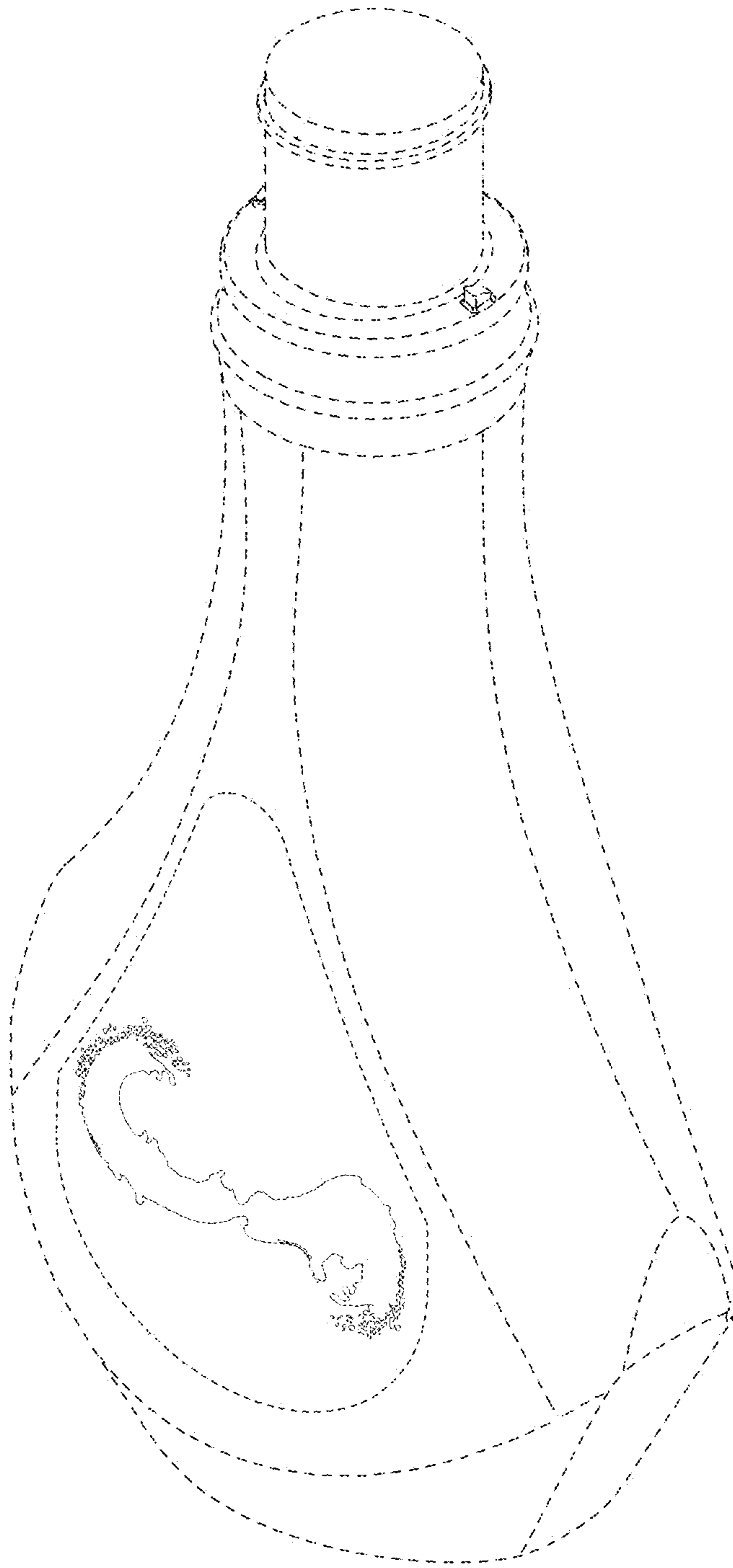

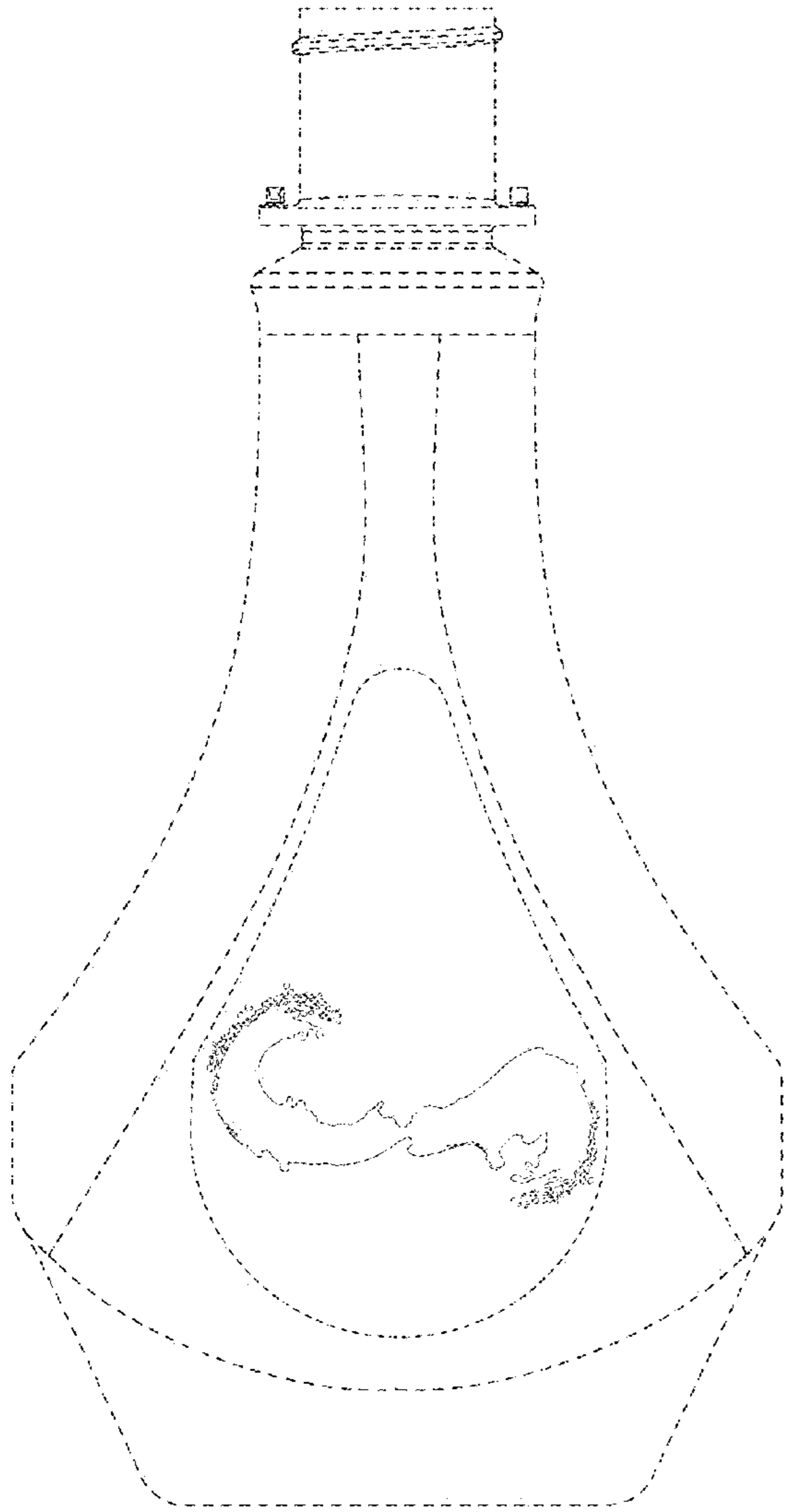

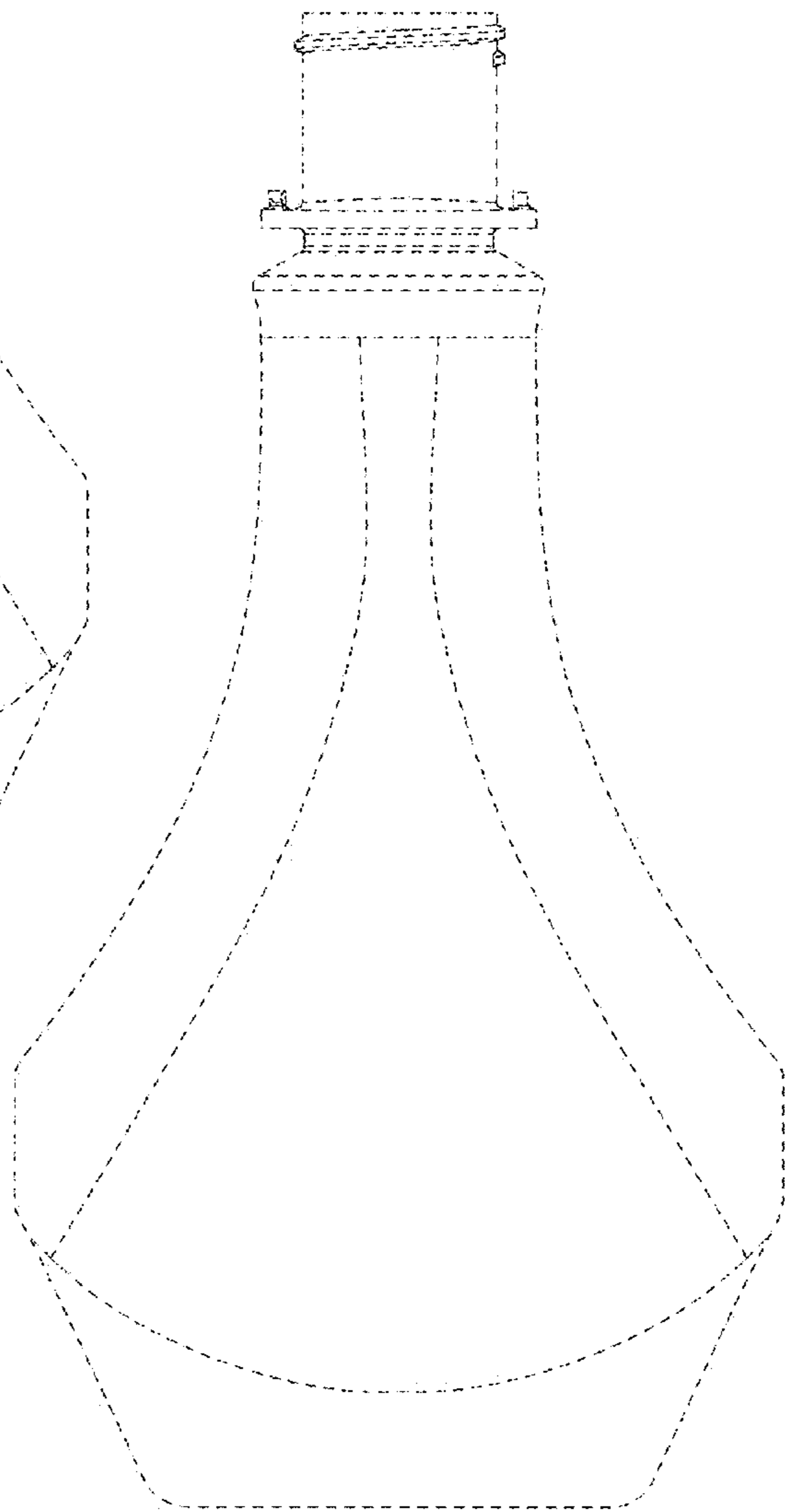

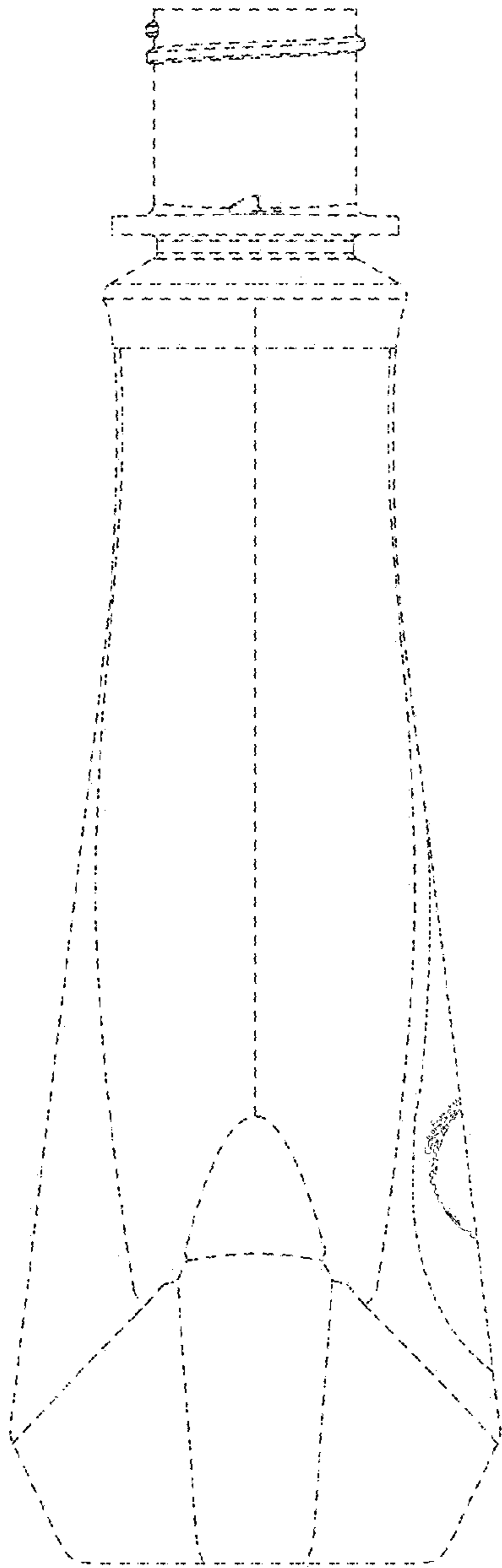

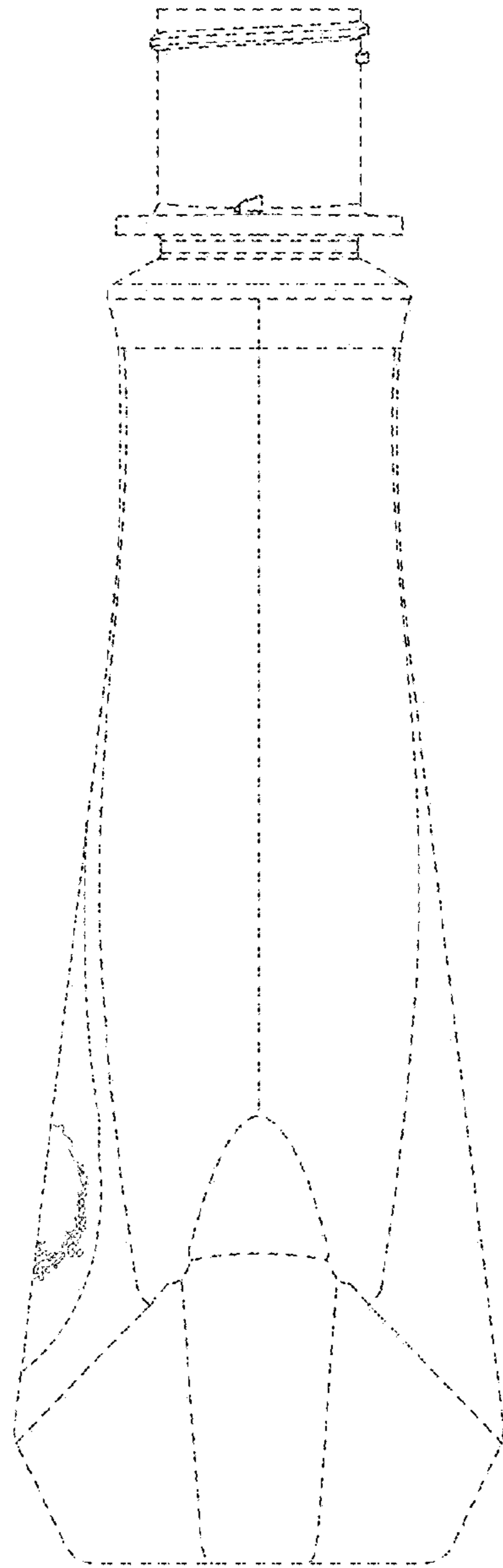

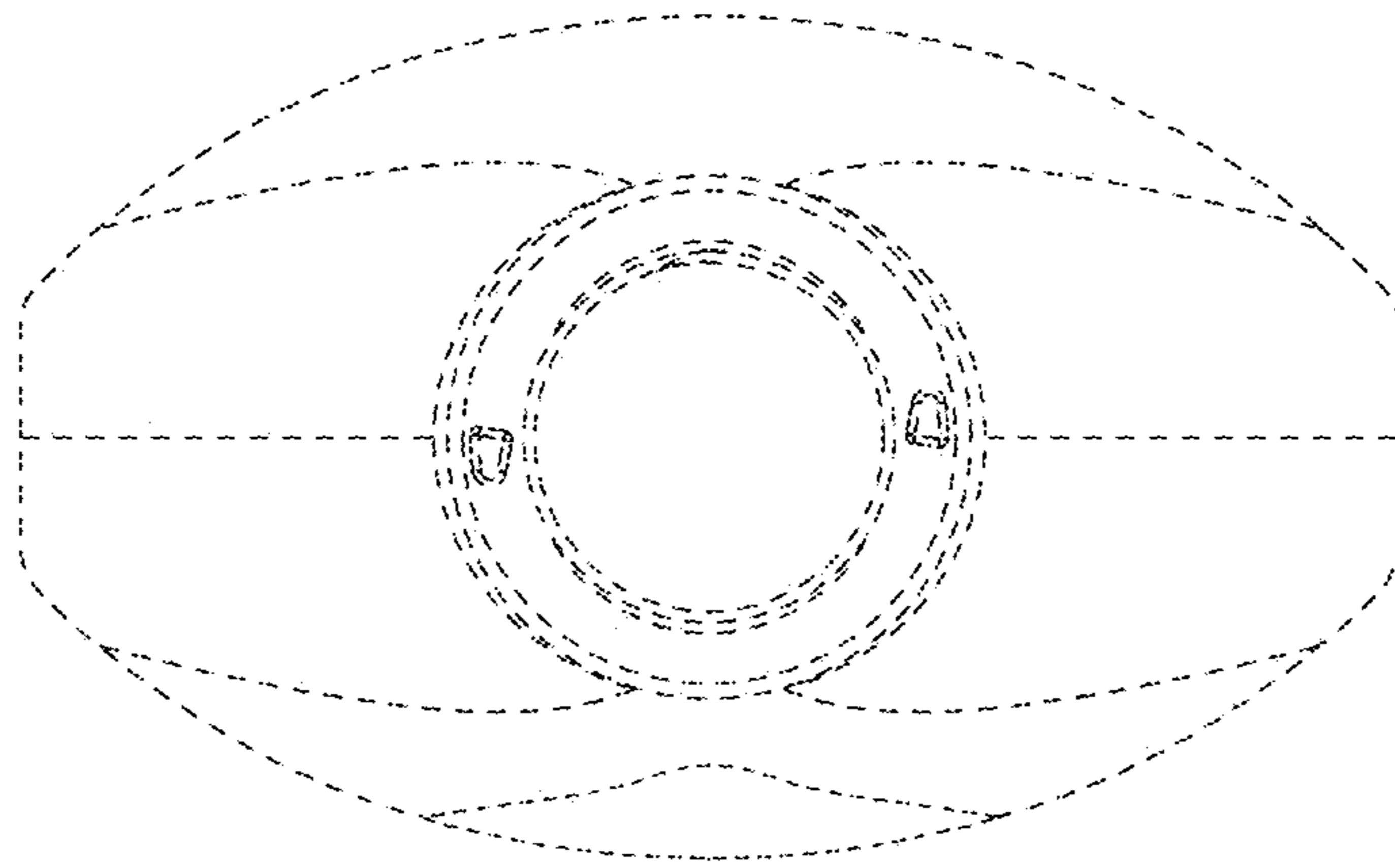

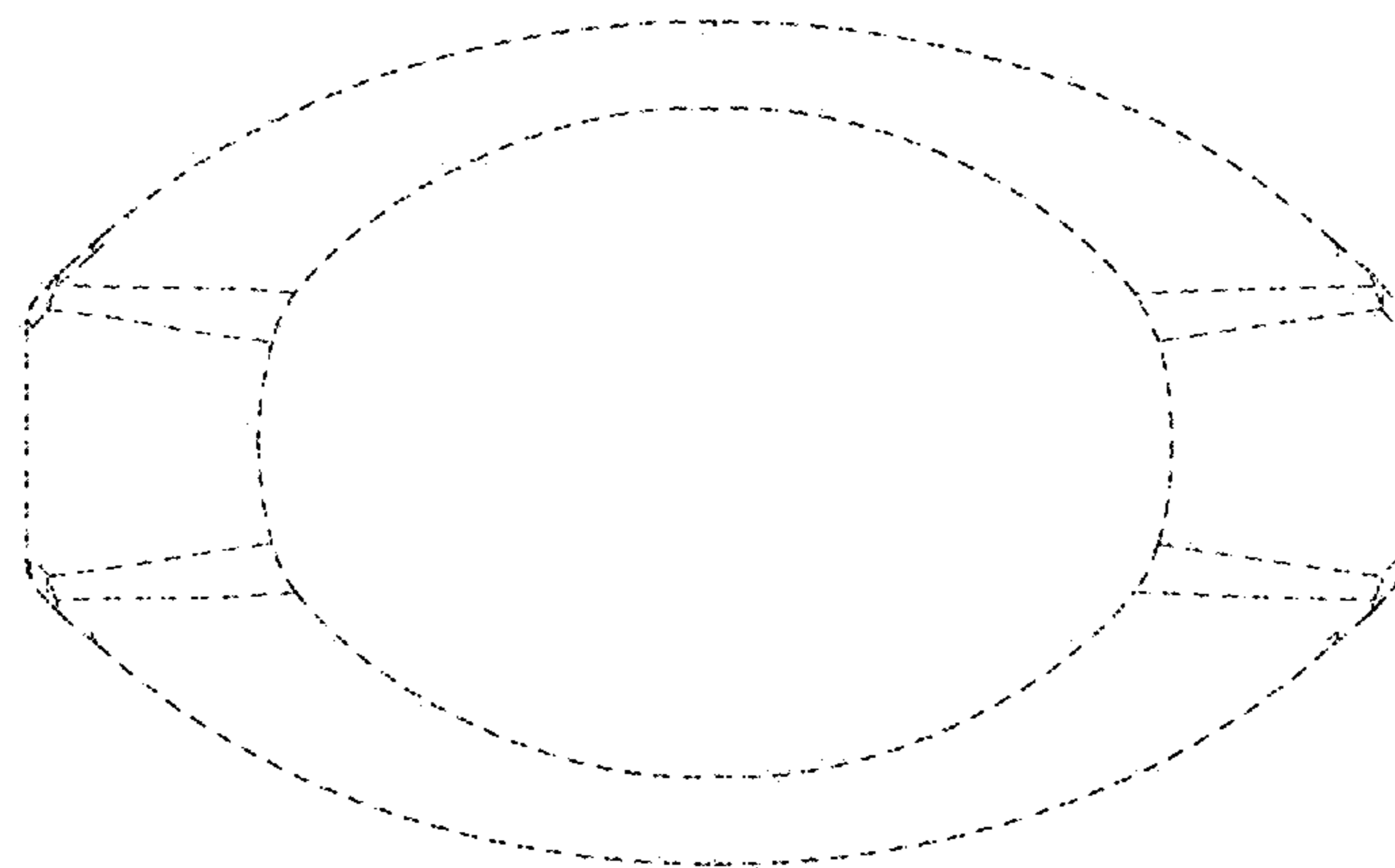

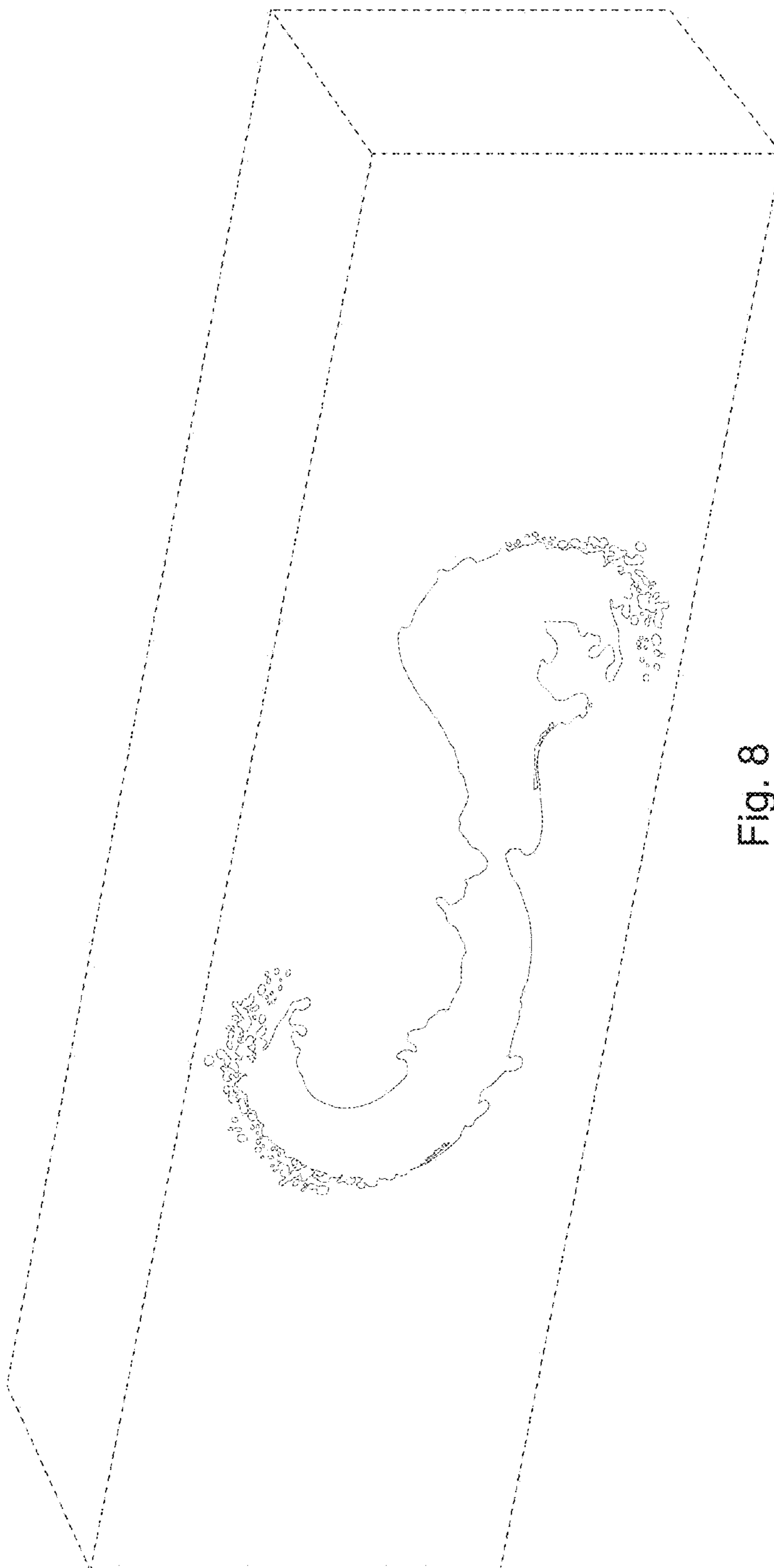

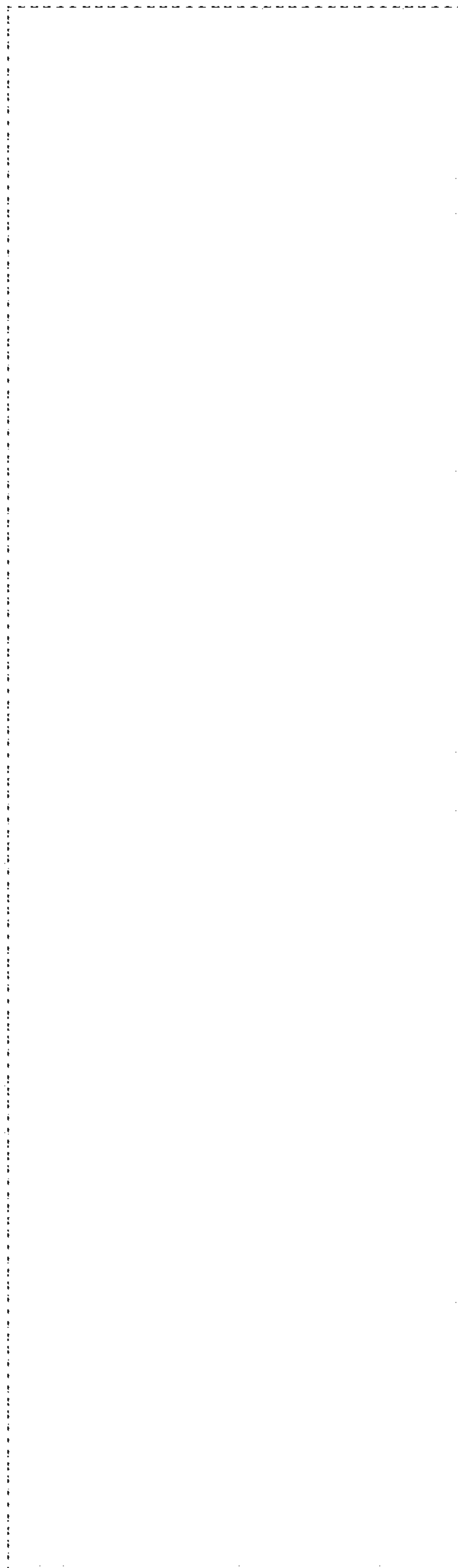

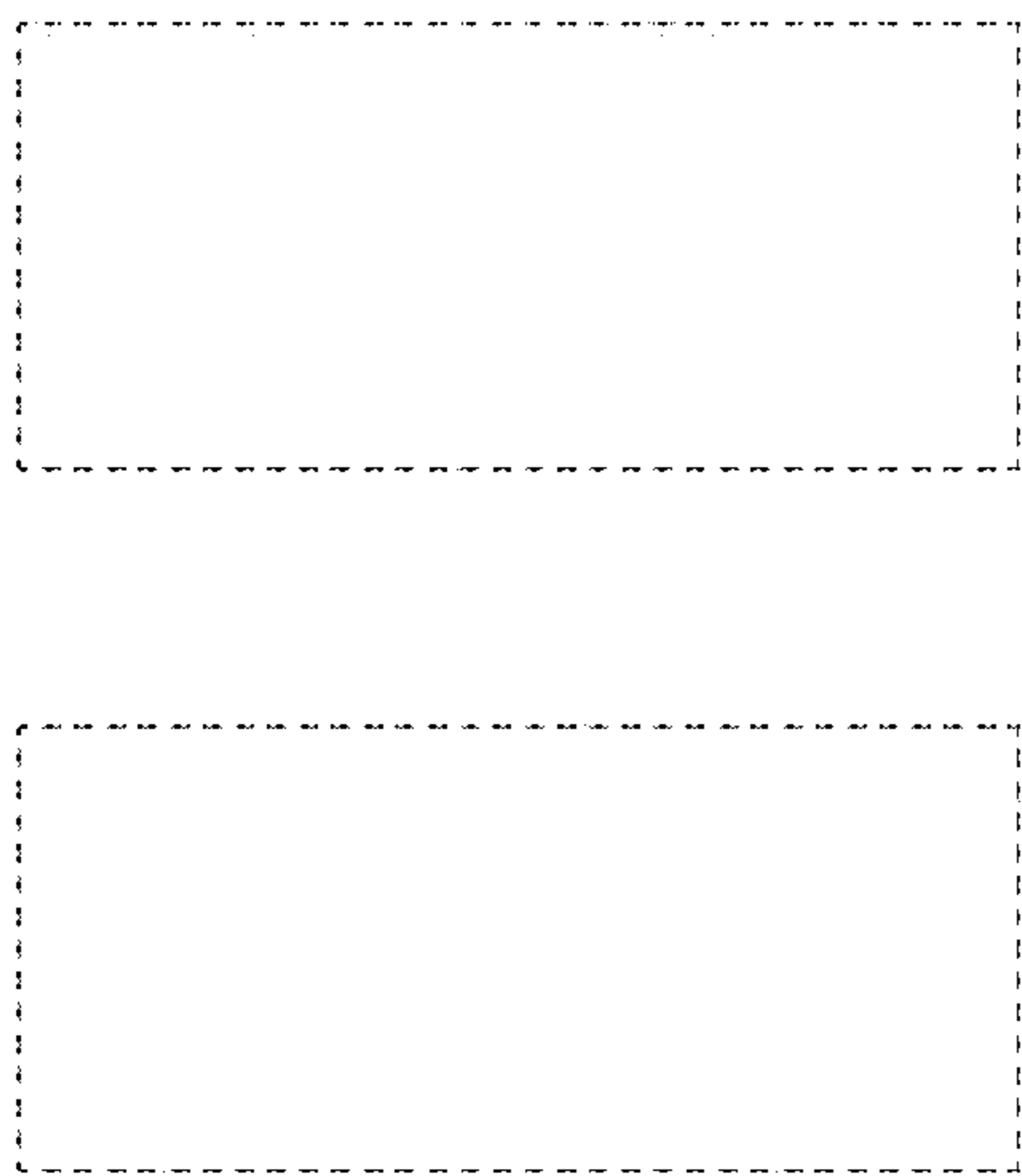

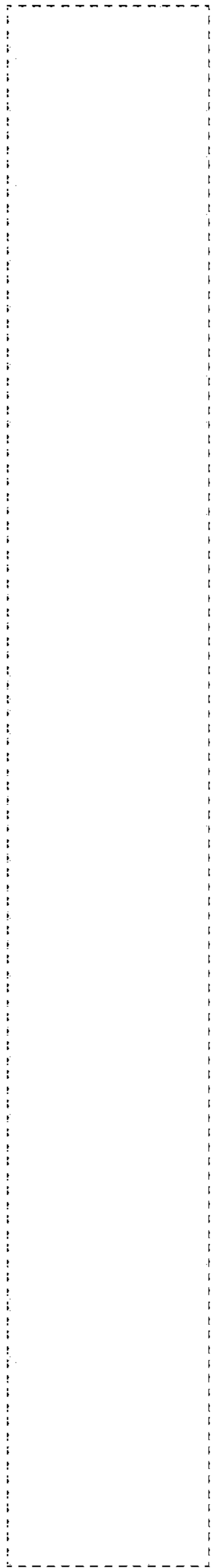

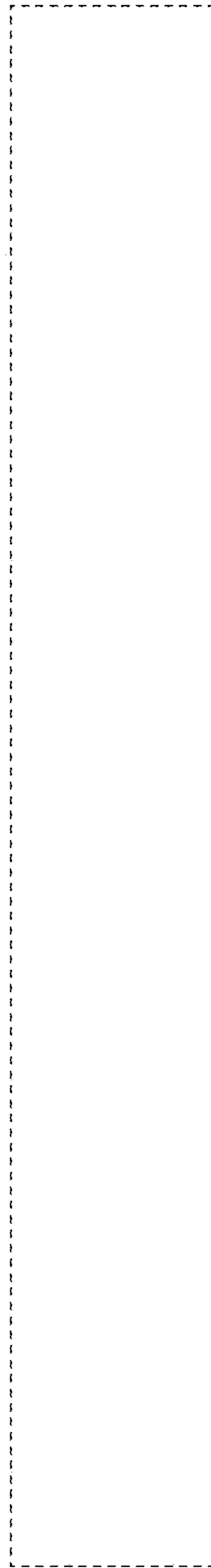
