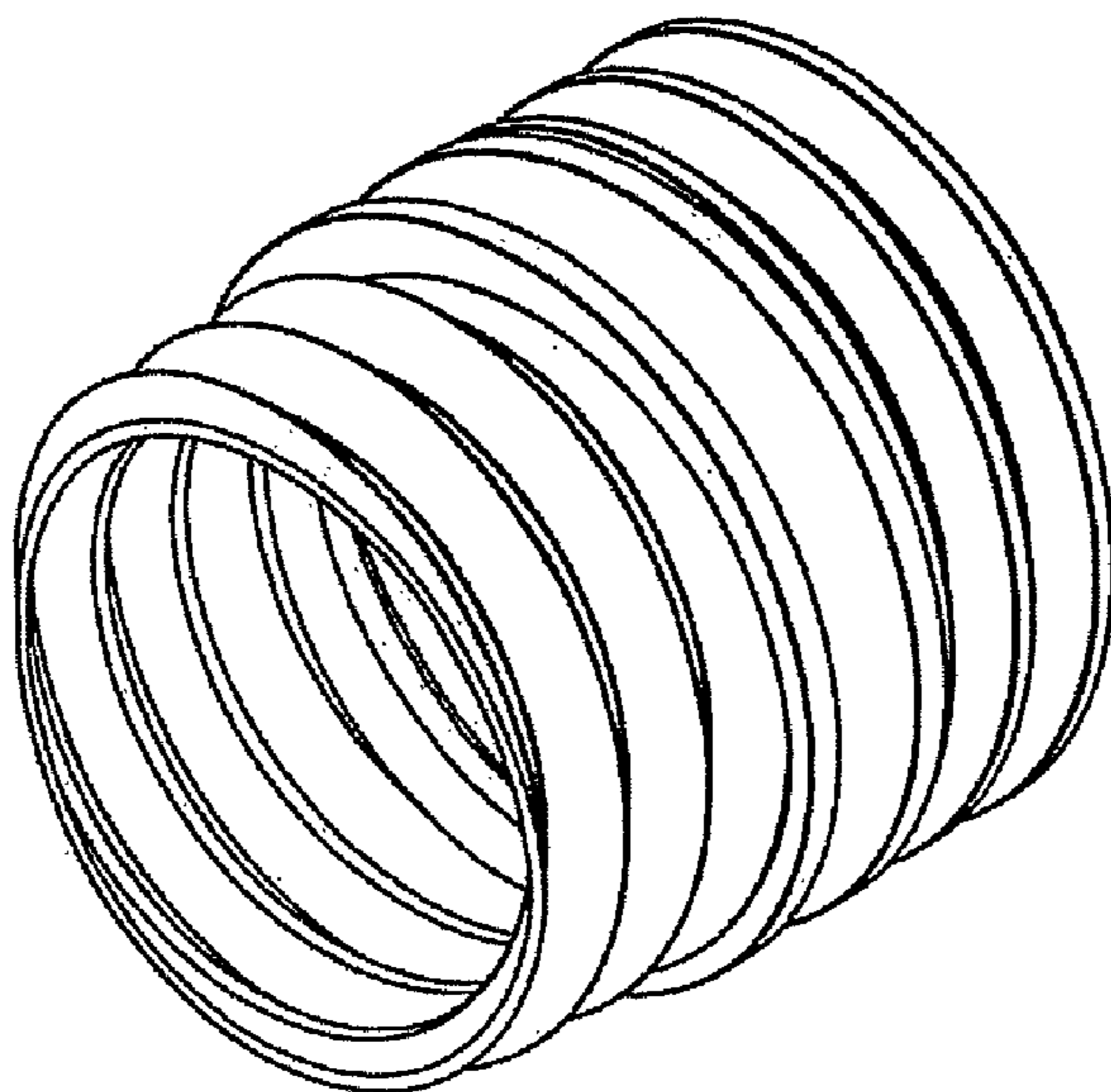
(57) **CLAIM**

The ornamental design for a pipe coupling, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view from one end thereof,
FIG. 2 is an isometric view from the opposite end thereof,
FIG. 3 is an isometric view similar to FIG. 1, but from
beneath,
FIG. 4 is an isometric view similar to FIG. 2, but from
beneath,
FIG. 5 is a side elevational view thereof, the opposite side
being a mirror image,
FIG. 6 is a top plan view thereof,
FIG. 7 is a bottom plan view thereof,
FIG. 8 is an end view thereof, taken from the left end of FIG.
5; and,
FIG. 9 is an end view thereof, taken from the right end of FIG.
5.

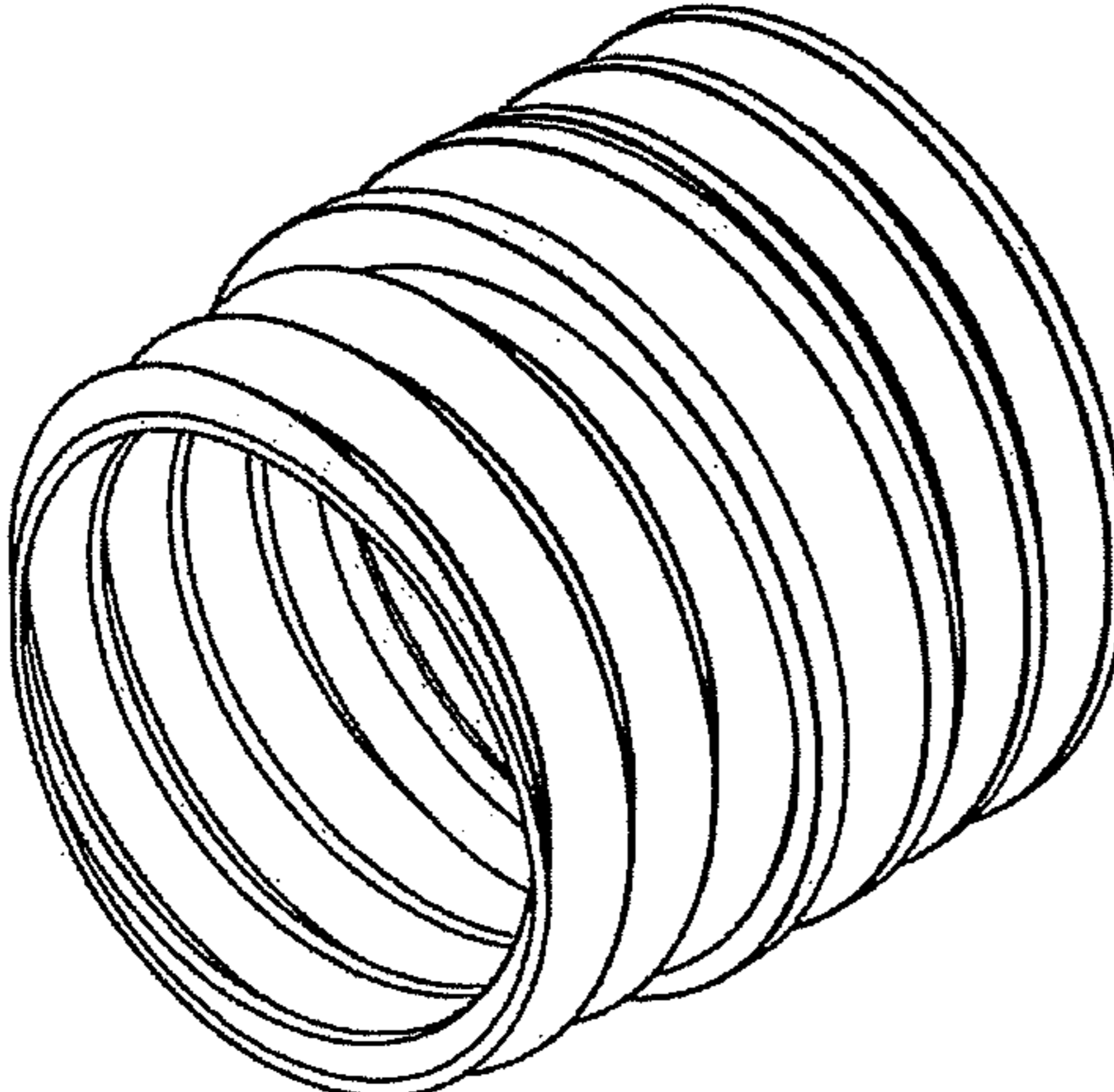

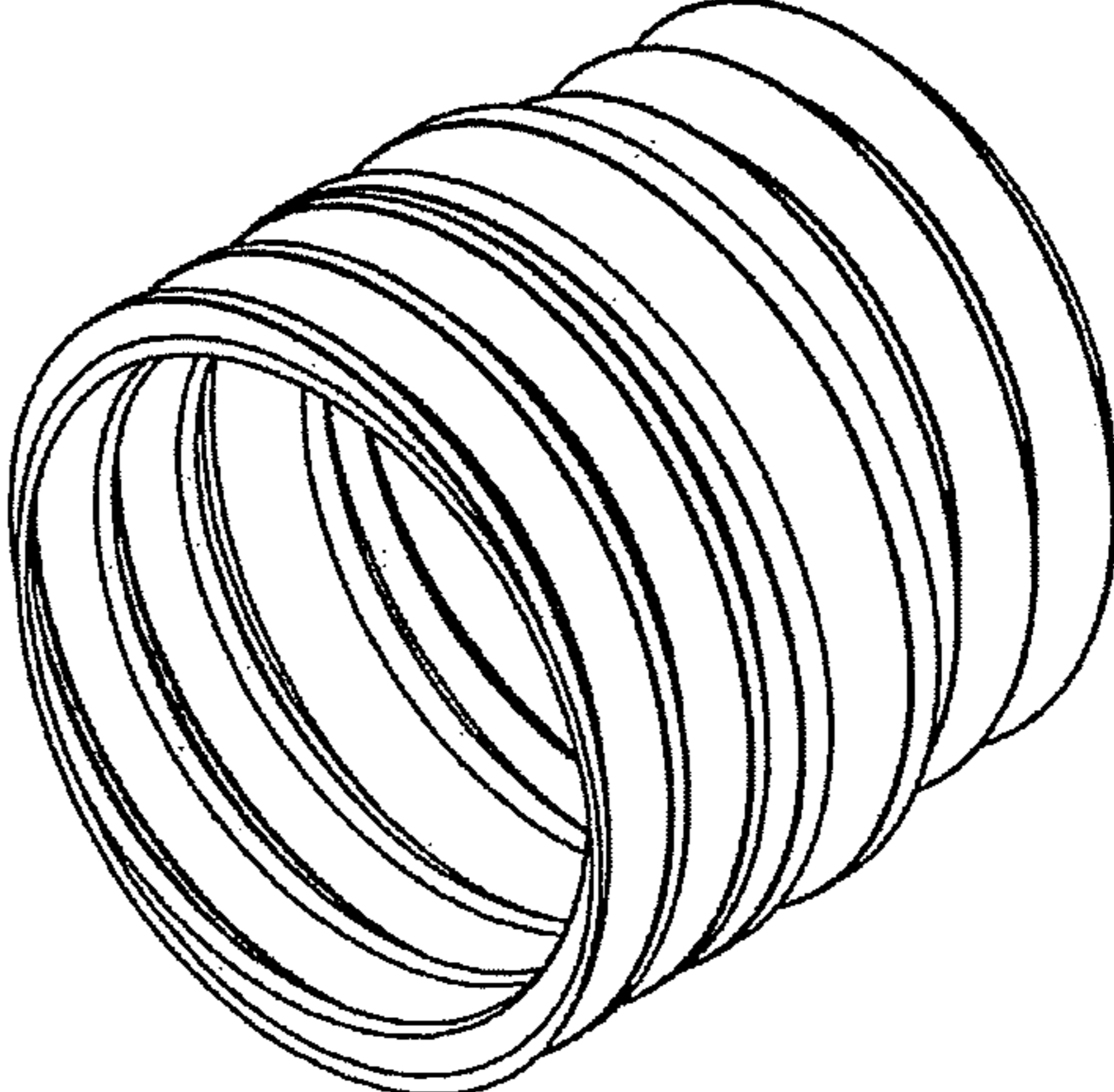

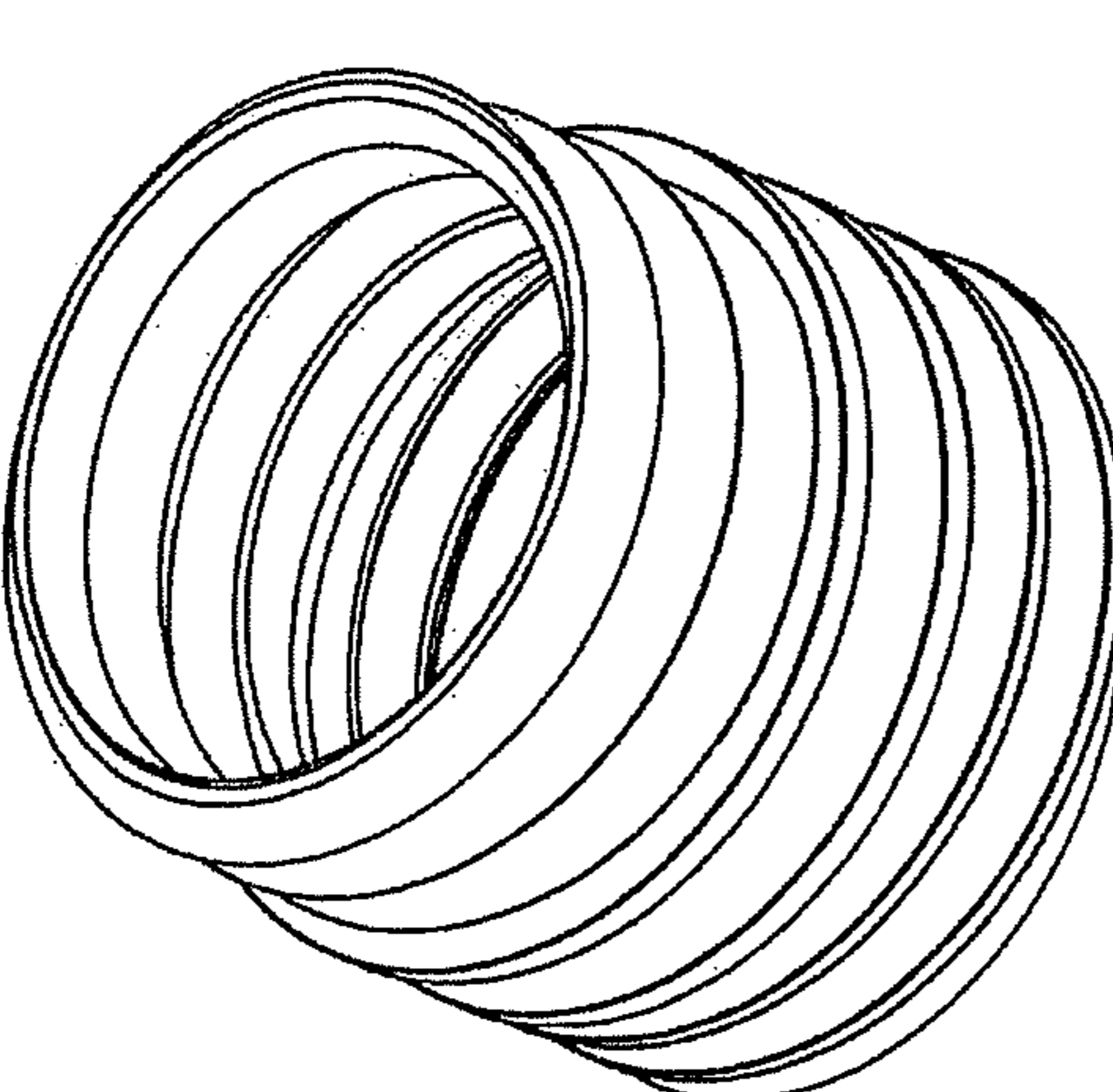

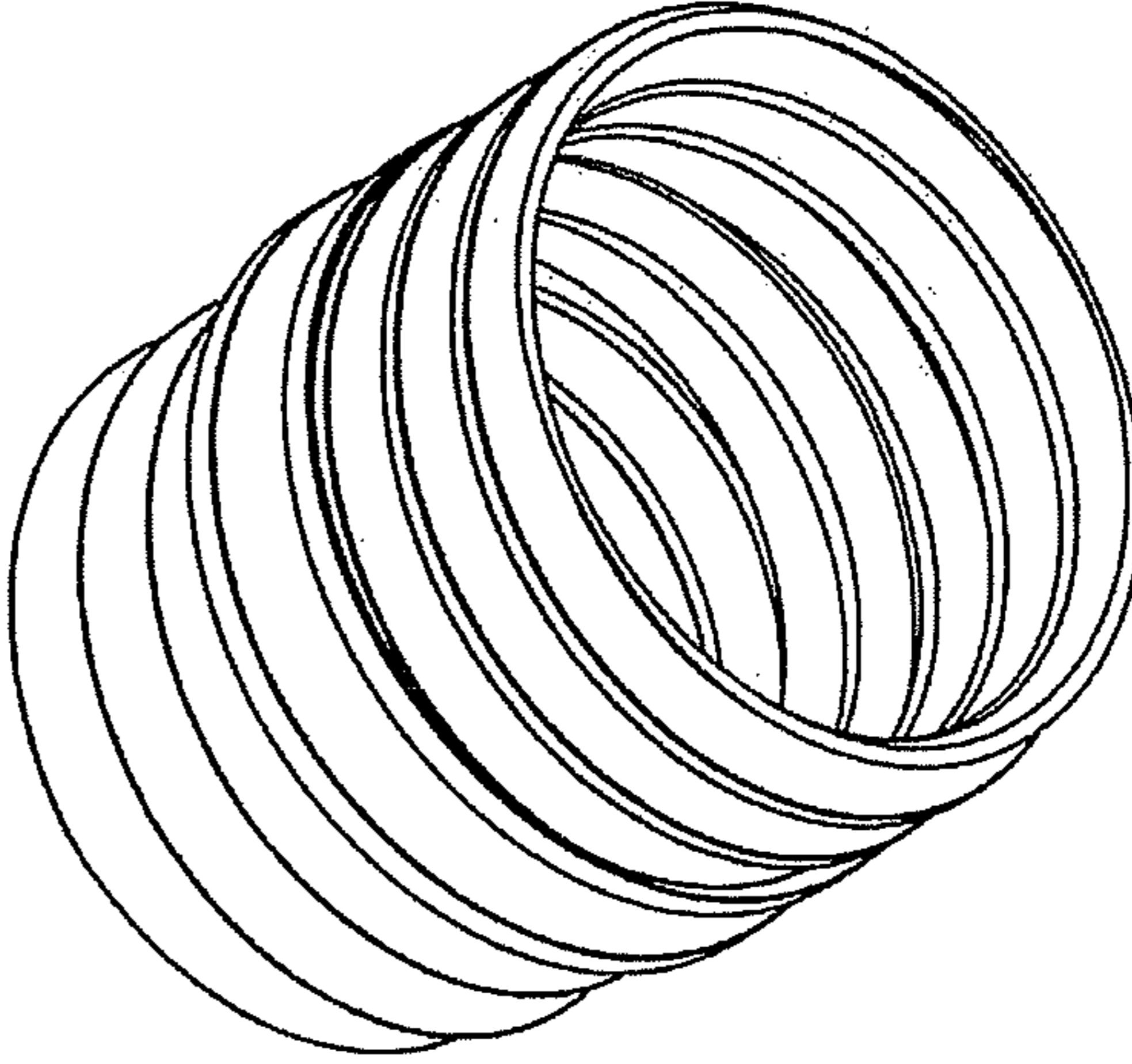

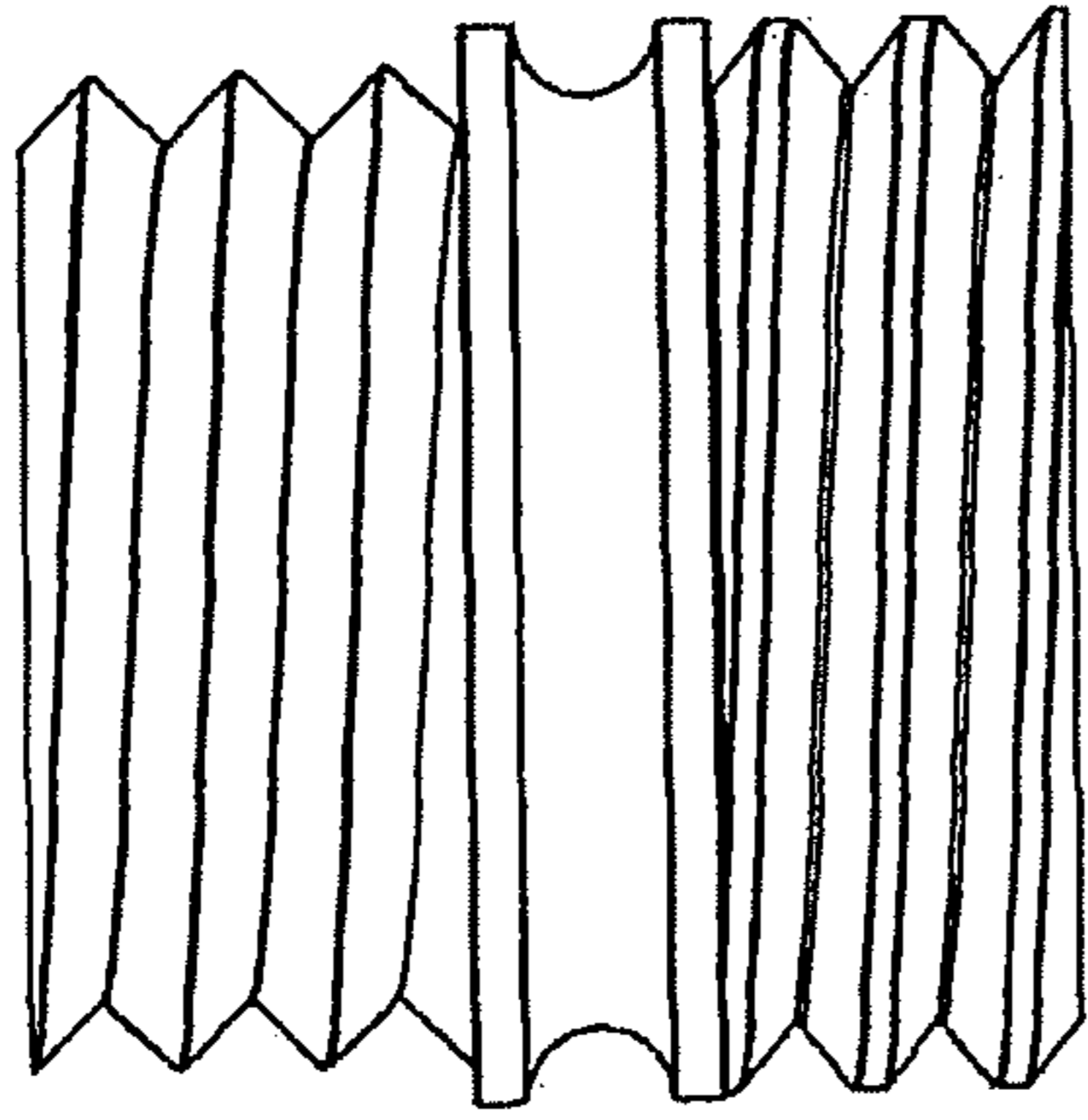

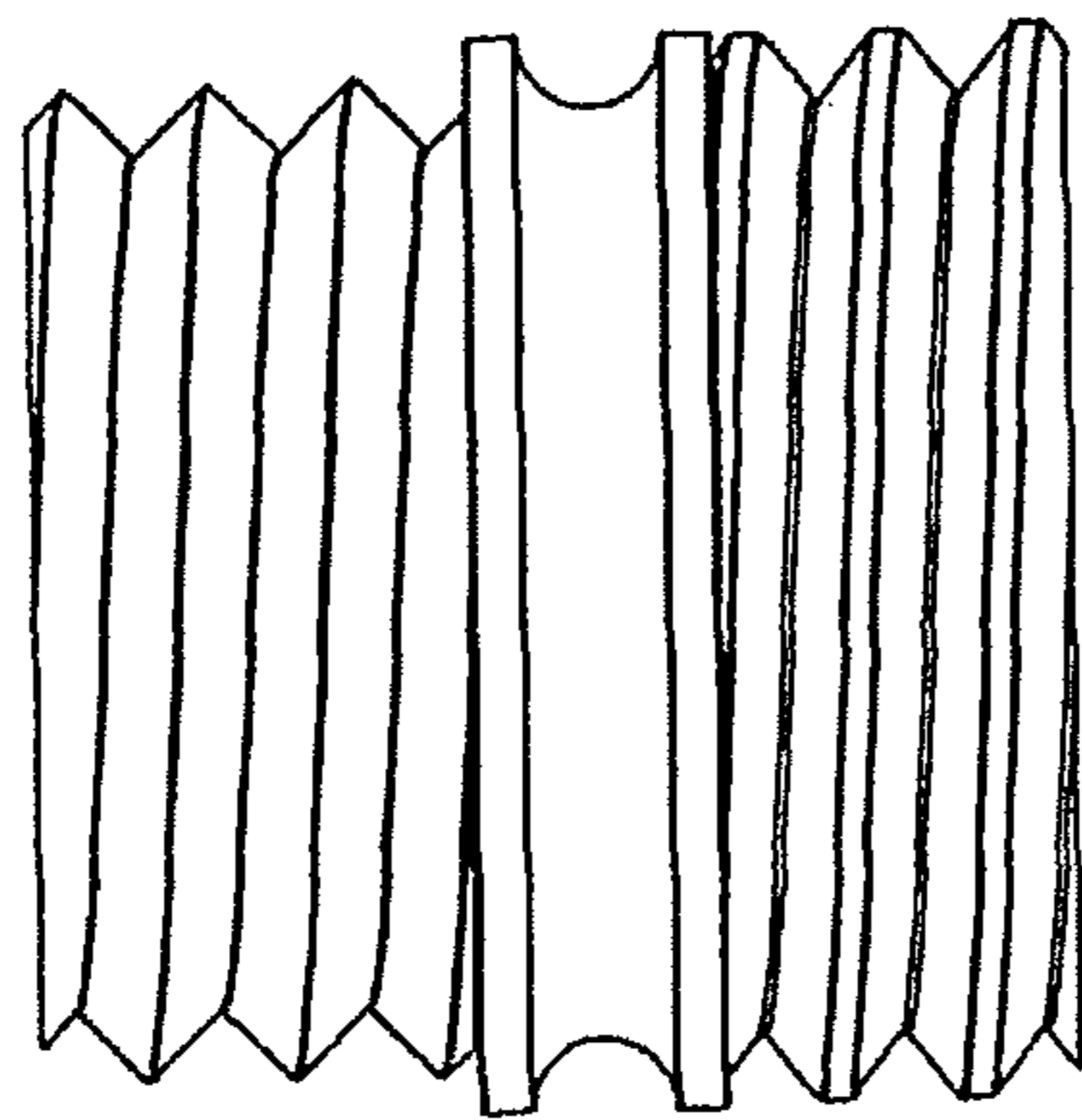

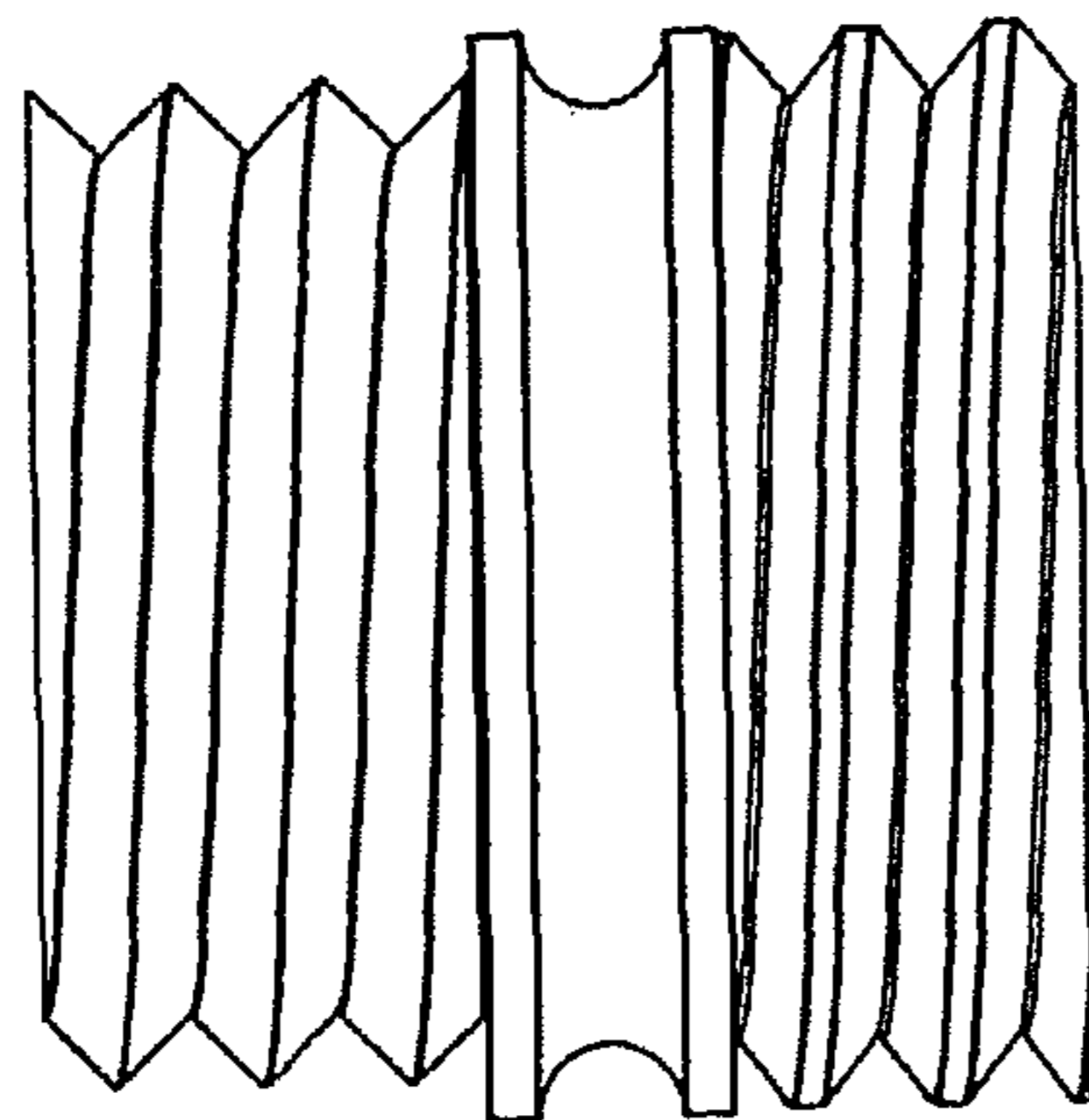

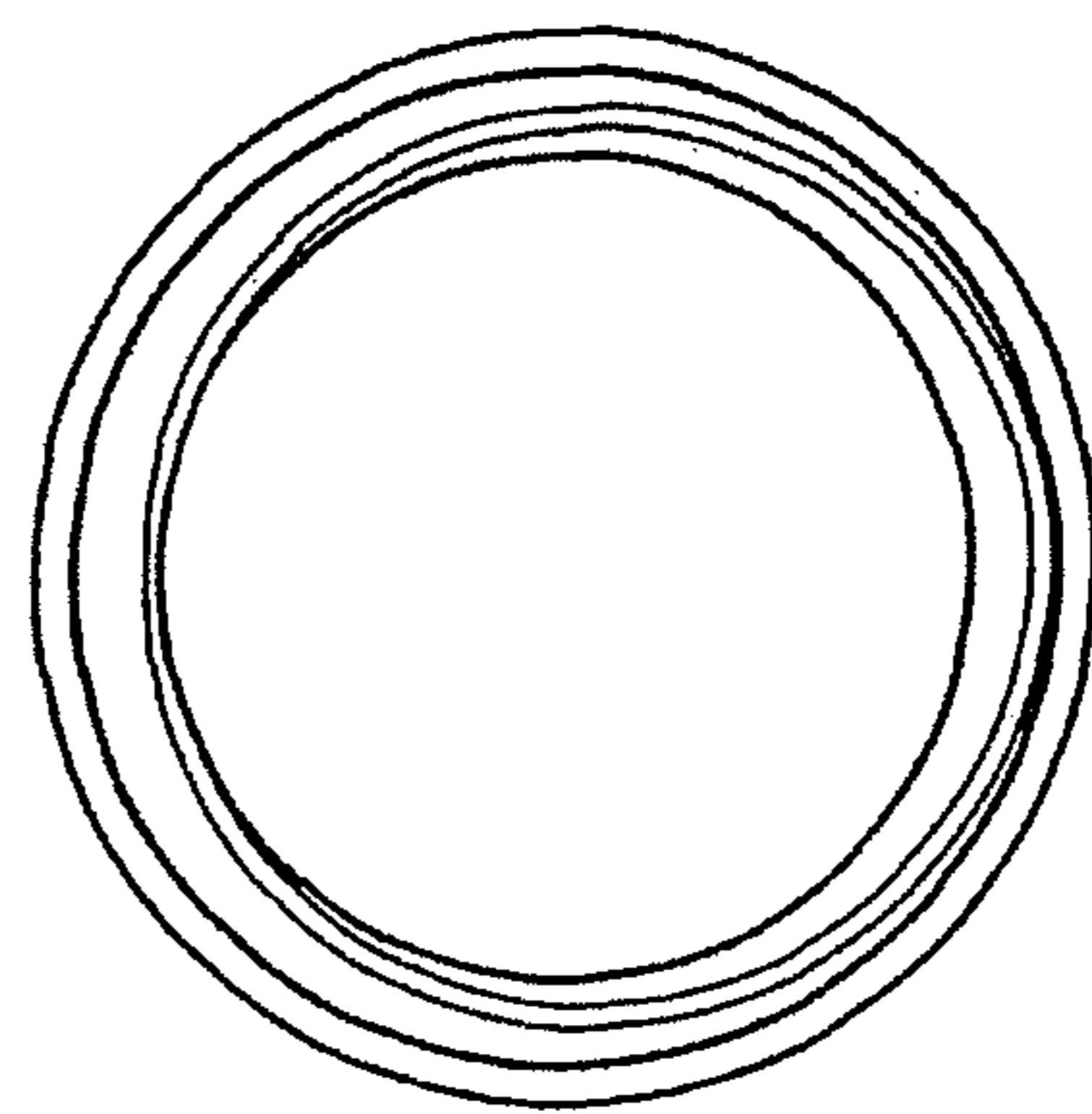

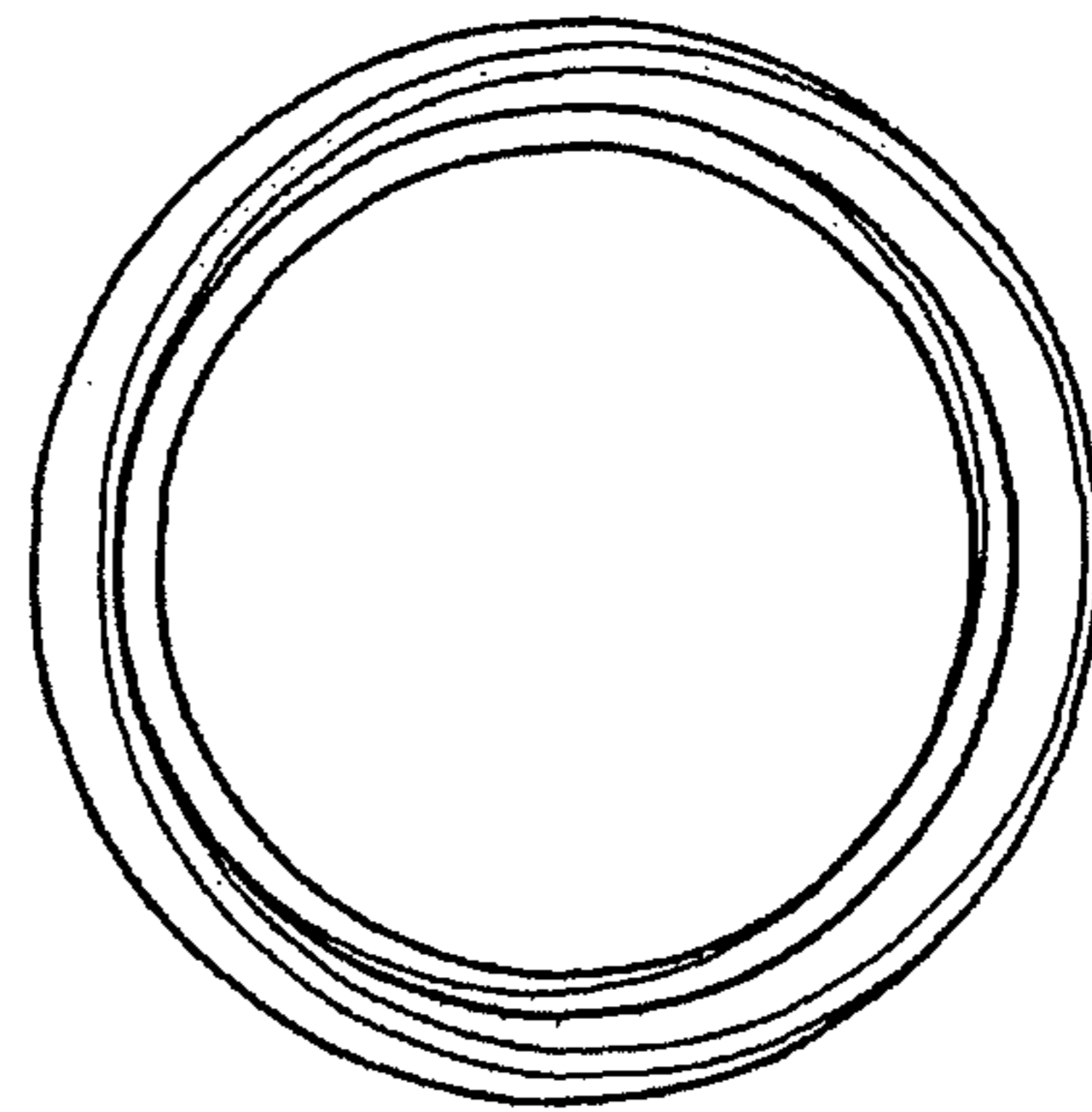
