FIG. 2: Left side view;

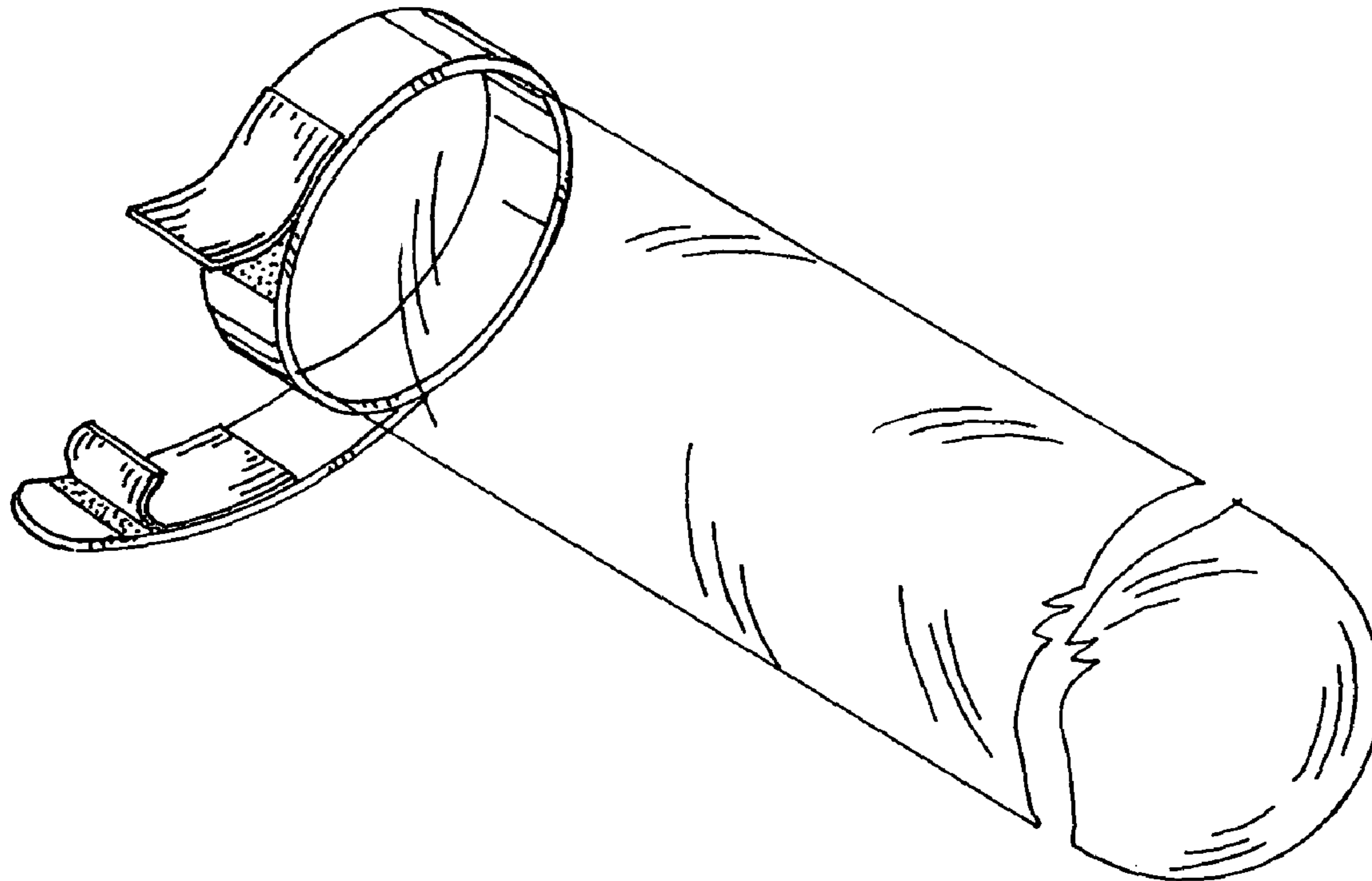
FIG. 3: Rear elevation;

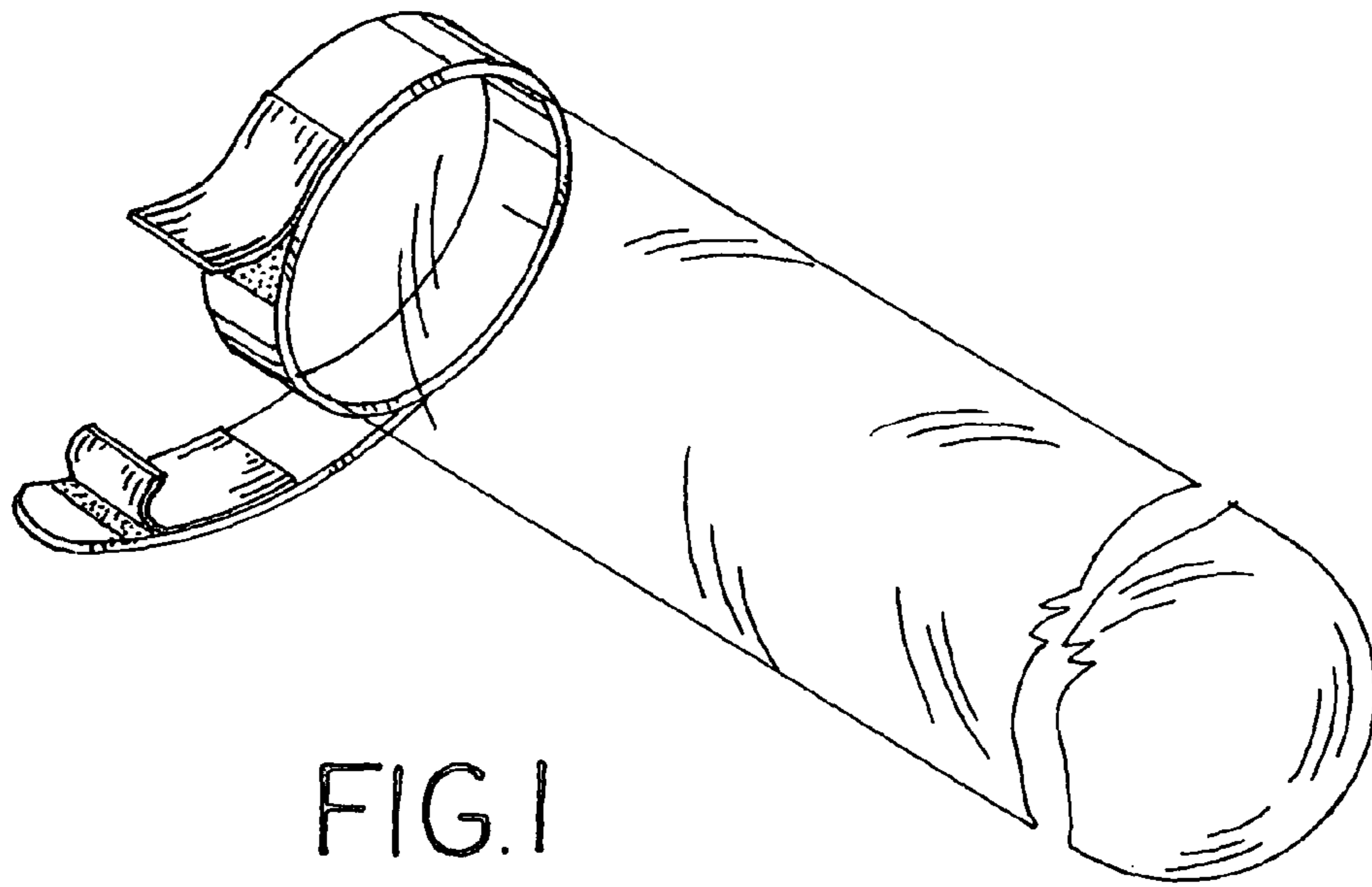

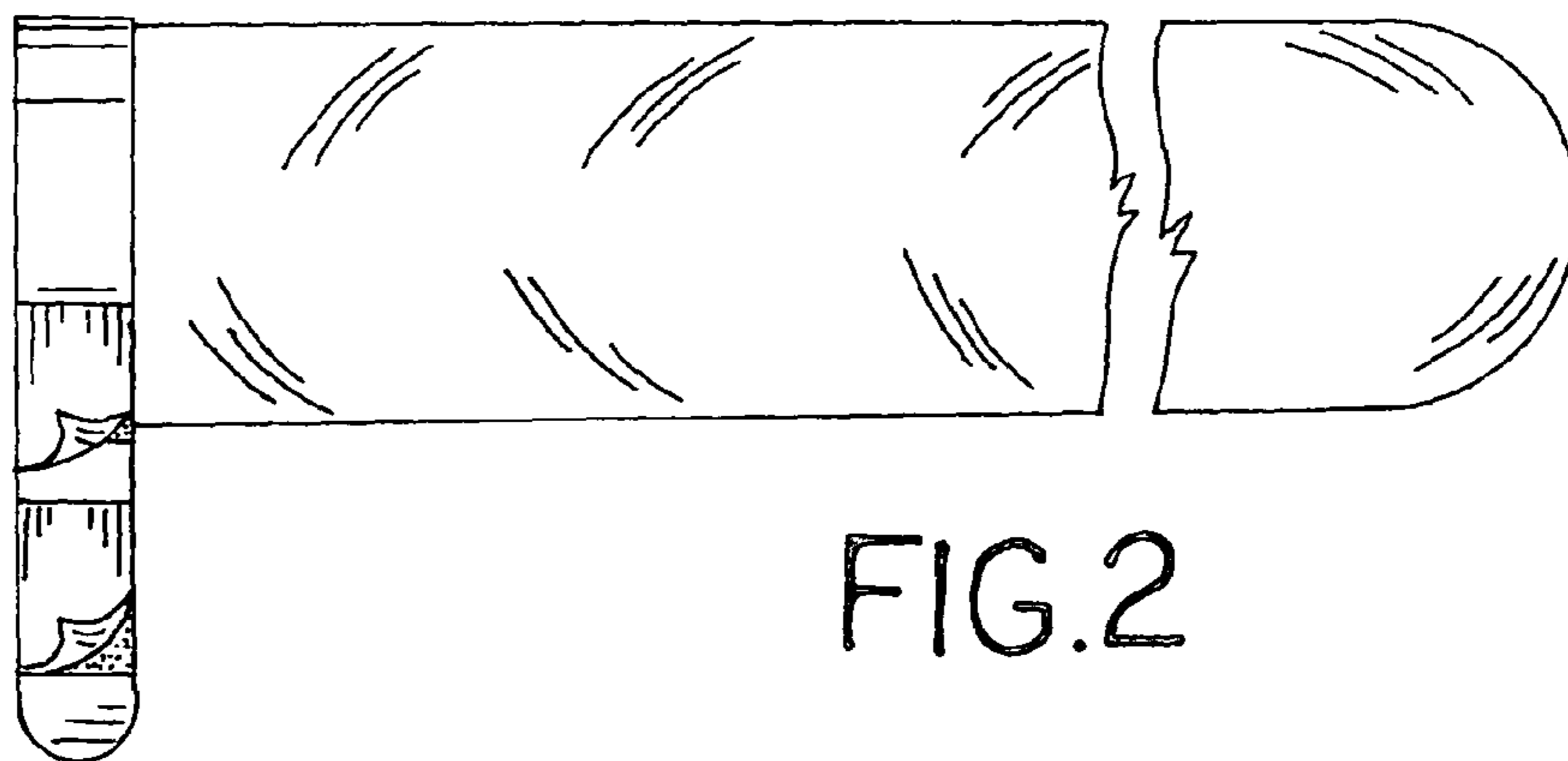

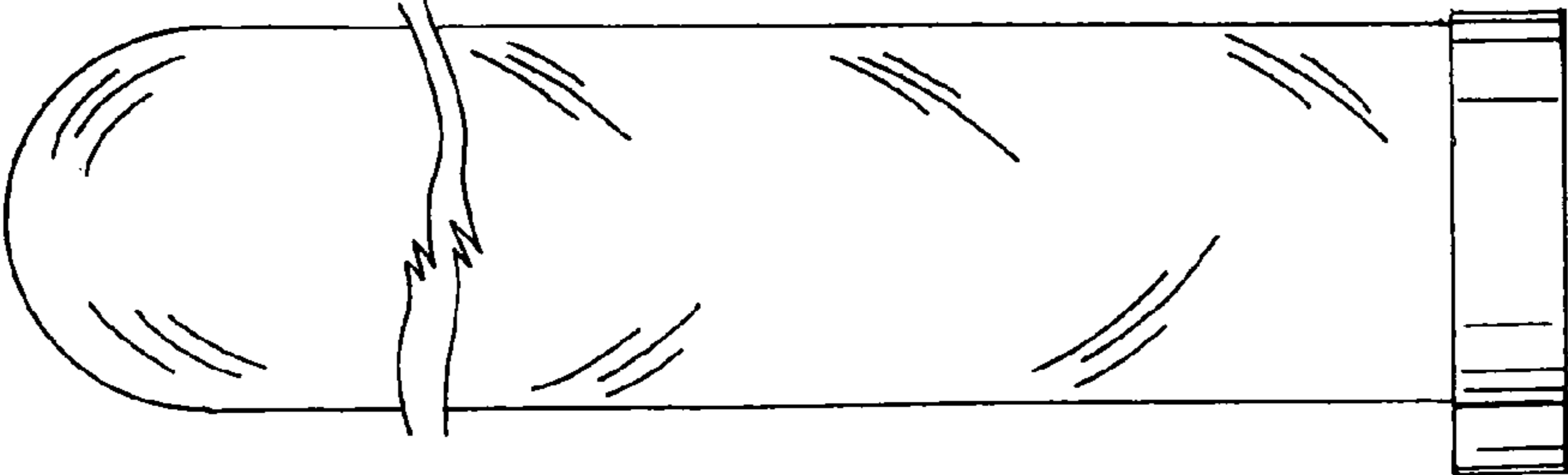
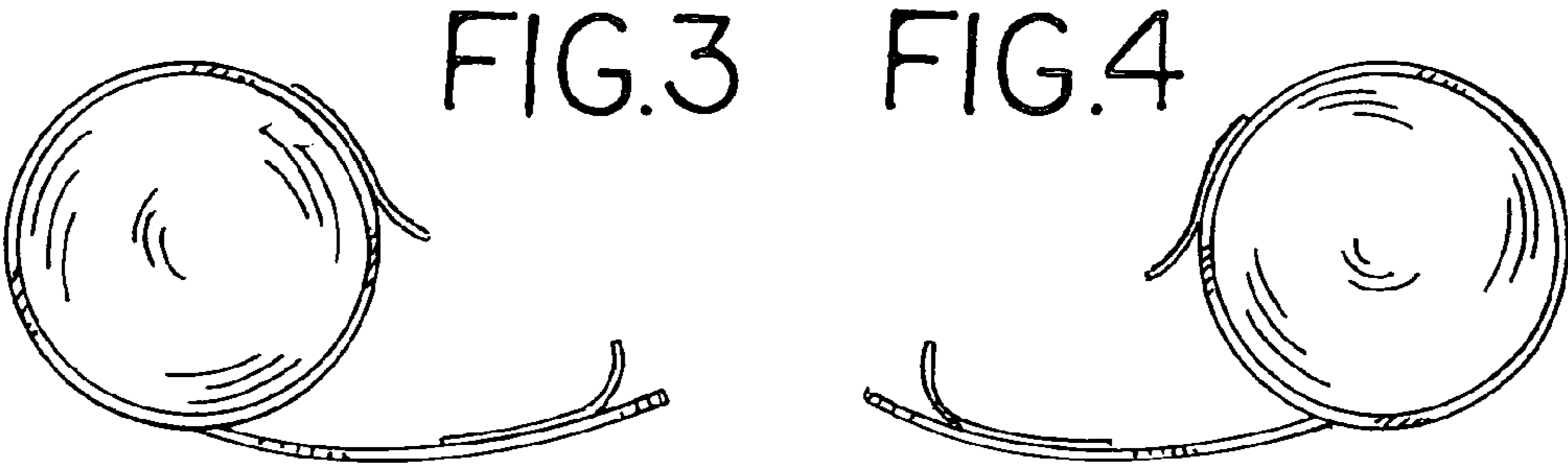
