FIG. 4 is a right side view of the architectural panel with millet and grass

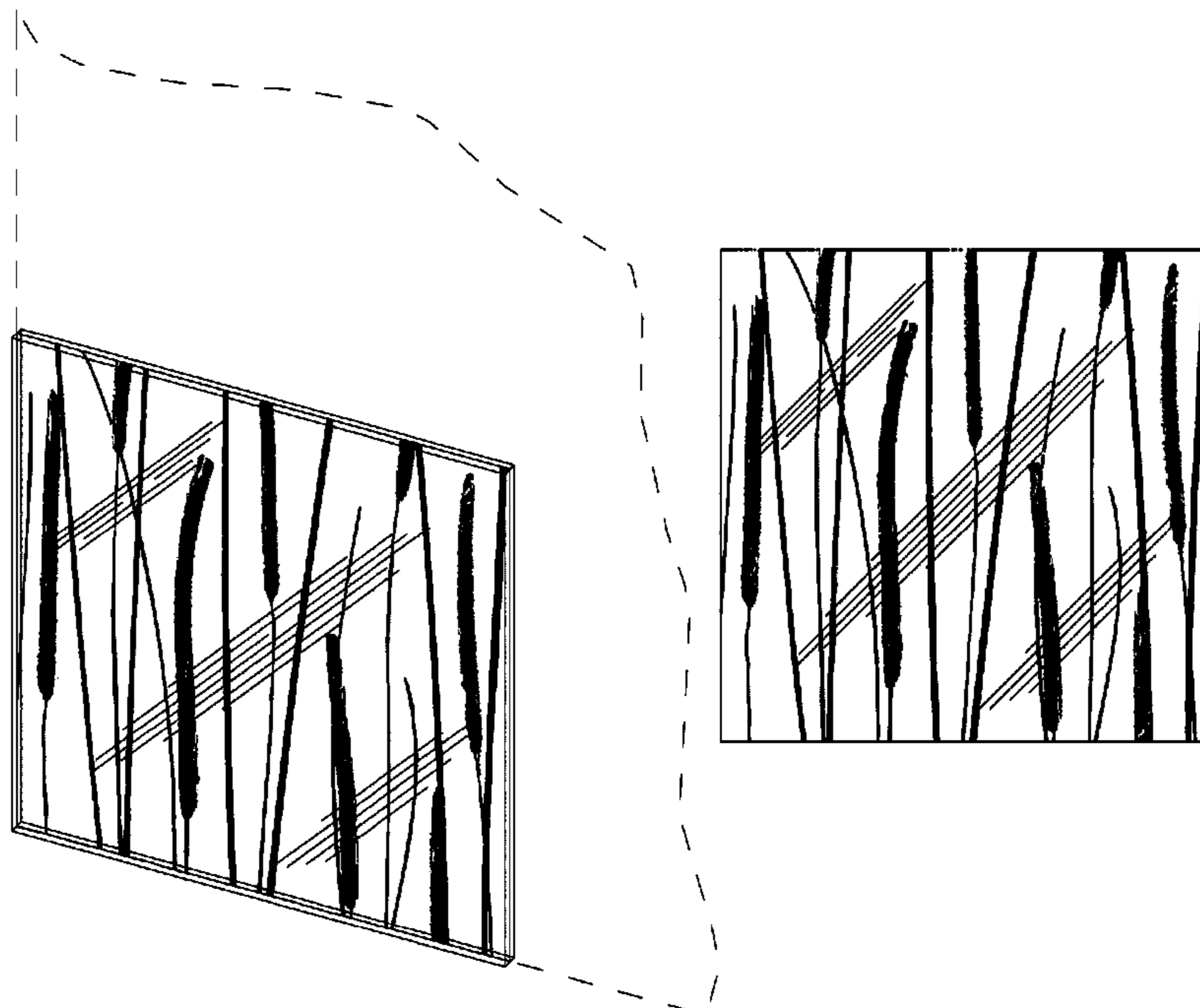
FIG. 5 is a top view of the architectural panel with millet and grass; and,

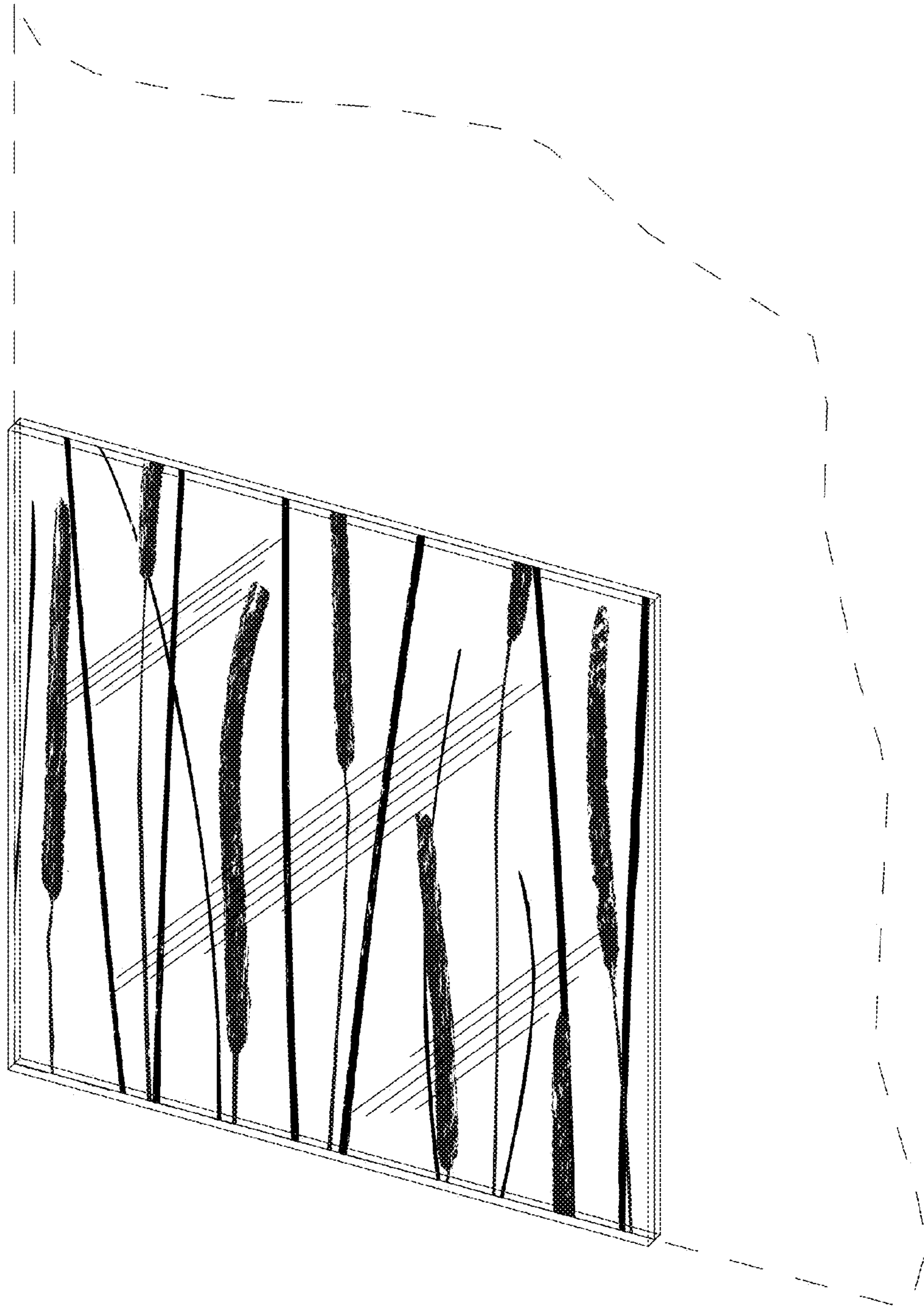

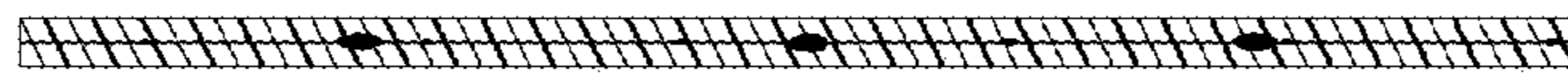

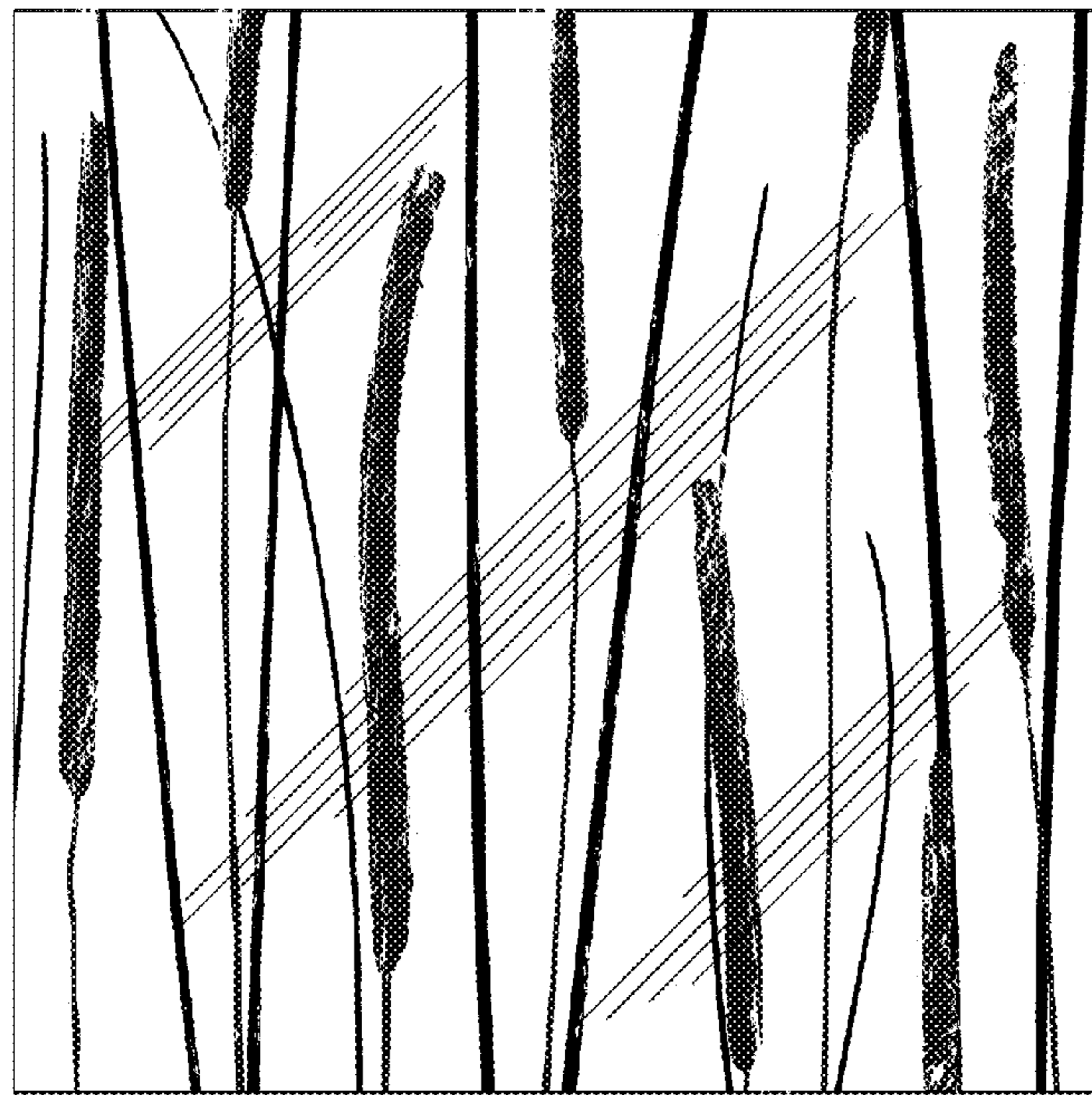

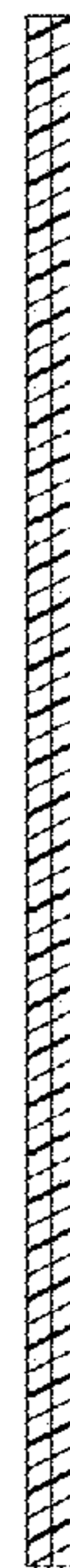

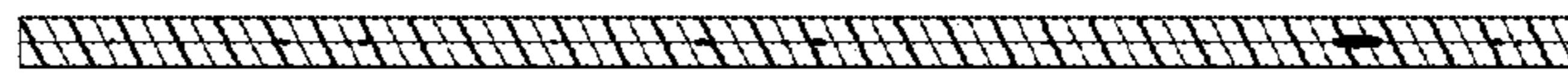
