FIG. 3 is a top view of the design for an epilation apparatus of FIG. 1;

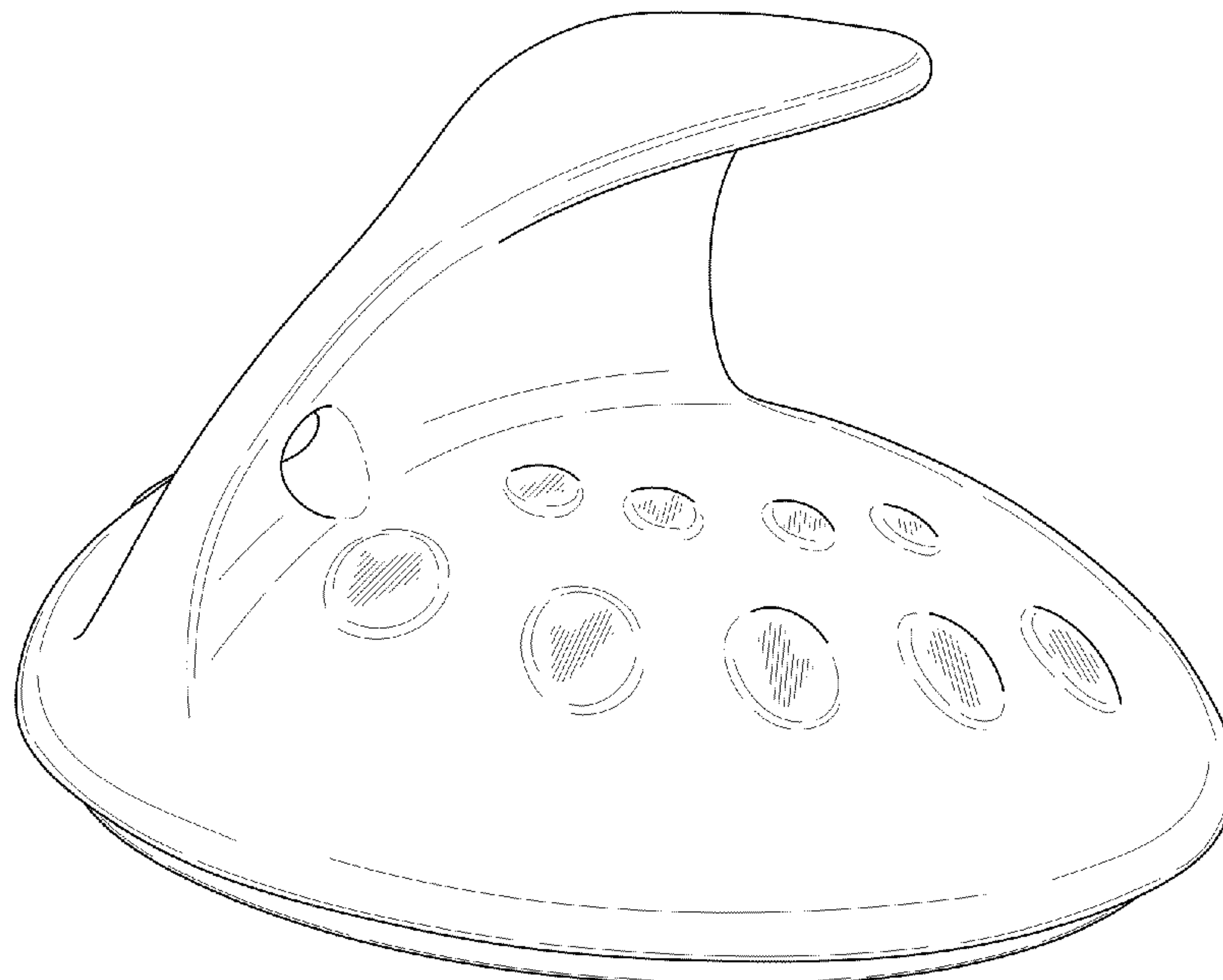
FIG. 4 is a left side view of the design for an epilation apparatus of FIG. 1;

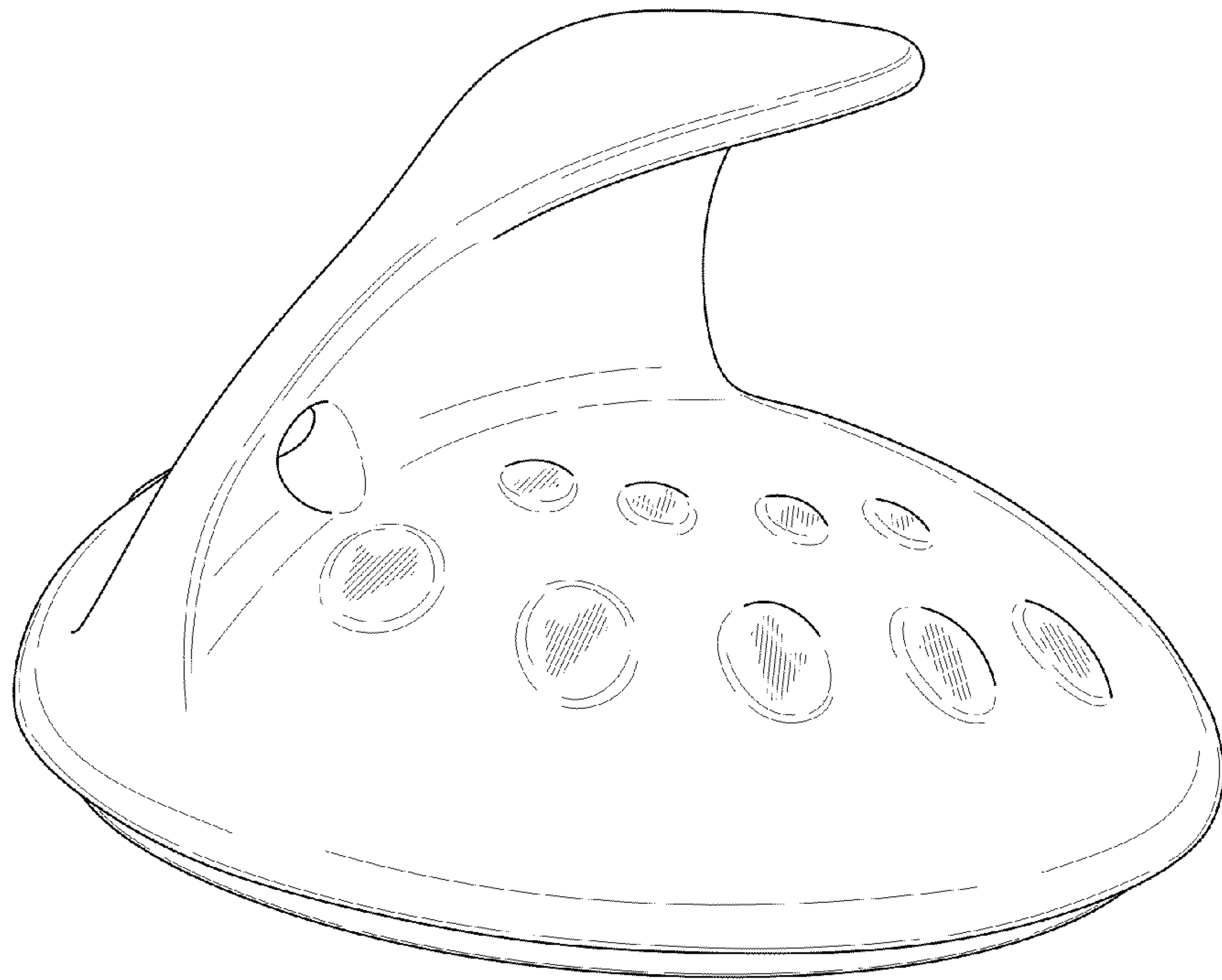

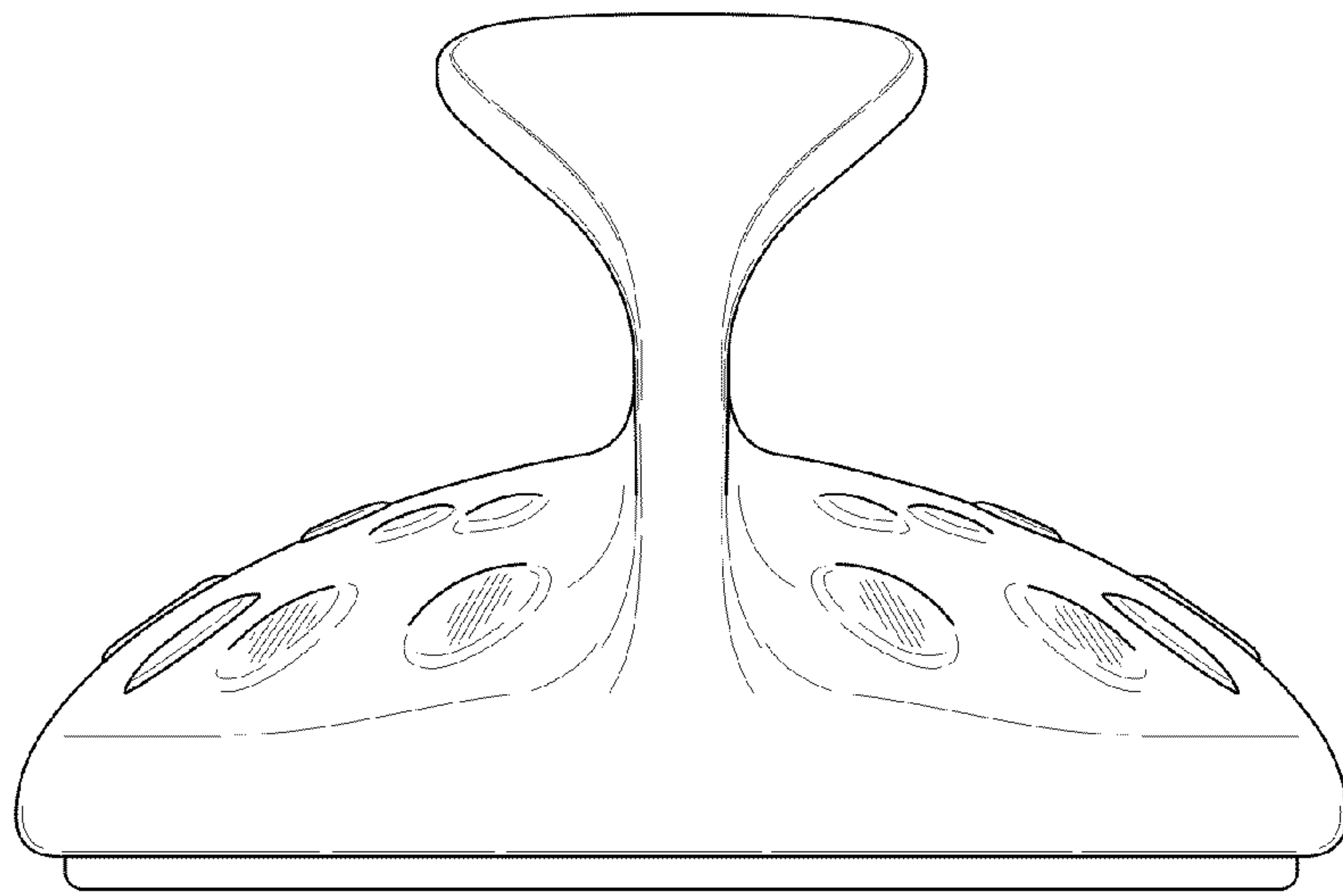

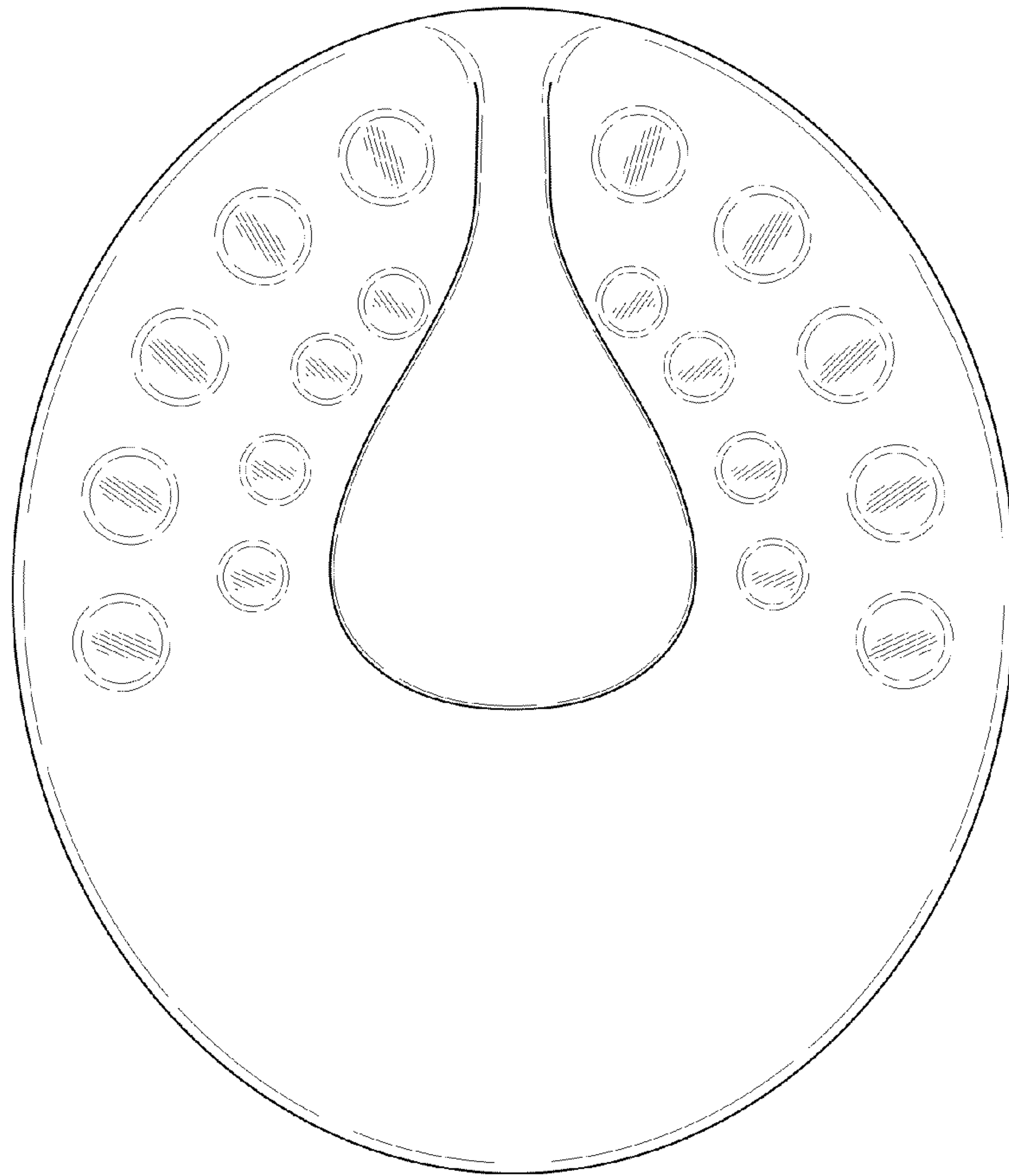

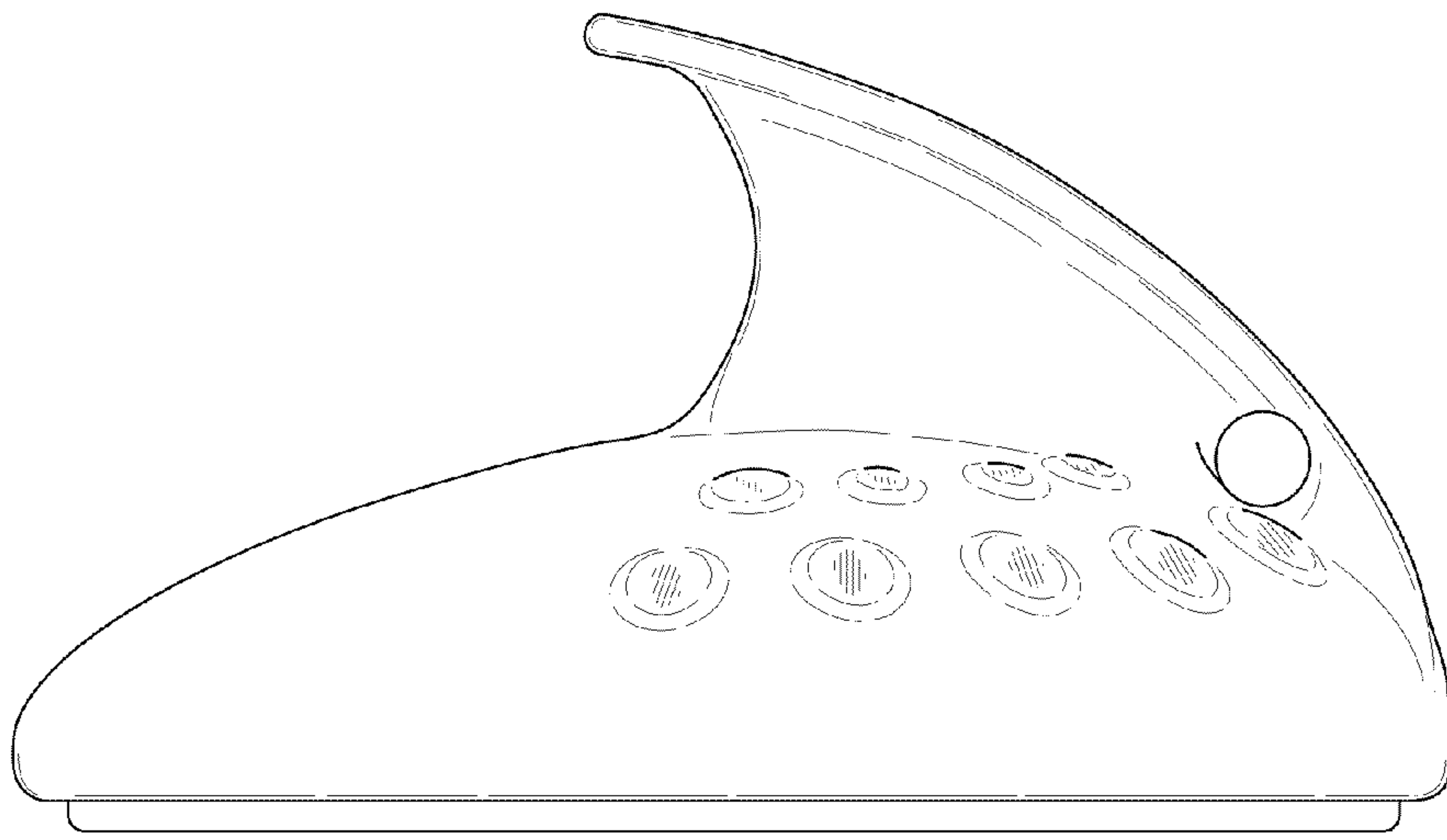

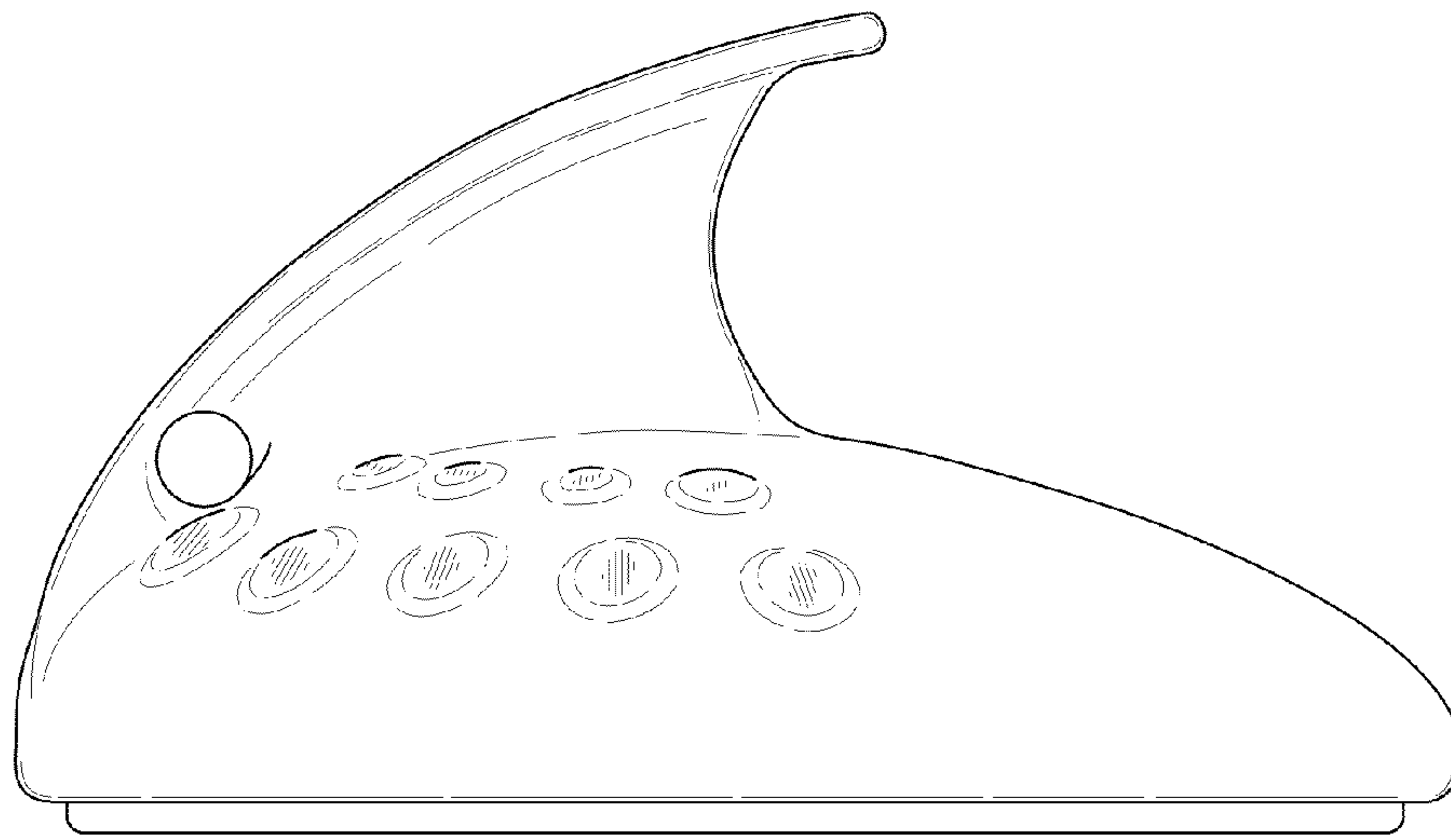

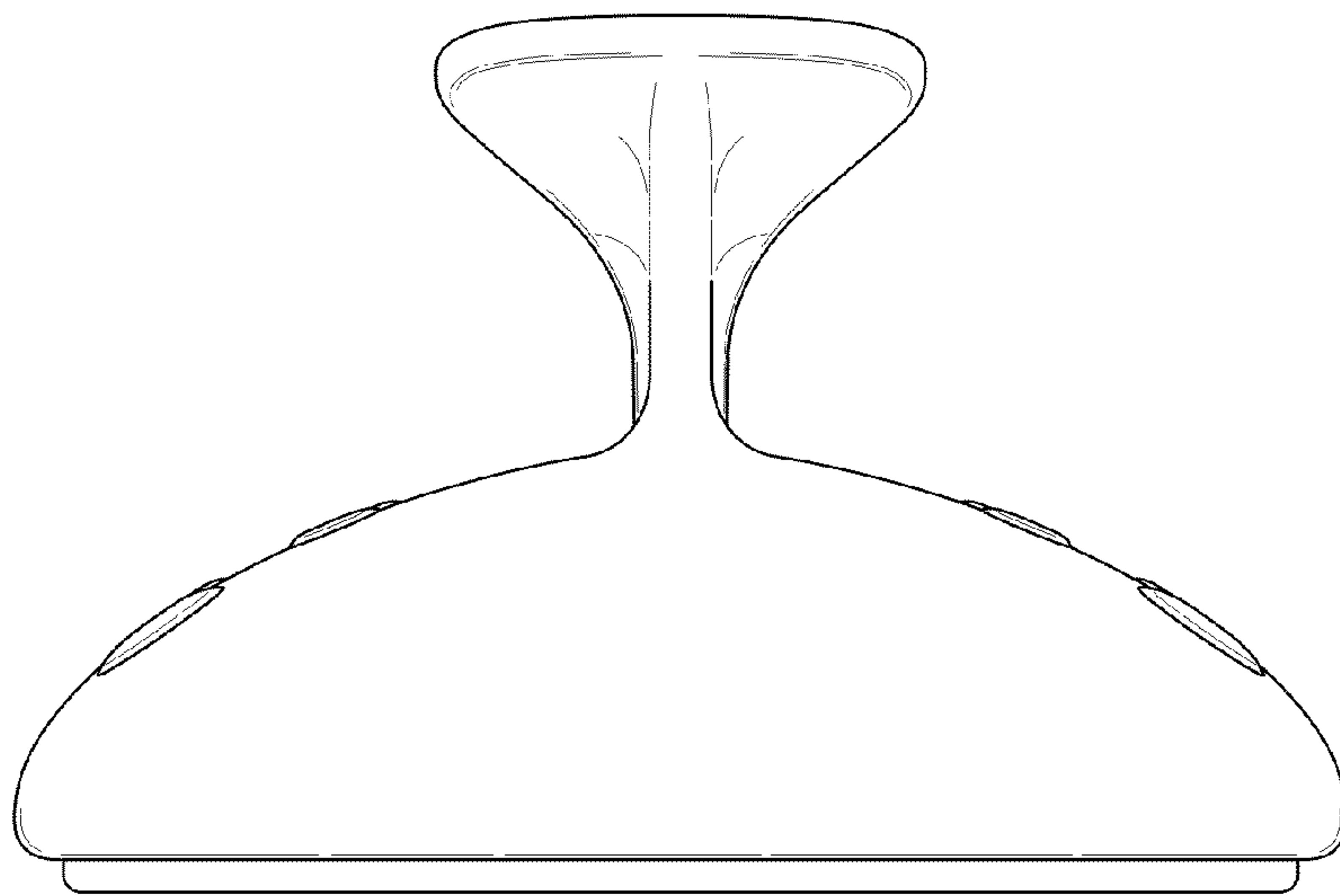

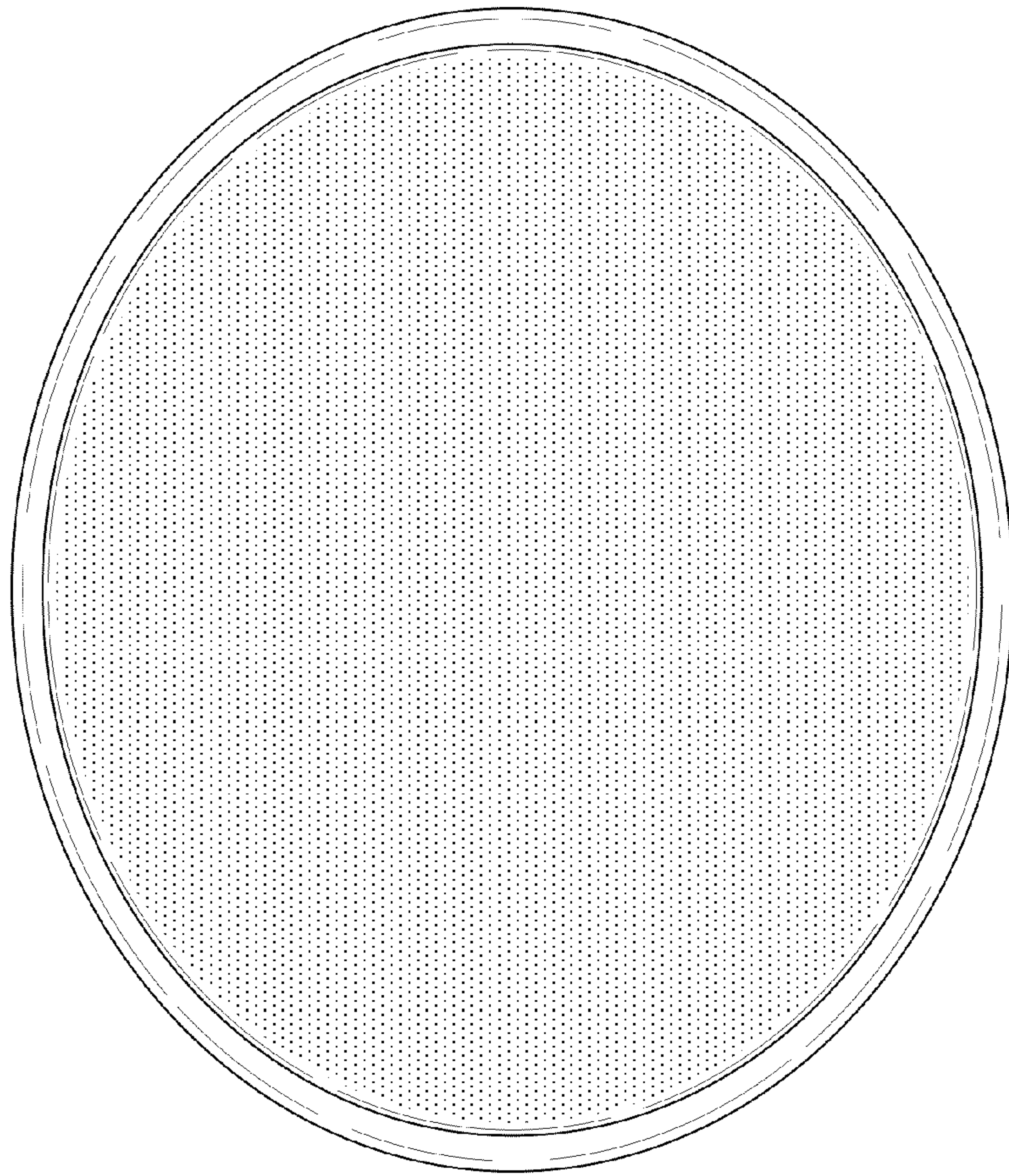
