The opposite rear view is a mirror image thereof.

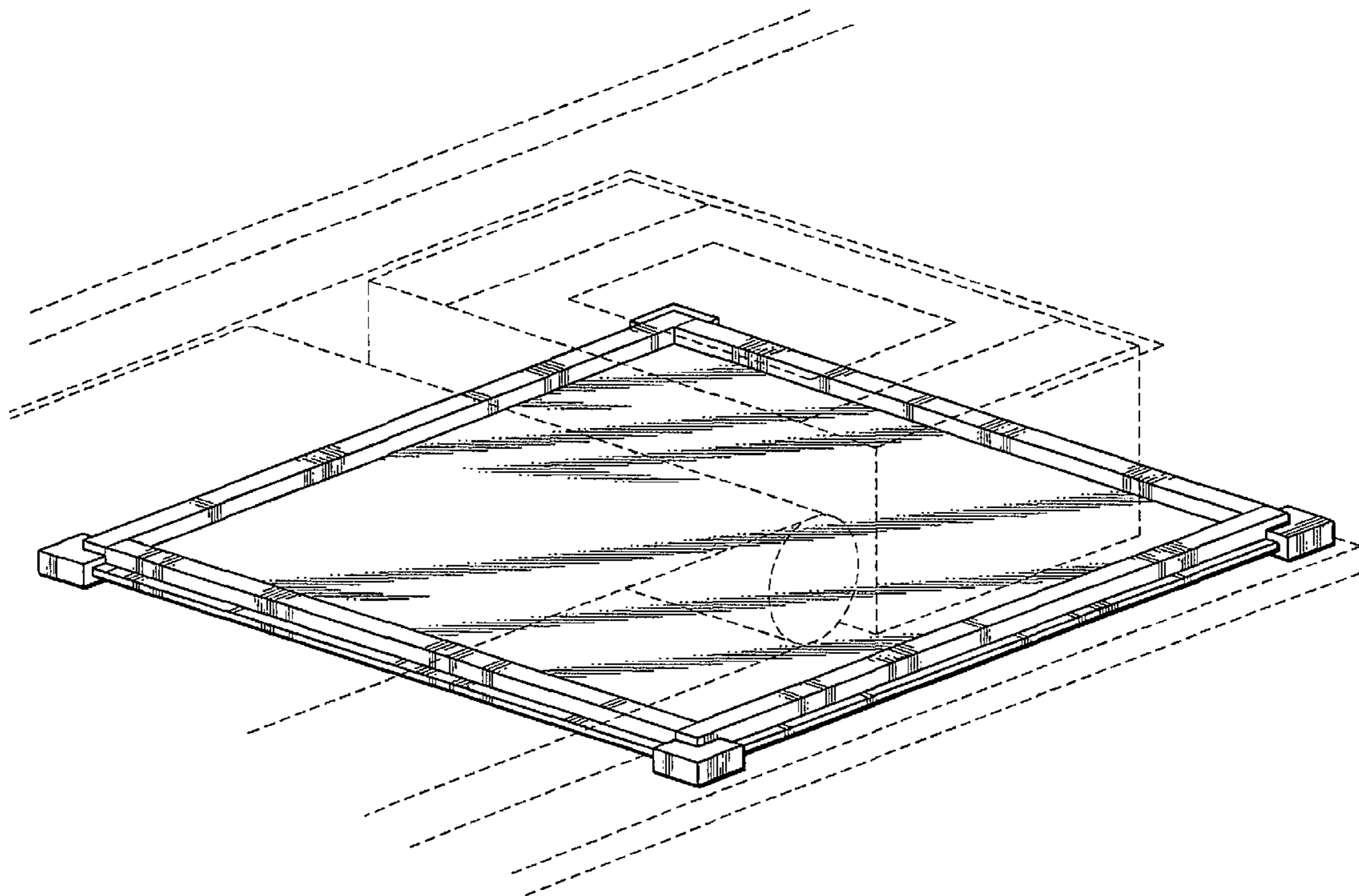
FIG. 4 is a side elevational view thereof.

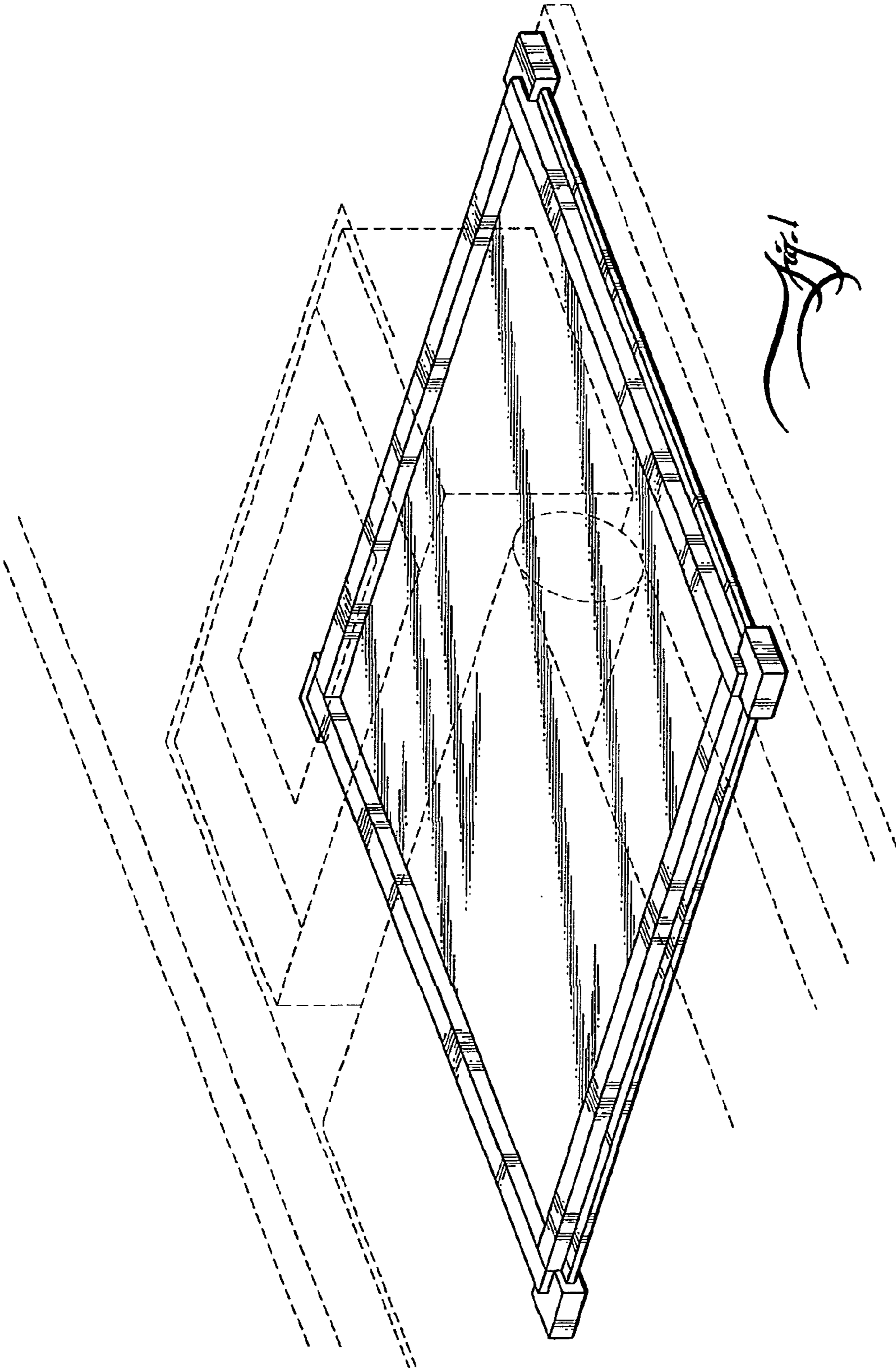
The opposite side view is a mirror image thereof; and,

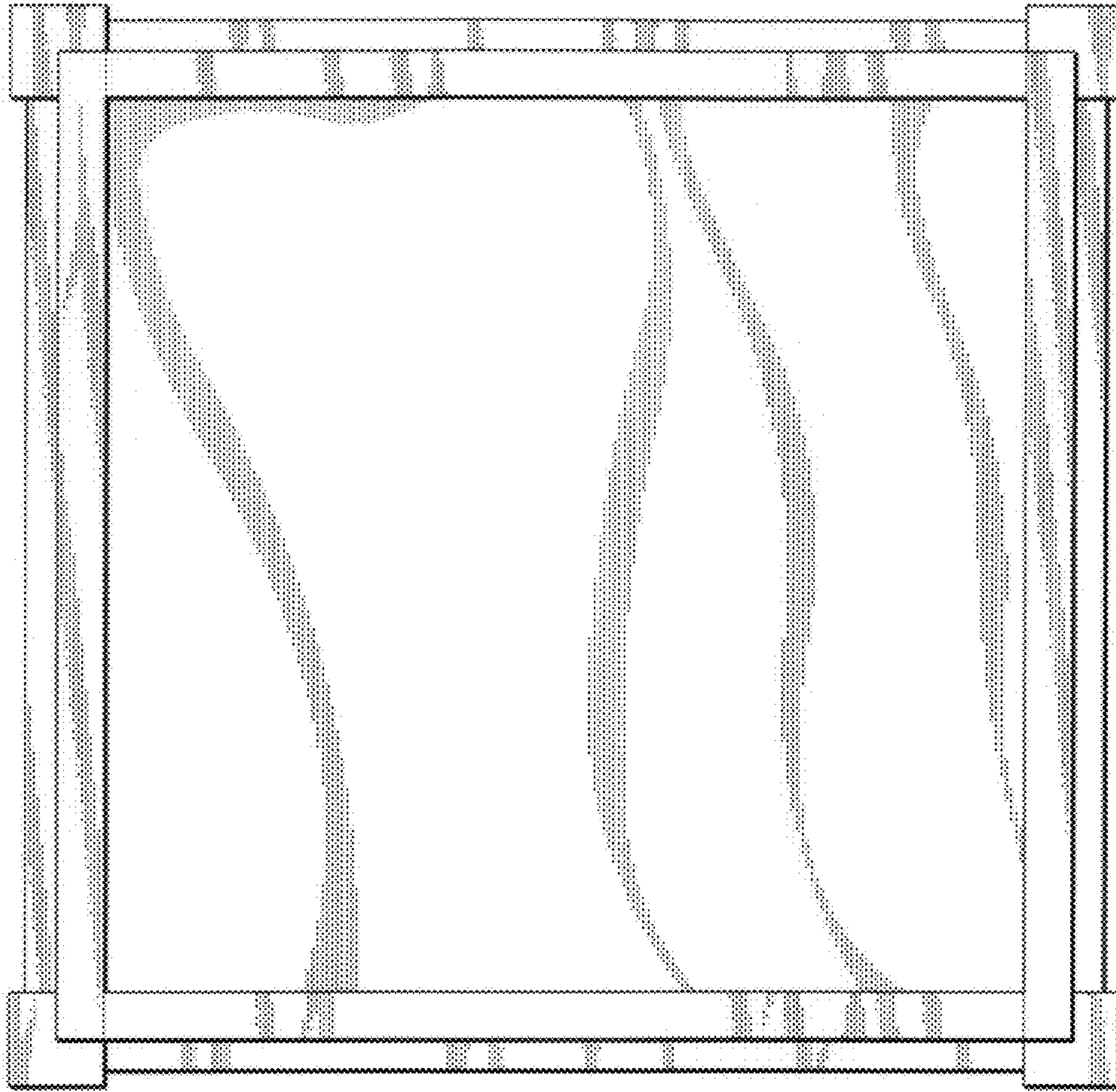

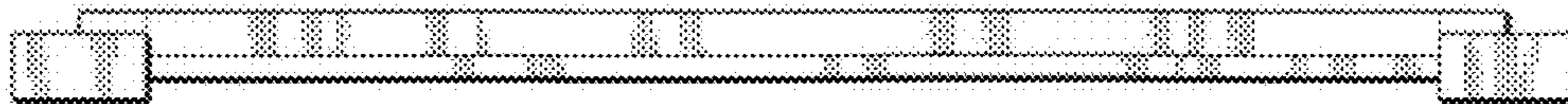

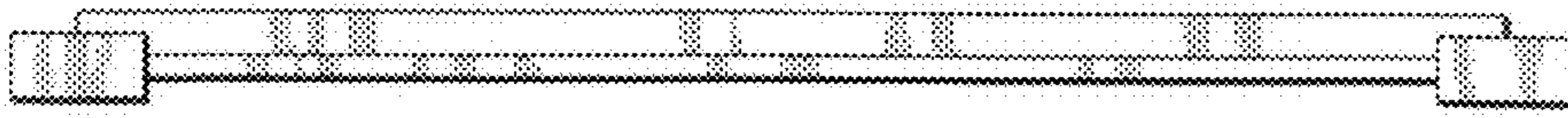

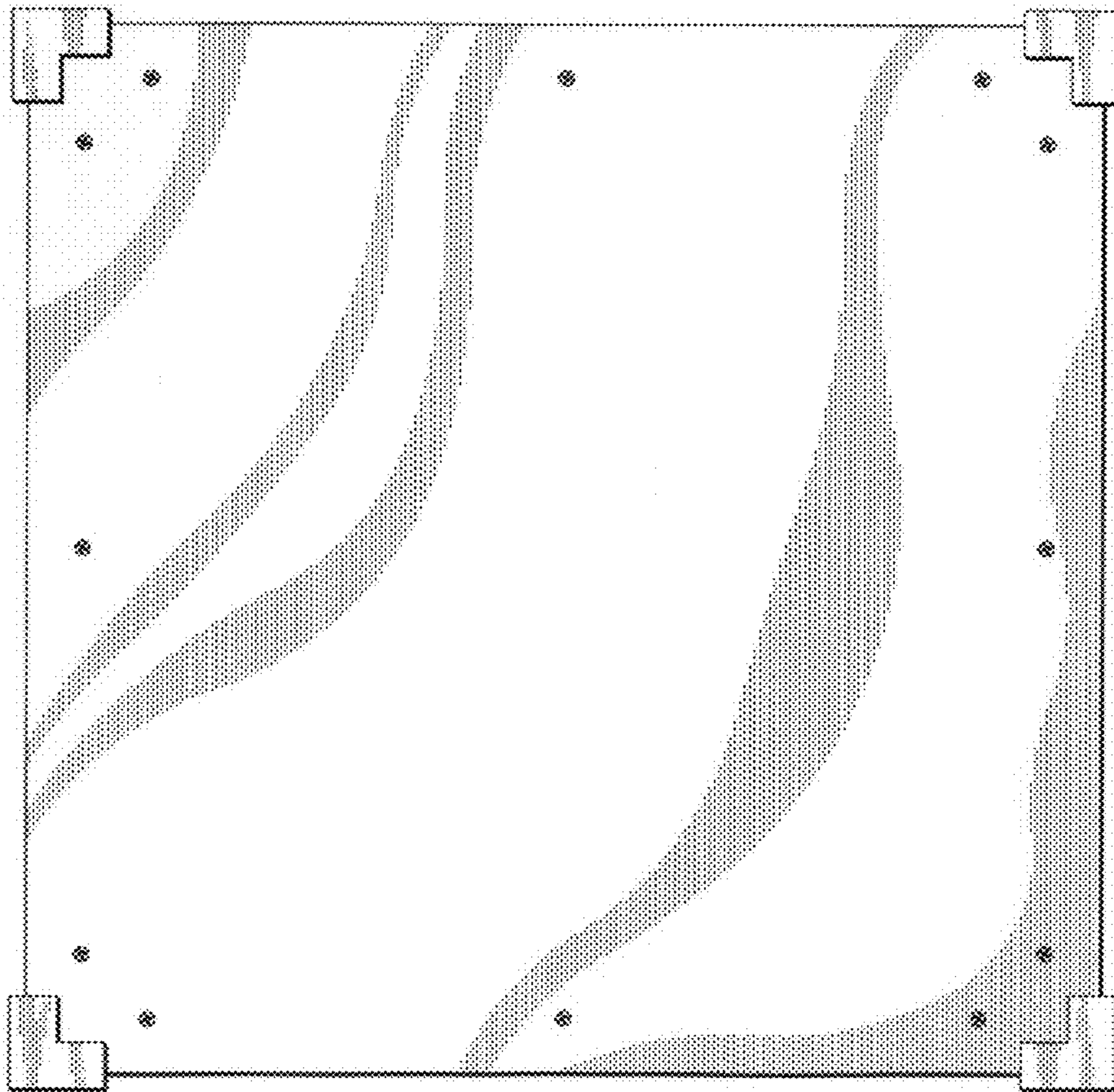
