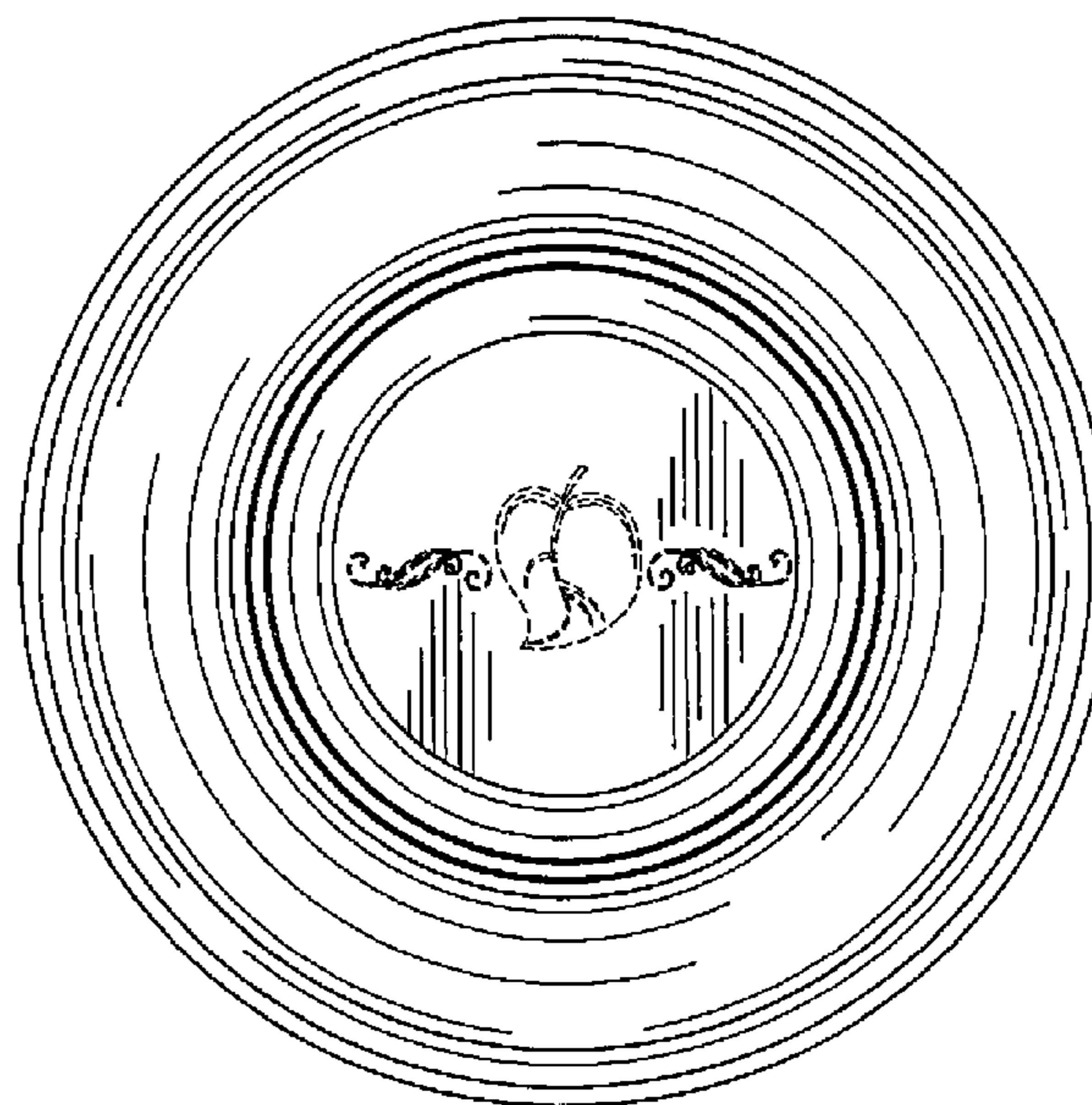
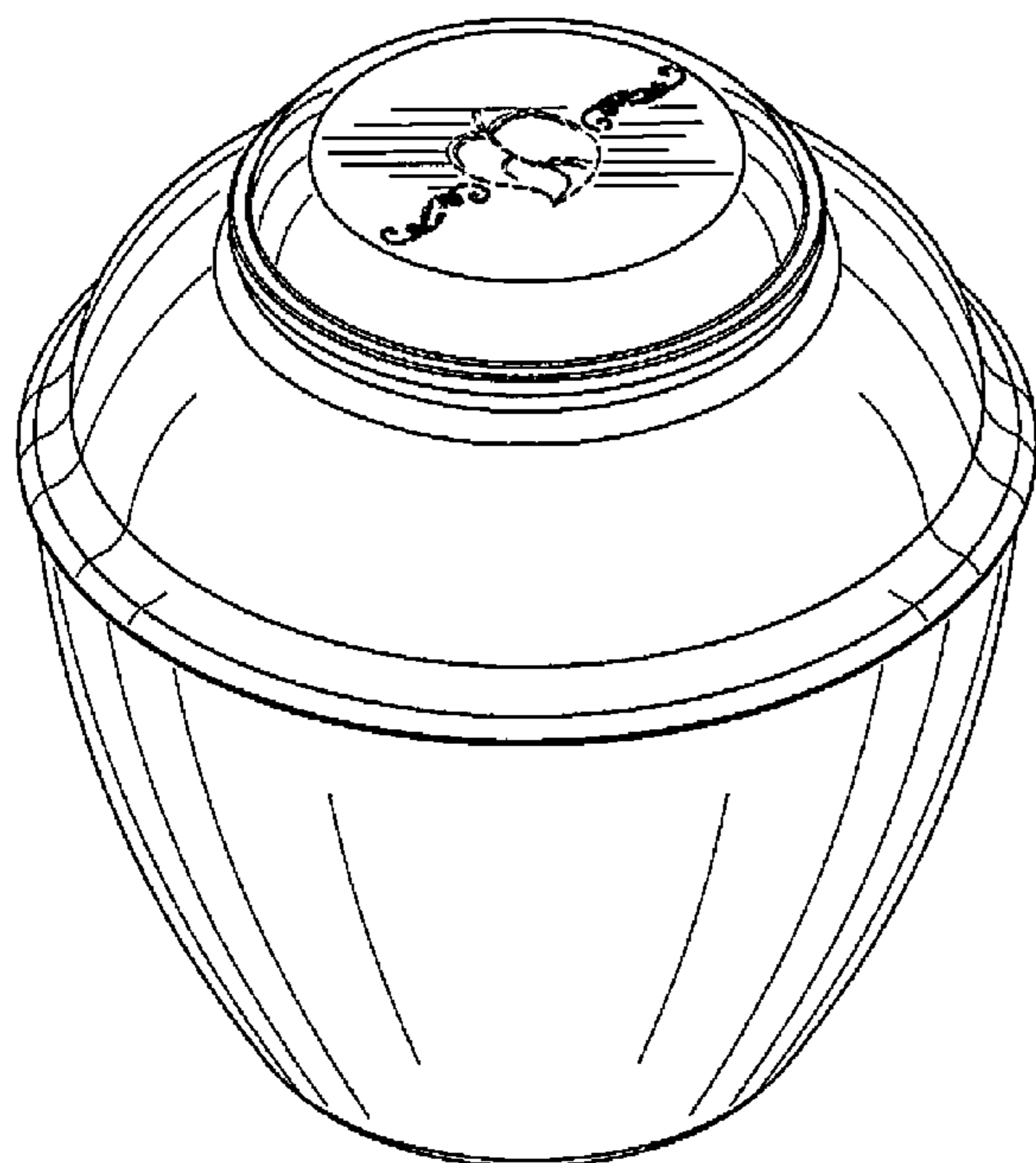
The ornamental design for a pet cremation urn, as shown and described.

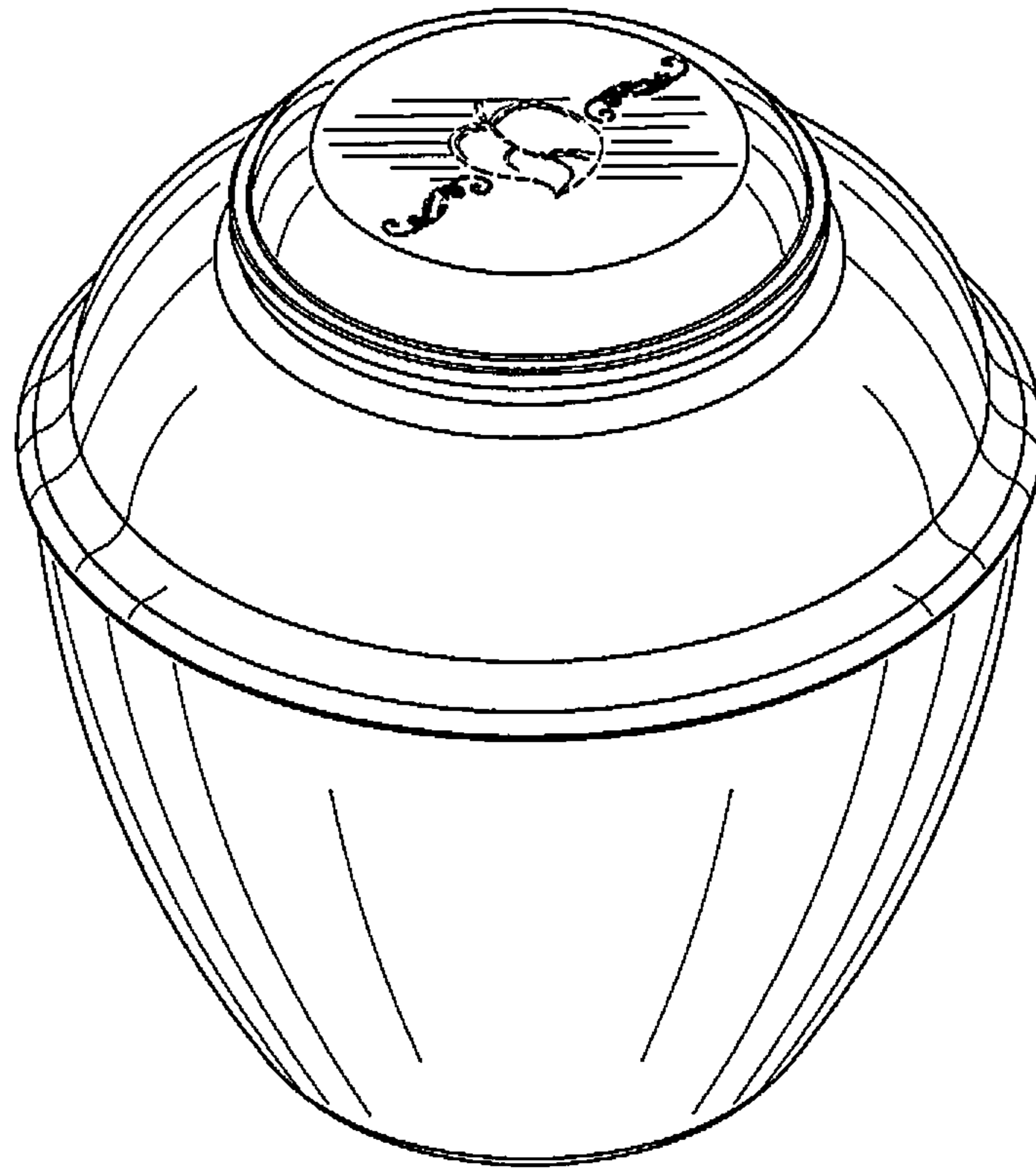

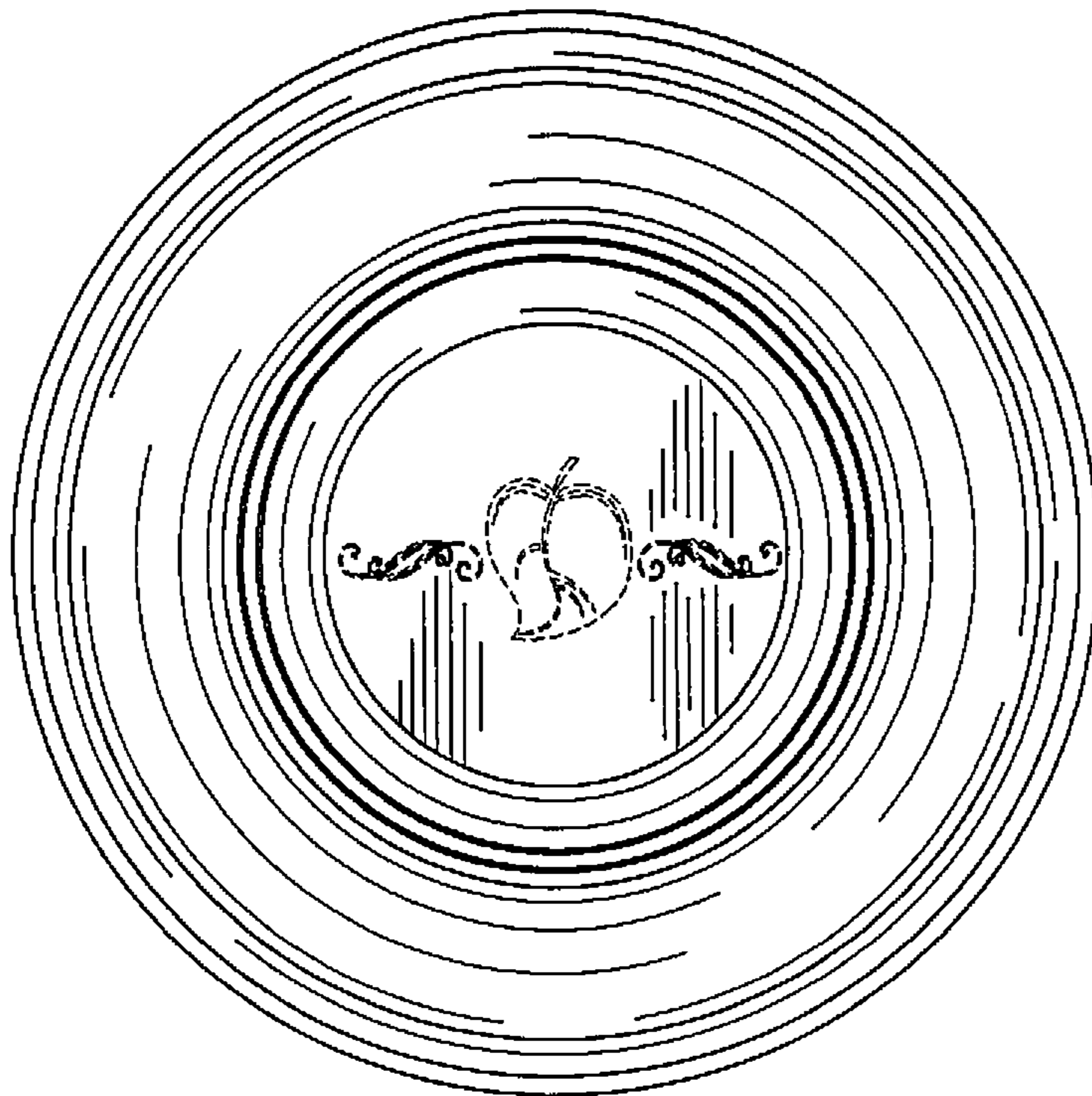

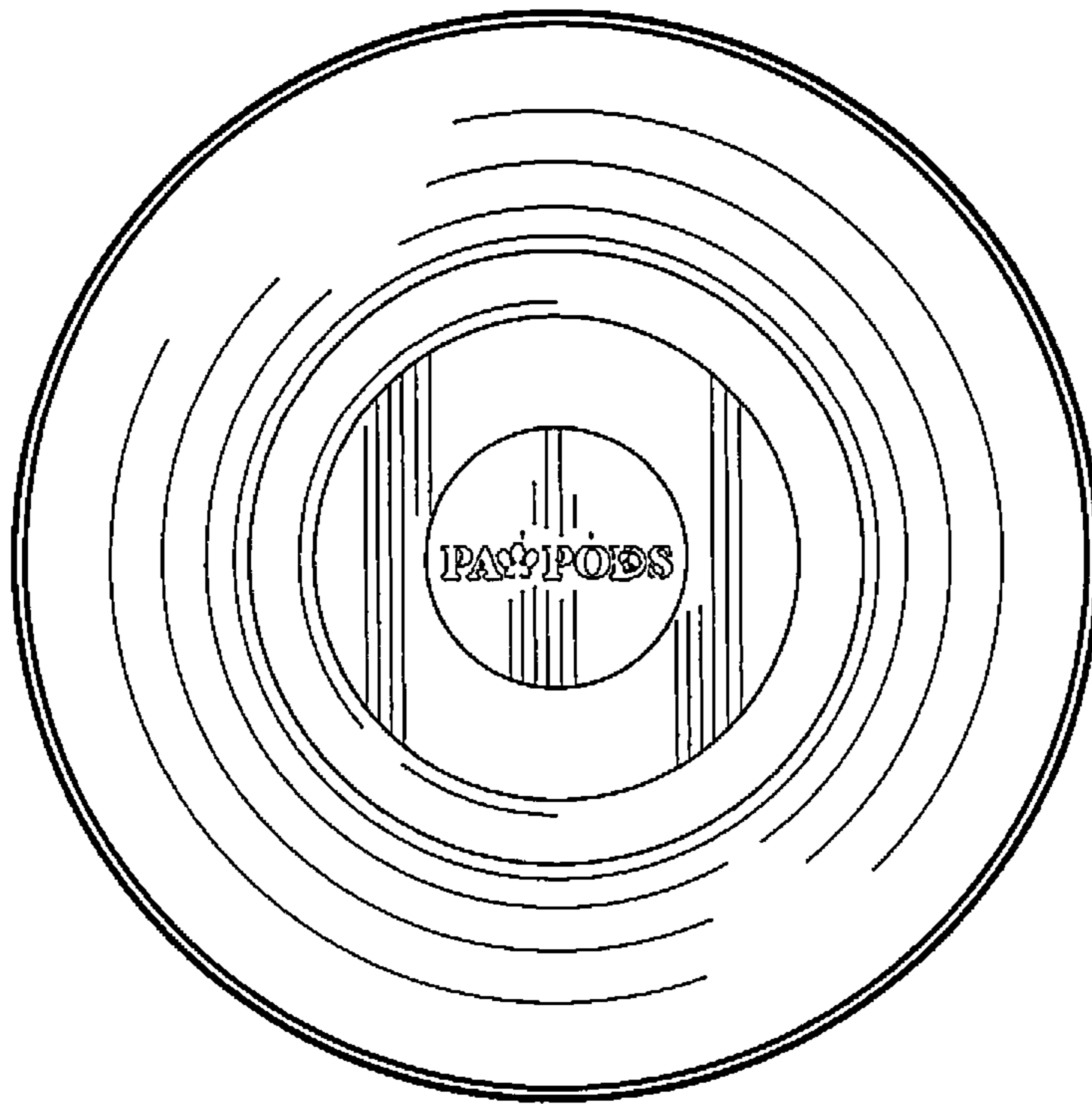
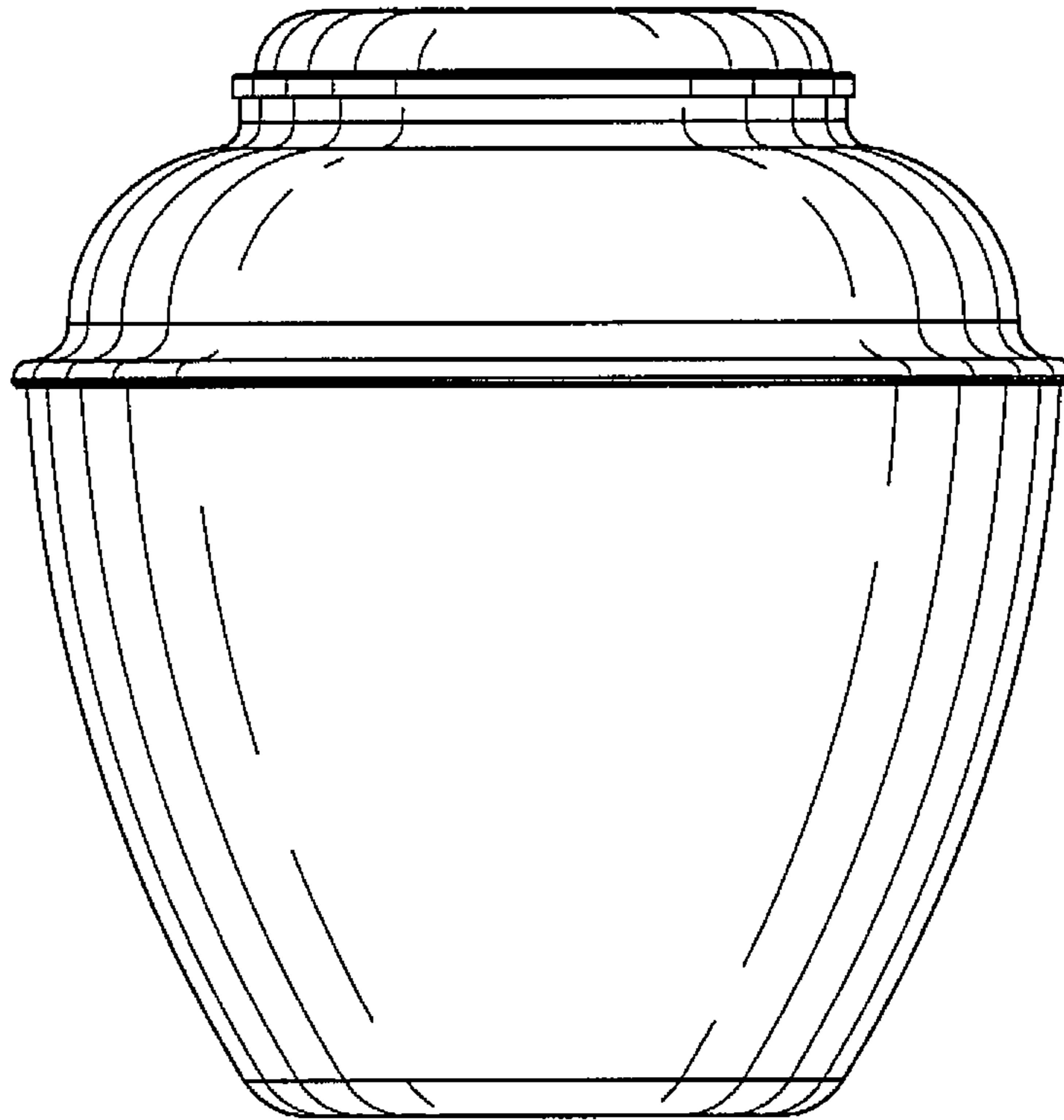
