(57) **CLAIM**

The ornamental design for trousers, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear/right side perspective view of a first embodiment of trousers, according to the invention;  
 FIG. 2 is a rear/left side perspective view thereof;  
 FIG. 3 is a rear view thereof;  
 FIG. 4 is a right side view thereof;  
 FIG. 5 is a left side view thereof;  
 FIG. 6 is a rear/right side perspective view of a second embodiment of trousers, according to the invention;  
 FIG. 7 is a rear/left side perspective view thereof;  
 FIG. 8 is a rear view thereof;  
 FIG. 9 is a right side view thereof;  
 FIG. 10 is a rear/right side perspective view of a third embodiment of trousers, according to the invention;  
 FIG. 11 is a rear/left side perspective view thereof;  
 FIG. 12 is a rear view thereof;  
 FIG. 13 is a left side view thereof; and,  
 FIG. 14 is an enlarged detail view of the stitching feature of a pocket of FIG. 1. The stitching features of the pockets in the other Figures correspond to the stitching features illustrated in FIG. 14.

The broken line showing of trousers is for the purpose of illustrating environmental structure that forms no part of the claimed design.

The broken line showing of stitching on the pockets forms a part of the claimed design.

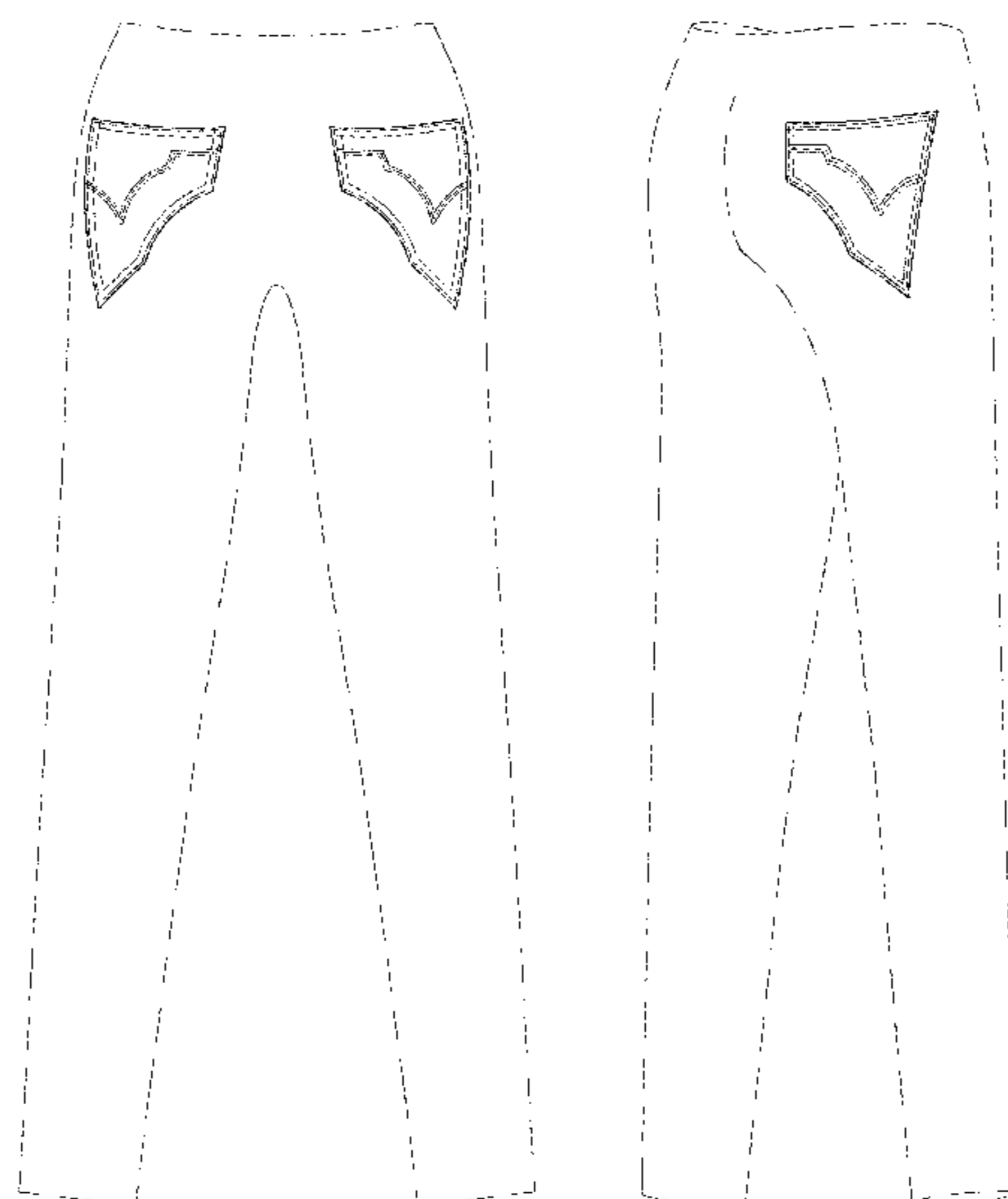

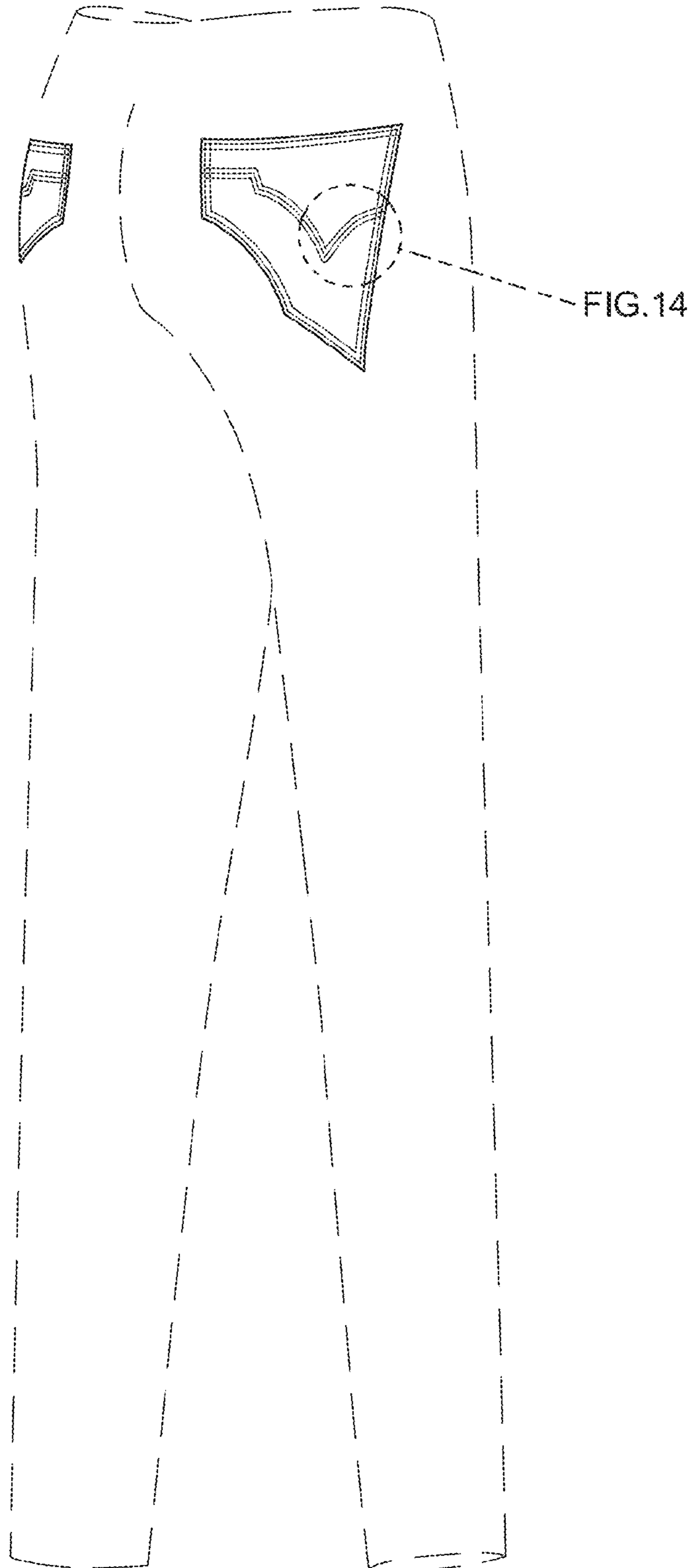

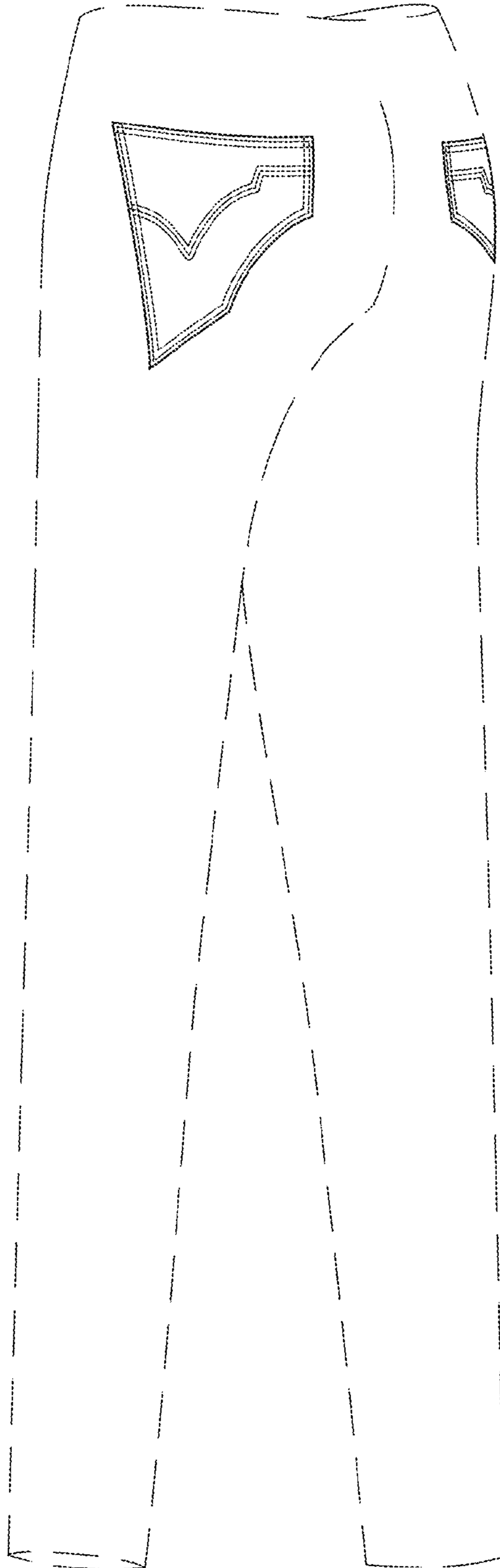

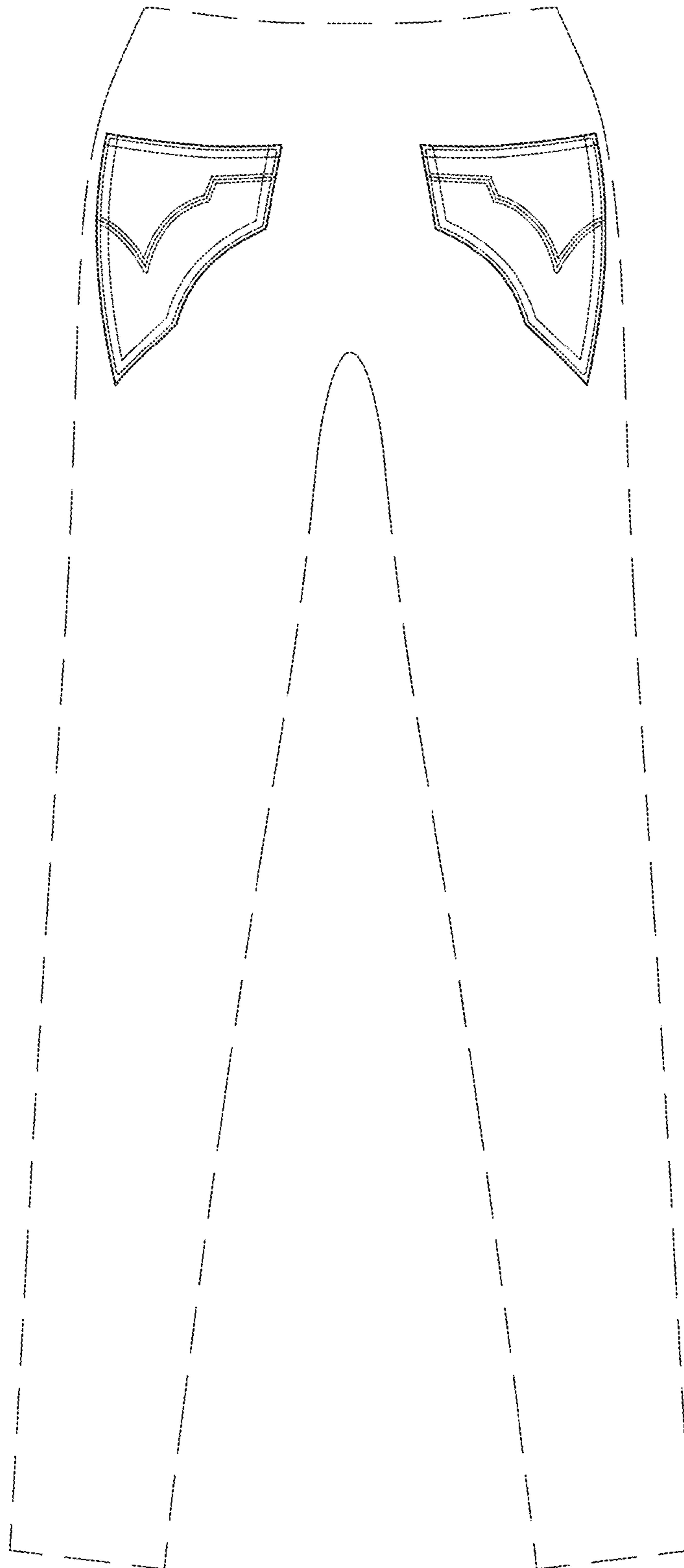

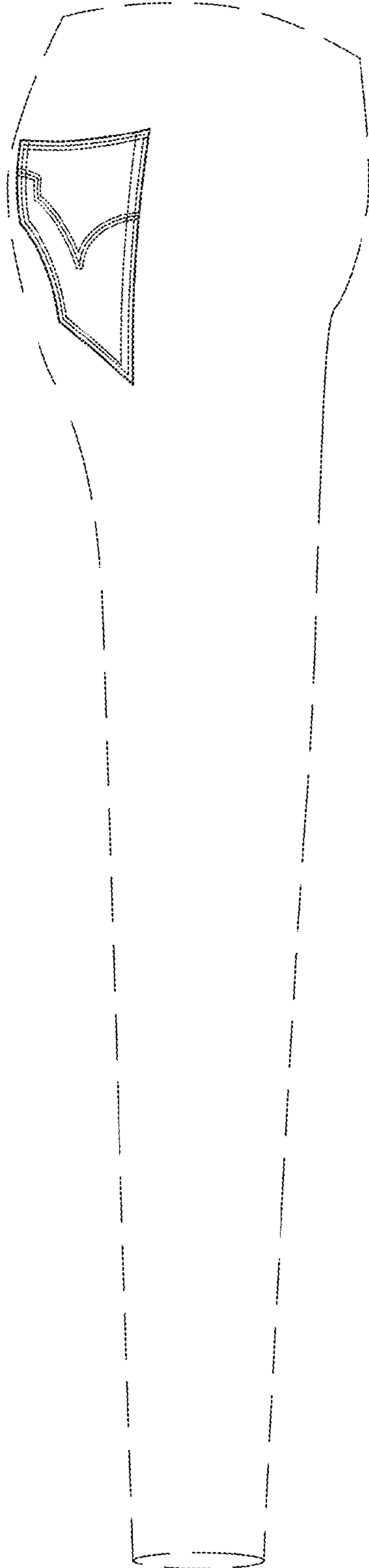

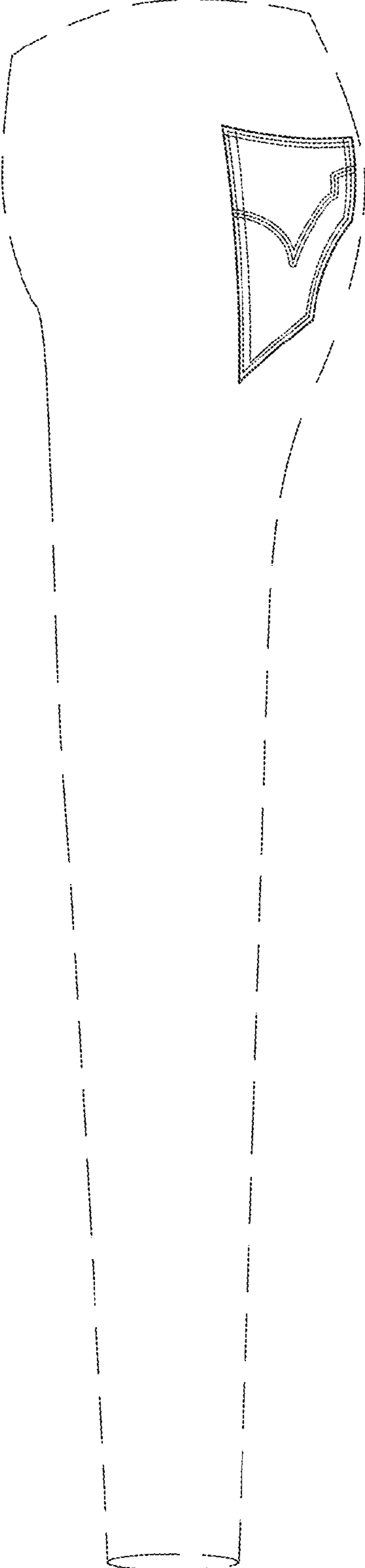

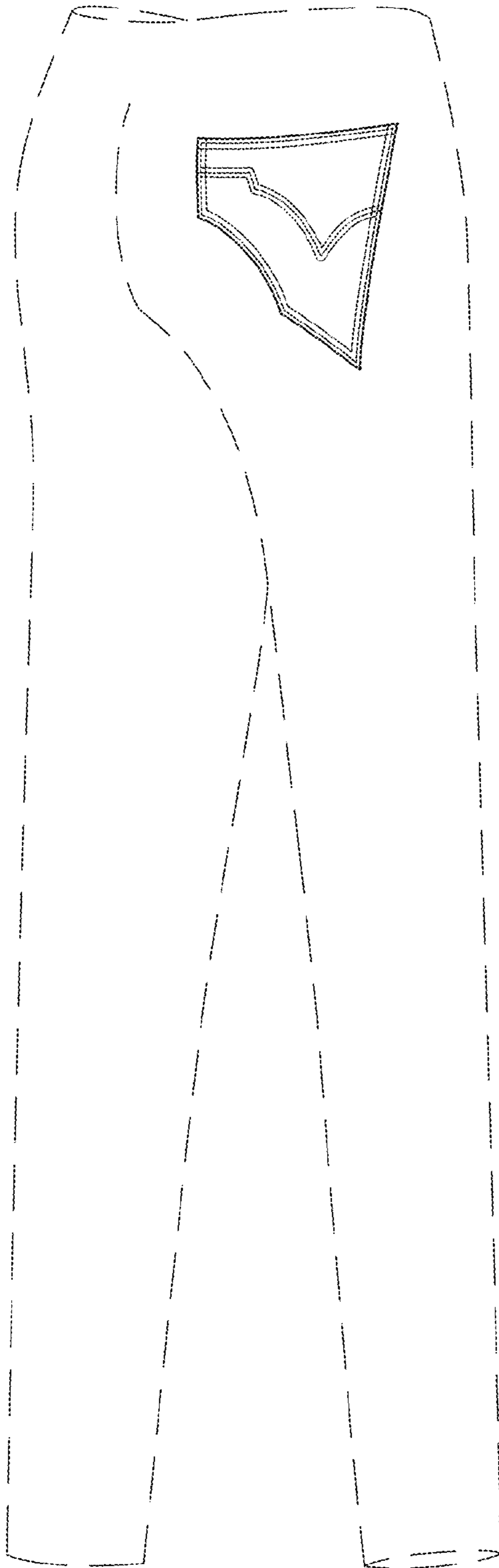

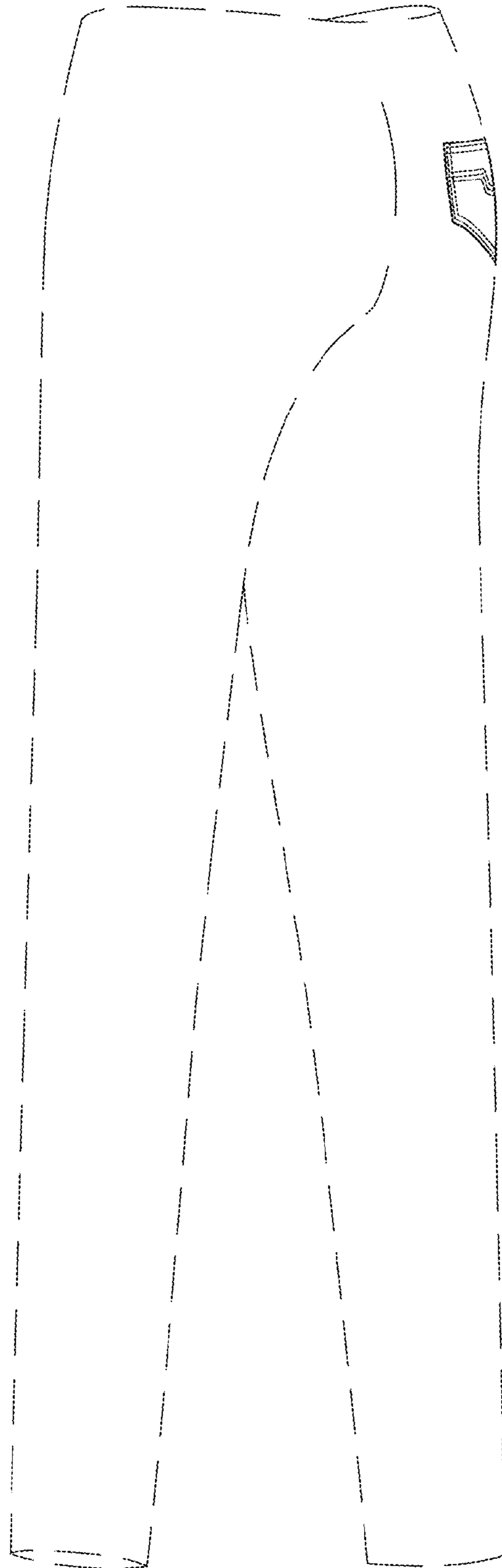

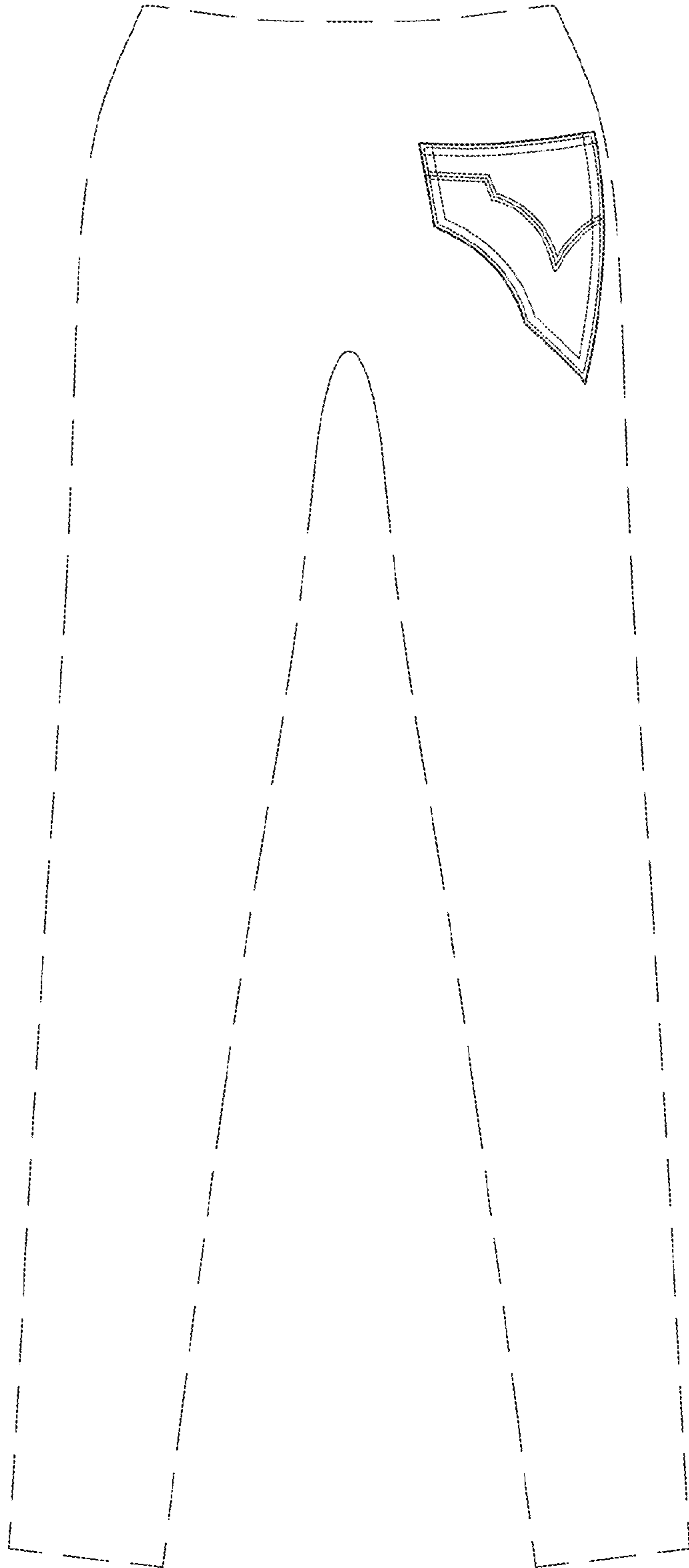

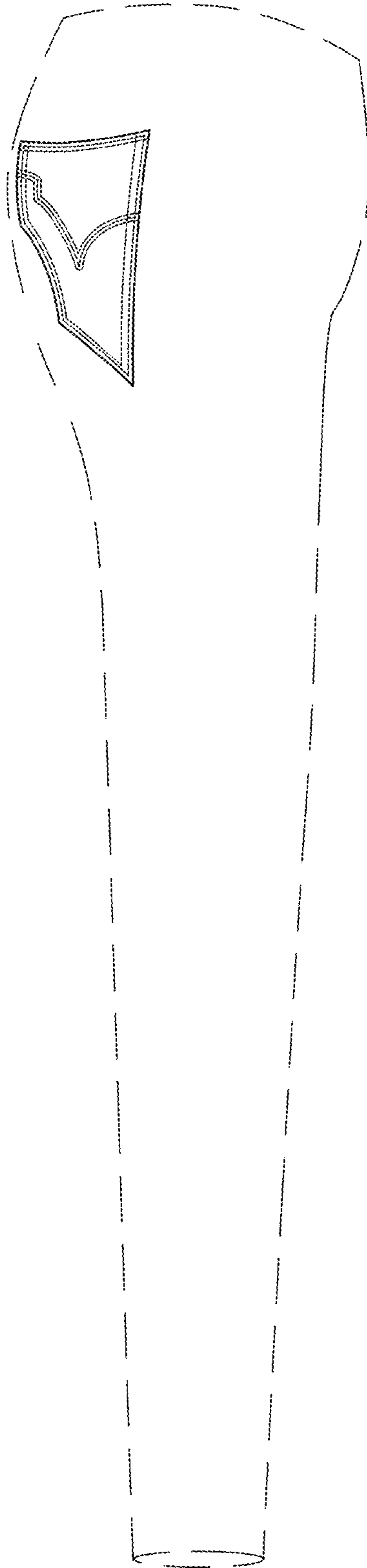

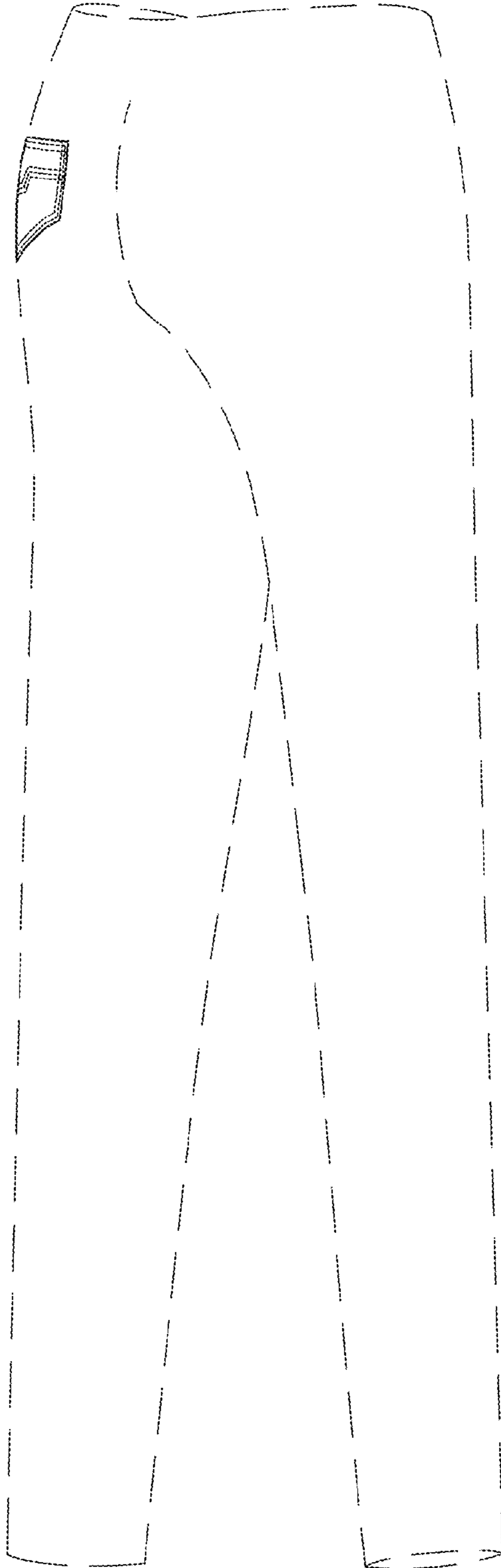

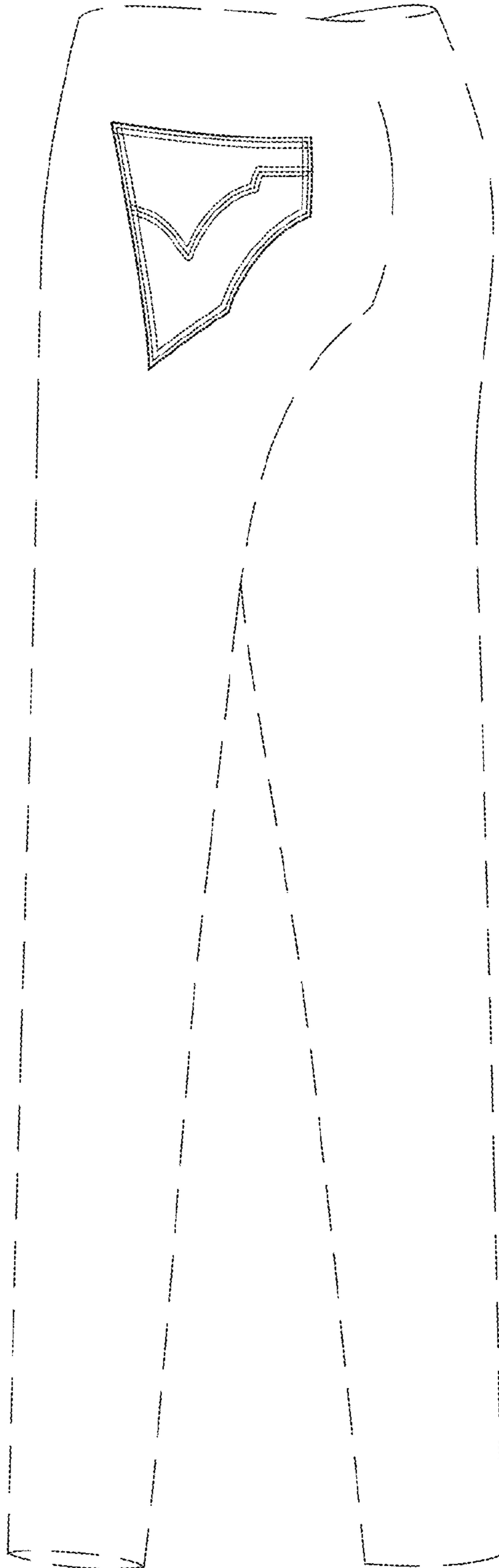

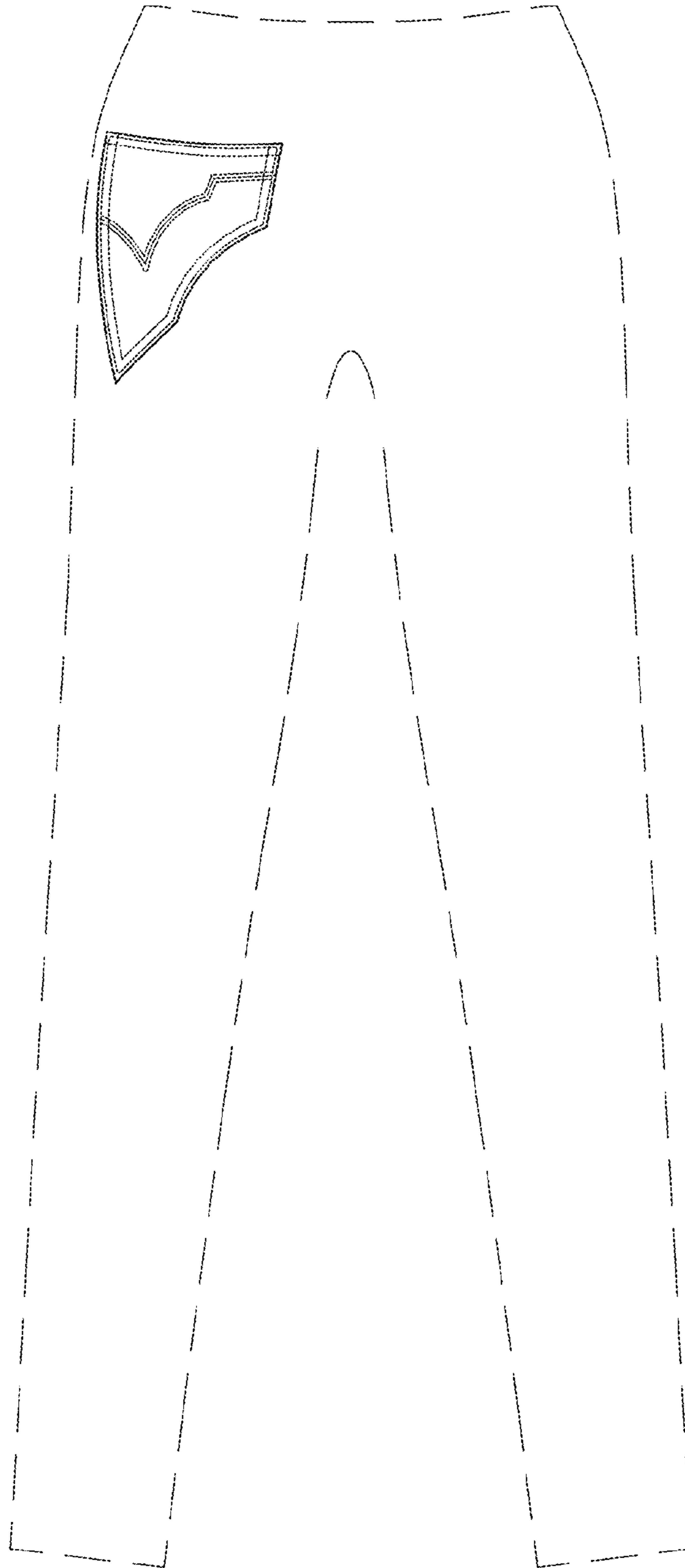

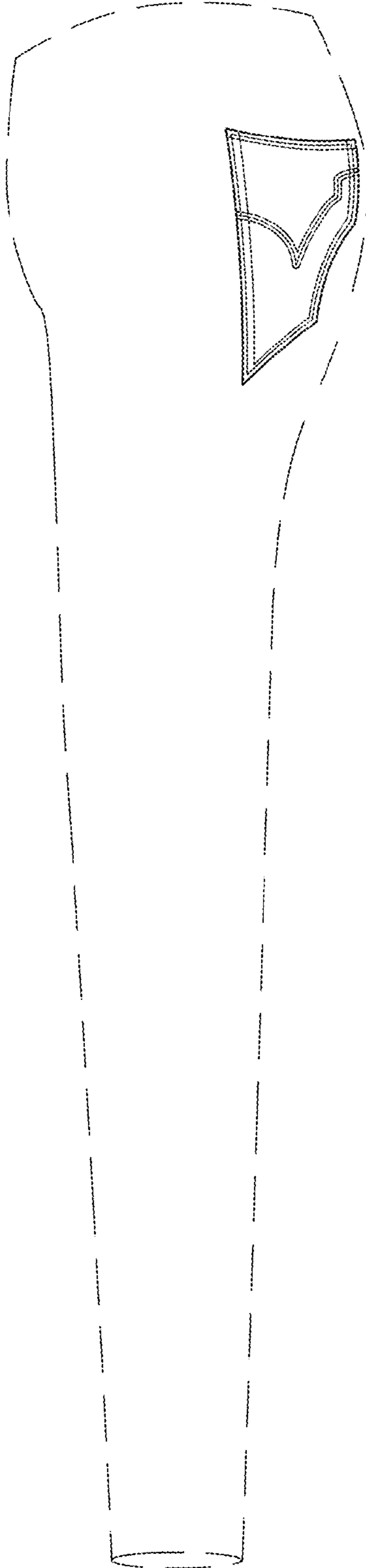
