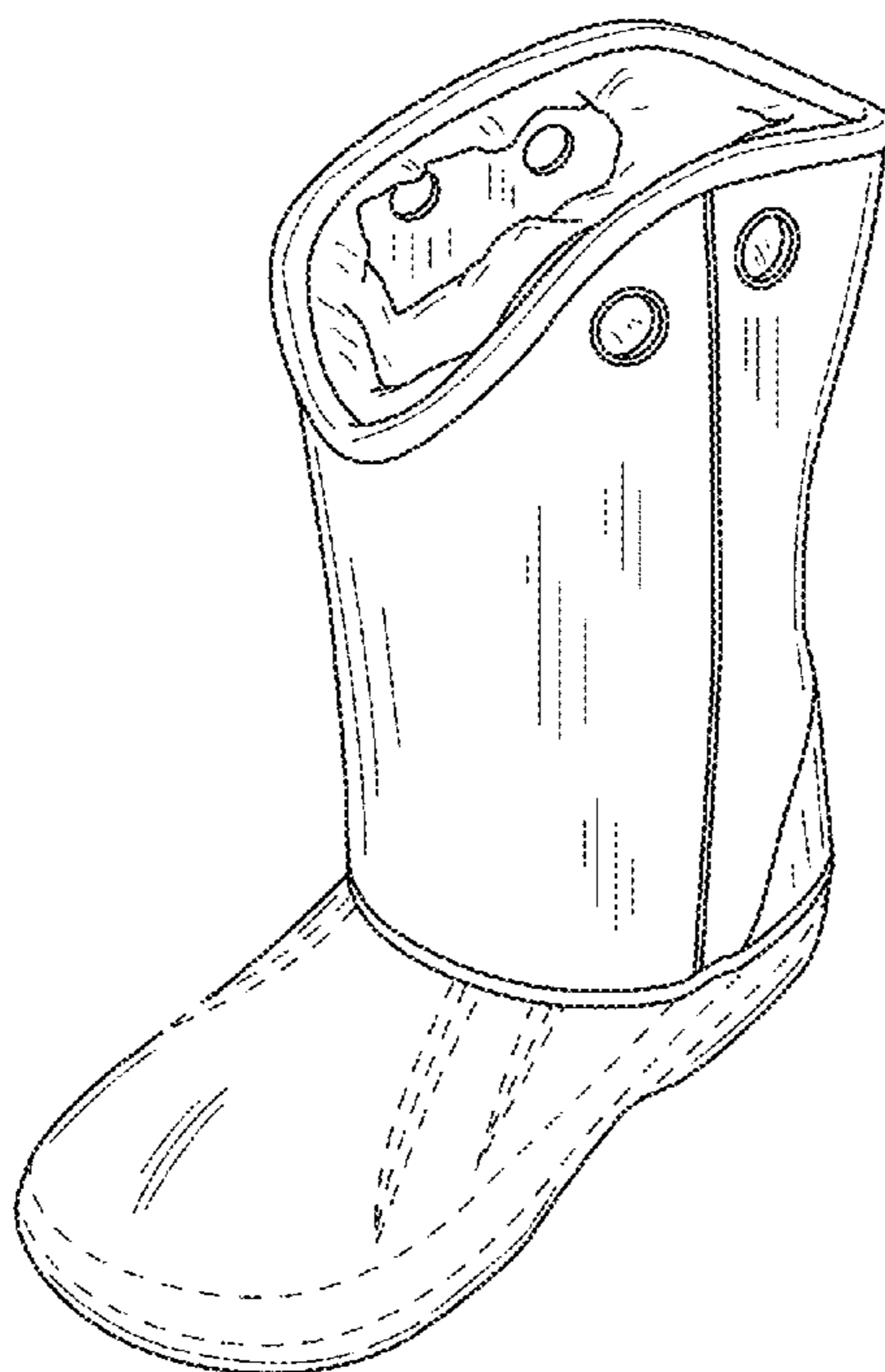

The ornamental design for a boot, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the boot showing the new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a right elevation view thereof;
FIG. 5 is a left elevation view thereof; and,
FIG. 6 is a top plan view thereof.
The structural features depicted by broken lines have been provided for the purpose of illustrating portions of the boot that form no part of the claimed design.

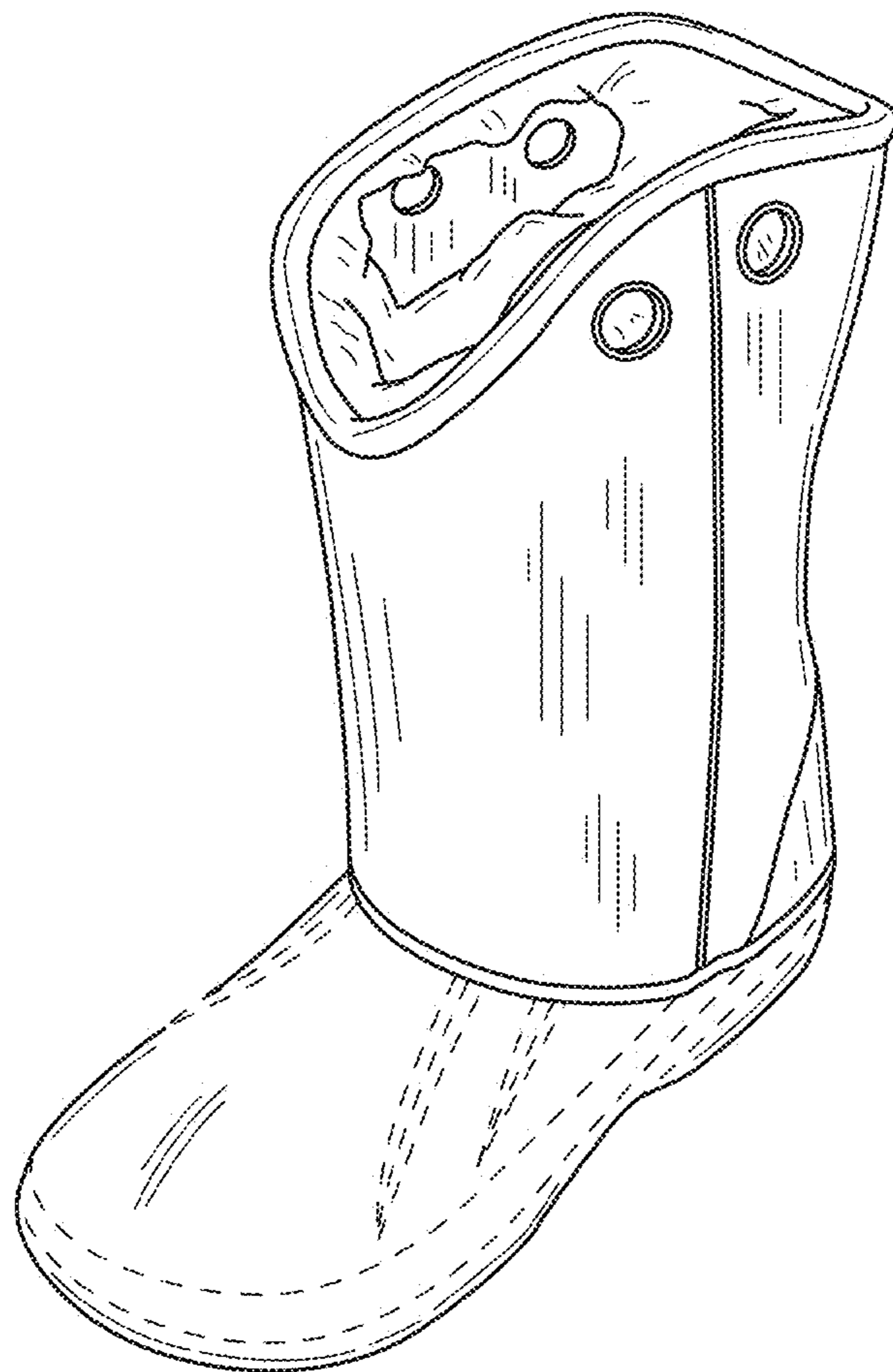

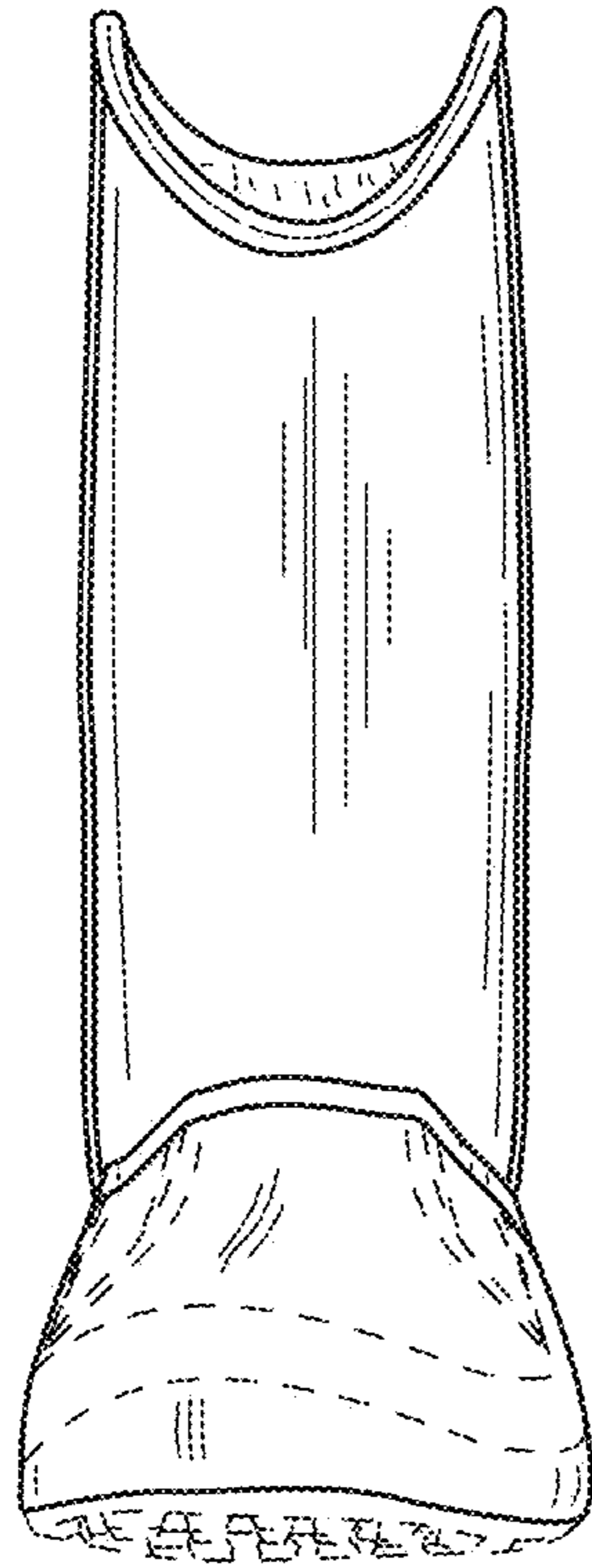

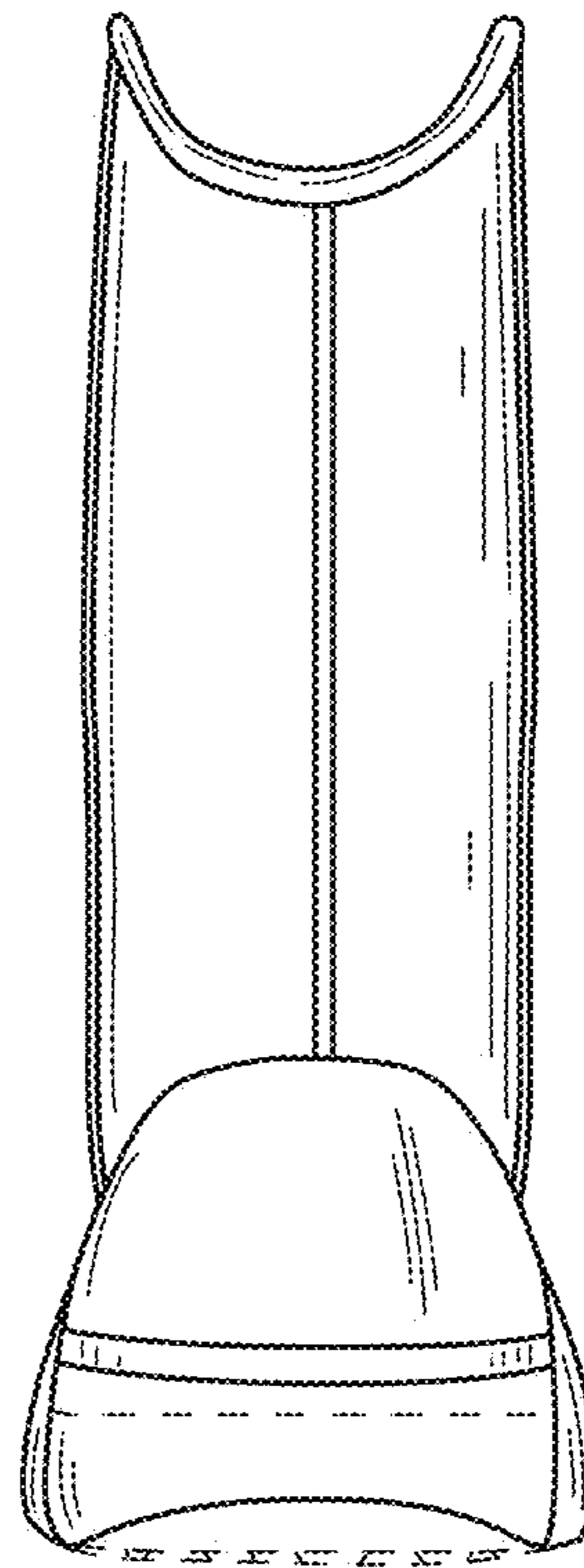

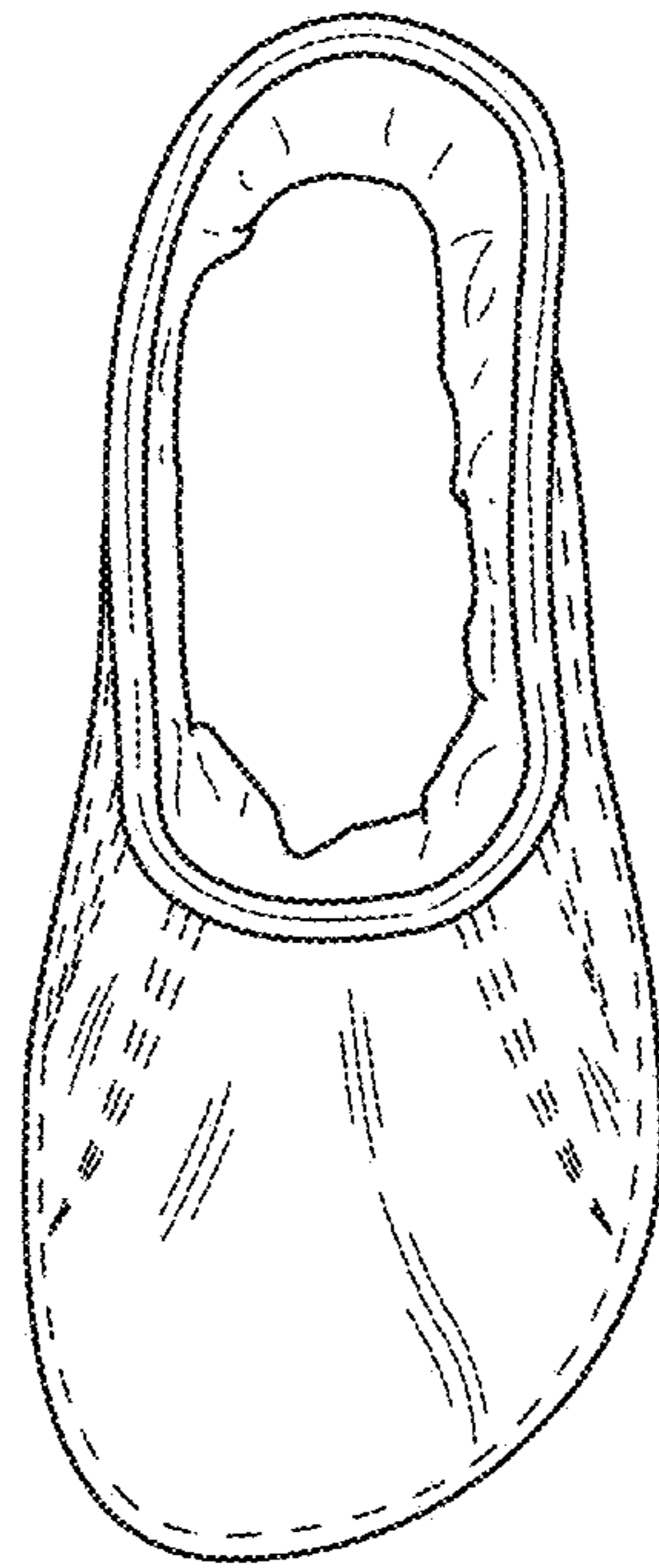
