(57) **CLAIM**

We claim the ornamental design for a golf shoe outsole, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a golf shoe outsole as viewed from the front and one side thereof, according to an embodiment of the design;

FIG. 2 is a front elevation view of the golf shoe outsole of FIG. 1.

FIG. 3 is a rear elevation view of the golf shoe outsole of FIG. 1.

FIG. 4 is a side elevation view of the golf shoe outsole of FIG. 1.

FIG. 5 is a side elevation view of the golf shoe outsole of FIG. 1, from the side opposite FIG. 4.

FIG. 6 is a top plan view of the golf shoe outsole of FIG. 1; and,

FIG. 7 is a bottom plan view of the golf shoe outsole of FIG. 1.

The dashed lines in the drawings are for purposes of illustrating environmental structure as well as portions of the design that form no part of the claimed design.

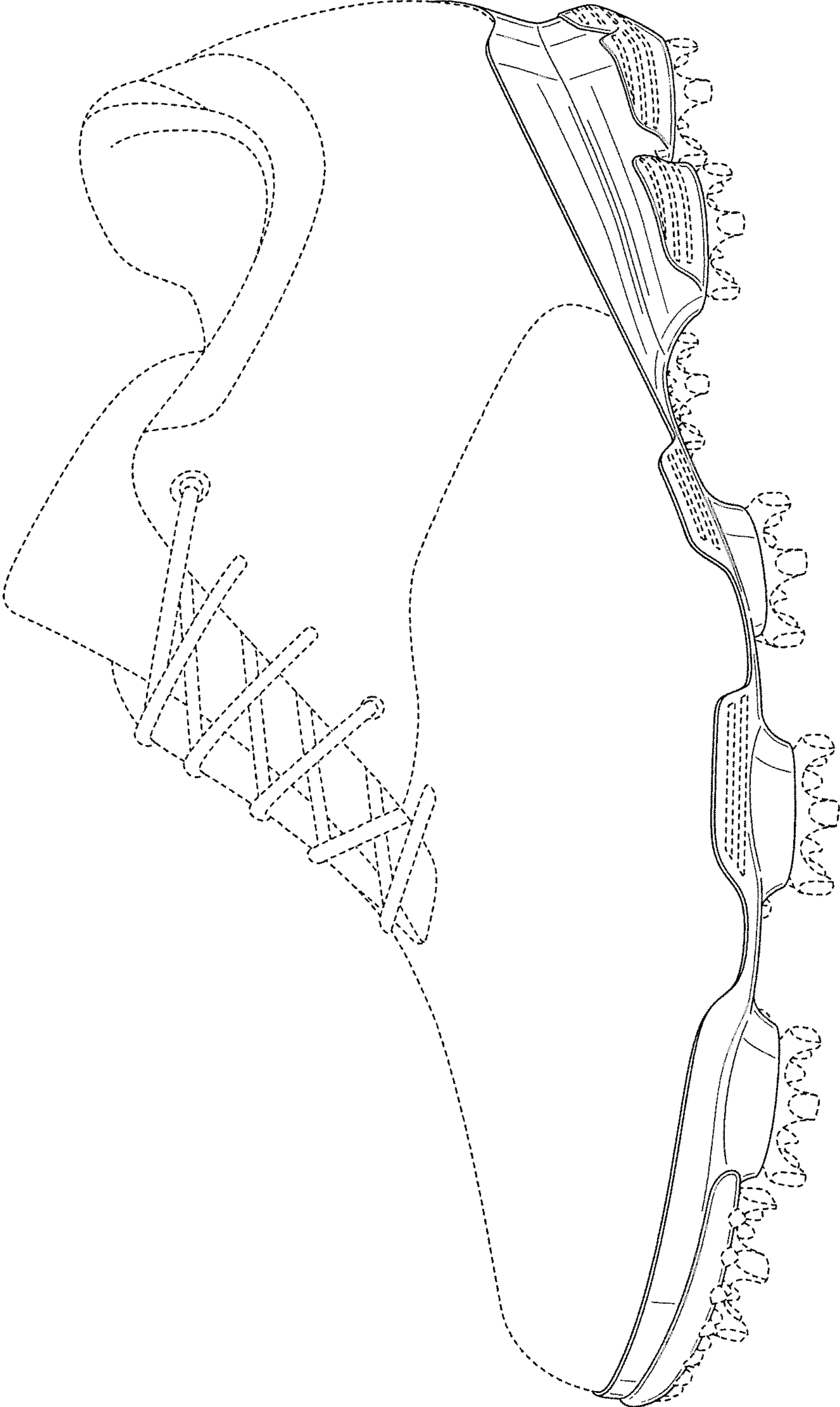

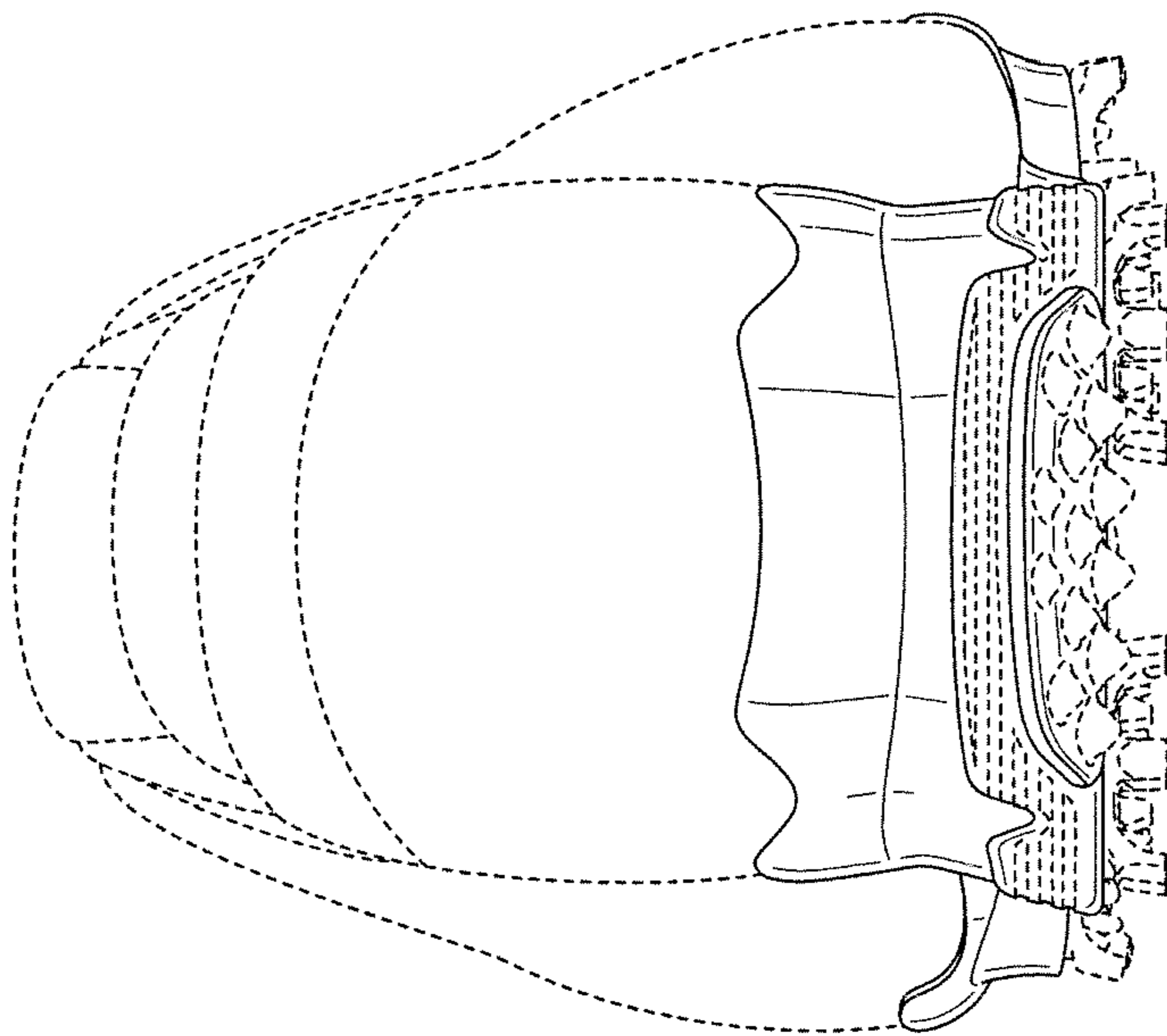

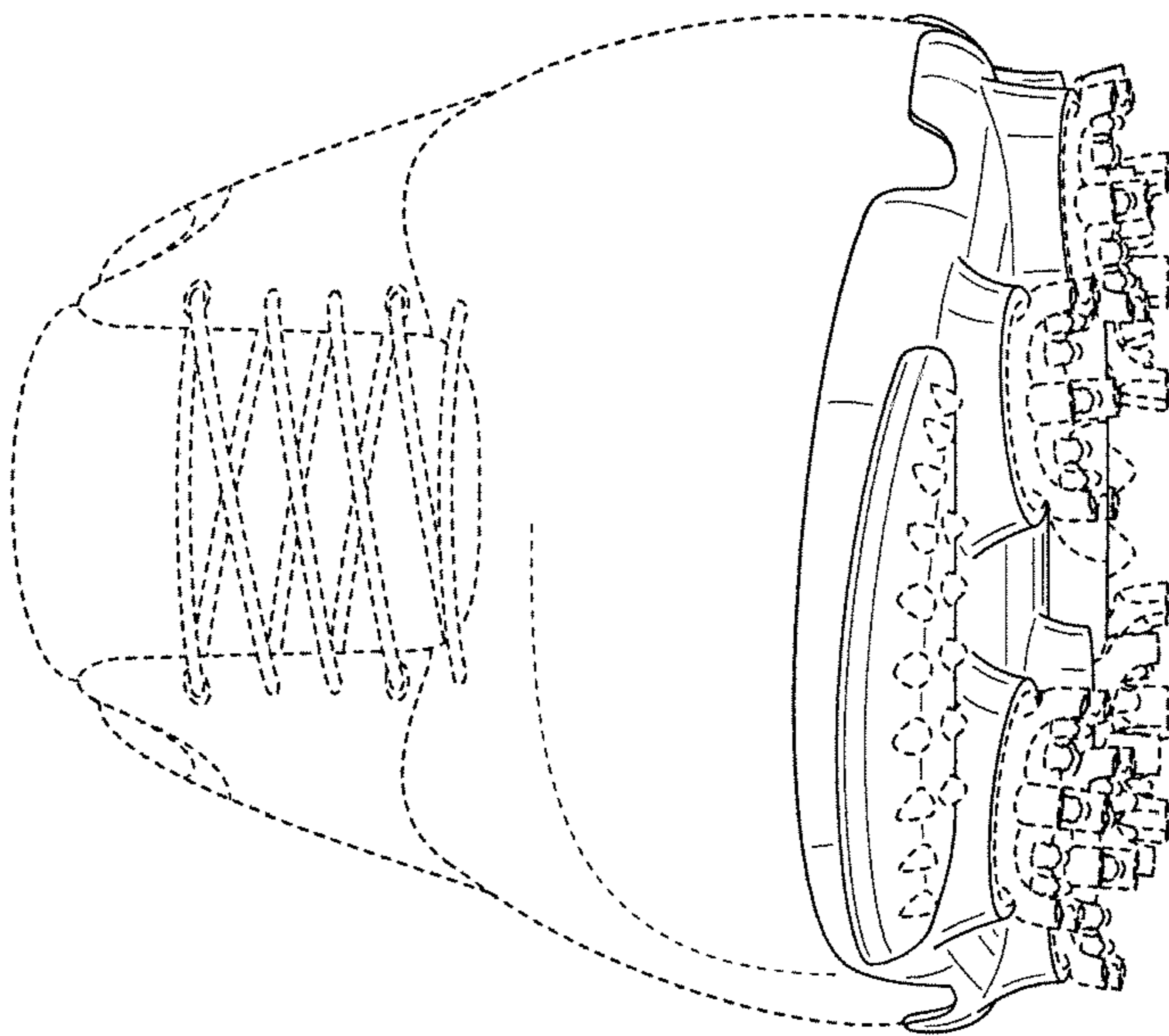

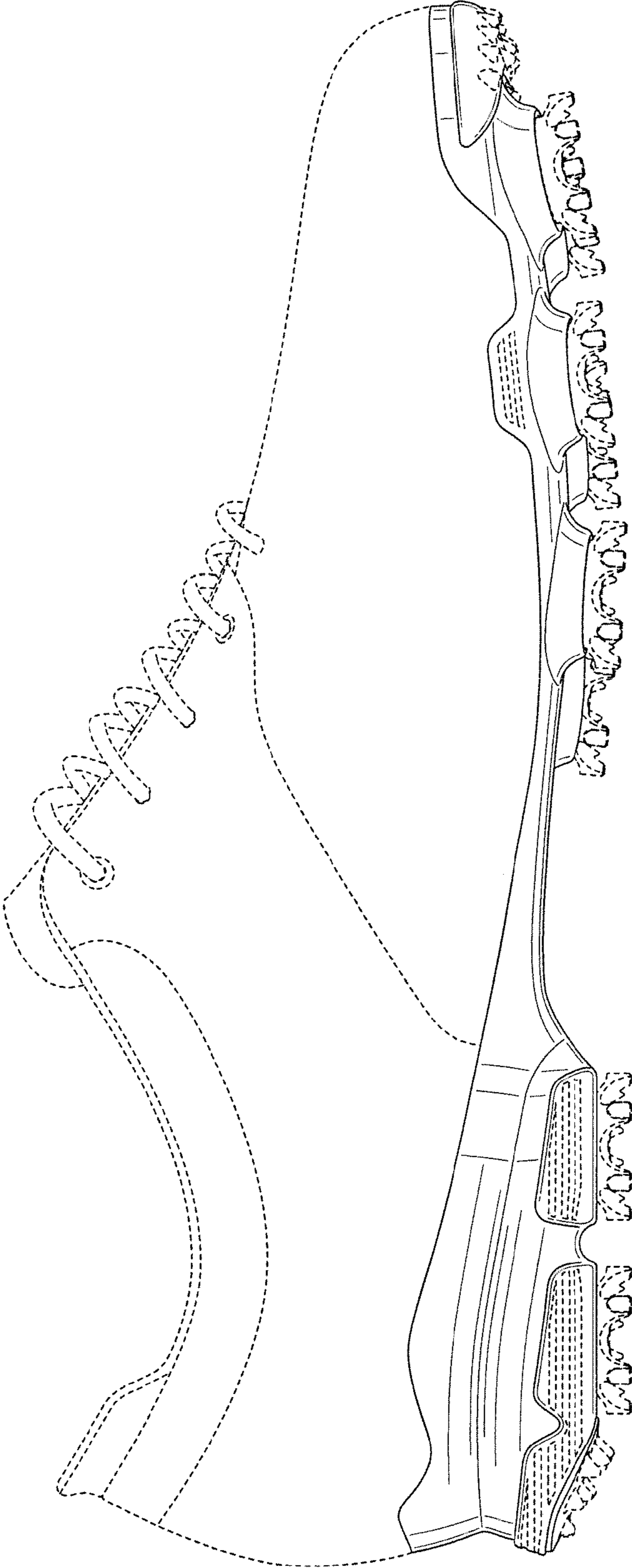

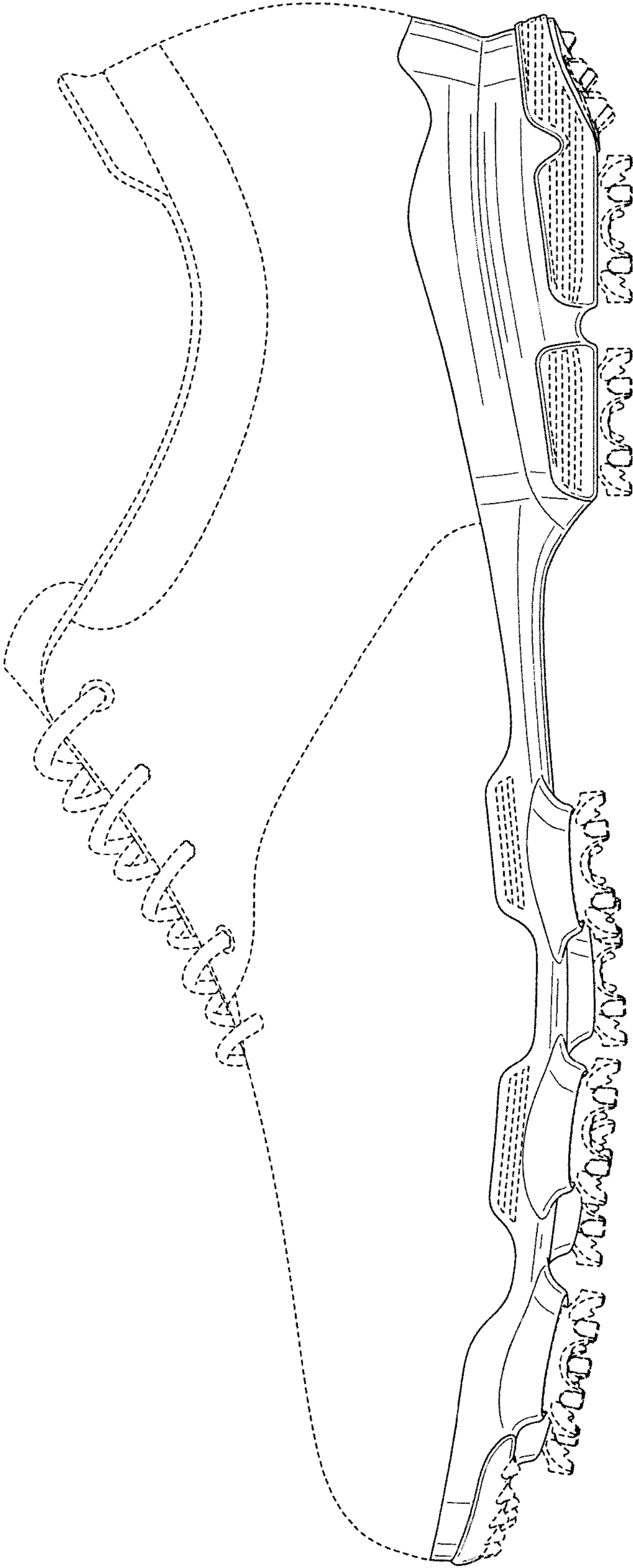

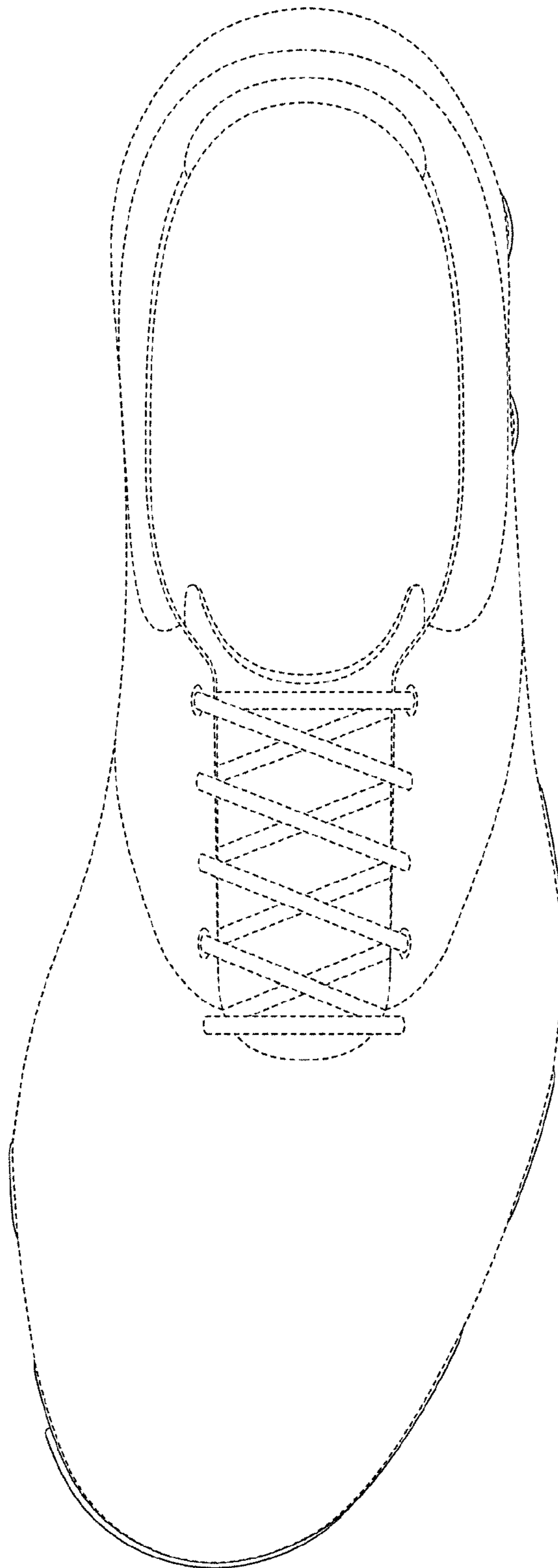

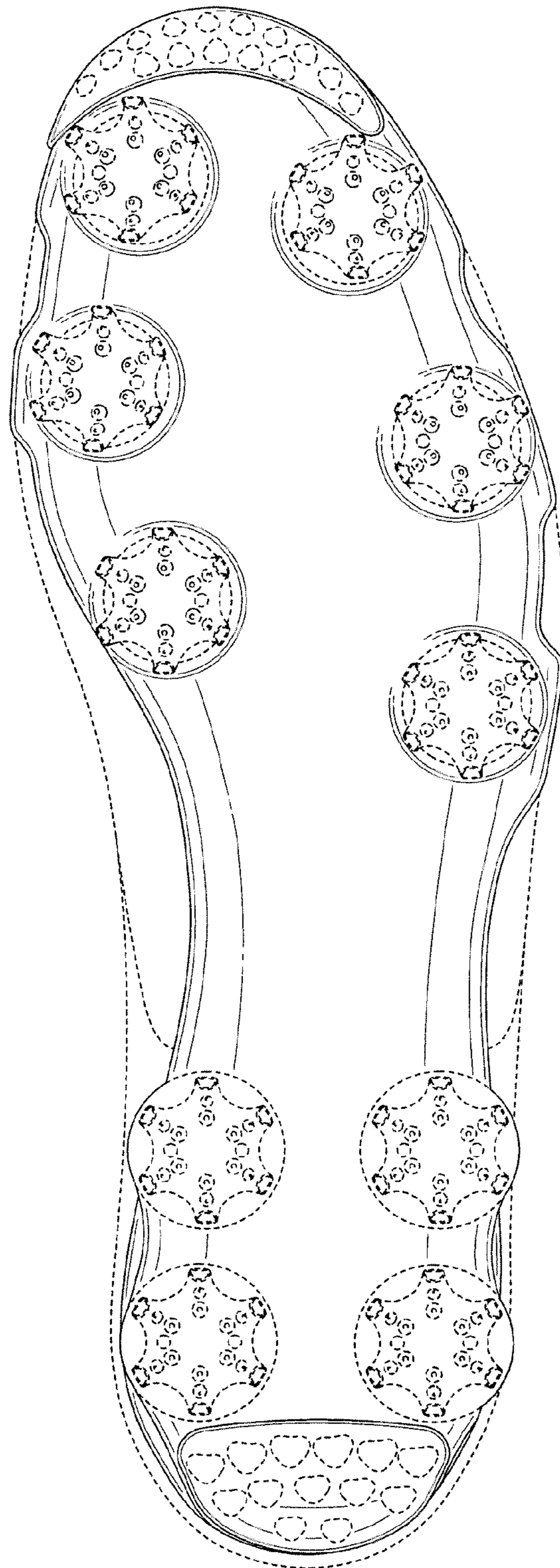
