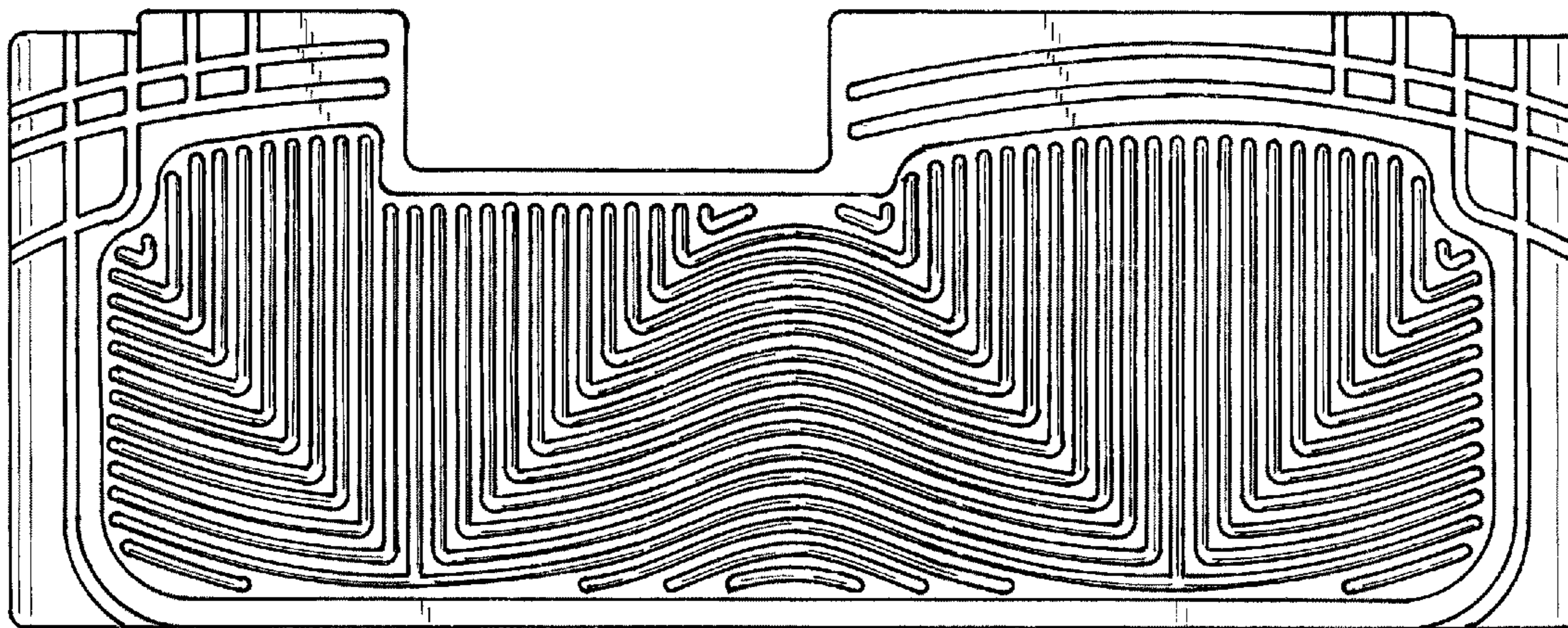
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top view of a first embodiment of a golf cart floor mat;
FIG. 2 is a bottom view of the golf cart mat thereof;
FIG. 3 is a front view of the golf cart floor mat thereof;

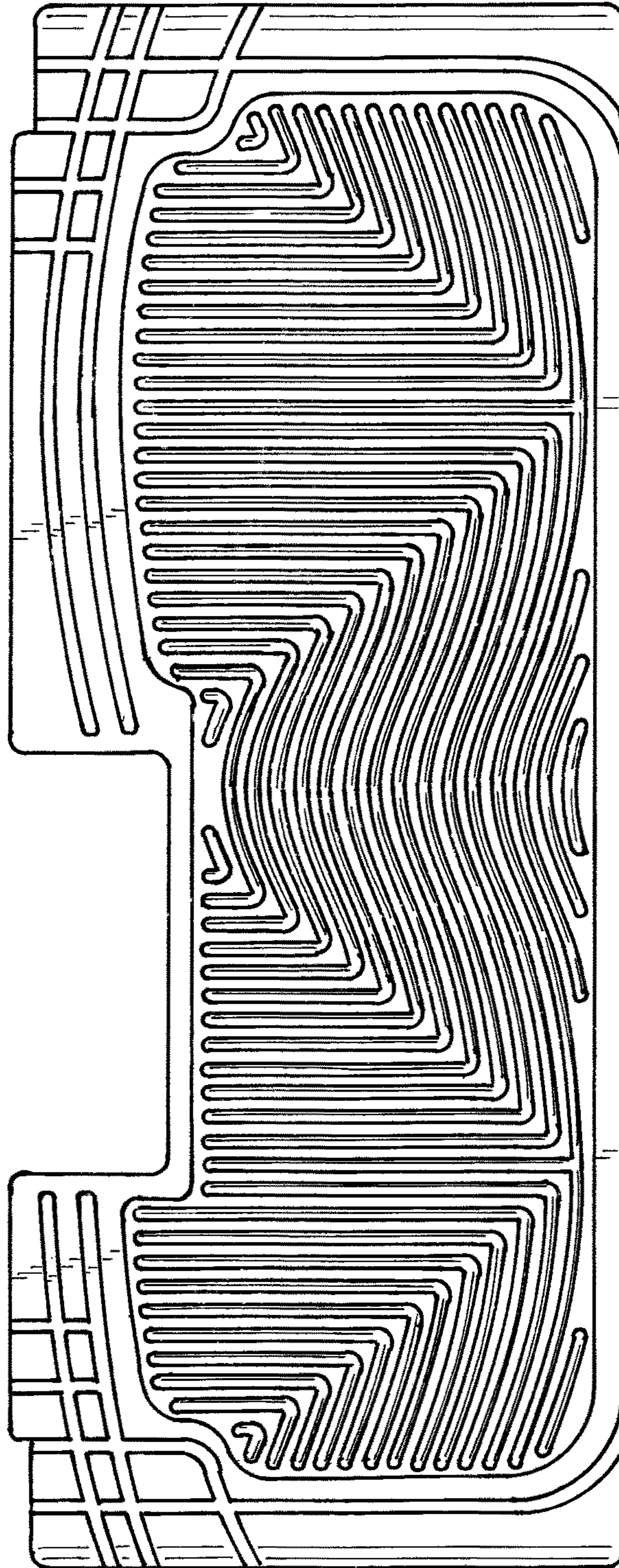

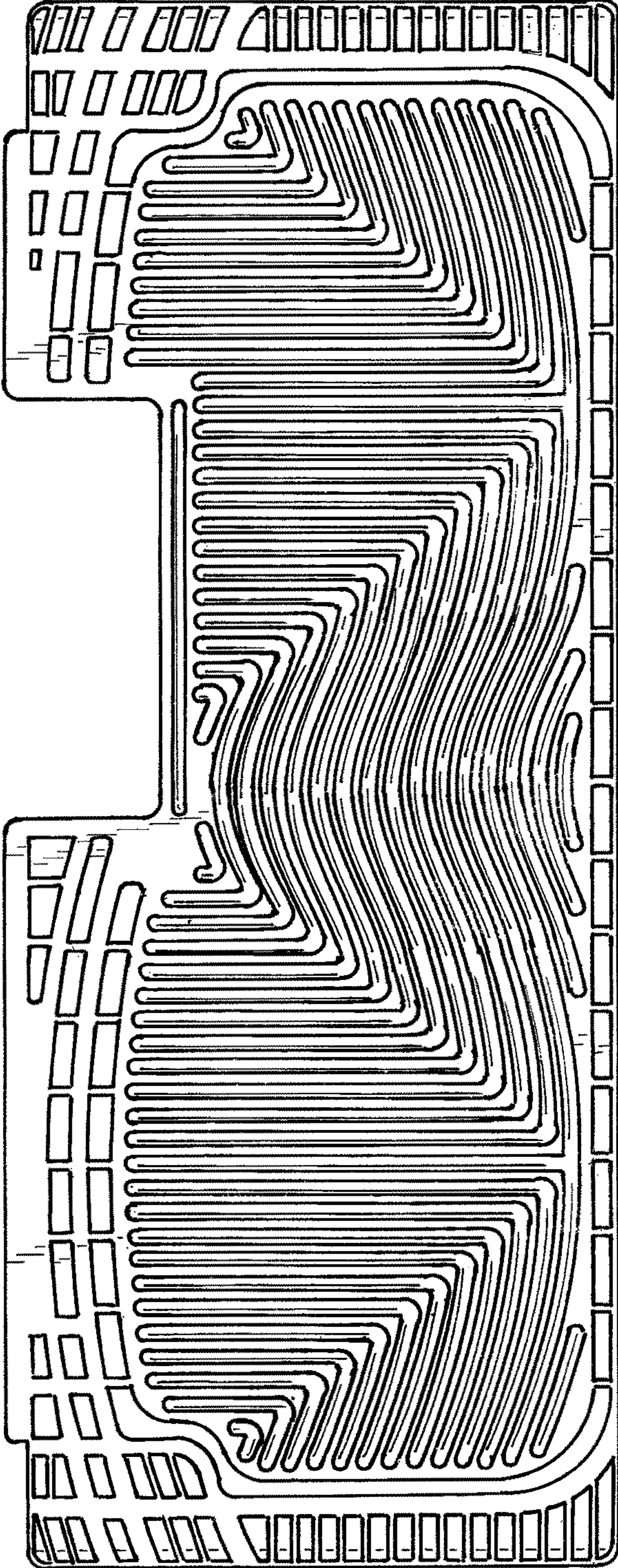

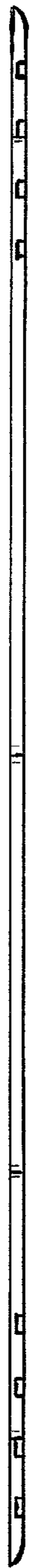

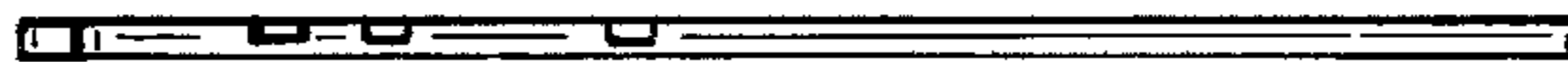
