FIG. 2 is a front view of the chair;

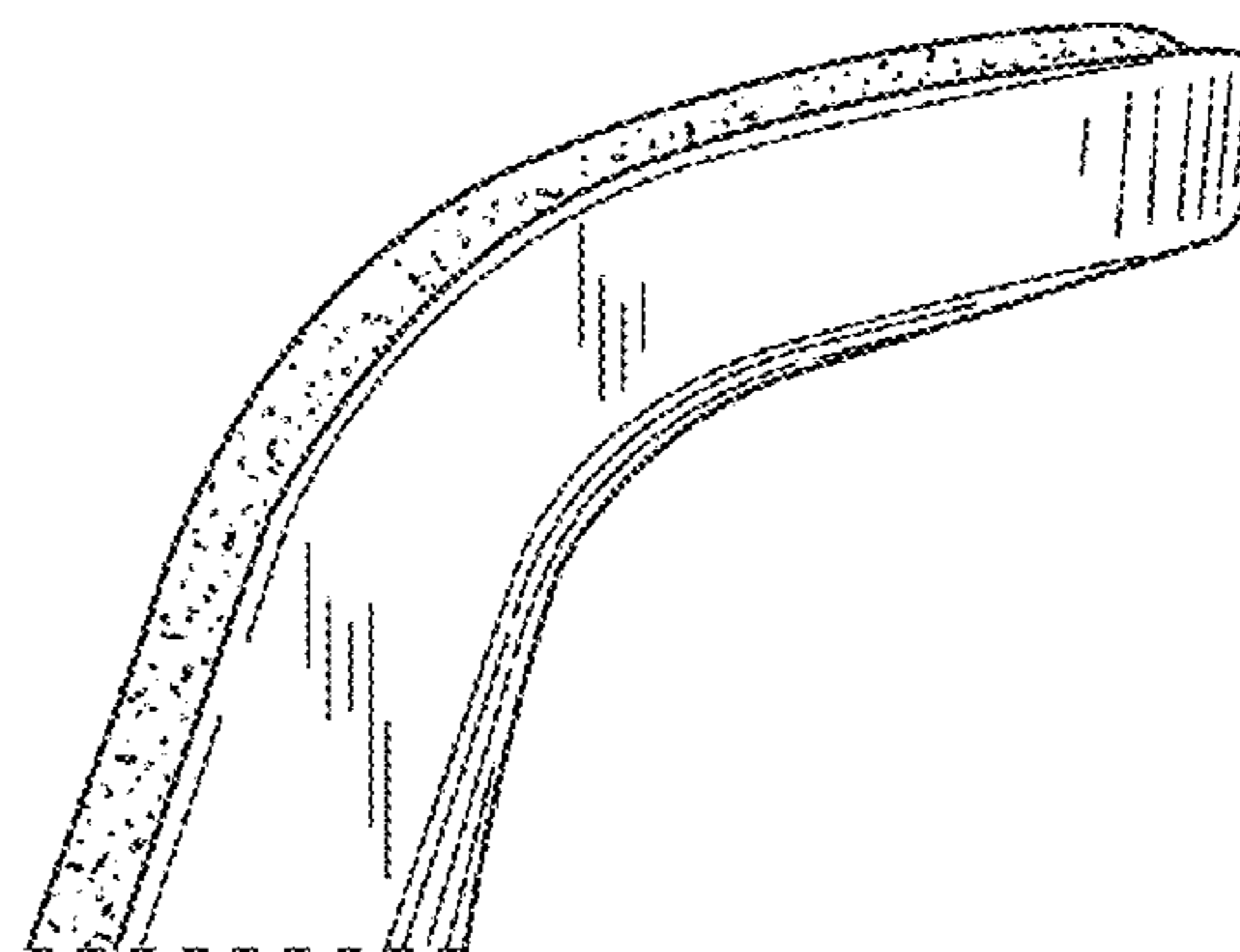
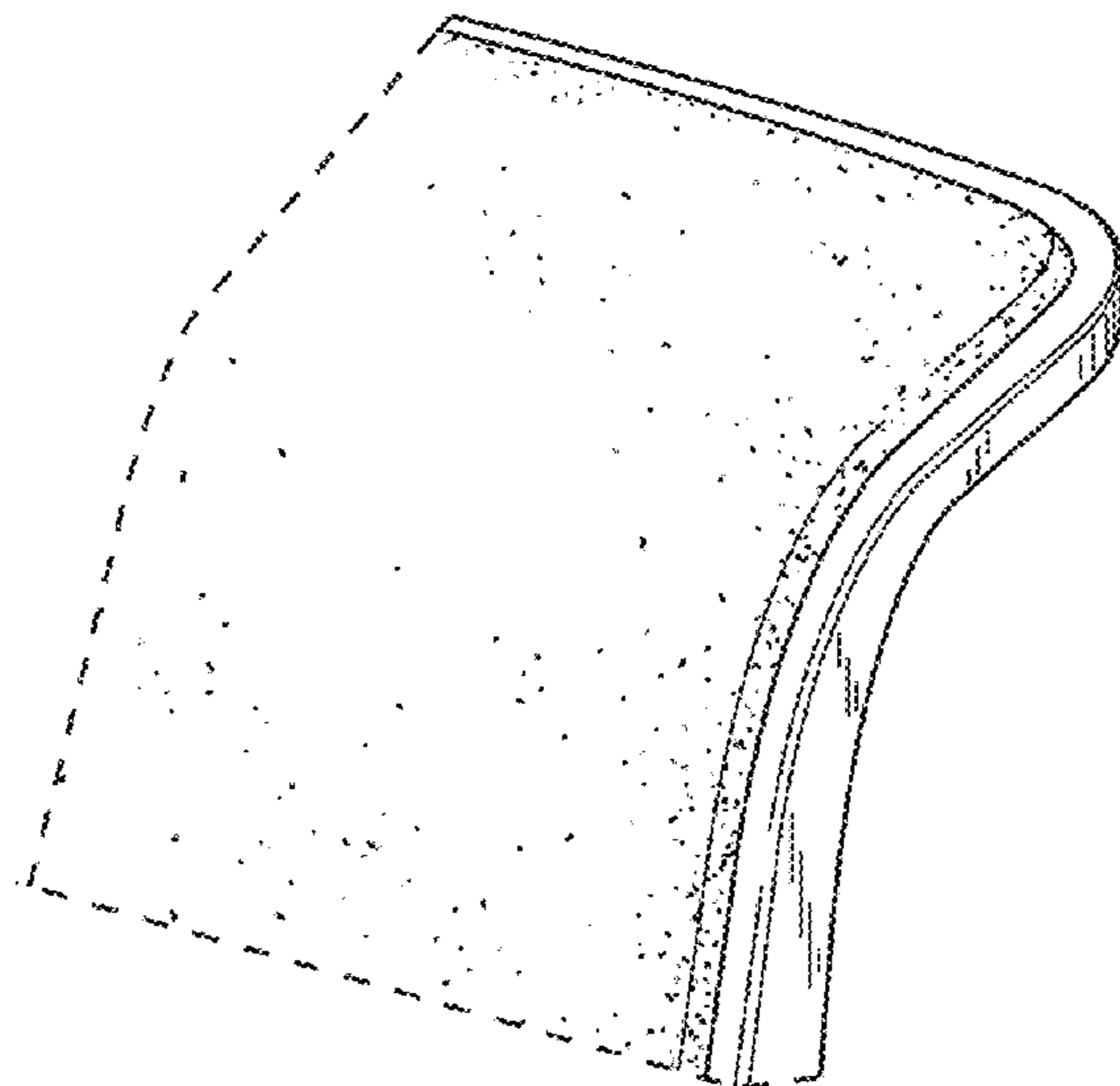
FIG. 3 is a first side view of the chair;

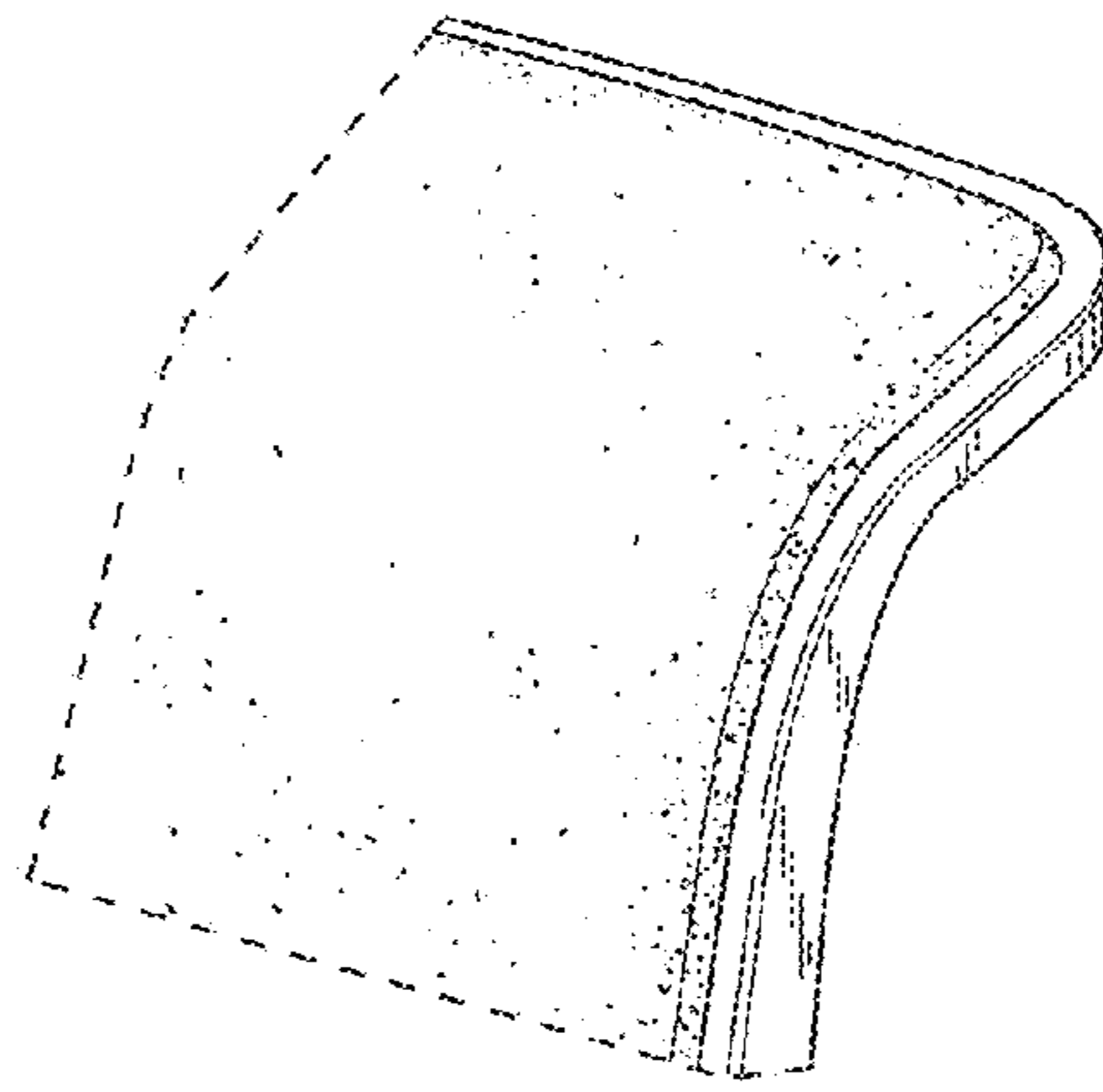

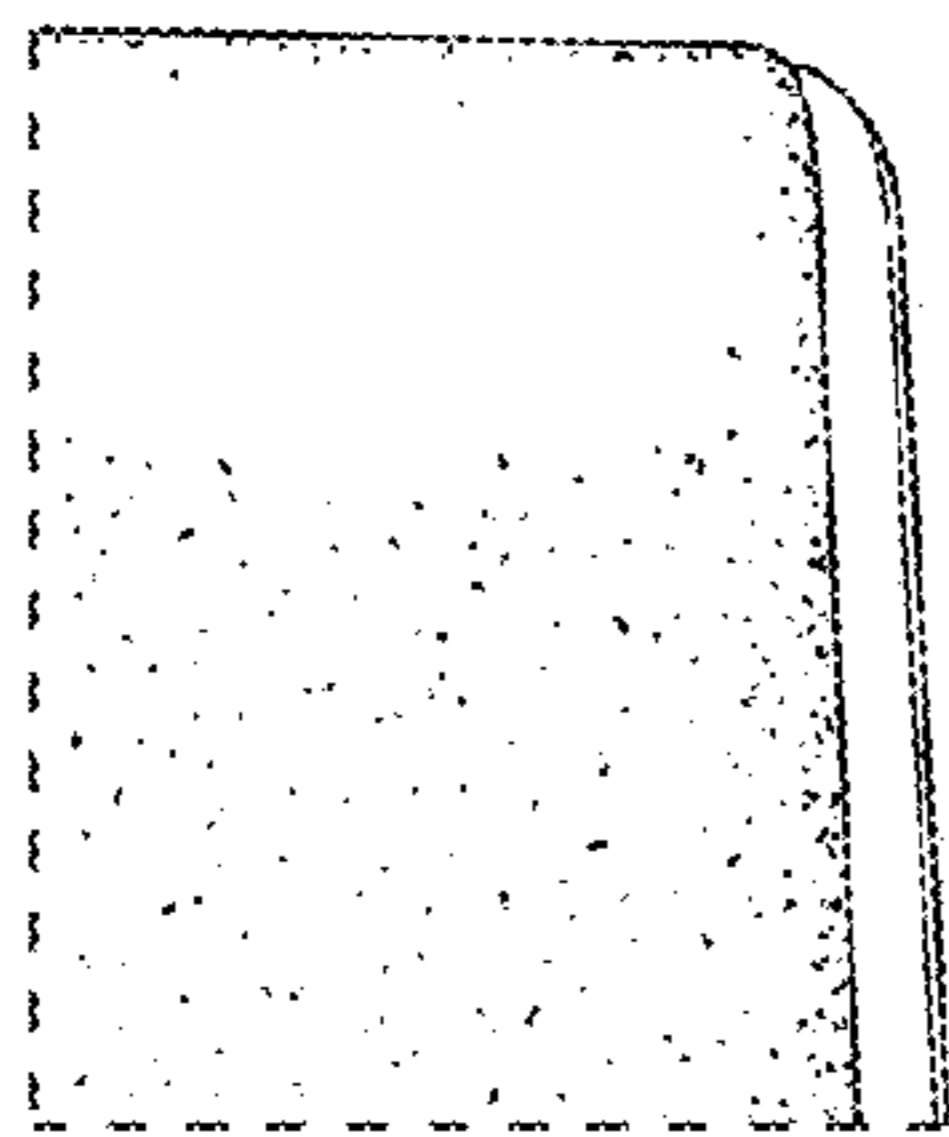

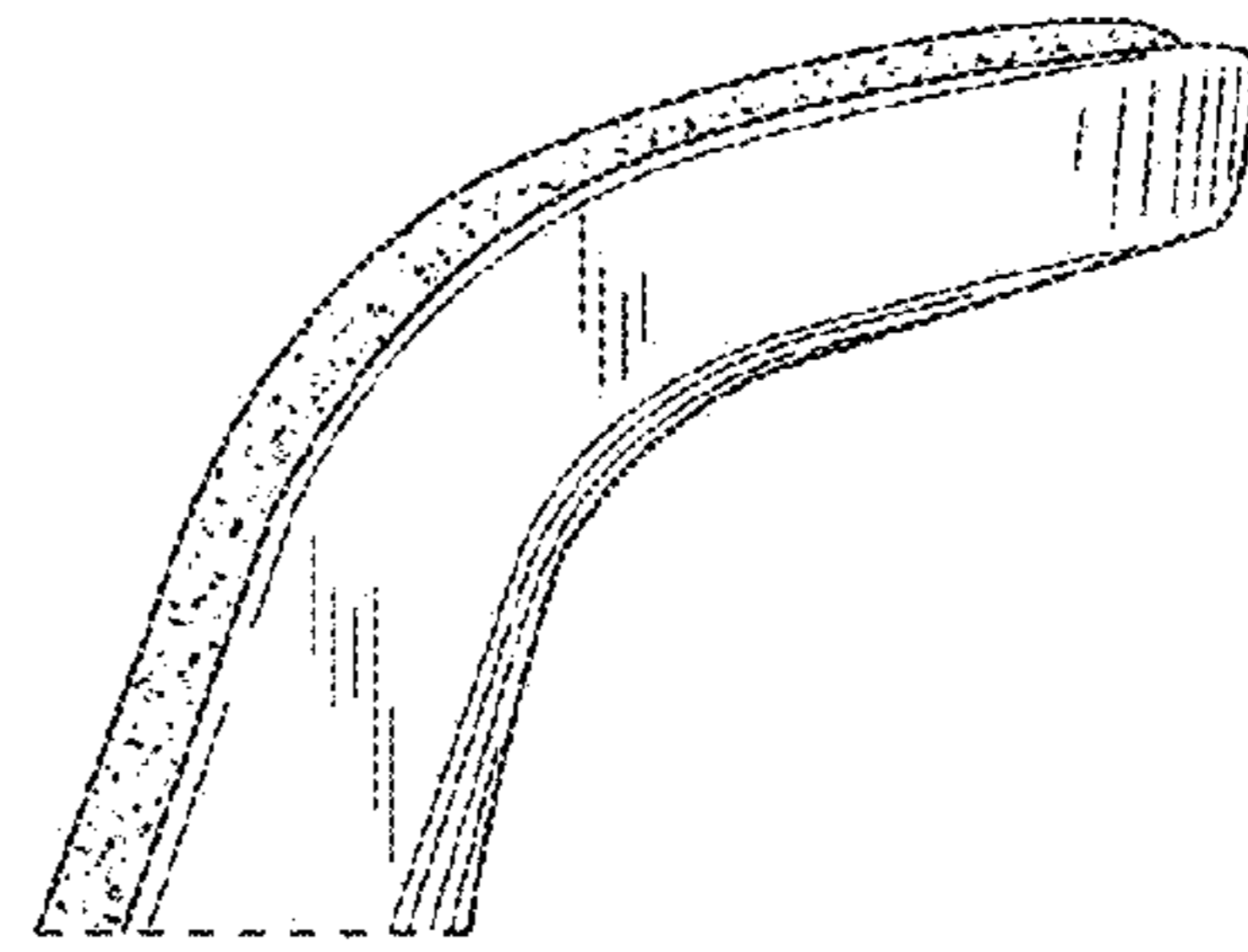

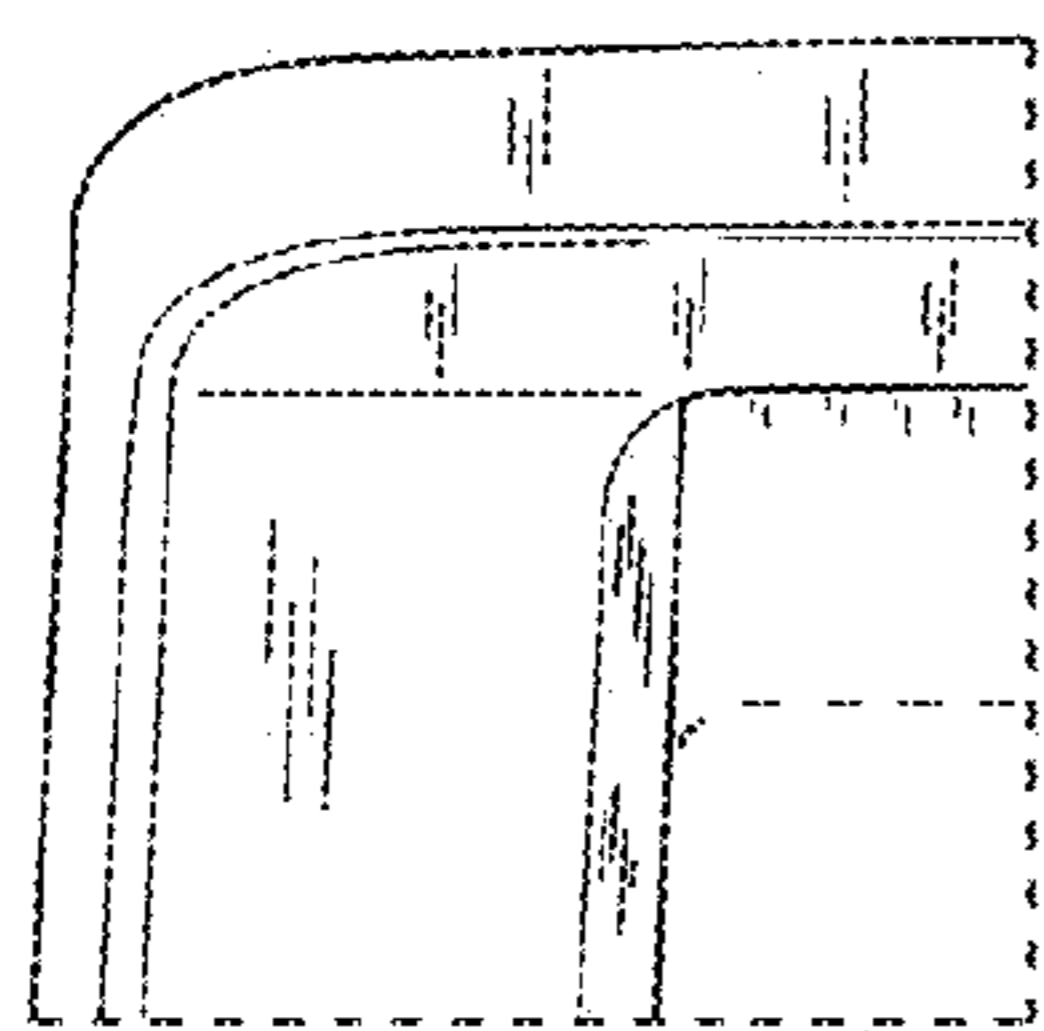

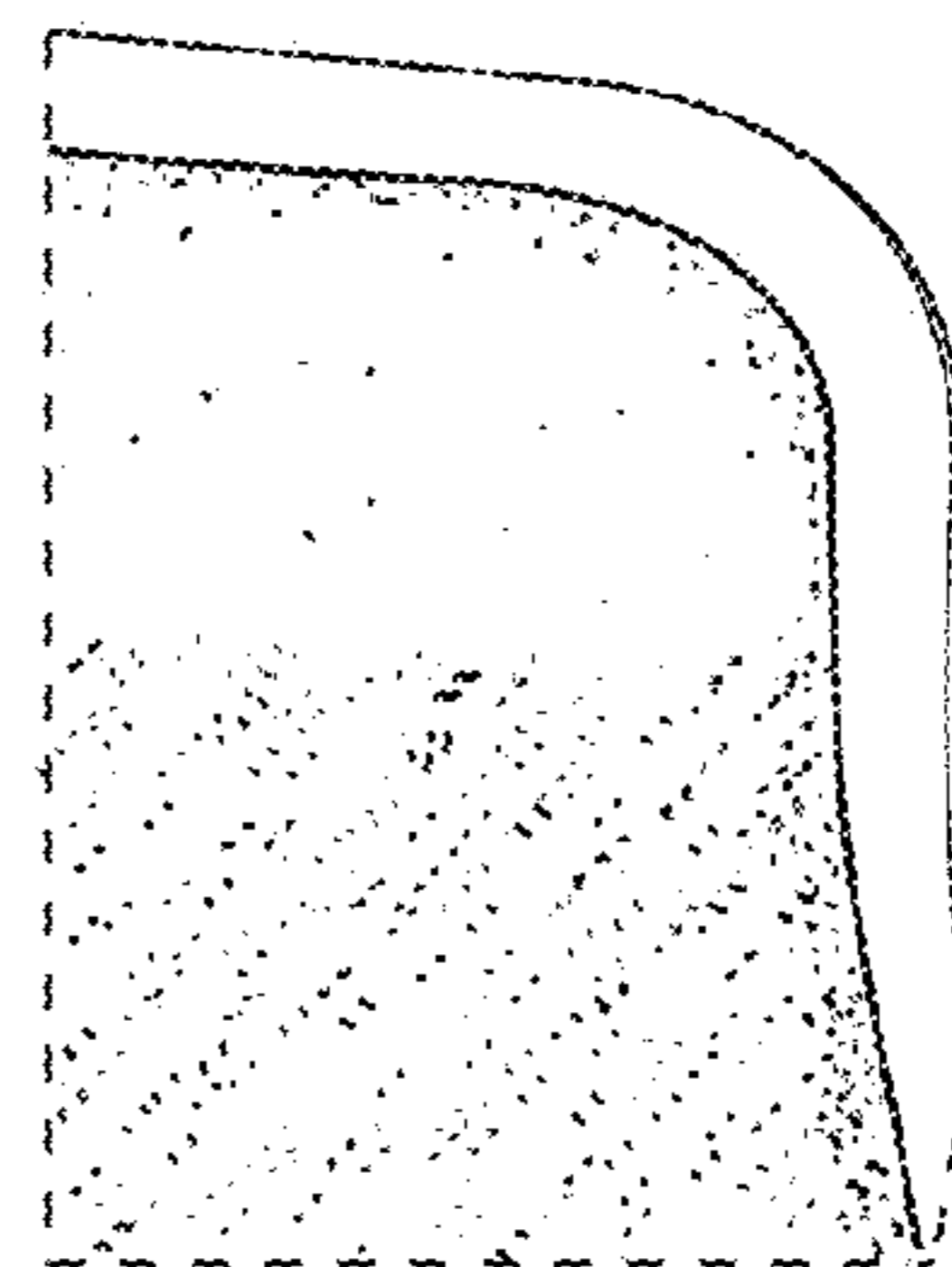
