(57) **CLAIM**

The ornamental design of the drink bottle with smooth hand grip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from the upper, front, right-hand side of the drink bottle with smooth hand grip of the present invention;

FIG. 2 is a perspective view taken from the lower, rear, left-hand side of the drink bottle with smooth hand grip of FIG. 1; FIG. 3 is a side elevational view of the left side of the drink bottle with smooth hand grip of FIG. 1;

FIG. 4 is a front elevational view of the drink bottle with smooth hand grip of FIG. 1;

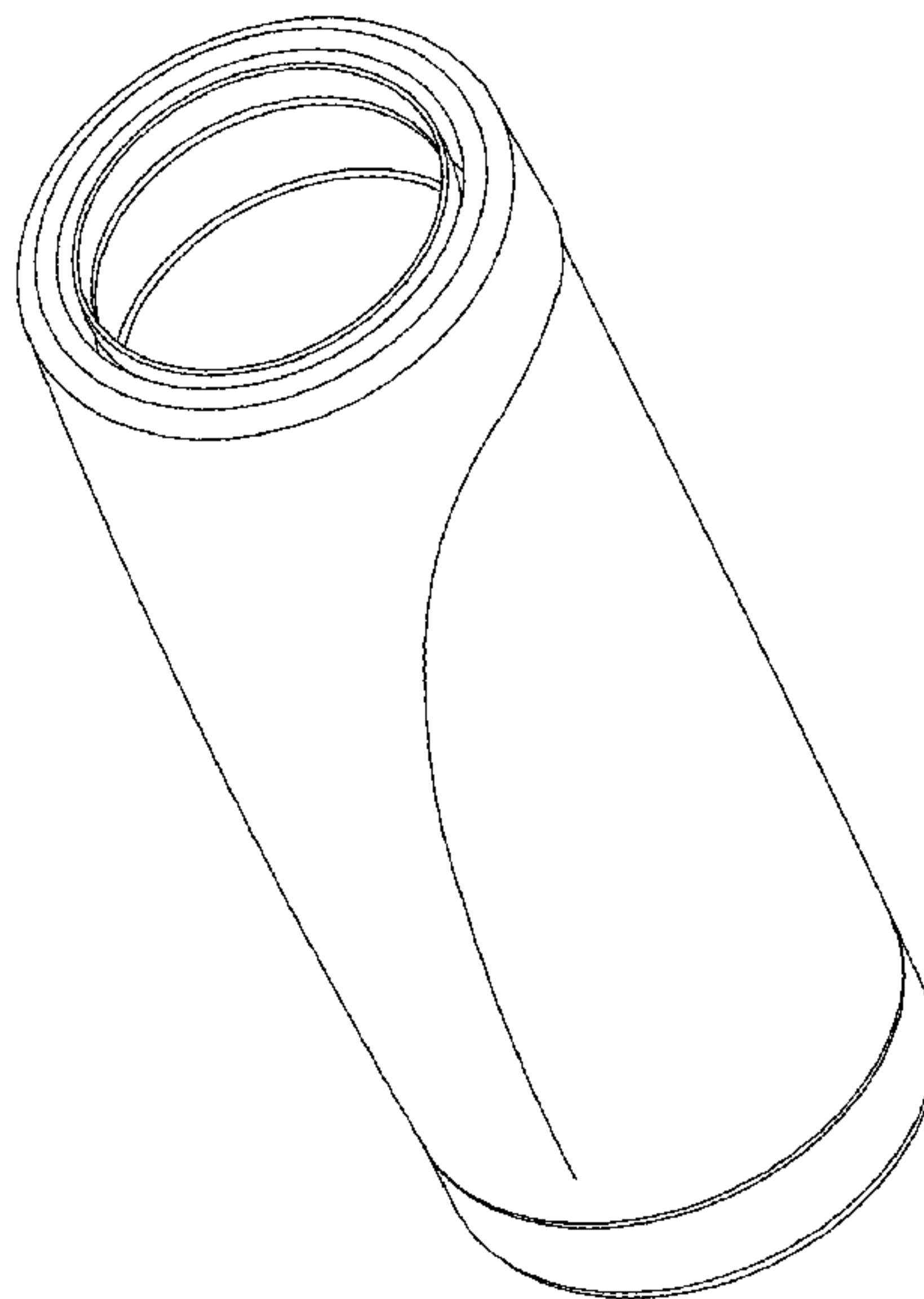
FIG. 5 is a side elevational view of the right side of the drink bottle with smooth hand grip of FIG. 1;

FIG. 6 is a rear elevational view of the drink bottle with smooth hand grip of FIG. 1;

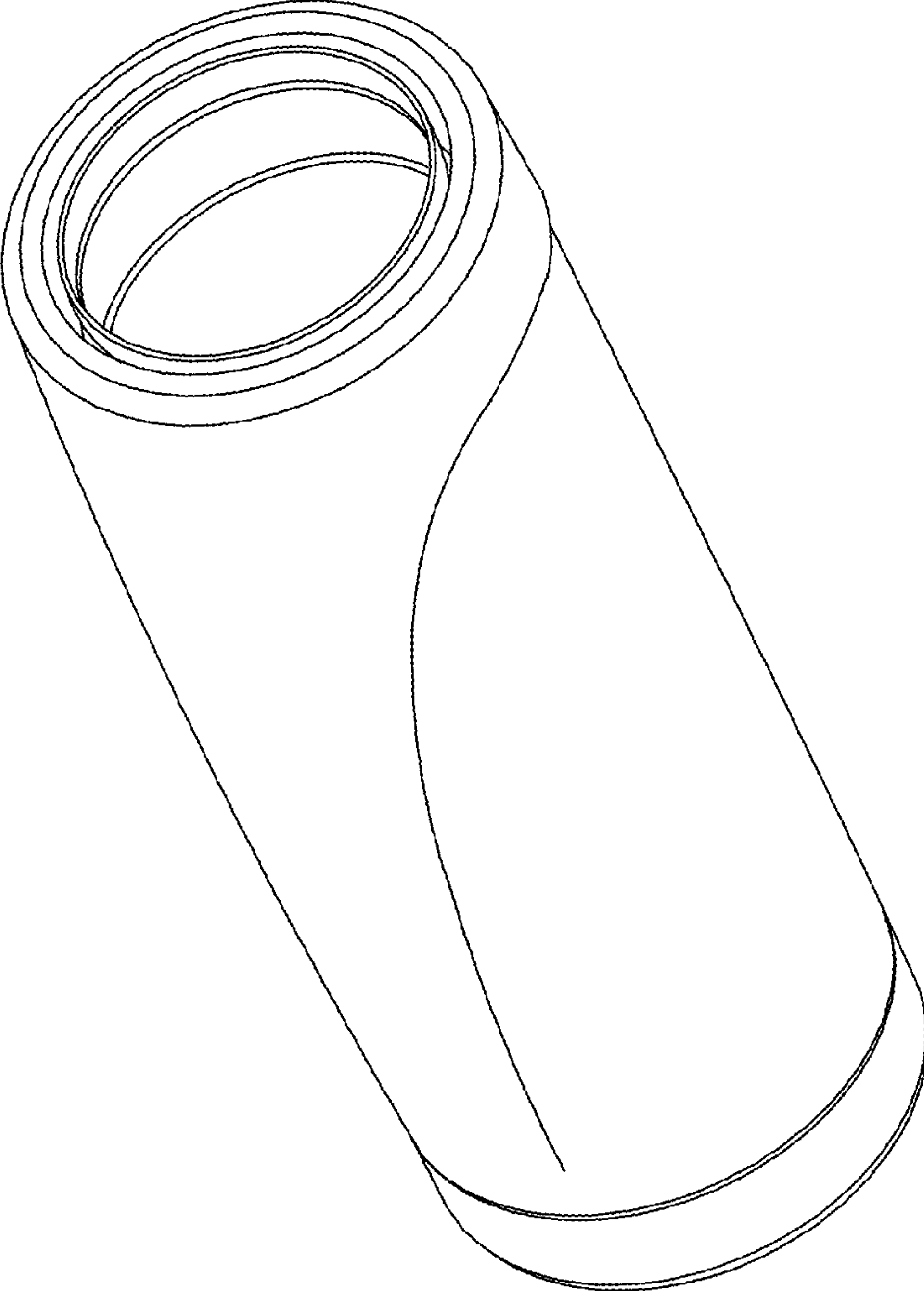

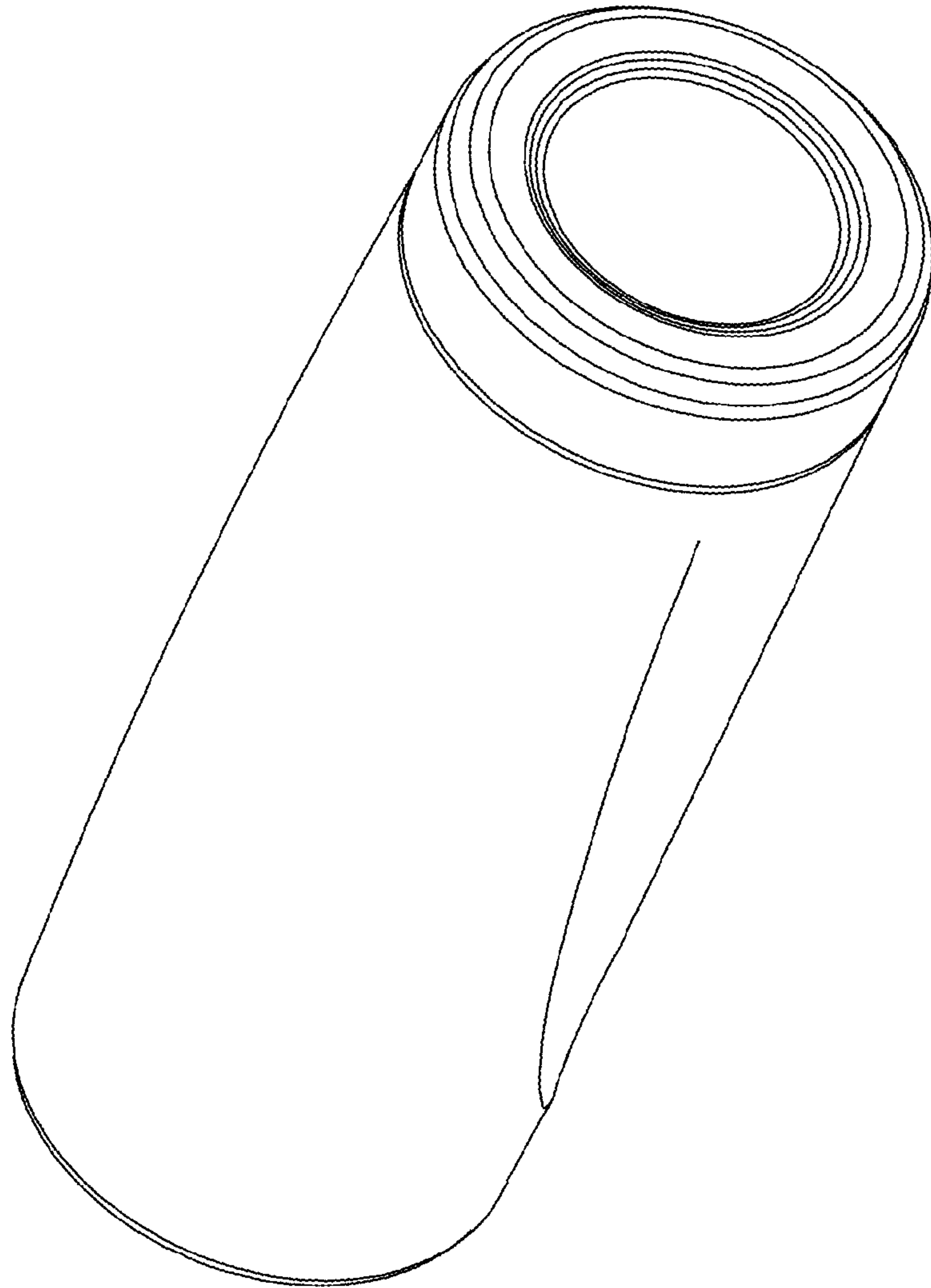

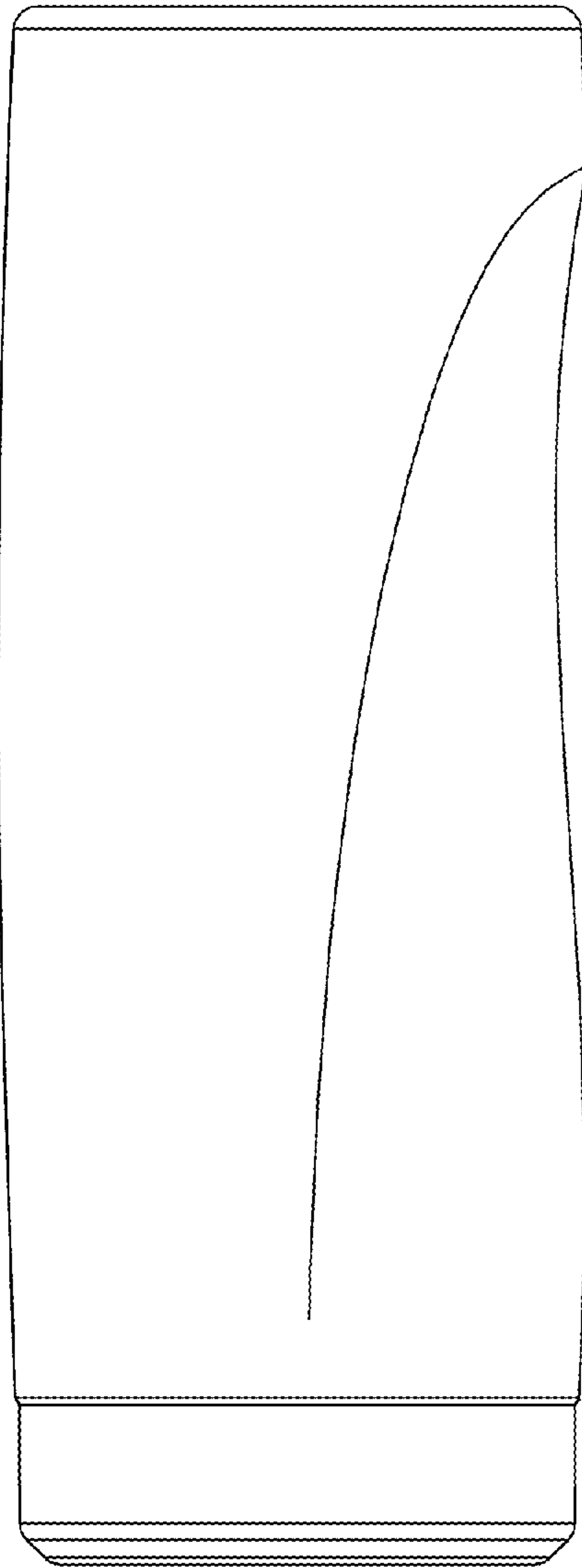

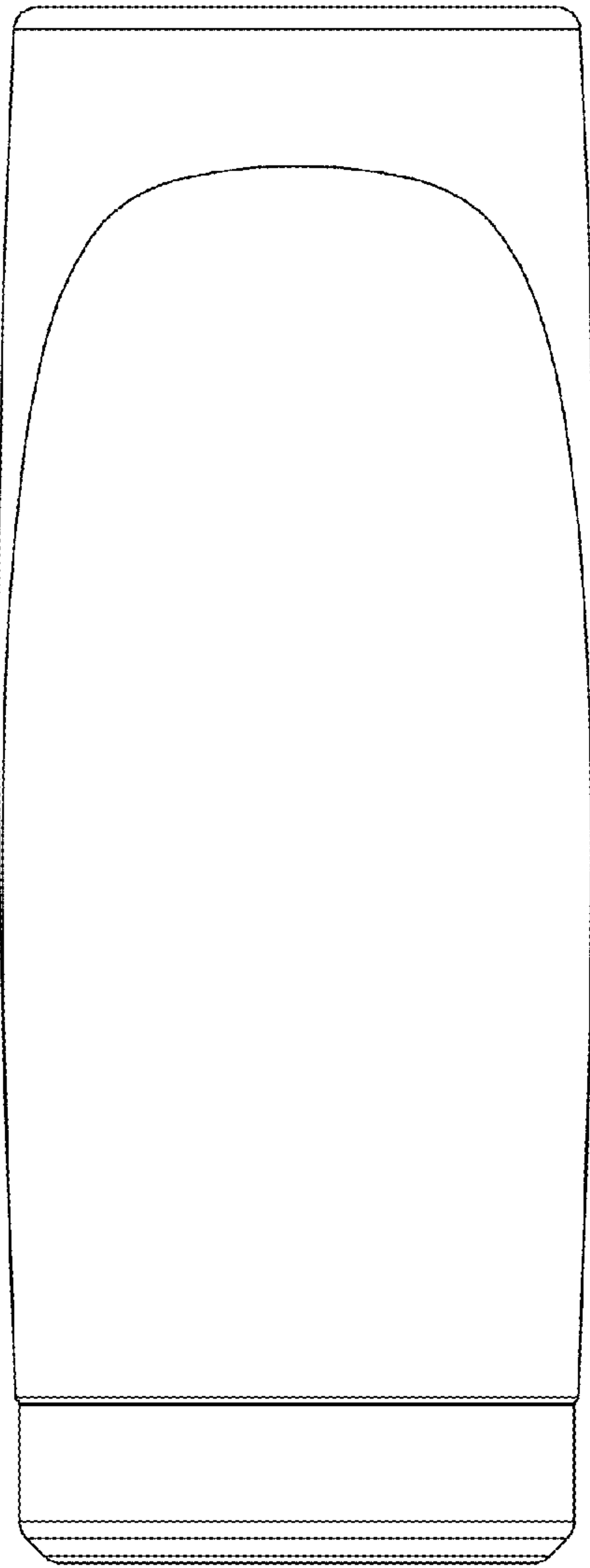

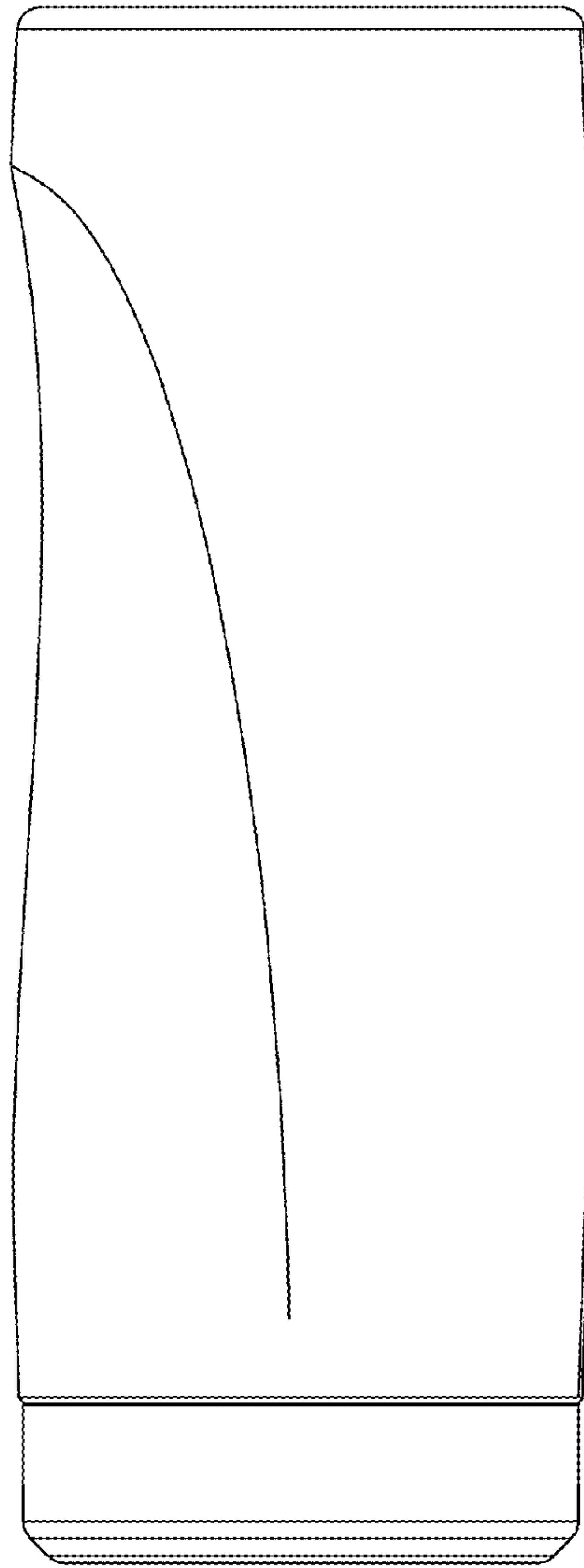

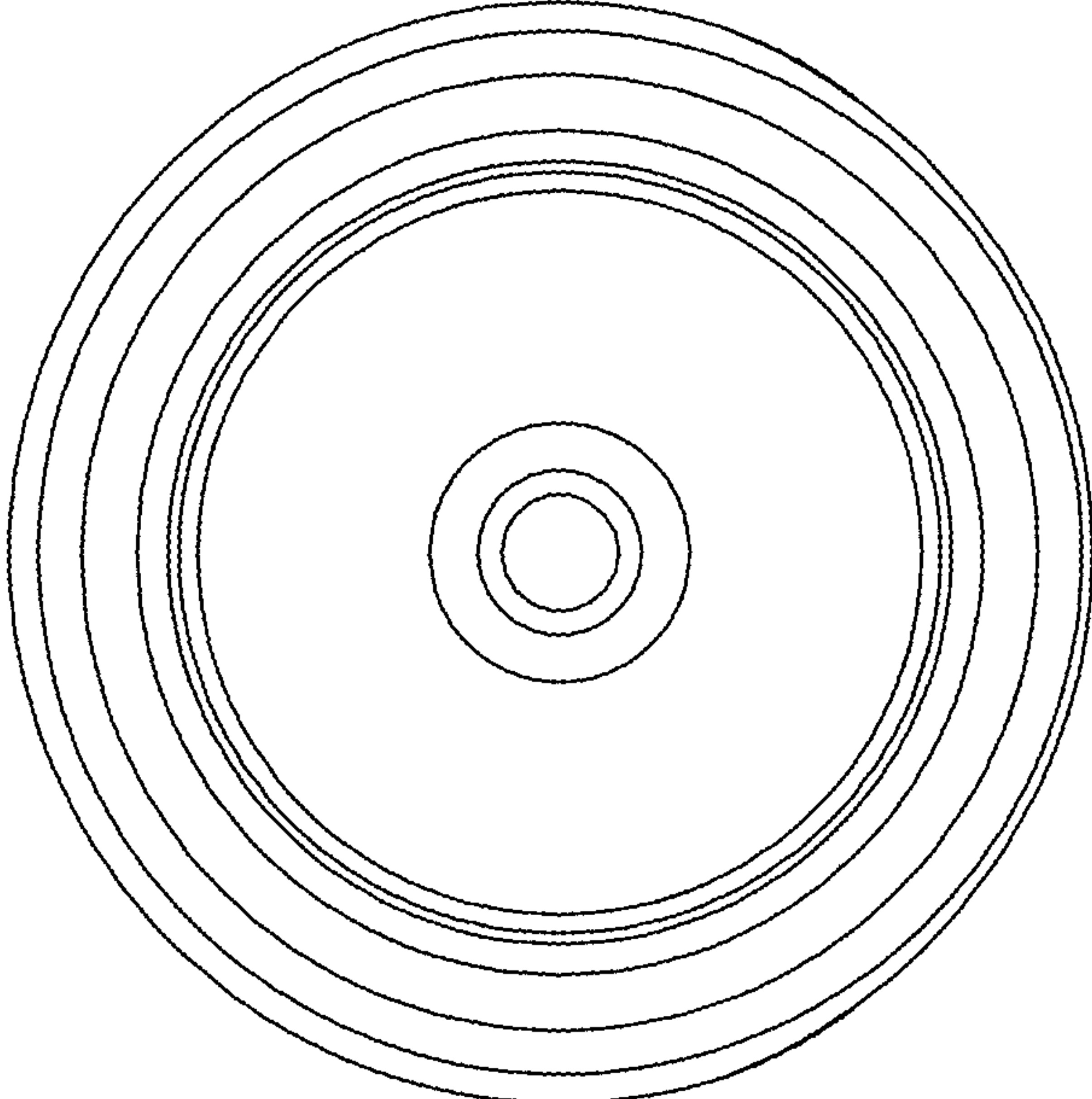

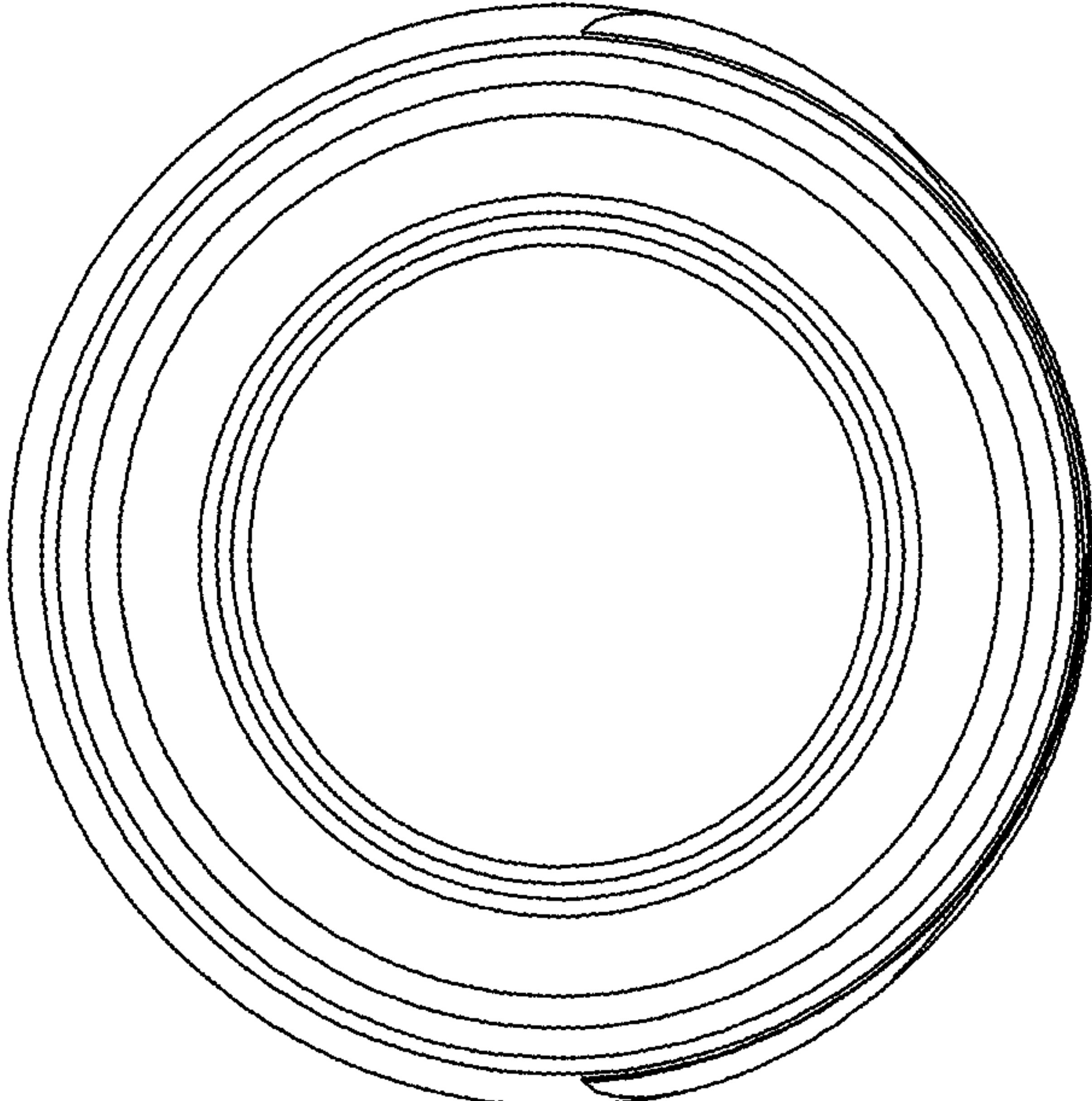
