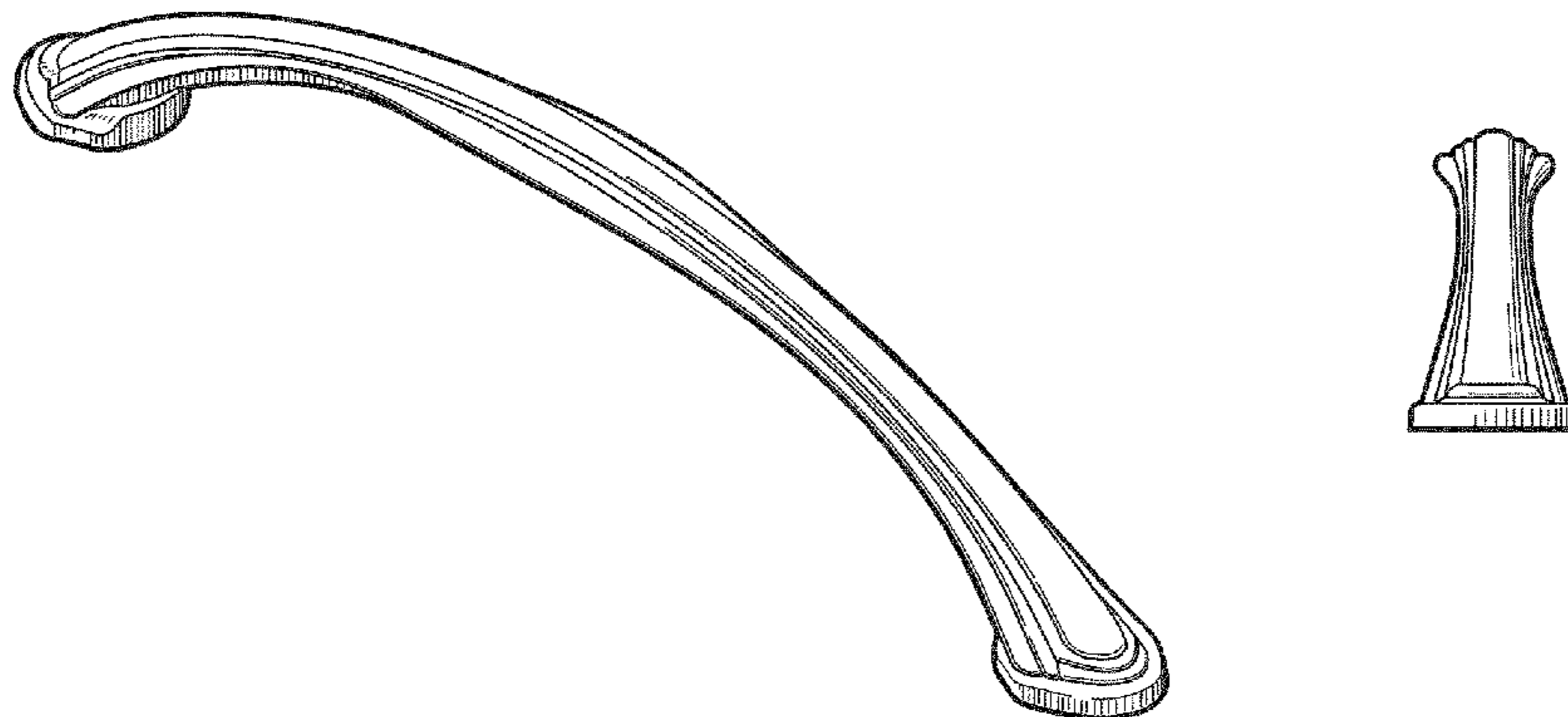
(57) **CLAIM**

What is claimed is the ornamental design for a cabinet pull, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a cabinet pull;

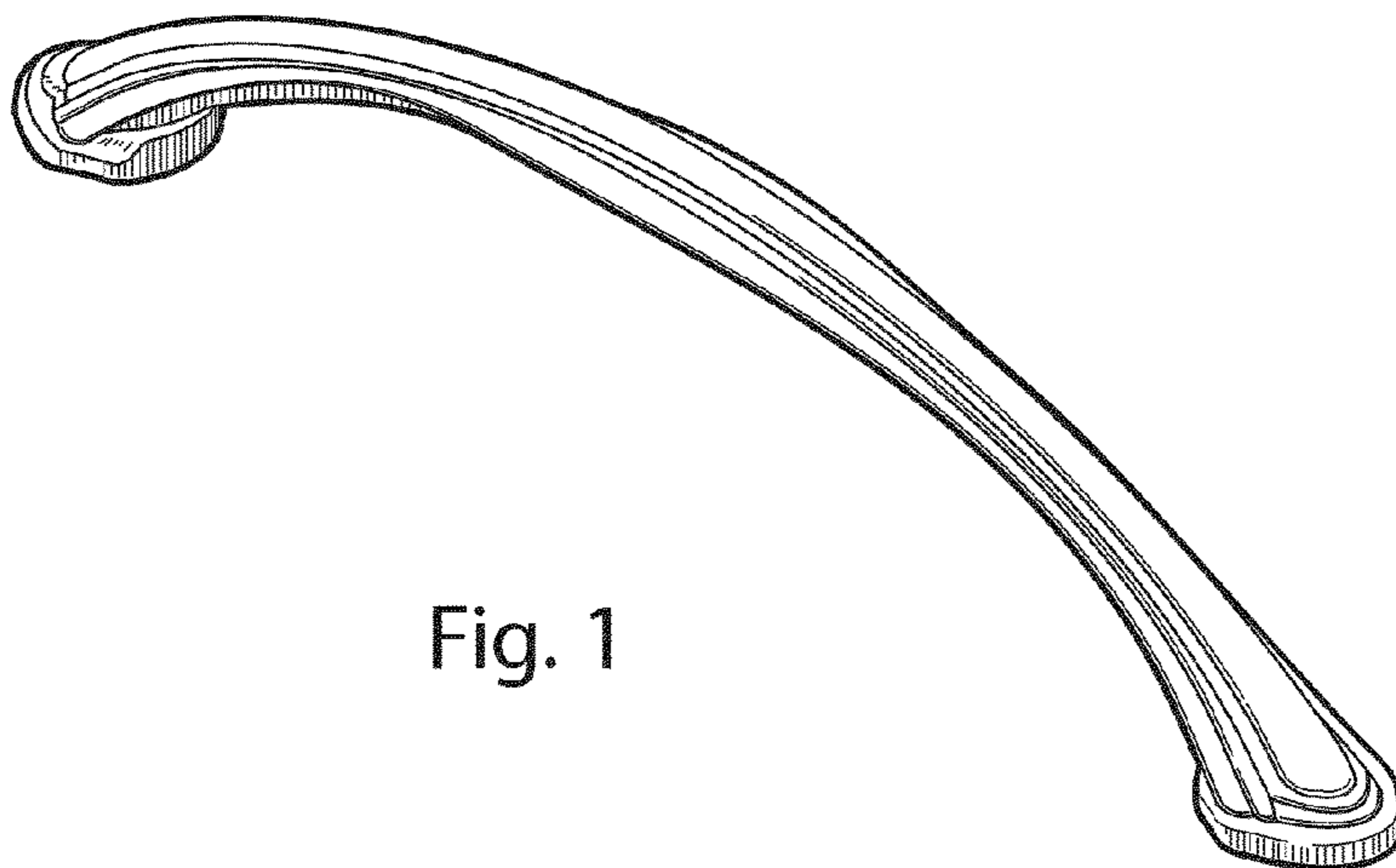

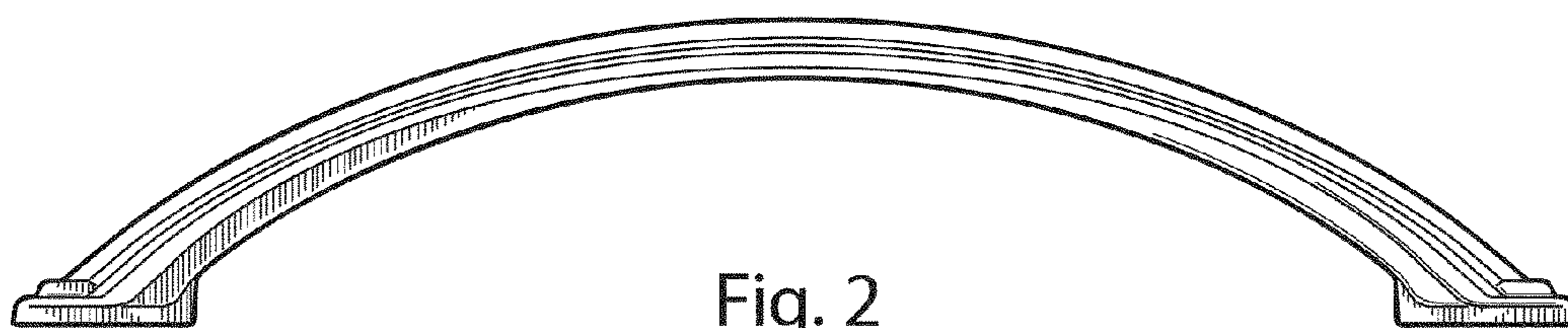

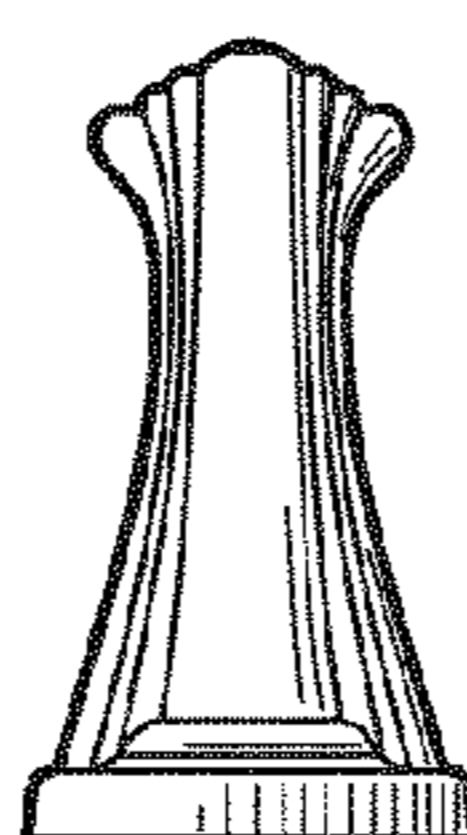

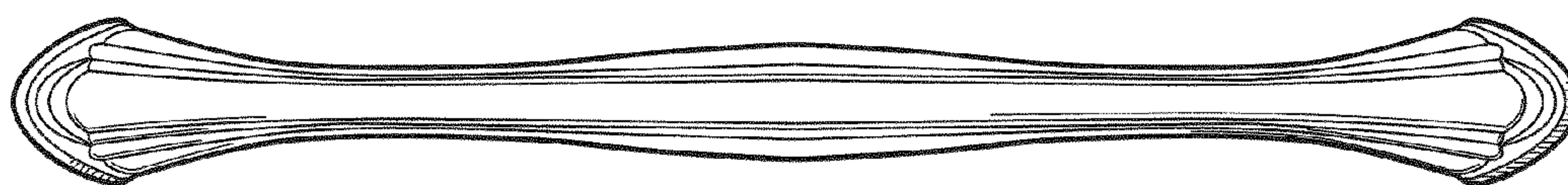

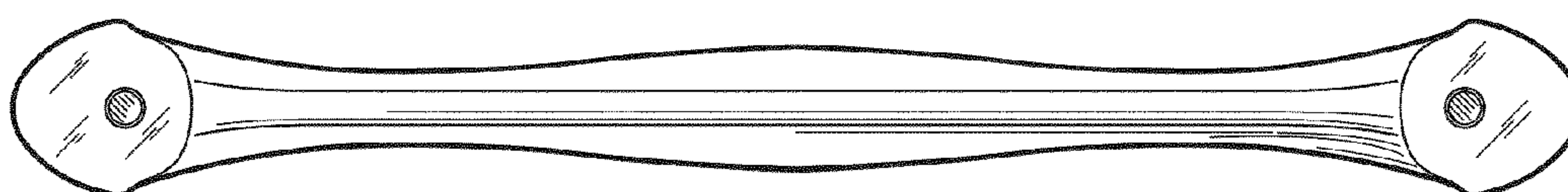
