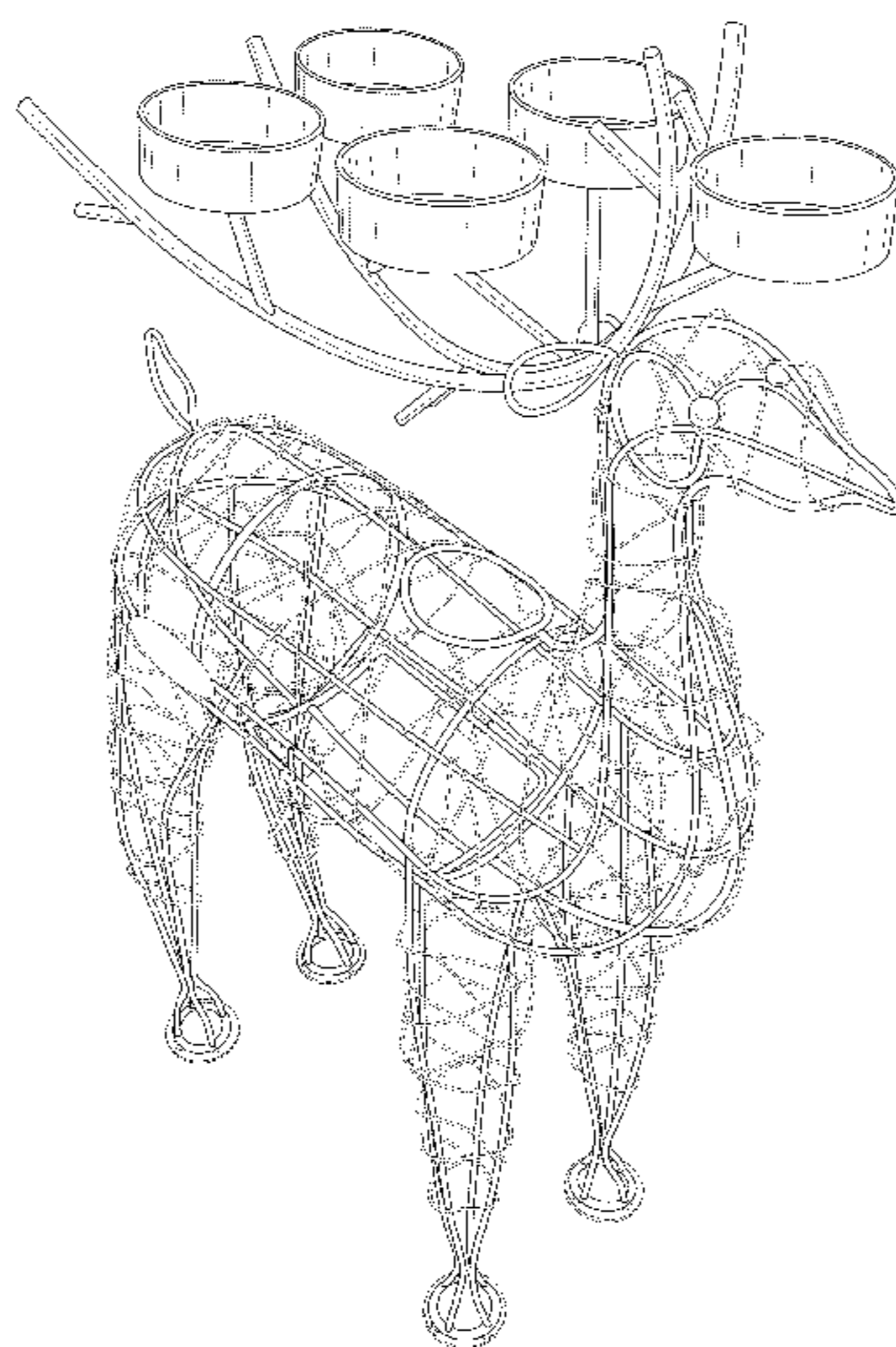
(57) **CLAIM**

The ornamental design for a reindeer candelabra cork holder, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a reindeer candelabra cork holder showing my new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a side view thereof; and, FIG. 4 is a top view thereof. The broken lines depict portions of the reindeer candelabra cork holder that form no part of the claimed design.

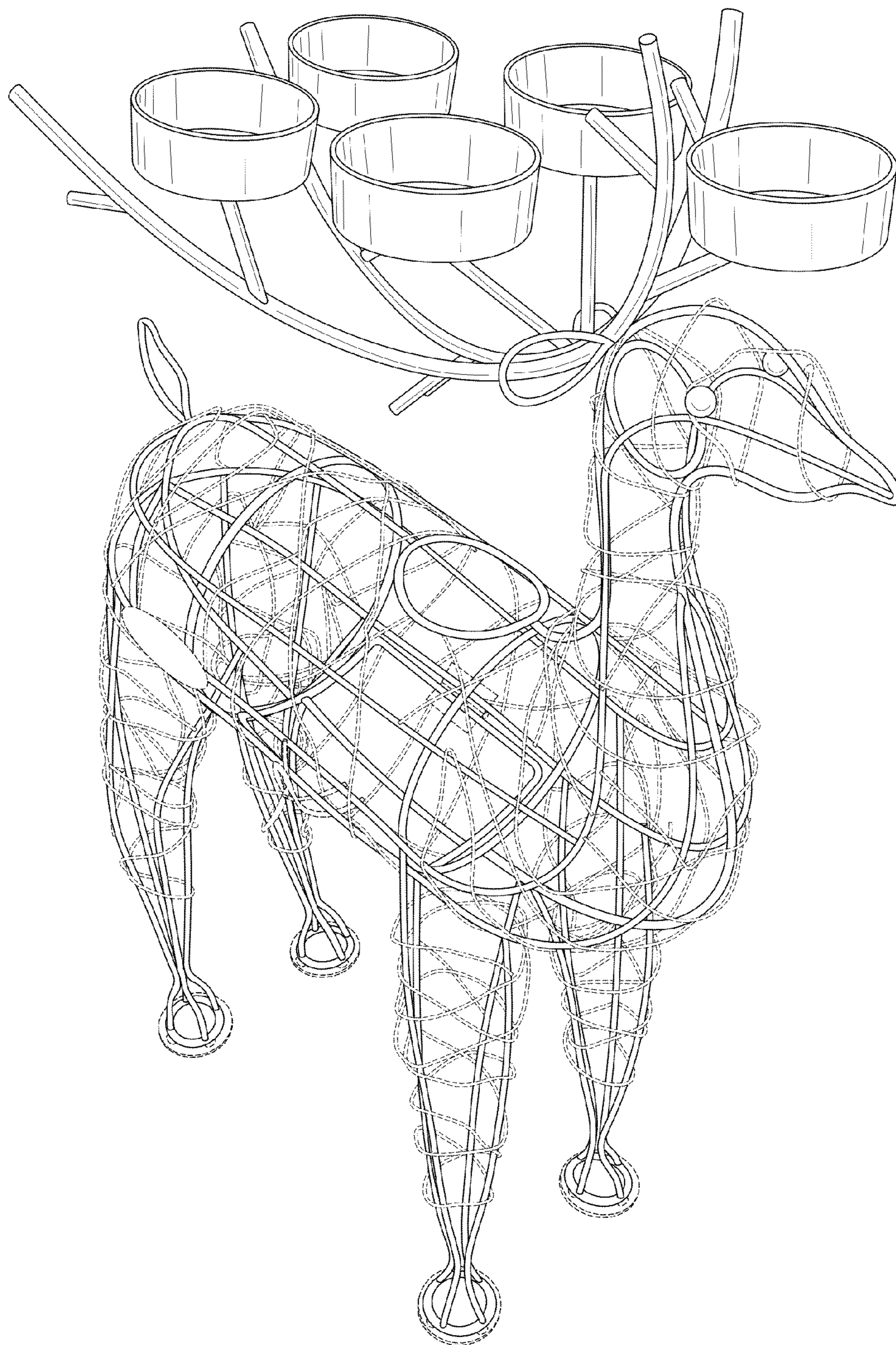

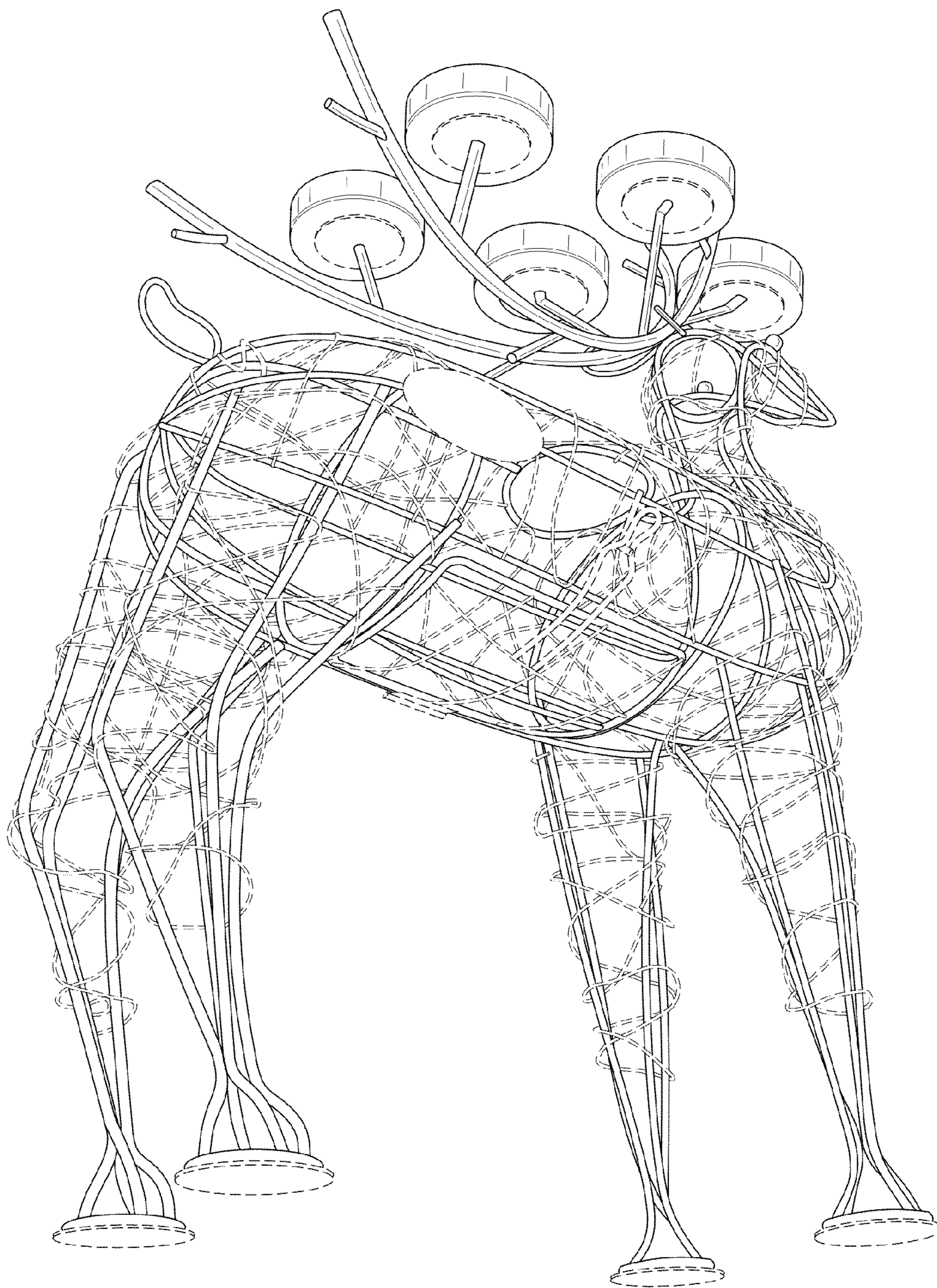

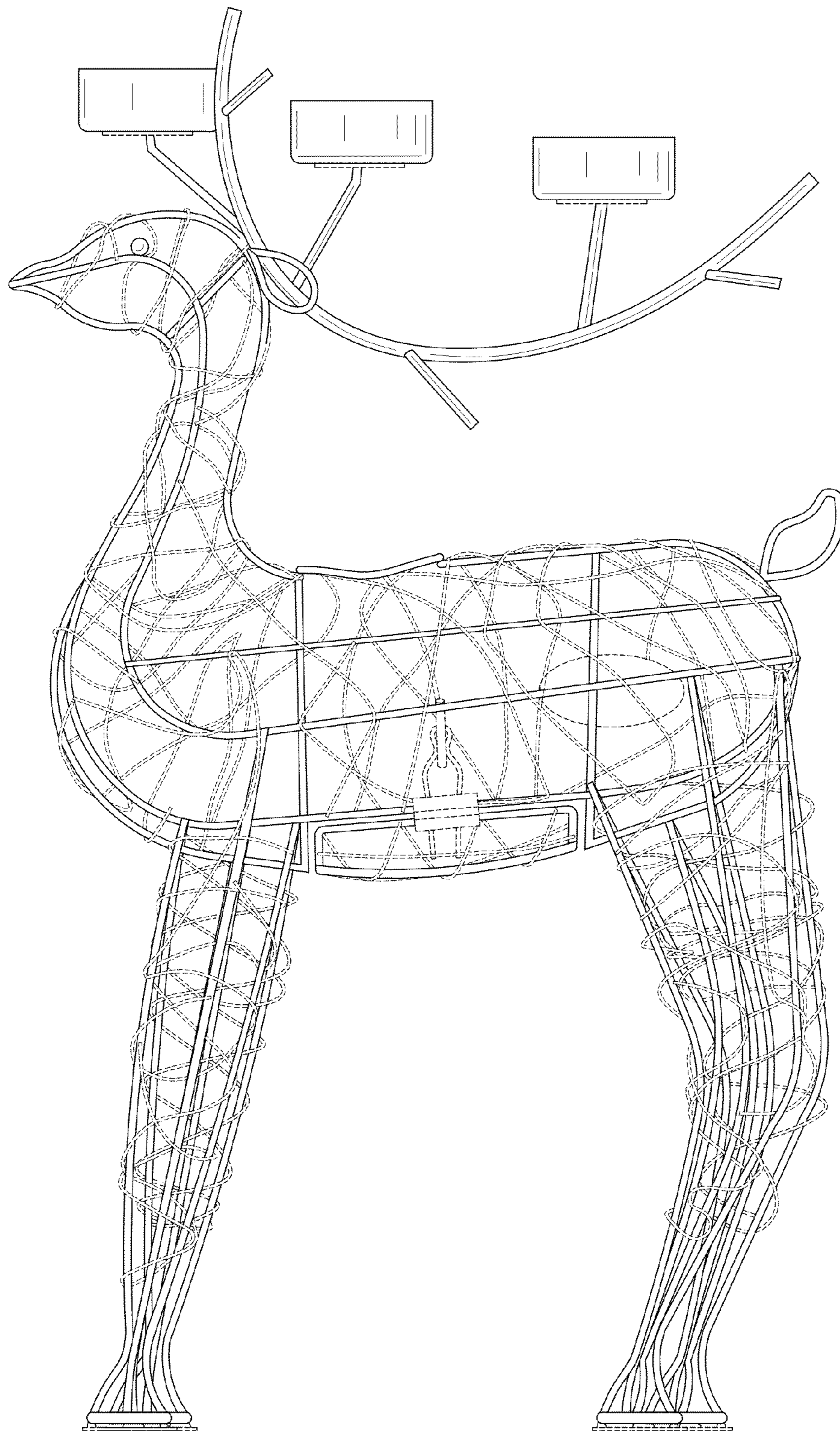

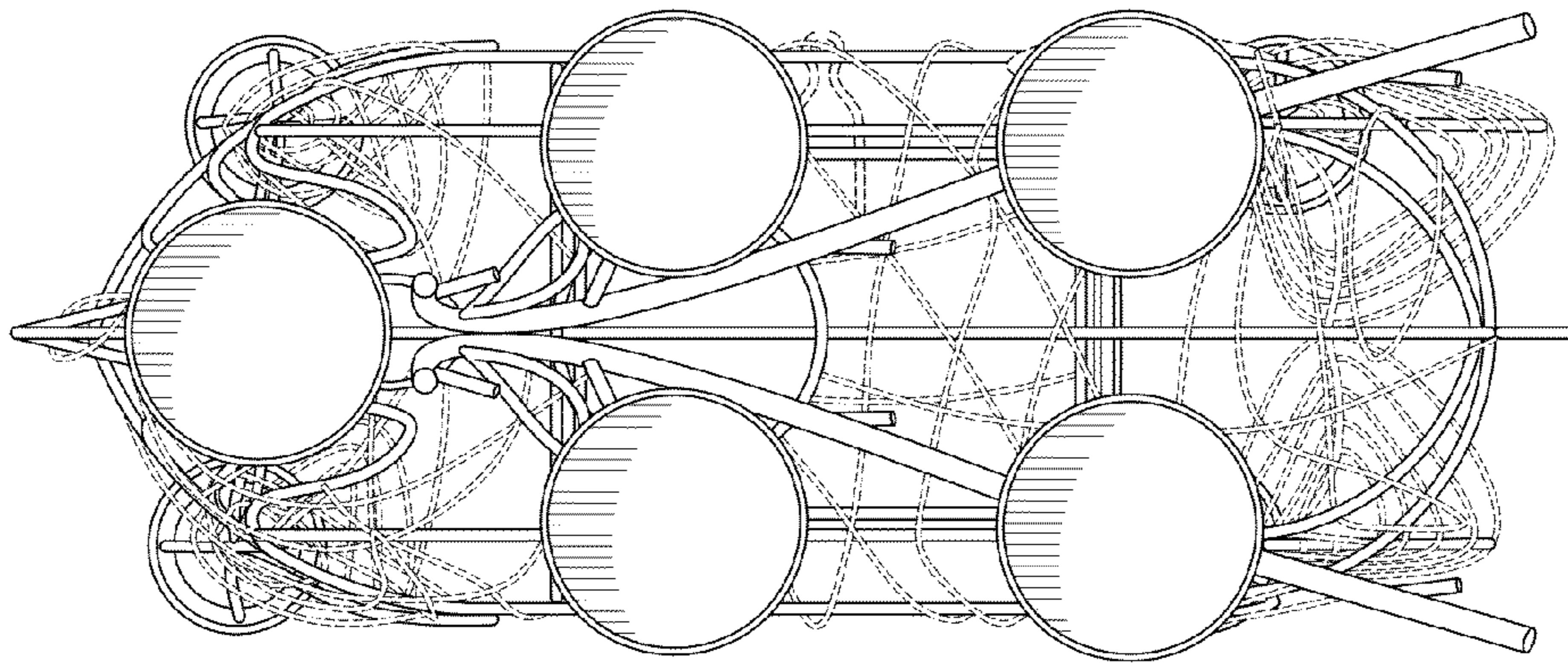
