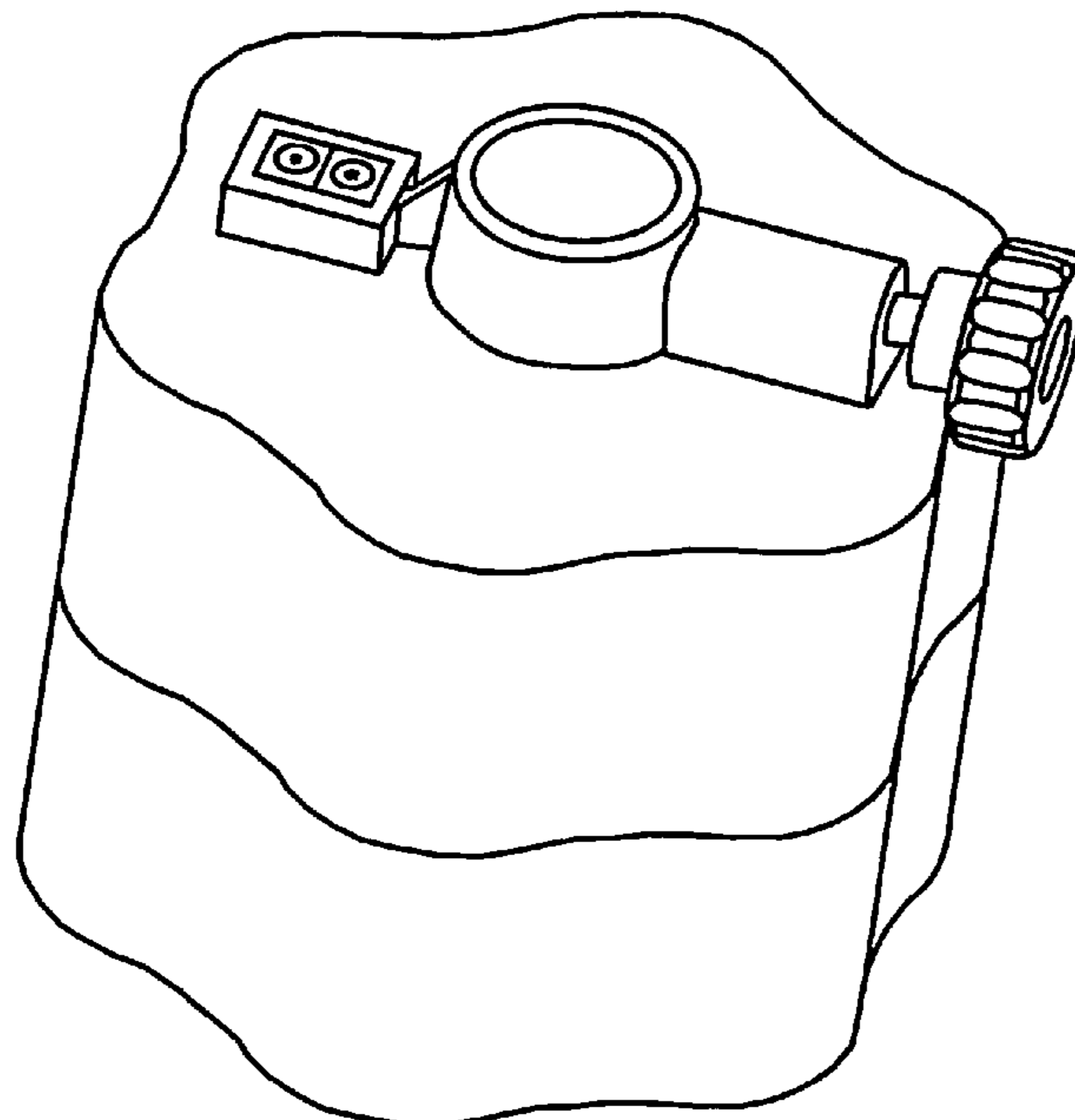
(57) **CLAIM**

The ornamental design for a rechargeable battery pack, as shown and described.

DESCRIPTION

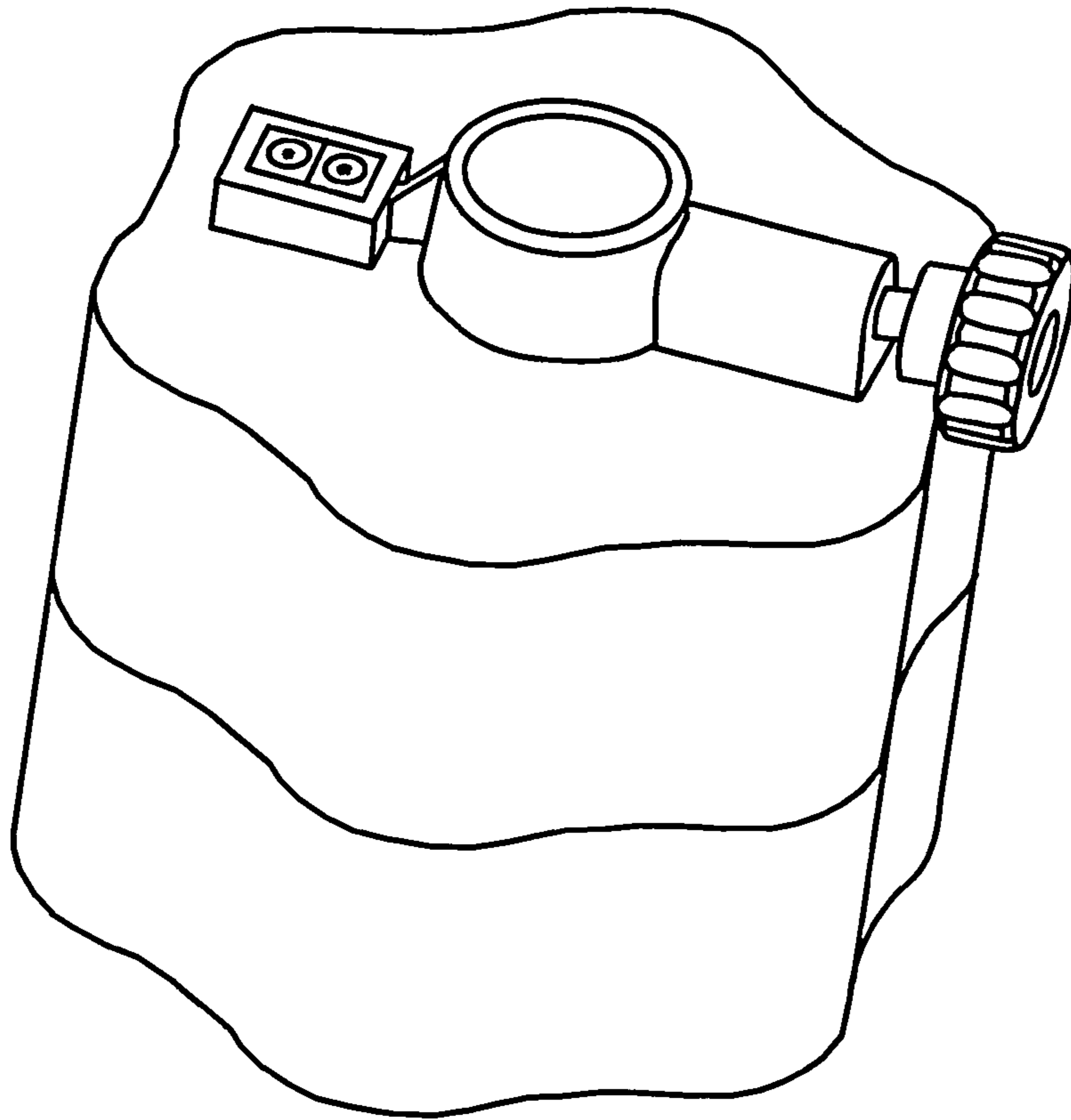


FIG. 1 (Amemded)

FIG. 1 is a perspective view of a rechargeable battery pack showing our new design;
FIG. 2 is a top view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a left view thereof;
FIG. 6 is a right view thereof;
FIG. 7 is a bottom view thereof; and,

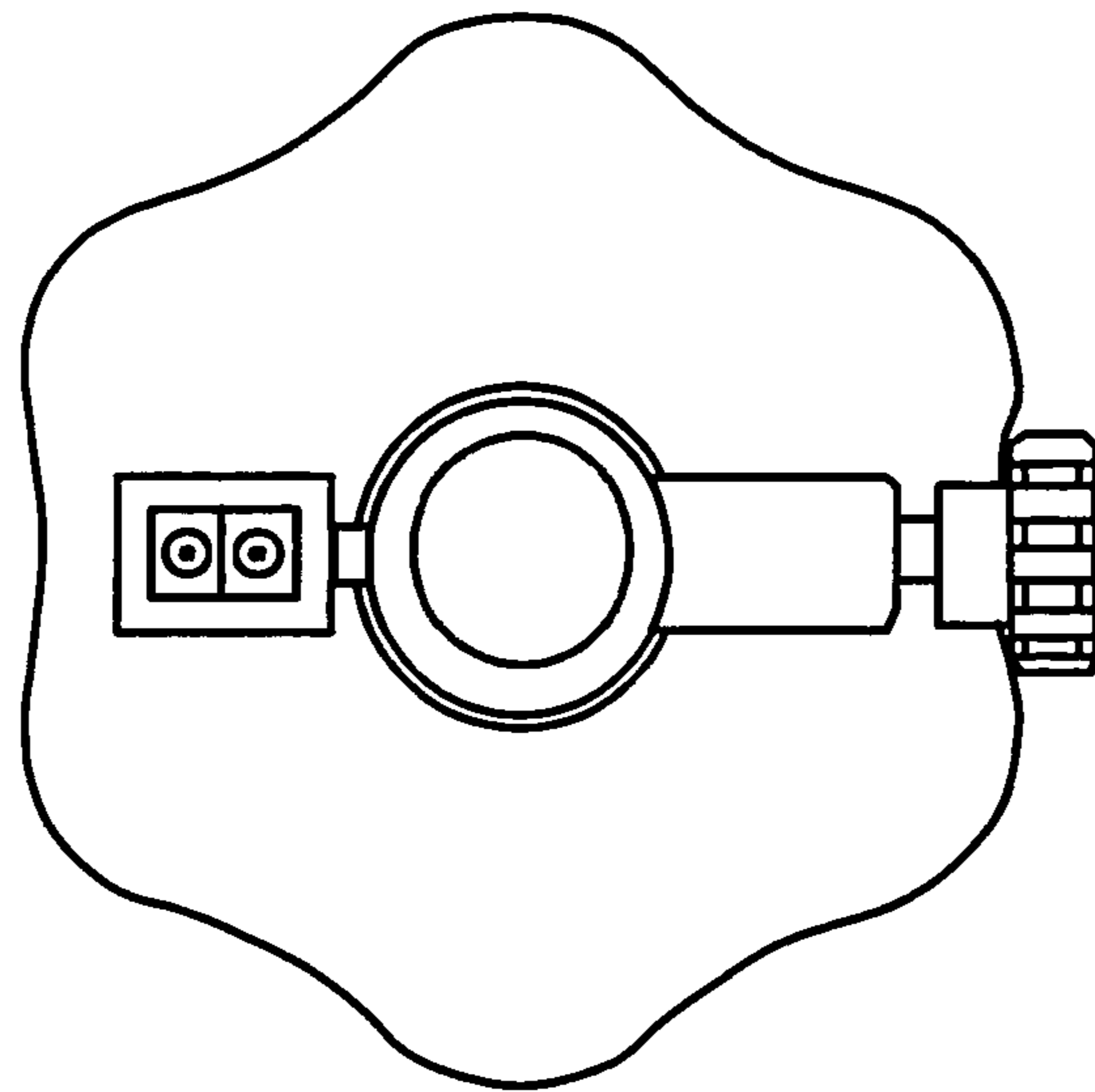

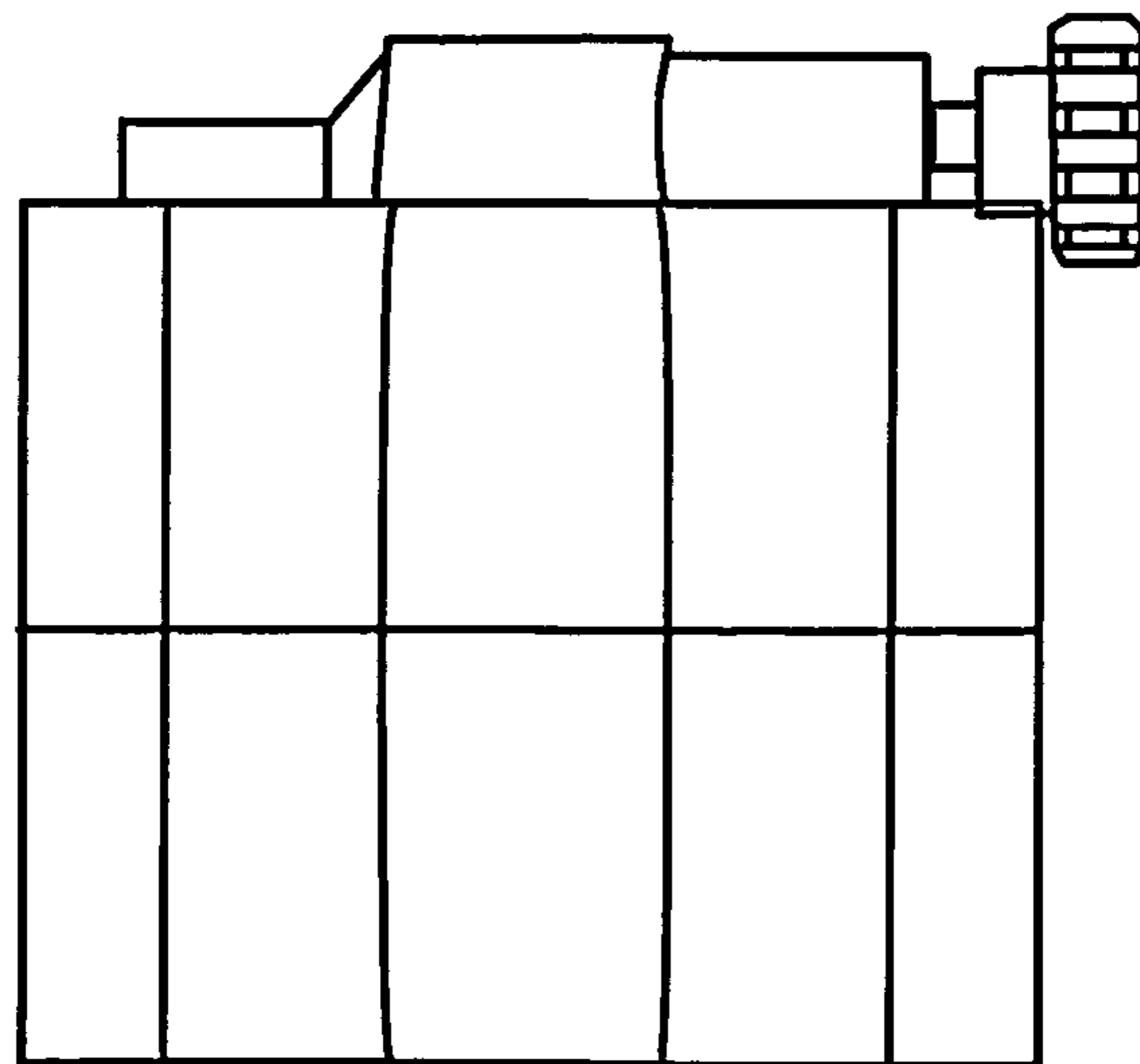

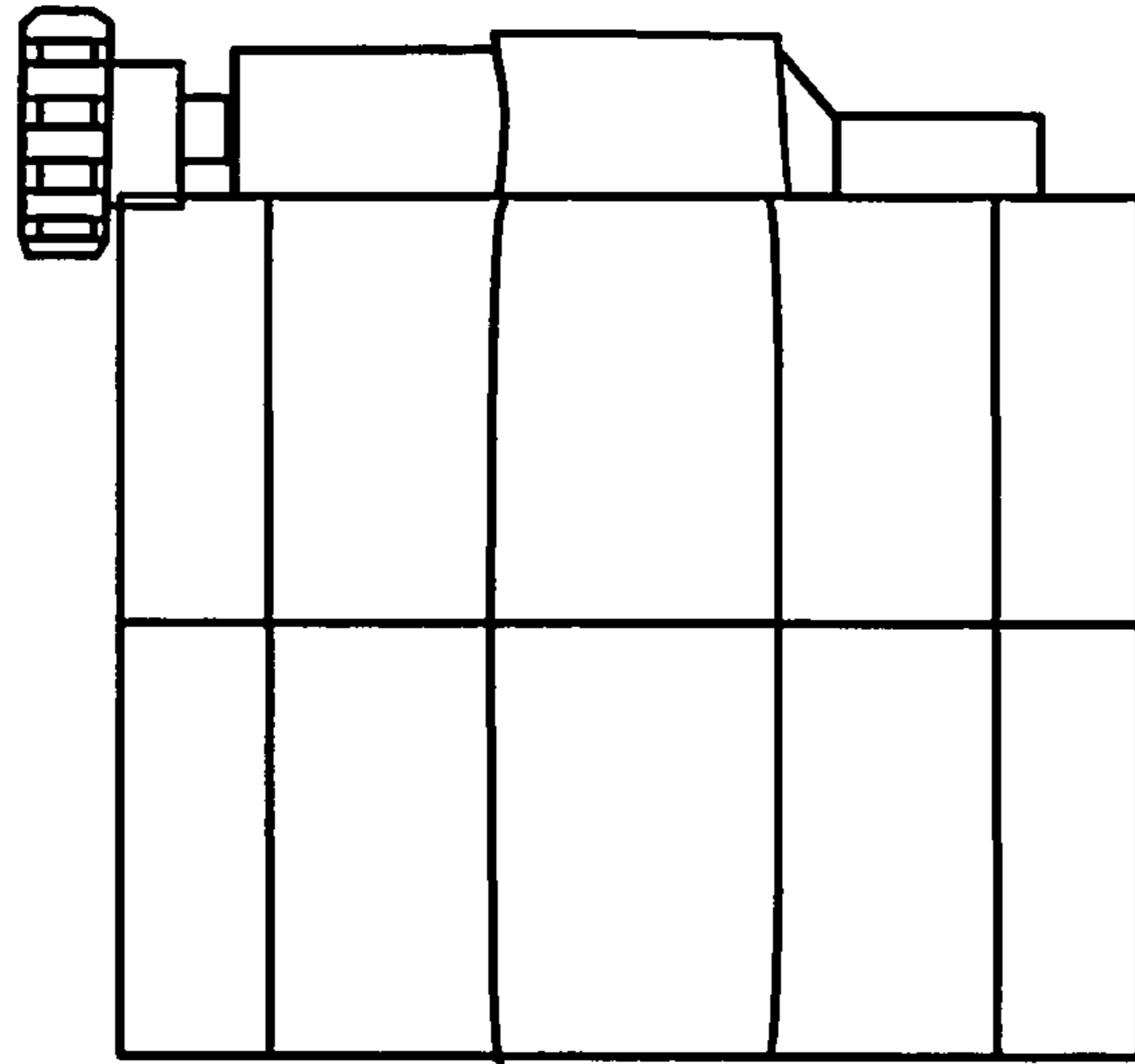

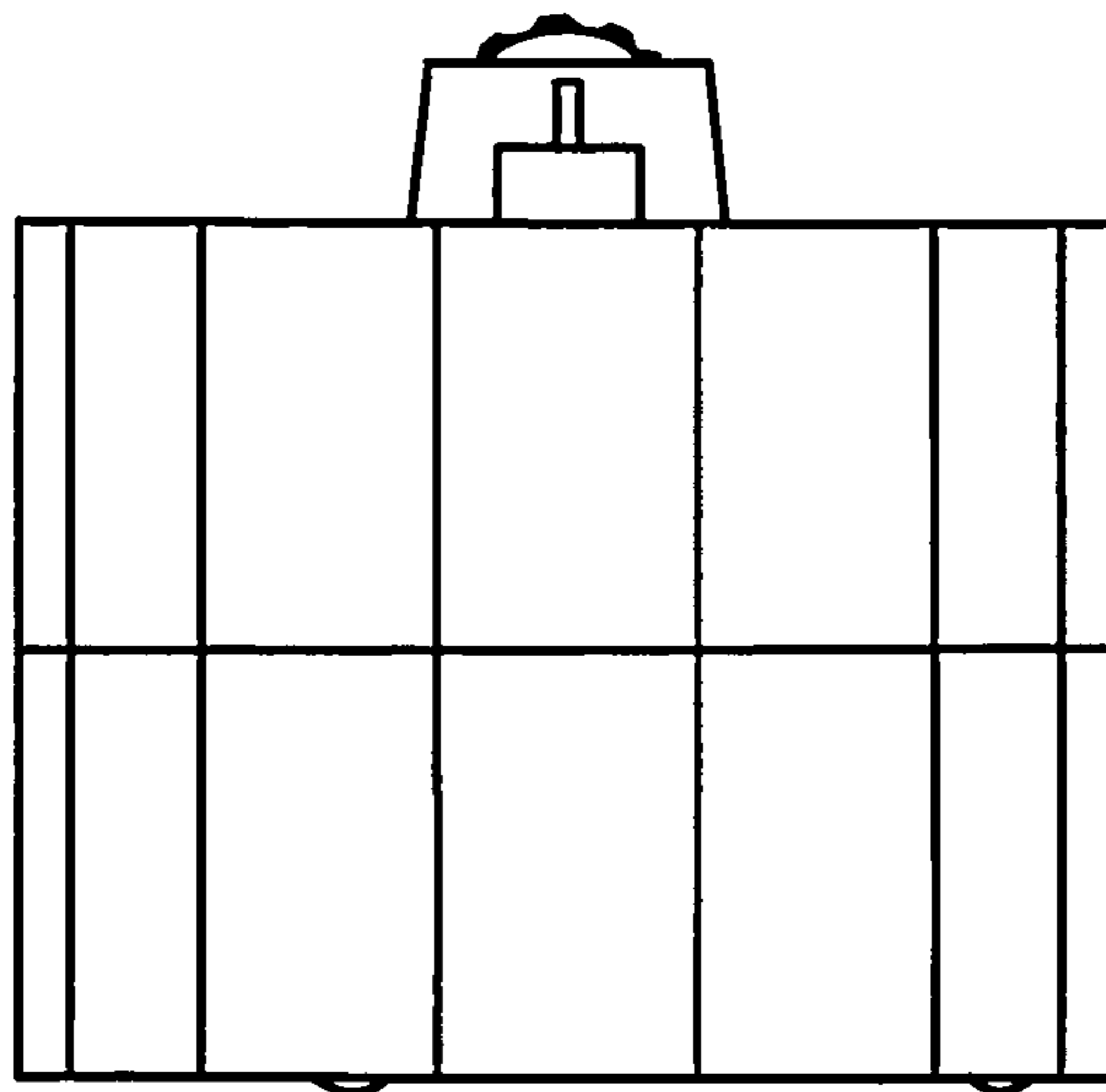

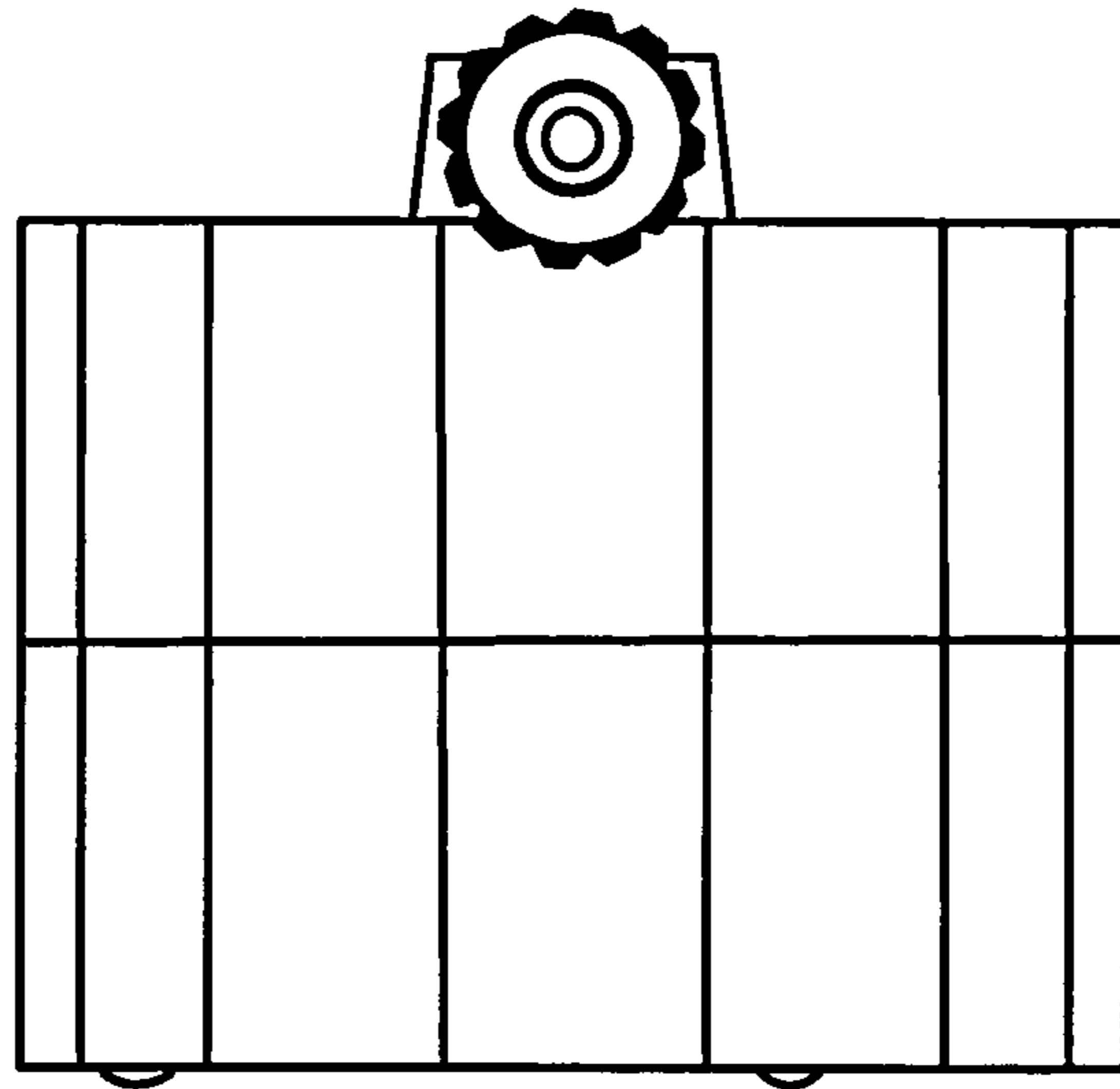

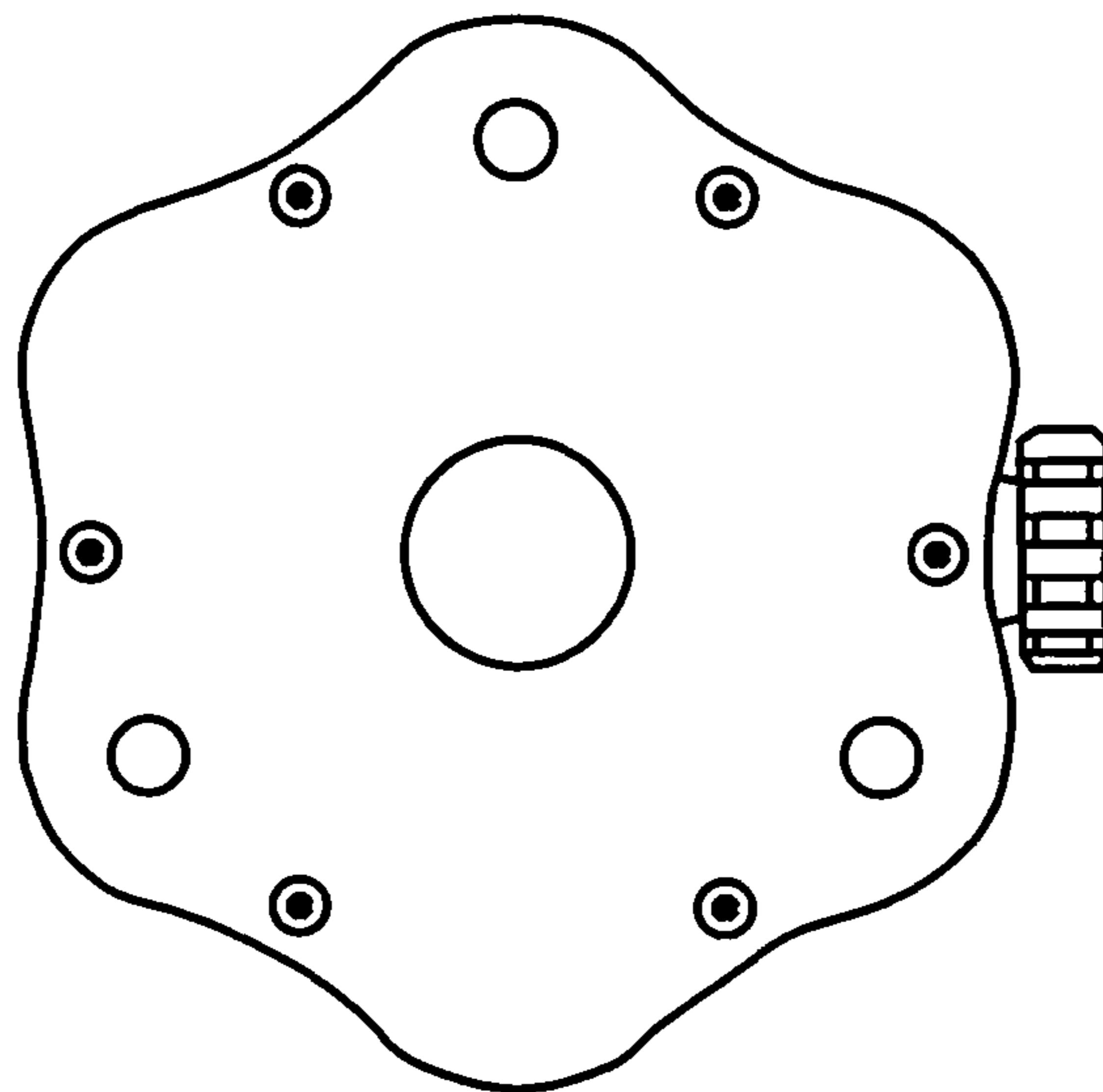

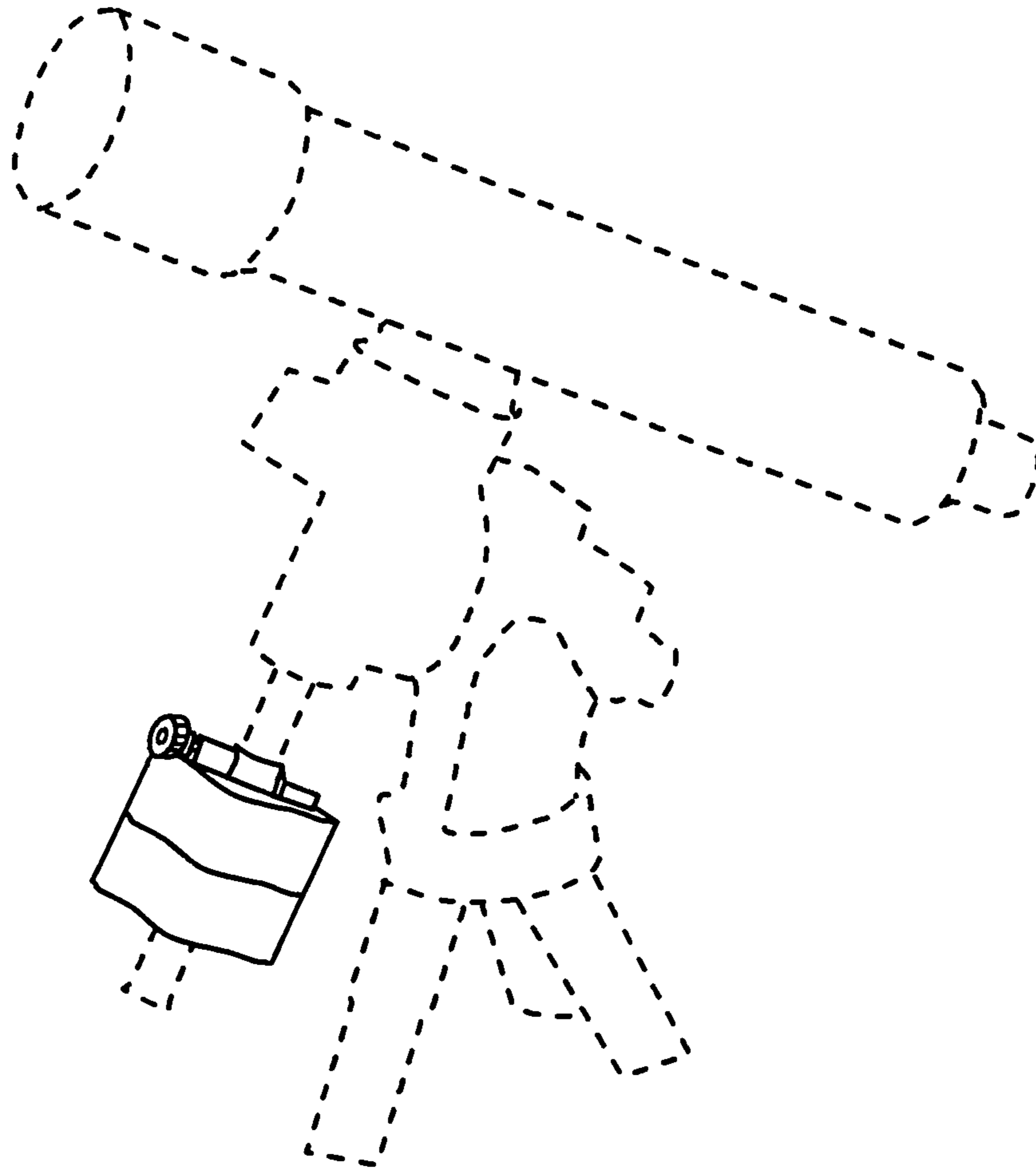


FIG. 8 (Amended)
