(57) **CLAIM**

The ornamental design for an electronic charging device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of one embodiment of an electronic charging device showing my new design.

FIG. 2 is a top plan view of the embodiment of the electronic charging device shown in FIG. 1.

FIG. 3 is a bottom plan view of the embodiment of the electronic charging device shown in FIG. 1.

FIG. 4 is a front elevational view of the embodiment of the electronic charging device as shown in FIG. 1.

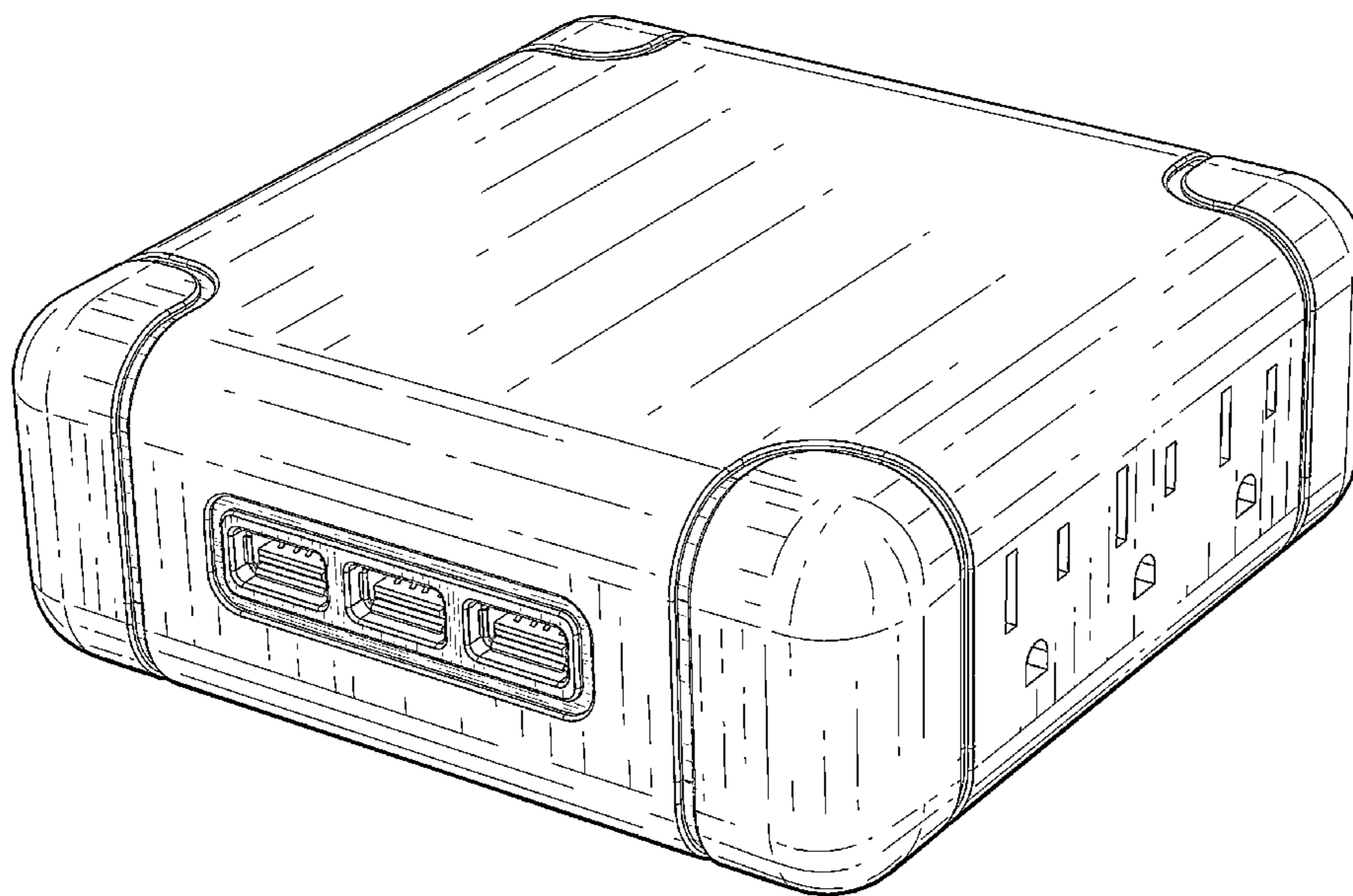
FIG. 5 is a rear elevational view of the embodiment of the electronic charging device shown in FIG. 1 with an opening shown in broken lines to demonstrate where the attached or removable AC plug is located.

FIG. 7 is a left elevational view of the embodiment of the electronic charging device shown in FIG. 1.

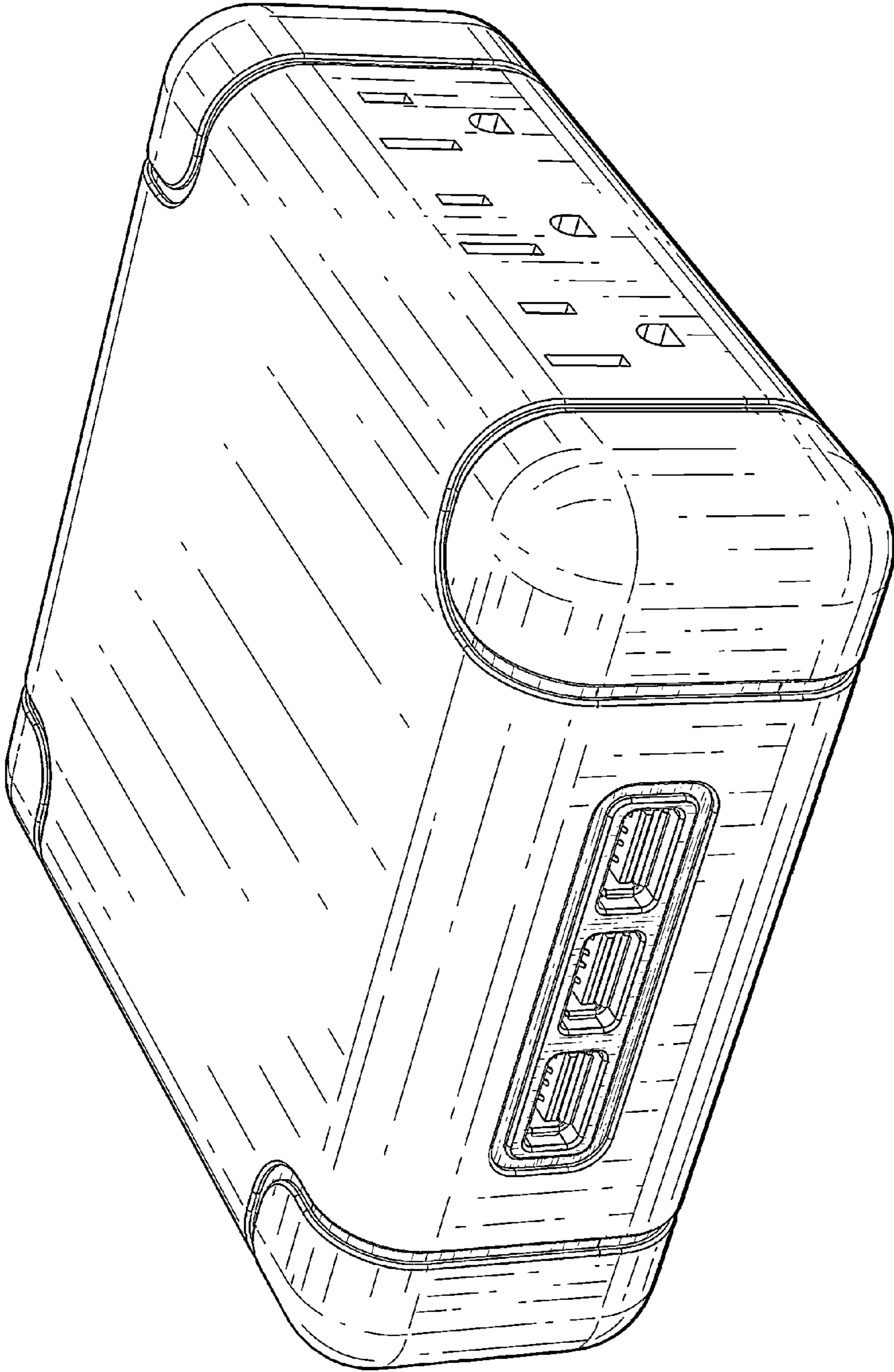

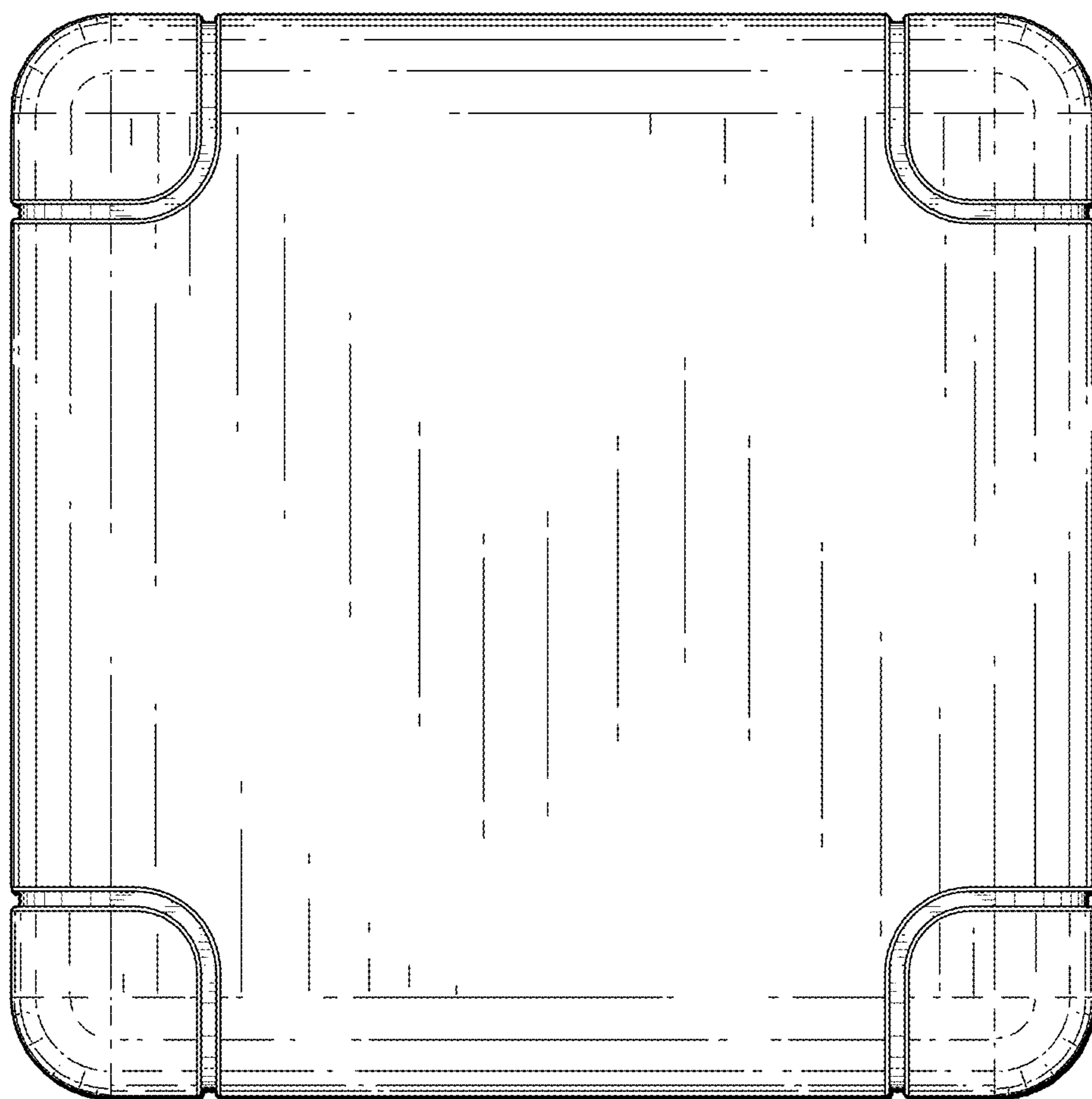

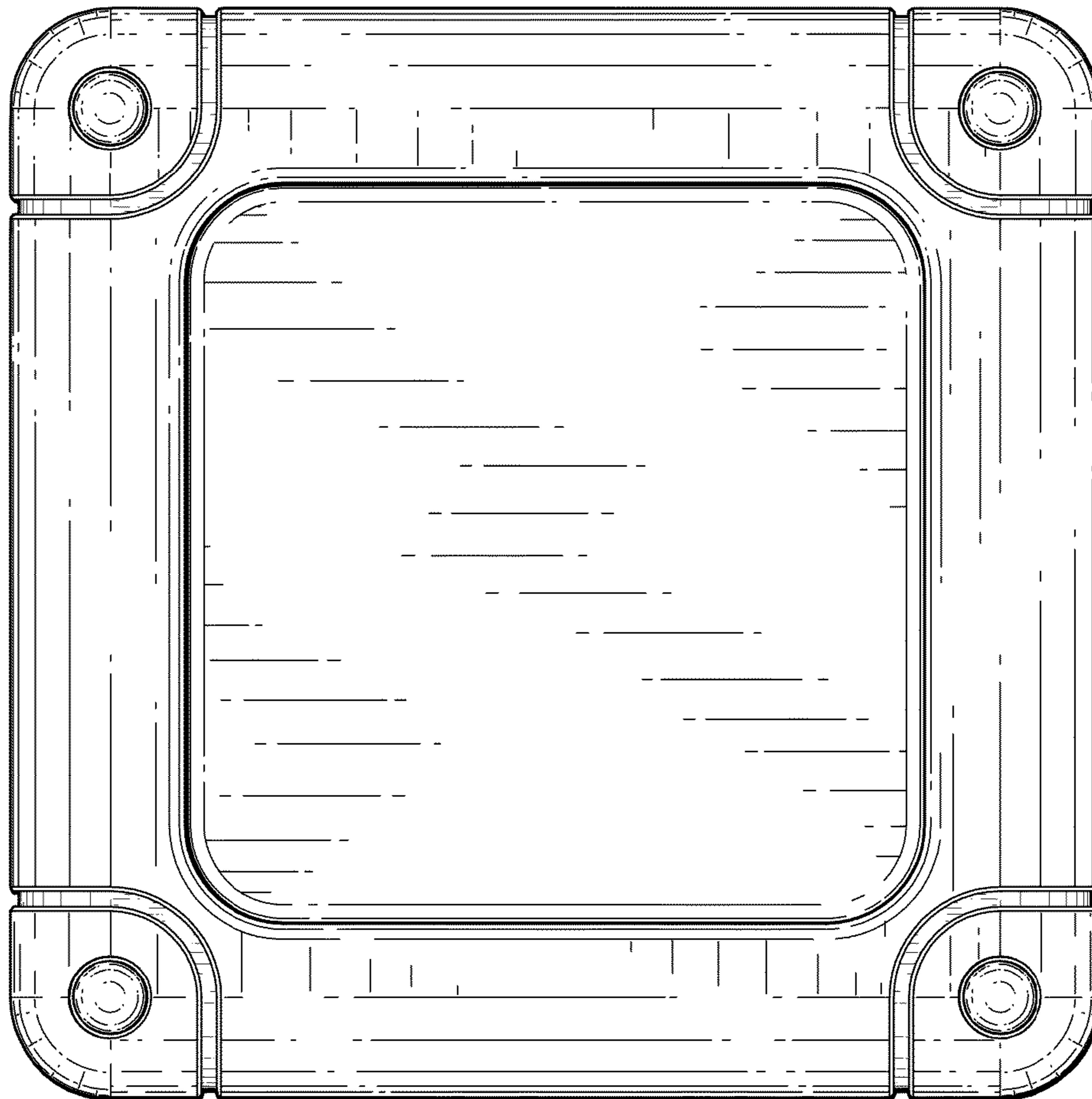

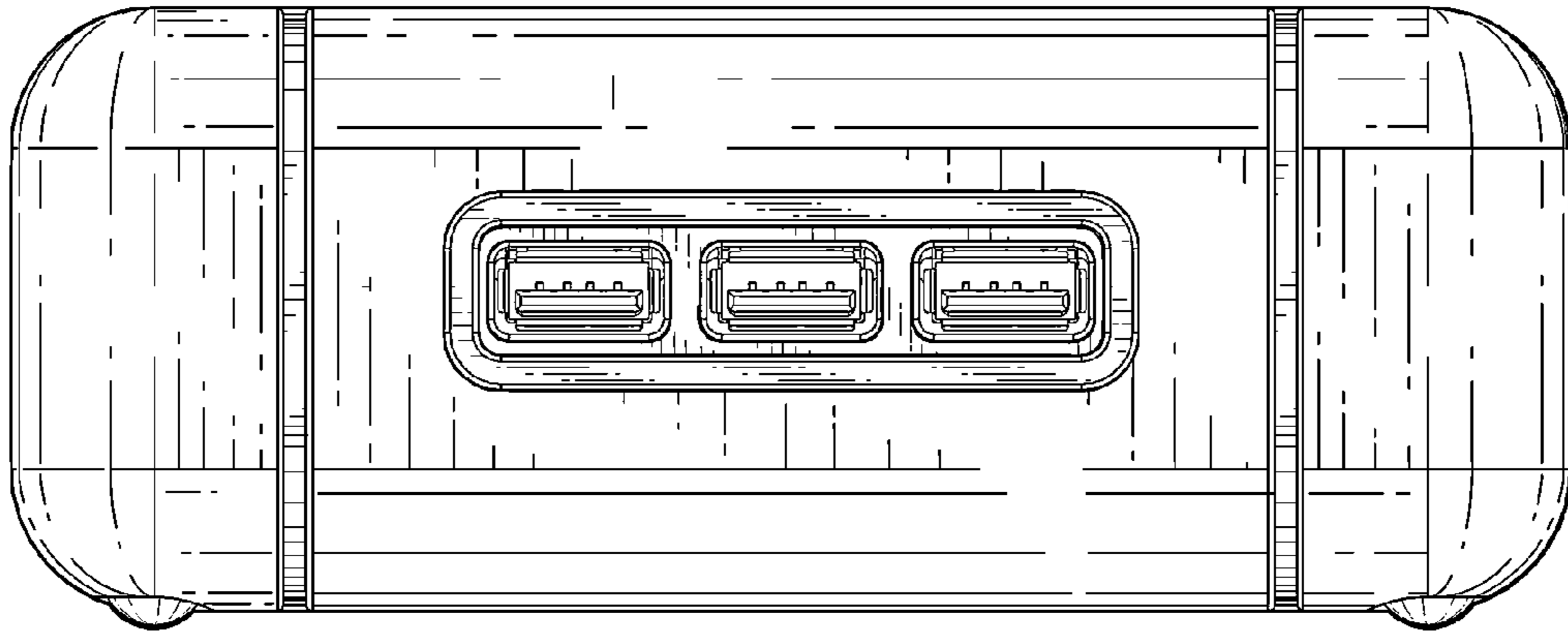

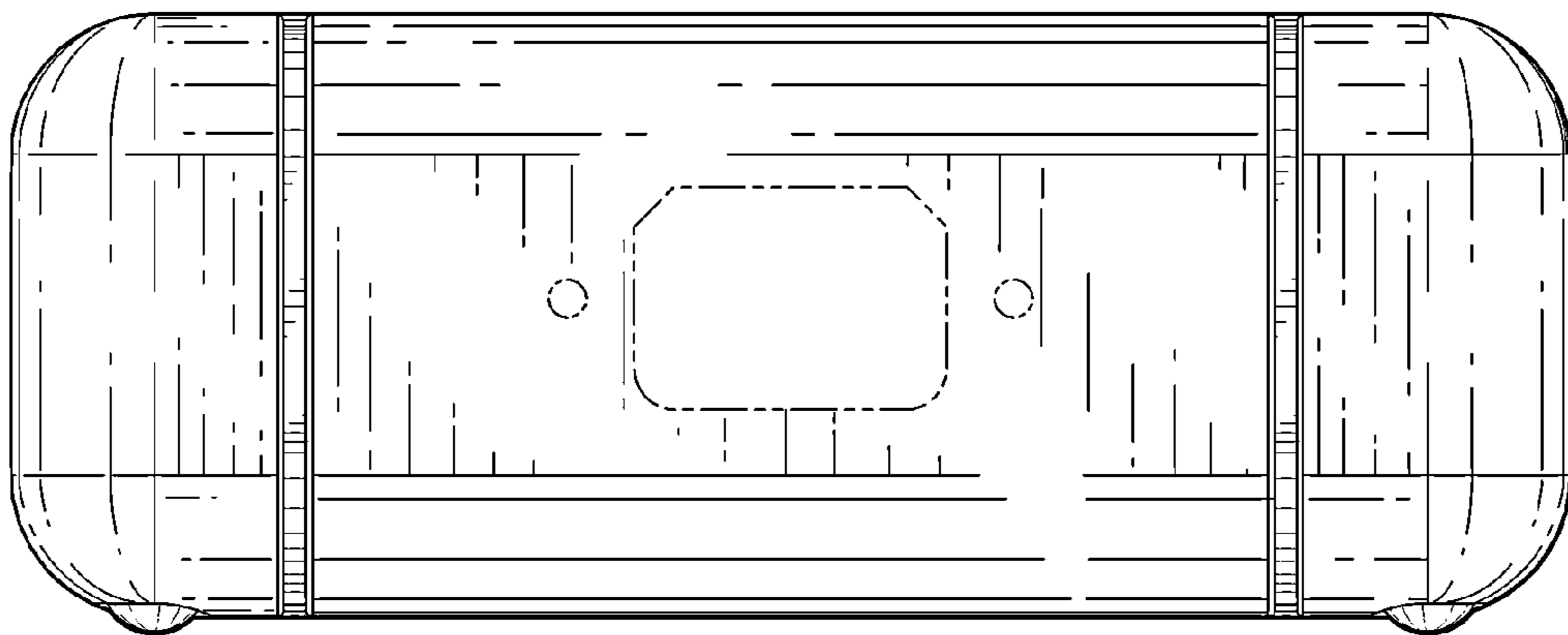

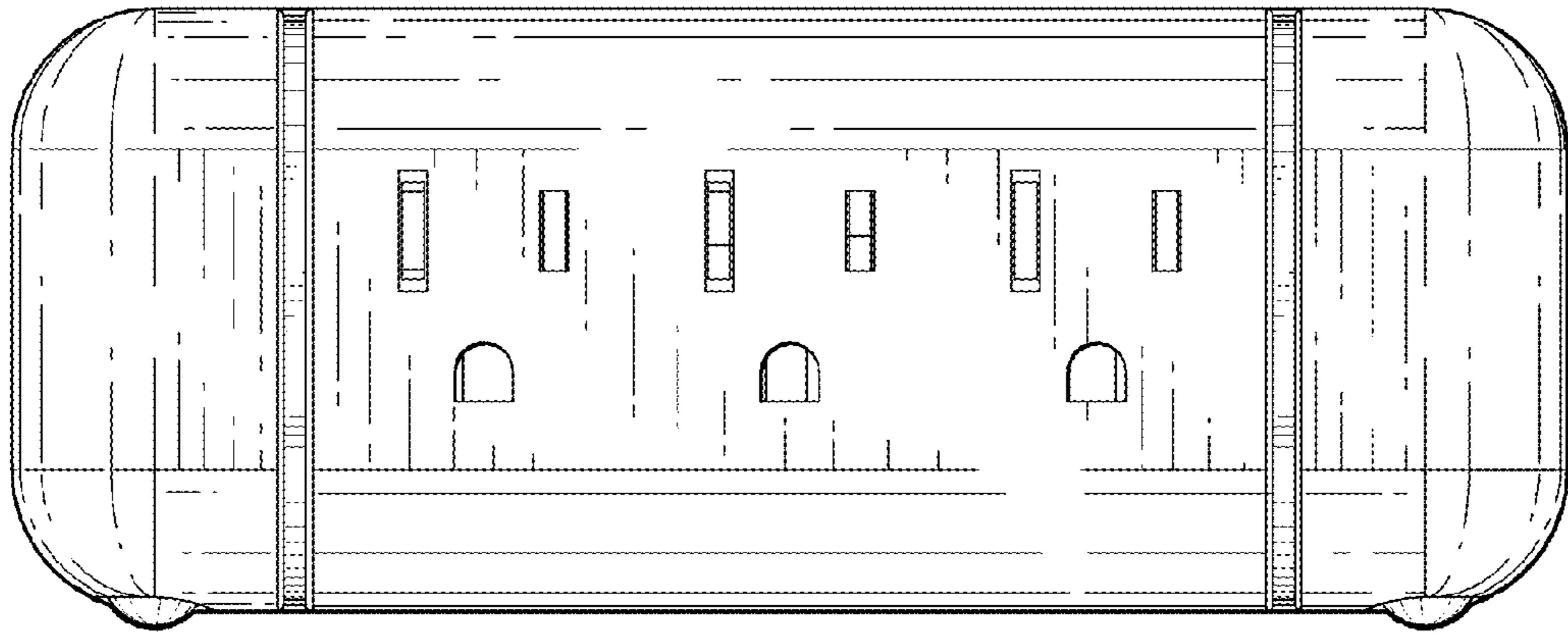

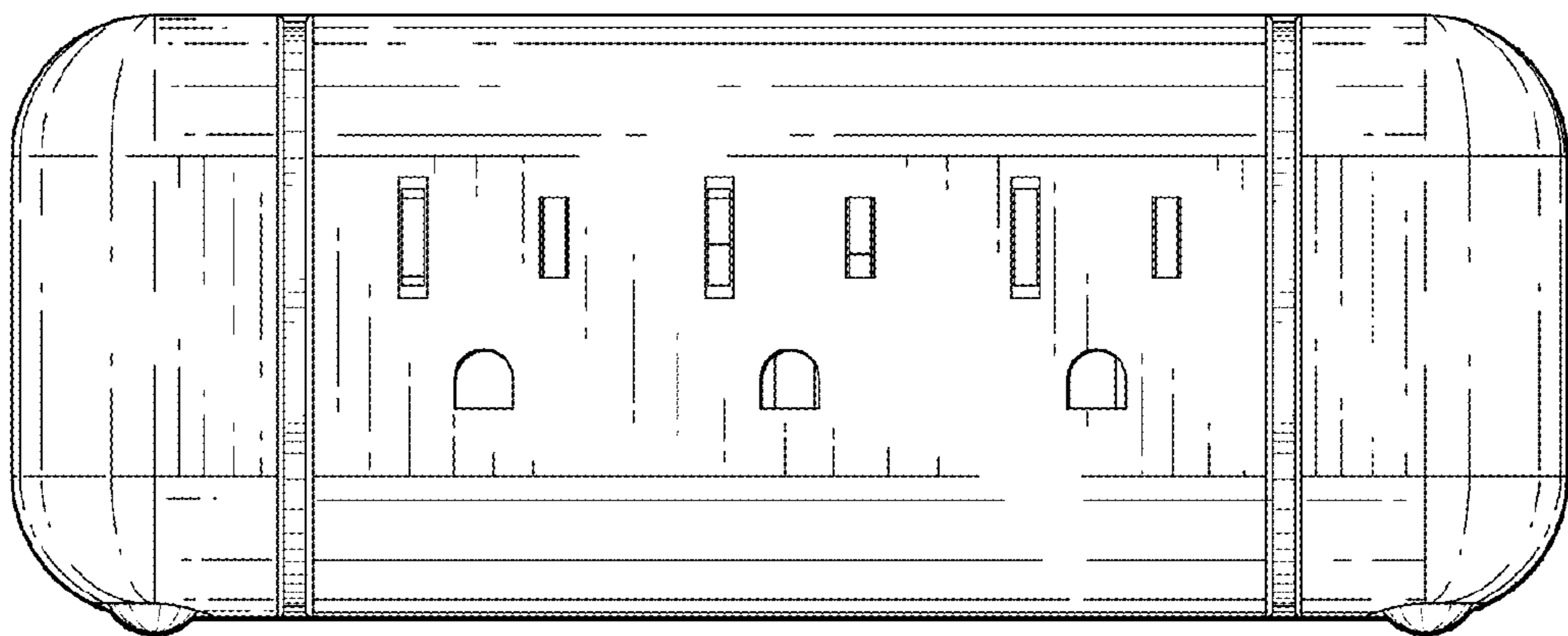
