 FIG. 11 is a front isometric view of a stand, but showing the stand in use.

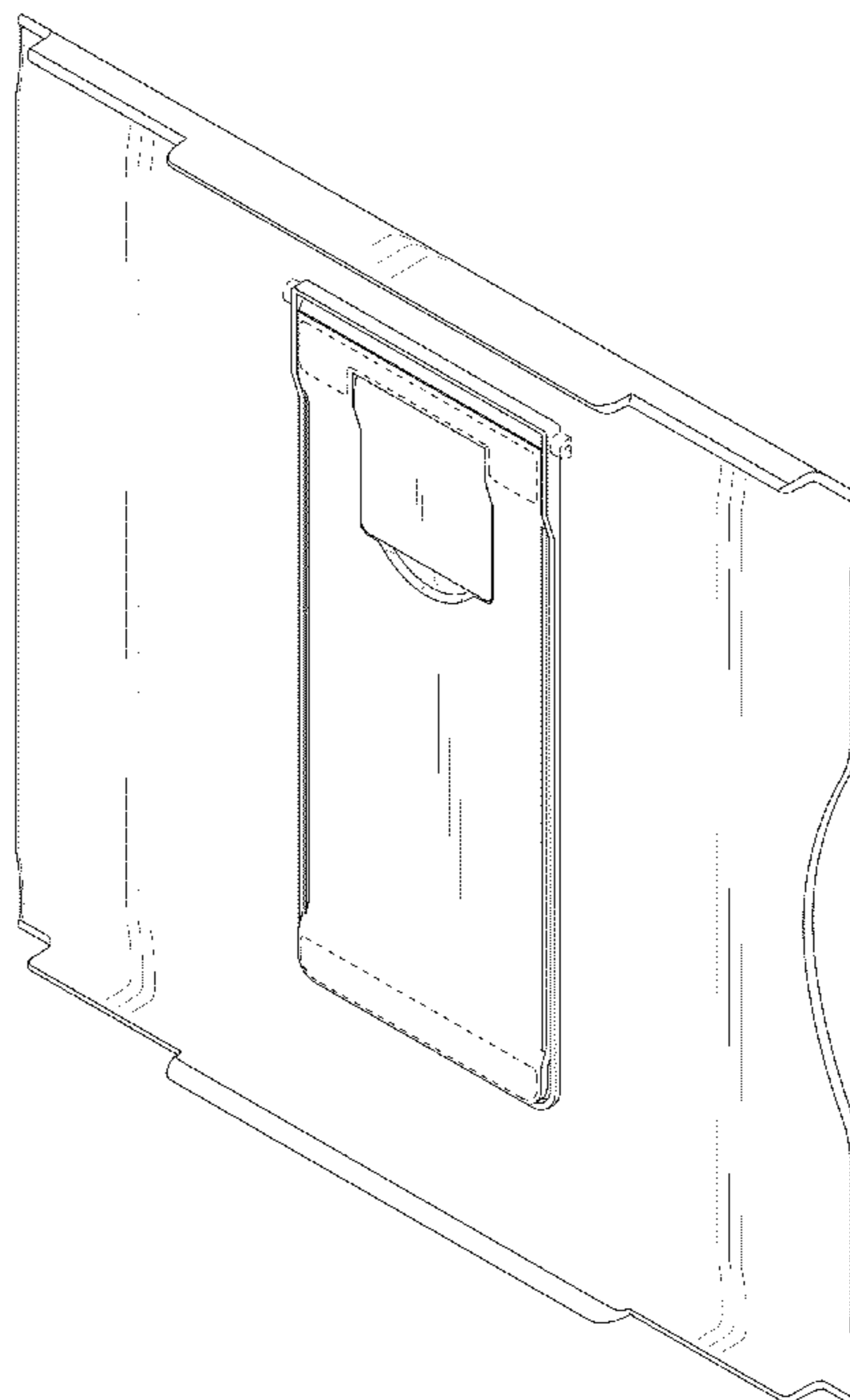

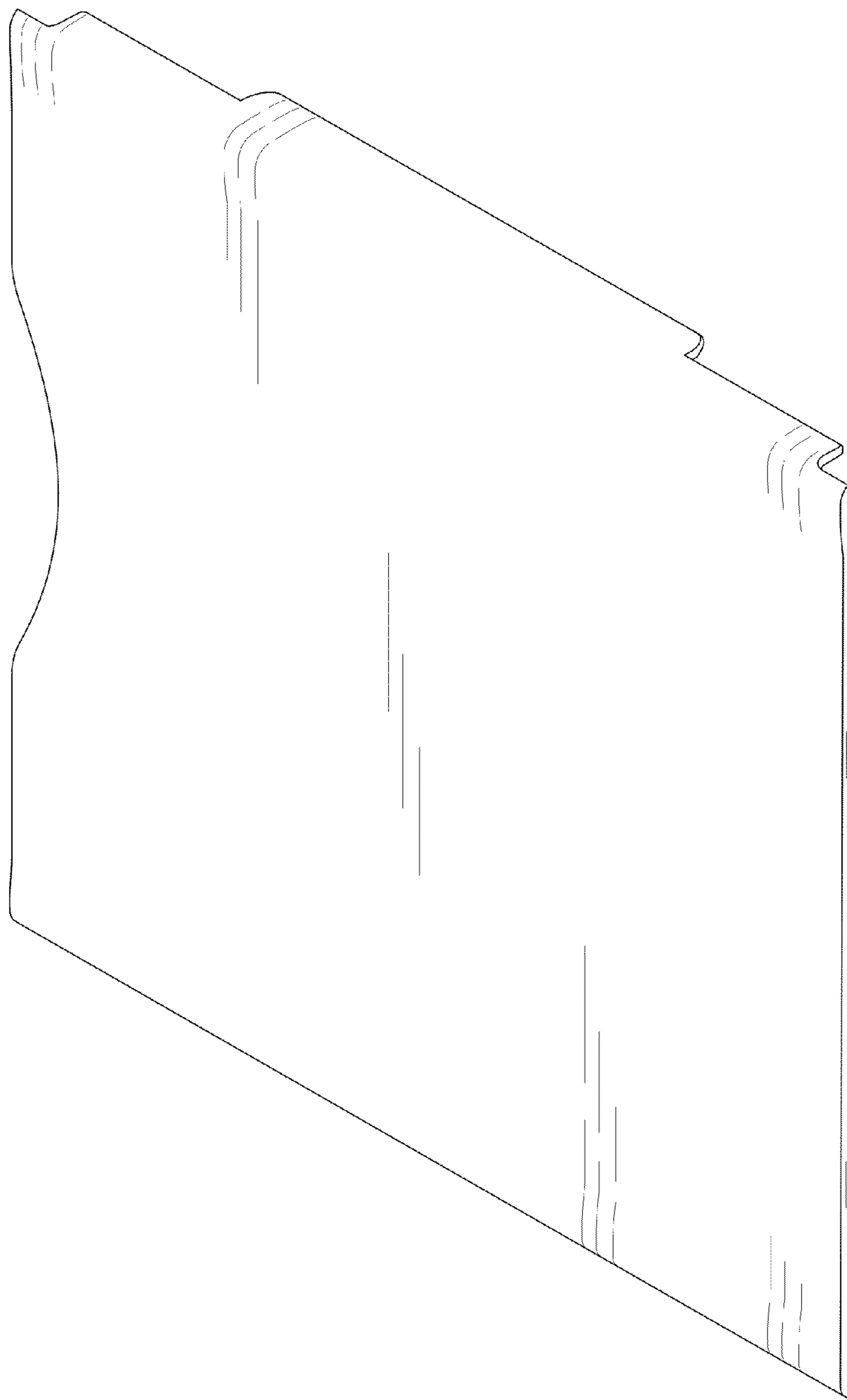

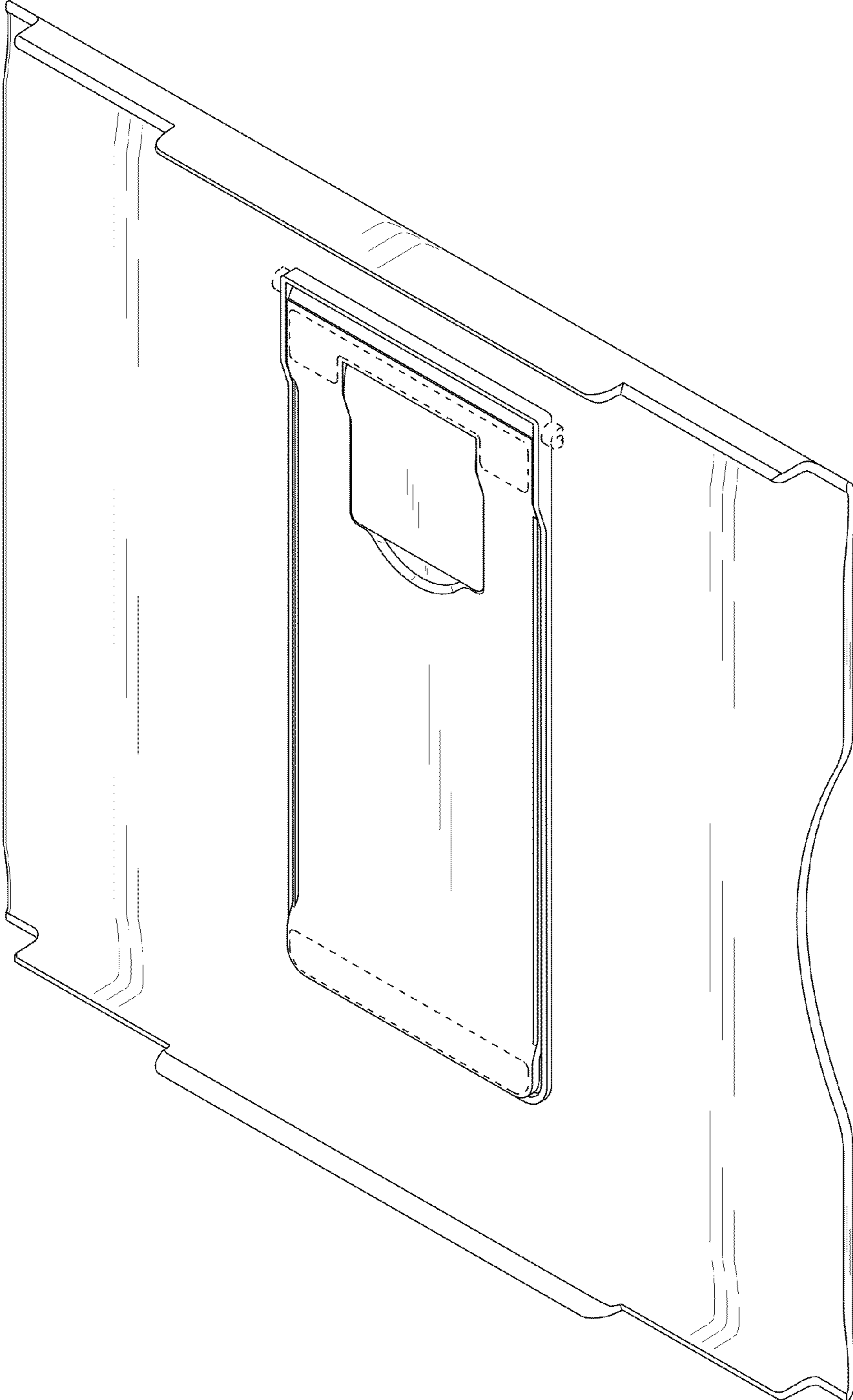

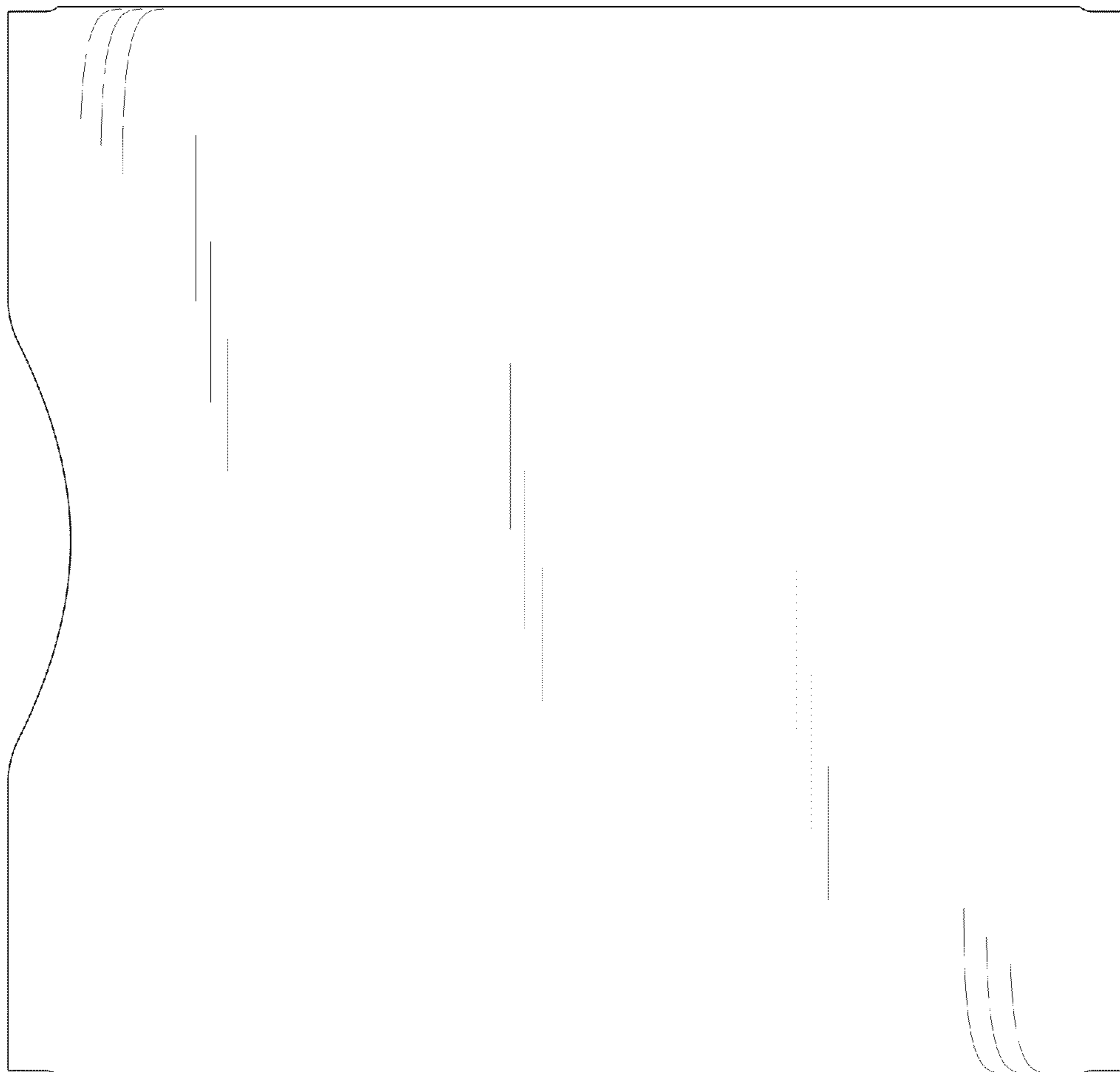

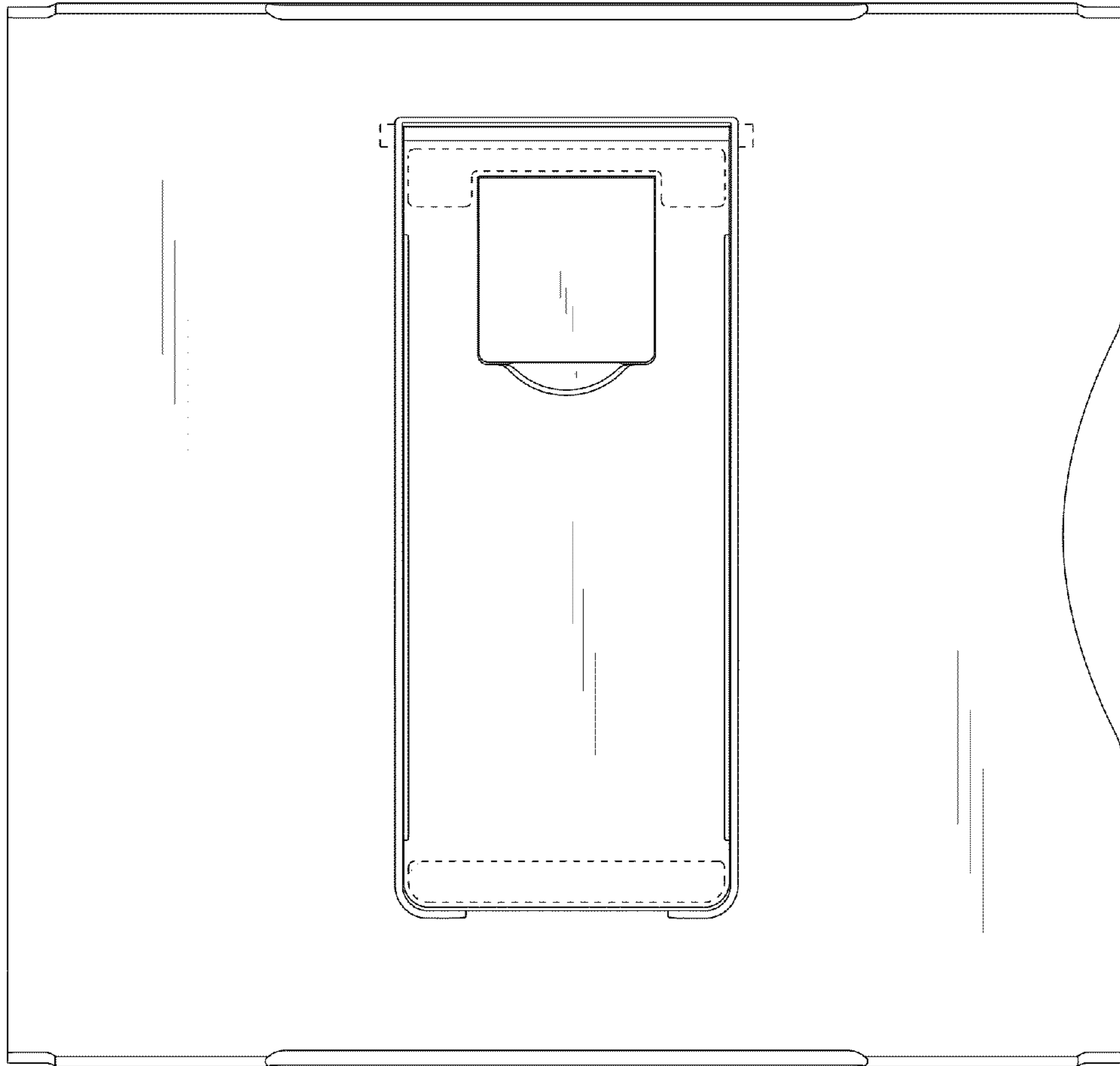

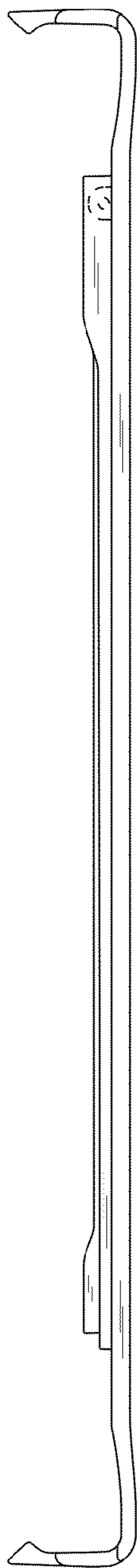

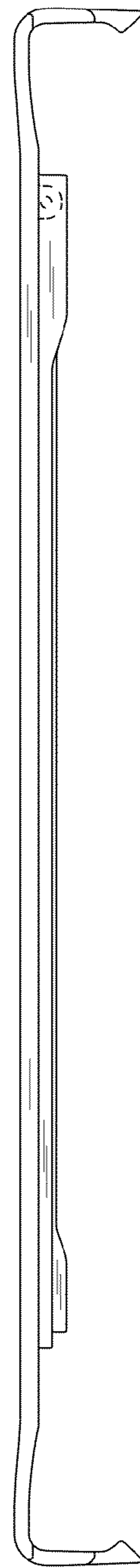

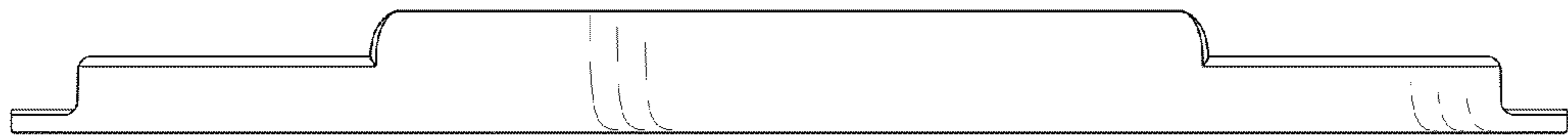

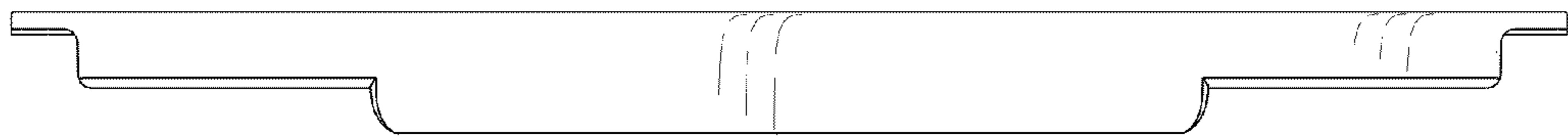

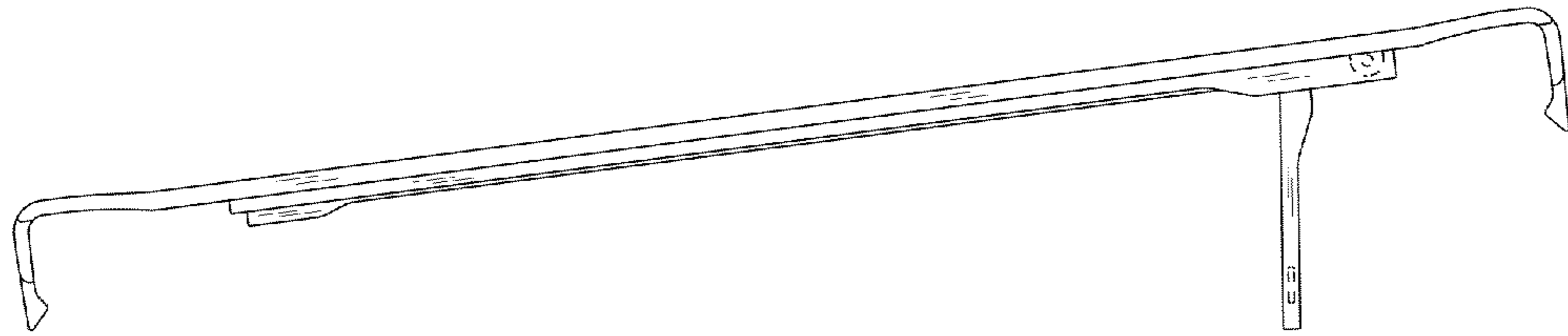

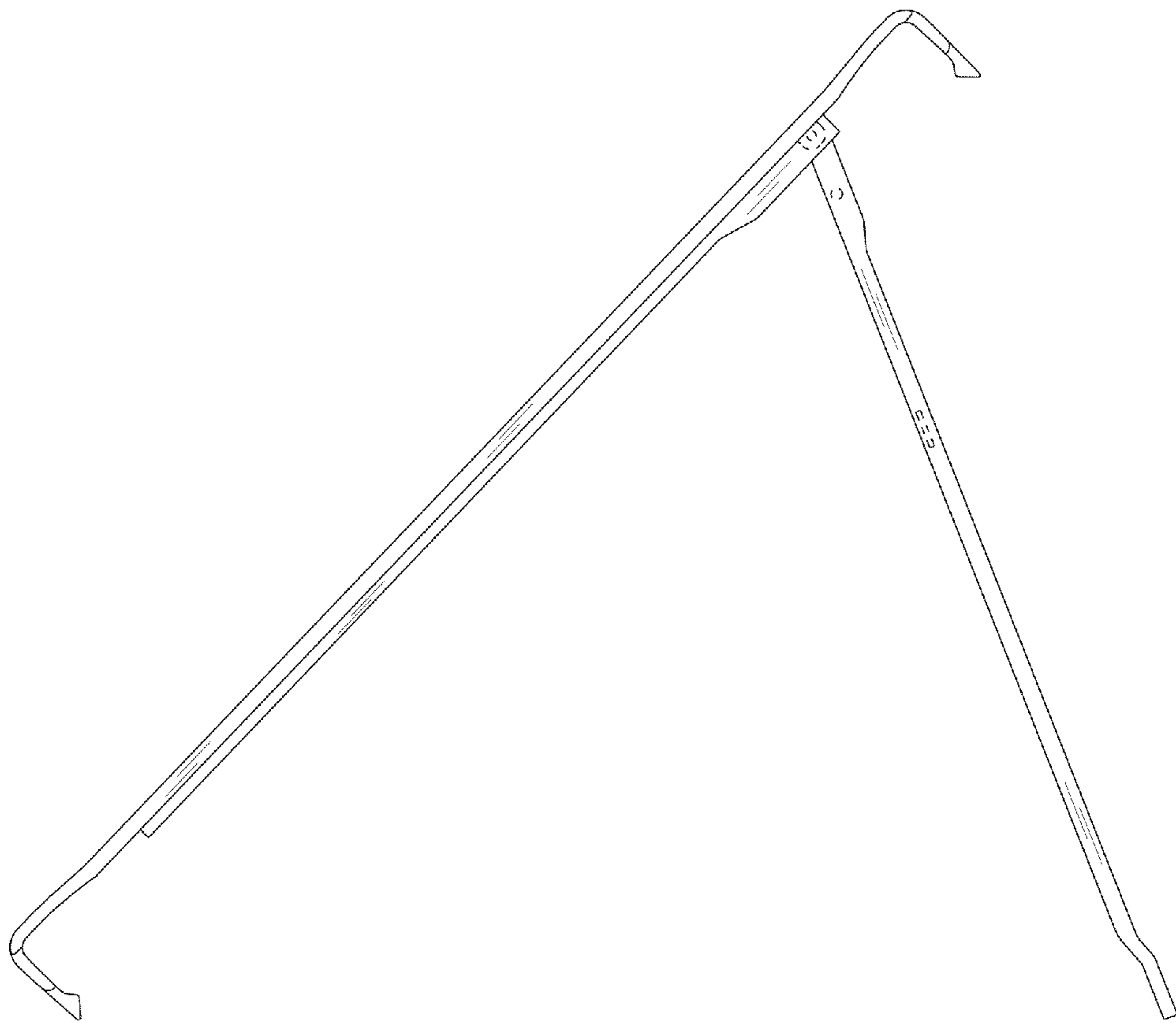

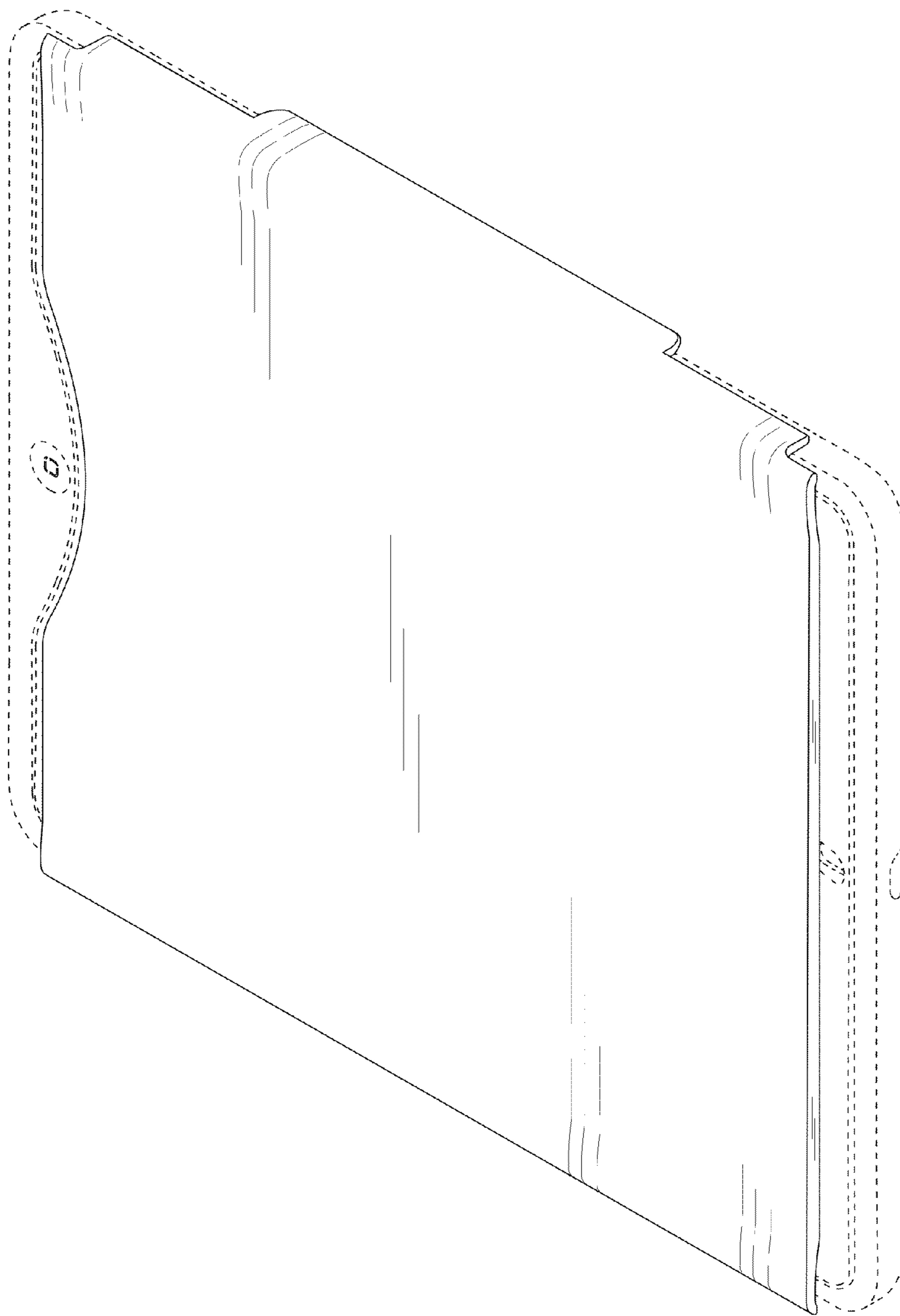
