 FIG. 4 is a front view of display screen with icon of FIG. 2 shown on a device.

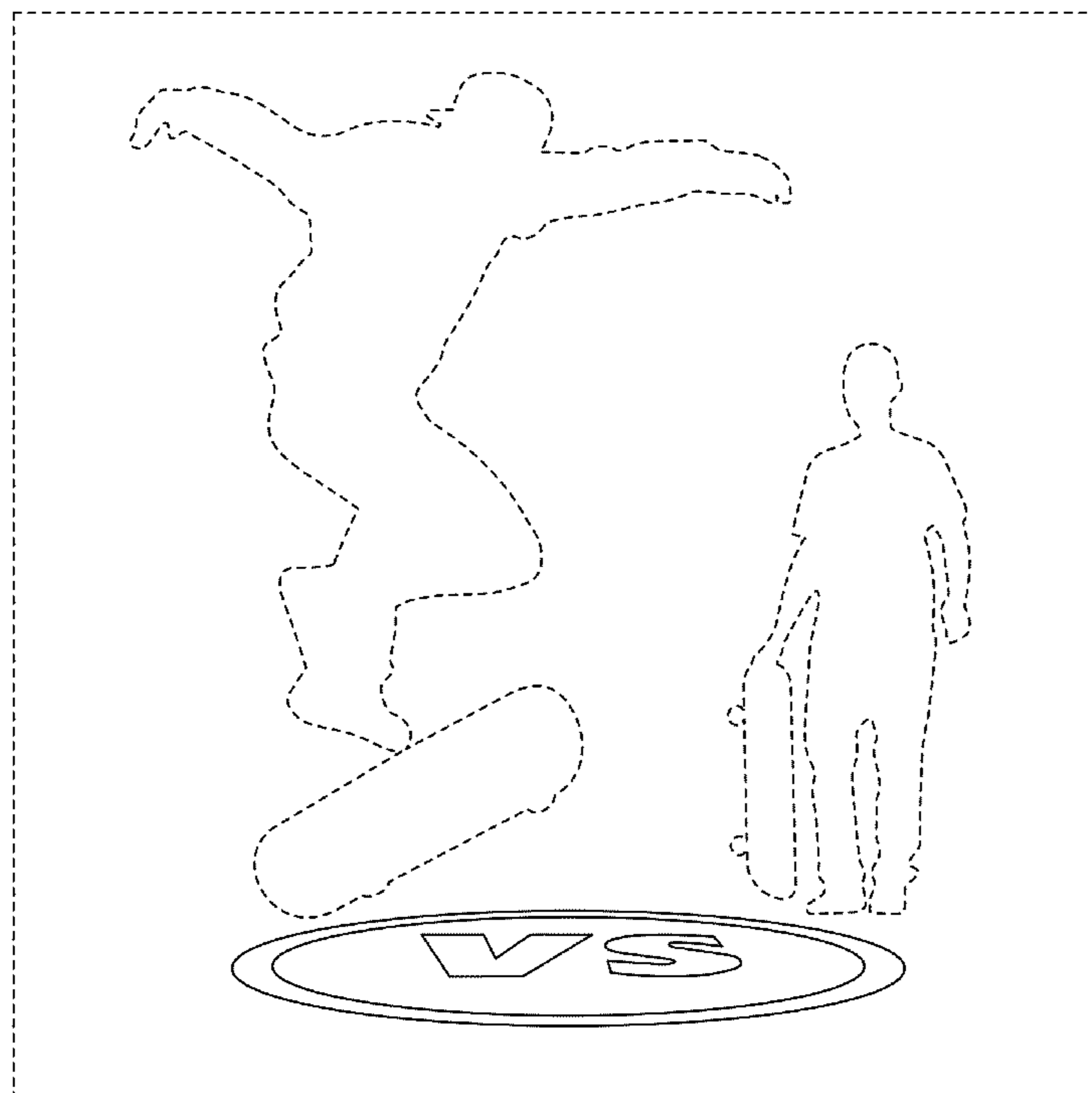

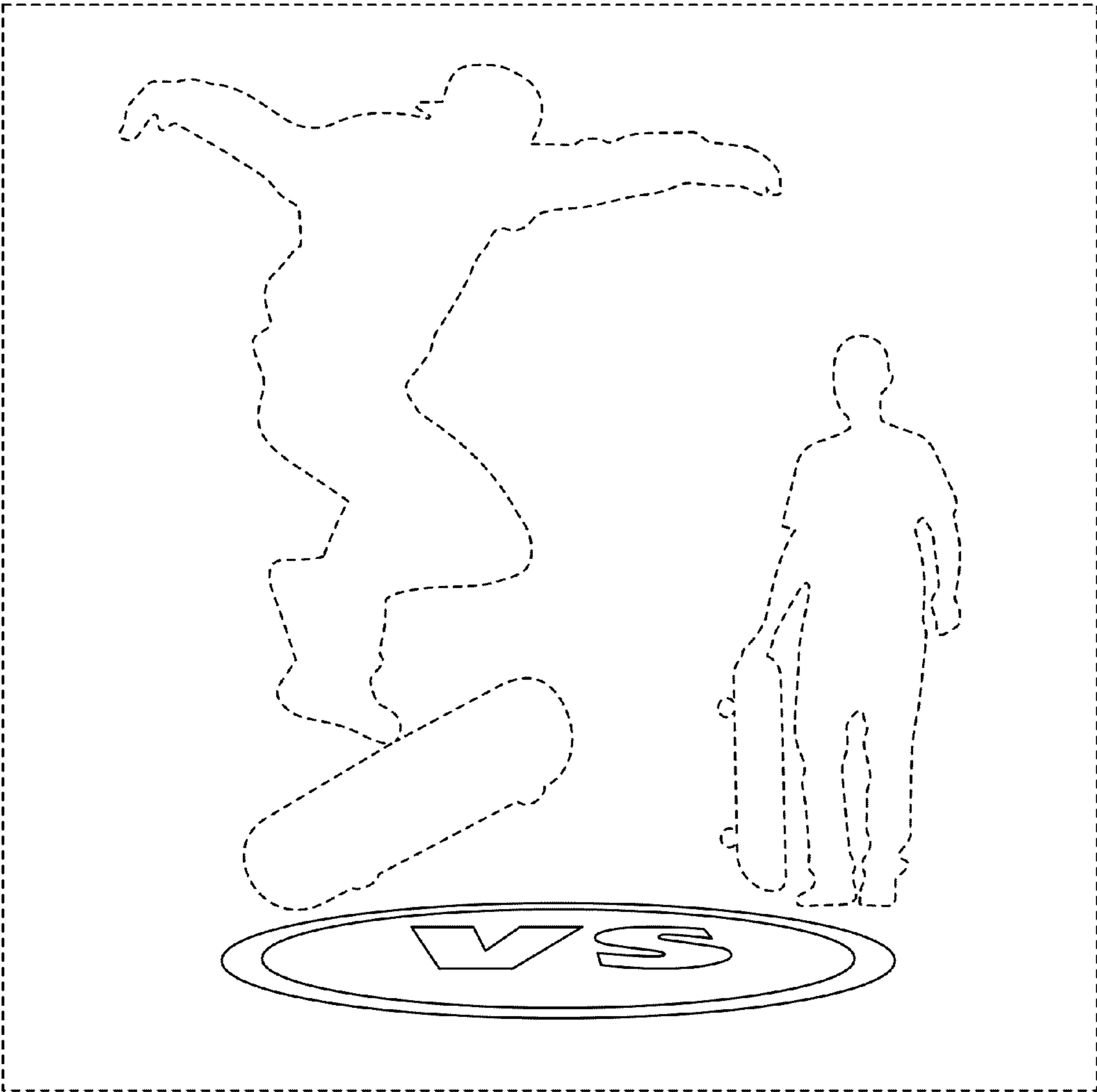

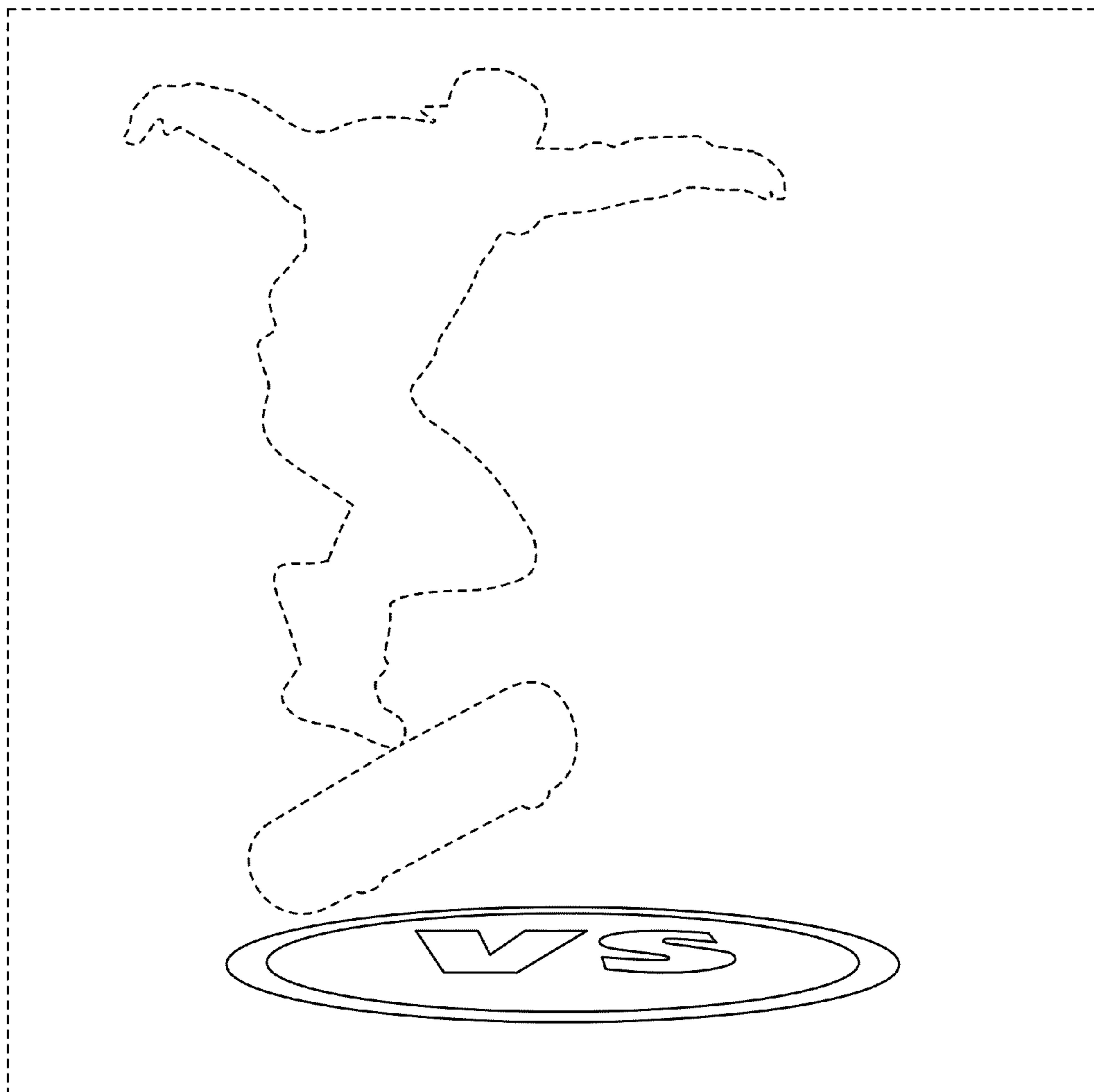

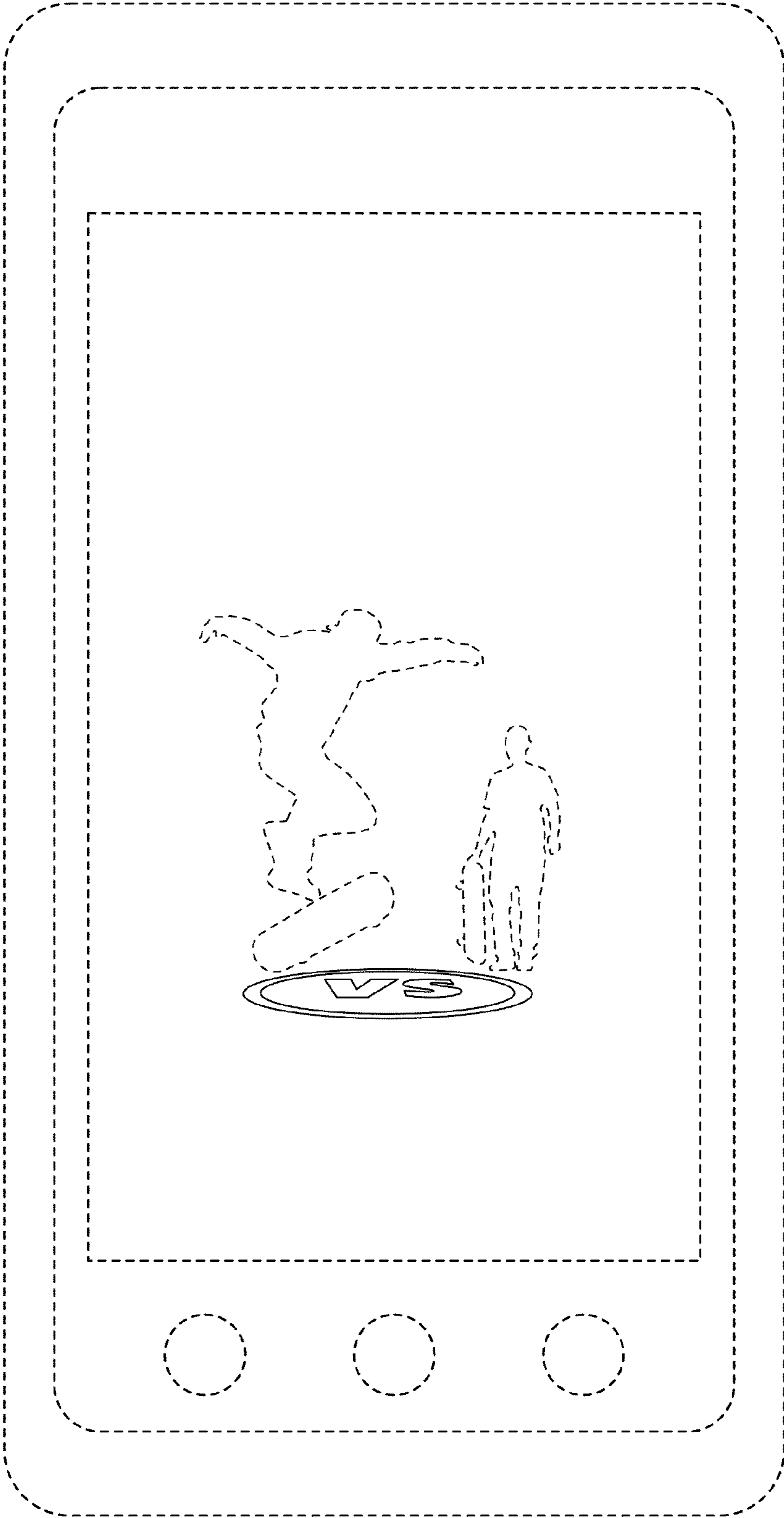

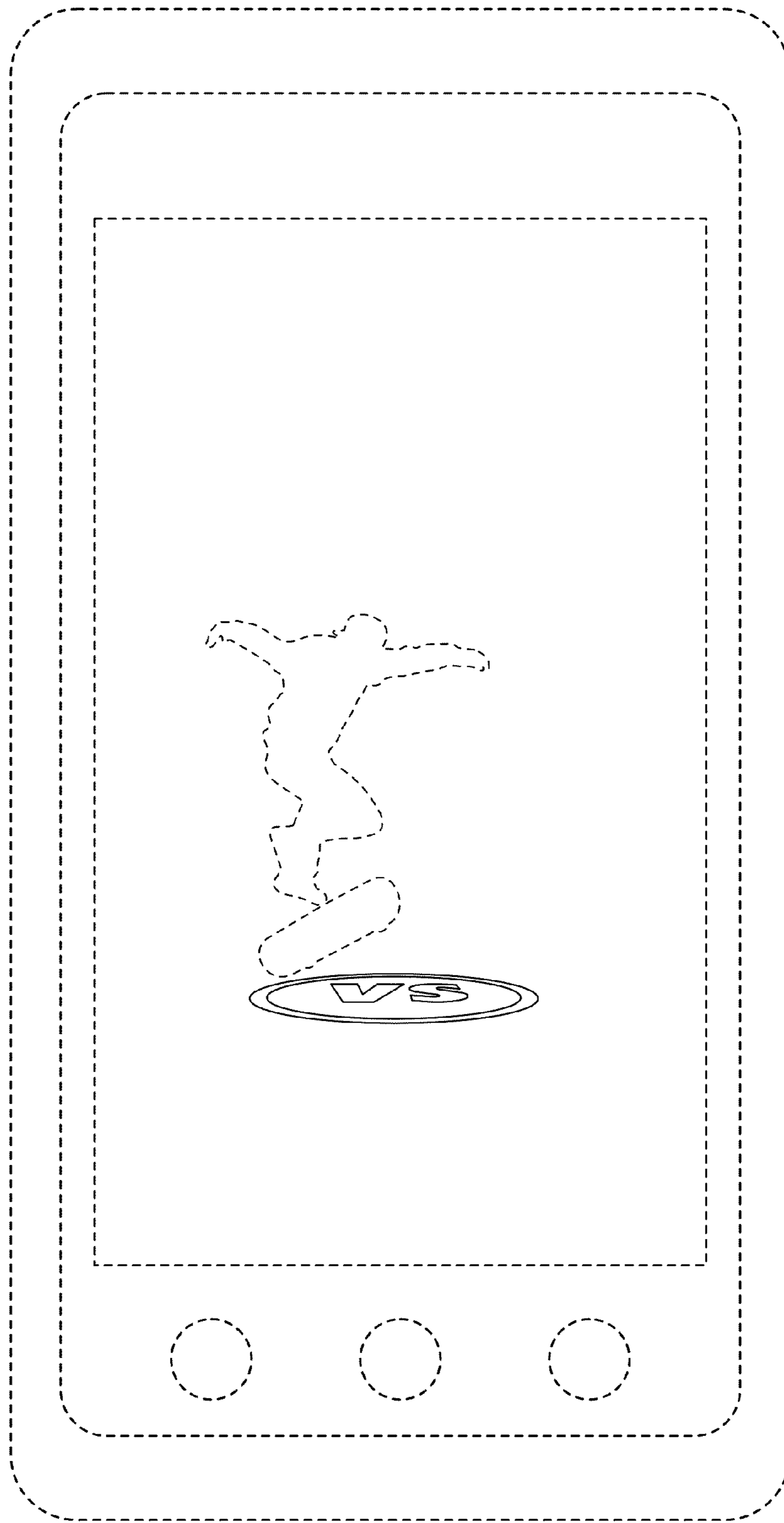
