The ornamental design for a portion of a display panel or screen with an icon, as shown and described.

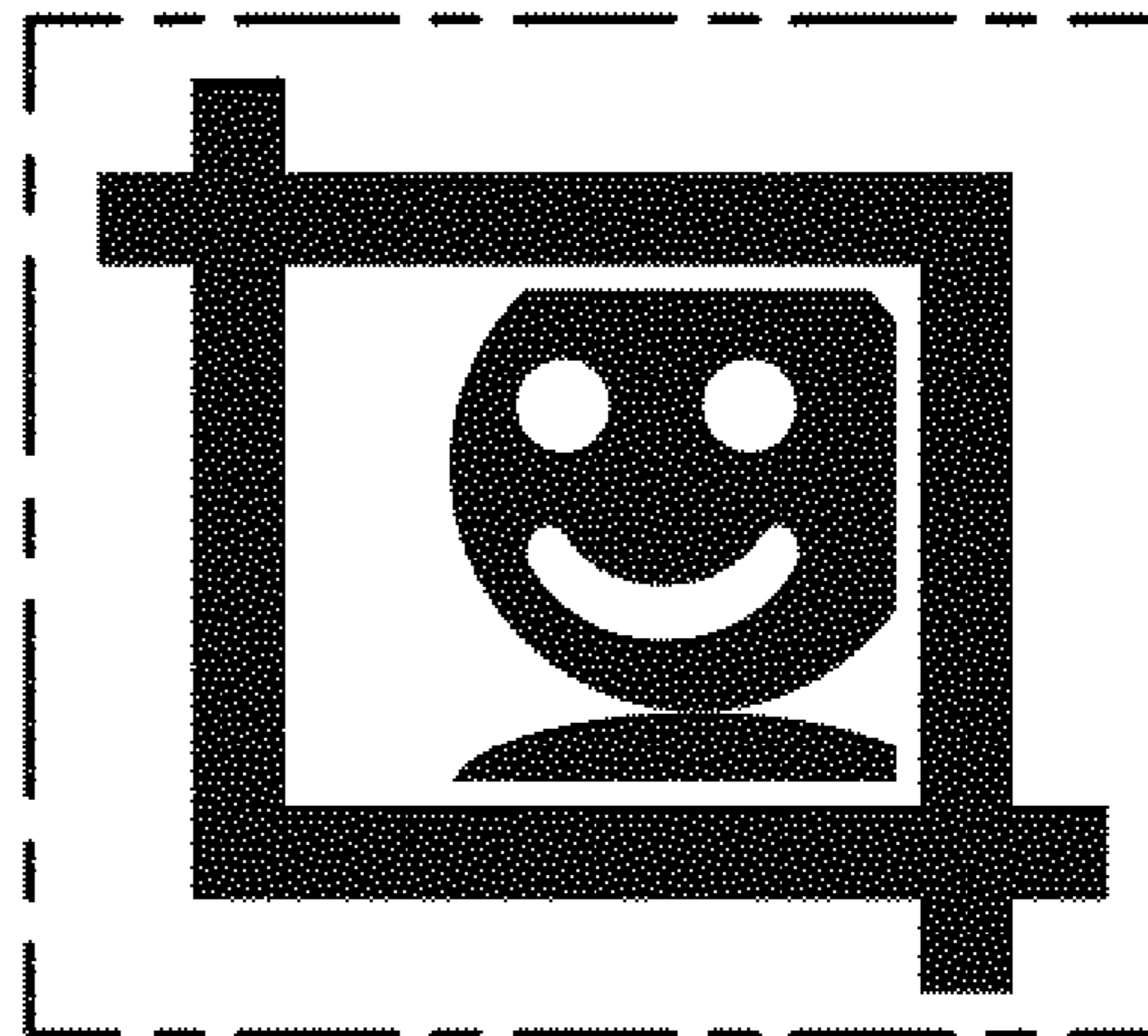
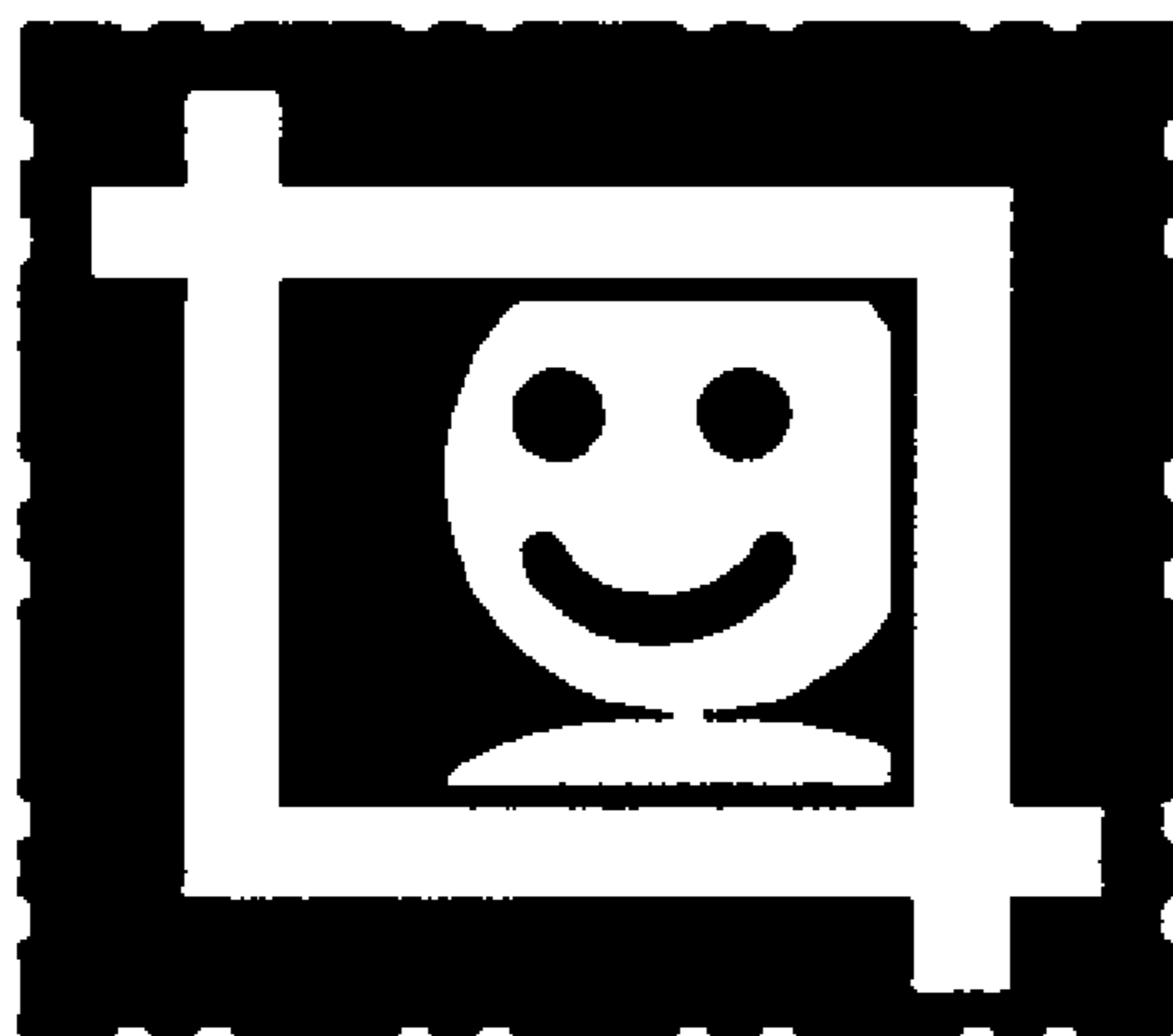
**DESCRIPTION**

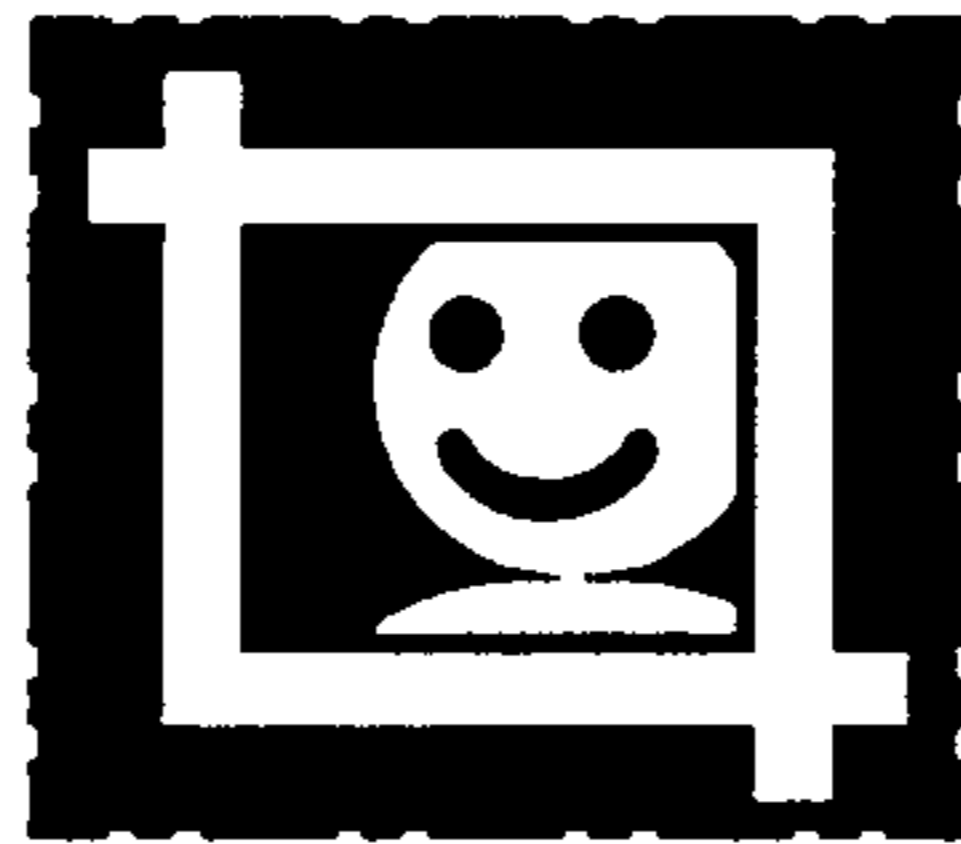

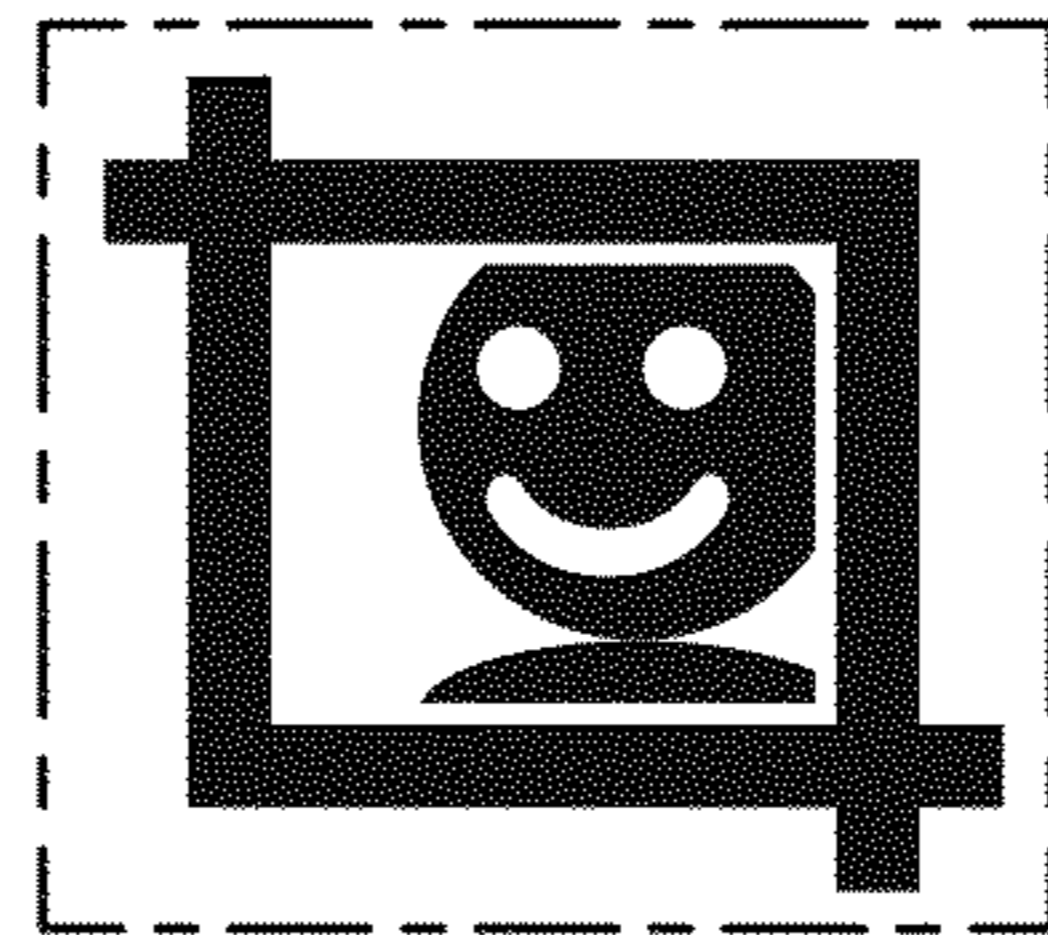
