**DESCRIPTION**

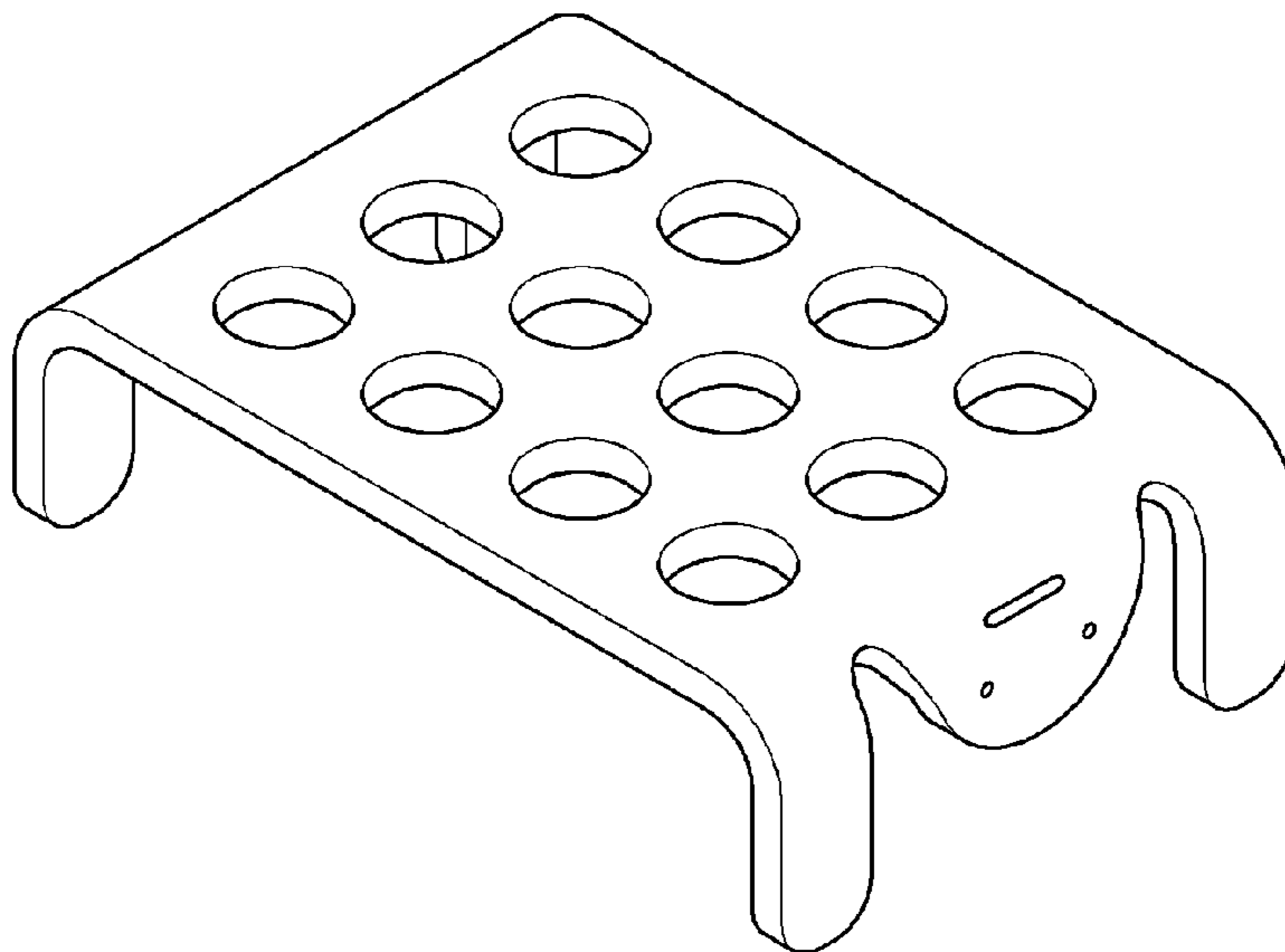

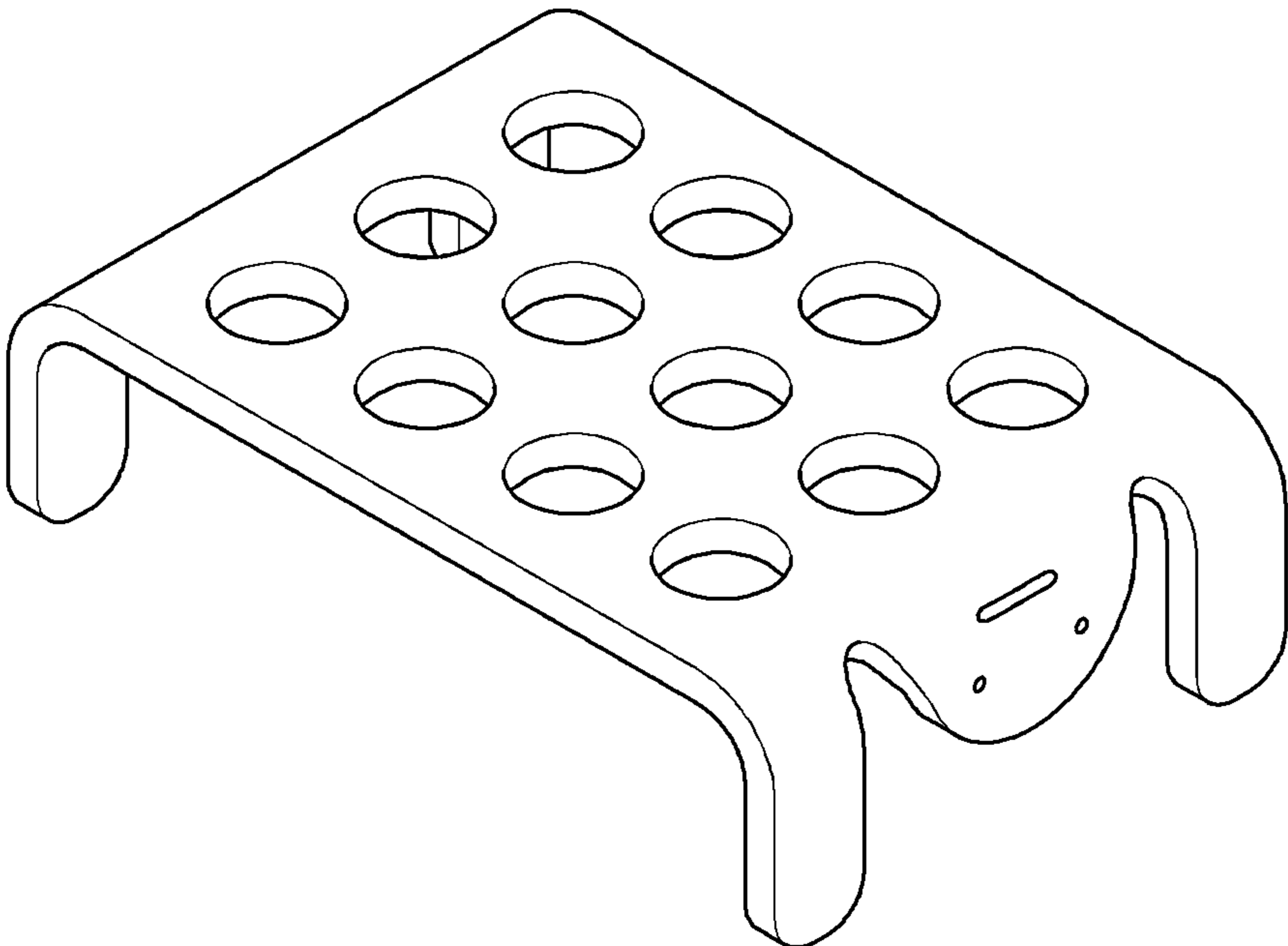

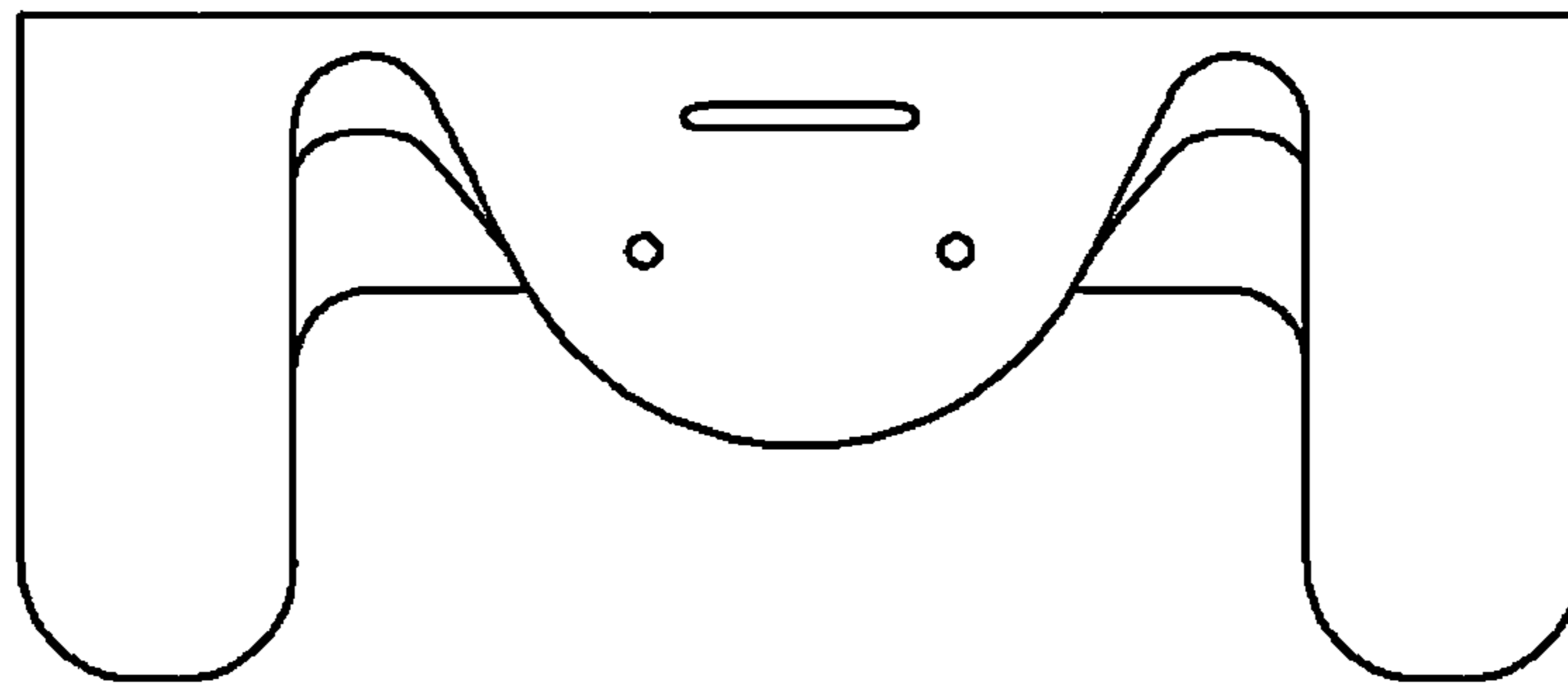
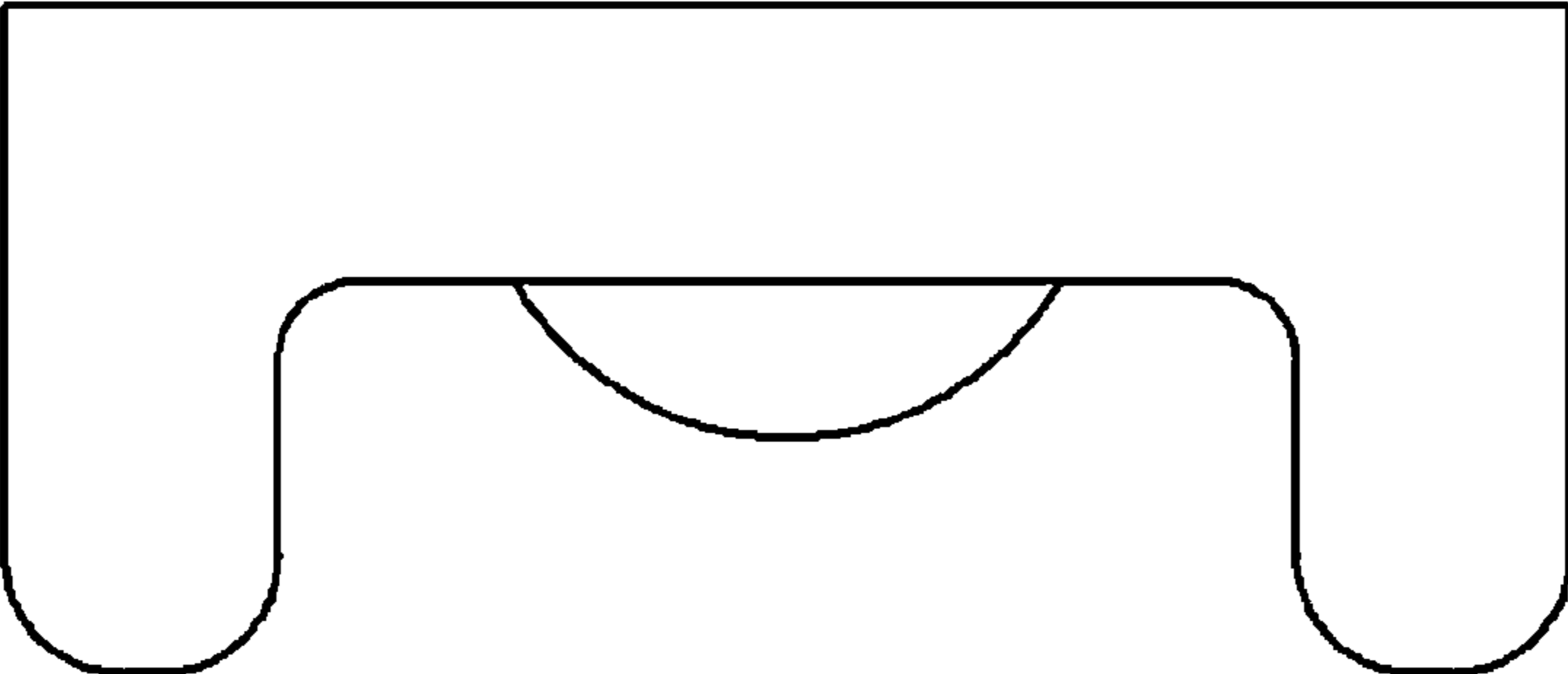
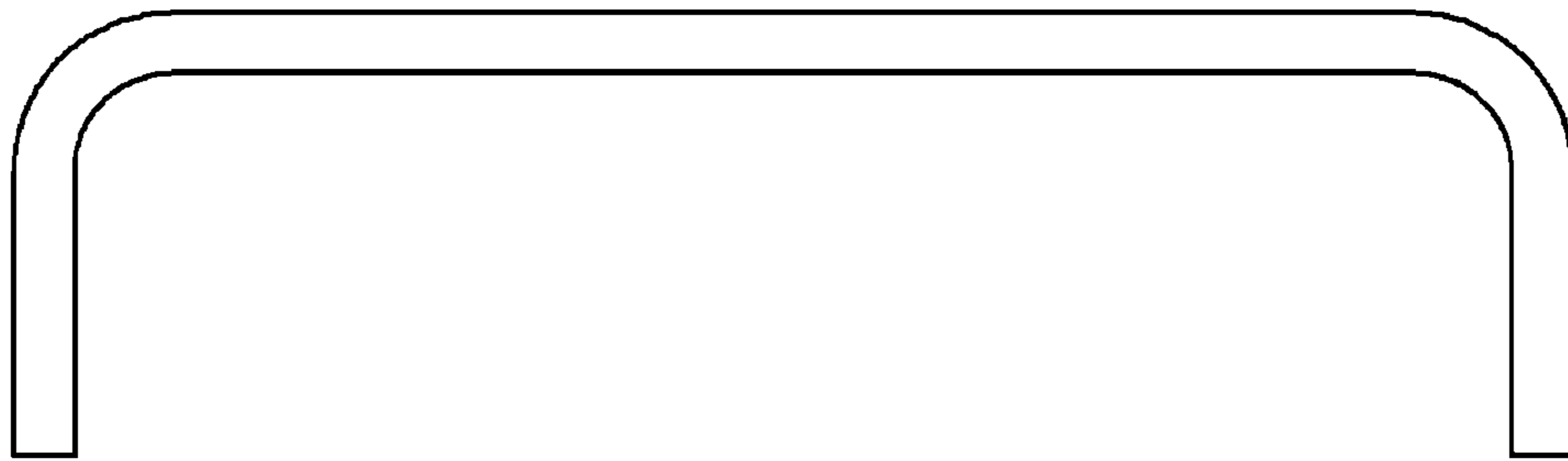


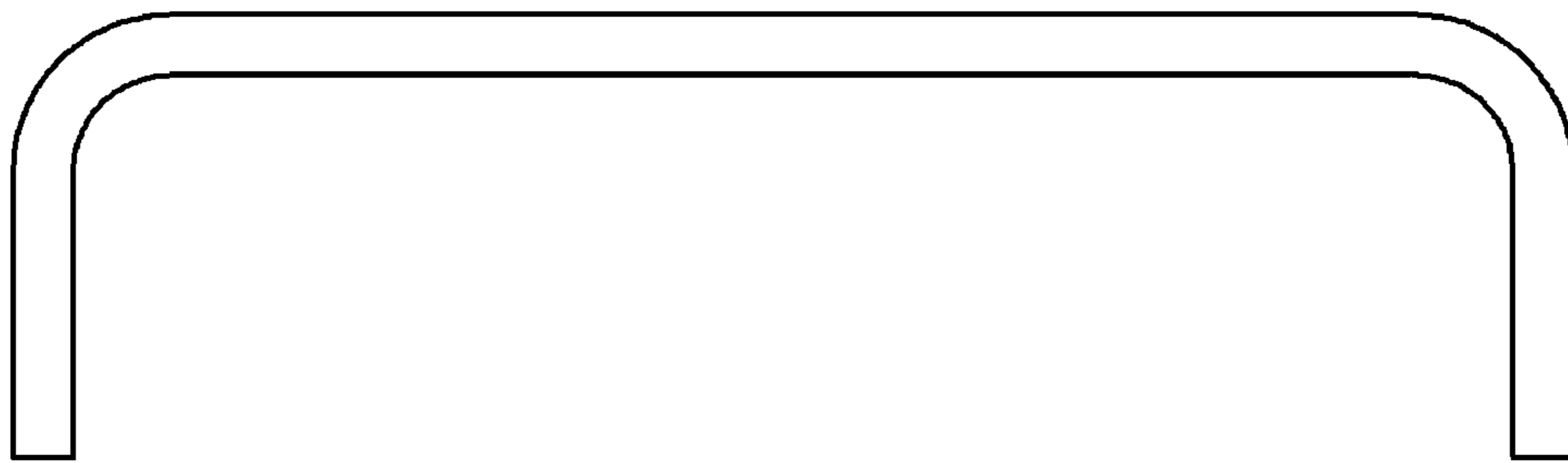

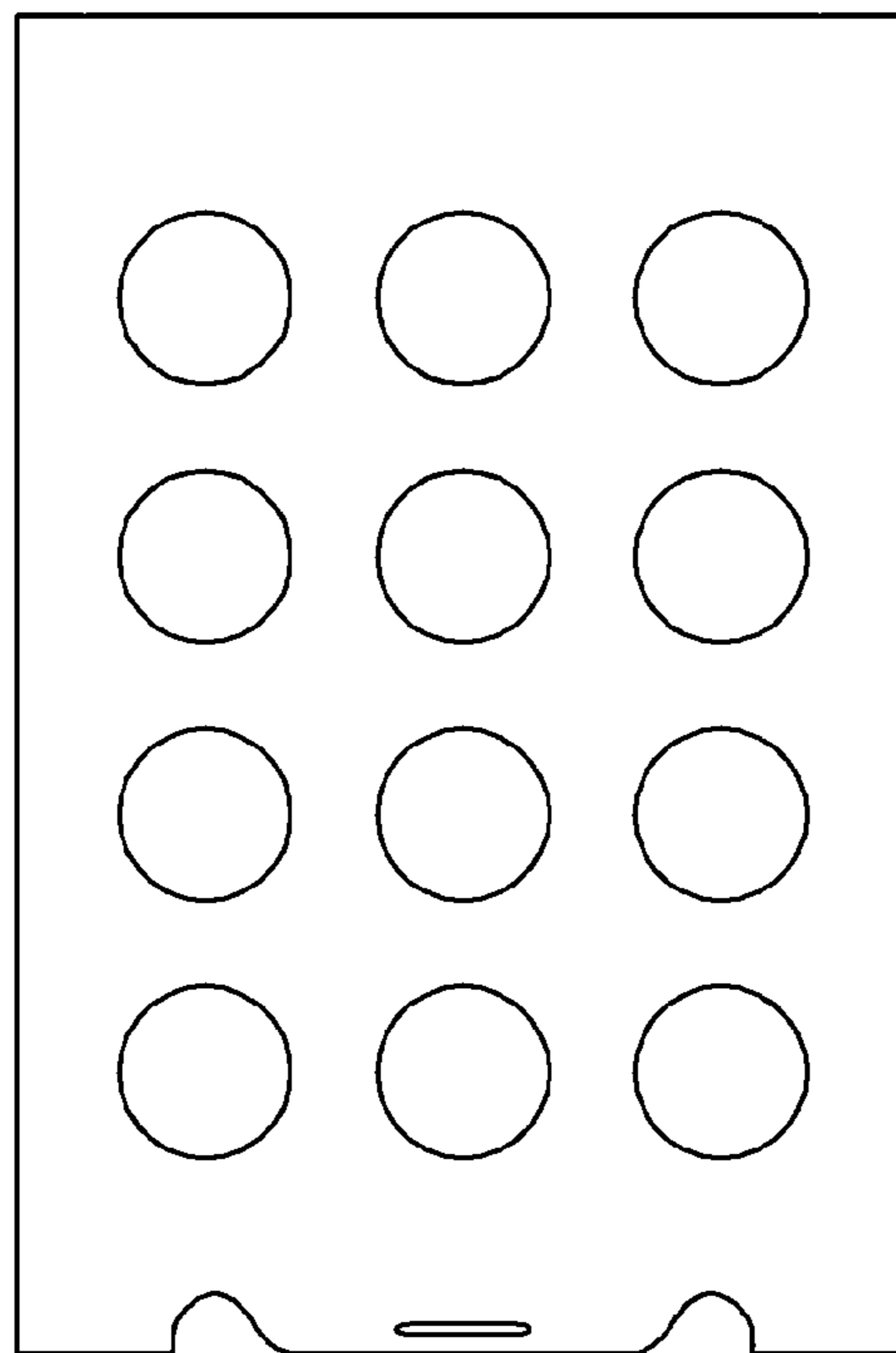

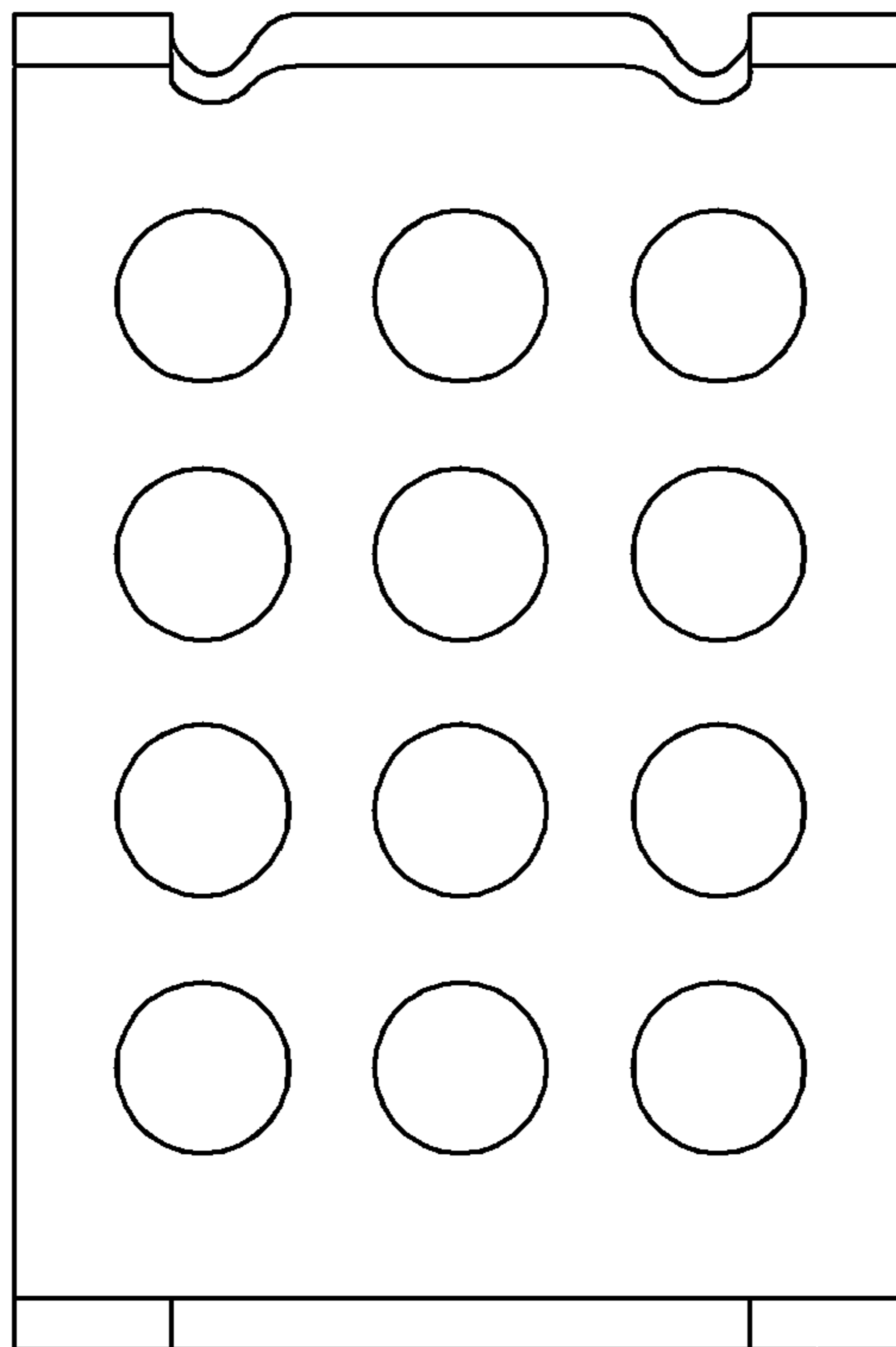
