(57) **CLAIM**

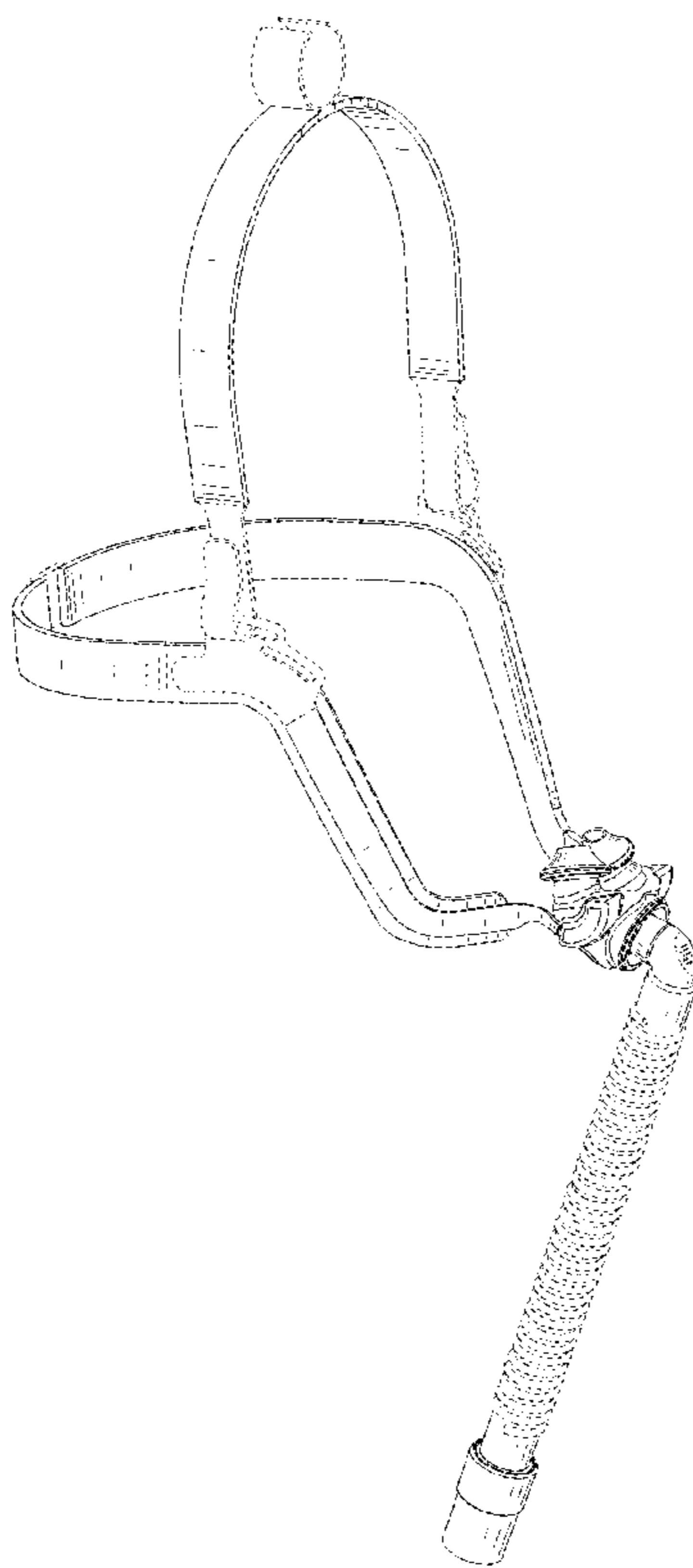
The ornamental design for a headgear and nasal pillow assembly, as shown and described.

DESCRIPTION

FIG. 1 is a front, left side, top perspective view of a headgear and nasal pillow assembly showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a rear view thereof; and,
FIG. 6 is a bottom view thereof.

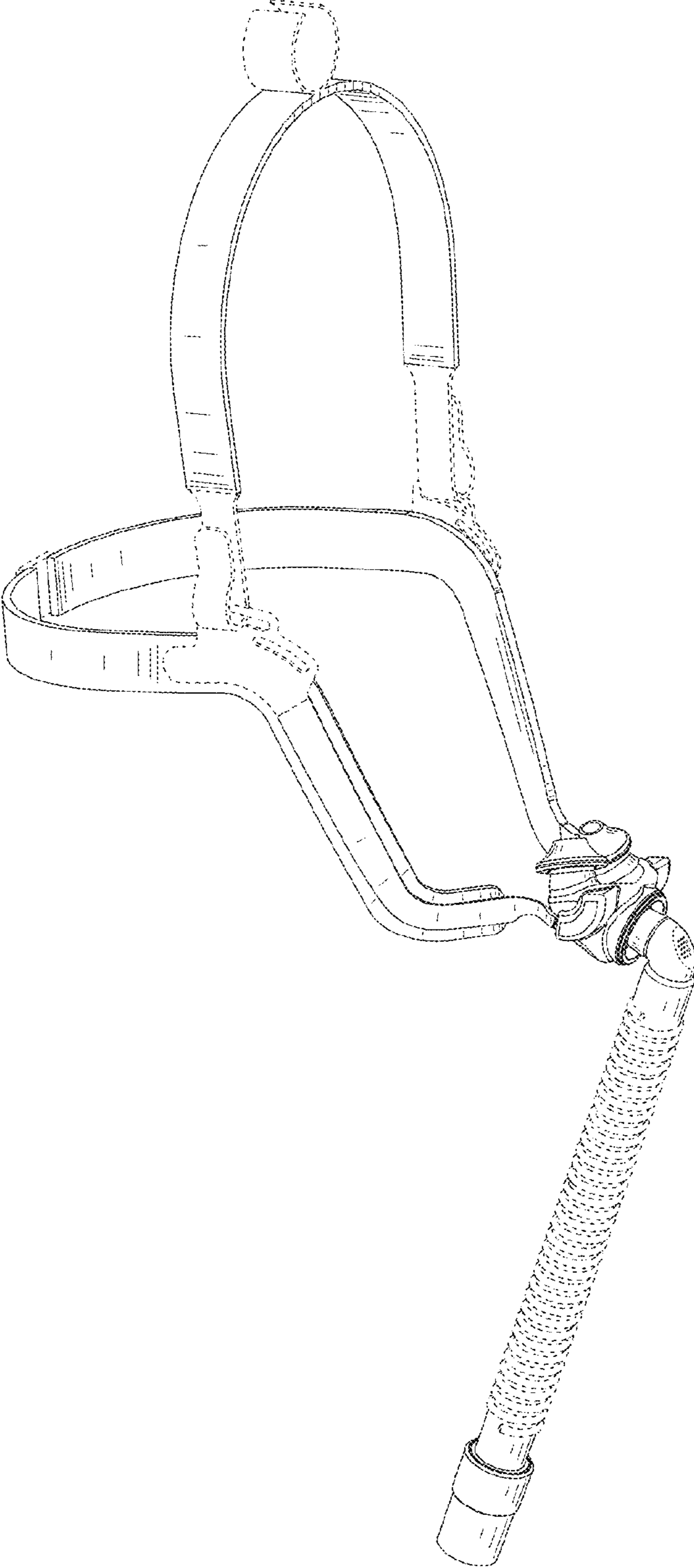

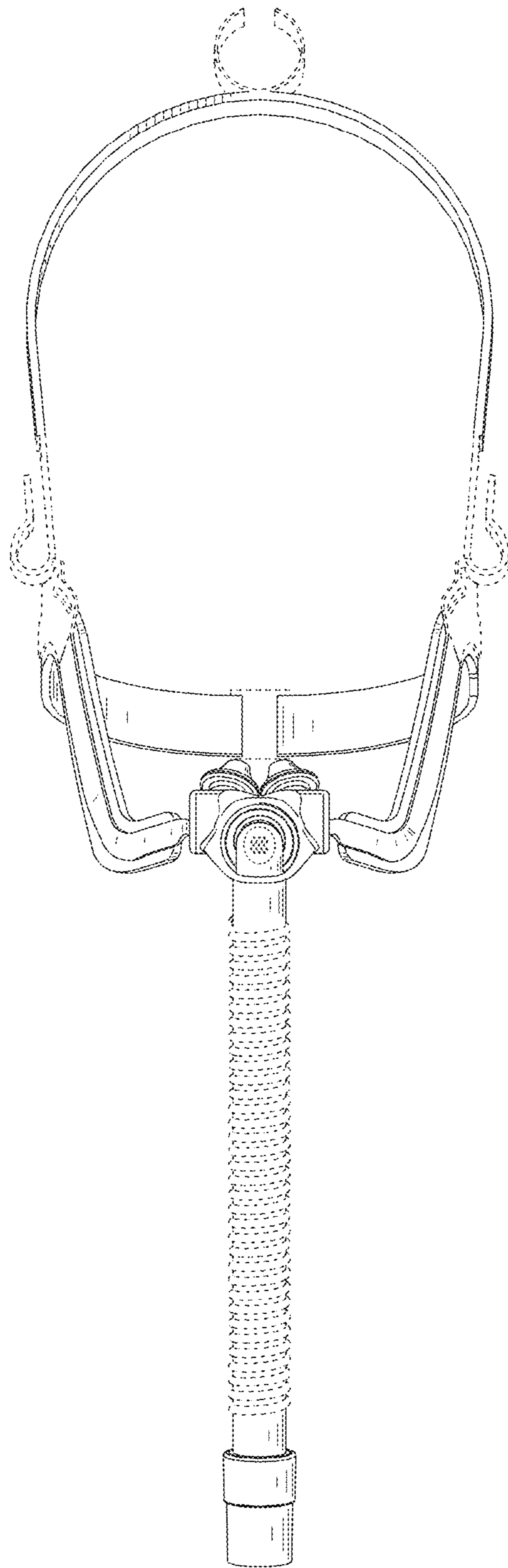

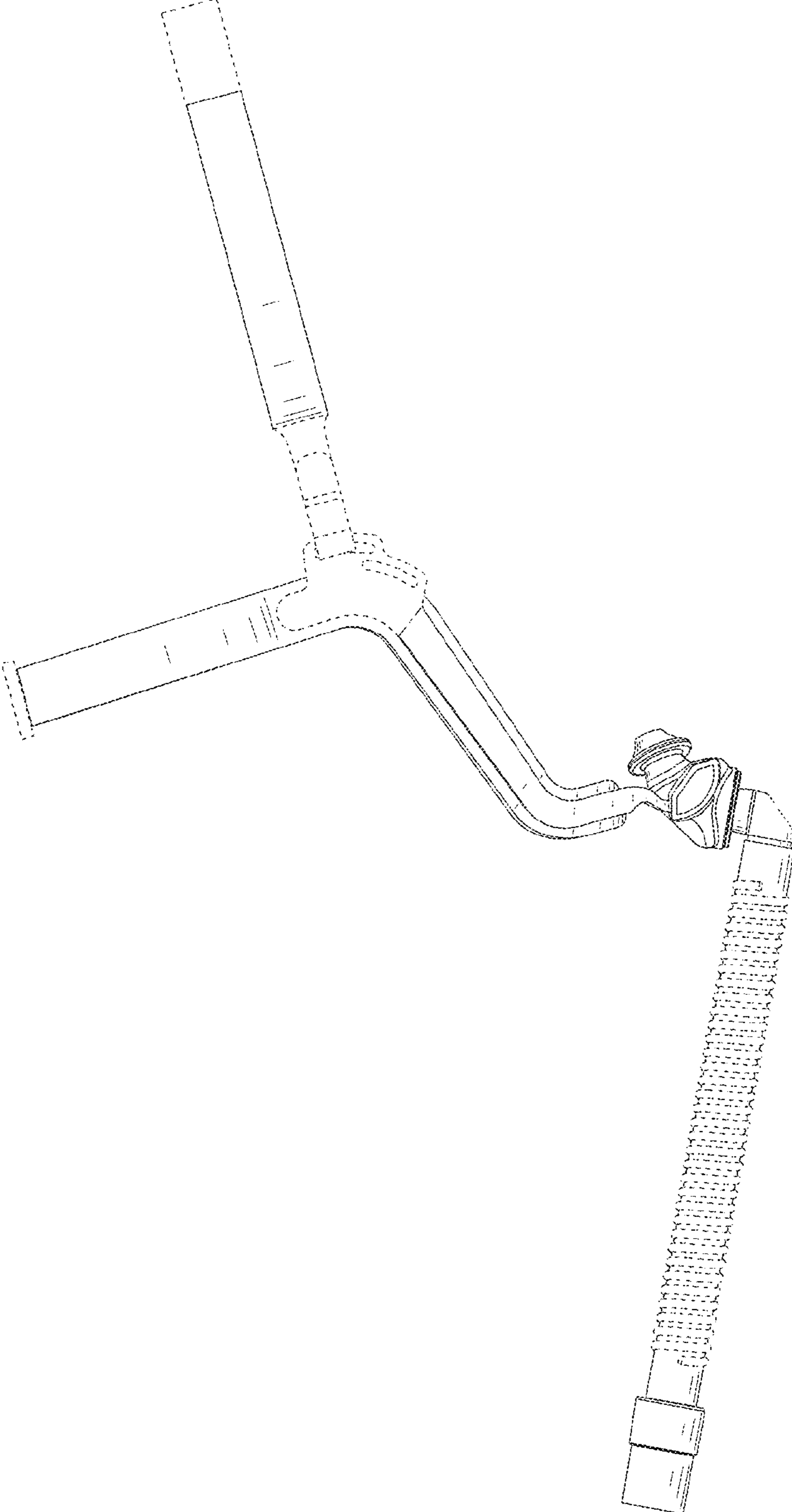

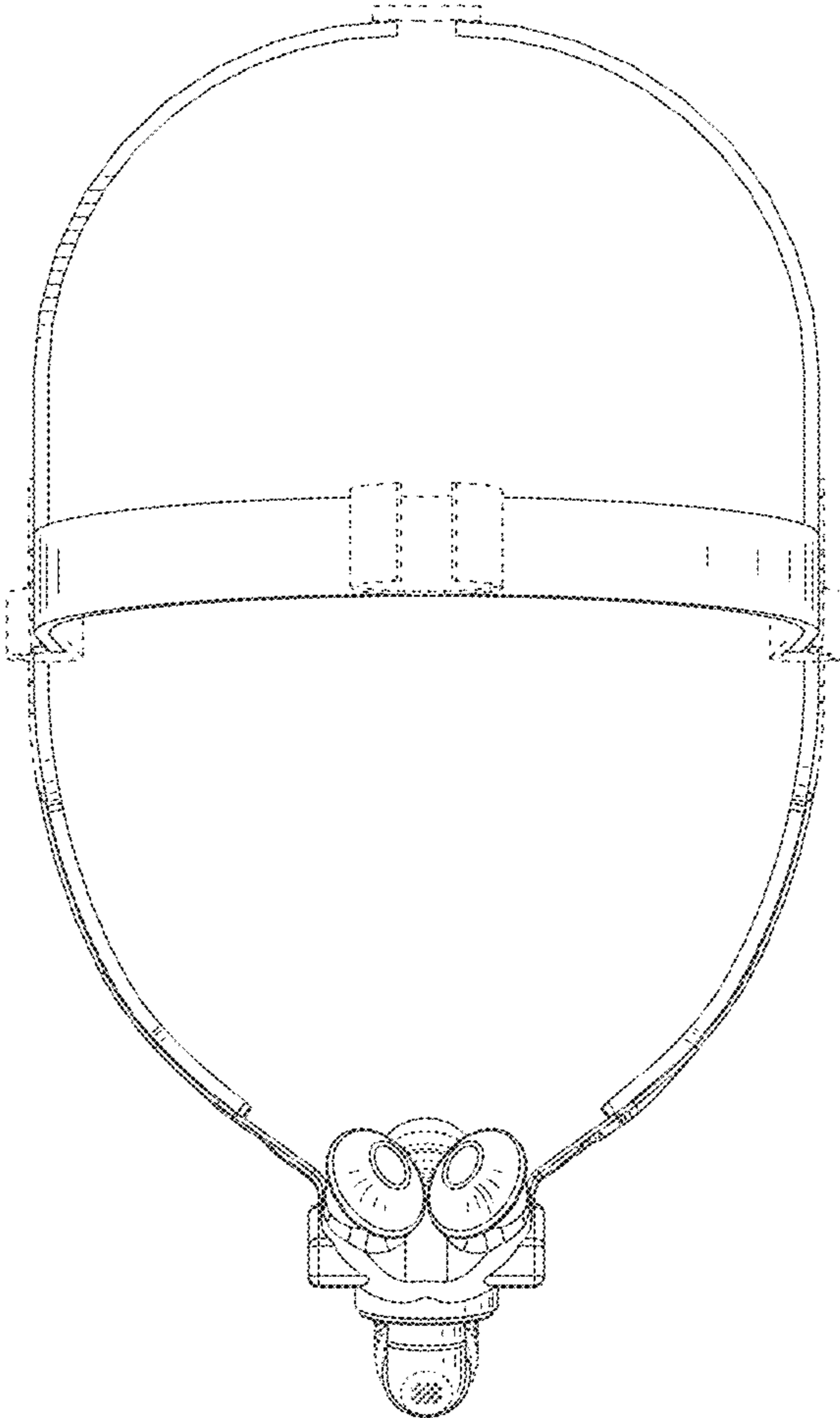

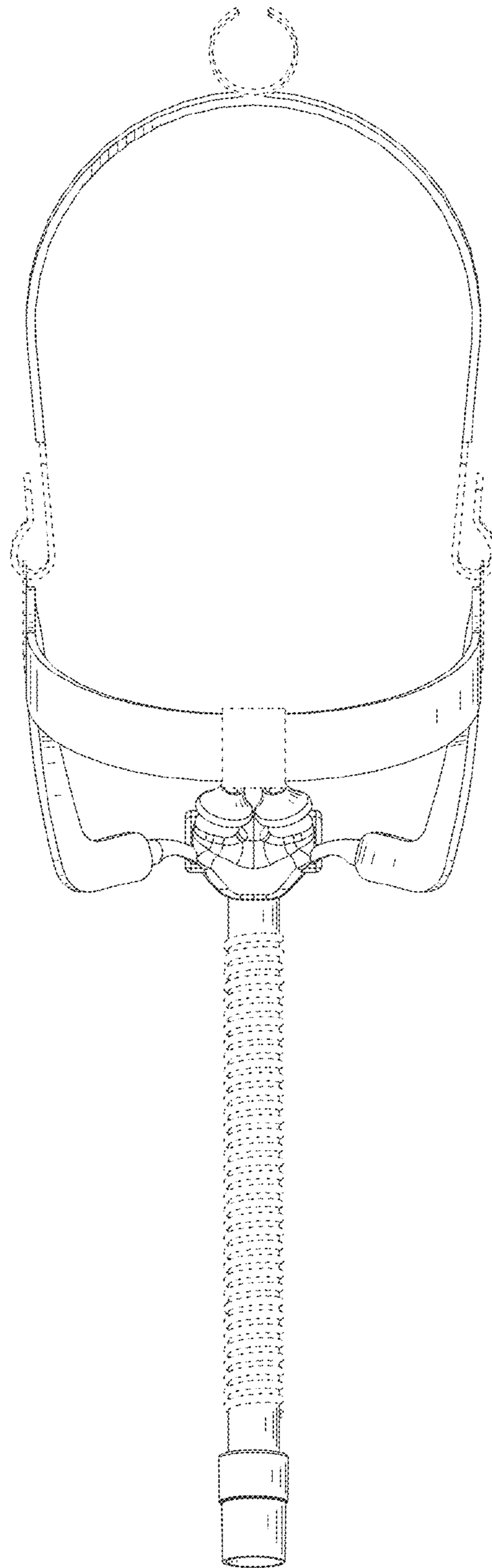

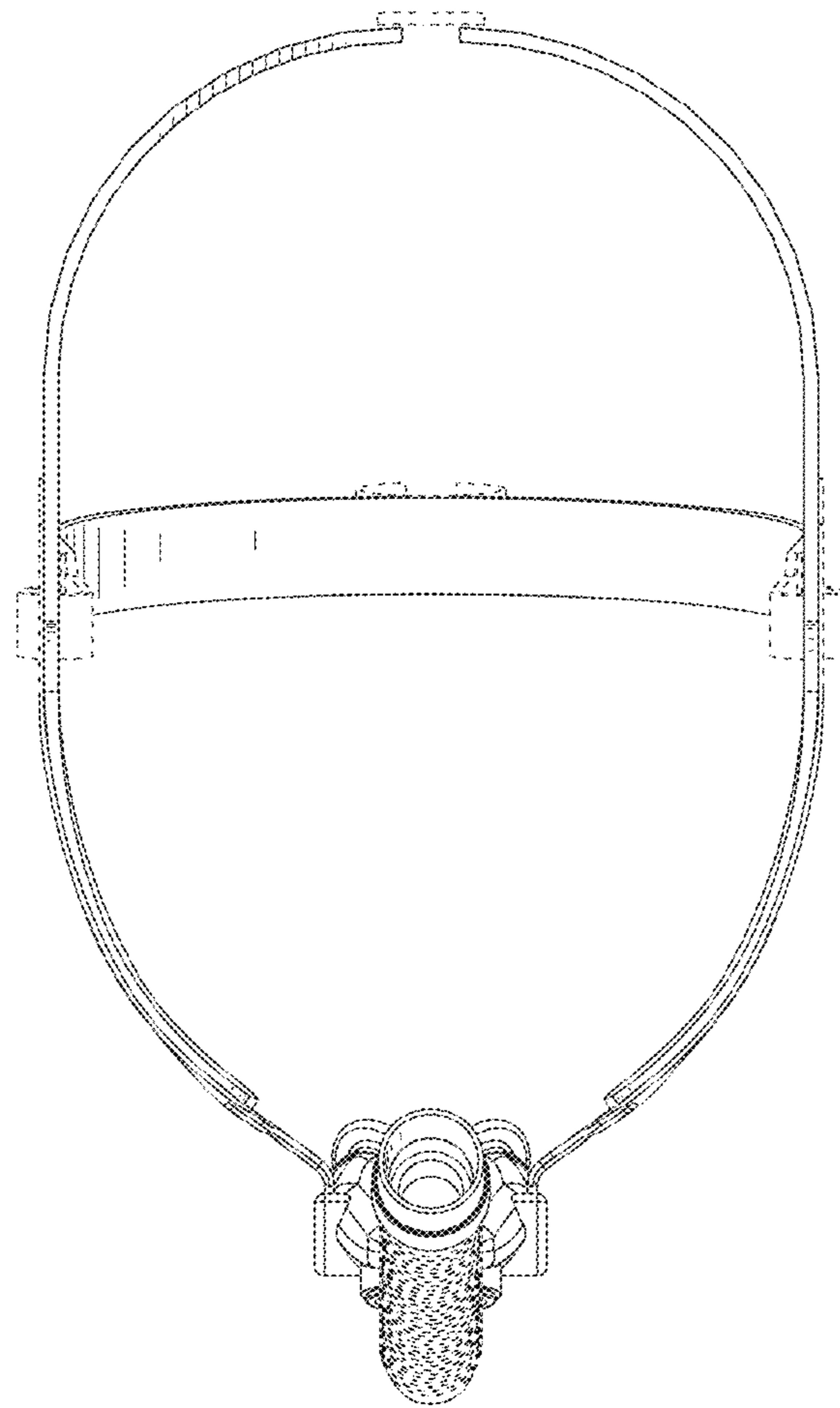
