FIG. 2 is a perspective view of a proximal end of the drill guide of FIG. 1.

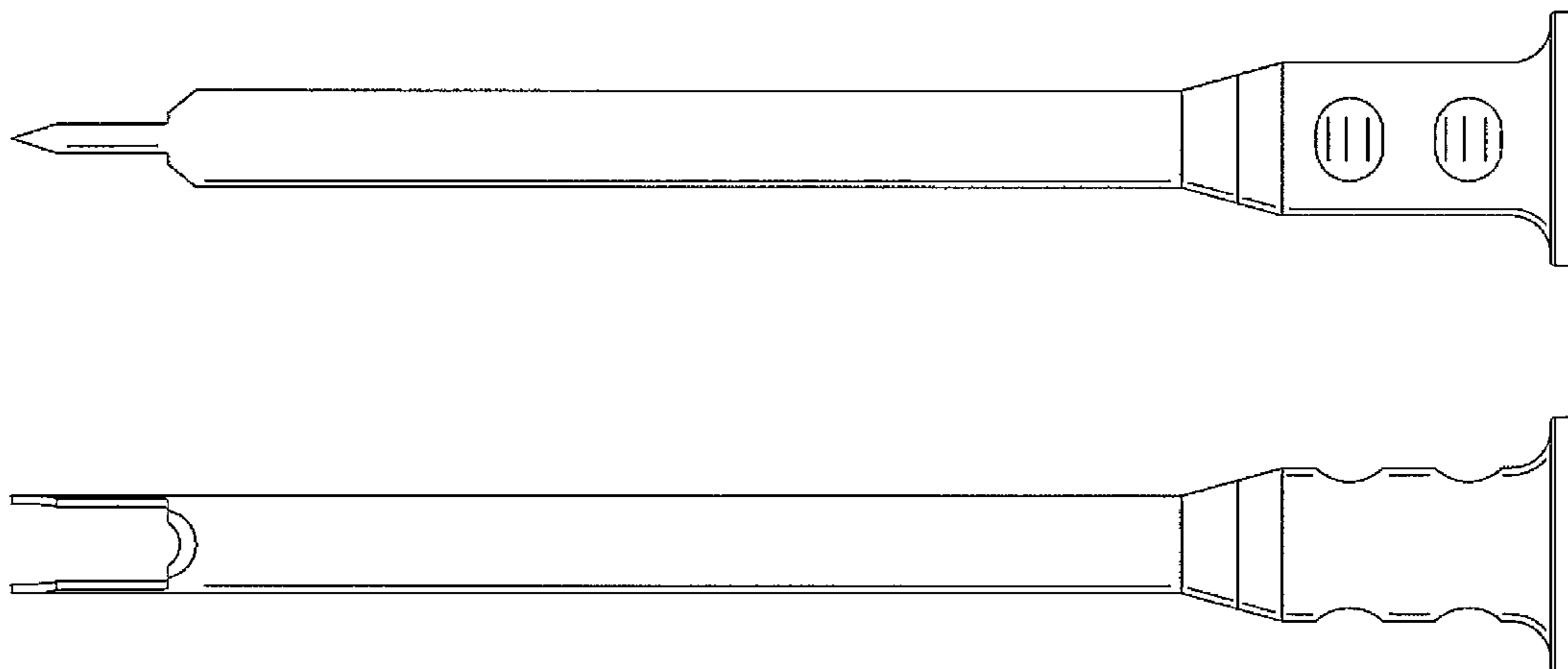
FIG. 3 is an elevational view of the drill guide of FIG. 1.

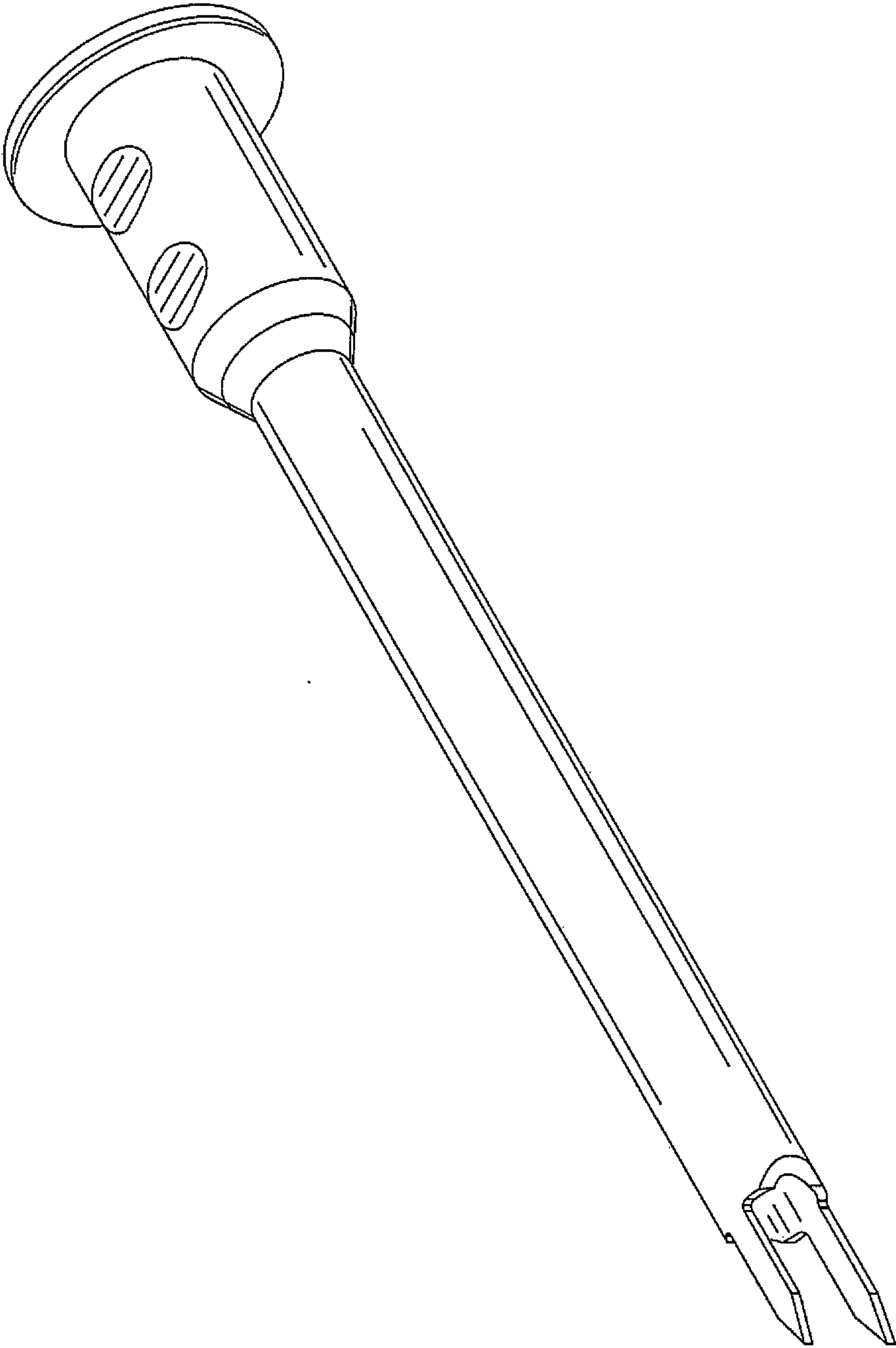

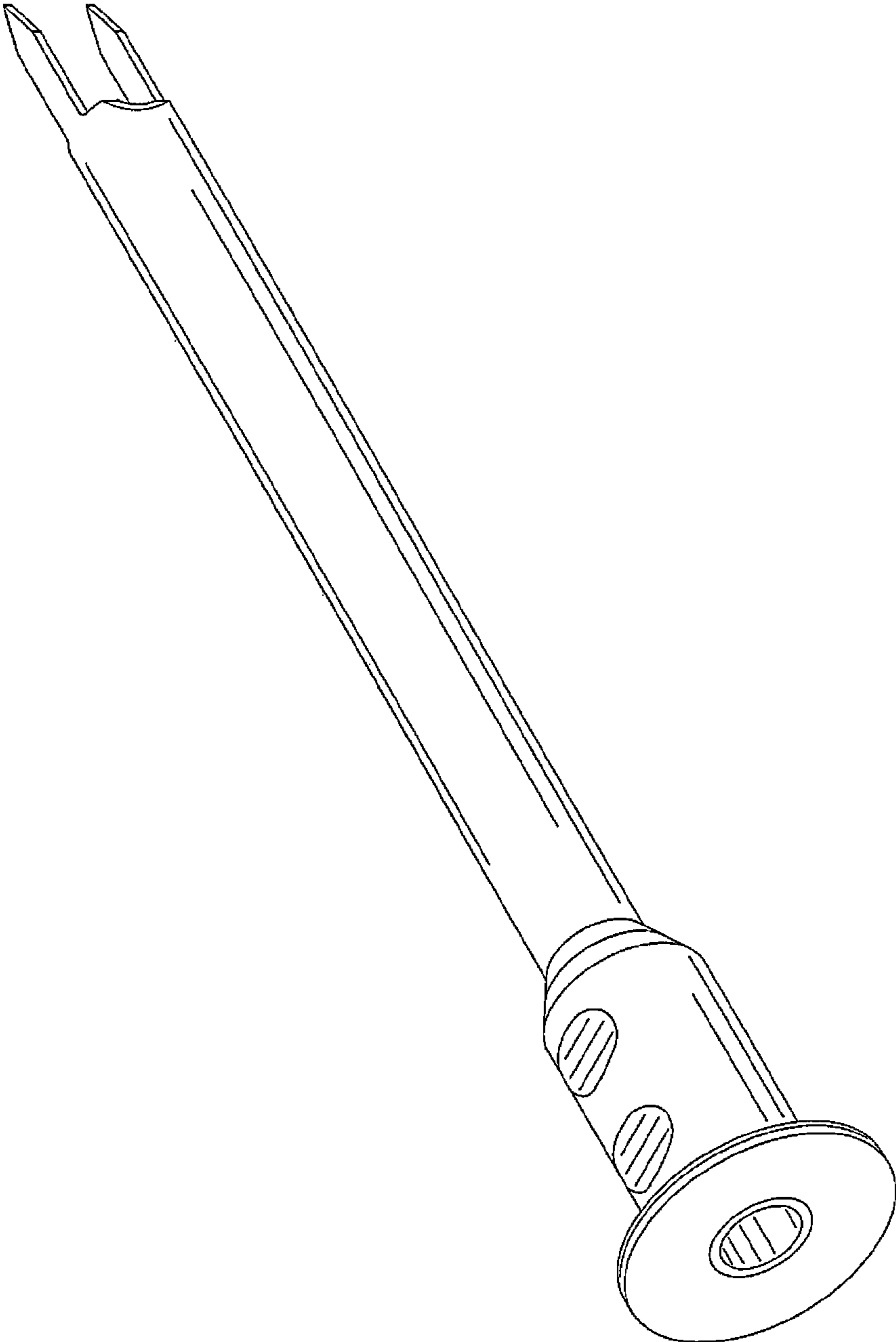

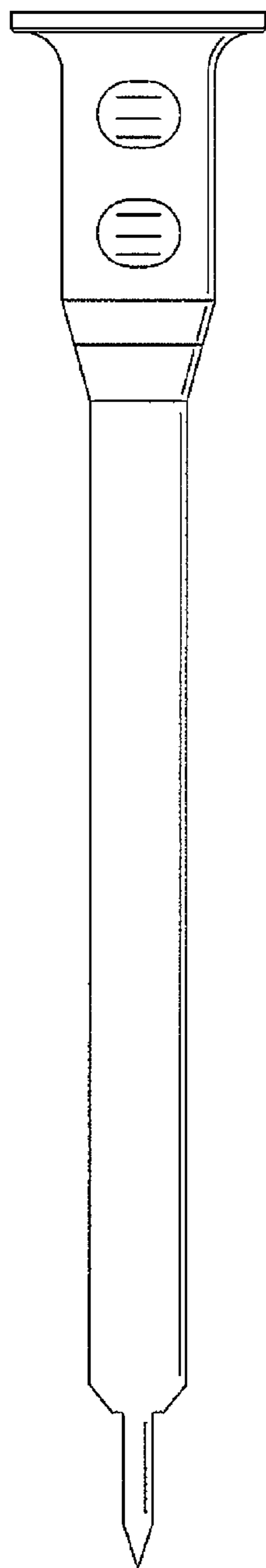

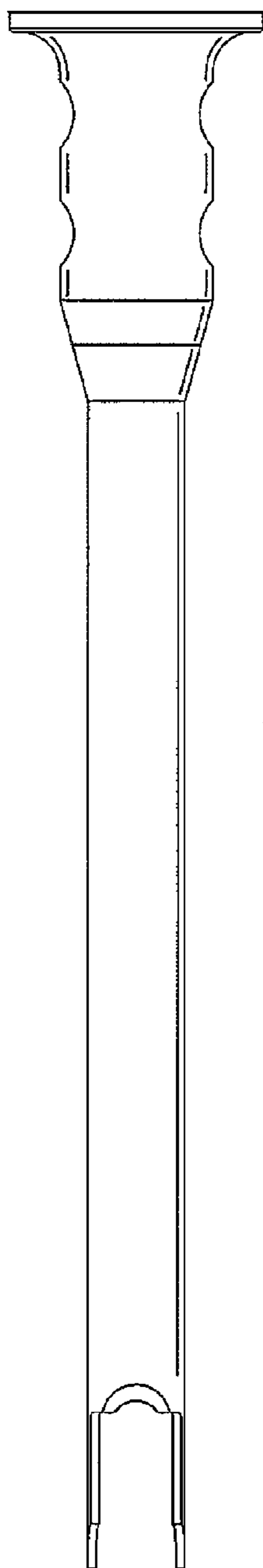

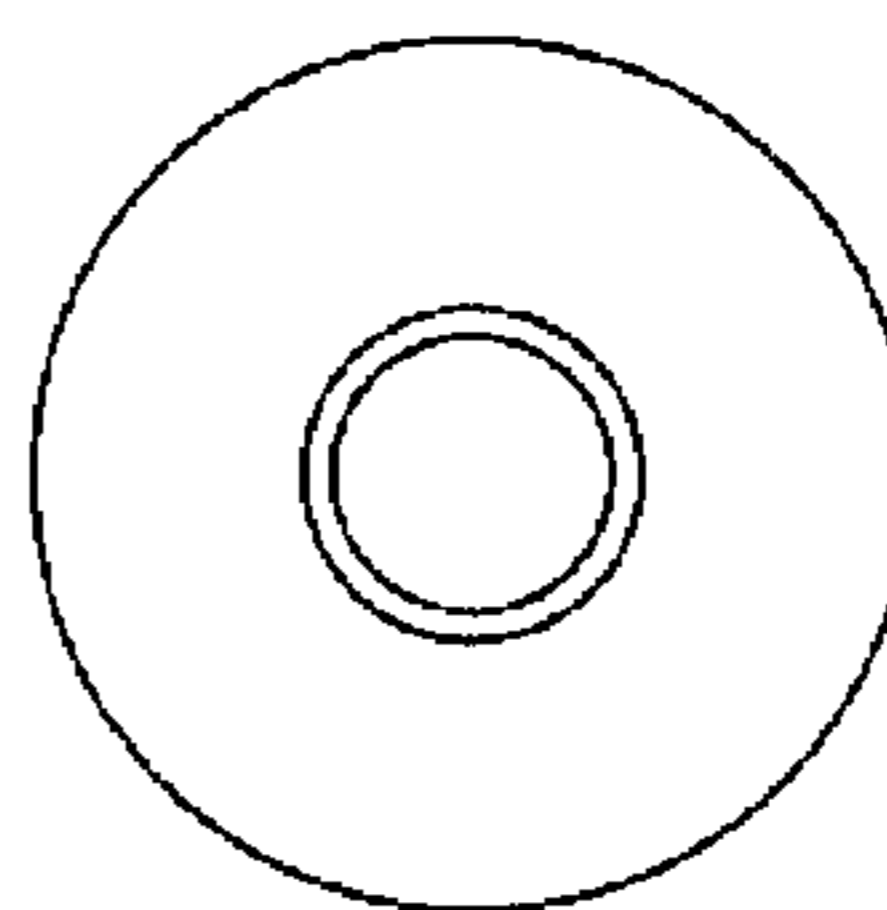

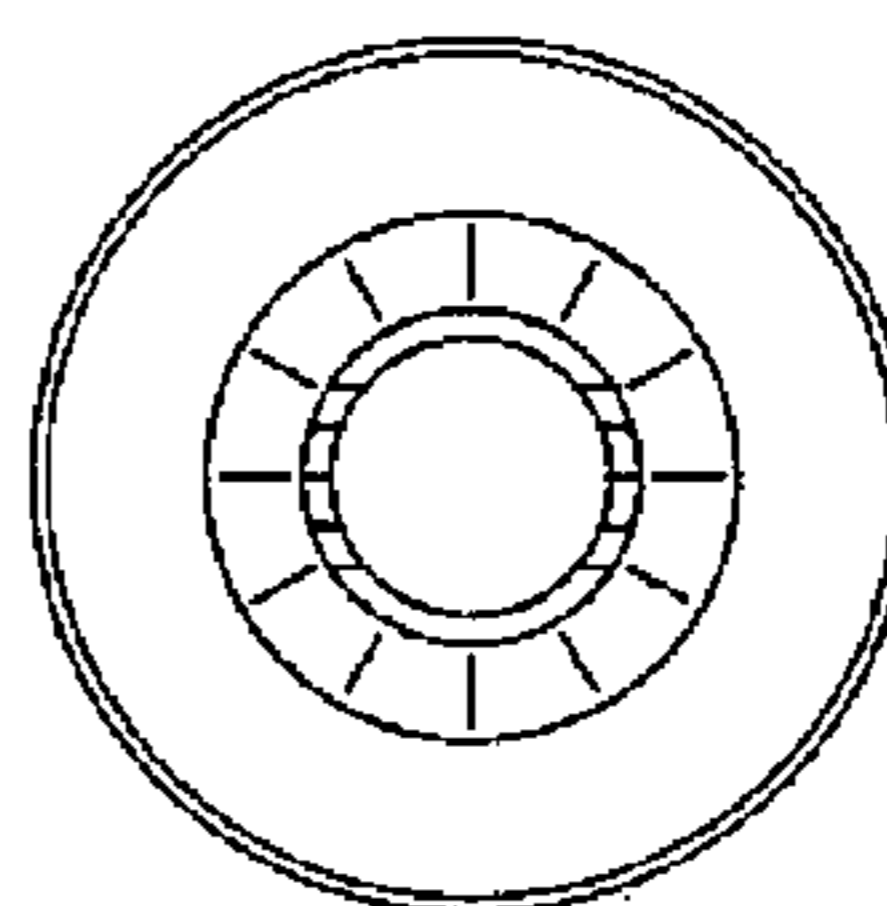
