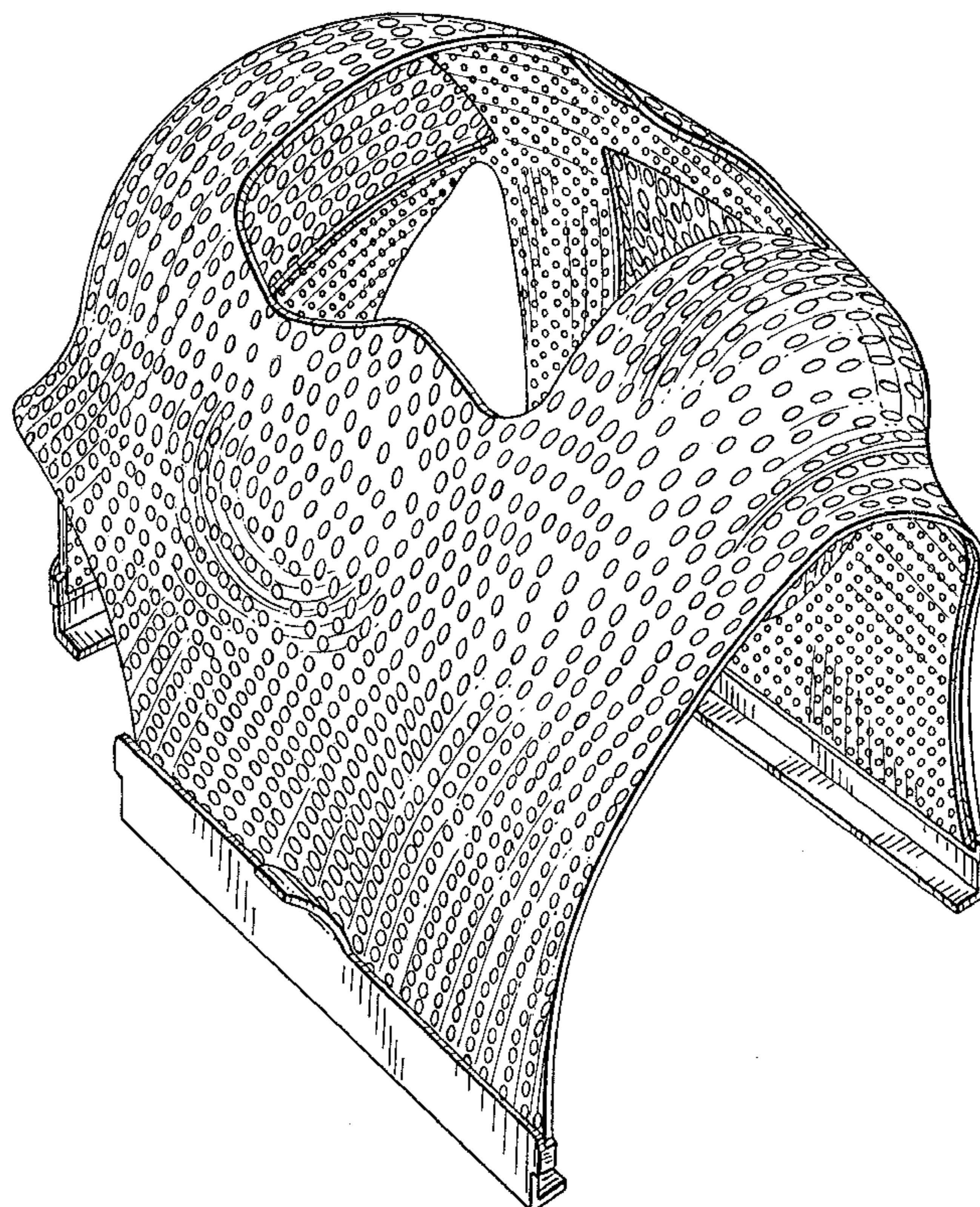
(57) **CLAIM**

The ornamental design for a radiotherapy mask, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a radiotherapy mask according to my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a right side elevational view thereof, the opposite left side being a mirror image;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is an exploded, perspective view thereof; and,
FIG. 8 is a sectional view thereof, taken on line 8-8 of FIG. 4.

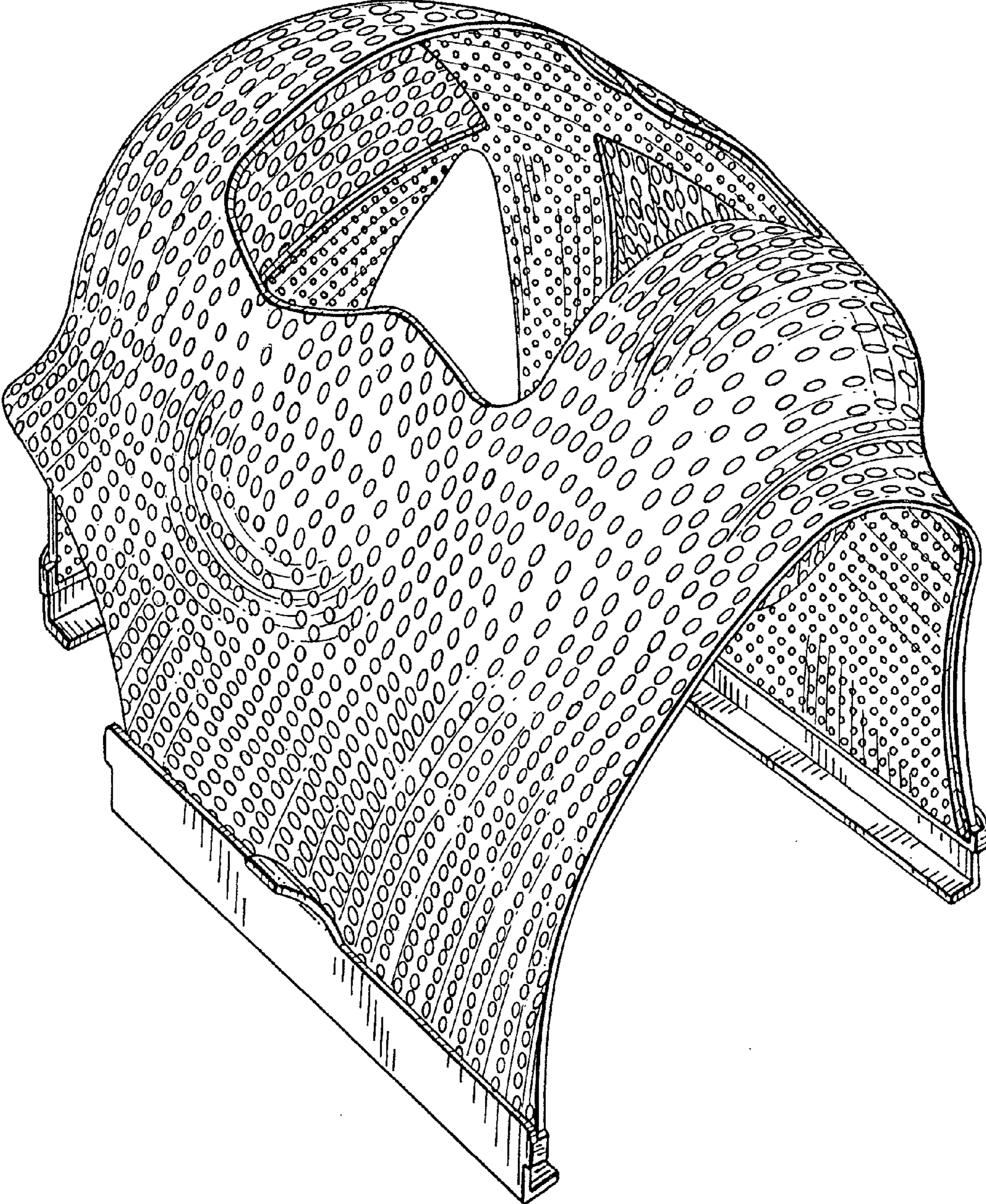

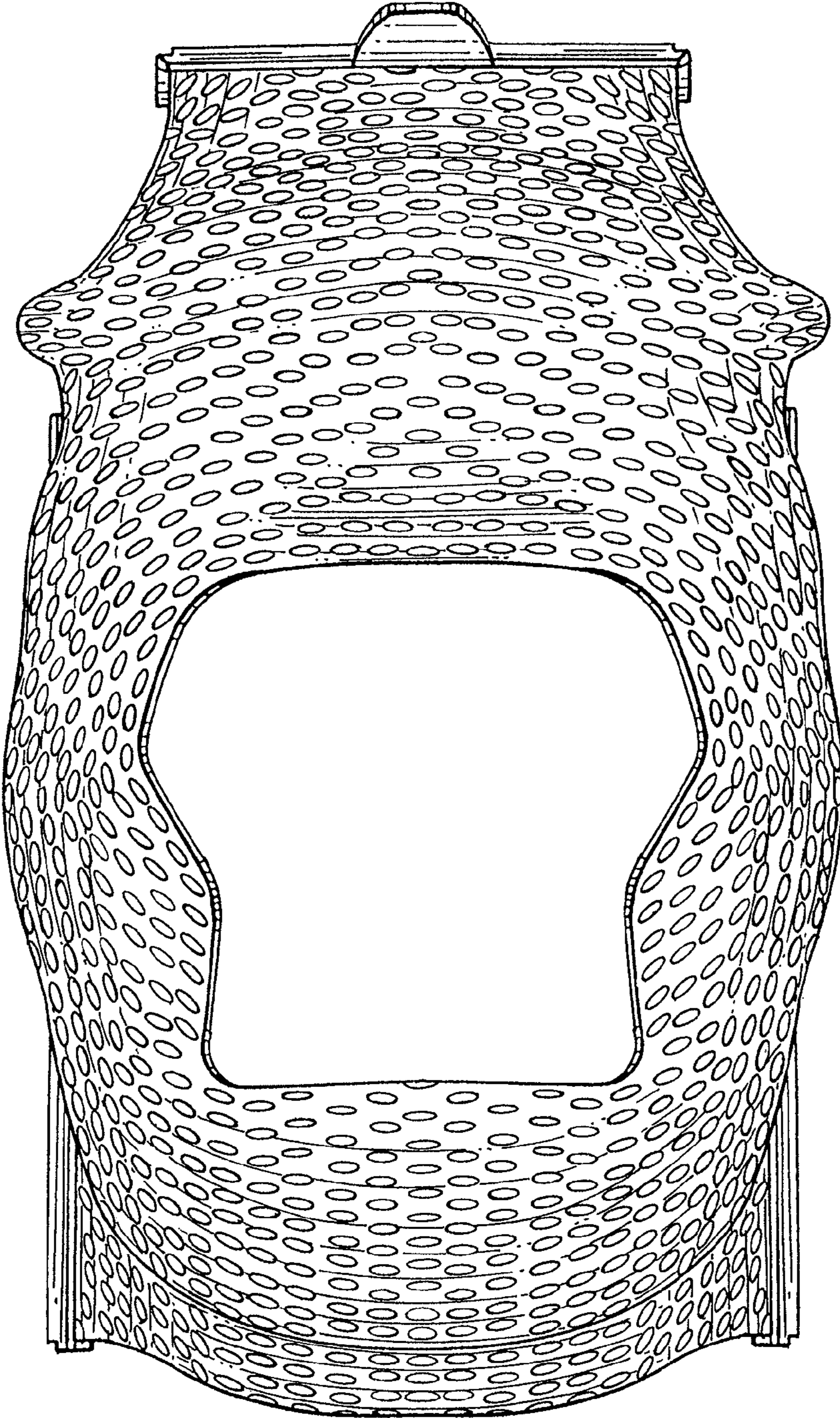

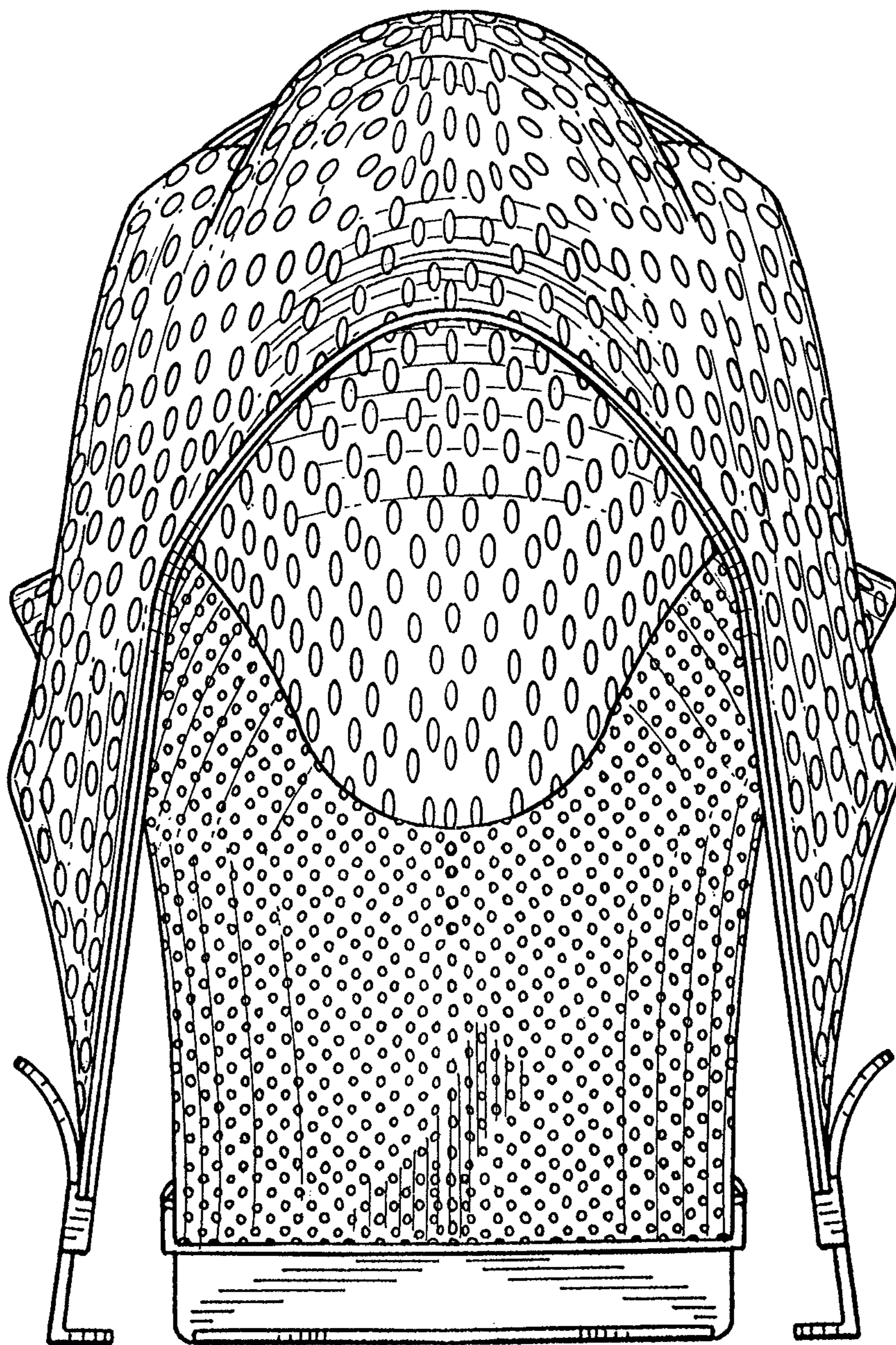
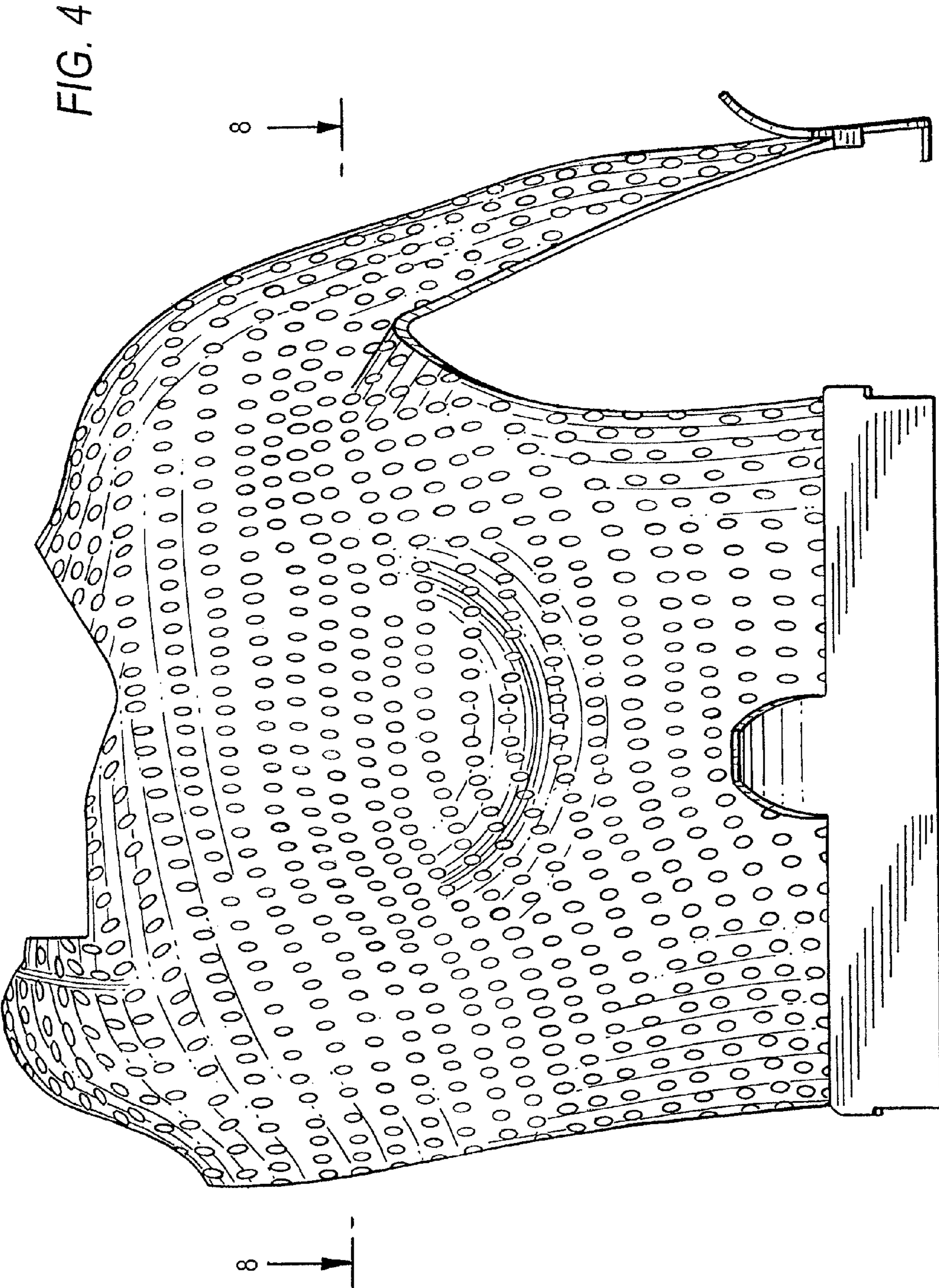

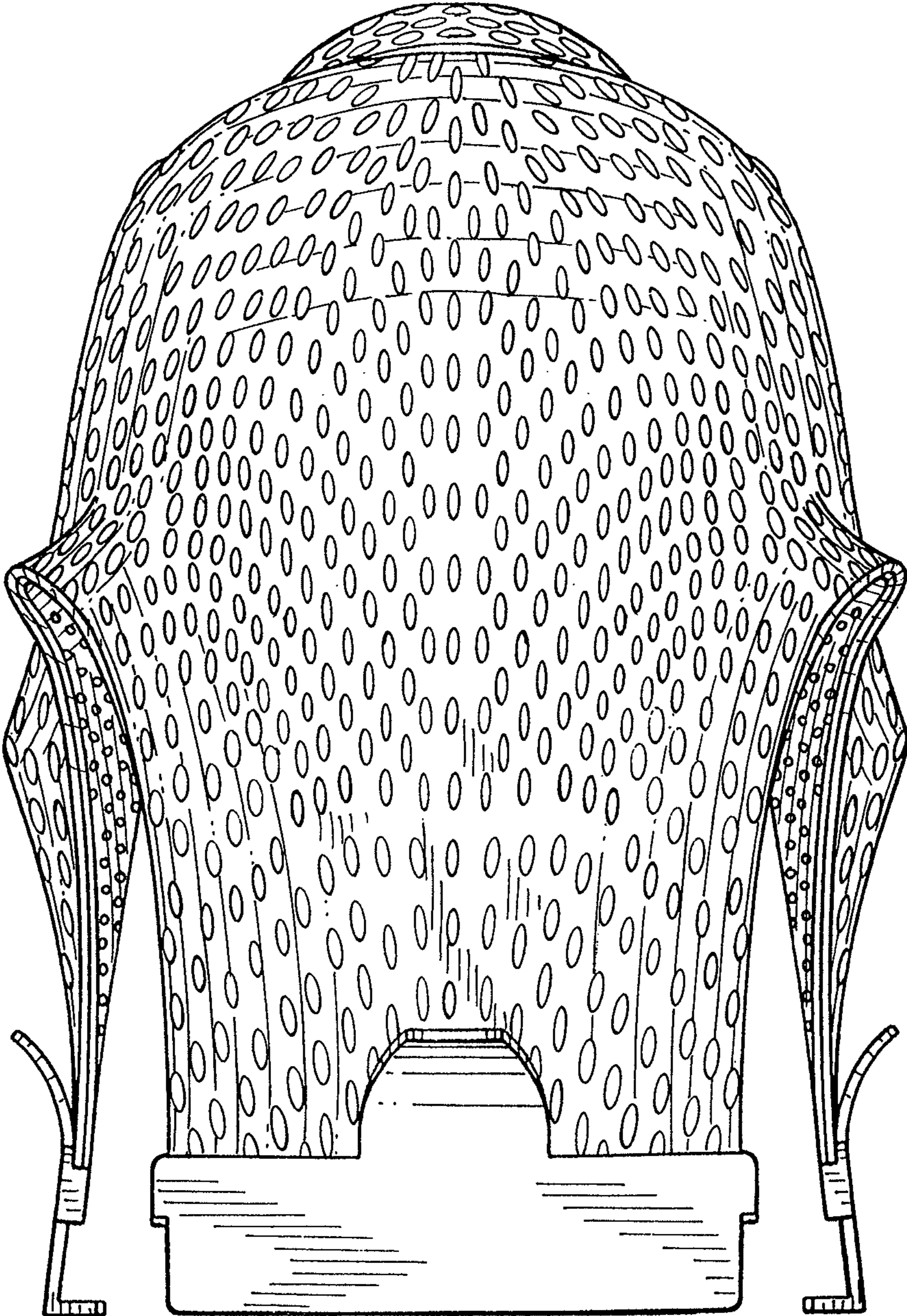

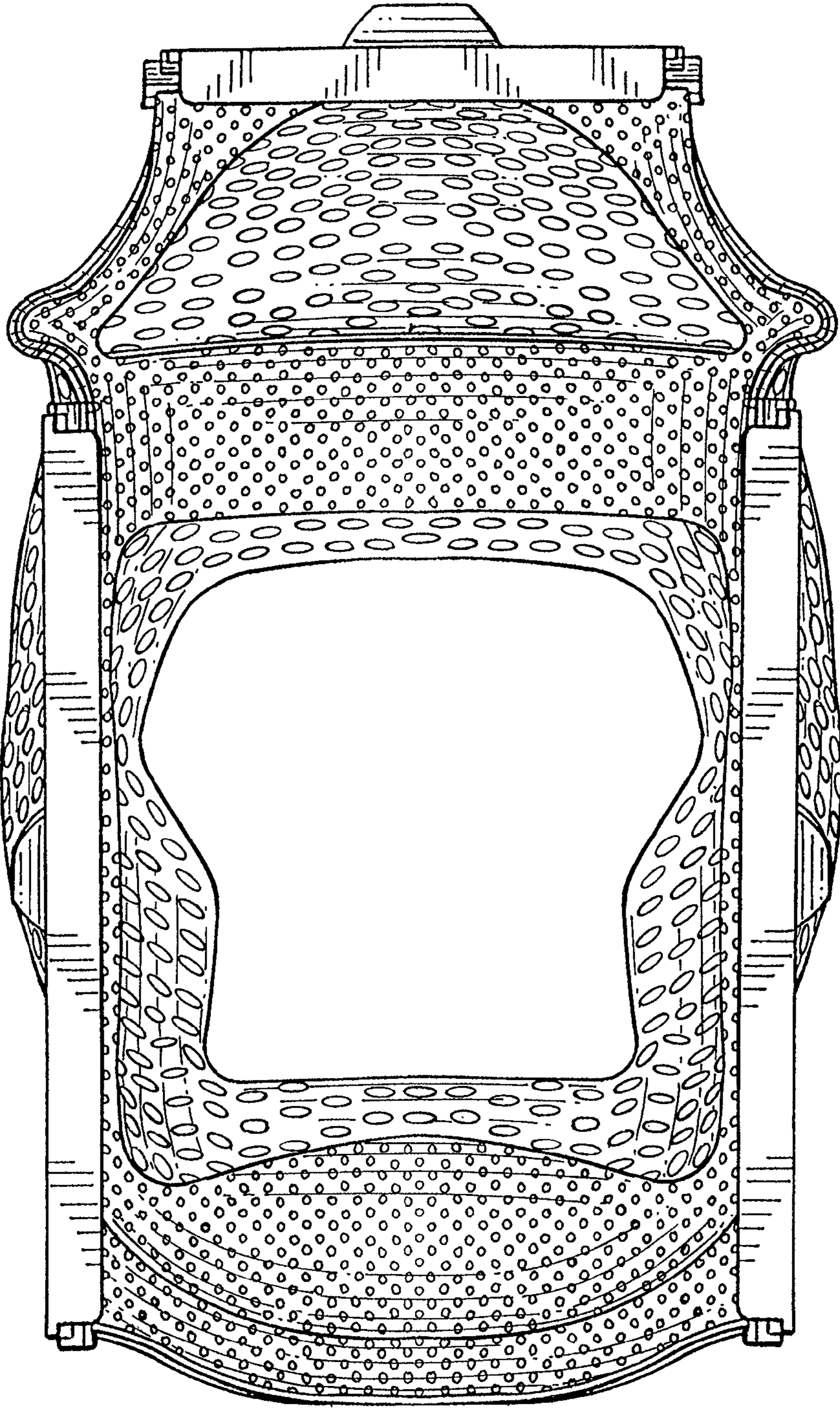
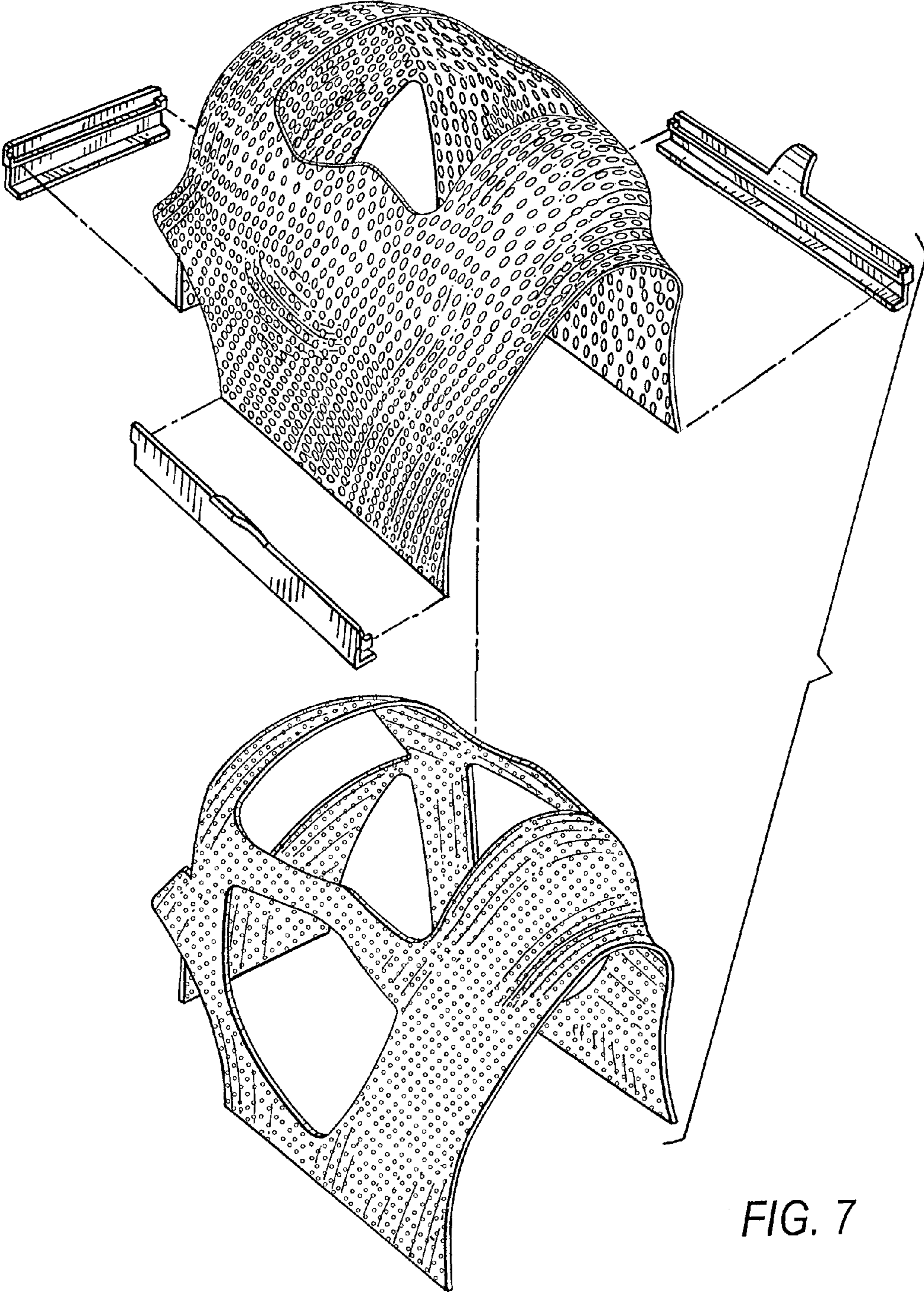

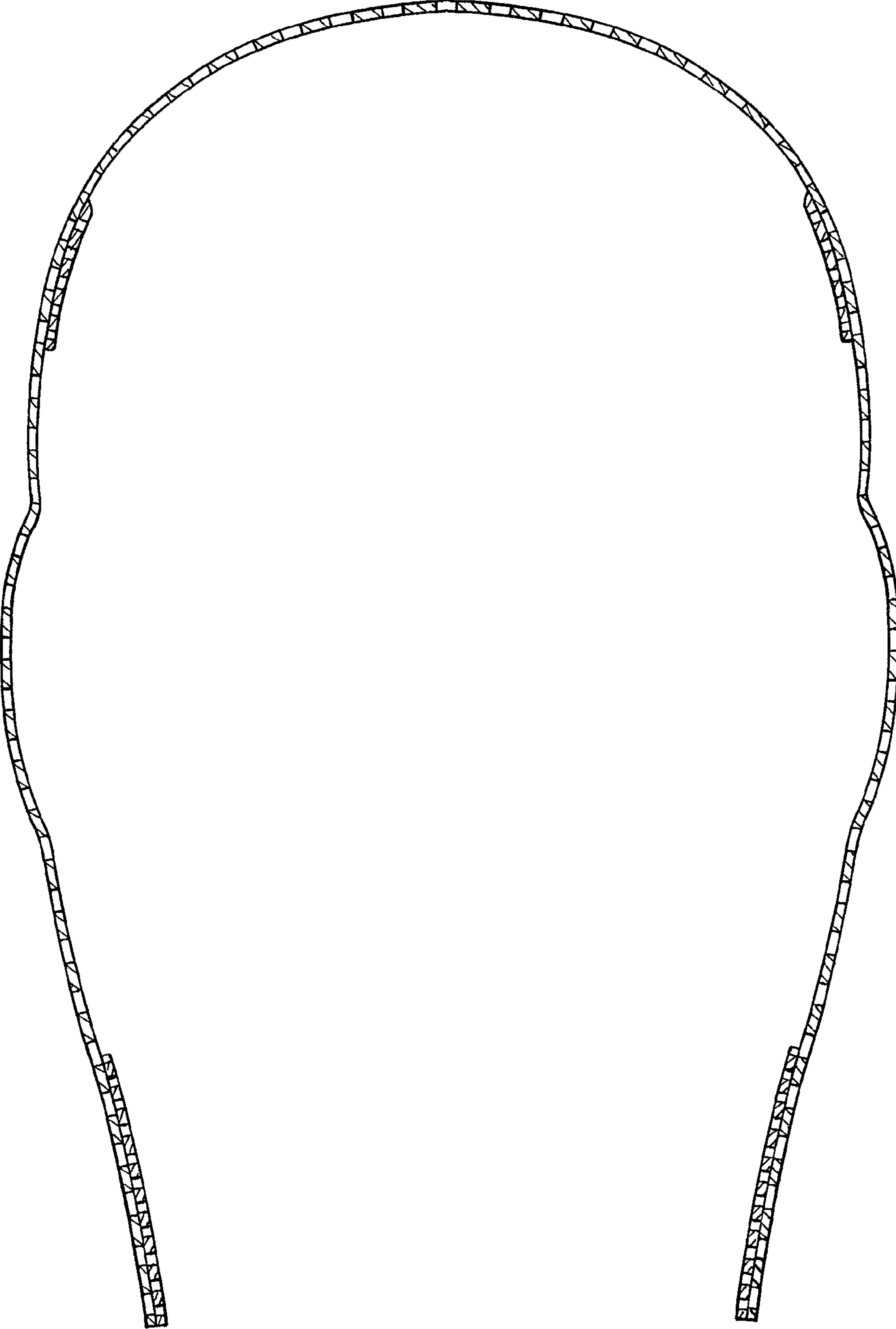
